Complaint

A third impeachment complaint against President Aquino is set to be filed today, Thursday, July 24.

Act Teachers' Party-list Representative Antonio Tinio says the impeachment complaint will center on government's Enhanced Defense Cooperation Agreement with the United States.

Tinio and Gabriela Women's Party-list Representative Emmy de Jesus will endorse the complaint which will be filed by activists Carol Araullo and former congressman Teddy Casiño.

"For impeachment, it is not necessary to wait for Supreme Court's decision. We've impeached President before without benefit of Supreme Court decision. It's a clear cut case-clear that EDCA is new military base agreement, bypassed the Senate and Congress and violated consitituon," Tinio says.

Earlier this week, two impeachment complaints were filed against the President.

The first was endorsed by Bayan Muna and Anakpawis law-Cont. on page 11

Body Formed to Set Rules in Lawmaker Presses for Farmer's Wife in Search Hiring of Job Order Employees Equal Allotment of BAGUIO CITY - Mayor Mauricio in City Domogan last week formed a committee to formulate policy guidelines on the hiring of job order employees in the city government.

This is to resolve questions on the lack of well-defined policy guidelines on the recruitment of personnel through job orders which was raised by the Commission on Audit Cordillera (COA-CAR) through the audit team leader and supervising auditor in the city.

The said observation was contained in the audit memorandum dated March 31, 2014 addressed to Domogan, city human resource management officer Estrella Bisquera, city accountant Antonio Tabin and budget officer Leticia Clemente.

The mayor said the COA officers themselves recommended the creation of the committee to formulate said guidelines which was considered by the local finance committee, Bisquera and the department heads in their meeting last May 23.

Clemente will chair the committee with Bisquera, Tabin and the department heads with job order employees as members.

They were given two months to formulate the guidelines which the mayor said should be in consonance with the provisions of section 77 of the Local Government Code of 1991 and existing Civil Service Commission laws./ A Refuerzo

Indemnify the Victims! Never **Again to Martial Law!**

"In the early morning of May 6, 1983, we were awakened by the sounds of firearms being fired in our community. We thought that it was a dream. But it was never a dream. Members of the dreaded Civilian Home Defense Force attacked our village. All of us were rounded up and forced to the front of our church. There, we witnessed and suffered different forms of physical abuse. In front of our church, we also witnessed the burning of our nearby village.

When the sun was up, we went to check our nearby village and what we saw is beyond words to describe. Three bodies of our relatives and village mates were tattered with bullets and burned. Their faces were beyond recognition. The victims were a seven-month pregnant mother and her four-year old daughter, and a barangay official.

Because of this, we were forced to leave our village for two months. When we went back to our village, our animals were gone. Our houses were ransacked. Our rice was burned. We had nothing to eat. Our families struggled to make both ends meet. These are our memories of Martial Law that even today, we tremble by the mere thought of it.

I am here today to file my claims as a victim and survivor. I do not expect monetary compensation in return but my action today is big step for me and my

Govt Resources Across the Regions

Every Filipino family should get VIP treatment

Senate Majority Leader Alan Peter S. Cayetano is pushing for the equitable distribution of government resources in all regions across the country, as he cited data that the lion's share of the government's budget for infrastructure is focused in the National Capital Region (NCR).

"Why are we so Metro Manila-centric? Bakit ang mundo ng Pilipino ay napapaloob sa Metro Manila? From 2001 to 2010, some 70 percent of all projects nasa Metro Manila. Thirty percent or the rest, sa buong Pilipinas," Cayetano said.

"Every Filipino family should feel like a VIP. It is high time the government gives the families in the provinces the support they need.

Cayetano cited that in 2013 alone, the National Economic and Development Authority (NEDA) approved P184.2 billion worth of 10 major infrastructure projects, eight of which are located in the National Capital Region (NCR). The two other projects are the Bulacan Bulk Water Supply Project worth P24.4 billion and Mactan Cebu International Airport Expansion at P17.5 billion.

He said many Filipino families are robbed of opportunities because the biggest chunk of the national budget pie is allocated to NCR. Under the 2014 General Appropriations Act (GAA), 13.07 percent of the total P2.265-trillion national budget will be spent on the capital region.

"Sabi ide-decongest daw ang Metro Manila dahil masikip na pero dinadagdagan ng skyway at highways para lumuwag ang mga kalsada sa dami ng sasakyan. Pero sa mga probinsya at ibang rehiyon, sira-sira ang mga kalsada. Kaya tuloy ang mga investors at big businesses, pinipili talaga ang NCR compared to other regions," he said

"Bakit nga ba nasa Metro Manila lahat ng pondo? Kasi, ang presidente, nasaan? Nasa Metro Manila. Nasaan ang Kongreso at Senado? Nasa Metro Manila. Nasaan lahat ng departamento? Metro Manila. Nasaan ang mga embassy? Metro Manila," Cayetano added.

Cayetano challenged the government to deliver on its promise of rapid inclusive growth by exploiting the potential of other regions, and implementing projects that will benefit each and every Filipino family through employment, health care services, and accessible infrastructure and public transportation.

He said the national government should part-

Developments for the Samaritans worse – medically and finan-

cially - have been too fast for Marco Joseph Ogas, a 51-year old vegetable farmer and father to four from Alapang Proper, La Trinidad, Benguet.

Last May 19, he was brought to the Benguet General Hospital after he threw up blood and was experiencing severe stomach and back pains. The following day, he was at the Baguio General Hospital and Medical Center to begin his life-time hemodialysis treatment for kidney failure, spaced at three times a week.

Last month, Delia, his 49-year old wife and fellow farmer, with the help of friends, sought media publication of Marco's plight. Like the spouses or close relatives of many other dialysis patients, she had no recourse but to make a public appeal for help to sustain the blood-cleansing treatment that is one of two options for those suffering from total kidney failure.

The other option is a kidney transplant. It's only for those who have relatives willing and physically able to donate an organ which can pass the tissue matching, and have at least P2 million for the procedure and the healing.

The couple's three sons and daughter may be too young to serve as organ donors. Neston, the eldest at 23, finished high school and works as a helper earning P300 a day. Jason, 21, finished elementary education and has no work, being a person with disability. Daughter Kris Cyril, 19, is in fourth year college while Nico jim, 17, is a high school graduate and now out of school.

In her report, social welfare officer Melanie Sahoy said Delia told her Marco had been taking maintenance medicines for hypertension for almost 10 years. After their marriage in 1991, the couple settled in Alapang.

"They were able to build their own house in 2006 from the savings of (Delia) who worked as a domestic help in Kuwait," Sahoy noted.

Marco is at the dialysis room of the BGHMC at 8:00 p.m. every Tuesday, Thursday and Saturday for his treatment. Otherwise, he's at their house at BC 66, Alapang Proper, La Trinidad.

Meanwhile three Samaritans pooled support totaling P24,600 for 43-year old Nancy Bugnay, another dialysis patient and mother of five from Pongayan, Kapangan, Benguet.

The biggest donor, who regularly reaches out to patients whose plights he reads from the local weeklies, coursed P15,000 through Nancy's son, Edward.

A woman who also declined to be identified wrote a check for P6,600 (good for three treatment sessions) which she left with the nurses at the BGHMC renal treatment room.

Another gentle soul from Bontoc, Mt. Province sent P3,000 through a GL bus plying the route to Baguio. He or she must have been the same kind stranger who earlier sent P3,000 each for patient April Sakiwat and his nephew, Robert Tomas.

"We don't know how to address the donor to thank him or her, as he or she declined to be identified," Divina, mother of Robert, said. "He or she just texted that we go get the cash support from the conducted of a GL bus with body number 928."

From southern Germany, Shoshin Kinderhilfe, the small foundation established by Bontoc native and Shotokan karate teacher Julian Chees, recently provided school fee support to two girls trying to pursue college courses.

Sharmaine Boquiren, whose mother, Rhoda, sorts out garbage and a third year commerce student at the King's College in La Trinidad, received tuition fee support totaling P2,746, while Cherry Anne Realina, freshman information technology student at Data Center, got P4,130 fund assistance./Ramon Dacawi.

City Mulls on Roving Vending BAGUIO CITY - Mayor Mauricio Domogan disclosed during his weekly forum last week on allowing roving vending in the city of Baguio subject to guidelines, rules and regulations to be set by the Baguio City Market Authority (BCMA).

The BCMA agreed to allow roving vending in the city to give way and opportunity to individuals earn a living.

Among the rules and regulations to be set by the city are as follows: must be a resident of Baguio City, applicants will undergo the screening process subsequently be given and identification card and a special permit defining the specific place/area where they will be allowed to vend, stationary selling of their products is prohibited otherwise their identification cards will be confiscated and will no longer be allowed to vend, they are not allowed to sell products that are found in the surrounding area assigned to do vending in a roving style, and cleanliness must be maintained and sustained.

Domogan stressed that the screening committee team will be tasked to evaluate and screen interested applicants pursuant to the criteria set by the city.

A number of interested individuals were already submitted to the BCMA for screening and evaluation, added the mayor./Jho Arranz

Waste Board Asked to Look into **Increase in Volume of Garbage**

BAGUIO CITY - The city council on Monday tasked the City Solid Waste Management Board (CSWMB) to look into the alarming increase in the volume of city wastes being hauled out to the landfill facility in Urdaneta City.

The body approved the resolution proposed by Councilor Peter Fianza who said the board should check and investigate the drastic hike in the volume of wastes from a daily average of 127 tons in 2013 to 155 tons during the first half of the current year representing an increase of 22 percent.

City general services officer Romeo Concio said he will check on the accuracy of the reported amount of increase albeit he affirmed that the city normally experiences a significant rise in the volume of wastes usually at 15 percent during peak tourist months, opening of classes and the rainy season.

He said this is caused by the slackening of collection operations for recyclable wastes due to the rainy season and the added weight of the wet refuse.

Fianza said the increase was deduced from the record of payment of hauling services to Urdaneta waste facility for the period January 1 to June 30 this year amounting to P24,318,986.35.

"Unless remedial measures are immediately instituted, the city may have to supplement the budget allocation for the current year for hauling services of garbage that will include tipping fees with an additional amount of P20,000,000," Fianza noted.

He said it should be "encouraging to interpret that the payment of hauling services for the month of December 2013 with a low of 100 tons per day will suggest possible and attainable increase of waste diversion targets as mandated under section 20 of Republic Act 9003."

He said the solid waste board should be on hand to look into this being tasked to monitor and oversee the implementation of the city's solid waste management plan and to adopt measures to promote and ensure the viability and implementation of waste programs in the component barangays./A Refuerzo

P-Noy Asked to Release Funds for City's **Priority Projects**

BAGUIO CITY - City officials appealed to President Benigno S. Aquino III through Budget Secretary Florencio Abad to release the funding for the priority projects of the city

The city council last Monday approved a resolution conveying said request to the President noting that the priority projects are "necessary and shall promote the social, cultural and environmental enhancement for the good and enjoyment of Baguio constituency."

"Although the city has a sound has a sound fiscal standing, it does not have enough resources to fund all the projects that are needed," the body said.

The body expressed confidence that the request will be approved on account of the national government's supportive stance on all endeavors of local government units that bring progress and social justice to all.

Mayor Mauricio Domogan made the same call in June.

The 13 projects which are included in the city's Annual Investment Plan for the year were identified after a consultation with stakeholders in the city and have a total fund requirement of P796,277,758.

These are the improvement of Mines View Park with a total amount of P25 million; Bayan Park, P25 million; expansion of the Baguio cemetery, P50 million; development of Burnham Park picnic ground, P25 million; proposed Wright Park Stall Cluster at Lualhati barangay, P50 million; City Hall extension (legislative building), P60 million; proposed engineered sanitary landfill at Sto. Tomas barangay, P300,000; improvement or rehabilitation of Heritage Hill buildings, P30 million; Botanical Park walk-through Botanical Garden, P25 million; construction of General Services Office building, P100 million; rehabilitation of Baguio Convention Center, P70 million; concreting of road going to the Philippine Science High School Cordillera, P6,277,758; and one-stop shop for souvenir and livelihood center, P30 million./ A Refuerzo

Youth Tapped on Campaign **Against Smoking**

BAGUIO CITY - the city government here thru the Health Services Office has tapped the youth to help educate their peers in the dangers of smoking

City Epidemiology and Surveillance Unit head Dr. Donna Tubera presented Wednesday (July 23) during the public consultation on the new Comprehensive Anti-Smoking Ordinance of Baguio City the result of the survey on tobacco use by adults and youth.

The Global Adult Tobacco Survey (GATS) for the city revealed 36.4% of adults are smokers in this mountain resort translating to 105,947 adults of the current population.

Six out of ten current smokers plan on quitting and 83.7% believe smoking causes serious illness.

At least 3,857 adults also shifted to the use of smokeless tobacco and 6 out of 10 smokers plan to quit smoking.

For the Global Youth Tobacco Survey (GYTS), 43.20% of students have tried smoking, 28.13% are currently smoking and 10.39% are currently using other forms of tabacco.

It was also revealed in the survey that first time smokers start at the early age of 12 and 13.

This also reveals that 63.89% of the youth can openly buy cigarettes in any store while 28.15% who buy cigarettes are not refused purchase because of their age.

The data shows provisions of Republic Act 9211 or the Tobacco Regulation Act of 2003 is being violated due to lack of enforcement.

Tubera said, "there are still a lot of minors who can easily buy tobacco products in stores."

Currently, the City Health Office (CHO) has strengthened its monitoring on business establishments in the city.

The Comprehensive Anti-Smoking Ordinance prohibits the sale and distribution of tobacco products within 100 meters from the perimeter of any school, church, or building frequented by the public in general.

Authorities say the best way is to quit smoking or don't smoke in areas not allowed under the ordinance or in the places frequented the public especially minors./paul rillorta

The antigraft court suspended Sen. Jinggoy Estrada for 90 days at his pork barrel scam trial. Detained Senators Juan Ponce Enrile and Bong Revilla hold their breaths for similar suspensions.

Russian President Vladimir Putin denies his fingerprints are on the SA-11 missile that killed 298 civilians (three Filipinos) aboard Malaysia Airlines Flight 17 as it was flying over Ukraine en route to Kuala Lumpur. Bodies, plane shards and children's books splattered on the towns of Snizhne and Torez.

In Gaza, 47,000 Palestinians crammed into 43 UN shelters as Israeli troops blew up multiple tunnels that Hamas burrowed over the years.

Less dramatic but significant items are sidelined. Take the July pastoral letter—"A Nation of Mercy and Compassion"—of the Catholic Bishops' Conference of the Philippines. It confirms the early January 2015 visit of Pope Francis to the Philippines. Skip the ceremonies. The pontiff will instead meet with typhoon and earthquake victims in the Visayas.

Francis comes after a Jan. 13-15 stopover in Sri Lanka where he is expected to restress that Catholics should continue working for a reconciliation between the government and the Tamil minority. That reinforces his plea, during an earlier "ad limina" call by the bishops of Sri Lanka, led by Cardinal Malcolm Ranjith.

His visit here is to a local Church whose work is woven into the history of the people: schools, care for prisoners, leprosaria, sanctuaries for abused women, orphanages and, in the words of a soused Marcos ally, "those f—g nuns who guarded ballot boxes."

The local Church's emerging leaders are breaking away from brimstone excommunication threats made by a few over single-barrel

issues like reproductive health. Cardinals Luis Antonio Tagle and

Orlando Quevedo are the face of this new generation. They focus on a range of targets from securing justice for the slum dwellers to cooperation with Muslims and marginalized minorities. They also live austerely.

"Are we a church that really calls and welcomes sinners with open arms?" Francis asked earlier. "Or are we a church closed in on herself? Are we a church which is a house for everyone... the strongest, the weakest, sinners, the indifferent... Are we a church where one cares for another, where the face of God dwells?"

"Become a people rich in mercy" is the distinctive way to prepare for Francis' visit, CBCP president Archbishop Socrates Villegas wrote. "Let us make mercy our national identity." He lists practical suggestions, from sharing food with the hungry to simply refraining from the use of harsh words.

Two short years ago, the Catholic Church was rocked by the first resignation of a pope in nearly 500 years. Benedict XVI quit, citing failing health. The conclave then elected a little-known cardinal who had then already booked his return flight to Argentina.

"Buona serra" Cardinal Jorge Mario Bergoglio told the crowd in St. Peter's Square and stunned them by asking for their blessing first. He took the name of Francis, the mendicant friar from the North Umbrian town of Assisi. The simple lifestyle of Francis and his followers is credited for recasting a 13th-century church splintered by corruption.

From day one, Francis set the example. He waved aside the ermine cloak for a papal elect. "Wear it yourself if you wish, Monsignor," he told the attendant. "But this carnival is over." He shunned the Vatican apartment and lodges in a spartan Vatican hostel. He grounded papal limousines, tooling about in a modest car. He stood in line for coffee.

Pope Francis' reforms vetted and closed out 3,000 suspect and unwanted accounts in the Vatican Bank, a New York Times editorial noted. And more important, he's instituting reforms that rocked its governing bureaucracy, the Curia, mired in turf wars.

Reforms are tough but progressing, say two key cardinals: Oscar Rodriguez Maradiaga of Honduras and Oswald Gracias of India. They are among eight prelates Francis picked to spearhead his recasting of the Church. None are Italians.

By December, this council of eight shall have submitted for Francis' approval a new constitution for the Curia. It would replace "Pastor Bonus," the 1988 apostolic charter written by the now St. John Paul II.

The proposed reforms range from capping service in the Vatican to five years and bringing more lay people into the Curia. It would scrap automatic cardinal red hats for Vatican officials. More diocesan bishops with expertise will serve in the councils. Francis fired a German archbishop for creaming funds and has taken on the Italian mafia. These actions are jolting the Vatican.

Meanwhile, he named 58-year-old Rainer Maria Woelki archbishop of Cologne, Reuters reported. Berlin's Tagesspiegel newspaper called him "the prototype of a new generation of bishops... not grumpy and dogmatic.... These men speak of mercy and mean it. They're open to people, even their critics, to a point and have a heart for the disadvantaged. Still, they're theologically conservative."

Worldwide, Catholic population crested at 1.21 billion at the end of 2011, says the latest "Statistical Yearbook of the Church," with increases in Africa (4.3 percent) and Asia (2 percent). Europe and the Americas kept abreast of population growth. The number of priests, religious and seminarians increased. In contrast, there has been a 10-percent decrease in the number of women religious since 2001.

Come October, a synod of bishops called by Francis will tackle issues not visible on the horizon in the 1980 conference. The issues range from surrogate parenthood to childless marriages. The gathering will affect the Philippines where the "Francis effect" is increasingly felt./Juan L. Mercado

The other night, I stayed up almost until dawn monitoring the new tragic airline disaster in strife-torn Ukraine involving, yet again, another Malaysian Airlines aircraft that claimed innocent lives. I felt sad for the so-called "collateral damage" of war. The agony of relatives and loved ones cannot be fathomed by us observers, although I was in the middle of that kind of human anguish and grief when I was crisis manager of another plane crash in Mindanao many years ago. As I went to sleep already almost dawn, something strange struck my mind as I suddenly jumped out of bed to check some data. I found an interesting common thread to those earlier disasters: the number "7". Consider the following:

1) Malaysian Airlines flight MH17 crashed after being reportedly shot down by a surface-to-air missile over Ukraine a few days ago. It was a Boeing 777 aircraft and flew its first inaugural flight on 17 July 1997. It was exactly 17 years to the day when it crashed last 17 July. Strange coincidence.

2) Still remember Malaysian Airlines MH307 which is up to now still missing and being searched ? It was also a Boeing 777 aircraft. By the way, Boeing 777 entered commercial service on 7 June 1995.

3) Many years ago, in 1998, it was Cebu Pacific Flight 387 that crashed in the outskirts of Cagayan de Oro City. I took charge of the whole crisis situation when former President Ramos assigned me to handle coordination of the incident. That was one of my unforgettables.

4) Then I remember a similar airline incident in September, 1983. Korean Airlines flight KAL 007 was shot down when it strayed into Russian territory. All passengers and crew died. It was a Boeing 747 aircraft.

FACEBOOK POSTS —- Mere coincidence, I am sure, but this sounds eerie. So I posted my initial take on No. 7 on my Facebook account. Gods! I got a flurry of interesting but spontaneous, off-the-cuff comments. An FB friend going by the name PHOTOVISIONEERS FOTOGRAPINOY simply said: "The ancients said that 7 is the number of God". Another one, RO-MAN RAMA GUERRERO (from North Cotabato) posted: "Shouldn't we alert Malaysian Airlines with these observations Sec Jess? It's time to turn away from #7 as we did with the President whose favorite number was 7". Another FB friend KUMAW MONTECLAR SEBALDA posted an internet-generated fact sheet about MH17 and Boeing 777.

An FB post from ELTON CERNA (In Davao City) said: "Seven is God's number. Take this: a) God created the world in six days and rests on the 7th; b) He commanded his people to labour for 6 days and to rest on the 7th; c) Noah's ark during the biblical great flood floated for 6 days and rested on Mt. Ararat on the 7th; d) in Revelation, God warned of the 7 last plagues. In fact, there are many other biblical accounts that mention 7 as having close association with God."

You might ask me, "Why are you active in social media?" I actually have many reasons to be active in social media, particularly Facebook.

It hones my writing skills. I've been writing this column for over 25 years. It began with Business Day before it became Business World shortly after Ninoy Aquino was murdered. I'm also in the process of writing a book. It helps me to try finding new ways to keep it brief and interesting.

It allows me to be myself. On some days, I function as a deejay posting music videos from YouTube. These range from retro songs dating back to the '60s and '70s, to my family's favorite songs, to current hits.

On other days, I want to make people laugh with humorous stories, jokes and funny videos. At other times, I go on a poster binge that I find on other walls that give food for thought and calm the soul.

DID RPBENEFIT FROM TESDA'S P1.6 B DAP? Even in death, prison catechist Cristina Dicang had to be in the Baguio city jail where she spent her last 43 years, quietly ministering to a congregation of sorts.

Last Sunday morning, three days after she passed on at 74, her immediate family acceded to a written request of the inmates, done through their Catholic Community, to bring the wake to the city jail so the detainees and their guards could also "offer our last respect to her and pay tribute for everything she has done for us".

"Both the female and male inmates will be enormously grateful if they will be able to see their beloved sister Dicang for the last time," the request, noted by male and female dormitory wardens, Chief Inspectors Wilson Banasen and Mary Ann Tresmanio.

"It's a wish we can't deny, for, aside from us, the prisoners have always been Manang Cristy's family," Swanny Dicang, Cristy's younger brother, said.

Fr. German Ledesma celebrated the mass at the multi-purpose hall which Cristy had converted into a chapel. The inmates in yellow T-shirts filled it to capacity for the chance to offer prayers, have a last look at her at their spiritual guidepost and listen to jail officers and their fellow wards express collective and individual sentiments through eulogies.

"Kalawangin man ang rehas at madagdagan ang pintuan dito sa bilangguan, sa puso namin, kanyang kabutihan di na mapapalitan (The prison bars may turn to rust and the prison doors open up, yet no one can replace her goodness)," a female prisoner noted.

"I will miss her frequent aned long visit to our cell, sipping her coffee and just enjoying talking to us," another female detainee admitted. "As I look around the confines of our cell, I feel very lucky that I had been a special part of her life.

"When she made her journey from this world, she was surrounded by loved ones, in the comfort of what she considered as her own home."

Addressing her directly as she lay inside a white coffin in front of the altar, Senior Insp. April Rose Ayangwa, the former wardress of the female dorm, pointed out "you have done all of these without compensation".

"I guess it would be difficult to find someone who can be as passionate and as happy in such kind of volunteer work as she was," observed Cristy's nephew, retired Army Gen. Alex Dicang who flew in from Agusan for the wake and funeral.

Only a few people and institutions – her immediate family, the guards and inmates of the city jail and the Episcopal Commission Prisoners' Welfare of the Catholic Bishops' Conference of the Philippines – were aware of Cristy's years of volunteer prison ministry. Baguio residents came to know of it only after the city honored her as one of its most outstanding residents in 2002 in the field of community service.

Twenty three years into her ministry, the Episcopal Commission then chaired by Bishop Francisco San Diego honored her with the "Gawad Paglilingkod" in recognition of her "love and concern for the members of the prison society – the prisoners and their families, the released prisoners and the correctional employees – (that) has con tribute significantly to the realization of the Church's Mission of uplifting the quality of life of the disadvantaged".

Writing about her after she received Baguio's highest award, teacher Vicky Rico-Costina noted: "Helping prisoners is not exactly everyone's idea of a profession., In fact certain quarters would agree against Cont. on page 10

LGU Baguio Rates Fair in Citizens' Satisfaction

BAGUIO CITY - During the Citizens' Satisfaction Index System (CSIS) Utilization Conference last July 23, it was revealed that the city government of Baguio was given a fair rate in citizens' satisfaction on the programs of the city which means that the clients/citizens were satisfied with the programs as well as services of the city.

CSIS is a tool which aims to generate citizens' feedback on local government's performance on service delivery and the citizens' general satisfaction, and the level of availment of services.

The Department of the Interior and Local Government (DILG) has been utilizing performance measurement tools for Local Government Units (LGUs) as early as 1980. DILG is developing a new tool which really can appraise whether a LGU is in the right track in attaining good governance.

DILG-CAR Regional Director John Castañeda said, "despite having the Local Governance Performance Management System (LGPMS), there is still a need for a performance measurement tool that will incorporate the "clients" or the citizens' perspective as to the realization of good governance. The CSIS will determine the awareness of the citizens on the programs of the city as well as the level of satisfaction."

The University of the Cordilleras (UC) has conducted the CSIS survey to 150 respondents covering 28 barangays in the city of Baguio.

Eight service delivery areas namely: health services, basic education, social welfare services, governance and response, public works and infrastructure, environmental management, agricultural support services and tourism promotion services were surveyed based on the awareness, availment and assessment/satisfaction or the multi component performance assessment framework of citizen satisfaction.

Based on the result of the CSIS, the awareness score provided the lowest level of score among all indicators of Citizen Satisfaction. However, most of the components of local government services and programs r5ated fair to high level of availment among those aware of the services.

On satisfaction with local public services, fair to high level of satisfaction was observed among all components. Meaning, those who have been able to avail of the services provided by the city have a satisfactory level of satisfaction with said services.

Accordingly, a great emphasis must be given in information dissemination of the services and programs of the city government. Although services and programs exist to meet the need of

the citizenry, the lack of knowledge prevents them from accessing these services.

Considering that the result was based on the perception of clients/citizen, DILG City Director Evelyn Trinidad said "the result will serve as an eye opener and challenge to the city government and that the city of Baguio will strive harder towards the commitment for excellent good governance."

Be Alert for Rainy Day Diseases, Store Basic Emergency Supplies, DOH Urges

BAGUIO CITY - With the typhoon season in, the Department of Health reminds the public to be wary of common rainy day diseases and be ready in storing basic emergency, medicine and food supplies.

DOH Cordillera Regional Office Assistant Regional Director Dr. Amelita Pangilinan, in a kapihan media forum here on July 17, said with the afternoon rains and typhoons enhancing monsoon, the public should be alert for food and water borne diseases. She advised the public to ensure proper food storing, handling and preparation.

She also reminded against vector borne diseases such as dengue. Though there is a decrease in cases, the hot weather when there is no rain remains a threat for more mosquitoes especially if possible breeding sites are not regularly checked and cleaned.

Pangilinan also reminded the public on keeping basic food supply – rice, canned goods, noodles or veggie noodles and drinking water, as well as flashlight or candles and to check their cooking needs such as charcoal or liquefied petroleum gas.

She advised the public to maintain a supply of basic medicines and maintenance drugs for those into regular medication.

She also informed that the health department has been prepositioning drug and medicines including medical supplies needed in emergency situations in the different government hospitals in the region.

 Statement of a Martial Law Survivor from Beew, Tubo, Abra

Today, July 24, 2014, victims and survivors of the Martial Law period will file their human rights claims before the Human Rights Victims Claims Board at the Baguio Convention Center under the Republic Act 10368 or the Human Rights Victims and Recognition Act of 2013 which covers the period from September 21, 1972 to February 25, 1986.

According to Mr. Jude Baggo, Secretary General of the Cordillera Human Rights Alliance (CHRA), "The passage of this law is a temporary victory for all the victims and their families, survivors and communities who suffered during the Martial Law years of the Marcos dictatorship. This law only proves that during the dictatorship of Ferdinand Marcos, the State used its machineries especially the armed state security forces to perpetrate widespread and systematic human rights violations against innocent civilians and communities in the name of national security."

"We welcome this law but its requirements are overwhelming. Its requirements are tedious and entail documents that are practically not available. In our region and especially during Martial Law years, our indigenous communities are not documented on paper. Life and its cycles were based on rituals and traditions. There were no marriage contracts, birth and death certificates. Because also of State neglect, most communities during thad no clinics and hospitals, therefore there are no medical certificates for torture, physical injuries, rape. Furthermore, since it was Martial Law, the arrest and detention of innocent civilians in our villages were not documented. The law requires most of these papers befor filing any claim. Without possessing any of these documents, most victims cannot file their claims and narrow the chances of recognition and reparation. For those

killed, disappeared, tortured, raped, massacred, arrested and detained, is this not too much for them to prove that they are victims by looking for documents that they do not possess?

Even the required two valid government-issued IDs are difficult to produce since most of the victims are poor and cannot afford to secure an ID, and live in farflung communities. There are even victims who cannot file in person because they do not have money to pay for their transportation. Others cannot afford to pay an amount of P50 for a notary of their documents. Instead of providing easier access to justice, the law is actually limiting and even closing doors to victims to attain justice, to think that the victims have to relive their entire experience of suffering during the dark martial law years. The law asks too much from the victims instead of offering a helping hand. This law further exposes theat the legal system we have which only caters to the rich and powerful.

We therefore call for an urgent review of RA 10368's implementing rules and regulations. Based on stories of victims from

our communities, most of the violations are mostly collective in nature. Most individual cases such murder, torture, arrest and detention also happened in front of community residents. We therefore propose that community testimonies should be honored as a piece of evidence to strengthen the claims of indigenous peoples as victims. Lastly, we call for the resignation of former PNP General Lina Castillo-Sarmiento as the Chairperson of the Claims Board to pave way for a more neutral and credible review of the claims./Reference:/ Jude Baggo/Cordillera Peoples Alliance Public Information Officer/ Ms. Abigail B. Several health districts are now down to only one case each, such as Aurora Hill, from 21 cases; Campo Filipino, from 7 cases; Pacdal, from 14 cases; and Quezon Hill, from 7 cases, all in 2013.

Three health districts have only two cases; Atok Trail, from 9 cases, Engineer's Hill, from 10, and Irisan, from 29 cases. Loakan and Pinsao now have three cases each, from 24 and 36 cases last year, respectively.

Atab, City Camp and Mines View have 4 cases each; from last year's 25, 31 and 10 cases respectively. Lucban district is down to 7 from last year's 33 Dengue cases.

Dengue cases last year added to 315, now down to 35, a marked decrease of 88.89%.

On the other hand, from the 126 Typhoid cases April to June last year, 60 cases have been reported the same period this year, at the CESU. Dr. Tubera of the CESU reported however that Barangay Asin, from 3 Typhoid cases in 2013 now has 7, and Quezon hill with 1 case has now 3; making up a 133.33% and 200% increase, respectively.

Scout Barrio has best improved with 5 cases in 2013, now zero; Atab, with 10 cases in 2013 has now 5, a 50% decrease, Atok Trail and Quirino Hill each with 7 cases then, now with 2, both with 71.43% decrease.

Aurora Hill with 6 then, now 3; City Camp with 12 in 2013, now has 6; Lucban with 20 then, has now 10; Pacdal with 2, now only 1; all having 50% decrease in Typhoid cases.

Campo Filipino still has 3 cases; Engineers' Hill with 4 cases; both same as last year; Irisan has 12 cases in 2013 now has 3, a 75% decrease.

Loakan had 19 cases last year now has 4, a 78.95% decrease, Mines View posted a 40% decrease, from 5 to 3 cases this year. Pinsao had 10 cases, now 4, a 60% decrease.

Of the reported cases, eight (8) were treated at the Baguio General Hospital, one case at the Baguio Medical Center, five (5) at the Benguet General Hospital, 22 at the Notre Dame de Lourdes Hospital, five (5) at the Pines City Doctors Hospital, and 19 at the Saint Louis University Hospital of the Sacred Heart.

The monitoring reports are part of the ASK meetings; as presided by Mayor Mauricio Domogan and attended by concerned government offices and private entities, all for the city's concerns: clean and green, water quality, air ambiance, graffiti, parks, forestry and re-greening, market, health and nutrition, information dissemination and police reports.

The ASK meetings are conducted at least twice a month./juliegfianza

months of age, which as to projected statistics, the City Epidemiology and Surveillance Unit (CESU) believes to be 29,000. Aiming to reach 95% of the city's children populace, the CESU-HSO in coordination with the Department of Health-CAR has scheduled a daily morning clinic, and a reach-every-child-in-the-purok scheme during the afternoons. There are also vaccination schedules in day care centers, churches, pre-schools, hospitals and pediatric clinics.

From April to June this year, 103 cases of measles has been recorded in contrast to 27 last year, during the same period, making up a 281.48% increase.

From eight health districts having zero cases in April to June 2013, Atok trail now has 15; Campo Filipino has 4; Engineer's Hill, 3; Loakan, 10; Pacdal, 6; Pinsao, 11; Quezon Hill, 4; and Scout Barrio, 1.

Asin and Irisan health districts in 2013 had one case each, now have 8; as with Quirino Hill with only one case last year; now have 2 cases.

Atab health district and City Camp then have 2 cases each; now has 9 July 26 to August 1, 2014

measles cases and 10, respectively. Aurora Hill has now zero cases, but in 2013 had 2 cases.

Lucban health district which had 16 cases last year, now has 11. Mines View had 2 cases in 2013, now has one case.

As to age group, there had been 17 girls and 22 boys, all under one year of age, 4 girls and 20 boys, ages 1 to 9 years old, 8 girls and 10 boys, ages 10 to 19 years old, infected by measles. Eight young ladies and 10 gentlemen, ages 20 to 29; one female and 2 males, age 30 to 39; and a male with age range of 50 to 59; for a total of 103 cases from April to June 2014.

The illness is communicable, though preventable and children could be protected from it through vaccine, it was known.

The symptoms for measles are fever, dry cough, runny nose, sore throat, with some having conjunctivitis, later with whitish spots in the inner lining of the cheek, skin rashes of flat blotches which would spread to the whole body and disappear after a few days. Care should be taken as there may be complications such as ear infection, encephalitis and seizures, specially in cases of very high fever. As it is viral, measles could not be treated by antibiotics.

HSO Officer-in-Charge Dr. Rowena Galpo during the planning activities for the mass vaccination expressed full support for the program.

The Philippines was declared polio-free in 2000, yet reports cite isolated wild polio virus outbreaks being spread from other countries. The World Health Organization says the emerging and re-emerging diseases are an international concern as to public health./juliegfianza

He is simlpy explaining to them the basic issues they have a lot at stake. ...from page 5 ment Assistance Fund (PDAF) issue that led to the Million Man March at the Luneta in August last year. That event brought to mind the text brigade that mobilized hundreds of thousands of protesters at EDSA in 2001 that led to then President Joseph Estrada's downfall.

Farther back, I witnessed the use of other social media tools like the Pocketbell pager messaging before, during and after the 1986 People Power Revolt, and at the time of the two most violent coup attempts against President Cory Aquino.

I also use Facebook to advocate for national security, good governance, poverty reduction, responsible citizenship and reproductive health that I consider indispensable to nation building; and to feel the pulse of the Facebook community on these issues. Facebook is also an effective medium to disseminate weather warnings and call for assistance, as well as coordinate efforts for rescue and relief when other channels of communication break down or prove ineffective.

NEWS

It is a major source of information – for personal milestones such as new relationships, weddings, births, birthdays, graduation, anniversaries, trips, deaths, wakes and funerals. At times, I come across friends and relatives who need care and solace due to illness or a family crisis.

Social media also provide useful information about my alma mater, breaking and headline news, fine and casual dining, travel, movies, the performing arts and sports.

At the FIFA World Cup in Brazil, two of my favorite teams clashed for the championship – the teams of Pope Francis and Pope Benedict. I think the sauerkraut community will be celebrating all year long starting today.

I've noted that the uniformed services have been using social media for communication and information dissemination. It has tremendous potential for other purposes:

Military news, connectivity for networking, morale-welfare, family guidance and child care, crisis communications, rescue-relief-rehabilitation operations, educational courses, operations, security guidance, online shopping and banking, spouse or partner employment support, cyber security education, location services.

A personal caveat: I'm careful about discussing confidential information in social and mass media that, if revealed, could be harmful to the national interest. I'm also aware of the deluge of misinformation and disinformation out there that must be discerned. Cyber security begins with self, and what not to say or reveal is vital to our national wellbeing.

Let me end with another quote from Gandhi. The advice he gives is timeless:

Keep our thoughts positive because they become our words;

Keep your words positive because they become our behaviours;

Keep our behaviors positive because they become our habits;

Keep our habits positive because they

become our values; Keep our values positive because they become our destiny.

BAGUIO CITY - the Comprehensive Anti-Smoking Ordinance in this mountain resort is now ripe for its needed amendments.

Committee on Health, Sanitation, Ecology and Environmental Protection Chair Councillor Fred Bagbagen gathered stakeholders this week in a public consultation for the needed amendment of the new anti-smoking ordinance.

City Ordinance No. 8 Series of 2008 crafted to safeguard public health and protecting the people from the harmful effects of smoking and tobacco consumption is being groomed to incorporate stiffer penalties for violators in the new Comprehensive Anti-Smoking Ordinance of Baguio City.

The fortified implementation of the smoking prohibition which has defined 'public places' as all places fixed or mobile, that are accessible or open to the public or places of collective use, regardless of ownership or right of access including, but not limited to establishments that provide food and drinks, accommodation, merchandise, professional services, entertainment or other services.

Section 5 of the new ordinance will prohibit smoking in enclosed or partially enclosed public places, workplaces, public conveyances whether mobile or stationary.

Persons who allow or tolerate smoking in this places will also be meted a penalty.

It will also be prohibited and unlawful to sell, distribute tobacco products in schools, public playground or other facility frequented by minors or within 100 meters from any point in the perimeter of this places.

Selling and distributing tobacco products to minors and purchasing tobacco products from minors is also unlawful.

Mayor Mauricio Domogan said, "the needed amendment which clarifies the definition of public places where smoking is supposed to be banned is now defined in this ordinance."

Recently, a violator of the anti-smoking ordinance was acquitted by the court due to the seeming vague definition of public places as defined in City Ordinance No. 8 series of 2008 which did not discourage the city from implementing the same.

Domogan said, "now that the grey area in the ordinance have been addressed in the new comprehensive anti-smoking ordinance, it can be effectively and fully implemented.'

Section 8 of the new ordinance imposes fines from P500.00 for the first offense, P1,000.00 for the second offense and P2,500.00 for the third and subsequent of-
