BAGUIO CITY – Now that the "Smoke Free Baguio" ordinance has been approved, there is a need for concerned city government offices and

other agencies to coordinate with local police in strictly implementing the measure's rules and regulations.

This was emphasized by Mayor Mauricio Domogan during a recent meeting with department heads led by city administrator Carlos Canilao, city health office head Rowena Galpo, city treasurer Alex Cabarrubias, city accountant Tony Tabin, medical officer Donabelle Tubera, a Baguio City Police Office representative and others at the SP session hall, city hall.

Ordinance number 34 series of 2017 prohibits the use, sale, distribution and advertisement of cigarettes and other tobacco products in certain places, imposing penalties for violations thereof and providing funds therefor, and for other purposes.

Senior high voucher system clarified

BAGUIO CITY -Issues about the Senior High voucher system of the K to 12 academic program were clarified by Department of Education (DepEd Baguio) Curriculum Implementation Division Head Dr. Rachel Bugtong in the press conference at the Baguio City Police Office hall last week.

According to Dr. Bugtong, the Senior High School Voucher Program (SHS VP) which is good for two years could be applied for and availed of by Grade 10 completers, from private schools and non-Educational Service Contracting (ESC); and also from public schools and ESC grantees.

The voucher entitles the senior high entrants/ Grade 11 students to claim a discount or deduction from the cost of tuition and other fees,

not in cash form but student is enrolled; at the disbursed to where the student is enrolled, either in private high schools, local and state universities and colleges; and technical and vocational schools, starting school year 2016-2017.

Grade 10 completers from public schools and ESC grantees from private schools are automatically qualified voucher recipients, and need not apply; while non-ESC grantees grade 10 completers from private schools could apply online, or inquire at any Department of Education (Dep-Ed) office.

Public junior high school students (JHS) receive 100% of the voucher amount, while ESC IHS students receive 80%. The amount of each

National Capital Region (NCR) or in Highly Urbanized Cities (HUCs), which include Baguio. The cost of education in the locality is also considered in the voucher. Applications, however,

are subject to review and approval, it was known, and any amount in excess of the voucher would be paid to the SHS provider by the beneficiary.

For current senior high students, a passing grade and compliance to the school's admission requirements is needed for the next voucher approval.

In a Dep-Ed memorandum earlier issued it was known that the SHS voucher must be used in the school year immediately after JHS completion, and within two successive years. A

Reforestation of city watersheds to be intensified **B**AGUIO CITY – Mayor Mauricio G. Domogan ordered the concerned city gov-

ernment offices and prospective volunteers to help in the city's intensified efforts to reforest its watersheds to ensure the sustainability of water sources for the increasing population.

The local chief executive said the local government will be using the bulk of the 500,000 assorted tree seedlings to be given by SM City Baguio management to increase the forest cover of the boundary of the city-owned 139hectare property at Sto. Tomas school area barangay, particularly with its boundary with Tuba, Benguet, and the Busol watershed, particularly with its boundary with La Trinidad, to improve the state of the city's watersheds in the coming years.

Based on data obtained from the environment department, only 20 percent of the city's over 5,000 hectares land area remain to be forested and that the pace of deforestation is rapidly increasing compared to the pace of reforestation.

"We also welcome the efforts of concerned residents and groups to plant Arabica coffee seeding in various portions of our watersheds because it will be helpful in improving the forest cover of our existing sources of water. We want to continue improving the greenery of our forests so that there will be increased water holding capacity of our reservations," Domogan stressed.

Aside from providing the local government with the tree seedlings for planting in the watersheds as its compensatory requirement for the 82 trees it cut at Luneta Hill, SM City Baguio will be hiring experts who will take care of the trees that will be planted for a 3-year period to guarantee that the planted trees will grow and serve their purpose.

Domogan claimed volunteer individuals and groups are welcome to actively participate in the numerous tree planting activities that will be scheduled during the rainy season to make sure that the seedlings to be planted will survive and contribute to efforts to preserve and protect the environment.

He urged barangay officials to also help in convincing their constituents to plant trees in available spaces within their properties to increase the presence of trees around the city and contribute to increasing carbon sequestration to help reduce the pollutants in the city's air.

Speaker Alvarez to defy Supreme Court



Speaker Pantaleon Alvarez has vowed to defy the Supreme Court if it orders Congress to tackle Martial Law in a Joint Session (as mandated by the Constitution). He insists that as co-equals, the Judiciary cannot "dictate" Congress what to do.

Alvarez is ignorant of history – forgetting the recent episode under the last president where the Supreme Court effectively struck down the self-serving pork barrel "bargain among thieves" that Congress and the Executive had reached on PDAF and DAP.

He is also ignorant of the "separation of powers" between the three branches – in **EDITORIAL** particular, on the role of the Supreme Court as final arbiter on constitutional matters.

The division is straightforward: Congress writes the laws – but only within the framework of the Constitution. Executive implements the laws. Judiciary interprets the laws.

If Congress refuses to follow the law – such as to meet in Joint Session to review & discuss the President's declaration of Martial Law – citizens should have recourse thru the Supreme Court to compel Congress to do its job. If Supreme Court supports the petitioners' positions, Congress is duty-bound to follow.

To defy a Supreme Court order on a constitutional matter is to trigger a constitutional crisis. Such a stalemate may be resolved thru statesmanship. But in today's toxic political climate, it could also be resolved by military intervention (if the officers decide to defend the Constitution) or mob rule (if the fanatics decide to do away with the Constitution altogether).

Both scenarios would be bad for stability, bad for business, bad for investments, bad for the peso, etc. Ultimately it will be bad for the pocket and stomach of Juan Dela Cruz. Not equally bad as one scenario is clearly worse than the other.

Alvarez' statement courts such a constitutional crisis. It is clearly a challenge to the Supreme Court as an institution. Supreme Court should not shirk from the challenge. It should interpret the law without fear or favor. Otherwise this could be the final nail in the coffin of rule of law.

The Speaker is a Destabilizer. Just like his political master. Both are not above the law. The Supreme Court should rediscover its voice before it becomes a mere parrot of tyrants. /By : Bernard Ong

...from page 1 safeguard public health and ensure the wellbeing of

all its constituents by protecting them from the harmful effects of smoking and tobacco consumption. "It shall be unlawful for any person to smoke or allow smoking in public utility vehicles, government-owned vehicles or any other means of public transport for pas-

sengers, accommodation and entertainment establishments, public building, public place, enclosed public place, or any enclosed area outside of one's private residence or private place of work, except in duly designated smoking areas," the ordinance states.

The measure shall apply to all persons, whether natural or juridical, whether resident or not, and in all places, found within the territorial jurisdiction of the city government of Baguio.

It also lists the prohibited acts, penalties to be imposed on violators, where the funds will go and creates a smoke free task force chaired by the Mayor whose members include various heads of government offices and other concerned agencies.

The task force will aid in the implementation, enforcement and monitoring of the ordinance and protect the same from tobacco industry interference at all times, as well as to conduct educational awareness campaigns, information dissemination and capacity building programs that will inform constituents and train enforcement officers.

much as P150,000 per square meter. The city has proposed to raise the market value in this area at P110,000 per square meter which is still lower that the prevailing price.

"Under the law, the city is duty-bound to impose the correct market value of the properties in our area of jurisdiction and we have been negligent and remiss on this duty since we did impose any adjustments for 21 years," the mayor said.

"But now, it is high time to correct this and also address the falsehood bred by our outdated market values which the city unwittingly tolerated with its failure to update the market values. Dapat itugma natin sa kung ano ang totoo," he intoned.

Furthermore, the city made sure that the new market values are comparable to zonal valuation of the Bureau of Internal Revenue (BIR) which is still in the 1998 level so the new rates cannot be dismissed as unreasonable.

The officials also assured that this will not result to confiscatory taxes as they have proposed to lower the assessment levels to temper the effect of the increased market values from the current assessment levels of 12 percent to just six percent for residential lands; 35 percent to eight percent for commercial and industrial lands; and from 12.5 percent to just five percent for cultural, scientific and hospital lots.

"That to me is already going down nearly to the bottom just to ensure that the resulting taxes will not go beyond what is reasonable," the mayor said.

Citing examples, city assessor Almaya Addawe said a 100-square meter lot along Benin road in Pinsao Proper barangay commands a P25.20 annual tax at present. With the proposal, this tax will increase to just P270 annual tax.

Residential lots within subdivisions in certain barangays are presently charged P212.40 per 100 square meters annual tax and after the

BAGUIO CITY – Mayor Mauricio G. Domogan ordered the City General Services Office and the City Legal Office to work out the filing of the appropriate charges against the embattled operator of the cityowned Asin hot springs after he allegedly dismantled the gate and removed the notices that were placed around the fence informing the public of his eviction from the city-owned property.

The local chief executive said aside from the filing of the contempt of court charges against Roger Sinot, criminal charges of malicious mischief will also be filed against him for allegedly forcibly removing the temporary gate installed by the GSO in the premises of the property and the notices installed around the gate informing the public that the swimming pool area is a city-owned property and that Sinot is no longer the resort operator based on an order from a Benguet court.

Assistant General Services Officer Eugene Buyucan reported during Monday's regular department heads meeting that they already served the eviction notice against Sinot for the latter to vacate the premises of the city-owned Asin hot springs pursuant to a court order and immediately installed a temporary gate within the swimming pool area apart from installing notices informing the public that Sinot is no longer the operator of the city-owned resort.

However, Sinot, together with his cohorts, allegedly dismantled the gate and removed the notices installed by the GSO personnel in the area as well as posting in the social media a certification issued by the municipal assessor's office of Tuba certifying among others that the local government of Baguio has no property in the said area.

Domogan argued that the people of Tuba know for a fact that the Baguio city government owns the property which was purchased in 1935 from the Ramirez family but the property was not segregated from the title of

This tax rate applies to most subdivisions and residential areas as per the proposal, Addawe said.

As to commercial areas like Session Road, they pay P5,775 per 100 square meter annual tax and with the proposal, they will be assessed P21,120 per 100 square meter or a 357 percent tax increase for these profitable businesses, Addawe added.

To further cushion the impact of the increase, the city is willing to implement the adjustment in three tranches for three years. This is on top of the 20 percent prompt payment discount being given by the city every year, the city officials said.

The officials reiterated that the adjustment is long overdue as the city has for years been berated by no less that the Bureau of Local Government Finance for its failure to comply with section 219 of the Republic Act 7160 or the Local Government Code which mandates the city assessor to undertake a general revision of real property assessments within two years after the effectivity of the code in 1992 and

The mayor appealed to the people to "understand what is reasonable" for both the city government and to them.

"By now, our people should have realized that we do not want to impose the new rates just for the sake of increasing taxes. This and other humanitarian considerations are the reasons why we have stalled on imposing the increase that long," he said.

"We want to impose what is reasonable for both the taxpayers and the city government and we believe that this proposal is as fair as it gets."

The city officials also assured that the proceeds of the increase in taxes will not be squandered and will be used for its intended purpose in the form of basic services to the public. /*Aileen P. Refuerzo*
