City Ready To Accept Offers On Asin Hydro Privatization



DEMOLISHED!!! - An illegal stall along Lion's Head, Kennon Road is being demolished and confiscated by the elements of the Public Order and Safety Division led by POSD team leader Benamin Tan while the Baguio's Finest provides safety and security with the presence of barangay officials last Sept. 24./ By Bong Cayabyab BAGUIO CITY – The city government is now ready to accept offers for the privatization of the operation of the Asin minihydroelectric plants.

Mayor Reinaldo Bautista Jr. Thursday said the city will soon issue notices to prospective companies who have the capability to operate and manage the facilities based on the terms of reference adopted for the purpose.

The mayor said the city council through Resolution No. 104-2009 granted him the

authority to negotiate for the operation of the power plants to maximize the facilities' income-generating potentials.

The mayor said the offers to be received by the city will be referred again to the city council for confirmation.

The city's confidence on the facilities was boosted by the encouraging results of the feasibility study conducted by experts from Czech Republic on the rehabilitation of the city's minihydroelectric plants.

Lawmaker To Pag-Ibig Junk Plan To membership is manda-**Hike Contributions**

Opposition Sen. Chiz Escudero vesterday called on the Pag-IBIG Fund to junk its plan to hike the membership contribution rate, backing instead the proposal of a labor group for the agency to raise funds by expanding its coverage to include all government and private sector employees.

"If it is true that Pag-ibig now covers only 7.4 million of the potential 29.2 million members, then an increase in the membership rate is ill-advised and untimely," the 39-year old lawmaker said.

"It also raises

questions about the direction of the agency's advertising campaign which has been funded by millions of pesos taken from contributions of members," he added

The Pag-ibig Fund announced last Sept. 18 that it was planning to increase its membership contribution rate to further improve the agency's financial capability and meet the demands of members for more loans and benefits.

In a statement, the TUCP criticized the planned increase as "unnecessary and indefensible." The labor group pointed out that while Pag-IBIG tory, only one out of every four workers is actually covered by the fund.

Escudero said Pag-ibig should seriously consider the proposal of the Trade Union Congress of the Philippines (TUCP) for the agency to raise revenues instead by expanding member-

"This will not only increase its available funds but more importantly it will benefit more of our workers and employees," Escudero said.

At the same time, the 39-year old lawmaker asked for a full report on how the agency has spent its funds in the past nine years./Office Of Senator Chiz Escudero

Presenting suspects to the media violates this right, because it projects them to be guilty already of the crime, aside from subjecting them to humiliation," Escudero, chair of the Senate Committee on Justice and Human Rights,

The resolution directs the Department of Justice, the Department of the Interior and Local Government, the Philippine National Police and other law enforcement and government agencies to issue implementing rules and regulations regulating the practice of presenting suspects to the me-

"We must remember that these suspects are still under investigation when law enforcers present them to the media. It constitutes unwanted publicity that only works to besmirch their name and reputation and that of their family," Escudero said.

The resolution also directs the government to include in its rules on the regulation of this practice provisions on administrative sanctions against those who would violate the rights of the sus-

The resolution has been passed on third reading at the Senate and is expected to be acted upon in the House of Representatives before Congress goes on recess on October 17 /Office Of Senator Chiz Escudero

instead of taxing text messages.

"The proponents of the measure to tax text messaging seem to have a skewed sense of priority. Instead of providing tax relief to the Filipino public, they think of adding burden," Escudero said in a statement.

"Taxation should be based on the ability of taxpayers to pay. We all know text messaging is prevalent among the lower socio-economic classes, that about 90 percent of mobile phone lines are pre-paid. Imposing a tax on it will hit the masa more than those with the capacity to pay more. So why not increase the taxes on items used by those who can and are willing to pay, like luxury cars and jewelry?"

cies supporting consumer rights and interests in the region, has lined up a series of activities to mark this year's celebration of Consumer Welfare Month (CWM) this October.

The annual celebration is in pursuant to Proclamation No. 1098 dated Sept. 26, 1997 declaring the month of October of every year as Consumer Welfare Month. This is in order to promote dissemination of sound consumer information by both public and private sectors, including the media, on subjects such as complaints and policies affecting consumer and encourage dialogue and cooperation among consumers, business and government and broaden the scope of consumer education by heightening consumer awareness.

For this year, the Department of Health (DOH) takes the lead in the celebration of CWM with the theme "Generic Drugs; Gawang Pinoy! Galing Pinoy! Tangkilikin Natin!". The theme is an-

policy area of the national government to protect public health and to adopt appropriate measures to promote and ensure access to affordable quality drugs and medicines for all.

In line with this. the National Consumer Affairs Council (NCAC) and DOH in cooperation with all implementers of the Consumer Act, are expected to join forces in encouraging the extensive use of generic drugs and the promotion of our own Filipino-made generic drugs.

Use Of Deceiving Lights On Market

Goods Now Penalized

BAGUIO CITY - The city government will penalize vendors using "de-ceiving lights" to make their commodities like meat, fish, vegetables and fruits look fresh.

Mayor Reinaldo Bautista Jr. signed Ordinance No. 71 series of 2009 setting penalties for persons guilty of said violation as follows: P500 fine for first offense; P1,000 for second offense; and P2.000 fine and revocation of permit to operate for the third offense.

The measure

which was introduced by Vice Daniel Mayor Farinas mandates the adoption of a "lighting standard" in shops and stalls to support the ordinance. The Baguio

City Market Authority through the marе superintendent's office in cooperation with the city veterinary office was tasked to recommend the best lighting condition to set the said standard.

Farinas said the measure aims to stop the nefarious practice of some market vendors to mask the quality of their products.

Farinas said consumers commonly complain that the fish or meat they meticulously buy from market stalls particularly those that use lights over mounds of

their products but the goods turned out to be not as fresh the moment these were brought home.

"It has been noticed that unscrupulous stall tenders and owners in the Baguio City Public Market have been surreptitiously installing lights that when illuminated especially onto meats and fishes tend to make them appear fresh and a whole lot more appealing to the unsuspecting buyer. Albeit it may also be claimed by innocent stall tenders and owners that they may just have simply installed these deceiving lights without malicious intent, however, this Ordinance intends to put a check to and prevent such sinister practice from persisting once and for all," Farinas noted./ aileen p. refuerzo

Mayor Says Only Legal Stallholders persons **Entitled To Market Spaces**

BAGUIO CITY - Only legitimate stallholders are entitled to spaces at the newly built structures at the city market.

Mayor Reinaldo Bautista Jr. stressed this as announced Thursday the completion of the new market structures that replaced the burnt area particularly the vegproper etable buildings 1 and 2, sari-sari and tobacco sections.

The mayor said the city will allow only those with existing and binding contracts with the city government to occupy the stall spaces starting next week.

The legitimate occupants properly listed in the master list being kept by the city treasurer's office.

Many vendors have reportedly complained claiming they were displaced or uncere m o n i o u s l y stripped of their right to stalls they claimed to have occupied for many years before the fire.

The mayor said the subject

claim to have occupied stalls but are not included in the list may have just been sub-lessees of the spaces rented out by the original stallholders or just plain illegal occupants.

He said it is not the city's responsibility to accommodate them as they have no contracts with the city government. He said on ad

Three Inevitables

In 2010, Benigno Aquino, Salvador Escudero, Gilberto Teoodoro or Manuel Villar may be President. Whoever is elected will inherit, from outgoing (hopefully) President Gloria Macapagal-Arroyo, three "inevitables": death, taxes –and nearly 92 million Filipinos. Populationwise, we'd be 20 Singapores.

Rewind to 1940. The census, that year, informed Preisdent Manuel Quezon: there were almost 20 million Filipinos. Quezon's successor, next year, will have five times that pre-World War II headcount.

Fast forward to 2016. Noynoy, Chiz, Gibo or Manny will step down from Malacanang. ("What about me?", asks Erap, shackled by plunder and murder charges) He will also pass on three "inevitables": death, taxes —and probably 101.6 million Filipinos. We'd equal eight Cambodias then.

EDITORIAL

That's a given. Population growth has a momentum that

ignores presidents, or bishops. Not "all thy piety nor wit shall...cancel half a line," Omar Khayam wrote.

Consider the "youth bulge". Majority of Filipinos are young. With hormones in overdrive, many start families early, despite marriage codes that jack up minimum age. They tarry in reproductive years longer. Family planning services are patchy.

Other Asian nations have completed their "demographic transition". That's when death and birth rates drop, and population stabilizes at lower levels. Have we even started?

The "Asean Twins" offer a case study. Thailand and the Philippines had, in the 1970s, almost identical demographic and economic profiles. Thailand adopted a population policy. We waffled.

Today, there are almost 64 million Thais. Contrast that with 88.5 million Filipinos, our delayed 2007 census tallied. A bogged down demographic transition added 24.5 million Filipinos more. That's almost one Malaysia.

The bitter debate over the Reproductive Health bills, meanwhile, continues. Ironically, both sides agree on key points.

All concur that the cascade of wizened ill-nourished babies, into city slums or rural hovels, short of food, medicine, clean water, etc. is a scandal. This can not continue. Otherwise, we forfeit all claims to being a humane society.

Shrill advocates or opponents of RH bills blur the fact that government and church agree on responsible parenthood.

The Catholic Bishops 2nd Plenary Council, for example, taught: Parents should "beget only those children they can raise up in a truly human and Christian way...The decision on number of children rests solely with parents."

"It is legitimate for government to orient the demography of population," the Catholic catechism says. It can do so by information, but not by coercion or "means contrary to moral law"

All recoil from abortion. Yet, "nearly half a million Filipinas opted for underground abortions, in 2000," notes Dr Mary Racelis formerly of Unicef. Illegal clinics and hilots ply their subrosa trade.


Are abortions up to 700,000 today? No one really knows. But all agree women must be helped to become informed and speak for themselves. Continued neglect would "abet the terrible reality of abortion as the only viable choice open to poor Filipino women."

Both sides agree that families should be educated, including natural family planning methods. Almost a third (27%) of women in the poorest fifth of population want to limit their families.

But they lack access to information and services. These are essential if couples are to make family size decisions responsibly and freely. Pope John Paul II stressed. A "bahala na" attitude spills into unplanned pregnancies and abortions. Children are denied support to realize their God-given potentials.

Bucking artificial contraception is not enough, says the new book: "Natural Family Planning". Practical programs, must replace

Comelec seeks amendment of overseas voting law

COMELEC SEEKS AMENDMENT OF THE OVERSEAS ABSENTEE VOTING LAW: The Commission on Elections is seeking an amendment of the overseas absentee voting law in an effort to entice more Filipinos abroad to register and then ultimately exercise their right to vote in any Philippine election.

According to Comelec Commissioner Armando Velasco in an interview Thursday with BATAS RADIO, the poll body wants to effect a system of registration and voting for overseas Filipinos which will no longer require the registrants to personally appear to be registered and to vote.

"We are looking into the possible use of the Internet or other computerized systems where our countrymen no longer have to leave their homes or their work to register and then vote in their places of residence or employment abroad," Velasco said.

Officials of the poll body have been conducting meetings and dialogues with concerned governmental agencies and private entities to attain this objective, Velasco added.

560,000 FILIPINOS OVERSEAS REGISTERED TO VOTE IN MAY 2010: Right now, there are approximately 560,000 Filipinos abroad who have already registered with the Comelec for purposes of participating in the May 2010 elections under the overseas absentee voting law.

This represents an increase of almost 50 percent from the previous total number of overseas Filipino-registrants which, in 2007, stood at 300,000 more or less. Filipinos in Hong Kong account for about 90,000 registrants, while a great number come from the Middle East. Very few come from Europe, although there is a big number of Filipinos in the area.

Nevertheless, these figures pale in comparison with the estimated number of 15 million or so Filipinos who are in foreign soils, either as permanent immigrants or as temporary workers.

Velasco told BATAS RADIO Thursday the poll body is making an appeal to those already registered, and to the relatives in the Philippines of Filipinos who are abroad, to encourage others to likewise register and then participate in the country's political exercises.

COMELEC NOW FINALIZING LIST OF OVERSEAS FILIPINOS WHO CAN VOTE: Registration for overseas Filipinos who would like to vote in the May 2010 elections was terminated on August 31, 2009, pursuant to law, with the Comelec now finalizing the list of qualified overseas Filipino voters.

But for those who would like to vote in subsequent elections, Velasco said registration is usually carried out at the Philippine consular and embassy offices abroad.

Those who can register are Filipinos who are 18 years old and above and who are Filipino citizens, and who are not suffering from any disqualification as determined by Philippine laws.

The catch however is that, the intended registrants must personally appear in the consular and embassy offices and submit proof of their age and Filipino citizenship, and this is where the problem lies because not many overseas Filipinos would want to leave their work and their homes just to register.

LOW VOTER TURNOUT AMONG OVERSEAS FILIPINOS FEARED: One big problem the Comelec faces here is seeing to it that, of the 560,000 or so who have already registered for overseas absentee voting as of August 31, 2009, many, if not all, of them will actually vote.

The record, Velasco also told BATAS RADIO Thursday, shows that in 2007, only 16.21 percent of the 300,000 or so that registered for that year. In 2004, the percentage of those who

A MYSTERY IN THE GT

In the other Administrative Regions of the country, there is nothing mysterious or even obscure about the Garage to Terminal (GT) Express Service Program of the LTFRB. The Program is open, fully disclosed and widely desiminated for all qualified applicants to avail. But not in CAR or Cordillera Administrative Region, or so it seems.

It will be recalled that as a new mode of land-based transportation service, the GT Express, as extensively explained by the LTFRB to the media and transport operators, was thought of or aimed to provide a more convenient and fast moving service using air-conditioned utility vans, compared to buses and jeepneys and much, much cheaper compared to taxis.

Incidentally, before it was re-named GT Service allegedly as a compliment to the former boss of the LTFRB General Thompson (GT) Lantion, it was first called the P2P or Point to Point Express Service during the reign of his predecessor, Chairman (Reyna) Elena Bautista. Under the present Chairman, Alberto Suansing, there is plan or rumor to appropriately rename the Program to Terminal to Terminal Service or TT Express. Except for a slight difference in the cost of fees to be shouldered by the van applicants, the P2P or the GT or the TT are one and the same banana, In all, three programs, however, nothing was intended to be mysterious or hidden.

Strangely, the GT Express Program as presently implemented under the LTFRB-CAR or DOTC-CAR has become baffling not only to the general holders of Vehicle for Hire CPCs who are sort of mandated to convert to GT Express Service, but also to the concerned public watching on the sideline in case their own interest will adversely be affected by the actualization of the Program.

For one, it now appears that the LTFRB-CAR has already accepted many such applications for CPC under the GT Express Program even in the absence of a Memorandum Circular or similar issuance coming from the Board opening the GT routes and allowing the acceptance of CPC applications for conversion thereof. It also appears that what are being accepted for GT Conversion are applications mostly filed by members of the Cordillera Van Federation Association Incorporated through a lone emissary or staff of one lawyer, hence, other van operators are constrained to seek membership in this Federation. Why?

Further, it appears that these GT applications accepted for filing are being processed by a separate select group of LTFRB personnel specially assigned for the purpose. If this is true, why?

Furthermore, why has the LTFRB-CAR started accepting GT applications when the AD HOC Committee of the City Council tasked to study the GT issue has not even reported its recommendation to the Council? There is only a proposed Resolution authored by Councilor Lourdes Tabanda, a member of the AD HOC Committee who can't wait any longer for the action of its Chairman, recommending the acceptance of only 132 Baguio-based vehicle for hire for conversion to GT Service pending further study and conduct of RMC survey, yet the LTFRB-CAR has been accepting silently these GT applications, why? And probably worse, why would the LTFRB-CAR allow the conversion to GT Service which in effect is a legalization of these vans or vehicles for hire which CPCs were all issued in violation of the moratorium in BLIST between the period 1998-2005 when, on the other hand, it is questioning, investigating and does not approve the renewal of CPCs of PUJs and Taxis which is found to have been issued in violation of the same moratorium I the period from 1996 to 2006? Why? Is this not selective, unfair and unjust?

These are puzzling, if not mysterious, aren't they? Nagtatanong lang naman!

Benguet to conduct CBMS provincewide

LA TRINIDAD. Benguet-A Community-Based Monitoring System (CBMS), a diagnostic tool to assess poverty in the barangay, municipal, city, and provincial level, will soon be carried out in the province.

Sangguniang Panlalawigan in its session held last week granted authority to Governor Nestor Fongwan to enter into an agreement with the different municipal governments for the implementation of the CBMS.

The towns of Kapangan and Sablan are excluded as they have already completed their CBMS.

Rose Melecio of the Provincial Planning and Development Office who appeared before the members of the board said the project entails more than P2 million. The LGUs will also be sharing their

counterparts for the survey.

Melecio said P1million will be allotted from the Provincial Integrated Health Plan while P1.5 million will be shelved from the Provincial Development Fund.

The project will be in coordination with the Department of the Interior and Local Government.

Vice Governor Crescencio Pacalso said the CBMS is a comprehensive undertaking which covers all concerns at the community level and on a larger scale is critical in aid of planning purposes.

Board Member Rogelio Leon, on the other hand, expressed apprehension should the LGUs utilize the data for planning purposes. They might be focusing only on the identification of infrastructure projects particularly in their annual investment

He stressed the

need for paradigm shift at this time not only on infrastructure projects but also on social concerns such as health, education, nutrition.

According to the Philippine Institute for Development Studies, CBMS is an organized way of collecting information at the local level for use of local government units, national government agencies, non-government organizations, and civil society for planning, program implementation and monitoring.

It aims to provide the national and local governments with up-to-date information for policy making and program implementation. In particular, CBMS intends to the informationgaps in diagnosing the extent of poverty at the local level, determining the causes of poverty, formulating policies and programs, identifying eligible program beneficiaries, and assessing the impact of policies and programs./ S.C. Aro/PIA-Benguet

Health Department intensifies campaign Council (AWAC) against HIV/AIDS

BAGUIO CITY - In line with the government's continuing effort completely eradicate HIV/ AIDS in the country, the City Health Services Office -Reproductive Health and Wellness Center (HSO-RHWC), through the initiative of the Department of Health in partnership with Global Fund, is currently conducting HIV/AIDS surveillance interviews on entertainment establishnightspots in the

HSO-RHWC head Dr. Celiaflor Brillantes, in an interview said the Health Department is intensifying its campaign against HIV/AIDS. In the past surveillance is only done on 10 key cities nationwide, but this year it is expanded to 23 sites and also includes other small cities.

For Baguio, the city's HSO-RHWC, in coordination with the city's Aids Watch

has four interviewers who are facilitating the Integrated HIV Behavioral and Serological Sentinel Surveillance System. "The surveillance is on-going and we are on track on achieving our target, aside from the usual night entertainers, we are also focusing on the freelancers (unregistered street sex workers) and the group of Men having Sex with other Men or M S M s Brillantes added.

PMHABBCI bats for mentally Healthy ily Court Judge

TRINIDAD. Benguet - In every situation or undertaking, stress is always there. It depends on how one responds to it, either positively or negatively according to the Philippine Mental Health Association Baguio-Benguet C h a p t e r Inc(PMHABBCI).

If responded negatively, then it is harmful but if responded positively, then one takes this as a challenge in coping with stress, said Dr. Ronald Bandonill, of the National Bureau of Investigation and a member of the Board of Management

PMHABBCI. In line with the observance of Mental Health Month this October, the PMHABBCI held a kapihan forum last week at the Family Court at the Provincial Capitol and tackled "Mental Health in Workplace.'

mentally Α healthy workplace is safe, productive, comfortable, and retains quality staff. A mentally healthy workplace is linked to lower costs, less injury, lesser absenteeism, as well as

lesser turn-over. Inability cope with job stressors is one of the barriers to a mentally healthy workforce according to the PMHABBCI. Stress in the workplace may happen when the requirements of the job do not match the capabilities, resources, or needs of the worker.

Branch 9 Fam-

Francis Buliyat, a member of the Board of Management, identified causes of stress in the workplace such as unclear job description, lack of focus, mistrust and unfair treatment. dealing with new requirements and procedures, random interruptions such as frequent telephone calls, mobile phone, internet, walk-in visits and spontaneous demands from supervisors or too little or too much workload.

PMHABBCI Chairperson Dr. Dionisio Claridad, a surgeon and administrator of the Baguio Medical Center, who shares his experiences as a consultant, manager aside from being involved in extra curricular activities, emphasized time management as a big factor in minimizing stress. It gives one the ability to plan and do things one at a time which eventually becomes habitual.

Newly appointed Judge Mia Cawed, also a member of the Board of Management of the association, stressed the importance of enjoying the benefits of vacation leave. Instead of converting into cash, the employee might as well make use of the leave benefits for the purpose. Doing so produces a high quality output of staff and consequently yields a productive workplace, she added.

Cawed also hinted that visiting a psychiatrist or psychologist is a healthy practice. Having experience in counseling, she also undergoes stress debriefing meaning she unloads herself from stress after dealing with her clients. Otherwise, she gets affected after the session, she disclosed.

Admittedly, Filipinos generally are not yet accustomed to availing of the services of a psychiatrist unlike in the western countries. There is a stigma attached that only those who have mental disorder subiect themselves to a psychiatrist or psychologist according the PMHABBCCI.

Nonette Benett, a media practitioner and also a member of the association cited ways to avoid stressors in the workplace such as maintaining an open communication, giving appreciation and encouragement, giving feedbacks.

Lawrence Adube of the Baguio City Barangay Affairs Office and the secretary of the Board of Management had this to say in coping with stress in the workplace. One must have a good aura, a good feeling towards officemates. If there is anything that bothers laugh it off.

Other ways in coping with stress include taking care of one self, be realistic of one can change, learn to say no, slow down, take one step at a time, be honest with colleagues, and give solutions to problems./S.C. Aro/ PIA-Benguet

Brillantes also confirmed that HIV cases in the city is increasing. Based on data, there are already 35 cases recorded with 17 deaths and the age ranges from 17 to 45 years old. In the first half 2009 alone, they have already recorded four HIV positive cases.

"Another good thing with this surveillance is that, in coordination with the city's AWAC, it is being done side by side with peer education. Aside from the interview surveillance that we are doing, we are also education them on how to protect themselves from getting HIV," Dr Brillantes

Brillantes also bared that for the rest of the year, they will be preparing for the annual HIV/AIDS Conference in December, simultaneous with the commemoration of World Aids Day. RHWC will also partner with the Aids Watch Council for the preparation of other events/activities for the World Aids Day.

In another health issue, the World Health Organization (WHO) assured that there will be equitable distribution of A H1N1 pandemic vaccines once they become available. This was assured by WHO Director-General Margaret Chan, during the 60th Session of WHO Regional Committee for the

Western pacific, which was held Monday Hongkong and was attended by DOH Sec Francisco Duque.

At present, the WHO projects that it will be able to obtain donations and funding for the procurement of at least 300 million doses of vaccine against the AH1N1 virus which will be enough to cover 15% of the population of the developing world./Lito Dar/PIA

Municipal Ordinance No. 39, series 2009 mandates the development of the political history of the town appro-


priating P600,000.00 to be taken from any supplemental budget appropriation.

Based on the result of the study, the facilities if totally rehabilitated can generate a total of 24,680,000 kWh of power annually which if computed based on the "redemption value of electric energy" will be equivalent to \$2,307,580 per year.

The mayor said the positive result gave the city more leverage in its privatization plan.

The study was conducted by the PS PROFI Ltd. Firm and funded by the Embassy of the Czech Republic in the Philippines in the amount of \$28,000.

A summary of the study results indicated that the rehabilitation of the facilities would require a total investment cost computed based on "turnkey basis with using of firstclass equipment" of \$11,602,952. This is divided into civil works rehabilitation which would cost \$6,252,545 and technological part including services at \$5,350,407.

The expected revenue was calculated from the annual energy general of 24,680,000kWh and redemption value of electric energy./aileen p. refuerzo

vantage gained from the market improvement project was that it gave the city the chance to purge the said area of illegal vendors and stem the practice of sub-leasing which is also not allowed by the city government. The project also ensured fairness as all stalls were constructed in uniform sizes

The stalls - numbering 200 at the vegetable section, 56 at the sari-sari section and 20 at the tobacco section will be distributed equitably to the legitimate grantees, the mayor said.

The project amounting P12 million was undertaken by administration to rebuild the burned area where 238 stalls were razed by the fire and improve the façade of the market.

Mayor Bautista earlier assured that the structures to be built will all be temporary or collapsible so these can be easily dismantled should the full-blown market development project be implemented. in deference to the contract with the Uniwide Sales Realty and Resources Corporation (Uniwide) which had been declared binding by the

CBAO head Engr. Oscar Flores earlier assured that the space allotment for the vendors in the structuren was made equitably based on the original area allotted for said sections.

He said the spaces allotted to the vendors are of equal size and that the number of stalls in the plan corresponds to the number of legitimate vendors affected by the fire thus nobody will be displaced.

He said the space extensions made by the vendors themselves were removed in the new structures thus the area of the stalls was inevitably reduced.

Bautista said that in the new building, the city will prohibit the vendors from putting up additional constructions like mezzanines or space extensions./aileen p. refuerzo

DOLE To Give Vending Carts To 100 Ambulant Vendors In Cordillera

BAGUIO CITY - About 100 qualified ambulant vendors in the region will be receiving free vending carts or "Kariton," from the Department of Labor and Employment (DOLE) as it focuses on giving assistance to the informal sector through its "Nego-Kart" program this last quarter of this year.

According to DOLE-CAR Director Atty. Ana Dione. the Nego-Kart program, is project in partnership with the different Local Government Units (LGUs), which aims to assist ambulant vendors in major cities nationwide in making their existing livelihood undertakings grow into profitable and sustainable businesses.

Dione explained THAT the Nego-Kart project may vary depending on the needs of the ambulant vendors in each area. For Baguio City, Dione said they will be initially giving vegetables ferrying carts to vegetable sellers in Baguio and La Trinidad.

"Next month will initially give five vegetable ferrying carts each to five qualified beneficiaries in Baguio and La Trinidad. By December, we hope to give about 30 carts and by March of next year we hope to

achieve our target of giving out 100 carts," Dione said.

Dione said the cost limit for each Nego-Kart assistance is P15,000. A vegetable ferrying cart will cost about P7,000 and the rest will go to beneficiary as a working capi-

The DOLE director also announced that for the last quarter of this year, DOLE will also be giving 20 "starter kits" to small time entrepreneurs, like hair cutters and manicurists to enhance their work.

For the Out of School Youths (OSYs), the DOLE will have the "Kabataan IT" program, an information technology appreciation course wherein former OSYs who graduated from their "Mega-Byte" project will teach a 22-hours basic computer/IT course to other OSYs. "Aside from providing IT appreciation course to OSYs, we will also be giving employment opportunity to the OSY instructor, as we will be providing them stipend of about P4,000 each, for the 22-hour course," Dione said.

In support to the Micro-Small and Medium Enterprises (MSMEs), CAR will be joining the Productivity Olympics next month. Among the entries are the Tartland Pasarabo, Good Shepherd, Baguio-Benguet Consumer Credit Cooperative Inc (BBCCCI) and Carlos Bamboo Crafts (Abra), which Dione said are already practicing good productivity.

Meanwhile, Dione confirmed that the employment rate in Cordillera remains stable, as the latest National Statistics Office Labor Force Survey shows an increase in employment rate nation-

wide.
"Cordillera only has about 677,000 - 700,000 participating in the labor force and it is not even a fraction of 1% compared to the national figure. 
