Eight-Year Old Kid Battling Cancer Needs Blood Donors Michael said. The kid had undergone initial chemo-

Blood donors may find it difficult to deny support to Ethan Marcus Runas, an eight-year old boy who is into his sixth- month fight against acute myeloblastic leukemia, a type of blood cancer that requires frequent transfusion.

"The kid used up 27 bags of blood after his illness was diagnosed last February," his grandfather, Manuel Runas Sr., recalled. "Last month (July), he required 18 bags. "He needs more and we're encouraged to appeal to donors because he wants to continue fighting, saying he won't give up."

The kid's need for lots of blood was first aired last April by his uncle, Michael Elamparo. "Fact is, the kid is fighting hard, something that inspires us to ask the community to help us look for blood donors to boost his fighting chance,"

The kid had undergone initial chemotherapy and will be into his second re-induction phase on August 20- or 21, Runas said. "We hope his hemoglobin count would be stable by then."

The upcoming systemic chemotherapy protocol, prepared by Dr. Jenniel Poyaoan, pediatric resident-in-charge at the Baguio General Hospital and Medical Center, is set for six cycles monthly at P28,210 per cycle, or P169,260.

The boy's blood type is 0+ but any blood type will do as it will be swapped with his type at the blood donors room of the BGHMC.

Donors can go to the extraction room any day between 8 a.m. to 4 p.m. and tell the staff they are bleeding for Ethan, of Cresencia Village Barangay here.

Did Pnoy Secretly 'Tolerate' Pork Barrel? pa ang president ng 'good intentions' and so on. Dito, ano pong good intentions?

President Noynoy Aquino is facing a fourth impeachment complaint—this time in relation to the Priority Development Assistance Fund (PDAF).

President Benigno "Noynoy" Aquino III is facing a fourth impeachment complaint, the latest development as the Justice committee prepares to start the proceedings this week.

Alliance of Concerned Teachers (ACT) Rep. Antonio Tinio says they have "strong evidence to show that President Aquino is responsible for perpetuating congressional pork despite the Supreme Court (SC) prohibition."

Two of the impeachment complaints filed previously tackled the Disbursement Acceleration Program (DAP), several acts under which were declared unconstitutional by the High Court.

As a lawmaker, Tinio endorsed the third complaint, which dealt on the supposedly "blatant sellout of Philippine sovereignty to the United States through the Enhanced Defense Cooperation Agreement (EDCA)."

In the fourth one, Tinio is a direct complainant.

Alleged violation of Constitution

In an interview on ANC's *Headstart*, Tinio says "Nilabag po ng presidente ang konstitusyon at ang batas, and this is totally indefensible. Doon sa DAP, humihirit

pa ang president ng 'good intentions' and so on. Dito, ano pong good intentions? Nagkakaisa po ang lahat na masama ang congressional pork. Ipinagbawal na po ito, pero ipinagpapatuloy pa rin ng Presidente. Bakit? Dahil kailangan niya para ma-control ang Kongreso. Alam naman natin ito ang purpose ng Congressional pork as far as the President is concerned. So nasaan ang matuwid na daan dito?" said Tinio.

Tinio said that the lump sum in the budget previously allocated to the PDAF, was broken up and inserted into budgets of six agencies, like the Department of Labor and Employment (DELOE), Department of Health (DOH), and Commission on Higher Education (CHED).

Lawmakers were then given discretion on the use of these funds within the agencies.

"Everyone can see that there are lump sums. 'Yung dating PDAF na dating P20 billion (mahigit), ang ginawa, they were broken down and inserted into six agencies, including the Department of Labor and Employment, Department of Health, CHED, and so on. What's wrong is that there is an understanding between Malacañang, the secretaries, the heads of these agencies, and Congress, particularly the House of Representatives, that they will have individual allocations from these lump sums. So for instance the CHED, merong 4.1 billion. Tig-14 million ang bawat Kongresista," said Tinio.

Ailing Woman from Pacdal Cries Out for help

Jocelyn Bustarde-Balanag, a 31-year old mother of three, gently asked through text last Monday when her mother's medical plight would be published, saying the family has nowhere and no one else to go to for help, except to go public through the media.

Her mother, Emilda Seguin-Bustarde, 61,was found suffering from end-stage kidney failure last March. Given her age, she was advised to undergo hemodialysis for life, spaced at three times a week, with each four-hour session pegged at P2,200.

The patient needs, at the very least, P6,600 a week. Compared to the total family take, that figure is mind-boggling. Her husband, Herman, 61, gets, at the most, P300 a day as dispatcher of jeepneys bound for La Trinidad, Benguet. Her son-in-law, Orlan Balanag, Jocelyn's husband, earns about P500 a day as jeepney driver.

Working seven days a week, the most the two men of the family could gross would be P5,600, or P600 short of the patient's requirement if she has to survive.

Part of the family's earnings will also have to go to food and other basic needs, including those of Orlan and Jocelyn's

two kids – Prince Dave, 9; and Shane, 2.

"She has only two more treatment sessions to be shouldered by the PCSO (Philippine Charity Sweepstakes Office)," Jocelyn admitted last Monday.

This, despite her mother whittling down her treatment schedule to two times a week to save on costs. The second-to-the-last session courtesy of PCSO was last Tuesday and the last was last Friday, on the fourth shift (8:00 p.m. to 12 midnight) at the Baguio General Hospital and Medical Center.

Emilda and her husband are from Basista, Pangasinan, according to social worker Jennylyn Camsol. They were married in 1972 and raised two sons and two daughters. In search for a better life, the family moved to Baguio in 1994 and eventually was able to build a two-floor, two-room abode at 167 Maria Basa, Pacdal Barangay.

"Awan pang-dialysis na nanang kon (My mother has nothing any more to pay for her next dialysis)," Jocelyn texted. "Mabalin kadi nga isu to isaruno yo nga isurat ti kasasaad na? (Can you set her case for publication?)."

Mayor Sets Grassroots Consultation on ESI

BAGUIO CITY - Mayor Mauricio Domogan will personally visit the site of the planned Integrated Solid Waste Management System (ISWMS) this week for a conduct of another consultation with the people who will be directly affected by the project

The City Government has conducted initial stages of public consultation previously but the mayor stressed the lines of communication between affected residents and the city should remain open in order that public concerns would be bet-

The move is to let the people know that initial site inspection and survey is now being undertaken to ascertain who and how many residents will be affected and what specific area will be developed.

Domogan said, "the affected residents including barangay officials will be involved in all stages of the project which is seen to benefit not only the city but the BLISST.

"We have to explain to them that the new waste system we will be adopting is safe, environment friendly and clean," he

The mayor recently visited a waste facility in Hesperia City, San Bernardino County, California, USA which will be adopted as a component of the planned ISWMS in Santo Tomas here.

Domogan said, "the plant integrates a very advanced technology that will surely change how we perceive waste disposal.'

"The plant has its own segregation component where it separates wet and dry waste, bio-degradable from nonbiodegradables including recyclables, he

A separate dryer for wet waste is also a component of the system so everything

is processed," he said.

Presently, the city is producing more than 360 to 370 tons of garbage per day but the planned Waste-to-Energy plant can accommodate a minimum of 200

Domogan however assured the public that before the project would start, the city will have to comply with all environmental laws and procedures that the Department of Environment and Natural Resources (DENR) would require.

"We will have to undergo the process of securing an Environmental Compliance Certificate (ECC) and all environmental requirements and conditions that the DENR will require and recommend," he

As early as 2009, the City Council has confirmed the Santo Tomas city property as the site for the city's Engineered Sanitary Landfill (ESL) Facility and classified as 'city needs' area.

In 2011, due to the difficulty in putting-up the ESL, the Environmental Recycling System (ERS) was acquired to manage bio-degradable wastes being transported out of the city and converting the same to fertilizer for beneficial

The closure of the Irisan Facility in July 15, 2008 and the eventual haulingout of waste impacted huge costs against the city government prompting city's Punong Barangays to extend support in mitigating costs to the city by practically implementing reduction of wastes at source and mandatory segregation of wastes.

Presently, the General Services Office (GSO) hauls out approximately 122 tons of waste to a landfill in Urdaneta City while the rest are processed by the ERS and recyclable wastes are taken by waste pickers./Paul Rillorta

Athletic Bowl Rehab up for *Implementation*

BAGUIO City - the 14.7 Million repair and rehabilitation of the city's Athletic Bowl will hopefully start this month after the Department of Public Works and Highways (DPWH) said the project is up for bidding here.

The scope of the rehabilitation work was presented to the City Council Monday (Aug. 11) by DPWH City District Engineer Alexander Castaneda, Project Engineer Cesario Rillera and OIC City Buildings and Architecture Officer Johnny Degay.

As explained by the implementing agency, the 14.7 million rehabilitation and repair fund only covers 96 linear meters of the total 128 linear meter bleachers of

Engr. Rillera said,"the project entails the demolition of the entire structure and replacing the same with a more sturdy one that would meet required standards.

"The posts and roofing is dilapidated and we have to replace them with new ones to make it safer but it should be within the budget limit of 14.7 million," he said.

The funding was initiated by Congressman Nicasio Aliping, Jr. recently in time for the staging of the Cordillera

Administrative Region Athletic Association (CARAA) Meet by February next year with the city as host.

Aliping appealed for support to the city council on the immediate implementation of the rehabilitation which he said should start soonest because time is of the essence.

He said, "the development of the Athletic Bowl has long been delayed and that the implementation of the project must be done forthwith for the benefit of those who will utilize the same."

Part of the development will be the construction of multi-purpose quarters below the bleachers mainly for use of ath-

Rillera said, "the spaces will cover at least four spans of the entire bleachers and would house an extension office for the City Environment and Parks Management Office (CEPMO)."

Mayor Lauds DENR Move Denying BCDA Patent Application Over patent application. John Hay The mayor said the patent application

BAGUIO CITY - Mayor Mauricio Domogan last Wednesday lauded the Dept. of Environment and Natural Resources Cordillera (DENR-CAR) for taking the cudgels for the city government in denying the application of the Bases Conversion Development Authority (BCDA) for special patent over Camp John Hay in deference to the city's 19 conditionalities on the development of the former military reser-

"We are very thankful that DENR-CAR Regional Executive Director Paquito Moreno Jr. for taking the lead to inform the Land Management Bureau (LMB) of these conditionalities and that these conditionalities should not be violated and instead should be complied with," he said.

The mayor took to task BCDA for the special patent application made under the nose of the city government.

"It's good that the DENR-CAR made that stand because if not and Camp John Hay is patented, then the city will lose its right over John Hay and they will have full control over it. Perhaps that's what they want to achieve so they themselves could sell the lots within the camp," the mayor

With DENR-CAR's intervention, the mayor said the LMB will not be able to facilitate the requirements for the special

is the latest in a string of surreptitious acts of the BCDA in blatant disregard of the city and its conditionalities following its application for water rights over the water sources of three barangays inside the camp, the alleged extension of the contract of lease to the Ayala company for 75 years and a string of other underhanded moves.

We are really saddened. It's very unfortunate that they are doing this to the city. They who claim to be our partners in development," he lamented.

The mayor also took exception from BCDA's statement making it appear that the city was not cooperating in the bid to collect the unpaid shares from the Camp John Hay Development Corporation

He said it was a fact that the city made efforts for both the BCDA and the CJHDevCo to achieve an amicable settlement which the city mayor even brought up in a meeting with the executives of both parties but it was not heeded.

"Instead, they went to court and the matter is now subject to arbitration where the same process of settlement as we have suggested is now being done," the mayor

He said BCDA should stop making unfounded statements against the city and instead answer the city's questions and

Youngsters' tomorrow

Filipino Catholic youngsters will join delegations from 29 other Asian countries this week when Pope Francis launches the Sixth Asian Youth Day ceremonies in South Korea.

"This will be a dialogue with Asian youngsters in their own continent, where some 720 million of them live," writes Han Hong-Soon, South Korea's former ambassador to the Holy See. The visit's motto—"Arise and shine"—is from Isaiah and underscores the role of the youth in transmitting their faith.

Francis will beatify, at an Aug. 18 Mass, 124 Korean martyrs from the Catholic Church's first entry into this East-Asian nation in the 18th century. Lay people were its first evangelizers. French missionaries arrived a century later. That markedly differs from the Philippine pattern where priests landed with Ferdinand Magellan in 1521 in Cebu.

Over 10,000 Koreans were martyred for their faith in the local church's first two centuries. In 1925, Vatican beatified 79 of them, and another 24 in 1968. John Paul II enrolled all 103 in the calendar of saints during his 1984 visit to Seoul. "Blood of martyrs, seed of Christians," Tertulian wrote at second century's end.

In South Korea today, Buddhists make up 23 percent of the population. Christians account for 18 percent, with Catholics constituting 11 percent. And 46 percent say they have no religion.

North Korea persecutes adherents of all faiths. Pyongyang "continues to severely restrict religious freedom for its people," the State Department said in its 2014 annual report released late July. "Government bans all religious activity, except for officially recognized groups that it tightly supervises," says the latest International Religious Freedom Report.

So do other countries, including Myanmar, China and Saudi

Arabia. Francis has other martyrs on his mind. In Iraq, 100,000 Christians are now refugees from the new caliphate decreed by the radical Islamic State of Iraq and Syria.

The Korean Catholic Bishops' Conference earlier expressed hope that Pope Francis' visit to the peninsula will help relaunch the reconciliation process between the two Koreas. North Korea declined an invitation, sent by church officials in the South, to send Catholic believers to a reconciliation Mass to be offered by Francis on Aug. 18. In a letter, the North's state-run Korean Catholics Association (KCA) cited Seoul's refusal to cancel a military drill with US forces. "Coming to Seoul would be an agonizing step," KCA wrote.

If present trends continue, more than half or 56 percent of the Korean population could be Catholic adherents by 2044, a Buddhist research institute forecasts. By then, "the Catholic Church could well be the largest religion in Korea in the near future."

The world backdrop provides a needed context. Over the past century, the Catholic Church has shifted southwards, notes the New York Times. In the 1900s, two thirds of Catholics lived in Europe, symbolized by spires thrusting skywards from various religious shrines located in Notre Dame and Mont Saint-Michel and like places.

Since then, and especially since the 1960s, Catholicism has been moving south. Latin America's Catholics will rise to 600 million within two decades. In Francis, Latin America has its first pontiff in over a millennia. But the number of Catholics in Africa have grown at a rate of 6,700 percent, says John Allen in his book "The Future Church."

"In Western Europe, millions of Catholics are church members but only in the technical sense of having been baptized; they never darken the door of a church, and don't support official Church policies on issues of morality or sexuality," Philip Jenkins notes in "Gone South," an article he wrote for the New Republic. "By 2050, according to projections, Africa will have far more Catholics than Europe with only 15 percent Catholics," he says.

Jenkins also believes that the Catholic Church will remain the major player in the world's spiritual economy but "The Vatican is now in the wrong location. It's 2,000 miles too far north of its emerging homelands."

Part of Korean Catholic clout is due to its leadership role in justice, human rights and other social issues that spun off from Korea's rapid economic surge

Under authoritarian regimes (1960s-1980s), the church stood on the side of the poor and the oppressed, promoting their human rights by words and actions, writes Ambassador Han. It continues to sustain charitable works for the needy. Thus, the church in Korea is recognized for "its prophetic role, both within and outside the country, as a champion of human rights, and a moral reference point in Korea."

There is another unnoticed indicator: Since the 1980s the church in Korea has sent 834 missionaries abroad. A breakdown tallies 181 priests, 621 sisters and 32 brothers serving in 78 countries on all continents, Gerard O'Connell writes in an article titled "Korea Gets Ready to Welcome Pope Francis to Asia" in the Catholic magazine America. "So it has been transformed from a missionary-receiving to a missionary-sending church," he adds.

Filipinos will see Francis close up when he visits the Philippines come January 2015. He asked that meetings with survivors of Supertyphoon "Yolanda" in Eastern Visayas and earthquake-devastated Bohol be given priority by a local church with emerging leaders more of his mould.

"Faith is not a light which scatters all our darkness," Francis says. "But a lamp which guides our steps in the night and suffices for the journey."/Juan L. Mercado

JULIE, framed by how incumbent PRESIDENT AQUINO does his thing today, asked both Gabby and I how it was, working close-in with former PRESIDENT RAMOS and former PRESIDENT ARROYO. Of course we were reminiscing and candid, although a bit restrained on details for obvious reasons. We obliged the curious group a few snippets but not that much. I mentioned several and GABBY dished out a few, although we were both conscious that things that we learned in confidence during official functions in the past—were, to some extent appropriate, ours to keep and cherish.

MAR ROXAS — Then, talk riveted, inevitably ((what else?) on SEC. MAR ROXAS. Opening the salvo, JULIE naughtily asked what in heaven's name moved SEC. MAR to propose another 6-year term for P-NOY. Julie had that charming, inquisitive way of wiggling information that one couldn't usually resist. GABBY, who was presidential political adviser in previous capacities, initially hesitated and was more interested to know more about VILLA MEDICA's FCT due to his congenital and still recurring back pains after several surgeries, the latest done no less by his surgeon identical twin brother, DR. RAFAEL, chief orthopedic of MEDICAL CITY. But JULIE wouldn't give up. GABBY eventually relented and said that MAR's latest mouthful on giving PRESIDENT AQUINO an additional 6-year term may be hazardous to his political health as it could be construed as an indication — or his own admission — that amending the Constitution and getting P-NOY win another term is easier to achieve than a MAR ROXAS victory in 2016. And Gabby was not saying it with tongue in cheek. Knowing his good instincts in these matters, I conceded to his analysis.

DENR Implements Us\$63m Watershed Protection Project in CAR

TABUK CITY, Kalinga - The Department of Environment and Natural Resources (DENR) will implement the US\$63 million Integrated Natural Resources and Environment Management Project (NREMP) within the Upper Chico River Basin (UCRB).

UCRB covers a total watershed are of 454,621 hectares in the municipalities of Tinglayan, Lubuagan, Tanudan, Tabuk, Balbalan and Pinukpuk in Kalinga; Bauko, Barlig and Bontoc in Mountain Province; Conner in Apayao; and Tuao in Cagayan including a small part of Hungduan in Ifugao and also in Benguet.

Portion of sub-watershed areas in some areas are covered as these are tributaries of the Chico River- Barlig and Tanudan because of the Tanudan River, Balbalan and Pinukpuk for the Saltan River, and Conner for the Matalag River.

Severino Dalutag, OIC provincial environment and natural resources officer, said the project will be implemented from 2014-2020 and expected to generate hundreds of employment opportunities from its four component projects with 30 percent women involvement.

The four project components are river basin and watershed management and investment planning; small holder and institutional investments in forest protection and conservation, reforestation and improvement of rural infrastructure; strengthening of river basin and watershed management capacity, and project management and support services.

Development interventions are natural resources management through reforestation, assisted natural resources regeneration, sustainably managed natural forest, agro-forestry, and commercial tree plantation aimed in the long-run to mitigate climate change

Small infrastructure are access roads rehabilitation, communal irrigation, potable water system, trading center; on livelihood investments are micro, small and medium size agro-agribusiness, post harvest management, micro credit, seed fund, and conservation of farming practices.

Dalutag said the source of fund is a loan from the Asian Development Bank, International Food and Agriculture Development, Global Economic Fund, Climate Change Fund, DENR with local government units covered and land owners equity.

The INREMP will be launched on August 12 simultaneous with an orientation with stakeholders on the project and the organization of the provincial watershed management council/JDP/PAB-PIA CAR, Kalinga

City Employees to Undertake Stress och Conducts Contingency Planning and Hazard Assessment in Baguio-Benguet

BAGUIO CITY - The Office of Civil Defense - Cordillera (OCD - CAR) recently conducted contingency planning with Baguio barangays and hazard assessment in the nearby town of Tuba, Benguet in line with their efforts to ensure safer and disaster resilient communities in the region.

Last August 5 and 6, through the initiative of the Department of Health (DOH – CARO), and in coordination with the City DRRM Operation Center, OCD spearheaded a contingency plan workshop at the Prince Plaza Hotel here.

The activity was attended by around 80 officials from seven Baguio barangays namely City Camp Proper, City Camp Central, Lourdes Extension, MRR Queen of Peace, Lower Rock Quarry, Middle Rock Quarry, and Gen. Emilio F. Aguinaldo.

OCD Regional Director Andrew Alex Uy, in an interview, disclosed that the contingency plan workshop is a forward planning process for a worst case scenario for a specific hazard which can build the organizational capacity of local communities, in terms of disaster risk reduction and management initia-

"It is the purpose of Republic Act 10121 (Philippine DRRM Act) to mainstream a safer adaptive and disaster resilient community towards sustainable development. The local chief executives leadership and political will is a crucial aspect to it. Likewise, bottom-up participation is also significant to increase awareness and strengthen multi stakeholders' partnership", he added.

Meantime, the OCD, in partnership with the Mines and Geo-Science Bureau of the Department of Environment and Natural resources (DENR – MGB) and the Tuba Municipal DRRM Office, conducted a site inspection of a reported sinking area in Camp 3 along Kennon road last August 8.


The team specifically inspected the Kiangan Village along the highway wherein households therein reported damaged and cracks in the homes and the visibility of un-leveled ground.

Uy shared MGB Geologist Ronnie Fortez findings that the area is an old landslide deposit so there are chances that the water from the mountains may sift underground which caused the ground to sink.


For recommendation, the inspection team stressed the need to improve the drainage system in the area, to avoid construction of houses in high steep slope and in building houses the team suggested the acquiring of permits and in building strong foundation for houses.

OCD also scheduled an information education campaign for the barangay on August 14 wherein they will award a "Batingting" (bell) early warning device to the community.

Uy also called on the public to be always reminded that instead of viewing disasters as an effect of physical hazards, people must look at it as a reflection of human vulnerability or the characteristics and circumstances of every community./JDP/CCD - PIA CAR

Climate Change Advocacy in Benguet Centers on Partnership

LA TRINIDAD, Benguet - It takes a partnership in pushing for a cause. This is what a group of stakeholders are into in an advocacy project on climate change in the province.

The advocacy is anchored on the theme, "Nagbabago na ang Panahon, Panahon na para Magbago", with the purpose of changing people's mindset due to an urgency for a call to action to climate change which accordingly is beginning to transform life globally.

In the partnership project between the Department of Environment and Natural Resources (DENR) and the Philippine Information Agency (PIA) cascaded from national offices down to regional and provincial level, forging of partnership among stakeholders locally is recognized as a scheme to boost the advocacy in the province.

In the initial engagement of the Provincial Environment and Natural Resources Office and the PIA for the project with the provincial government, Governor Nestor Fongwan found it more fitting to expand partnership with the private sector and suggested the inclusion of SN Aboitiz Power – Benguet, Philex Mining Corporation and the Jaime V. Ongpin Foundation, Inc. apart from the academe such as the Benguet State University and schools under the Department of Education.

Fongwan recognized the inclusion of private sectors as they are actively engaged and have mainstreamed environmental projects as part of their corporate social responsibility.

Schools as target audience is appropriate according to Fongwan saying "it is good to start them young" in inculcating values that impact on climate change.

The project was launched August 1, 2014 through a Memorandum of Agreement among the partners even as some of the project components already took off such as the Speakers Bureau Training held on July 24-25, 2014 and a seminar workshop that empowers youth as volunteers under the ASEAN Youth Volunteer Programme conducted on July 31 to August 1.

The provincial government is very supportive and has been advocating environmental programs even prior to the climate change advocacy campaign. It has been involved in reforestation projects, massive information campaign on the use of indigenous farming practices, information education campaign on climate change through various means, disaster risk reduction management among others.

On the other hand, the Benguet State University has engaged its Climate Smart Agriculture Center for the project apart from the technical assistance extended.

Other line up activities under the project are for a with elementary and high school students, the community and the general public as target audience. To equip the pool of resource speakers, Octavio Cuanso, PENRO Officer In Charge initiated the Speaker's Bureau training.

The BSU will also spearhead the crafting of modules for the various types of audiences this first week of September. There will also be the production of complementary materials such as video and information education material production.

Also scheduled in the last week of August are forum in some schools by the Pilipinas Natin, the volunteer arm of the Presidential Communications Operations Office, tapped to to help in the social mobilization aspect of the project.

Must have no unsettled or outstanding obligation to the cooperative during his membership in the cooperative whether personal or commercial or industrial connection of which he or she is the owner or a co-owner; An unsettled or outstanding obligation is an account which has not been paid within seven (7) days after the due date. For incumbent members of the Board who will seek reelection, unsettled or outstanding obligation includes power bills, cash advances, disallowances (including NEA Audit Findings; and materials and equipment issuances. At an y given time during his membership in the cooperative, he or she must be totally free of any unsettled or outstanding indebtedness and/ or disallowances with the EC.
 - B. Has not been apprehended for electric pilferage;

A mere apprehension of electric pilferage by the E.C., even without conviction for such offense by any court, shall be a valid ground for disqualification. Doubts about hooking up with Binay

Roxas said he remains committed to President Aquino's plans and programs for the country, which the opposition has repeatedly questioned.

He also said the LP remains intact following Binay's statement that he may be taken in by the Liberal Party as its guest candidate.

"Hindi ito tungkol kay Mar o Jojo sa 2016. Ang pinakamahalaga ay ang pagpapatibay at pagpapatuloy ng Daang Matuwid," Roxas said in a statement.

He added, "Napakalinaw naman na hanggang ngayon, salungat na salungat ang agenda ng [United Nationalist Alliance] sa agenda ng Daang Matuwid na siyang itinataguyod ng LP."

Roxas said he will accept and support the President's choice as standard-bearer whether it be him or someone else.

date of the President, there may be a need for them to convene themselves into a Constituent Assembly to amend the Constitution and allow the re-election of the president and the vice-president.

"Contrary to speculations, President Aquino has not conveyed any intention to stay in power beyond 2016 and in fact, he is already in a hurry to finish his term and live a normal life. There is, however, a great number of his supporters especially in Congress, me included, who thinks that he needs at least one more term to fully complete his mission to turn the Philippines into a First World nation," Trenas said.

He explained that a President cannot complete all his pro-people projects and programs within the sixyear mandate provided by the 1987 Constitution

"In the case of President Aquino, there is still a lot to be done for him to be able to finally reach the objectives of his Tuwid na Daan governance, and he might just need another term to do it. The cycle of boom and bust is always upon us if we cannot have consistency in leadership," he said.

He noted that even Sen. Nancy Binay, daughter Vice-President Jejomar Binay who declared his plan to run for president in 2016, and some business leaders also expressed belief that for a sitting President to achieve his or her goals, he or she should be given more than six years to lead the country.

many ways nowadays. I worked with him in the Arroyo cabinet, although we've met only during cabinet meetings and some common events. As we all know, he had been lately the object of bashing in almost all fronts, from the newspapers, TV, social media and even my chat with the taxi drivers in Manila. His controversial handling of "Yolanda" and the Zamboanga City seige still reverberate and we need not rub more salt on them. I just viewed a video posted on FACEBOOK showing SEC MAR, in dishevelled appearance, apparently enjoying himself while directing and unwinding traffic in some Manila street during a traffic tieup, but the comments of netizens were disparaging. It was posted obviously to jeer and put him in bad light. This is not to mention negative comments on other cases like how he wrongly handled the hammer when a photo showed he was helping repair a chair or how "EPAL" he was carrying a sack of rice on his shoulders. Oh so many of those. Then recently, I thought I saw a good break for him for a change. For a while I thought the recent release of PNP elements by the NPAs in Surigao was something positive to his credit that could break the jinx of bad press for him. I thought it could even be a signal of the thawing of the long frozen peace talks with the CPP/NPA/NDF. But, alas, only for me to later read the public complaint of Surigao Gov. SOL MATUGAS openly and strongly criticizing SEC. MAR for allegedly "short circuiting" the local provincial crisis committee. My heart sunk for him. Although the Matugases are LP's, the governor was saying things about not supporting him if he goes for the presidency.

THE MAR I KNEW — I have a few personal unforgettables with SEC. MAR when we worked up close while we were in the Arroyo cabinet. I could tell, with his experience as a banker/trader in the US before he joined government, that he had a natural, keen, no-nonsense economic eye for things. Well bred and well-endowed in leadership genes and resources, his competence was immediately evident. He was a warm, back-patting type but at times showed signs of not being able to personally connect. And yes, some sincerety issues to boot. I saw him how he worked hard to re-start the moribund Iligan steel mill in Iligan City that gave a sudden spurt to the local economy (although the mill is again back in the doldrums now.) He was at home being DTI secretary where his competence and interests were best suited. From all accounts, he is a decent man. When he started showing signs that he was lusting for the presidency, things radically changed.

MY REMOVAL —The last time I talked with him in person was in 2010. Let me recall that "unforgettable" with him. He came to General Santos City to open the annual Tuna Festival in September of that year where I was also scheduled to attend and address in my capacity as chairman of the MINDANAO DEVELOPMENT AUTHORITY. It was 3 months into the AQUINO administration and although I

had a fixed tenure to serve for 5 more years and was still willing to continue serving until 2015, I had expressed earlier my intentions to Malacanang to voluntarily relinguish to give the new president the option to choose who would be his own point person for Mindanao. I recall I was already in the venue of the event when I got a call from SEC. MAR that he wanted to talk to me in private before he would deliver his keynote speech. In that meeting, he told me he had to quickly see me because it was already when he was in the plane enroute to Gen. Santos City and while reviewing his prepared speech that he saw for the first time that in one of the paragraphs, he would be announcing that I would be replaced as chairman. I remember him telling me that he took the special efforts to see me because "Kumpare kasi kita" (he stood wedding sponsor to my son Jay). He seemed to send the message that he had no hand in my being terminated from service. However, I doubted very much his story because I had previously learned that he took charge of Mindanao for the new president during the early transition phase. Moreover, since I had the good sense of voluntarily offering to relinguish earlier in a formal letter addressed to the President, I thought I deserved a simple civil letter of officially informing me of the palace decision. And not being peremptorily removed by a public announcement with me as part of the audience. I thought wrong! (AFTER that Gensan City event, a Malacanang letter was sent to me so kindly thanking me for my long service to Mindanao and telling me I was being replaced.) But, yes I was greatly relieved that MAR took the effort of sparing me the public embarrassment of being publicly removed. So I skipped going back to the venue and promptly motored back to Davao City quietly disturbed by the impropriety of it all. And so my "kumpadre" MAR ROXAS merrily went on with his speech that day.

In that meeting that lasted for an hour and 45 minutes, Aliping explained that he was appointed as Chairman of the local Liberal Party on September 1, 2013 by then Acting President Emilio Abaya. Aliping presented documents as proof of his chairmanship. While most members recognized Aliping's leadership, Go (who ran under LP and was the local LP chairman before Aliping's appointment), noted that he thought he was still the Chairman, not until he was informed of the new leadership. He claims he was not informed of the change in leadership by the national headquarters. Yangot explained that when the Congressman took his oath as member of the Liberal Party, he being the highest ranking elected official of the City Baguio, will automatically assume as the Party Chairman. Aliping ran for Congress as an independent candidate, thus, a source said he is not beholden to any party and is free to join any political party of choice.

So while the party leadership was put to rest, the party membership has to decide on one pressing issue affecting not only the party but the City in general. That is, who will be the party's nominee to fill in the vacant seat in the City Council.

It is noted that a letter dated as far back as May 6, 2014 was sent to President Aquino nominating Mark Go for the position. A week after, on May 12, a meeting was supposedly held for the party's confirmation of Go. This supposed meeting was however put into question by Mrs. Lilia Yaranon (former Baguio City Councilor and former Baguio City First Lady) stating that the meeting did not take place, rather a letter being presented confirming Go as nominee. Yaranon, for her part said that on that occasion, she mentioned her interest as a nominee.

While Bilog, and others stressed that Go's nomination was done in "good faith," other members are also saying that the said nomination is dubious, and recommended due process. Despite the lack of unanimous feel, Bilog moved for the confirmation of Go which Go himself pushed stating "I'd like to follow the motion of Vice Mayor Bilog, endorsing me as the nominee of the party to be approved by the President of the Liberal Party in Manila and this will be submitted to the Office of the President for his formal appointment."

Noteworthy is Atty. Jose Molintas' dipping his finger into the matter (he being a non LP member), stating that the party should nominate Go and that Aliping should just take a leave from the party and "focus on the pending case against him." An observer in the meeting (who requested anonimity) questioned Molintas' motives saying it is improper and unacceptable for him to make such comment in private political party meeting where he is not a member of.

With some objecting Go's nomination, and with some others wanting to be in the nomination list, the Congressman decided to elevate the matter to the LP Headquarters for decision and nomination. It has to be noted that the local party itself is not clear on the nomination procedure (who nominates, who decides, etc.).

Not getting what they wanted, Go's supporters (more or less 130 heads versus a handful of legitimate LP members) started to jeer at the congressman, booing him until he was seen off the door. The Congressman did not say a word, decided to just smile at the jeering crowd as he left. "Most of Go's supporters are supposed to educated, but with what they've shown and what they did, I lost my respect on them," an observer said.

The Congressman, in his letter to the Liberal Party National Headquarters dated August 12 said that "Go's single-minded pursuit of the party nomination...has created disunity and dissension within the

Baguio City Chapter of the Liberal Party." He also said he "vehemently objects" to Go's nomination.

Sources also said that there is a standing political tradition that if a family member of a deceased political leader (in this case the family of the late Vice Mayor Daniel Farinas) indicates intention to be among the nominees, this is given weight and consideration as a courtesy to the deceased leader. An unnamed source said that the widow of the late Vice Mayor (who is currently a Punong Barangay) has indicated interest as a nominee

'Keeping PDAF secretly'

Tinio also alleged the Aquino administration's proposed budget still has "a policy of keeping PDAF secretly" while publicly saying they are following the SC decision barring the use of pork.

Tinio offered proof in the form of statements made by DOH Undersecretary Janette Garin and CHED Chairperson Patricia Licuanan.

For instance, Tinio says, Garin reported that the DOH got rid of walk-in patients.

"Kapag may nagwalk-in sa public hospital, 'di nila tatanggapin. [So] you go to the office of the Congressman. Kasi, sabi nga niya dun, it was made clear to that they are funds of Congressmen. Incontrivertible," Tinio says.

Due to this seemingly embedded system, Tinio says accesing health services has become politicized: "Kailangang may padrino ka muna bago ka maka-access ng basic services."

PNoy keeps calm

Despite these developments, Communications Secretary Herminio "Sonny" Coloma Jr. said the President is not bothered by the start of the impeachment proceedings against him.

In an interview with radio dzRB, Coloma said Aquino is confident he has not done anything that would warrant an impeachment and removal from office.

"Hindi po nababahala ang Pangulo doon sa mga proceedings na 'yan dahil panatag naman po siya na wala siyang nagawang ano mang impeachable offense," he said.

According to Coloma, it would be best to leave the process to the House of Representatives, which is mandated under the Constitution to assess and eventually proceed with impeachment cases with merits.

The first three complaints

Last month, three impeachment complaints were filed against the President.

The <u>first</u> was endorsed by Bayan Muna and Anakpawis lawmakers, while the <u>second</u> was endorsed by the Kabataan Party-list. These complaints were in connection with the DAP.

The <u>third</u> impeachment complaint was in connection with the government's Enhanced Defense Cooperation Agreement (EDCA) with the United States

According to Councilor Datuin, ten (10) days after the receipt of the approved resolution would be enough for the BFFI personalities to submit the income statement and expenses of the past flower festivals. We are not requesting for the summary of income and expenditures as submitted to the Securities and Exchange Commission (SEC), Datuin emphasized.

The resolution asked that the fund subsidy worth P4M from the city for the festivals should be audited, as those from other sources. Funds from the use of Burnham Park, Session road in Bloom, Athletic Bowl, advertisements and other income should be included in the audit, the resolutions also stated.

It should be known if the flower foundation is making money or if there is a need for additional, Datuin also said earlier.

This resolution is a reiteration of earlier requests from the council, Datuin clarified.
