A closer look at Baguio City's Postal Office

A Proposal to Revive Post Office,

Postal Museum

Baguio City - The cluster of eateries, snack-stops, cell phone load centers, parking lot rentals, posters, and tarpaulin ads along the Baguio Post Office's has become one of the reasons why a proposal to abolish the commercialization in Baguio Post Office and revive its original colonial architecture is being laid out to the public.

The proponent of the proposal is Media Specialist Art Tibaldo who first presented such proposal in Social Media recently this month. He said that since the supposed privatization of the place by the Philippine Postal Corporation, Post Office Cooperatives rented out some areas to these business settlers. But the public has slowly referred to the edifice as an eyesore that lies at the heart of the city. That's why Tibaldo is urging the public to support his proposal of declaring Baguio Post Office as a historical site by the National Historical Institute (NHI) and turn the Post Office into a Postal Museum. Having it declared such will make the Post Office be free from commercialization, and instead use the area for expansion of a Postal Museum. Cont. on page 7

Lawmaker Reiterates Proposal Kidney Ailment Dashed for CCT II Program to Battle **Increase in Hunger Incidence**

Senate minority leader Alan Peter Cayetano expressed alarm over the recent Social Weather Stations (SWS) survey that revealed that 3.9 million families experienced hunger in March.

The poll, conducted from March 19-22, noted an increase in the number of Filipino families that went hungry from last December's 16.3 percent to the present 19.2 percent.

Cayetano stressed that the government should now focus on ensuring that all Filipinos feel the country's stellar 6.6 percent GDP growth. "In 2011 alone, the government was successful in creating 1.156 million jobs. This is truly a good start. Now we need to build on this," he said.

Cayetano had earlier suggested that the government enact a second-tier program complimentary to the Conditional Cash Transfer (CCT) program currently in effect.

"The program will cater to working class people in need to capital to start their own business," he said as he suggested a procedure wherein a simple certificate indicating that a person has gone through a livelihood seminar would be enough to allow a borrower to avail of a loan grant.

Cayetano explained that enabling the growth of the small and medium enterprise (SME) industry in the country will is one surefire of ensuring that Filipinos will have the means to take advantage of the country's economic gains and provide a decent life for their families.

"Through the CCT II program, we will be able to teach Filipinos to "fish" rather than simply giving them fish," he said./ Office of Senator Alan Peter Cayetano

Mayor Cites Additions for City's Environmental Code

BAGUIO CITY the city's commitment in protecting its remaining forest reserves from degradation is a key component of 'Baguio's Environmental Code'.

Mayor Mauricio Domogan during the Weekly Ugnayan Presser Wednesday said, 'an important provision of the code should be the protection of watersheds and forest reservations in the city.

Domogan said, 'important areas in the city are already titled under ancestral claims which he said remains to be the city's biggest concern.

'The National Commission on Indigenous Peoples (NCIP) has issued titles covering portions of Forbes Park Reservation, Wright Park, Botanical Garden, Busol Watershed and Loakan Airport,' Domogan stressed.

Domogan further stated, 'his administration is not opposed to legitimate ancestral land claims but only those which are questionable.

'Let us work together to protect these areas which serves as the only remaining forest cover which our children would inherit, 'he

Domogan also said, the code should have a provision for a rain harvesting facility for structures and buildings which will be erected in the

He said, 'the city should not issue building permits to those who do not have this facility included in their plans.

Jeffer Udani, now 28, had wanted to be an Dream architect. To pursue that dream, he worked

as cook for seven years at the Chowking branch in Candon, Ilocos Sur. In 2011, he came up to Baguio and enrolled as a second year student at the University of the Cordilleras.

Life, however, sometimes gives one less than lemons. The second of five children of a former sampler at the Acupan Mines in Itogon, Benguet, Jeffer was diagnosed for kidney failure in January last year. The diagnosis came after he began throwing up and his vision blurred.

That means three times a week hemodialysis treatment. It's a life-time routine, for a machine to do what his failed kidneys used to do, which is to clean the blood of liquid waste, to prevent blood poisoning.

A few cleansing misses can prove fatal.

"When we could not raise the cost, he would skip a session or two," his mother, Evangeline, said last week. "His dad (Oscar,54), who was retrenched in the 1990s when Benguet (Corporation) closed its mining operations in Itogon, had no choice but to go home to Cagayan and work as a tricycle driver."

Jeffer, his mother and sisters Jade Cyril, 10, and Jazlyn, 7, are left in Baguio. They stay with their eldest brother Jaycar, 30, a jeepney driver who plies the route to Dominican-Mirador. Together with Jaycar's family, they live in a two-room affair at Malaya St., Dominican-Mirador.

Evangeline, a native of Sta. Cruz, Ilocos Sur, would have done odd jobs if only she's not occupied working out support to sustain her son's blood-cleansing sessions at the renal center of the Baguio General Hospital and Medical Center.

A four-hour session costs P2,200, so hard to come by nowadays for a family who had long experienced donor fatigue.

Last Monday, however, Evangeline found pure relief. The office of Rep. Bernardo Vergara approved a foursession support to Jeffer. It has given her mother respite from the daily grind of knocking on doors and hoping a Samaritan would open and respond.

As in previous cases of people needing people, there are Samaritans out there. They may ring up Jeffer's cellphone number 09159206220 or visit him during his hemodialysis schedule at the BGHMC from 3:00 or 4:00 p.m. on Tuesday, Thursday and Saturday.

Only recently, donors out there gave fresh hopes for Crisly Anayasan, a 21-year old boy have waited for years to undergo surgery at the Philippine Heart Center to mend a congenital heart ailment.

Responding to the appeal of the boy's mother, Emilia, an anonymous Samaritan had his secretary hand to her P15,000 while another civil servant added P2,000. The support will enable Crisly to continue his pre-surgery check-up at the Heart Center next week.

Previous travels to the Heart Center were supported by Shoshin Kinderhilfe, a foundation reaching out to sick children

Standardized Testing Benchmark, **Procedures Eved for** Private, **Emission Smoke Testing Centers**

BAGUIO CITY - The city government will push for the standardization of the testing benchmarks and procedures in the conduct of smoke emission tests for adoption by both the government and private testing centers.

Mayor Mauricio Domogan said this was the agreement reached to put to rest the doubt and questions on the credibility of the city's Roadside Inspection, Testing and Monitoring Team (RITMT) operation which the mayor suspended recently.

City environment and parks management officer-in-charge Cordelia Lacsamana said they are now framing the guidelines for the synchronized motor specification engine particularly the average maximum RPM (revolutions per minute) standard of vehicles during the testing and procedures in the conduct of the tests in collaboration with the Land Transportation Office and the Technical Skills Development Authority (TESDA) representatives.

Once finalized, these guidelines will be contained in a memorandum of agreement to be signed by all the stakeholders including the transport groups, line agencies and the private emission testing centers for implementation.

Lacsamana said the guidelines will address the tachometer requirement which came out as one of the causes of the disparity between the city RITMT test results and those of the private

Domogan said they also agreed that the transport group and private testing centers will be given representation in the RITMT committee to involve them in the emission testing concerns.

He said the city will resume the RITMT operations Cont. on page 7

Baguio Adjudged Anew as One of Country's Top Ten 'Next Wave Cities' BAGUIO CITY – Baguio was adjudged anew as one of the Top Ten

Next Wave Cities in 2012 that makes it a "preferred destination for Information Technology Business Process Management (IT-BPM) operations."

The top ten rating was conferred by the Information and Communications Technology Office (ICTO) of the Dept. of Science and Technology (DOST) with the Information Technology and Business Processing Association of the Philippines (ITBPAP).

Mayor Mauricio Domogan welcomed the award which he said affirmed the city's emerging status as an information technology hub in the country.

The city was first included in the Next Wave list in 2010 when it ranked ninth among the preferred sites for BPO business

The award was received on behalf of the city by city planning and development officer-in-charge Evelyn Cayat and Dept. of Trade and Industry (DTI) provincial director Freda Gawisan last May 20 at the Dusit Hotel in Makati City.

ICTO executive director Undersecretary Louis Napoleon Casambre and ITBPAP president and chief executive officer Jose Mari Mercado said the city's inclusion in the top ten showed the city's "commitment and excellent effort" to become "a preferred destination for IT-BPM operations."

The criteria in the selection were talent, infrastructure, cost of doing business and business environment.

The awarding rites coincided with the formal launch of the IT-BPM and Global In-house Center (GIC) Road Map 2012-2016.

Cayat and Gawisan compose the secretariat of the Information and Communications Technology (ICT) Council of the city which was created in 2011 by Domogan to address the issues of the IT industry in the city, promote and ensure harmony among the BPO players and stakeholders and coordinate and implement ICT programs and projects.

The creation of this council which is chaired by Domogan contributed in the ICT industry's continuous growth which Cayat said the city hopes to sustain in the coming years./A Refuerzo

Mayor Vows Continuity of Unfinished Projects

BAGUIO CITY - Mayor-elect Mauricio Domogan vowed to continue his unfinished projects in the city in his second term as city executive.

In his Ugnayang Panlungsod press briefing last Wednesday, the mayor spelled out his thrusts in his fresh mandate.

On infrastructure projects, the mayor said the repair and improvement of national roads will be continued while the unfinished city road projects will be pursued and the conversion of barangay roads into city roads will be prioritized to avail of funds for their rehabilitation. He said he will also pursue other infrastructure projects including the circumferential road along Marcos Highway, Balacbac and Camp 7, the rehabilitation of the sewerlines and sewerage treatment plant, the Baguio Convention Center, the Heritage Hill in Dominican, the warehouse project at the Auditor's Cottage, the Asin resort property and the Mines View multi-purpose building and of Burnham Park.

On educational services, Mayor Domogan said that Congressman-elect Nicasio Aliping Jr. committed to continue some of the programs of outgoing Rep. Bernardo Vergara particularly the construction of school buildings and will continue the grant of educational assistance to the existing beneficiaries of the Mauricio G. Domogan-Bernardo M. Vergara Education Financial Assistance Program (MGD-BMV-EFAP).

The mayor also committed to continue his programs on social services particularly those in place for poverty alleviation, senior citizens and health care.

For peace and order, the mayor said the city will continue to aid the city police in their logistical needs to attain their goal of reducing crime rate in the city.

The mayor also pledged to sustain a "green governance" by continuing programs on the restoration Cont. on page 7

City Hall Workers Return Lost Cash; Owner Traced Through CCTV

BAGUIO CITY – Assessment clerk Rosalina Lubina of the city assessor's office had only one thing in mind after picking up the two rolls of bills she found lying on the City Hall lobby staircase around 2 p.m. last May 10 and that was to immediately get the P5,000 cash back to its owner.

Instead of walking back to her office, she went directly to the public information office where she asked for assistance for media announcements to locate the owner of the two bundles of cash – one with three P1,000 bills and the other with two P1,000 bills. She left her find with the PIO for safekeeping in case the owner comes back for it.

The following week when no claimant turned up, Lubina, without revealing the details of her find, related the incident to her officemates just in case one of their clients happened to mention of any missing cash. At the time when she chanced upon the cash, most of her co-workers were at the PFVR Gym for the annual City Hall mini-olympics and only a skeletal force was left to man their office and deal with a stream of clients on land transactions including settlement of land

An officemate, local operations officer Vivian Estioco told Lubina she lost some cash that same day. The amount and the description of Estioco's missing money matched that of Lubina's find but Estioco was not sure where she may have dropped the money.

Another co-employee, administrative aide Marilou Regacho said a client mentioned of her missing cash on the same day and with the same amount and description and was suspecting that she dropped it on her way to the assessor's office.

Estioco then suggested that they retrace the incident through the closed-circuit television (CCTV) facility of City Hall's security service provider the Interlink Security Services as she herself was not comfortable in claiming the cash without concrete proof that it was hers.

Estioco herself facilitated the request to the Interlink through operations and CCTV in-charge Mark Padcayan who conducted a review of the tape.

Eventually, the CCTV tape showed that the money was dropped by Jacquelyn Rosado, Regacho's client on the exact spot where Lubina found it.

Rosado said she was not aware her money came off her shallow pocket and realized only that it was missing when she was about to pay her tax dues. She said she retraced her steps and went back twice to the stairway but did not find her cash. She even kept her loss from her husband who was with her at that time afraid it might tick him off.

She expressed gratitude to Lubina, Estioco and Regacho for their honesty and for exerting efforts to trace the owner of the cash.

"I was so glad my money was returned. It's good that it was here that I lost it and ended up in good hands. Otherwise, I might not have gotten it back," Rosado told the three

employees.

Lubina said that at the time she found the money, she was short of cash and even borrowed an amount from an officemate for her taxi fare to attend a prayer meeting but it did not occur to her to pocket the money as she knows that the owner will suffer from its loss.

The group proceeded to the Buddhist Temple where they were received by Sr. Cristina Sy and apprised on Bhuddists' spiritual beliefs and practices



Perennial Irony

Naty "Morales" never heard or read about the Marcoses, Estradas, Binays and Ampatuans wresting election victory. She is a 53-year old beggar, who looks a haggard 80. What matters is even left over food, she shrugs.

Alms cadged from shoppers and church goers tide Naty and grandkids to the next day. Walang tutong sa taong nagugtom. "There is no burnt rice to a hungry person".

In dumps, where ill-fed squatters huddle, TB spreads like wild fire. TB incidence here is 275 for every 100,000 population. It is 137 for Thais. Handouts couldn't buy for Naty the anti-tuberculosis medicine she needed. So, the wife scraped up the anti-TB pills.

But what about other Natys locked into this treadmill? Almost 3.9 million Filipinos experienced hunger in March, Social Weather Stations survey reported this week. That's 19.2 percent of Filipino families. SWS did the headcount from March 19 to 22. In December, 16.2 percent had empty pots.

Despite a 2 percent drop in self-rated poverty, overall hunger increased in all regions except in Metro Manila. There, hunger slumped to about 615,000 families. In Mindanao , 1.4 million families tightened their belts. So did 1.3 million families in Luzon and 580,000 in the Visayas.

EDITORIAL other race of creatures,

bound on other journeys," Charles Dickens wrote (We all) are fellow passengers to the grave. "In Asia and the Pacific, 578 million have empty plates, Food and Agriculture Organization estimates. Three out of four cluster in villages or *barangays*. Many eke out a living from scrub agriculture; others fish in depleted waters. "Those who produce the food are often the ones who suffer hunger the most." That is the perennial irony, former Malaysian agriculture minister Datuk Hussein Onn noted.

Many trek to cities to search for non-existent jobs. They bloat the ever-expanding populations of shanty towns. Hunger triggers a lethal cycle. Chronically malnourished mothers give birth of stunted children who often die early.

In the Philippines, more infants are orphaned today than in 2006. And one out of every four pregnant women are "nutritionally-at-risk," says the 2013 study by UP and Institute of Child Health Development. Worse, "there has been no change in the past 15 years." On average, 11 mothers die daily during childbirth.

Most of those deaths were preventable. "Sri Lanka and Honduras led in slashing maternal mortality," Nicolas Kristoff of *New York Times* reports. "The biggest themes of life are put into the best focus when held up against the very sharp light of mortality."

Over one-third of child deaths here are due to under-nutrition. They usher in diseases that a little more nutrition could have staved off. Out of every 100 kids, who survive, 22 .are scrawny under-weights, UNDP's 2013 Human Development Report notes. IQs will be dampened for life. "Their elevators will never go to top floor."

Among Southeast Asian countries, the Philippines and Cambodia rank second in prevalence of undernourishment: 17 percent. Laos towers at 28 percent. Chronic hunger means food intake slumps below minimum energy requirement."

My two grandkids put a human face on those arid figures. Some Sundays, their parents drive them to where grimy out-of-school kids cluster. The two share food packs they've prepared "A lola ate the rice I gave, then cried," our 6-year grand-daughter Katarina explained. "There were two children with her," 9-year old sister Kristin added. "They ate the sardines I put on their rice".

Malnourished Filipino children remain at 20.2% today. And what about the Philippine pledge to meet the Millennium Development Goals? We're committed to tamping down the prevalence of malnutrition among under five-year-old children to 13.6 percent by 2015. Forget it. We'll fall short.

In Asia, domestic prices of rice and cereals weakened with arrival of the 2013's early season rice and winter wheat harvests, FAO reports. That's a breather after over five years of food price inflation.

Hunger is local. That reality confronts 80 newly-elected governors, plus mayors, in 143 cities and 1,491 towns. The brunt of easing it's ravages, specially among infants and young mothers, fall on them, not national government. They have a window-of-opportunity to reverse the sorry track record of their predecessors.

Far too many local officials couldn't be bothered with voiceless endangered mothers or infants. Many squandered the 20 percent Local Development Fund on waiting sheds nobody uses. The late Interior Secretary Jesse Robredo had to issue memo circular No. 2010-138. This bounced claims for *honoraria*, *lakbay-aral* junkets and such.

Others tried to bore their way into the P44.5 billion conditional cash transfer (CCT) program. President Aquino beat them back — and rightly so. A 2013 World Bank study confirmed the program 's successful record of keeping kids from dropping out of school and better health care for mothers.

The hungry should spur the new LGUs to set their house in order. That calls for scrapping the laid back habit of just wheedling for larger slabs from the Internal Revenue Allotment Fund, as a start. Then, they have the gut-wrenching task of collecting local taxes better. In addition, they must revising obsolete taxes that coddled the rich. New revenues generated should then go to help the poorest. That 's why the European Union underwrote a project to buff up finance management.

In a 1955 award winning movie, the kid Marcelino offers a small loaf to the Crucified and says: "Tiene cara de hambre." "You have the face of hunger.' Just like Naty./Juan L. Mercado



It's too late to eradicate poverty. Now it has got heritage value.

The latest incident with Taiwan is "Strike 2". The first one was the bungled and mishandled Luneta bus hostage incident which resulted to the death of Taiwanese tourists. This was still fresh in the minds of the angry Taiwanese when the shooting by the Philippine coast guard happened. The recent killing of the Taiwanese fisherman is STRIKE 2. The mishandling, the 2nd time around, was quite obvious.

It was a mistake for us to BELATEDLY apologize to Taiwan. It's okay if that was proffered voluntarily by the Philippine side AT THE OUTSET. But when an apology was given after it was DEMANDED WITH THREAT by no less than the Taiwanese president, then, to offer an apology was beneath our integrity and pride as a nation. Worse, the Philippine's BELATED offer of apologies was OFFICIALLY REJECTED. Even Malacanang's representative, my former colleague in Congress, MECO chief Amadeo Perez was sent back home unceremoniously. (We do not have an embassy or diplomatic post in Taiwan due to the ONE-CHINA policy. We recognize only mainland CHINA. MECO in Taiwan is an economic cooperation office.)

Aggravating the actual killing incident, I think the diplomatic problem started right at the beginning when the Malacanang spokeswoman, Ms. Abigail Valte immediately issued a statement right after the incident saying the Philippines would NOT APOLOGIZE. This was clearly provocative and uncalled for at a time when the full story of the shooting incident was still unclear. This triggered a strong statement from the Taiwanese saying 'APOLOGIZE OR ELSE". In an effort to salvage the situation, Malacanang decided to apologize. As I expected, it was rejected outright.

The agitated Taiwanese public is also over-reacting. Taking it against all Filipino OFWs there is irresponsible and irrational. Of course, the Filipinos are also angry and furious.

The two governments must navigate this with prudence. There's no need to exacerbate the situation.

Then stage entertainment during rallies. And clowning from many candidates themselves. Free give aways and t-shirts. Handshakes and house visits. All the works.

Never been soooo... good. The pump priming of the economy with all the money released in circulation is always beneficial. All of these will be sorely missed. Until 2016 again.

BACK TO NORMAL — The fun days are over. Everyone must move on. The campaign materials, posters and garbage have to be removed. Accounts will have to be paid. Candidates who were busy in the field are reclaimed back by their families.

Mayor Pushes for Market Ordinance Implementation and Review

BAGUIO CITY -Mayor Mauricio Domogan last week emphasized there is a need to review market ordinances specially those on "antiquated legal contracts" and to monitor past demand letters for all delinquent market stall leaseholders.

There is also a need for developments in the city market, as to segregated garbage collection and a clinic for medical emergencies both for vendors and marketgoers, he added

made the pronouncement during Alay Sa Kalinisan (ASK) and Ugnayan media forum last week.

Vendors, stallholders and lessees need to know the legalities stated in the Book of Ordinances for Taxes, Fees, Charges, Market and Trade; compiled since 1945, the mayor said.

There are provisions for penalties for delinquent lesstallholders, stated in Chapter 19 of the

The mayor Tax Ordinance, Section 148; the mayor added, while early and prompt taxpayers are accorded up to twenty percent (20%) discount. "A surcharge of twentyfive percent (25%) of the amount due with an interest of two percent (2%) per month until fully paid" shall be deemed on the delinguent stallholder.

> "...a lessee shall be considered delinquent upon failure to pay a period of two (2)consecutive months," it stated in Section 149.

Section 167 also

states "...the city government shall avail of the civil remedies provided for the collection of delinquent taxes under this ordinance in addition to the cancellation of the award and contract of lease for the delinquent stall or booth."

The mayor also emphasized on Section 166 of the market code which states, "Construction of stalls or booths or improvements thereon may be introduced in the

The concept of such Postal Museum or News and Media Museum is to exhibit among others a historical collection of letters and stamps, along with a digital observatory, radio ham shack, TV studio, radio announcer's booth and print shop that the Media Newseum can provide for educational and tourism purposes.

Tibaldo clarified that the Baguio Post Office's usual operations will still carry on.

But according to Baguio Post Office's postmaster Bernardo Kubaron, despite seeing the benefits of the proposal, removing these small business establishments will paralyze their whole budget circulation. The postal industry's revenue has significantly decreased over the years (due to the advent of electronic mail), which resulted to the laying off of approximately 2,500 postal employees in the country as of January this year, under the Philippine Government Rationalization Program. Additionally, the Post Office employees are receiving very little suspension from the National Government. With the limited budget, they are utilizing every space they have just to generate income. They will not be able to give everyone their due salaries had it not been for the rentals and ad posters.

Baguio Post Office has an estimate of 56 million pesos as annual budget but Kub-aron stated they do not receive it aggregately but by portion. He also stressed that they issue receipts to this stalls and ad posters monthly.

The Post Office rent out a total of 9 stalls ranging from a monthly rental fee of 25, 000 to 10,000 pesos, while ad posters are for 1, 0000 pesos a month. The collected revenue from those rentals is remitted to the central office. After which it is budgeted and given out to them in the form of personal service expenses such as salaries, incentives, and maintenance and operational expenses.

The postmaster added that the rented lots had all undergone the legal bidding process. He also clarified that the city's Post Office is governmentowned but this renting out of areas is pursuant to the Philippine Public Private Partnership Program.

Meanwhile, stall owners confirmed that they are issued such receipts by the Post Office and are all written in record, shown to them with transparency. However, some of them think that the fee is too expensive as business is not that strong.

But despite Baguio Post Office's own reasons about the proposal, Kubaron still sees it as a good idea. Should the proposal reach the Philippine Postal Cooperative (PPC) and approved by NHI, the city's Post Office will coordinate accordingly.

After sharing the proposal to Social Media, Tibaldo stated that his next step will involve the mainstream Media, in hopes to gather more supporters. He further added that with the help of the public and city officials,

more so that we have elected a new set of public officials, the Post Office will not only be saved from its present condition but become one of the city's many attrac-

Furthermore, the younger generation will learn the about the history of Postal Industry and appreciate the beauty in writing telegrams.

Mayor Defends Name, Says Complaints not True

BAGUIO CITY - Mayor Mauricio Domogan during the Weekly Ugnayan Presser May 22 answered accusations against him for vote-buying and other election related offenses here.

Speaking to members of the media Wednesday, Domogan said, 'the for Patients charges against him is a desperate attempt of an individual to more for Patients charges against him is a desperate attempt of an individual to mar his reputation.

Domogan was reacting to complaints filed by one Mary Grace Bandoy with the Commission on Elections for Violation of Paragraph a,b,d,i,j,m,o Sec. 261 Article XXII of the Omnibus election Code.

Charges of vote-buying consisting of proposal of a group of barangay officials of Irisan, use of government Park reservation as headquarters of Timpuyog ti Baguio and the release of scholarship grants to students and beneficiaries have been highlighted in the complaint.

Domogan however said, serious allegations of vote buying against him has no truth and in fact his campaign is always based on issues and performance which he said the people can attest to.

'On the first issue, I have no hand much less personal knowledge about the proposal of the group of barangay officials from barangay Irisan, he said. 'I only heard about this proposal from second hand sources and from the media,' Domogan clarified.

In an affidavit, Barangay Chairman Thomas Dumalti and five of his kagawads admitted there was a draft proposal to extend their help during the campaign to the Timpuyog ti Baguio party.

However, Dumalti said the proposal was never presented to the Timpuyog Officials as it was allegedly stolen by an unidentified person and was later on exposed to members of the media as a form of a black propaganda.

On the second issue, Domogan said, 'the buildings used by the Timpuyog Ti Baguio Party are private properties owned by the Baguio City (Host) Lions Club, Inc. and Baguio Pines Lions Club.' 'We have entered into a Contract of Lease with them where we paid P100,000.00 and P80,000.00 respectively as rental fees for the facility,' he said.

On the third issue, the mayor said the release of the educational financial assistance fund to students and beneficiaries is not votebuying and is done by a committee. 'We have been doing this as early as 2001 when I was the Congressman for the benefit of poor but deserving students of Baguio,' Domogan said.

The mayor also said the program is funded by the Priority Development Assistance Fund (PDAF) which Congressman Bernardo Vergara committed to continue when he won in 2010 which has now reached a P14M budget per year.

The program is being implemented and Chaired by the Office of the City Social Welfare and Development Officer Betty Fangasan consisting of 12 members.

The financial assistance fund amounting to P7,000.00 per student/beneficiary is given towards the end of every semester.before the final examination.

Fangasan clarified, 'the financial assistance fund was initially scheduled to be given last March 3 but was later on moved to March 17 due to the failure of some beneficiaries to accomplish requirements for the preparation of the payroll."

Domogan said, 'the release of the financial assistance was done at the Baguio Convention Center openly and publicly and in the presence of media personalities and a part of a regular program.'

'We have no hand in the selection of beneficiaries, the task is entrusted to the committee which screens the applicants they be a voter or not, Domogan said.
