On 1-10-99 about 5-10 minutes after 2am I was traveling NB on HWY CR and observed someone walking SB on the west side of the road approx 1/2 mile N of Silver Creek Rd. I proceeded NB to Viebahn and made a left turn and then made another (L) turn onto Hecker Rd. I deliver papers and delivered 8 papers from the time I saw the subject and when I observed a subject lying in the middle of the road on HWY CR at Silver Creek Rd. After making the turn onto Hecker Rd. I traveled SB until Silver Creek Rd. and then made a left and proceeded to HWY CR. I made a (R) turn onto CR and observed some body laying in the middle of the road. There were no other vehicles around and I called 911 using my cellphone at 2:25 am. Between the time I observed the male walking and made a (L) turn on Viebahn I saw 2 cars and 2 trucks traveling SB on CR. I didn't observe the color or make of any of the vehicles. When I saw the body it was not moving. All 4 vehicles observed by me were not together and it was the 2 cars first and then the 2 trucks. Both trucks had caps on back.
