BAGUIO CITY --With the Yuletide season just few weeks away, the City Council is urged to pass an ordinance imposing a total ban on the sale of firecrackers and pyrotechnic materials to prevent injuries and even death.

Dr. Donna Tubera-Panes, City Health Services Office Epidemiology and Surveillance Unit head, said that as early as now, they are praying that the city council will pass an ordinance to ban all kinds of firecrackers that may harm people especially the school

She reported thal1 cases of firecracker-related injuries were monitored in the city last year and that more than half of the victims were minors with the firecracker "Piccolo" as the number one cause of injuries.

Mayor Mauricio Domogan is consistent in his stand against sale of firecrackers in the city, and he has been continuously lobbying to the legislative department to come up with an ordinance for the total ban of firecrackers.

For his part, City Fire Marshal, Superin-

Bangyod said it is high time for people to revisit the way they celebrate the Christmas and New Year festivities - by not exploding firecrackers and lighting up pyrotechnic materials in order to prevent the destruction of life and property.

# **City Health Ohffice raises Dengue alert**

BAGUIO CITY- -The City Health Services Offices is calling for a community action against dengue as cases continue to rise and clustering of cases already being experienced in several barangays.

Baguio HSO City Epidemiology and Surveillance Unit Head, Dr. Donnabel Tubera, disclosed that from September 1 to October 5, 283 dengue cases were recorded in Baguio City, which is way high compared to the 30 cases recorded during the same period last year.

Tubera also af-



firmed the clustering of cases in several barangavs with Camp 7 having the most cases with 25, followed by Irisan with 14, Bakakeng Central with 11, Loakan Proper with eight and Dontogan and Rock Quarry with seven each. There were also

seven barangays with six cases each, two barangays with five, 11 barangays with four while five others have three cases each, she added.

Tubera pointed-out that dengue cases are expected to be on the down trend at this time

# Eco-walk sustains environmental mission

BAGUIO CITY Eco-Walk, the long-running indigculture-based enous children's environmental awareness program continues to fulfill its mission to foster love of the environment among children in the city and at the same time save the Busol watershed, one of the remaining pine stands that supply potable water to parts of the city.

Several groups recently underwent the Eco-walk experience which involves hiking at the forest, lecture, tree-planting or ring-weeding of their planting sites called "muyong" after the traditional forest system of the Ifugaos.

The Baguio Seventh Day Adventist School which adopted the Eco-Walk as a yearly school activity set the tone this year with twin tours held last July and September with more than 150 elementary and high school students who planted trees at their muyong.

"(Eco-Walk helps us attain our objectives) to let the students value the natural resources around us and conserve them; enhance and foster the love and care of our environment, protect our environment against illegal ways of denuding it, appreciate the beauty of a well conserved national resources, and to let them feel the beauty of working together for progress," school coordinator Avelino Gadiano Jr said

Another Eco-Walk patron, the Irisan National High School dispatched a group of more than30 students to the watershed last Sept. 25.

"The Eco-Walk never fails to inspire us in strengthening (our) commitment to the environment. After every visit, I receive positive remarks and comments

from each group of participants after seeing the beauty of Busol watershed, the experience of visiting the trees they have planted, weeding a part of the muyong and realizing what they have contributed to Mother Earth," INHS teacher Maricel Cadingan said.

Since establishing their muyong in 2008, INHS students have been returning to their muyong to either plant new trees or tend to the trees planted by their predecessors.

BAGUIO CITY - Government agencies and private groups have planted more than twenty one thousand tree seedlings within the city to help mitigate the effects of climate change.

As of the end of 21,220 September, seedlings; 17, 758 from the Botanical nursery and 3,462 from the Busol watershed nursery have been planted in Forbes Park I and II, Upper Wright Park, Sto. Tomas rain catch basin. More than 10,000 seedlings await later planters in other venues; watersheds, residential or commercial sites.

Tree planting in other venues; within residential compounds and commercial establishments, is also done in compliance to City Ordinance no. 5; for the issuance of occupancy permit. At least 65 or-

As the tree-planting activities, 1,379 city hall employees from 24 departments; 82 associations and offices. the National Greening Program was complied with. Other tree-planting activities were done in line with the Civil Service Commission month celebration last September.

Benguet Pine Alnus, Caliandra, Mahogany, African Tulip, Percimon, Calamansi, Arabica Coffee and pomelo are among the

species planted and some still for dispersal.

Tree-cutting and trimming around the city is also being done, it was reported, for the safety of home-owners.

In the same forum, Jones Gas-ib of the Burnham Park Office reported that the city cemetery is being prepared for All Souls' and Saints day. Clearing of said cemetery is done by job order employees, he said.

Mass propagation of flowers and ornamental plants for "Christmas In Baguio" is also done in the city parks, Gas-ib said.

In general, plants absorb pollutant Carbon dioxide, and exude Oxygen which is utilized by human beings and animals for respiration. Planting in all vacant spaces, thus, is urged for Baguioites./Julie G. Fianza

# Arrogance of power: 'Bahala kayo sa buhay n'yo!'

It turns out that Mayor Alfred Romualdez wasn't telling everything when he said in a congressional hearing Monday that Secretary Mar Roxas, President Aquino's point-man in Tacloban after the super typhoon hit, told him, "You are a Romualdez and the President is an Aquino."

Romualdez didn't report the more chilling statement Roxas made: "If we cannot legalize [the turnover of authority to the national government], you'll be in charge, we'll help you, and that's it, pero bahala na kayo sa buhay niyo."

That Pilipino sentence has a particular nuance, which can't be captured by its literal translation, "You're in charge of your lives."

Rather, it means, at best, telling somebody, "I don't care whatever happens to you from here on." At worse, it's a veiled

threat from a superior or from somebody with authority. "You can go to hell for all I care,"

or "I wouldn't lift a finger to help you from here on," would be more accurate translations.

Coming from Roxas' mouth and made in a meeting with a stunned mayor of a devastated city and his aides, it was a clear threat that if Romualdez wouldn't formally turn over authority over the city, he won't get the help he needs from the national government that Roxas represented.

Rather than just apologizing and regretting that his words were misinterpreted by the mayor, Roxas instead came out belligerent and quarrelsome. Apparently thinking that Romualdez' supporters took a video only of that particular part of that meeting, Roxas claimed that the mayor was lying and that the video was "spliced, and its intention malicious."

He had threatened to "release to the public" what he claimed was the untampered video "at an appropriate time." He was unaware though that as he spoke, thousands were already viewing the clearly unedited 40-minute video on YouTube, posted by columnist Cito Beltran and Romualdez' father-in-law Jose Ma. Gonzales.

As of this writing, the two posts together had been viewed more than 500,000 times, a record of sorts for Philippine videos posted on YouTube that aren't entertainment in nature. It's probably the most viewed YouTube video of a political nature involving our country ever.

Worse, Roxas claimed that Romualdez was not in his right mind as he was traumatized by Yolanda's devastation, saying—and laughing madly afterwards—in an interview in GMA's 24 Oras news program: "Tanong ko sa kanya, nagpa-stress debriefing ka na ba? Kung nag pa stress-briefing siya, baka tumino, luminaw ang pag-iisip niya." ("My question to him: Has he undergone stress debriefing? If he did, he'd probably be sane and his thinking made clear.")

Roxas' statements in his meeting in Tacloban with Romualdez, his response to the criticisms against him for that episode, even his body language and choice of words reflect this man's arrogance of power. What's obviously has been going in Roxas mind: "Who is this mayor to defy what I wanted to be done in Tacloban, and to complain about it? We are in power."

But it is not just Roxas'; it's the deep flaw of his boss President Aquino, an arrogance of power.

It is the same arrogance of power that explains why President Aquino ignored a Supreme Court order to let former President Gloria Arroyo seek medical help abroad; why he removed Chief Justice Renato Corona and spent billions of pesos to bribe Congress to do so; why he filed trumped up charges against Arroyo and jail her; why he junked Cont. on page 5

## PNoy administration more corrupt than GMA's government

We've been saying it all along. Noynoy Aquino, Butch Abad and associates have circumvented provisions of the Constitution that laid down basis to the Supreme Court (SC) rulings outlawing pork barrel.

The High Court declared unconstitutional the Priority Development Assistance Fund (PDAF) in November 2013 and the Disbursement Acceleration Program in July 2014.

Instead of heeding the SC rulings, Noynoy and his cohorts merely changed the labels of and concealed the congressional and presidential pork barrel items in the railroaded 2014 and 2015 national budgets.

In the same way that a drug addict cannot do away with his fix, these pork barrel addicts shrewdly got around the SC landmark rulings to keep their loot.

Noynoy's administration has, in fact, outdone and outperformed Gloria Arroyo's in terms of lascivious leakages in the national treasury.

Like sex-starved perverts, the "bright heads" in the Palace and the stamp-pad 16th Congress raped and ravaged the nation's coffers, making the national budget balloon to trillions of pesos and sinking us deeper in foreign debt.

That is why the Philippine Constitution Association (Philconsa) has asked the Supreme Court to stop the shameless fleecing of public funds, including Noynoy's pork barrel.

In petitioning the SC for a temporary restraining order (TRO), Philconsa cited the "scandalous and unconscionable freight" of P424-billion lump sums that were "cleverly embedded" in nine departments, including two agencies directly under the Office of President.

Former senator Ping Lacson said the agencies with the biggest pork barrel are the Department of Social Welfare and Development, Department of Education, Department of the Interior and Local Government, Department of Health, Department of National Defense, Department of Agriculture, Department of Public Works and Highways and Department of Transportation and Communications.

Among the specific unconstitutional provisions the petitioners cited in the General Appropriations Act of 2015 were Section 65 on lump sum appropriations, Section 70, which redefined "savings," and Section 73, which allowed realignment of funds.

Philconsa, led by its president Leyte Rep. Martin Romualdez, along with former Budget secretary Benjamin Diokno, former senator Francisco Tatad and Archbishops Fernando Capalla, Romulo de la Cruz and Ramon Arguelles, sought the SC to issue a TRO on the allocation of lump sums.

In a full-bench session presided over by Justice Arturo Brion, the SC ordered Malacañang and Congress to respond to Philconsa's claims in its petition in 10 days.

Earlier this month, former national treasurer Leonor Briones of anti-corruption watchdog Social Watch Philippines filed a similar petition in which case the SC also ordered the government to respond.

Abad blamed lawmakers for the existence of lump sums as they were the ones who approved his national budget scheme.

Incumbent Baguio City Congressman Nicasio Aliping Jr., chairman of the Baguio Liberal Party, is seeking for re-election for his second term in office.

"It inspire me to help my mother in taking care of our mini-garden. I realized being attached to nature is so great," said Irish Oficial.

Conceptualized by members of the local media led by city public information officer Ramon Dacawi in 1991, Eco-Walk was pilot-tested in 1992 and since then became the top environmental awareness program of the Baguio Regreening Movement and the city.

Under Dacawi's tutelage, the program won for the city the 1996 "Galing Pook" Award bestowed by the Asian Institute of Management and the Department of the Interior and Local Government. This children's environmental immersion into the vital role of forests in sustaining life was made a model throughout the world. Its effectiveness was cited by the United Nations Environmental Programme which bestowed on the children's project its 2002 Global 500 Award.

The program does not only move children but adults as well.

Around 20 members of the San Vicente Saving and Credit Cooperative who joined the trek to the watershed last Oct. 3 agreed with the children on the program's worth and effectiveness in enhancing environmental consciousness among the people and in preserving and protecting the Busol watershed.

The members insisted on planting their trees despite the risk of them not surviving at all due to the lack of rains. They instead promised to visit their trees to regularly water them to ensure their survival.

The rest of the students' reflections go:

"It is my third time to visit our muyong and I was so happy because the two trees I planted survived. I really appreciate our muyong because as Mr. Dacawi said, muyong are the ones holding the water so that it will not directly flow to the houses below the mountains," – Joline Bohol;

"Let's plant more trees! Trees give us many things. When they are all gone, no amount of money can bring them back again." – Franzes Yrah Quintinita;

its chapters are labeled after the cycle followed in agriculture consistent with the DepEd-CAR road-map.

The first chapter with subtitle "Remembering Our Home" gives an overview of the IP and how it came to be in CAR side by side with an overview of public school system in the region.

The second chapter, "Preparing the Fields", underscores efforts undertaken in the early years in the Cordillera region since 1988, its legal basis of creation, the Indigenous Peoples Rights Act (IPRA) promulgation, Education for All among others.

The third chapter, "Sowing the Seeds", includes forwarding responsive education with the region being recipient of Philippines' Response to Indigenous Peoples' and Muslim Education (PRIME) which initially included four divisions namely Ifugao, Mountain Province, Kalinga, and Apayao, and issuance of the IP Policy Framework and national roll out of Learning Resource Management and Development System (LRMDS) to come up with instructional materials suited for the region.

The fourth chapter dubbed, "Planting the Seeds", incorporates the region's undertakings such as immersion with IP communities from north to southern part of the country, piloting of LRMDS, inclusion of other divisions as recipients of PRIME namely Baguio, Abra, Benguet and Tabuk City.

The fifth and final chapter, "Nurturing the Rice Fields", features write ups on understanding more the IP such as setting in place the processes in IPED contextualized in K-12, presentation of regional policies on IPED, activities that support the council of elders that gave birth to the first Regional Basic Education Congress in 2013, a venue which dished out the cultural dimensions of K-12.

It is clear and evident that there is a pattern and systematic plunder of public funds throughout Noynoy's term.

This weekend, the House of Representatives overwhelmingly approved the General Appropriations Act (GAA) based on Abad's national expenditures program for the 2016 election year.

Of the 291 congressmen, only 20 voted "nay" to the exorbitant P3 trillion budget proposal for 2016.

With a number of senators running for reelection to or for higher office, the GAA is expected to pass smoothly.

The House-approved bill was left virtually untouched from the original budget proposal submitted by the Department of Budget and Management.

Bayan Muna Rep. Neri Colmenares noted the presence of pork barrel or lump sums or discretionary funds amounting to P758 billion.

2. The petitioner be legitimated by virtue of his parents' marriage;

3. The petitioner's mother's surname be corrected from "Moidino" to "Moldino"; and

4. The petitioner's father's first name to be corrected from "Rey" to "Reynaldo."

It appearing that the instant petition is sufficient in form and substance, the same is set for hearing on November 23, 2015 at 11:00 o'clock in the morning before this Court at its Session Hall, Justice Hall Building, Baguio City. # Peso weakens against dollar

MANILA - The Philippine peso closed Friday weak against a US dollar following the latest release of US inflation data.

Peso ended the week's trading at PhP46.05 reversing its gain on Thursday at PhP45.85 from Wednesday's PhP46 finish.

A trader said peso is tracking regional currencies after the better-than-expected US inflation data that strengthened the dollar.

US' official figures showed that consumer price index in September only rose to 0.2%.

Peso already opened the day weak at PhP45.94 from last day's opening of PhP45.86.

It traded between PhP45.90 and PhP46.05 bringing Friday's average level at PhP45.98.

Volume of trade increased to US\$ 740.8 million from last day's volume at US\$ 679.5 million.

Peso-dollar trading next week is expected between PhP45.80 and PhP46.10./ PNA

## Aspiring Philippine politicians, presidents kick off turbulent election season

ANILA – The Philippines' election season kicked off Monday with politicians registering for thousands of posts, launching a typically raucous and deadly seven months of campaigning in a famously chaotic democracy.

A successor to President PNOY will be chosen in the six-yearly polls, with the front-runners a savvy politician accused of corruption, the adopted daughter of a movie star and a lowkey stalwart of the ruling Liberal Party.

Aquino, who has won international plaudits for tackling systemic corruption and for his solid economic stewardship, is imploring voters to choose longtime ally Mar Roxas to continue his "straight path" style of governance.

"This is a campaign to continue the straight path, a campaign to make our hopes possible, a campaign that will continue the heroic story of the Filipino people," Aquino said at a rally to announce the LP's Senate ticket.

But Roxas has struggled in opinion polls and is facing strong challenges from Jejomar Binay, the current vice president who is being investigated for graft, and Grace Poe, a political novice riding on her late father's popularity.

The start of a weeklong registration process began Monday for more than 18,000 positions up for grabs — from the presidency down to village captain level — for May's elections.

Binay, a former Aquino ally who now heads the main opposition party, was the first of the major candidates to register at election headquarters in Manila on Monday morning.

Binay was a clear leader in opinion polls until the Senate and ombudsman began investigating him for alleged corrupt activities when he was mayor of Makati, the financial district in the Philippine capital. Binay has insisted on his innocence, maintaining the allegations are part of a political smear campaign.

The Philippines, a former U.S. colony of 100 million people, has struggled to establish a stable democracy, with many of the problems blamed on dictator Ferdinand Marcos's rule from 1965-1986.

But his son and namesake is running for the vice presidency next year as an independent, insisting his late father's rule was benign and that voters will focus on present problems rather than the past.

"There are corrupt Filipinos ... within and outside the government who are killing our economy and keeping us poor," Marcos, 58, said at a weekend rally alongside his controversial mother and former first lady Imelda.

Another feature associated with Philippines democracy has been politicians resorting to violence to eliminate

rivals or cheating to rig polls.

The best-known incident occurred in 2009, when the warlord family of a southern province allegedly massacred 58 people to try to stop a rival registering his candidacy as governor.

While some members of the Ampatuan family accused of orchestrating the massacre are behind bars and on trial for the murders, many others are expected to compete in the polls.

These include Sajid Ampa-tuan, who has been charged with murder but was allowed to post bail this year.

"I am not here to scare the people but to make their vision real," Ampatuan, who registered Monday to run for a village mayor position in his family's stronghold, said by phone.

Pre-election violence had already flared before the registration process.

A roadside bomb injured a local mayor and killed three of his bodyguards in the vio-

lence-wracked southern island of Basilan on Oct. 1.

Another enduring challenge for the nation's democracy has been the power of elite clans who dominate national, provincial and local posts, according to political analysts.

"Philippine politics has always been governed by the elite ... I don't think the dynasties will change," Ateneo University political science professor Benito Lim said

Roxas, for instance, is the grandson of a former president.

And while Binay does not come from a political family, since rising to influence he has set up his own dynasty, with his wife and children becoming powerful politicians.

Only celebrities, such as movie or sporting stars, have generally been able to challenge the elites.

Boxing hero Manny Pacquiao, 36, is one of those.

The eight-time world champion is currently a member of the House of Representatives and will next year run for a higher-profile Senate seat./*AFP-JIJI* 

# Scientists create artificial 'skin' that could feel sensation

WASHINGTON -- US researchers said they have created a plastic "skin" that is capable of distinguishing the pressure difference between a limp handshake and a firm grip and then transferring these sensory signals to the brain cells.

For the many people around the world living with prosthetics, such a system could one day allow them to feel sensation in their artificial limbs.

"This is the first time a flexible, skin-like material has been able to detect pressure and also transmit a signal to a component of the nervous sys-

tem," said Zhenan Bao, a professor of chemical engineering at the Stanford University, who led the 17-person research team responsible for the achievement.

For the top layer, Bao's team combined plastics and rubbers with billions of carbon nanotubes to create the plastic sensor to mimic human skin, which transmits pressure information as short pulses of electricity, similar to Morse code, to the brain.

The team then hooked this pressure-sensing mechanism to the second ply of their artificial skin, a flexible electronic circuit that could carry pulses of electricity to nerve cells.

One challenge is that the team had to prove the electronic signal could be recognized by a biological neuron.

"We have a lot of work to take this from experimental to practical applications," Bao said. (PNA/Xinhua)

# GSIS bares additional benefits for members and pensioners

**B**AGUIO CITY-- The Government Service Insurance System (GSIS) updated stakeholders on the latest benefit enhancements for its members and pensioners and other breakthroughs that the pension fund is implementing to provide responsive service.

During the "Dialogue with Public Sector Union (PSU) Leaders" held on October 14 at Hotel Supreme, this city, Vice President for North Luzon Group Eduardo V. Fernandez informed GSIS funeral benefit for members and pensioners has been increased to Php 30,000 from Php 20,000 effective September 2015.

Old-age and disability pensioners as of December 2014 have started receiving a one-time benefit equivalent to one-month pension or Php 10,000.00, whichever is lower.

"The benefit will be automatically credited to the pensioners' account ", Fernandez said explaining that the benefit will only be granted this year which can be considered as additional bonus.

GSIS is also granting "Milestone" benefit to nonagenarian and centenarian pensioners. Those who turn 90 to 94 years old as of September 1, 2015 will receive Php20,000; those 95 to 99 years old will receive Php50,000; and those who are 100 years old and above will get Php100,000.

Starting September 2, 2015 and thereafter, regular pensioners will be paid the following milestone benefit on their birthday: Php20,000 to pensioners who will turn 90 years old; Php30,000 to pensioners who will turn 95 years old; and Php50,000 to pensioners who will turn 100 years old, Fernandez said.

Fernandez also discussed reforms implemented by GSIS in the last five years. These include the re-engagement with Land Bank of the Philippines(LBP) as an additional servicing partner in December 2010. Pensioners and active members now have the choice, not only to use LBP's nearly 1,000 ATMs deployed across the country (70 percent of which are in the provincial areas), but they can also have their own LandBank-issued UMID eCard.

GSIS also allocated at least 20 slots for children of indigenous peoples, persons with disability and solo or single parents under the enhanced **Cont. on page 8**

# Cordillera spared from of El Niño this year

BAGUIO CITY - Here's a good news for the Cordillerans especially the farmers.

The Cordillera region will feel the effects of the El Niño phenomenon during the first quarter of next year 2016.

Department of Agriculture (DA) regional information officer Robert Domoguen, informed that in his recent tour around the region, most areas still experience afternoon rains and the springs have plenty of water flowing.

He said DA has not recorded incidence of damaged crops due to drought.

Kalinga province, particu-

larly Tabuk City, which is often hit by drought, has abundant agricultural harvest and still the the top producer of quality rice in the Cordillera. The provinces of Ifugao and Mountain Province still have large quantity of hybrid corn production and rice, he said.

Danny Galate of Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA)-Cordillera, affirmed that the region is experiencing regular rains.

"We have been having a good cloud formation in the region even with the El Niño that is why we do not feel much the effect. Our high elevation is also an advantage which makes our temperature better aside from the rains that we are having," said Galati.

Even as the Cordillera is not yet affected by El Niño, Domoguen said the DA is designing plans that suit the needs of farmers and other agricultural stakeholders to combat the effects of the phenomenon. He said they are closely coordinating with the National Irrigation Administration and other partner agencies for mitigating measures./JDP/JBZ-PIA CAR
