

DA Scholarships Available

BAGUIO CITY – More than a thousand local scholarships are available for qualified students in the city, as allotted by the provincial office of the Technical Education and Skills Development Authority (TESDA). This is stated in the letter of Benguet Provincial Director Angela Gabriel.

Interested individuals are enjoined to apply at Congressman Bernardo Vergara or the city mayor's office, both at city hall.

Limited number of scholarships in animation and 2d animation are offered at the Cordillera School of Digital Arts; while a finishing course for call center agents at the Global Tech school along Magsaysay Avenue has been allotted Three hundred Ninety-Seven (397) slots.

There are One Hundred (100) slots available for a slaughtering course at MMS, along Session Road; One Hundred and Seventy-five (175) slots for housekeeping NC2, and Three Hundred (300) slots for a finishing course in Medical Transcription at CTEISI. For the Medical Transcription course, it is pointed out that medically-trained students are preferred, due to medical terms being used in the lessons.

Accordingly, applicants must be at least 18 years old and for the time being, unemployed. His/her family should qualify under the Conditional Cash Transfer program and have not been under any Training for Work Scholarship Program (TWSP), from 2006 up to 2010.

It is also learned that application should be on a first come, first served basis.

The TWSP has been going on for the past years, with scholarships allotted through the local government unit.

Another program, as to Mayor Mauricio Domogan, is the forthcoming GM Advanced Technician Training Program for Automotive Mechanics/Technicians through a scholarship starting January next year.

Interested and qualified individuals are encouraged to apply through the Public Employment Services Office (PESO) at city hall starting next week.

Applicants should be between 24 to 40 years of age, with a minimum of 12 months Automotive Course, have more than 24 months experience as an all-around mechanic/technician and should pass an initial automotive theoretical test and interview. The applicant should also have a valid passport and in good medical and physical health.

The training offers free uniform, lodging, study guides, and a monthly stipend. A graduation bonus awaits deserving trainees upon completion of the program./juliegfianza

P25 Million for Burnham Park fencing released by Pres. Aquino

BAGUIO CITY. Nov. (PIA). The Vicariate of Benguet and the City urged its involvement to the bidding process for the P25 million fencing of Burnham Park allocated by President Benigno S. Aquino III.

According to Bishop Carlito J. Cenzon, Apostolic Vicar of Baguio and Benguet,

the money for the fencing of the Burnham Park is already with the Department of Public Works and Highways (DPWH) –

"Every single centavo should be spent in the project (fencing) and there should be transparency during the bidding to contractors with good track record," Cenzon said.

"We want to maximize the coverage of the money to be expended. This is peoples' money and we will be supervising the implementation of the project until it is finished," he said.

Cenzon personally asked President Aquino the funding for the fencing of Burnham Park when he (Aquino) administered the ceremonial switch-on of the park's lighting system project of the Department of Energy (DOE) last August.

The initial fencing intended to keep the children safe while inside the park was initiated by the bishop with the help of the private sector and some civic leaders.

There are lined up plans for the development of Burnham Park like planting more trees and flowers to keep it beautiful for park goers to appreciate, Cenzon said.

'The lake needs a lot of improvement as well as Melvin Jones Football Field and we are encouraging everyone to help make Burnham Park a place for promenading," Cenzon added.

The Melvin Jones Football Field where concerts and major events also take place is adjacent Burnham Park. /SCA JBZ/PIA-CAR



Firecrackers to be Banned in La Trinidad

LATRINIDAD, Benguet — Mayor Gregorio Abalos is keen on saying no to firecrackers in the municipality.

Abalos, in an interview, said that he is keen on stopping the use and sale of firecrackers in this capital town after Baguio City Mayor Domogan has shown his seriousness to stop the sale and use of firecrackers in the city.

Just recently, Domogan disallowed the sale and use of firecrackers during the celebration of the holidays in the city but the businessmen from the firecracker industry appealed to sell only pyrotechnic and fireworks used for aerial viewing only.

La Trinidad is very near Baguio City and entrepreneurs may think of applying permits for them to sell their firecrackers in the municipality, and Abalos is committing not issue permits for them to sell their goods anywhere in town.

He added that the ban on sale of firecrackers has good intentions to prevent untoward incidents related to firecrackers during the yuletide and new year celebrations.

Meanwhile, Provincial Health Officer Dr. Esteban Piok is also supporting firecracker ban in the province of Benguet.

He said that they are strongly advocating the campaign of the Department of Health which is "Iwas Paputok" to prevent firecracker related incident which has been a problem especially among children./JDP/RC-PIA CAR

1-Utak Party List Pushes for United Transport Sector Consumer Power Vs

Fuel HikeBAGUIO CITY - For transport sector groups to unite as one, exercise their consumer power and buy fuels - by volume, from one supplier or oil company. Such is the alternative solution the 1-UTAK Party List is pushing in its effort to address the concern on the continuing increase in the prices of fuel products that is besetting the sector.

This was stressed by 1-UTAK Party List National Chairman Atty. Vigor Mendoza II, in a press conference here Monday.

According to Mendoza, petitions for a fare hike increase is the last resort or solution they are looking into in addressing the concern of continuous oil price increase, which is why they are here in Baguio for the second stop of their scheduled 7-leg transport sector conference in various parts of the country.

"Our objective in meeting the transport sector stakeholders here in Northern Luzon, as well as in the other parts of the country, is simple. With the continuing increase on the price of fuel products, we want to know the situation in every area, if there is a need for a fare hike and what alternative solution that we can do, in lieu of a fare increase", Mendoza said.

He asserted that they are willing to support the transport sector all the way, in pushing for such alternative - encouraging transport groups to unite and exercise their consumer power by buying fuel from a single oil company and take advantage of volume sale.

According to Mendoza, similar talks are also already being undertaken by various transport groups in Metro Manila. After Mindanao and Northern Luzon, they will also advocate for such alternative project in the other parts of the country.

"Through this method, the oil companies will respond. We will test what they are calling a free market system. If there is true market competition in the ground there will be an oil company that will respond, if no company calls (the demand for volume buying) then it will be a clear and convincing evidence that there are collusion among oil companies, which will also be the evidence that we will present for the nullification of the Oil Deregulation Law, as we already have a pending petition for it at the Regional Trial Court of Bacolod," Mendoza disclosed.

"Whatever the result of such exercise, we can prove one thing - whether there is really an existing free market or true competition or if there is collusion among oil companies (in relation to the increase in fuel prices)", he added.

Meantime, Mendoza also affirmed that they have pending petition for a fare hike in Manila for a P2 increase in the first four kilometers and an increase from P1.40 to P1.75 per succeeding kilometers that will be imposed in the National Capital Region, and Regions III and IV.

According to Mendoza, similar fare hike petitions will also be filed here in Baguio/Cordillera soon if there will be no alternative solutions that can be made on the continuous increase in fuel prices.

(LaTOP) Multi Purpose Cooperative during the DA led Food and Organic Agriculture Investment Forum, Friday.

Acosta, in his presentation dubbed as, 'Organic Agriculture: A Response to Consumer's Health and Welfare', stressed that choosing between organically grown veg-

etables and the traditional ones, only boils down to a person's health consciousness or concern.

Environment Forum Held For Drivers, Commuters Along Benguet Roads Halsema Highway way and 737 along and Benguet- the Benguet-Vizcaya

LA TRINIDAD, Benguet - Motorists and travelers en route to Halsema Highway and the Baguio-Vizcaya Road yielded for a short briefing on proper solid waste management in an environment forum held simultaneously along the stretches of the two main thoroughfares recently.

The environment forum on the massive information campaign on Republic Act 9003 otherwise known as the Ecological Solid Waste Management Act is in line with the celebration of the 111th founding anniversary of the prov-

ince thru Adivay.

Motorists and travelers passing

and Benguet-Vizcaya road were stopped for a few minutes for a short briefing on their role and support in maintaining cleanliness along the highway through proper disposal of solid waste while drivers of private or public utilities were told to provide thrash containers to dump wastes in their respective vehicles.

Truck drivers were also told not to dump their 'ubak' or vegetable wastes and other forms of wastes along the thoroughfares.

According to Environment and Natural Resources Officer Julius Kollin, who chairs the Environment Forum, a total of 1,333 vehicles along Halsema Highway and 737 along the Benguet-Vizcaya road were put to a halt and whose drivers and passengers were briefed by the members who were scattered in strategic locations in both thoroughfares.

The forum is a partnership among the provincial government, concerned line agencies, municipal, barangay, s a n g g u n i a n g kabataan officials, transport groups, health officials, religious and the private sector.

The first Environment Forum along the Halsema Highway held last year gathered positive feedback, inspiring the members to include the Baguio-Vizcaya road.

Time Of Visitation Spurned

In his 1967 essay "Tyranny of the Urgent," Charles Hummel warned: "Our greatest danger is letting urgent things crowd out the important."

It was urgent that she seek medical treatment abroad, formerPresident Gloria Macapagal Arroyo told the Supreme Court. There were no pending court charges and she had a right to travel. Eight justices she had appointed scrambled to issue a Temporary Restraining Order (TRO).

A hasty TRO "could frustrate the Government's right to prosecute," cautioned Antonio Caprio, the best chief justice Filipinos never had. "This Court must hear first the Government in oral argument..."

"The Commission on Elections decided, by a 5-to-2 vote, to file poll sabotage charges against GMA. Across the road, the

Supreme Court rejected by an 8-5 vote the

Solicitor General's motion to scrap the Arroyo's TRO. It ordered Justice Secretary Leila de Lima to explain why she should not be held in contempt of court for shrugging off the TRO. Palaam Gloria and Mike."

In October, the joint Department of Justice and Commission on Elections panel recommended that GMA and 35 others be probed, and charged if warranted, with 2007 election fraud. GMA lawyers walked out in protest.

Others tagged included former Comelec chair Benjamin Abalos Jr. and ex-commissioner Nicodemo Ferrer, former Justice Secretary Alberto Agra, supervisor Lintang Bedol and detained former Maguindanao governor Andal Ampatuan Sr.

Beyond the TRO and charges, by GMA camp of "railroading election sabotage charges", fester long range issues. These are tossed up by the clash between a President, who seeks to hold the corrupt accountable, and Supreme Court justices who say they seek the same end. Arroyo justices are hobbled by charges of subservience.

However, this TRO issue plays out, the issue of GMA's health will persist. That "crown o' thorns" that Arroyo wore, on her earlier aborted departure flight was, not a put on. This "Minerva Brace" should be worn for three months, St Luke Hospital doctors say.

Prognosis by her Filipino physicians state that barring complications, GMA should be fully recovered from spine surgery in six to eight months, Justice Lourdes Serreno notes. The metabolic bone disease needs lifetime maintenance treatment.

Arroyo's claims of life-threatening ailments fall short of "evidentiary requirements for a TRO. "The majority is completely bereft" of any explanation on for granting a premature TRO "in the face of untruthful statements, Justice Serreno adds.

Have TROs become a buy-one-take-one-drill? The completed Senate Blue Ribbon Committee report on dumping overpriced helicopters on the National Police, tags Mike Arroyo, among others. Yet, his separate request for a TRO had been stitched into his spouse's petition."

"Mike became free to leave by virtue of consolidation," Inquirer's Raul Pangalangan points out. "How did Mike get to benefit from Gloria's medical emergency"? If one asked Hamlet, he'd have shrugged: "There are more things in heaven and on earth Horatio, Than are dreamt of in your philosophy."

Indeed, this "TRO proved the wisdom of packing the high court with one's appointees—for that foreseeable future when one is forced to call in favors," an Inquirer editorial pointed out. And "why didn't Chief Justice Renato Corona inhibit himself?", wondered Sun Star columnist Frank Malilong "(This) case personally involved his former boss."

President Arroyo skipped senior justices to hand her former chief of staff a midnight appointment. Thus former Sen. Rene Saguisag and some see a "de facto chief justice."

Like Juan Manuel Marquez of Mexico, DOJ can not "accept a referee's decision graciously", observes constitutionalist Joaquin Bernas. TRO means "executive officials must allow GMA to travel "effective immediately", until the court lifts the order—"if we're to abide by rule of law."

Secretary Leila de Lima's view is a motion for reconsideration stops TRO dead in it's tracks. That 'd render any TRO absolutely useless...Anger at GMA "consigned reason to the sidelines. "That affects even the highest executive authorities (and) is a sad, sad thing". Senator Miriam Santiago adds. It's enough to make one feel like "slashing wrists."

Maguindanao Massacre Two Years Ago (Day One)





(Note: Right after the Maguindanao incident, Dureza then presidential adviser for Mindanao wrote a personal account as "crisis manager" which was published and carried by media. Now back in the private sector as Publisher of the Mindanao TIMES daily newspaper and actively managing Advocacy MindaNow Foundation and doing consultancy work, he is re-printing his "recollections" with on a day-to-day account recalling the four (4) critical days of the incident. This will be a 4- part series starting today.)

DAY ONE —Nov 23 Two years ago, I was in Davao City that day and was finalizing arrangements for me and wife Beth to fly to Manila in the late afternoon flight for her usual medical check up. By noon, I was getting text messages from several sources about the missing convoy. I started inquiring.

Gensan Inquirer Correspondent Aquiles Zonio told me over the phone that he was supposed to be with the convoy from Buluan to Shariff Aguak on board the Mitsubishi Lancer of Mindanao Bulletin Editor Joseph Jubelag, who was driving. But Joseph decided to peel off from the convoy and proceeded to the pension house in Tacurong where they stayed the previous night to pick up some belongings. They did not try to catch up with the convoy anymore.

At 9:30 a.m., Joseph said he called by phone Bulletin Correspondent Bong Reblando who was ahead in a rented van with the convoy enroute to Shariff Aguak. He told Bong that they decided not to proceed anymore as they were delayed in Tacurong but would catch up with the group when they return to Buluan from Shariff Aguak for the scheduled press conference after the planned filing of the certificate of candidacy of Toto Mangudadatu. That was to be the last phone call with Bong.

Bong was a close friend and a kumpadre, being ninong to one of his sons. I found close kinship with Bong because both of us had similar beginnings. I was Bulletin correspondent too during my early days as a journalist. He was always supportive of my work in Mindanao, in the peace process, as press secretary, etc. I recall Bong's naughty practice of calling me by phone and telling me that his article about my latest statement was published in the Manila Bulletin issue that day. When I asked what it was all about since I had not issued any new statement, he would simply say: "Just confirm it, Kumpadre. It's about moving the peace talks forward". He knew me so well that press statements I issued a long time ago he would be able to re-cycle and spin aligned with current events. I would always caution him though: "Pakiusap lang kumpadre. Please always tell me ahead what statements I had supposedly issued to you before you report. It may trigger a war!" And we would laugh together.

From all accounts, the Mangudadatus knew of the dangers they were facing in opposing the Ampatuans. They were political allies before. The filing of the certificates of candidacy was a declaration of war. The media delegation to be part of the convoy was a security cordon. Most of them were from Gen. Santos City.

Joseph later related to me that on November 22, he stayed overnight with some mediamen, together with Bong, Aquiles, etc at a pension house in Tacurong in preparation for the activity organized by the Mangudadatus. The following day, at 6:30 a.m. Monday, he drove his vehicle to Buluan where the convoy was supposed to assemble before the jump off.

Joseph said there was some discussion, before the convoy left Buluan about the security concern as they learned that there was no security escort provided by the authorities. Joseph said they contacted by phone Gen. Cayton, then 6th division commander based in Awang, Cotabato city who said that while there were no security escorts, there should be no concern. Joseph however got worried. That's when he decided to just let the convoy go ahead and instead drove to the Tacurong pension house to first pick up his belongings. On board his vehicle were media friends Aquiles and Paul Bernardo. His close buddy, Bong rode in a van and went ahead with the group. There were 6 vehicles in the caravan. Joseph's Lancer would have been vehicle No. 7.

Aquiles remembered that while they were at the hotel lobby, and while Joseph went up to the room for his belongings, one of the waiters approached him. The waiter was nervous. He told Aquiles that when they left the hotel early that same morning, some unidentified and suspicious-looking men arrived and asked about the identities of those who joined. Cont. on page 10

"The blind can now also earn tremendously more, with more self-respect at that, by making paper bags, which are then marketed nationwide and even worldwide," Carina told me as we chatted Tuesday night on the sidelines of a necrological service for a Rotary Club president who had just died.

As of now, Carina's Rotary Club is initially pushing through with the training of blind individuals who are being cared for by the Epheta Foundation for the Blind, with the aim of turning the 700 blind men and women housed therein into expert paper bag makers. And the training is for free, Carina said, who dreams of training the blind in the other parts of the Philippines in due time.

Once trained to make paper bags, the blind can then be harnessed as a regular source of the bags, which are getting to be popular these days because of increasing environmental concerns among plastic users—paper bags are proven to be more environment-friendly than plastic.

Right now, there is a great demand for paper bags from supermarkets, stores and other retail establishments in the Philippines and even abroad. This could become a steady source of respectable income for the blind everywhere in the country, Carina added, thereby giving them hope for a better life, and opening for them more opportunities.

Carina said she has been advocating paper bag making even when she was not yet Rotary Club president. Through the years, she has trained out of school youth, drug rehabilitation patients, and even former rebels who have gone back to the folds of the law. solution efficiency improved to 16.5 percent this 2011 from 14 percent last year.

As per assessment, Adnol stressed that most crimes against persons and properties took place in capital towns and Central Business Areas, though for street crimes such as pick pockets and snatching, most of the cases happened in Baguio.

As per crime clock, Adnol stressed that for crime against person most of the cases happen from 6:00PM until midnight while crime against property peaked 9:00PM-5:00ÂM.

As for the PRO-Cor's peace and order initiatives, Adnol also reported that they have already intensified their Police Integrated Patrol System (PIPS) and have already activated Barangay Peace Action Teams (BPATs) to participate in crime prevention.

In addition, PRO-Cor is currently working on the institutionalization of a reward system in the provinces through the Provincial Peace and Order Councils (PPOC), deployment of e-letter (electronic blotter system) in urban areas, as well as the establishment of GIS (Geographical Information System) for crime mapping and analysis.

It is also a primary directive of Magalong to all their personnel to intensify their Police Community Relation (PCR) activities, as he acknowledged the importance of getting the thrust and support of community in ensuring peace and order in the region.

Magalong, in a statement, also acknowledges that as they have intensified their peace and order efforts, programs and strategies, emergence of flaws cannot be avoided but he assured that they are doing their best and working doubly hard to make the necessary adjustments./JDP/LD-PIA CAR

to join the BCBC-led event.

Significantly, they were there to commemorate death with life - 58-trees to commemorate each of the victims; vowing they would stand guard against senseless killings and impunity of people behind the violence that was two years passed.

It was a simple but meaningful ceremony.

Graders from Baguio Pines Family Learning Center, members of the non-government organization Citibuddies, staff of University of the Philippines College Baguio, students of Baguio Central University College of Nursing, staff of the Department of Environment and Natural Resources-Cordillera Clonal Division were there.

Joining them were elements of the 21st Philippine Air Force Group Reserve, life savers from the City Disaster and Risk Reduction Management Council – Disaster Operations Center and the National Union of Journalists in the Philippines.

Pupil Danica Torcuato's innocence couldn't mask her indignation at the turtle-paced justice the families of the victims now cry for. "At best," she said, "we could only let their memories live on by caring for the trees we commemorate them with."

Torcuato's alma mater, Baguio Pines Family Learning Center, is the very first institution in 2009 to write Malacanang Palace, ahead of the Baguio Centennial Commission, urging then President Gloria Macapagal – Arroyo to spare the Baguio Convention Center pine patch from being built upon.

Eva Fianza of Citibuddies and Baguio Central University and Rafael Tallocoy of the City Mayor's Office on the other hand both vowed support for media, each vowing in representation of their respective groups to stand by truth and dissemination of the same.

TSG Emmanuel Carantes on behalf of the PAF on the other hand assured, "Our men in uniform share the same hope for peace... we are here because we likewise believe there is no room for senseless violence in our country."

For media's part, Richard Valdez gave a picture of the role of media in society, the hazards of his chosen vocation, and a personal look into the lives of some of his media friends he lost in the tragedy.

The latest count of slain journalists already reached 146, five of whom

perished only this year.

Since 1986 however, the Center for Media Freedom and Responsibility only notes 10-convictions and the bigger fishes are yet to be charged, leaving their mere henchmen to fry.

So far, only Andal Åmpatuan Sr. and Andal Ampatuan Jr. who were tagged as masterminds of the massacre are the only ones who have entered their plea before the court. Of 196-accused, 100-remain at large.

At dusk, members of the Baguio press down Session Road holding torches symbolic of that flicker of hope that someday, the dark days of immunity would be over./isl

Aquiles suspected something was wrong and got nervous.. He recalled that they were not able to catch up with the convoy as Joseph stayed in the comfort room for a long time. "Thank god for that bad stomach, I survived," Aquiles in hindsight told me. Unknown to Aquiles, Joseph had already decided not to proceed to Shariff Aguak and his upset stomach was due to tension and fear. Being an old hand in the area, he trusted his instincts. He decided not to go. That's when they called Bong at 9:30 a.m. and told him about the decision that they would not be able to catch up and join. The next call at 10:30 a.m. to Bong's cellphone and all the frantic calls that ensued were no longer answered, except for one call to another mediaman's phone and someone with a moro accent answered briefly then cut the line.

Later that day, the gruesome massacre of the Mangudadatu convoy including the media contingent was confirmed. At first it was a feeling of denial. Almost all of the mediamen in the group were my close friends. Everytime I made trips to Gensan or Cotabato before that, many of them would always be there covering my events. To some of them who joined the Mangudadatu delegation, perhaps, it was another opportunity to do a job. And I can tell you, media work especially in the provincial press, although exciting at times, is a hard, dangerous grind. For one, it does not pay well. But many stick to it for what I call "psychic income" - not the cash rewards, but of course it also counts - but more for the adventure and the excitement of getting a good story out. That's why they are a special breed – and for all of their faults too. That was the reason why when I was press secretary, to the discomfort of some sectors in Manila, I was giving priority to the provincial press. I recall changing the format of presidential coverages. Where the usual practice was the accompanying Manila press took the front seats and got the first shot of asking the first questions with the provincial media at times sidelined or even excluded from the event, I revised this giving the locals priority even in the physical arrangements. For a change, Malacanang hosted Christmas parties on a regional basis for the provincial press while I was there. I knew how it was as I was once one of

By the way, the tragedy befalling our media victims could not be sufficiently vindicated, even if all the perpetrators were sent to jail. For some sectors to even say or suggest that I received bribe money from the Ampatuans to help quash the cases is mercifully wrong. Even my visit at the military hospital as part of my work as in charge of Mindanao affairs to check on reports that Bapa Ampatuan was reportedly getting VIP treatment was dramatized as another telltale evidence that there was bribery. I was fortunate that the emissary of the Ampatuans who was always sent to me during the whole period came out and gave his full story of how I even declined to lift a hand on the case, knowing that many lives of my friends were lost aside from the fact that it was ridiculous - if not dangerous - for me to get a payoff to quash a case totally outside of my control. I asked for a separate investigation but nothing happened up to now. But I guess that's par for the course for public officials like me. Too bad for me. So

you will all understand why being back now in the private sector is so liberating! But it's another story altogether.

That fateful day was a media tragedy unmatched anywhere in the world. The unfolding of the gruesome event continued later in the day. And being in charge of Mindanao for the palace, I braced my-

I was trying to piece together the events of the day as more reports came in. When media called for a statement, I said I would recommend proclaiming a state of emergency. Late afternoon, as I was boarding my flight to Manila with my wife Beth, Defense Secretary Bert Gonzales called by phone. "Do you know what's happening?", he asked. I simply said: "It's unbelievable.!". He told me to proceed to the lobby of Edsa Shangrila hotel in Ortigas immediately upon landing. At 8 p.m.that night Bert told me that the President directed us to go to Maguindanao immediately. higher in terms of minerals, especially sodium - which is said to be the hardest element to be absorbed by the human body.

Acosta admits that high cost is still an issue or concern on organic vegetables as it plays with the law of supply and demand. He also stressed that if organic farmers increase in number, it will also lower the cost of organic veggies.

The said forum serves as the culminating activity of the regional celebration of Consumer Welfare Month last October.

DA-CAR Information Officer Robert Domoguen in an interview stressed that the activity aims to encourage the government, private sector, and farmers, who participated in the forum to ensure that food supply is safe through organic farming as well as to advocate good practices in food handling.

According to Domoguen, the activity, which is in coordination with the Cordillera Consumernet, is in line with the government's National Organic Program and the country's Organic Act, which DA Secretary Proceso Alcala initiated when he was still a Congressman.

For Cordillera, Domoguen affirmed that DA currently has P25 Million fund to promote and demonstrate organic farming here in the region as well as in ensuring that such vegetables are truly organically produced through a monitoring mechanism and labeling system.

the father of shotokan (knife-hand) style of martial art in the Philippines.

Sasaki planted the seed that is shotokan in the Philippines in the early 60's as a young second dan blackbelt sent by JKA central headquarters in To-

"This will be a world-class training," assured Sensei Hermie Pelingen, head of the Philippine headquarters of JKA in La Trinidad.

"The accomplishments of Chees would speak for the quality of what he is injecting to our local karate landscape.

Chees now holds 50-gyms in southern Germany. During his younger days, he was the only non-German by birth to have joined the German National Karate

His triumphs as a Karate practitioner started while he was working in an army camp in Germany where the national team coach took notice of his prowess after winning several regional and national tilts.

Soon, he rose to the world rankings topping the England and Dutch Internationals. The icing on his cake came in 1993 at the World Shotokan Championships in Saarsbrucken, Germany when he won his world title.

Like a monk whose travails are sure hit when transformed from 'real' to 'reel', Chees recalled, "I prepared for the 1993 World Championships for months and months, including winter by my lonesome in the wilderness.

Three years later, Chees emerged sixth in kata at the World Championships in Las Vegas, Nevada. In 2007, he ruled the seniors' kata at the Worlds in Bergamo, Italy.

His most recent crown came at the Fort Launderdale, Florida World Championships in 2009.

But his world-renowned exploits had humble beginnings. Chees started karate under Edgar Kapawen, Sr. - one of Sasaki's early students who now head the JKA-Orient Northern Luzon Head-

Before Germany, he earned his blackbelt as an in-house student of Sasaki, made to do odd jobs aside from training for 3-years at the former JKA Philippines Headquarters in Manila.

The December 3 seminar will enable karatekas of all belts to have a glimpse of Gasshuku, the rigid week-long training program being conducted by JKA Germany headed by Master Ochi.

Proceeds of the seminar will be used to support indigent patients in Baguio and Benguet as an extension project of Shoshin Kinderhelfe, a charitable foundation Chees established with his German students.

of the sector and the provincial board in passing legislative measures and other policies that regulate the industry.

The non-issuance of mining permits is still an issue confronted by the small scale miners. They are constrained from getting consent from mineral claimants, mining agreements for exploration, mineral production sharing agreement, and financial and technical assistance agree-

Fongwan also urged the miners to stop the use of heavy metals such as cyanide and mercury which is not allowed, in order to protect themselves, their families and the community.

He likewise urged them to protect the environment during operations and rehabilitate even after leaving the mined area.

He further encouraged the planting of bamboos, a fast growing species called Moso grown in China to prevent soil erosion and as alternative livelihood in crafting handicrafts and furniture. It thrives in a short span of time. In 85 days it could grow more than 15 feet.

In his trip to China just recently, Fongwan was able to get samples for propagation and further distribution.

The province could not do away with small scale mining which is one of the major industries in the province aside from agriculture or the vegetable industry but this should be regulated, Fongwan stressed. Pocket mining existed long before the exploration of large scale mines./ JDP/SCA-PIA CAR, Benguet

Belen-Making Contest Ushers in

BAGUIO CITY - Barangays are Yuletide Season encouraged to join the belen-making contest, with the purpose of instilling teamwork between and among grassroots officials and their respective residents. That is because only one entry per barangay is allowed.

This was announced during the well-attended monthly Punong Barangays' (PB) meeting last week.

The "Belen" or nativity scene entry should be in place by the last week of November, it was learned.

Registration which started Tuesday, at the Office of the Liga ng Mga Barangay, shall be up to Nov. 30 only. A list of materials used for the belen should be prepared for the assessment of judges.

The Liga Office shall set the evaluation date once the list of entries is finalized.

The barangay belen entries shall be judged as to creativity or the use of indigenous and readily available materials, 30 %; communication of the theme, 25%; appropriateness, 25%; and teamwork or the barangay's efforts for the belen, 20%.

The first prize winner shall receive P10,000; the second and third prize winners shall have P5,000 and P3,000 respectively.
