Tabanda urges colleagues to accept BENECO offer for streetlight maintenance streetlights/fixtures

BAGUIOCITY-Councilor Betty Lourdes Tabanda is egging colleagues to accept the offer of the Benguet Electric Cooperative Inc. (BENECO) to manage the city's streetlights subject to conditions.

In a proposed resolution, Tabanda proposed the acceptance of the BENECO offer subject to the following terms: *Only unmetered streetlights shall be subject of this Agreement; *Upon approval of this resolution, a joint inventory of the streetlights shall be undertaken; *The City shall pay for the electric consumption of TEN (10) burning hours for each streetlight included in the inventory based on the existing bulb rating.

BENECO shall provide for the repair/ maintenance of all inventoried streetlight, including materials thereof, at no cost to the City; and in addition thereto: *Any replacement of a luminaire/bulb shall be at 70 watts only; *No additional

shall be installed/ erected without the approval of the concerned city government offices; *A joint evaluation shall be conducted in an annual basis by the City and BENECO to determine the viability and effectivity of this Agreement; and that *This Agreement shall take effect upon the signing of a MOA, and shall remain in full force and effect until revoked or cancelled upon mutual agreement, after notifying the other party 30 days prior to its intention.

"For the past several years where unmetered streetlights were billed at the flat rate for ten burning hours, BENECO collected even for electricity not actually consumed because of the busted streetlights, Tabanda said.

"While the collection was in accordance with the MOA, still it is un-

deniable that the collection for electricity not utilized constituted profits for BENECO. Fixing the number of burning hours at TEN is realistic, since this will cover the hours when illumination is needed, to prevent, if not minimize, the commission of crimes," she said.

BENECO general manager Gerardo Verzosa earlier assured that the city will benefit in terms of costs and service if the power firm will take over the maintenance and operation of the city's streetlights.

He said the city spends P.5 million monthly for the repair maintenance which encompasses labor costs of these streetlights. This is on top of the P571,000 fee for the 94 clusters of metered lights and P1.8 million charges for the 15.802 unmetered lights.

Verzosa said they project that under BENECO's management, the city will have to pay only an additional amount of P368,000 being the ex-

Senator Pia S. Cayetano today said the Arroyo government should not take lightly the latest blunder of the Office of the Ombudsman which resulted in the dismissal of robbery and graft charges against former justice secretary Hernando Perez at the Sandiganbayan.

"President Arroyo must not tolerate the latest foul-up committed by the Office of the Ombudsman. Its officers should be made accountable, and I am simply shocked at the blatant display of incompetence by the agency that was precisely mandated to fight corruption in government."

"I believe sanctions are in order and heads should roll. President Arroyo

should put his foot down lest she be suspected of deliberately protecting a very close political ally in Perez," she stressed.

"It's highly suspicious how a high-profile case like this would not go through the normal process of being evaluated by the Office of the Special Prosecutor which will argue the case before the Sandiganbayan."

"It's a basic lapse, yet a big slap on the crusade against good governance."

She said prosecutors at the Ombudsman who prepared the defective charge sheet against Perez, including Assistant Special Prosecutor Elvira Chua, should be made to answer. Ombudsman Merceditas Gutierrez

should also be investigated by virtue of command responsibility.

She suggested that an independent committee composed of reputable people with a good track record in prosecuting corruption cases should be created to handle the special investigation of Gutierrez, Chua and other concerned personnel in order to dispel suspicions of bias and cover-up.

"Nothing also prevents the justice committee of the Senate from looking into this matter in aid of legislation, because with the entire justice system in question, who else can the people trust to uphold good governance under the Arroyo administration?"/

Dads call for halt of DENR cadastral survey project for city Controls for tire Bagnio C

BAGUIO CITY—The city council last Monday demanded the suspension of the bidding and implementation of the cadastral survey project of the Department of Environment and Natural Resources Cordillera (DENR-CAR) for the city due to concerns raised.

In a resolution, the aldermen rued the lack of consultation and participation of the city government in said project which they said is very crucial to the city.

The body also agreed to invited the DENR DENR-CAR executives to clarify issues on the project.

The resolution was jointly authored by Vice Mayor Daniel Farinas and Councilors Isabelo Cosalan Jr., Rocky Thomas Balisong, Betty Lourdes Tabanda. Galo Weygan, Perlita Rondez, Nicasio Aliping Jr., Antonio Tabora Jr., Erdolfo Balajadia, Nicasio Palaganas, Richard Carino. Fred Bagbagen, Elaine Sembrano, Ioe1 Alangsab and Gloria Ysabel De Vera.

It was gathered that the DENR-CAR embarked on a Cadastral Survey for the City of Baguio, the first phase of which was implemented in 2007 with Barangay Brookside, Baguio City as the pilot area.

The bidding process for the said project is scheduled to start on November 24, 2008 until December 2008.

"In a letter dated 08 March 2008 of Regional Executive Director Samuel R. Peñafiel of the the DENR-CAR to then Councilor Faustino A. Olowan, preliminary activities were already undertaken relative to the said Cadastral Survey for Baguio City, including among others, the establishment of PRS '92 Stations in the City of Baguio," the body noted in the resolu-

"In the presentation of the DENR-CAR, an amount of P2,000,000 was earmarked for the Modular Cadastre of Brookside Barangay, Baguio City covering, 1) Establishment of Main and Subsidiary

Controls for the entire Baguio City, 2) Political Boundary Survey and Lot Survey for Barangay, Brookside, Baguio City while for the remaining 127 barangays, the budget for the lot survey is reportedly a measly P10,000,000 or P78,740.157 per barangay or P 300.00 per lot, which is way below what had been allotted for Brookside Barangay."

The body also cited Resolution No. 04, series of 2008 of the Geodetic Engineers of the Philippines, Inc.-Cordillera Administrative Region entitled, "Submitting concerns of the Geodetic Engineers of the Philippines, Incorporated-Cordillera Administrative Region (GEPI-CAR) Division in the **Upcoming Cadastral** Survey in the City of Baguio."

In said resolution, the group called for the suspension of the survey to address the following concerns: *Is the

Thus declared Baguio City Police Office (BCPO) chief Wilfredo Franco in a cold yet telling voice last week, in the heels of a long-drawn-out war among youth gangs in the city; and senseless violence the baby thugs employ upon their innocent peers.

Franco revealed he has ordered a 24/7 special team to employ tight watch over youthful malefactors.

He said, "Right now, the special team is focusing efforts to bring down the heads, who are mostly in the age of criminal responsibility."

"We have given these kids ample time to reform, even inviting them to the Brotherhood for Peace (BFP) as a way of giving them a legitimate avenue to discuss their problems with us; and to help them make good use of their youth before they lose it," he added.

He however clarified, "even groups enrolled in the BFP cannot hide behind the mantle of the pact they signed and we witnessed."

(cha-cha)?

The non-existent House Resolution 550 sparked today's controversy. Filed by Batangas Rep. Hermilando Mandanas, HB550 would have transferred the May 2010 presidential elections to May 2011." All incumbents – including the President —could coast for one more hassle-free year in office.

This resurrected the no-election ("No El") controversy of 2006. The Malacanang-backed Constitutional Consultative Commission then submitted a draft charter. Section 7 of it's "Transitory Provisions (Article XX) would have scrubbed the 2007 elections"

Public fury forced the Palace to inter this "No El" idea, plus-

all charter changes proposed. And today's reactions are just as fast and

"You want Gloria Macapagal Arroyo as Preisdent for life?" fumed Rep Teopisto Guingona III. (Misamis Or) Rep. Victor Ortega (La Union) scrambled to deny that HR550 remained "active" before the House committee on constitutional amendments.

'No, no, no, protested Chairman Ortega. HB550 had been deleted. Rep. Mandanas yanked his chestnut back in August. 12 "No proposal, pending in the committee, speaks of any extension whatsoever," That's true.

But is this all smoke and mirror? Oretga glosses over other pending cha-cha bills Speaker Prospero Nograles (Davao), for example, has one that'd rewrite the constitution's economic provisions only. But everybody knows it's "open house" on revisions, once the assembly or convention is convened.

The President's son, Rep.Mikey Arroyo (Pampanga) has another that's even more loaded. This convenes Senate and House into a constituent assembly to blue-pencil the charter. But there is a kicker: This time, the two houses would "vote jointly not separately"

Now, the House has 240 members. Most are under the President's thumb. They outnumber ten-to-one the 24-member Senate. But the Senate is no mood to meekly agree to be slaughtered, It will therefore insist on voting separately, as in the past. The Arroyo son is inviting, with eyes open, the next Supreme Court

Mala yerba nunca muere, my grandmother used to say. "The bad weed never dies." The October survey by Social Weather Stations says that six out of every ten Filipinos oppose charter change. Yet, this idea, like a toxic shrub, refuses to wither.

Thus, we should look at the track record. This may jack up further citizen watchfulness. As the Ilokano proverb puts it: ""He who has meat to dry has something to be watchful for. Presidents are made, like us, of common clay. Most are tantalized by possibilities of prolonged tenure. Few resist the temptation.

Corazon Aquino did. She stepped down, after her term, without whimpering. But dictators like Marcos, Suharto and Zimbabwe's Mugabe try clinging to power for life. Nicaragua's Anastacio Somoza simply rigged the polls.

Now, rewind to Fidel Ramos in 1997. He got Pirma to launch a signature campaign for cha-cha. He lassoed 87 congressmen to back his claim that the constitution needed 147 amendments. No one remembered what the 146 were. But all agreed on the 147th: caps on their terms of office should be lifted. But Catholic bishops and civil society buried this self-serving bid.

Fast forward to September 2006. "(Why) waste P10 billion to P20 billion for the election?" Presidential Chief of Staff Michael Defensor told 2,000 councilors meeting in Cebu. "Without an election in 2007, you could put in your perspective on what path this country should take....Instead, we should work for a system that is stable... (like) a parliamentary system."

Make no mistake. This is No-El'. It would have disenfranchise 43.2 million voters to clamp on a vague constitution. An entire

Peace avenues must be used to prevent a Mumbali





The assault by Muslim militants in Mumbali, India, raises the specter of the possibility of the same taking place in the Philippines. As of yesterday, 143 lay dead and 284 were wounded in a coordinated attack in several sites in Mumbali: a train station, Jewish center, and a luxury hotel.

This is very sad considering that Islam and Christianity have the same roots. The militants have been doing the attacks in the name of Allah, the merciful, the same God that is praised in Christian New and Old Testament bibles as merciful and loving.

Of course, faith has dimensions that only the faithful can understand and I will be happy if there would be opportunities for me to understand how prayerful Muslims are able to justify the use of violence among what I assume or believe to be innocents in the ongoing real attempts to marginalize or exploit the Muslims.

The attacks on the innocents in Mumbali, India can trigger selfmade Christian militants in various parts of the world. Even if Christians largely subscribe to a Christ that is self-effacing and forgiving, there are passages in the Old Testament bible that can justify massacres and plunder in the same manner that Muslim militants are able to justify the murder of infidels.

Nevertheless, even if there are passages in the Old Testament that would justify violence, Christians largely interpret their faith as a faith of peace notwithstanding the existence of Christian exploiters who instigate the exploitation of Muslims and non-Muslims alike.

I sincerely hope that the Muslim militants would prefer to win over the Christians to their side and causes rather than making them the collateral damage in their fight for equality and recognition of their rights. I am sure that both Muslim and Christians can rediscover a commonality in their faith rather than emphasize the differences

I have a notion that the Allah in the Muslim faith is merciful. I heard the line somewhere and I have listened to a Muslim preacher once. At the same time, the elders of my clan have raised me to believe in a forgiving and loving God that had sacrifice His Son for the salvation of many.

If I am wrong on my notions on both my faith and those on my notions on the Muslim faith, I would be happy to be enlightened! I will be most happy to hear messages of faith from a Muslim personally or via email.

What is significant in the Mumbali incident is that "Christian Infidels" are not those who are dominant in that city. The militants executed an attack in a train station whose commuters are not predominantly Caucasians or Christian.

Thus, the Mumbali incident creates the specter that similar attacks can be executed in cities or population centers that are not predominantly Christian or Caucasians. In the Bali, Indonesia carnage, for instance, the attacks were focused on Caucasians or tourists. That was not the case in the Mumbali incident.

A problem in the tactic in the Muslim militants is that it may force the creation of a militant "Christian" extremism similar to what is happening now in Mindanao. The militant "Christians" can justify anarchism and massacre by using isolated passages in the Old Testament.

May I therefore respectfully suggest to the militant Muslims to reconsider their tactics and consider winning over the Christian population to their sides and causes instead. Imagine what a dirty place our world will be if a "Christian" militant group would emerge and retaliate. Of course, genuine Christians must not retaliate and must seek to understand the causes and grievances of their brother Muslims.

The BFP is an aggrupation of some 17gangs which decided to establish an advocacy of peace in the streets of Baguio via a memorandum of agreement signed by their leaders, October 11.

Currently, there are about 29-gangs in the BCPO's "order of battle," to which the 17-BFP groups are likewise listed.

'So far," Franco added, "We already have a list of groups and names... we are just waiting for them to make a mistake. It wouldn't be long before they are brought to justice."

Meanwhile, during an outreach program at the Baguio City Jail, November 28, BFP chair Jason Balag-ey welcomed Franco's declaration of a crackdown, even offering the BFP network as a means to end violence in city streets.

He said, "As far the brotherhood goes, we have already turned our backs from turf wars since we signed the agreement cum peace pact."

"We can never thank chief Franco and administrator Peter Fianza more for what they have done in keeping us on the right track encouraging us to group ourselves together and give something positive back to our community."

"Thus," he said, "We are willing to help out in establishing genuine peace by way of opening our arms to other groups who wants to be a part of our group; and being a watchdog against those who sow fear and violence in our streets."

"After all, we believe that we could provide useful information to our local cops as erstwhile sheep gone astray ourselves."

As to the declaration of Franco even BFP members are not exempt from the crackdown, Balag-ey said, "We have gone so far as to even think of tarnishing the name of our network."

"If one of our members is found to have done something criminal, the very agreement we signed provides that BFP is bound to bring its erring members to justice through the

Franco, defending the BFP from insinuations that grouping rival gangs is a bad idea meanwhile said, "The strategy of making an organization is not a failure.'

He said, "Statistics do not lie... we have lesser index crimes involving kids as compared to the time when the BFP had not been established."

A source who spoke on condition of anonymity bolstered Franco's statements saying the recent apprehension of gang-bangers who stabbed 15-year old Chermaigne Calpito to death was made easier with the aid of the BFP.

Fianza for his part said, "If we gave up on the BFP now, what would you think would happen if the groups involved went back to their old ways?

As of press-deadline, the BFP holds true their promise for reforms. The instant case is one for annulment of deed of sale and reconveyance. The subject matter of the action is a real property covered by tax declaration under Assessment of Real Property No. 99-005-0239 located at Tomay, La Trinidad, Benguet.

The owner indicated in said tax declaration is the defendant Nena B. Vasquez.

6. The plaintiffs are the niece, nephews of Agripina Kilito-Covano who died on December 20, 2007 without a will. She was childless when she died. The plaintiffs are the only surviving heirs of Agripina Kilito-Covano:

7. A Tax Declaration with number 99-005-02397 was issued in the name of defendants by the office of the Municipal Assessor of La Trinidad, showing Benguet, that the market value of the property allegedly sold is in the sum of Php105, 394,00 which amount is twice the amount in the Deed of Sale tile purchase

price of the land which is in the sum of Php50,000.00 only: A copy of the Tax Declaration in the name of Nena S. Vasquez is attached as Annex "B" and is made integral part of this complaint;

8. On December 20, 2007, Agripina Kilito-Covano died due to pneumonia and other unspecified causes. Since July 2007 until her death on December 20, 2007 when she was hospitalized at the Pines City Hospital at Baguio City, she was so seriously ill that she could not have been conscious enough to have executed the attached alleged Deed of Sale. A copy of the Death Certificate is attached Annex "C" and made Integral part of this complaint;

9. The plaintiffs predecessor in interest Agripina Kilito-Covano was incapacitated to execute the alleged Deed of Sale because at the time she was physically infirmed. She was 83 years old and was hospitalized due to a serious illness that impaired her mental faculties that prevented her from properly and intelligently entering into a contract of sale at her death bed:

10. The defendant Nena Vasquez is an alien who is legally disqualified to acquire lands in the Philippines, undeniably, the land which was subject matter of the sale is only an ancestral land;

11. The plaintiffs are duly compulsory heirs of deceased Agripina Kilito-Covano. They are willing to return the sum of Php50,000.00 to defendants in order that the latter shall recover the land which by operation of law, is theirs on December 20, 2007;

12. The present and actual value of the land which is the

land is in the sum of Php2,000,000.00. Which includes two (2) houses made of semi-concrete and other house built on the said land made of G-I sheets and lumber. The amount of Php50,U00.00 as the allege consideration is unconscionable.

13. Irreparable damage to the plaintiffs should surely result if defendants would sell and transfer the subject property and it would work injustice to the former. The act of defendants in transferring the subject property would render any judgment from this Court ineffectual;

14. The plaintiffs are entitled to the reliefs they are demanding and are ready and willing to file a bond;

15. Defendants Marvin Covano conspired with Nena B. Vasquez in the execution of the fictitious Deed of Sale. On January 29, 2008 plaintiffs discovered from the Provincial Assessors Office of La Trinidad. Benguet, Covano was in the process of transferring the ownership of one of the houses built on the parcel of land:

16. The K a t a r u n g a n Pambarangay Law does not cover this case since there is a prayer for a Provisional remedy.

PRAYER

Wherefore, it is respectfully prayed that before hearing, a temporary restraining order and/ or a writ of preliminary injunction be issued ordering the defendants from disposing of the property.

cess amount that will be incurred if the city agrees to the BENECO set-up which will entail increasing the electric consumption charges from the present 10 burning hours to 12 burning hours for the unmetered lights.

He said the P368,000 is still cheaper compared to the P500,000 being spent by the city at present.

He said this comes with the assurance of better service for the constituents as with the firm's expertise and red tape-free operations, maintenance needs like fixing of damaged lines, replacement of busted bulbs and the like will be attended within 24 hours unlike under the present set-up where the repair and replacement of needed parts take some time due to government procedures.

He said this works to the disadvantage of both the residents who are deprived of the benefits the lighting system offers and the city government which stands to pay the flat rate of P1.8 million monthly consumption charge for unmetered lights even if the consumption was not maximized due to the existence of busted and unserviceable lighting fixtures.

Apart from this, Verzosa said the BENECO board has approved a resolution to undertake the maintenance, repair and improvement operations of the city's streetlights for the first three to six months at no cost to the city by way of waiving the additional two burning hours on the consumption charges for the unmetered lights. This would mean big savings for the city government for the first three to six months of BENECO's operation.

BENECO's position is being considered by the council in line with Councilor Nicasio Aliping Jr.'s proposal supporting the power firm's request to take charge of the streetlighting operations./Aileen P. Refuerzo

phoma, or cancer of the lymph nodes. He treated the kid to pizza and chocolate, bought a take-home for Mark's sister, and left P12,000 from the fund to start his chemotherapy treatment.

Later, the fund paid for the emergency medicines of four-year old cancer patient John Mark Enqiquez (P1,500), seven-year old dengue fever victim Sarah Puguon (P3,000) and cerebral palsy patient Manuel Tagulino (105), and for the dialysis session of kidney patient Filbert Almoza (P4,000).

John Mark, youngest of three kids being raised alone by their mother, died last Nov. 17, 11 days after his birthday A thousand pesos from Shoshin was added to the amount being raised for the funeral expenses.

Part of the fund (P6,9521.50) paid for the travel expenses of Veronica Lee, a 27-year old kidney patient who is working out her second organ transplant. A P2,000 support enabled heart patient Crisly Anayasan to go for his check-up at the Philippine Heart Center.

A thousand pesos, to which another Sa-

maritan added an equal amount, enabled Nora (not her real name), to buy milk substitute for her one-year old boy, medicines for her daughter Angel and food for the family. Nora, a mother of three and wife to a sidelined farm tenant, can't breast-feed her baby as she herself is on maintenance dose for bipolar disorder.

Shoshin will help Binhin Balansi, an eight-year old, recover from injuries he suffered after a bad fall that landed him in the hospital.

Chees said P66,300 of the fund will be for the basic and educational needs of four children who were orphaned when their parents were killed in a bus accident in Nueva Vizcaya last April.

Mayor Pablo Cuyahon of Hungduan, Ifugao where the orphans live with relatives, recently received P33,000 from the total amount for Neil Denver Dao-ay, 10; his brother Jrick Jon, 3; Francis Tamkiw, 11; and Petrin Pocopio, 12.

officialdom, no less, was being titillated into trashing the 2007 ballot – as HB550 would have done today. In exchange, they get more years without the hassle of facing voters while President Arroyo expands her powers. It'd be like 'unleashing hungry monkeys in a cage full of bananas', as the old Thai proverb put it.

The re-burial of "No-El" in 2006 turned out to be temporary. It re-surfaced in a so-called "people's intiative" It's most strident advocate then is the most strident critic of Malacanang today: former Speaker Jose de Venecia.

By mid-year, de Venecia "prophesied": Congress would have convened into a constituent assembly or a "people's initiative" launched.

Either would then: (a) scrap the 1987 Constitution; (b) abolish the Senate; (c) run a nationwide plebiscite where majority of people would have meekly assent (d) to being strapped into a "land of milk and honey" otherwise known as a parliamentary system. That'd allow— De Venecia to be Prime Minister." Ah, that a man's reach should exceed his grasp. Or what's a heaven for?"

In the event, De Venecia proved a bogus prophet. By an 8-7 vote, the Supreme Court, struck down a petition seeking to amend the 1987 Constitution, through the so-called "People's Initiative.

The Sigaw ng Bayan and the Union of Local Authorities petition to support the President's shift to a parliamentary system" was "constitutionally infirm", the Court said in an 8-7 vote. This is a "revision and not an amendment," Hence it fractured the Constitution that limited people's initiative to amending the Charter.

And the supposed over six million signatories did not sign the petition. Signatures backing it "were gathered deceptively gathered. "To allow this constitutionally infirmed initiative, propelled by deceptively gathered signatures, to alter basic principles in the Constitution," the decision penned by Associate Justice Antonio Carpio, stressed.

"No-El's" carcass repeatedly rises from the grave because President Arroyo needs to retain immunity from suits, beyond 2010. She's aware of the example of Joseph Estrada: floundering into conviction for plunder after eviction from power. And Ferdinand Marcos discovered exile, is bitter.

Tinkering with the constitution for selfish interests reduces us to a banana republic. The Filipino people have consistently shown that in their rejection of "No-El" and charter change over the last decade. Thus, the Catholic Bishops Conference has suggested any rewriting of the Constitution be put off till after 2010. But we have, as Adlai Stevenson said, a "grand memory for forgetting./J.L.Mercado

and all the children will enjoy the right to education and are protected from abuse and exploitation," Tobin's letter to the governor partly states.

Dalog's State of Children's Address reveal that were three and 57 cases of maternal and child death respectively last year, malnutrition rate is 7.68 percent, education participation rates in the pre-school level, 70.6 percent; elementary, 82 percent and high school, 63 percent. The same report shows that there were 12 sexually abused children reported last year.

The report also disclosed that Mountain Province is first among the 24 UNICEF- assisted province and cities in birth registration, 97.50 percent; fully immunized children, 79.50 percent; exclusive breastfeeding up to six months, 72.8 percent and early childhood care and development, 70.60 percent.

The UNICEF head assured the governor of UNICEF's continued assistance to the province to sustain and scale up the gains in the CFM. She also called on the strengthening the functionalities of structures and systems supportive of child and women programs./Andrew Doga-ong/ PIA – Mt. Province

on the implementation of R.A. 9262, otherwise known as the "anti-Violence Against Women marked a high point in the history of the country's commitment to uphold and protect the rights of women and their children.

Niwane disclosed that the law in itself is an indication of the need to involve the citizenry in addressing domestic violence and mandating the barangay officials to perform certain roles to defer further acts of violence against women and their children.

VAWC is one of the issues that face our communities. "More often than not, victim survivors opt to keep silence for shame, if not they are doubtless of whom to seek help and how to seek help," Niwane said.

Records obtained from the PSWDO show that throughout the province, there were 43 sexual abuses committed to children from January to September 2008, 18 cases of violence against women and 77 cases of Children In Conflict with the Law./Vency D. Bulayungan/PIA-Ifugao
