Dads Ask Legal Office to Reply to P-Noy's Order on Bocap Case

BAGUIO CITY - The city council on Monday asked the city legal office to take charge of the body's comments and other needed actions relative to the barangay administrative case of Bakakeng Central barangay captain Helen Miranda now pending before the Office of the President (OP).

The OP through Undersecretary and Assistant Executive Secretary for legal Affairs Ronaldo Geron ordered the city council to submit its comments on a memorandum on appeal filed by former Bakakeng Central Punong Barangay Alicia Pacsi-Dizon, et. al. for Miranda's suspension over cases of grave misconduct and abuse of authority.

The city council in September last year suspended Miranda for six months but Pacsi and other complainants filed an appeal before the OP.

The OP order dated Janaury 10 required the city council and Miranda to submit within 15 days from receipt of the memorandum of appeal their comments which as prescribed should: "point out insufficiencies or inaccuracies in appellants' statement of facts; and state the reason why the appeal should be denied or dismissed.'

> The answer also discussed and justified the actions made by the city government in ensuring the safety and stability of the dump facility.

It also mainofficer-in-charge tained that the city Melchor Carlos has stopped using the facility for dumping since 2008 and countered such other claims posed by the petitioners.

In the answer, In the answer, the city asked the court to dismiss the case and lift or dissolve the Writ and the TEPO issued earlier.

The city also asked to be allowed "to fully complete the process of making Irisan dumpsite as an eco-park in accordance with R.A. 9003 and other environmental laws" and sought P10 million in moral damages and whatever amount the court may decide for exemplary damages.

As this developed, Mayor Mauricio Domogan bemoaned his inclusion as a private

BAGUIO CITY - Mayor Mauricio Segregation Domogan called for a more aggressive segregation stance in the barangays here to enable the city to properly manage wastes in face of the closure of Irisan dumpsite for waste sorting and transfer.

In his Ugnayan Panlungsod media briefing, the mayor announced a directive to barangay officials to take to task residents who continue to defy the segregation policy by returning the unsegregated wastes to their owners.

He said the city needs to be more aggressive in implementing policy to avoid complicating the waste disposal system which now relies on temporary sorting and pick-up areas in the various

"I appeal anew to our residents to segregate their wastes reliegiously so the city will not encounter problems in disposing our wastes. Segregation is our duty and mandate so we hope we take it seriously at all times," he said.

The city now uses existing materials recovery facilities in barangays Lourdes, City Camp lagoon and Lualhati as temporary sorting and transfer sites for the wastes collected.

In the said sites, nonbiodegradable wastes are sorted into recyclables and residuals. The recyclables are being bought on site by dealers while the residual wastes are taken by the Pro Tech Machineries for transport to Capas, Tarlac.

The biodegradable wastes continue to be processed by the Environmental Recycling Ssystem (ERS) machines in

The city is also waiting for the P80 million fund from the national government to implement the rehabilitation of the collapsed retaining wall.

The mayor said the city has implemented support measures and hopes that the fund will be released soon to begin the construction of an all-weather retaining wall to ensure the safety of the dump facility./ A Refuerzo

NCCA Launches Philippine Arts Festival 2012 in Baguio City

BAGUIO CITY — The National Commission for Culture and the Arts (NCCA) is leading the country's celebration of Philippine Arts Festival 2012 the whole month of February focused on the theme, 'Tradisyon at Inobasyon'.

Launching the festivity in this part of the country, NCCA Deputy Executive Director Marlene Ruth Sanchez spearheaded a kapihan forum at the Philippine Information Agency (PIA-CAR) Dap-ay last Thursday. Sanchez was joined by Festival Director and Vice Head of the National Committee on Dramatic Arts Edward Perez and NCCA Northern Luzon Coordinator Mary Carling.

According to Sanchez, this year's festival aims to bring in together traditional and modern contemporary arts in the promotion and preservation of the country's rich cultures and traditions especially among the youth. It will communicate to the younger generations to educate and appreciate the culture and the art so as to provide a bigger door of innovation which will still evolve around the rich traditional arts and culture of

She also announces that the month-long schedule of festivities set for PAF 2012 celebration banners the flagship projects of the seven committees of the NCCA's Sub-commission on the Arts (SCA) embracing architecture, cinema, dance, literature, music, dramatic and visual arts.

For architecture, Sanchez disclosed that the Committee on Architecture and Allied Arts will highlight three simultaneous exhibits focusing on the growth of Philippine furnitures, architectural artists and the country's finest icons.

For cinema, NCCA will have the 'Cinema Rehiyon 4' in Bacolod City and Negros Occidental on February 8 to 11, which will feature screening and forums that focus on the artistic endeavors in filmmaking from the different regions.

For dance, 'Sayaw Pinoy', now in its ninth year and the longest-running Arts month flagship project, will continue to spread the beauty of dance in various areas all over the coun-

On Literary Arts, Sanchez announces that the National Committee on Literary Arts will mount the 'Taboan 2012: Philippine International Writers Festival', in Pampanga and in Baguio on February 9 to 11, which will gather writers and readers for panel discussions, lectures, book fair, literary readings and performances, among others.

Gun-Ban Enforced in Baguio City for Panagbenga Festival

BAGUIO CITY - To ensure peaceful and orderly staging of the 17th Panagbenga or the Baguio Flower Festival, the police issued a memorandum order suspending Permit-to-Carry Firearm Outside Residence (PTCFOR) in this summer capital the whole month of February.

P/CSupt. Benjamin B. Magalong, regional director of Police Regional Office-Cordillera (PROCOR) said that suspension PTCFOR is in reference to the request

of Baguio City Mauricio Mayor Domogan who justified that the gun-ban contributes to the decrease of crime incidence.

Another reason why gun-ban is enforced is that criminal elements and treat groups may take advantage of the festival to carry out their nefarious activities during the monthlong celebration, he added.

The police personnel, the Armed Forces of the Philippines (AFP) and other law enforcement agencies like the

Shattered Halos

"We're all experts at practicing virtue (from) a distance", noted Notre Dame University's Theodore Heshburg. His comment explains why tin halos were shattered even during the early phase of Chief Justice Renato Corona's impeachment trial.

Did Corona and family keep integrity at a distance? Yes, says the loosely-drafted eight charges, now being spelt out, by a sometimes bumbling opposition. Not so, says the defense panel, overseen by grizzled veteran Justice Serafin Cuevas. They've lobbed everything but the kitchen sink to defend Corona. That included a demand that Senator Franklin Drilon inhibit himself from the trial—for bias.

By deft questions, Drilon prodded a reluctant Supreme Court clerk to turn over Corona's Statement of Assets and Liabilities. It is the prerogative of a challenged judge to inhibit

The defense strenuously insisted that Bureau of Internal Revenue Kim Henares be strait-jacketed into merely confirming Corona ITRs were authentic. "That can be done by any notary public", fumed Senator-judge Miriam Santiago before her blood pressure bolted to a worrisome 180/90.

Notarization of Corona 's ITRs, in some obscure office as demanded by Maid Miriam, would not have brought out the crisp documented answers that Henares provided. They bear on the example set by the chief justice on tax paying. Some points of Henares testimony:

Corona's gross income ranged from of P465,000 in 2006 to P657,000 in 2010, as shown by Alpha List on tax payments by justices. His net worth, declared at P9.5 million in 2006 bolted to P22.9 million in 2010.

Wife Cristina, became a registered tax payer in September 2003. That was for purchase of an P11-million house in La Vista subdivision, Quezon City. What about income as a Camp John Hay officer? "BIR is examing whether she had the capacity to purchase the La Vista property".

Corona's daughter, Carla, declared a 'taxable income' of P8,476 in 2009. Carla bought an P18 million property in on October 18, 2010 or 10 months after she filed her ITRs. Sellers? The Chief Justice and wife.

Daughter Charina, had no income tax returns when she bought a McKinley Hills property in Taguig City from Megaworld Corp in October 2008. "Not a single income tax return?" asked the prosecutor. "None sir," Henares replied. The buyer is registered with us as an one time taxpayer."

So, how could Corona buy into Bellagio Condos, etc? Future hearings may show math that prove financial clout. For now, the modern axiom will do: "If you live in a tin house, don't leave can openers lying about."

Another question is being asked this early Will BIR's Kim Henares be to the Corona impeachment what Banker Clarissa Ocampo turned out to be for the Joseph Estrada impeachment in 2001?

A day before judges, in the Estrada impeachment trial, were to go on Christmas break, Rep. Joker Arroyo and prosecutors presented a "surprise witness": the "impeccably groomed... the Equitable-PCI Bank's Clarissa Ocampo.

She sat (Erap's) left side, 'about a foot away,' as he signed 'Jose Velarde' on documents for a P500 million investment in the Wellex group, owned by a presidential crony.""He did not sign his real name," Ocampo said. "So, I did not authenticate his signature." She was one of the very few who could link Estrada to the Jose Velarde persona. She was very, very scared".

"She came forward in December after Senate prosecutors alleged that a mansion bought for one of Estrada's mistresses had been paid for with a \$2.8 million check signed by Velarde. Philippine law requires officials declare their assets. But Estrada admitted to only \$700,000, recalled Bloomberg Businessweek.

Ocampo's revelations helped spark Esda II that forced Estrada to quit. Ocampo flew to the U.S. after she testified. She joined ABS-CBN this year as it's chief financial officer.

Henares seems to come from the same mould of Filipina professionals with grit: Justice Cecilia Munoz Palma, PCGG's Haydee Horac, Commission on Audit's Heidi Mendoza and Clarissa, among others. Tiene cojones is the irrevent accolade paid to them by some. "They have balls." **Cont. on page**

Why Panagbenga Will Not Benefit Baguio

February will mark the opening of PANAGBENGA! Tourists, especially domestic tourists, will be flooding our streets. Expectedly the mass of people will be too many such that nobody will be able to move freely in our streets. Baguio City will be like Quiapo on the Feast of the Nazarene! But this is exactly my point why I believe that Baguio will lose in the tourism market share.

Take Quiapo of Metro Manila. The businesses supported by the ambience of the municipality are pirated DVDs, prostitution, fishball stalls, kikiam stalls, bar-b-q ambulant vendors, odok, adidas, betamax, peanut selling, segunda manos, balut, penoy, and all those street food. Yet, annually, Quiapo has its procession of the Holy Nazarene where perhaps close to a million people participate. Just like Baguio, annually there are close encounters of sweating bodies in our sidewalks and overpasses. The crowd is so tight that hardly anyone would notice if someone would pinch another's ass so hard or so lustfully.

Did the mass of people annually running to the streets of Quaipo made Quiapo more prosperous than the other municipalities of Manila or Quezon City? No. Similarly, this is the case for Baguio City because our own development priorities converted what was once a beautiful city into the dirty-kitchen of Northern Philippines. People flock to the city for only a short while and those that are most attracted are not the people with the highest level of incomes. There is quantity or a large mass of people but the purchasing power of the many are not high enough to boost the economy of Quaipo. Further, people massing to Quiapo are not those who intend to stay long and spend much in Quiapo.

What is true for Quiapo is also true for Baguio City's PANAGBENGA. PANAGBENGA attracts some tourists with good money to spend but the larger bulk that would be coming are those with less money, the curious types focused on the parade and not really on what Baguio City can comprehensively offer to tourists. Quantity but lacking quality.

Of course, nothing in this discussion should be taken to mean that I would like Baguio City to be a city of the rich or that only the rich have the right to visit the city. However, PANAGBENGA is never part of the indigenous traditions of Baguio City. PANAGENGA is essentially for attracting tourists. It is one of Baguio City's business. However, while we will attract some tourists in PANAGBENGA, the qualities of the tourists that we will be attracting are not those types who would stay in the city for several days or weeks. We are merely attracting a mass and not those who would be spending much in the city.

It is the opinion of the PEACE COMBATANT that the correct route for reestablishing the city as a premier tourist destination is to strengthen the city's ambience or image as a large nature city of the north with a unique ecology of cold **Cont. on page 11**

Rationalize, Not Kill, Mining!





(NOTE: This is part of a series of articles written by the Times Publisher on mining after he revisited recently Mount Diwata or Diwalwal, hub of small scale mining in Compostela Valley Province.)

"Let's not kill mining. Instead, we should rationalize it."

The mining industry today is at a crossroad. Both for small scale and large scale mining. Anytime this month, President Aquino will announce his administration's "new" mining policies. My sources told me the office of Executive Secretary Jojo Ochoa will put on the presidential desk soon for the President's signature the executive order. A task force commissioned to study mining has sent in its recommendations.

There are "leaks" going the rounds of what those papers contain. Some are accurate, others are mere speculations. Some mining industry players fear that a radical shift in the government's mining policy will not only drive away foreign investments but will kill existing projects already on stream. When this happens, the whole economy inevitably, together with the people, will get the ultimate backlash. The Chamber of Mines of the Philippines, headed by Phillip Romualdez has a policy paper for consideration in behalf of the mining industry. Not to be outdone, anti-mining advocates, notably Ms. Gina Lopez of ABS CBN Foundation, including the Catholic church intensify their pressure tactics, to somehow sway official decisions. It's fair game for all.

What President Aquino will announce soon will definitely have strategic implications on a long term. It will have far reaching effects - positively or negatively, depending on what will come

out and which side of the fence you are in.

NO TO "STOP MINING" – In my case, I am for sustainable and responsible mining. I do not agree with the "stop mining" or "no to mining" campaign of anti-mining advocates, although I respect their views. I am for the rationalization of the mining industry to make it a potent driver of the economy; to improve the lives of those in remote and far flung areas, mostly our indigenous peoples or lumads. They never had this opportunity ever.

To me, stopping mining is nothing but a sure-fire formula of depriving the poor and the forgotten, an opportunity to make a breakthrough from poverty. I refuse to accept the proposition that we leave alone the rich minerals lying there beneath their feet "for the future generation". By golly, why worry more about the future when we cannot even take care yet of the present.

The anti-mining campaigners can easily whip up emotions. To agitate support, they present doomsday scenarios. Appearing to be taking the high moral ground, they ride on tragedies, like floods and calamities, as their convenient propaganda vehicles. They resort to scare tactics. And they squeeze dry those incidents "to the max". Well and good. Their campaigns should pressure the mining industry, government and all players to do better. But to kill the industry is something else. Because they also kill the dreams of the poor.

Yes, indeed, there are culprits and bad guys in the mining industry who deserve the bashing. But there are guys too who do good. For example, we should not lump up the sins of the small scale miners with those of large-scale corporate miners who have been doing a good job. The latter have the ways and means of addressing the dangers anti-mining sectors predict may happen. Big, developed countries like the US, Canada, Australia built their economies starting with mining. Their mining footprints did not devastate these countries. Look at where they are today. Many of these reputed mining companies come from these capitals and have imbibed the best practices of the industry where they come

WHERE IS NATIONAL GOVT? - We have enough good laws to address many of these valid concerns. The implementation however falls short. Our own national government must take the lead to promote mining but at the same time seeing to it that the industry does good than harm Unfortunately, this is not so today. Government, when the crunch comes, even abdicates its own authority.

A case in point. It showed reluctance in exercising its authority to crack the whip on local government units exceeding their authorities. It did not decisively act to help the multi billion dollar SMI Tampakan project, a project the government says it is supporting, when the South Cotabato province passed an ordinance disallowing it. "Impeachment Not Sole Prerogative Of Congress"

SC ASKED TO STOP CORONA TRIAL: Now, it would seem that the proverbial bridge to be crossed has already been laid before all Filipinos on the issue of whether the Supreme Court can act against the Senate doing its job as an impeachment court, with the filing of a petition with the tribunal by Chief Justice Renato Corona seeking to stop his trial.

Is the impeachment court really supreme on matters of impeachment trials, as senator-judges and congressmen-prosecutors have been saying, so that not even the Supreme Court can do anything against the acts of the Senate while it is trying an impeachment complaint?

Or, as Corona's lawyers are now arguing in their petition before the high court, the Supreme Court really has the power to correct, amend, modify or even reverse or nullify orders or resolutions of the impeachment court which are perceived to have been issued in grave abuse of discretion?

JUDICIAL POWER VS. ALL BRANCHES OF GOV'T: The law here is Section 1, Art. 8 of the 1987 Constitution, which, in two paragraphs, provides: "The judicial power shall be vested in one Supreme Court and in such lower courts as may be established by law.

"Judicial power includes the duty of the courts of justice to settle actual controversies involving rights which are legally demandable and enforceable, and to determine whether or not there has been a grave abuse of discretion amounting to lack or excess of jurisdiction on the part of any branch or instrumentality of the Government.'

The key phrase here, it would seem, is "to determine whether or not there has been a grave abuse of discretion amounting to lack or excess of jurisdiction on the part of any branch or instrumentality of the Government", which is a phrase that has already been explained twice by the Supreme Court.

"IMPEACHMENT NOT SOLE PREROGATIVE OF CON-GRESS": In the case of "Ernesto B. Francisco, Jr. vs. Nagmamalasakit na mga Manananggol ng mga Manggagawang Pilipino, Inc.", G.R. No. 160261, November 10, 2003, written by the present Ombudsman, former Justice Conchita Carpio Morales, the Supreme Court said: "... the Constitution did not intend to leave the matter of impeachment to the sole discretion of Congress..." (found at pages 130-131 of Supreme Court Reports Annotated, Volume 415).

This was reiterated by the Supreme Court in "Merceditas Gutierrez vs. House of Representatives", G.R. No. 193459, February 15, 2011, where it said: "The Court finds it well-within its power to determine whether public respondent (House of Representatives) committed a violation of the Constitution or gravely abused its discretion in the exercise of its functions and prerogatives that could translate as lack or excess of jurisdiction, which would require corrective measures from the

On the argument that the power of the impeachment court to act came from the people, the Supreme Court said its own power to review the acts of all branches of government, including the Senate acting as an impeachment court, also came from the people themselves, when they ratified the very Constitution that contained the power of judicial review against all branches.

DENR Secretary Ramon Paje repeatedly announced support for the SMI's plans to operate an open pit mine, he denied SMI's ECC (Environment Compliance Certificate) because it is into open pit mining. What contradiction! In Zamboanga del Norte province, TVIRD, a mining firm affiliated with a Canadian mother company which has been responsibly operating for about 9 years and well accepted by its host communities but still with a few years of remaining mine life had to go to court alone to battle a similar ordinance. It has surfaced lately in the court hearings that the province is exploiting environment issues when its real motive is to shakedown TVIRD into giving more to the province. Up to now, the national government, supposedly the owner of the minerals and the entity that contracted the mining company to extract minerals, is just sitting helplessly by the wayside. No wonder many investors, mostly foreign, are now starting to look somewhere else to go. Pity because we are now hoarse in crying for foreign investments to come. In this case, we foolishly squander it by driving them away.

WHERE'S MINING INDUSTRY? Tragically, the sector directly affected, the mining industry itself, has been nonchalant about dealing with anti-mining issues and propaganda. It merrily goes about its profitable business with not much regard to winning the hearts and minds not only of its stakeholders but the bigger audience as well. In the face of a growing antimining sentiment, the industry allows this avalanche of disinformation to sway public sentiments without helping much to clarify and explain. Their reactions, if not too late, are laid back. They are not rising I begin to suspect up to the occasion. that perhaps some of those in the mining industry, especially the foreigners, get cold feet because they just prefer to lie low and avoid being "political". They may lose by default!

Here is another irony. On the ground, while some mining companies enjoy the support and goodwill of the host communities, people who are not the locals are the loudest in raising their hackles against these operations. How sad because the are the more noisy and the more vociferous ones. And the public wrongly thinks they espouse the preponderant view. Some politicians do not know any better. They jump into the bandwagon to appear publicly as environmentalists, or conservationists without much of serious study. It's the easiest way out. (But having been a politician myself before "that is par for the course", to use an old

INITIAL FEEDBACKS — I am saddened to know that unlike in the past, mining today appears to be no longer considered one of the principal drivers of the economy. Some members of the Aquino cabinet were even reported as scoffing at the low contribution of mining to the national economy. They profess ignorance of the big positive impact a mining company brings to a remote host municipality and If they look only at the its environs. amount of excise tax being paid, (2%) then they can say it's pitifully low, that even if they close down mining in the country, it will not matter much because it is an insignificant factor in the economic profile. Sorry, but those facts do not give a complete picture. They fail to reckon the totality of mining's contribution. It's not only taxes. We must factor in the government's share as agreed in the Mineral Production Sharing Agreement (MPSA), the salaries and wages paid to the thousands employed, the income taxes paid, the roads and infrastructure built and maintained for the host communities, the required social and development projects (schools, scholarships, livelihood programs, etc); the royalty funds turned over to the host indigenous peoples (lumads): the security-related expenses, (which mining companies have to bear by necessity, given that government cannot physically protect everyone), the extent of business and economic activities it generates specially in the locality, the required rehabilitation fund and the volume of money infused into the local economy on the various operational activities. And so on and so forth.

I'm sure I missed some points but the mining industry must put these numbers together accurately and clearly. And fast! If you total it, it's definitely not peanuts to scoff at. The industry should have done this arithmetic a long time ago. I am surprised. Even the business sector is tentative in what action to take when the whole business community, not only the mining industry is at a crossroad. Wake up boys and girls!

WINDFALL—If the government makes the right moves, the reported measly contribution so far of the mining industry to the Gross Domestic Product (GDP) can rise dramatically and perk up the economy. It can serve as a windfall — the button just waiting to be pushed. For instance, the US\$5.9 billion direct investment of Saguittarius Mining Inc. in its proposed Tampakan project can perk up Mindanao's GDP several notches higher. Instead of government making light of mining's impact, it should instead view it as an opportunity and a readily available tool, just waiting to be tapped, to spurt the regional and national economy. It's badly needed, especially nowadays, when the economic trend is on a downward trajectory.

PROPOSALS —There are proposals for a review of the tax holidays to mining. Or an increase of the 2% excise tax to 5%. There's this proposal that will factor in the so-called total economic value formula, whatever that means. Then there's the complaint of local government units about the low and slow flow of benefits from mining companies that they host. Well and good. Whatever they are, it's always desirable for government and the people to have a bigger piece of the action. But the bottom line is to retain investors' interest and not drive them away.

SMALL SCALE —Rationalizing the small scale mining industry is also a must. Small scale mining should not (and CANNOT) be totally stopped but must be brought within the ambit of law and regulations. As we have seen, mostly, they are the harbingers of many problems, environmental or otherwise. (I cannot understand why anti-mining voices are focused at big scale mining and not at the real culprits.) Despite past efforts, government failed to follow through on this. The whip must be cracked to totally stop the environmental harm and damage. So sorry to say: during our time, efforts were exerted but did not fully succeed.

WAY FORWARD —My unsolicited advice is for the national government, as owners of all minerals to consolidate control over these resources, rationalize the system so that government, the communities and all stakeholders get their due and equitable

share, punish and weed out the bad guys and allow to operate only responsible and compliant mining companies which have good track records and capable of using world-class best practices and technology in the business. And use mining as one of the principal drivers of improving – not destroying or harming— the well being of our people. Killing the industry is not the answer, folks! It's like killing the hen that lays the golden egg just because it shits everywhere when all you have to do is clean it up!

In the midst of these uncertainties, only President Aquino can finally put clarity to all these with the awaited policies to be announced soon. Also, he must put to rest the "floating" status of DENR Secretary Ramon Paje. Competent and well meaning, he is neither here nor there because his non-confirmation in the Commission on Appointments is still a "sword of Damocles" hanging over his head. The President must also put to rest the growing, but perhaps speculative, fears of alleged policy-capture by some "anti-mining" elements who now walk the corridors of power. The mining industry is so vital that we cannot just relegate it to the dustbin. Or leave its fate in the hands of those who want to kill it.

Will President Aquino do the right thing? Let's watch and see.

Walter William's Journalist's Creed

This creed was written by Walter Williams (1864-1935), the man who founded the world's first school of journalism at the University of Missouri and perhaps contributed more toward the promotion of professional journalism than any other person of his time.

I believe in the profession of Journalism.

I believe that the public journal is a public trust; that all connected with it are, to the full measure of responsibility, trustees for the public; that acceptance of lesser service than the public service is a betrayal of this trust.

I believe that clear thinking, clear statement, accuracy and fairness are fundamental to good journalism

I believe that a journalist should write only what he holds in his heart to be true. I believe that suppression of the news, for any consideration other than the welfare of society, is indefensible.

I believe that no one should write as a journalist what he would not say as a gentleman; that bribery by one's own pocket book is as much to be avoided as bribery by the pocketbook of another; that individual responsibility may not be escaped by pleading another's instructions or

CJHDEVCO Wanted to Cut 1,033 Cordillera trees in John Hay, Rescinded **Contract when BCDA Stood** Firm to Uphold Environmental

earthballing that will affect 1,033 trees in John Hay.

BCDA said that only the Department of Environment and Natural Resources (DENR) is the only government agency authorized to issue tree-cutting and earthballing permits.

"We want to comply with environmental laws," Casanova said, "However, CJHDevco wanted us to exceed our authority by demanding that we approve their pending tree-cutting permits. When we did not give in to their demands, which may expose us to legal liabilities, they unilaterally rescinded the contract and are now claiming an atrocious amount of P14.4 billion from govern-

"We cannot be faulted for adhering to the rule of law. Gone are the days of impunity. We have a government now that stands for integrity and the rule of law, particularly laws that protect our environment," Casanova said.

Casanova emphasized that it is CJHDevco who owes government P3.024 billion, and has used the pending permits at the OSAC as excuse to evade their ballooning obligations.

"What they wanted us to do may be illegal," Casanova pointed out. "Now their flimsy excuse is backfiring on them.'

Recently, the DENR issued a cease and desist order for the cutting of trees inside the JHSEZ. The order is based on Executive Order No. 23 issued by President Benigno S. Aquino III on the moratorium on cutting and harvesting naturally grown trees since John Hay contains one of the biggest remaining pine forests in Baguio.

The John Hay Management Corporation (JHMC), BCDA's estate manager in the JHSEZ, reassured the public that DENR issued no permits for tree-cutting and earthballing despite CJHDevco's demands.

CJHDevco's demand letter shows that the lessee required BCDA to "cause the approval of all the applications currently pending and overdue and deliver to CJHDevco within the same period, all corresponding permits, licenses and certificates covered.'

CJHDevco enumerated fifteen permits pending with the One-Stop Action Center (OSAC). Of these fifteen, ten were for tree-cutting earthballing.

According to OSAC records, a total of 1,033 trees will be affected if CJHDevco's pending permits were approved. Of these, 520 trees will be cut and 513 will be earth-balled.

Except for the tree-cutting permits, the OSAC has issued a total of 89 permits in 2011. Of these 89 permits, 59 were issued to CJHDevCo and its sub-lessees. Ayala Land Inc. and other JHMC locators did not have any problems in acquiring their permits within the 30-day period.

Last year, the region made it in the three categories, with Violeta Salda of the Benguet State University establishing a record by winning her second "Lingkod Bayan" plum. Edgar Madlaing of the Benguet Schools Division copped the "Dangal" and the Abra Dental Team received the "Pag-asa" group award.

The Presidential or Lingkod Bayan Award is conferred on an individual or group "for exceptional or extraordinary contribution resulting from an idea or performance that had nationwide impact on public interest, security and patrimony'

Then mayor Thomas Killip of Sagada, Mt. Province received the Lingkod in 2001 for leading his constituents in making their town the first Peace Zone in the country. Baguio mayor Mauricio Domogan won it in 1995 for steering the city back to its feet after the July 16, 1990 earthquake.

The Pag-asa Award (individual or group) is "for outstanding contributions resulting from an idea or performance that directly benefit more than one department of the government".

Among the prominent winners is the Under-Five Clinic of the Baguio General Hospital (2002), a brainchild of the late Dr. Natividad Clavano as her base in pushing breast-feeding and developing the medical center as world's model baby and mother-friendly health facility.

The Dangal Award is for "performance of extraordinary act or public service and consistent demonstration of exemplary ethical behavior." Ifugao congressman Teddy Baguilat Jr. received the award in 1996 as then mayor of Kiangan town, while then Baguio jail officer Vilma Fangsilat took it in 2001.

Three Cordillera health workers nurse Rosario Magala and midwife Elena Buenafe, both of Abra, and midwife Teresita Dodon of Sablan, Benguet - were honored posthumously with the Dangal in 1994.

Sometime in 1993, Magala and Buenafe were on their way to immunize children and distribute iodine capsules to a remote barangay when they were swept by strong currents while crossing a swollen river.

That same year, Dodon was coming home after a whole day immunizing children in far-flung barangays when she fatally figured in a vehicular accident.
"As she lay dead on the road, she

was still protectively clutching the vaccines and medical paraphernalia, the tools of the trade she loved so much, " the Dangal citation pointed out.

The region has so far installed 11 champions in Metrobank's roster of outstanding teachers, according to regional director Leonardo Quitos Jr. of the National Economic and Development Authority who earlier called on schools to nominate elementary, high school and college teachers for the

Among last year's 10 outstanding teachers was Vilma Ambat of the Baguio City National High School. She is the fourth winner from Baguio and the school, according to Metrobank Foundation president Aniceto Sobrepena./ Ramon Dacawi.

and safety, enhance the right of the people to a balanced ecology xxx", as one of the basis for his request to the President. Bilog stressed further that the area where SM intends to implement its expansion project development is one of two remaining forested areas in the Central Business District (CBD) of the City and that these two areas contribute in reducing air pollution within the CBD area. He warned that cutting the 182 trees will definitely result in ecological disturbance that will contribute to global warming and pose other environmental threats to the citizens to Baguio.

Councilor Bilog also explained in his proposed resolution that pursuant to the alter-ego doctrine, the President of the Republic has the power to review decisions of department heads pursuant to the President's power of control over all executive departments, bureau and offices. The President may then, as averred by Councilor Bilog, affirm, modify, alter or reverse the administrative decisions issued by his subordinate officials.

Simultaneous with his proposal to request the President of the Republic to reverse the decision of DENR Secretary Paje allowing SM to cut and earthball trees within their property at Luneta Hill, Councilor Bilog has also filed another proposed resolution this time urging the Shoe Mart Development Corporation (SMDC) to reconsider its plan of cutting down and earth balling 182 trees in pursuit of their plan to further develop

The explanations contained in the second proposed resolution of Councilor Bilog are more or less the same with his previous justifications in requesting President Aquino to reverse the decision of the DENR secretary, albeit with the addition of some more pertinent laws such as Article XII, Section 2 of the 1987 Philippine Constitution which provides that "the exploration, development, and utilization of natural resources shall be under the full control and supervision of the State". and Executive Order 23 which says that "It is the obligation of the Sate to protect the remaining forest cover areas of the country not only to prevent flash floods and hazardous flooding but also to preserve biodiversity, protect threatened habitats and sanctuaries or endangered and rare species, and allow natural regeneration of residual forests and development of plantation forests"./ Briccio Domondon Jr./Information Officer/ Sangguniang Panlungsod (SP)

Assistant Regional Director Dr. Ramon Santiago during the Regional Student Nurses' Congress which was held here at the St. Louis University here last week.

According to Manalili, nursing graduates remain to be the top clients of the PRC in terms of number of graduates taking the licensure examination, and for the past eight years or so, nursing also captured the limelight on issues such as oversubscription, unemployment and over-employment.

Manalili explained that the national government, mindful of these challenges, provided initiatives to address the so called over-supply of nurses like the NARS (Nurses Assigned to Rural Service) and the RN HEALS (Registered Nurses for Health Enhancement and Local Service) programs. It is also engaging in the continuing talk with Business Process Outsourcing(BPO) industry in the hope and desire to find alternative jobs for nurses specifically medical transcription, health and medical services.

She also said that the commission's data from the licensure examination in the last five to ten years as well as its projection in the next five to ten years, have provided valuable information not only on the present oversupply of nurses but more importantly on finding a solution.

Manalili also disclosed that PRC is trying to open up Japan's market to Filipino nurses and other professional workers through a technical cooperation project between the Philippines in Japan or under Japan-Philippines Economic Development Agreement (JPEPA).

In addition, Manalili also informed that the PRC's Board of Nursing is also pushing for the adoption of a competency based national nursing career profession program which is a more directed and rational training for Filipino nurses towards general nursing practice since trending demand for nurses now is competency based.

On the part of CHED, Santiago said that the Commission has came out with a moratorium on the nursing program. CHED is pushing for the improvement of the policies, standards and guidelines that govern the nursing education and profession and for its strict implementation on higher educational institutions (HEIs) that are offering nursing program.

Santiago also bared that CHED , in partnership with the PRC, Philippine Nurses Association (PNA) and other partner stakeholders are closely monitoring the performances of HEIs with nursing program and that they are ready to close down or give sanctions to any institution that does not adhere to the policies, standards and guidelines of quality nursing educa-

"We are trying to do this to protect the general welfare of the public the parents, students, and the other who are helping provide education for our nurses. The commission and other stakeholders, are one with you in promoting safe and quality nursing care in clinical practice," Santiago said.

Nurses' Congress, now on its 7th staging, was initiated by the Association of Deans of Philippine Colleges of Nursing Cordillera Chapter and the Cordillera Association of Nursing Deans./JDP/LD-PIA CAR

The city government completed the bidding of the facilities last Jan. 27.

The mayor said the bid offers have been evaluated but he has yet to receive the result of the evaluation from the city Bids and Awards Committee.

Based on the TOR, the bid components will be for the rehabilitation and rental under the conditions that the operator shall invest a considerable amount of money for the rehabilitation, upgrading and expansion of the plants to produce 41,406,178 The said Regional Student kilowatthours, install independent substation and power line to the national grid.

The terms also provided the schedule of remuneration to the city government and other concerned parties including the provincial government of Benguet, municipality of Tuba and barangays Tadiangan and

Nangalisan where the plants are located and including the surface owners whose properties are affected by the pipelines and plant facilities.

Farmers use sprinkler or overhead irrigation overnight or early morning to counter the development of ice in plants. Frost does not immediately manifest and settle. It takes around three days, hence, the application of sprinkler or overhead irrigation helps counter the development of ice in plants, said Bentres.

It also occurs in plantations found between mountains. There is no air movement or air flow leaving the plants undisturbed which is the reason why ice emerges, according to Bentres. /SCA PIA-CAR/Benguet

C, PNP Approves PTC for **Suspension During Panagbenga**

The citizens of Baguio can expect a gun-free Panagbenga Flower Festival this 2012.

The Chief of the Philippine National Police, Police Director General Nicanor A Bartolome approved the request of PRO-COR Regional Director, PCSupt Benjamin B Magalong for the Suspension of Permit to Carry Firearms Outside Residences or PTCFOR in a memorandum from the Office of the C, PNP, National Headquarters issued February 6, 2012.

The memorandum stated that in view of the celebration of the "Panagbenga" Festival, all Permits to Carry Firearms Outside of Residence (PTCFORs) are hereby temporarily suspended for twenty four (24) days effective February 10 to March 4, 2012 in Baguio City. Moreover, it indicated that only members of the PNP, AFP and other Law Enforcement Agencies who are performing official duties and in agency-prescribed uniforms will be allowed to carry firearms in the city. This is to ensure the peaceful and orderly celebration of the "Panagbenga" Festival and to make it free from any firearm-related incident.

In addition, the said directive will be implemented through the Police Integrated Patrol System (PIPS), which includes the conduct of checkpoints, LOI SITA/Oplan Bakal, mobile/beat patrols and other police security operations in close coordination with the AFP, other Law Enforcement Agencies, government agencies and LGUs.

The temporary suspension of Permit to Carry Firearms Outside Residences (PTCFOR) was also implemented during the 2011 celebration of the Flower Festival which was one of the security measures of the Baguio City Police Office considering the influx of local and foreign tourist in the city. The last year's implementation resulted to a zero case of gun related incident and contributed greatly to the decrease of 28.3% of crime volume from 1,191 cases on 2010 to 854 cases on 2011./ KARISSMA STA JUANA, Police Inspector, PIO, BCPO,09178132009/09399089664/ bcpopio@gmail.com

Mavor: No Need to Halt Asin Bid

BAGUIO CITY – Mayor Mauricio Domogan on Wednesday said there is no need to stop the bidding of the Asin mini-hydroelectric plants despite an appeal from the Tuba town officials to stay the bidding due to questions on the mini-hydroelectric plant no. 3 lot ownership and claims payment.

"I don't think it's an issue that would merit stopping our bidding out the facilities," the mayor said during his Ugnayang Panlungsod press briefing.

He said he has referred the matter to the city legal office in coordination with the Baguio Water District (BWD) which possesses the documents on the lot ownership and BWD General Manager Teresita De Guzman has agreed to cooperate in the investigation.

The mayor said the issue is not a ground to halt the bidding as he sees no problem whether the lot occupied by the subject plant would turn out to be Tuba's or not.

He said that if indeed Tuba town owns the lot then the city is willing to pay whatever obligations it will incur.

On the other hand, if it is established that the lot is not owned by Tuba, then the municipality will also have to stop claiming its national wealth tax shares as there would no more legal basis for such claim.

The mayor said the issue on lot ownership cropped during his previous term as city mayor. "It is high time to settle this issue once and for all," he said.

The mayor said Tuba Councilor Roger Kitma met with him to air the town council's wish to defer the bidding of the facilities to first settle issues on the payment of rental fees on the lot occupied by the plant no. 3; payment of the power consumption as per the provisions of the Electric Power Industry Reform Act or EPIRA law; and payment of claims of landowners whose properties are affected by the pipelines and plant facilities.

Domogan, Farinas Defend Grant of Financial Support to Panagbenga

BAGUIO CITY - Mayor Mauricio Domogan and Vice Mayor Daniel Farinas on Monday defended the city government's grant of financial support to the Baguio Flower Festival amid questions on the practicability of extending such subsidy.

'I think it is but proper that we continually support this activity because it is our own festivity which has evolved into a much-awaited national and even international event. To run a festival of this magnitude would necessitate the cooperation of both the public and private sectors," the mayor said.

The mayor said that the P2 million subsidy being given by the city government annually is worthwhile considering the benefits that the city derives from Panagbenga in terms of promoting tourism and enhancing the city's economic activity.

The mayor said the city has to sustain its financial aid to the festival due to the enormous financial requirements which he said cannot be raised by organizers by merely relying on sponsorships and donations.

He said funds derived from sponsorships and donations are not definite as these are dependent on what the sponsors could actually deliver whereas the festival would need definite funds to defray expenses including the prizes promised to competitors in the various events.

City Administrator Carlos Canilao said the Baguio Flower Festival Foundation Inc. (BFFI) has programmed P11 million for the activity this year. The P4 million is expected to be provided by the city government and Rep. Bernardo Vergara so the organizer will have to fork out P7 million through other means.

Farinas for his part said that it is the city government's duty to promote tourist-oriented activities like the Panagbenga, tourism being the lifeblood of Baguio's economy.

He said he was informed that other local governments have been extending relatively bigger subsidies to their own similarly established festivals and it is but natural that Baguio support its own festival to create further economic activity and to sustain people's interest in coming to the city.

"We should not block this activity otherwise we will lose our tourists and our economic activity so we should unite in supporting this activity," he said.

The city council that afternoon approved the proposed budget of the city administrator's office including the P4 million subsidy for the festival. Cont. on page 11
