together, united as a community,

as a movement that is guided by the right knowledge and information on climate change adaptation and mitigation.

This is the climate change mitigation and adaptation approach that Philippine Information Agency Director General Jose Mari Oquiñena wants to bring to every Filipino and in every community in the country. He bared this in his inspirational talk during the PIA - National Capital Region- led Association of Information Officers in Metro Manila (AIMM) Skills Enhancement Seminar and Climate Change Forum here last week.

Oquiñena pointed out that climate change mitigation and adaptation is not only about dealing with the science of it but also about building a movement, a united front against climate change in minimizing its impact especially on loss of lives, because it cannot be done by any single institution or even by the government bureaucracy as a

"We have to stop looking I nto climate change as a science but as threat to our way of life, wherein we need a way for us to bond together for survival," he said.

Oquiñena encouraged the participants that as information officers and communicators, to help bond people together as a united front that will bring more strength in the fight against climate change.

He shared that they have spent a month in Yolanda- stricken areas and personally experienced the grief brought about the devastation though as they initiated a "Bayani Challenge" movement, he also shared that than 1.6 million people joined to help in rehabilitation efforts.

For the climate change advocacy campaign, Oquiñena also encouraged them to help bring in new and creative approach in order that the younger generation will be well informed about climate change so that they will be more prepared to deal or face the threat that climate change brings. They could also be examples to others.

Oquiñena pointed out that with communication as a powerful tool, as information officers they have the responsibility of giving the right information that will better equip them with the knowledge and skills in dealing with climate change.

"It is truth versus responsibility. I am not telling you to stop saying the truth but at the same time we must also help the younger generations become more successful Filipinos than us (as far as climate change adaptation and mitigation is concerned)," Oquiñena stressed./JDP/CCD - PIA CAR

Opportunities For Phl Tourism Industry,

DOT says

BAGUIO CITY - Regional integration for ASEAN Economic Community 2015 will open the door for more opportunities for the country's tourism industry.

Department Tourism(DOT) Policy Formulation and Evaluation Division Alex Macatuno, in the Department of Trade and Industry (DTI)- led AEC 2015 Forum here on Monday, said that AEC 2015 will open more opportunities for people in the tourism and hospitality sector. Filipinos he said have already established a very good track record and a competitive edge in the global market.

"Our workforce are very good and more competitive compared to other member states in the tourism industry. I say this not as a Filipino but it can be said on how many Filipinos are working on hotels abroad, how many are performers overseas and how many are in the cruise industry; so this is actually an opportunity primarily to our people," Macatuno said.

He also informed that locally, AEC 2015 can bring in more foreign investment especially in hotels and restaurants, which could create more employment for the country's tourism and hospitality workforce, as well as increase in tourist arrivals from neighboring ASEAN

For the mobility of tourism professionals and workers, Macatuno reported that skills enhancement trainings are already being implemented to prepare tourism workforce. He said that the possible influx of Filipino workforce abroad will not create a vacuum in the industry as studies show that there are more than enough students going into the industry'.

"It is just a matter of giving them the opportunity to enhance their skills and potentials", Macatuno said.

For boosting the country's tourism industry in preparation for AEC 2015, Macatuno pointed out the need to develop new products and in bringing in more tourism infrastructure development projects.

Macatuno disclosed that the country, through DOT is set to sign a Cruise tourism development project with Viet-

In terms of foreign tourist arrivals, though it increased from around 3.5 million in 2012 to 4.2 million in 2013, the Philippines still ranks sixth among the 10 ASEAN member countries. Macatuno reported that more work needs to be done on tourism infrastructure.

"Connectivity and seamless travel on air, water and land, for both foreign and local tourist is very vital for the tourism industry", he stressed.

He reported that the DOT and the Department of Public Works and Highways road infrastructure projects are already gaining ground and the national government is also already investing on the airports and seaport development projects./JDP/ CCD - PIA CAR

City Records Increasing Cases in Renal Disease

BAGUIO CITY - Mayor Mauricio Domogan is alarmed over the increasing number of patients undergoing Hemodialysis in this mountain resort.

The mayor announced his concern Thursday during the Ugnayan Presser aired live on Sky Cable and DZEQ Radio ng Bayan.

Domogan said, "the lifestyle and lack of exercise among city residents might be a factor in the bloating number of dialysis patients in the city.'

'Diet, Exercise and Attitude are the key factors for a healthy body," Domogan said.

As per reports from the Department of Health-Center for Health Development-Cordillera Administrative Region (DOH-CHD-CAR), there is an increasing trend of patients undergoing Hemodialysis in the region.

The top three leading causes of End Stage Renal Disease (ESRD) it said are Hypertensive Nephrosclerosis, Diabetic Nephropathy and Glomerulonephritis gathered from the hemodialysis clinics in CAR.

This however does not show the true picture of the region because only the province of Abra, Baguio City and Benguet have Hemodialysis units with which the data was gathered.

Presently, there are 6 hemodialysis clinics in Baguio, 1 in Benguet and 1 in Abra.

Other patients of the Cordilleras seek consultation in nearby regions, the report said.

The report showed the Hemodialysis Clinics cater to 79.6% of total cases from CAR while 20.4% are from other

36.8% of new cases annually come from Baguio City, 27.8% come from Benguet, 6.3% from Abra, 6.1% from Mt. Province, 1.2% from Kalinga, 1.1% from Ifugao and .3% from Apayao.

15.7% come from Region 1, 2.9% come from Region 2 and 1.7% come from other regions.

To address this, the CHD's strategy for this year is to work closely with Lifestyle-Related Diseases Program in doing information and education campaign on the prevention of renal diseases.

Priority of such activities would be the City of Baguio and La Trinidad which have the highest ESRD cases.

The CHD will also be conducting Renal Disease Screening through urinalysis for Grade 5 pupils in the region for the early detection of renal disease./Paul Rillorta

Dads Seek Public Consultation on New Anti-Smoking

Ordinance

BAGUIO CITY - seven years after it was first enacted in this mountain resort, the comprehensive anti-smoking ordinance is yet to see its needed amendment to attain its full objective for a smoke free city.

The ordinance entitled the 'New Comprehensive Anti-Smoking Ordinance of Baguio seeking to prohibit the use, sale, distribution and advertisement of cigarettes and tobacco products in this mountain resort has been put-on hold by the city council here.

The proposed ordinance Numbered 78 series

of 2013 introduced by Councilors Richard Carino, Elmer Datuin and Fred Bagbagen was deferred Monday during the regular session to pave way for a public consultation prior to its approval and eventual implementation.

The new 'smoke free ordinance of 2013' is seen as an amendatory ordinance to the existing Comprehensive Anti-Smoking Ordinance of the city approved in 2008.

The said 'new smoke free ordinance' for the city as Vice mayor Edison Billog pointedout is already a repetition of a national law.

City Eyes Long Term Options Ifugao RTC Judge to Ease Traffic

Baguio City - the planned Monorail in this mountain resort might work magic in addressing the congested streets of the summer capital.

Mayor Mauricio Domogan sees the monorail project of the Department of Science and Technology (DOST) as a welcome development in addressing the over-crowded streets of Baguio.

Domogan said," a mass transport can effectively lessen public transport which usually crowds the Central Business District (CBD).

"We are very optimistic that the project of the DOST can be piloted in our city and if it pushes through then we will address the clamor of the public transport sector regarding their livelihood," Domogan said.

The public transport sector is cold on the proposed monorail project as this could have a big impact on their livelihood.

Domogan however stressed the public transport sector will be part of the project if they are willing to organize themselves.

"They are a priority if the project pushes through, they will be tapped and proper coordination between the city and the transport sector will be done," he assured.

The local government is looking into long-term solutions to the worsening traffic congestion problem including air pollution in the city which is attributed to the increasing number of vehicles plying the city's streets.

Domogan said," the clamor to pedestrianize Session Road will be thoroughly studied considering that it is a major thoroughfare.

"We have to pinpoint alternative routes which will not cause traffic build-up if we decide to close it down as a promenade area, this is a good concept but we have to consider everything first," he said.

The city is still awaiting the result of the study on the proposed monorail project which is also being groomed to service the BLISST area including the feasibility study of an Australian Firm on the planned parking complex for the city.

The two projects will not only address the ballooning traffic congestion being experienced in the CBD but will also add to the city's coffers if feasible.

Domogan also said the city is not closing its doors to other similar feasibility studies and project proposals from interested groups./Paul Rillorta

Reminds Witnesses of Their Civic Duty to Testify in Court

LAGAWE, Ifugao - The presiding judge of the Regional Trial Court Branch 14 here reminded witnesses of their civic duty to testify in court in order to help in the speedy and effective administration of justice.

Judge Romeo Habbiling made this reminder following his order for the dismissal of a case involving suspected communist rebels Grayson Naogsan and 17 other co-accused due to the failure of the Prosecution to present its evidence because of the non-appearance of the witnesses to testify during the trial period.

The charge of murder and frustrated murder against the accused arose from the Complaint and Information filed by the IPPO headed by Atty. Joseph Tumapang on October 20, 2011 wherein it alleged that in the morning of February 26, 2011, a platoon of soldiers of the 86th Infantry Battalion led by 2Lt. Mark Anthony Bernardino and guided by two former New People's Army members conducting security patrol in the municipality of Asipulo were waylaid by the communist guerillas resulting to the killing of three and wounding of

The three witnesses who belong to the 86th IB and are now transferred in the province of Isabela, failed to appear during the court trials because of the distance they have to travel and the time, effort and expenses they have to incur in order to testify in court located in the capital town of Lagawe.

The prosecution for several times was not able to present the witnesses and other evidence to prove their case against the accused within the period allotted for them in the litigation, hence the order of dismissal.

The non appearance of witnesses during trials is a big blow in the dispensation of justice, Habbiling claimed./JDP/DBC-PIA CAR,

EMB-DENR Regional Ecology Center

BAGUIO CITY - A linkage hub on solid waste management called the Regional Ecology Center(REC) for the Cordillera region is now being established at the Environmental Management Bureau of the Department of Environment and Natural Resources-Cordillera(EMB-DENR-CAR) office

The firming up of partnership with the various sectors is underway with its launching and forging of a memorandum of agreement tentatively set next month.

The ecology center is expected to provide technical expertise, information, training and networking services in the implementation of Republic Act 9003 or the Ecological Solid Waste Management Act.

Aside from functioning as a hub, the center will facilitate training and education in integrating the solid waste management concept. It will also promote the development of a recycling market and act as the clearinghouse for clean production or clean technologies on solid waste. It will provide or facilitate expert assistance in

Mayor Lists Priority Projects for

BAGUIO CITY - Mayor Mauricio Domogan is in high hopes for the eventual funding of the city's priority projects which remain un-finished in this mountain resort.

The projects which were conceptualized previously or have been started but needs additional funding have been brought to fore to attain the city's goals towards development.

Domogan said, "a list of priority projects needing funding is already provided to the Department of Budget and Management (DBM) which he personally handed Wednesday.

The list includes projects for solid waste management particularly for the set-up of the Integrated Solid Waste Management System (ISWMS) which he said is of major concern.

The mayor asked for additional funding for the renovation of the Baguio Convention Center which is being used on special occasions and programs.

Also included for funding is the provision of the Legislative Building beside the Baguio City Hall and a Livelihood Center.

The mayor said the provision for a rain harvesting facility beside the Baguio Convention Center is also being prepped-up.

Also included in the list for priority improvement is the concreting of the road leading to the Philippine Science High in Irisan, rehabilitation of the Mines View Park and improvement of the Botanical Garden among others.

The fund which is being asked from the national government totals more or less P800 million.

The city is also pursuing a Public-Private Partnership venture for the development of the Burnham Park, the Asin Mini-Hydro Electric Plants and the Abattoir./Paul Rillorta

Polarizing vigilantes

Are you a Catholic, Protestant, Sikh, Taoist, or Buddhist living in or visiting Malaysia? Watch it. You are not to use the word "Allah" referring to God, that country's highest court said in a 4-3 decision this week. Only Muslims may do that under the law.

Suppose you're Catholic, Protestant, Sikh, Taoist, or Buddhist just touring, or even living in, the state of Sarawak, the population of which, according to the 2010 head count, is 44 percent Christians, 30 percent Muslims, and the rest from other faiths. You may address God as "our Father" who causes "his sun to rise on the good and the evil and rain to fall on the just and unjust."

The edict applies only to the Catholic weekly Herald, Kuala Lumpur said after the decision was issued. Since 2007, the Herald had been ordered to cease using "Allah" on grounds of "national security and public order." Malaysian Christians may use "Allah" in church. Herald editor Fr. Lawrence Andrew sued, saying: "We have a responsibility to uphold religious freedom."

"Conflicting interpretations of the ban only added confusion to a debate that inflamed religious tensions," wrote The Associated Press' Eileen Ng. Ethnic Malays form two-thirds of Malaysia's population. Chinese and Indians number 22 percent and 7 percent, respectively. Christians number about 9 percent.

This ruling "shows how fast religious tolerance is falling in Malaysia," the New York-based Human Rights Watch noted. "Government should work to promote freedom of religion rather than politically exploit religious wedge issues."

Indeed, the ban appears "politically motivated," writes William Case at the City University of Hong Kong's Department of Asian and International Studies. Prime Minister Najib Razak's party failed to win a majority in the last election. He's strapped to recapture support of the country's ethnic Malay, and mostly Muslim, community.

"It's too soon to tell how government will implement the ban,"

Case adds. The judiciary may say one thing, the Cabinet another. "That would lead to further attacks on churches as Malaysia has become more polarized on ethnic, and increasingly religious, grounds. However, verbal threats against religious groups in Malaysia seldom translate into the kind of violence seen elsewhere..."

The decision doesn't stipulate the penalty for violating the ban. But it appears that a newspaper using the term would lose its publishing license. Whatever, Christians will continue to use "Allah" in bibles and during church gatherings, said the Christian Federation of Malaysia chair, Rev. Eu Hong Seng, as they did even before Malaysia split from Singapore.

In January, authorities confiscated 300 bibles in Selangor state. In late 2009, it impounded 15,100 bibles imported from Indonesia. Two Bible Society officials were investigated for breaking a state law that bans non-Muslims from using the word "Allah," BBC reported.

As of 2012, at least 17 nations (9 percent worldwide) have police that enforce religious norms, according to a new analysis of data, says the Pew Research Center. "In Malaysia, state Islamic religious enforcement officers and police carried out raids to enforce the Sharia law against indecent dress. [They] banned publications, alcohol consumption and khalwat (close proximity to a member of the opposite sex)," according to the US State Department.

Religious intolerance spawns even body snatching, blogs Mariam Mokhtar, who heads the Perak Liberation Organisation. "The most prominent [victim] is former chief justice Mohamed Suffian Hashim. A Cambridge scholar, he married Buny, a British Christian. She wanted to be cremated. But before services at the Cheras crematorium, religious officials took [the body] to Kuala Kangsar for burial according to Muslim rites."

Mokhtar cites similar body-snatching cases, including that of 74-year-old Gan Eng Gor.

Malaysia is "an ethnically polarized society," the New York Times' Thomas Fuller noted earlier. "Talent often does not rise to the top of government because of patronage politics within the ruling party dominated, until now, by the United National Malays Organization.

"A system of ethnic preferences blocks minorities, mainly ethnic Chinese and Indians, from government service. Ethnic Malays corner nearly all top government positions and receive a host of government preferences."

The local press is muzzled by licensing laws. "There has always been a kind of wait-for-instructions-from-the-top attitude." Authoritarian laws help keep an ascendant opposition in check, as the opposition's Anwar Ibrahim found in recycled sodomy charges. "The government is accustomed to getting its way. When you are not challenged in any meaningful way, you get complacent."

Late March, a once-unthinkable interfaith meeting gathered in Kuala Lumpur, after Malaysia Airlines Flight 370 disappeared. The imam cupped his palms to invoke Allah for the 239 passengers and crew. "The prayer was not unusual," wrote the AP's Eileen Ng. But the setting was a Damansara Perdana shopping mall.

"Today is a rare occasion for us to bring unity and harmony," prayed a Buddhist monk. "We are all in tears waiting for you," said Shantha Venugopal, the Hindu representative. The Taoist priest beseeched for divine intervention, while the Sikh leader pleaded for closure. A Catholic read from the hible

The rites "would have been inconceivable" before March 8 in a country "where religious bigotry is often openly displayed," the AP reported.

Vice President for Benefits Administration, said the pension hike covers about 17,200 active EC pensioners under SSS as of August 31, 2013 for permanent partial disability, permanent total disability and survivorship. Meanwhile, SSS claimants of EC funeral grants for deaths dated September 1, 2013 onwards are entitled to the higher P20,000 benefit.

President Benigno S. Aquino III approved the EC benefit upgrades under Executive Order No. 167 issued last May 26. The EC Program – which provides additional benefits for employees with work-connected sicknesses, injuries and death - is administered by SSS for the private sector and by the Government Service Insurance System (GSIS) for the public sector.

What's Wrong With City Council's Resolution Nr. 115, Series of 2014

On 16 June 2014, the City Council passed the above Resolution prohibiting public utility vehicles including jeepneys (PUJs) from picking up passengers along existing intra-city routes granted in their Certificates of Public Convenience. The Resolution was approved by the City Mayor on 19 June.

What then is wrong with the Resolution? Quite plenty, for instance, the following:

- 1. The Resolution was passed and promulgated without notice to or consultation with affected operators in the inter-city routes except for Beckel, Labilab, Sabkil and Lamut operators plying the routes along the Ambuklao trunkline. All other affected inter-city operators in the Red, Blue, Green and Yellow trunklines were not notified, consulted or given their day in court, so to speak.
- 2. The Resolution was passed by the City Council notwithstanding the contrary opinion of DOTC / LTFRB-CAR representatives given during the meeting on 3 April 2014 presided by Councilor Alangsab, Chairman of the Committee on Public Utilities, Transportation and Traffic Legislation.
- 3. The Resolution empowered the City to modify the terms and conditions in the Certificates of Public Convenience issued to inter-city jeepneys which power, supposedly, is vested by the Public Service Act and Executive Order No. 202 exclusively to the Land Transportation and Franchising Regulatory Board.
- 4. The Resolution, moreover, violated the law and jurisprudence on the matter when it directed that a Memorandum of Agreement entered into between intra-city operators (CGMVODA) and intercity operators (BAMATODA) on their common line prohibiting the latter to pick-up passengers along the Townhouse area, Felipe Street and Mansion House, to be complied with. For, such agreement is illegal (even unconstitutional), the same being in restraint of trade.
- 5. The City Council was in error when it categorized in the Resolution that inter-city route is a point-to-point route whereby operators therein cannot pick and drop passengers similar to Vehicles-for-Hire (VFH), Point-to-Point (P2P) Service and the UV Express Service. The truth is, PUJs like PUBs are allowed by their franchises to pick and drop passengers anywhere along their authorized routes.
- 6. The Resolution is confusing to both law enforcers and drivers concerned, since it is tentative and uncertain on whether or not violations of the Resolution would be meted with penalties.

While the City Council indeed has the power to approve and promulgate ordinances and resolutions necessary to an efficient and effective city government, however, it cannot do so if it infringes and it usurps the powers exclusively given by law to other agencies of government which in this case is the LTFRB. Unlike the LTFRB, it has no power to issue authorization or franchise to operate overland public transportation. Similarly, it has no power to amend and modify such authorization or franchise which powers are exclusive to the LTFRB, as provided under Sec. 16 (m) of the Public Service Act.

The City Council has already transgressed on this power of the LTFRB when it passed before Resolution Numbered 217, Series of 2005 legalizing the illegal operation or franchise of Vehicle-for-Hire vans in Baguio City. That act of the Council, similarly as in the instant case, are both ultra vires.

It cannot go on doing this!

Guv Urges Academe to Start Talking about AFTA

LA TRINIDAD, Benguet) – Governor Nestor Fongwan urges the academe to start talking about the effects of the ASEAN Free Trade Area (AFTA) agreement and instituting good agricultural practices to be at par with our neighboring countries upon the implementation of the AFTA in 2015.

Fongwan, who was guest of honor and speaker during the 98th Foundation Anniversary of the Benguet State University (BSU), said that 'while there is more money in circulation if we talk about mining industry, there are more people depending on the vegetable industry that is why let us not allow the vegetable industry to collapse."

More than 50 percent of the people in the province depend on agriculture as their livelihood.

The AFTA which is to be implemented in 2015 within the member countries of the Association of Southeast Asian Nations (ASEAN), will lift trade quotas and adopt zero tariffs on the importation of vegetables and other agricultural products.

The objective of AFTA is to increase the ASEAN region's competitive advantage as a production base geared for the world market.

He said that the vegetable industry of the province is most particularly threatened by China which has the same production, even the same variety of semi-temperate vegetables grown in the province.

"Let us now start educating our farmers on how we are going to compete your program now on organic production which is one of the solutions that would save the vegetable industry," Fongwan said.

We have to inculcate in the minds of our people the importance of practicing good agricultural practices, he added

He pointed out that if there is an over production in China, it finds its way in the 3rd world countries like the Philippines because we have very lax and regulation, that's why we should see to it that good agricultural practice shall be in place.

Fongwan also stressed that by 2015, quarantine laws should be fully enforced. The Bureau of Plant Industry should be the one to inspect inland bound vessels and no longer personnel from the Bureau of Customs, he said. /JDP/MAWC – PIA CAR

already governs the advertisement, distribution and sale of tobacco in the country and the passage of the smoke free ordinance will be in clear contradiction particularly its penal provision," Billog said.

Billog stressed," instead of pushing through with the ordinance, the body should just implement the provisions of the national law.'

Councillor Richard Carino however said arguments on the matter will be brought to the council on second reading after publication including other matters pertaining to said ordinance for discus-

The Committee on Health and Sanitation, Ecology and Environmental Protection earlier recommended for its approval.

Heart of the ordinance is the prohibition of the use, sale, distribution and advertisement of cigarettes and other tobacco products in certain places and imposing penalties for violations thereof.

Prohibition in certain places as referred by the ordinance include enclosed or partially enclosed public places, workplaces, public conveyances be it mobile

Public places as defined means all places, fixed of mobile that are accessible or open to the public or places of collective use, regardless of ownership or right of access, including establishments that provide food and drinks, accommodation, merchandise, professional services, entertainment and other services.

It also includes outdoor spaces where facilities are available for public or where a crowd would gather such as playgrounds, sports grounds or centers, church grounds, health and hospital compounds, transportation terminals, markets, parks, resorts, walkways, entrance ways, waiting areas and the like.

The proposed amendatory ordinance also prohibits persons-in-charge to allow, abet or tolerate smoking in places enu-

Selling or distributing tobacco products in schools, public playgrounds and other facilities frequented by minors or within 100 meters from any point in the perimeter of these places is also unlawful.

Selling or distributing tobacco products to minors or purchasing tobacco products from minors is also prohibited.

Other prohibited acts are placing cinema and outdoor advertisements of tobacco products, placing, posting or distributing advertising materials of tobacco

products such as leaflets, posters and similar materials even if it is inside the premises of point-of-sale establishments when the establishment is not allowed to sell or distribute tobacco products

Penalties under the proposed ordinance ranges from P500.00 to as high as P5,000.00 and imprisonment including the revocation or suspension of license to operate for establishments or public conveyances violating the same.

Violators who are unable to pay the fine will undergo community ser-

A Citation Ticket System (CTS) will also be put in place for enforcement of said ordinance including a Smokefree Task Force and a Smoking Cessation Program for assistance to smokers and violators who are willing to auit.

Mayor Mauricio Domogan sees the ordinance as a welcome development in the fight against smoking to attain a smoke free environ.

ishment of Halfway House Land in Benguet Pushed

LA TRINIDAD, Benguet - The provincial government is pushing for the establishment of a halfway house to cater to abused children with the alarming cases reported in the province.

The Office of the Provincial Social Welfare and Development during recent Provincial Peace and Order Council meeting reported a total of 97 child abuse cases in the province for the period January to May 2014. This capital town registered the most with 53 cases.

Majority of the cases are physical abuse with 27, followed by rape (20) which includes incest and acts of lasciviousness(11).

Governor Nestor Fongwan said the halfway house which is planned to be constructed this year will serve as shelter for victims of abused children including women before court disposition. It will be built in the area returned by the Department of Public Works and Highways - CAR in Wangal, this town.

Admitting that handling of child abuse cases is not an easy task, Fongwan pointed out that perpetrators especially the minors should also be looked into.

La Trinidad mayor Edna Tabanda also suggested the allocation of funds for research and development on child abuse cases to come up with baseline data as basis in giving interventions. She also batted for a comprehensive approach which seeks to harmonize efforts.

As intervention to address child abuse problems, Fongwan also forwarded the formation of a Child Abuse Prevention and Intervention Network(CAPIN) in all towns.

The CAPIN which involves the private sector, is an approach that promotes and implements a strong multidisciplinary intervention to child protection. It involves stakeholders in a community composed of police, social workers, lawyers, doctors among others working together to create an efficient and effective network to help child abuse survivors creating a locality responsive to the needs of survi-

Fongwan stressed the need to support the children as 'we all have the power and the responsibility to do so'./JDP/ SCA-PIA CAR, Benguet

Dengue Cases in CAR Lower; DOH Reminds Public to Stay Vigilant

BAGUIO CITY - There may be only 66 reported cases of dengue in the Cordillera Administrative Region from January to June of this year compared to the 197 cases for the same period last year, but the Department of Health-CAR Office reminds the public to stay vigilant in the fight against the disease. This they remind as the rainy season in the country officially begins.

DOH-CARO Assistant Regional Director Dr. Amelita Panganiban said the drop in cases is not an assurance to the public but rather a note to encourage more communities to be more vigilant, cautious, and be alert to any breeding ground that mosquitoes might thrive in.

The Health Department also continues its efforts and projects to the barangays such as the Aksyon Brigada Kontra Dengue and the "4 o'clock habit" or the habit of checking for and eliminating breeding grounds of mosquitoes at four o'clock every afternoon. Their efforts extend as well as to schools by giving out curtains with long lasting insecticides. They have also requested the Department of Education to allow all students (especially female students) to wear pants during the rainy season so as not to be vulnerable to mosquito bites./JDP/Pryce E. De Los Reyes pointed-out that the government's duty to distribute lands to landless farmers is not bound by any deadline since it is a constitutional mandate. He also expressed that CARP will not expire even with Republic Act 9700 - the law that extended the program until 2016, because there are still agricultural lands in the country that are not yet covered by the program.

"There is a database in 2009 (for landholdings to be distributed under CARP) but the problem is there in no existing database in the country that shows us which land is CARP covered

or not", de Los Reyes said.

He explained that subtracting the 6,964,119 hectares of CARP distributed lands from the 14,194,675 total hectares of Alienable and Disposable (A&D) land in the country, there are still 6,323,904 hectares of A&D lands in the country where some can be un-identified agricultural lands that can also be distributed to farmers under CARP.

"The problem here is in

the issued land titles, it is not identified if a land is agricultural or not. We cannot also rely on tax declaration or to zoning ordinances (in identifying agricultural lands)", de Los Reyes stressed.

Meantime, as both House of Congress went into recess without passing the CARP - "Notice of Coverage" extension bill, de Los Reyes affirmed that the De-
