# Anti-Drunk and Drugged Driving Law

**Takes Effect June 1** 

(Manila)- The Anti-Drunk and Drugged Driving Law (Republic Act No. 10586) will be in full effect this coming Sunday, June 1, 2014.

Traffic law violators suspected of driving under the influence will be made to undergo a series of sobriety tests.

The Eye Test, which requires the driver to follow with his or her gaze an object that the law enforcer moves horizontally, around one foot away from the driver's face.

The Walk-and-Turn Test, wherein the driver is made to walk nine steps forward in a straight line, turn, then walk back the same distance without difficulty.

Then, there's the One-Leg Stand, where the driver has to stand on one leg and raise the other around six inches from the ground for about sixty seconds.

The drivers who are found to be driving under the influence of alcohol or drugs range from a minimum of three months in prison, plus a P20,000 fine. The maximum penalty is 20 years in prison, plus a P 500,000 fine./ANC News

# Samaritans Respond to Pleas for help Manuela Battateng, a 63-

More Samaritans last week came to the rescue of several kidney patients who have to maintain twice or thrice-a-week hemodialysis treatment for as long as they live, otherwise they won't last

A fiftyish-looking man who declined to give his name handed P10,000 last Tuesday for patient Manuela Battateng, a 63year old farmer's wife from Boga, Monamon Sur, Bauko, Mt. Province who has been on dialysis treatment since October, 2012.

The same man then gave another P10,000 to Angelin Layugan-Taynan, wife of Jerry Taynan, a former policeman assigned to the La Trinidad, Benguet force who had to retire for kidney failure.

The Samaritan called Battateng's daughter, Annie Cadio, and Angelin, asking that they meet at the McDonald's branch at Km. 5, La Trinidad, Benguet. That's where he gave the twin amounts.

"He refused to identify himself but admitted he had undergone surgery for kidney ailment," Angelin recalled. "He had the intonation of a

# Uncle and Nephew Undergoing Life-Time Hemodialysis Treatment

With their growing number, chances are that some kidney patients undergoing twice or thrice-a-week hemodialysis treatment in order to survive are relatives.

Such are the cases of Robert Sakiwat Tomas, 24, of Buyagan, La Trinidad, Benguet and his uncle April Sakiwat, 35, of Lowere Magsaysay, Baguio City, whose appeals for help were juxtaposed in an earlier article in this and other local weeklies.

Such are the cases of 46-year old Winston Bangcawayan Kilongan, and his maternal uncle, Angel Bangcawayan Sr., 71, both of Upper Brookside, Baguio City.

Winston, who serves as the treasurer of Upper Brookside with a monthly wage of P5,542, is married with a 13-year old son. Last April, experienced dizziness, severe back and stomach pain and was rushed to the hospital by his fellow barangay service workers.

The diagnosis was chronic kidney ailment. He was advised to go on twice-a-week dialysis treatment, making him the sixth in his community suffering from the debilitating and financially stressful ailment.

His uncle Angel was a former driller for a private firm in Bicol where he retired in 2010. He lives with his wife, Betty, 68, while their four children are married and raising their own families.

Angel was diagnose for end-state renal failure in January, 2012. Since then, he has been on twice-a-week hemodialysis treatment at the Baguio general Hospital and Medical Center every Wednesday and Saturday from 11 a.m. to 4 p.m.

Winston., on the other hand, has his own four-hour blood-cleansing session at midnight on Monday and at 7 a.m. on Thursday, also at the BGHMC.

"Economic sufficiency of the family falls under the subsistence level, thus he is hard-up sustaining his regular and expensive twice-a-week dialysis and other medical needs," wrote social worker officer Liza Balao.

For Angel and his wife, Betty, stretching his monthly Social Security System pension of P5,500 a month would have been most probable without his eight times a month dialysis treatment pegged at P2,200 per session or P8,800 a month.

That treatment cost does not include other medications and the occasional blood transfusions he has to undergo to maintain his hemoglobin level.

Angelin also acknowledged the kindness of Engr. Galagal from Sablan, Benguet who visited Jerry at the hospital with a P1,200 donation.

Earlier, a head of a national government agency contributed P4,400, good for two dialysis sessions, and an equal amount for Taynan...

The same official provided P2,2000 each to Robert Sakiwat Tomas, 24, of Buyagan, La Trinidad and his uncle, April Sakiwat, 35, of Lower Magsaysay, Baguio City.

Both patients are also on dialysis at the Baguio General Hospital and Medical Center which, as of last week, counted 192 patients from various parts of Northern Luzon it is treating for kidney failure.

Also getting wind of Battateng's condition through the weekly papers here, somebody from Bontoc, Mt. Province had the driver of a Rising Sun bus deliver his or her P1,000 donation.

A Caucasian-looking man who also declined to be identified met Sakiwat's wife, Cathy (nee Mangeda) last May 22 at the Malcolm Square here with his donation of P6.600.

"He told me he's a missionary from Singapore," Cathy said.

# Mayor Calls on Plastic ASK Reports on **Ordinance Amendment**

BAGUIO CITY - Mayor Mauricio Domogan during the Weekly Ugnayan Presser Wednesday called on lawmakers here for the amendment of the city's plastic

The ordinance passed in 2007 was up for full implementation in 2012 promulgating the use of paper bags, buri bags and other biodegradable bagging containers in all supermarkets, groceries and other related establishments citywide.

However, reports from a Legislative Tracking conducted recently on the implementation of the ordinance showed the use of paper bags may not be the best choice as alternative to plastic bags.

Domogan said, "possible amendments to the ordinance such as the use of biodegradable plastics and other alternatives should also be taken into consideration in its implementation."

The ordinance was put in place to minimize and eradicate the use of plastic bags which is a major source of waste in the city.

Domogan said, "the use of biodegradable plastic bags that can easily decompose which was not yet readily available when the ordinance was crafted needs also to

Advocating the use of paper bags and buri bags is a noble endeavour he said but should also be carefully studied in order to achieve success in its implementa-

The city government has started with the information dissemination campaign on said ordinance early in 2011 garnering mix reactions from the public.

It covers all supermarkets, groceries, and retail outlets or stores in all areas identified as commercial zones specifically stating that all are required to use paper bags, buri bags, and other biodegradable materials as containers or bags for all dry goods and groceries instead of plastic bags.

It also covers the public market Wet Section, such as fresh meat, fish, vegetables and fruits, with the provision that the goods can be packed in plastic containers or sando bags provided these are placed in shopping bags allowed by the said ordinance.

Recommended as fine for violators is one thousand pesos (P 1,000.00) for the first offense for any business establishment found to have violated the provisions of the said law.

For the second offense a fine of two thousand and five hundred pesos shall be imposed for non-compliance and a fine of five thousand pesos is imposed as penalty for the third offense.

Those found to be habitual offenders shall be meted the penalty of suspension of business and non renewal of business permit.

The mayor however proposes a more thorough study on the matter./paul rillorta

ing their stalls in Blocks 3 and 4 here. The mayor said he has already sent a memorandum to the City Treasury Office (CTO) and the Office of the Market Superintendent to list all vendors awarded with stalls including names of thopse who were allocated spaces.

Domogan said, "they would be monitoring if said vendors are the ones occupying their assigned slots."

"There are allegations that there are stalls owned by only one person and we

## Park MGMT

BAGUIO CITY - The City Environment and Parks Management Office (CEPMO) takes the lead in sprucing up the city's parks and other areas, in preparation for Independence day, June 12, as it has for the Summer Vacation (SumVac) operations.

This was announced by Parks Division Head Jones Gas-ib during the regular Alay Sa Kalinisan (ASK) meeting last week at the City Multi-purpose Hall, presided by Mayor Mauricio Domogan.

Cutting and clearing of dead branches and trees are on-going which complements the cleaning of garbage bins, flushing of different park areas including the fountain areas by the parks person-

There was also signage renewal, repainting, and arrangement of donated signs and benches for park use. Personnel of the CEPMO inspected lamp post wirings, did maintenance works and checked water levels at the three (3) fountains at the rose garden park.

Burnham Park has been recipient to visitors during the past two months, including during the Holy Week, National Youth Congress, Le Tour Philippines among many other occasions.

It has been noted too that the road and sidewalk along Lake Drive has been rehabilitated, and pay parking signages have been installed at Jadewell and near the city orchidarium.

Included in the parks report are that of the Burnham Park Security personnel with 230 apprehensions from March 28 to May 22, some violators turned over to the Baguio City Police Office (BCPO). There are young violators turnedover to the Silungan Center of the City Social Welfare and Development Office (CSWDO) for further guidance, and some to the CEPMO Burnham Park Office. Among the violations are illegal peddling, smoking in public, drinking alcoholic beverage, spitting, momma-spitting, soliciting money without permit, illegal parking boys, skateboard and playing. Money-making services are also prohibited in the park; manicure, henna tattoo, massage, with the violators turned-over to the parks and police office.

Some however were given stern warning, some were ordered to pay at the City Treasurer's Office for their violations, materials for money-making were confiscated, others were lectured on park regulations, while some park regulation violators rendered community service.

For the anti-graffiti campaign, there shall be an inventory and identification of graffiti-laden areas in the city with launching program next month. A city-wide awareness and information campaign with a no-tolerance policy is being advocated, as posters in English, Tagalog and Ilocano are to be distributed during the occasion.

The anti-graffiti body however appealed for materials for re-painting and repair of those destroyed by the vandals. It was known that in some areas, walls were repeatedly painted; with cleaning and re-painting done several times. Mayor Domogan thus offered a scheduled golf tournament fund-raising event to help with the expenses. He also lauded the efforts of former graffiti artists who now are helping clean up slogan-painted walls.

Villagers' cooperation are needed in reporting and removing vandals' paintings in the barangays, the mayor noted. He rued the ratio of 540 policemen on duty in three shifts for more than 500,000 citizens; including students and daytime business people from the lowlands.

For the parks however, the mayor noted the addition of several security personnel to maintain peace and order within the place./juliegfianza

# CAR Bill Filing Needs to be Fast-

BAGUIO CITY - Cordillera region's bid for **Tracked** autonomy needs to be filed as a bill in the

house of congress by June 13, or before the senate takes a break, it was known from Mayor Mauricio Domogan during the media Ugnavan last week.

Accordingly, the autonomy bill needs to be voted on by Cordillera constituents by March 2015, for it to be included in the 2015 national budget.

It would be very difficult; at the most, "next to impossible to convince members of the senate for a supplementary budget for the region," if the vote is not done at the earliest possible time, the mayor said. Then we may have to wait for 2019 for the organic act, as the coming elections in 2016 would deem another delay, he

The mayor, known to be a staunch supporter and campaigner for the autonomy bill has been instrumental in the preparation of the third working draft of the autonomy charter. A Cordillera summit was done last April 30 where local and regional officials including that of the city attended and voiced out their support for the move./juliegfianza

## RITMT collects more than half million in fines in roadside tests

BAGUIO CITY - the Roadside Inspection Testing and Monitoring Team (RITMT) under the City Environment and Parks Management Office reported a steady decrease in vehicles failing antismoke belching operations being conducted here.

As per report of Wastewater, Water and Ambient Air Management Division (WAMD) Chief Engr. Moises Lozano, they have accumulated P626,400.00 in fines from motorist for the period March 27 to May 21, 2014.

For the period, they habve conducted 60 operations for diesel and 49 operations for gas and lpg fed vehicles.

A total of 730 diesel fed vehicles were tested with 253 failing roadside tests while 477 passed.

For Gas and LPG fed vehicles, 441 were tested in which 150 failed while 291 passed.

The operations were done along Magsaysay Avenue, UP Drive, Session Road, Kennon Road, Buhagan Road, Bonifacio

Road, Harrison Road, Naguilian Road and Leonard Wood Road. Those who failed are 56 diesel fed public utility jeepneys(PUJ), 77 diesel fed and 139 gas/lpg fed private vehicles, 114 diesel fed and 8 gas/lpg fed taxis, 4 diesel and 3 gas/lpg fed government vehicles and 2 other public utility vehicles.

Meantime, at least 789 diesel fed and 97 gas/lpg fed vehicles voluntarily subjected their vehicles for testing for a minimal fee of

Vehicle owners who fail in roadside monitoring tests are advised to have their vehicles undergo necessary maintenance and are required to pay Polluters fee of P1,000.00 for the first offense, P2,000 for the second offense and P3,000.00 for the third offense plus additional P100.00 for re-testing before the plate number of the vehicle is released./paul rillorta

## RSVP to a Lynching

May we share some items that crossed our cluttered desk in the past turbulent week?

"It's going to be one huge lynching party." That is what would happen if the Senate were to confront Janet Napoles in the pork barrel scam, wrote Sun Star columnist Frank Malilong.

Many senators fumed after their names cropped up in the Napoles list. But will bringing back Napoles to the chamber help the search for truth in the Priority Development Assistance Fund scandal? "I doubt it... The first time she appeared before them, she knew nothing about the scam." The senators are understandably obsessed with punching holes in her story—and saving their skin.

Napoles brought this upon herself. But what's the point in making her prey to the overwhelming anger? Any Senate hearing on the Napoles list cannot be remotely justified as in aid of legislation. Nor will it be an exercise of the Senate's established oversight functions.

The Senate is not the proper forum to determine whether Napoles spoke the truth with her affidavit. That power resides in the Ombudsman and, eventually, the Sandiganbayan.

What citizens want to see now is the Department of Justice speeding up the filing of cases against all those involved in the scam, regardless of whether they appear in the Napoles list or not. It's time for the Ombudsman to bring charges and for the Sandiganbayan to hold trial without delay.

"We can't afford to turn the Napoles case into a political circus. This is a criminal case. And it rightfully belongs in the judicial system." It is not impossible that many of the senators and congressmen appearing in her list are innocent. They may have been

wrongly accused for reasons only she knows.

"But like any other citizen under the same set of circumstances, they should seek relief from the courts. The Senate is not a trier of facts. The courts are. If the DOJ or the Ombudsman or the Sandiganbayan clears them, such determination of innocence would carry far more weight than any similar finding by the Senate."

The Viewpoint column "Alternative scenarios" (5/27/14) discussed Indonesia's protests against China's claiming part of the Natuna archipelago in Indonesia's Riau province. It straddles potentially large gas fields. Indonesia twice accused Beijing of claiming part of Natuna.

The column cited Singapore Prime Minister Lee Hsien Loong's sketch of a "good scenario" and a "less benign one" for this region's future over the next two decades.

One would be a region at peace, with countries working to secure shared interests. The other would be a region splintered by territorial disputes and protectionism. These two scenarios will play out in the context of how the United States, China and Japan interact. Lee says the next three years will be "a historic opportunity" for Asia.

"It is eerie," Hungkag e-mailed, but this column "parallels [the situation] in the Baltic states and other border states before World War II. Remember when these states were the subject of a tug-of-war between the West and Germany?"

Hungkag added: The United States was distant but later took steps to help these small states during the war. Later these states were the subject of Cold War activities between the United States and the Soviet Union. The Chinese claim the whole of the South China Sea because in their "historical records," this sea belongs to them. "If nobody resists this, then they will claim all of Asean because they assert they have [a paper trail]."

Wrote Edgar Lores: "The macrocosm of world affairs reflects the microcosm of our national affairs. The covetousness of China for resources [mirrors] ... the covetousness of our senators for pork barrel funds. The covetousness of the congressman for pork is a reflection of a man's covetousness for his neighbor's wife and goods."

The law extending the Comprehensive Agrarian Reform Program is set to expire by the end of June, wrote Leonardo Fuentes. The House committee on agrarian reform railroaded the approval of a bill that proposes to extend CARP.

This ignores a study by National Scientist and UP professor Raul V. Fabella, titled "CARP: Time to Let Go." After 26 years, CARP reduced agricultural productivity, drove away investments in agriculture and created a new class of farmers—the landed poor.


Some highlights: CARP sought to distribute 5 million hectares of land or 16 percent of total land area. In contrast, Japan's reform distributed only 1.76 million hectares comprising 4.7 percent of its land area.

There was an increase in the production of palay and corn. But a 40-percent decrease in coconut production resulted. It was an 8-percent dip in sugar harvests. The noneconomic size of farms made them into high-default risks that financing institutions avoided. "They were condemned to fail."

Slightly half the number of agrarian reform beneficiaries were organized. Thus, others missed out on government and nongovernment assistance for ARBs. Yet, more than half of them cluster below the poverty line.

Instead of continuing the fragmentation of productive agricultural lands, the government should focus its limited resources on providing support to existing reform communities. The focus should be on unglamorous but vital programs, such as irrigation, farm-to-market roads, mechanization, etc.

That'd "give the agricultural sector the much-needed boost to be more efficient and globally competitive in this era of Asean trade integration, which comes on stream next year."/Juan L. Mercado/E-mail: juanlmercado@gmail.com

#### WHAT IS TO BE DONE WITH NAPOLES AFFIDA-VIT NOW? There is something that the Aquino government and the Department of Justice are not telling the people, relative to the "tell all" affidavit of Janet Lim Napoles which named some 20 senators, 100 or so congressmen and other government officials as direct participants in the P10 billion pork scam: so what is to be done with that affidavit now?

What is more, while President Aquino already reacted to that affidavit by saying he was "confused" by its contents, there is no reaction at all, not even a whimper or even a sigh, from Justice Secretary Leila De Lima who, undeniably, was the one who asked Napoles to come up with a "tell all" affidavit in connection with the pork barrel scam before Napoles was to undergo a medi-

Indeed, considering the explosive content of the affidavit which implicated government officials in the biggest plunder case ever to hit the Philippines, the least that the President or De Lima should have done was to refer it right away to the Office of the Ombudsman for the proper preliminary investigation of those that have been named therein.

#### NAPOLES AFFIDAVITAS A BASIS FOR PRELIMI-NARY INVESTIGATION: For all intents and purposes (as we lawyers are fond of saying whenever we have run out of arguments), the affidavit of Napoles already constitutes a criminal complaint or accusation that is sufficient to start a preliminary investigation under Rules 110 and 112 of The Revised Rules of Criminal Procedure (as amended on December 01, 2000).

For one, that affidavit complies with Section 6 of Rule 110 of the foregoing Rules, which says that a "complaint... is sufficient if it states the name of the accused; the designation of the offense given by the statute; the acts or omissions complained of as constituting the offense; the name of the offended party; the approximate date of the commission of the offense; and the place where the offense was committed...'

Then, it also complies with almost all the other sections of Rule 110 which define the conditions by which a preliminary investigation under Rule 112 must and should be carried out-to determine if an offense had in fact been committed and that there is sufficient reason to believe that the persons named in the complaint were the ones who committed it.

#### CULPABLE VIOLATION OF THE CONSTITU-

**TION:** Considering the clarity of the foregoing rules of law and procedure, it was the undoubted duty of the President and of the Secretary of Justice to have acted to commence the requisite preliminary investigation pursuant to the rules of criminal procedure after receiving the Napoles affidavit.

Surely, no one can deny the fact that it is the duty of both Aquino and De Lima to prosecute criminal cases and the perpetrators of the crime. That duty to prosecute criminal cases is both Constitutional and statutory-meaning that, it is a duty that the Constitution and the laws themselves impose.

With their inaction on the Napoles "tell all" affidavit, could not the President and De Lima have committed a culpable violation the Constitution? Is this not even a case of obstruction of justice or, at least, of graft and corruption under Section 3 (e) of Republic Act 3019, which considers as graft the act of any officer which

# Driven **Program to Cordillera Towns**

BAGUIO CITY - Local folks in 52 municipalities in the Cordillera Administrative Region are set to be empowered in participatory planning, implementation and management of development projects as the Department of Social Welfare and Development (DSWD) approved community -driven development(CDD) projects in their respective localities.

DSWD - CAR OIC Regional Director Janet Armas, in an interview, disclosed that 52 towns in the Cordillera including 25 of the 27 municipalities in the province of Abra, are among the beneficiaries of DSWD's National Community – Driven Development Program (NCDDP) for this year.

Of the 52 municipalities, 21 are new beneficiaries of the NCDDP.

"Social preparations for the CDD projects are already set this July involving around P2 million to 20M funding or a per capita (per local folk) investment of P350 to first to third class municipality and P450 to 4th to 6th class municipality", Armas stressed.

NCDDP is formerly known as KALAHI-CIDSS (Kapit Bisig Laban sa Kahirapan - Comprehensive Delivery of Social Services) and is one of the three core poverty alleviation programs of DSWD alongside the Pantawid Pamilyang Pilipino Program and the Sustainable Livelihood Program.

The program aims to empower community through participatory planning, implementation and management of local development activities; improved local governance by strengthening formal and informal institutions to become more inclusive, accountable and effective; and reduce poverty in the countryside by promoting equitable access to basic services and inclusive growth.

Under NCDDP, community development sub projects proposed are those falling into the categories of basic social services, basic access infrastructure, community production, economic support and common services facilities; environmental protection and conservation projects and skills training and capacity building.

As of May this year, there were already 19 municipalities in Cordillera that benefitted from DSWD's CDD projects since 2011. The municipality of Besao in Mountain Province which has been recognized as best implementer of CDD projects is now on its third cycle as a beneficiary./JDP/CCD - PIA CAR

# DSWD Expands Community- DOH –CARO Reports Development Decreasing Trend in Diseases Under Surveillance

BAGUIO CITY — The Department of Health -Cordillera Administrative Regional Office(DOH-CARO)reported that diseases being monitored by its Regional Epidemiology Surveillance Unit had generally a significant decrease since January to the second week of May this year.

DOH Assistant Regional Director Dr. Amelita Pangilinan said that the majority of the 23 different diseases and syndromes under surveillance in the region have shown a decreasing trend since January 1 to May 10 this 2014 or Morbidity Week 1 – 19 compared to the same period last year.

Registering one of the most significant decrease is dengue with 457 and one death during the said monitoring period this year compared to the 789 cases with three deaths during the same period last year, or a 42 percent decrease.

Measles registered a 22 percent decrease from 27 cases with one death last year to 21 cases this year while influenza- like illness has a six percent decrease with 3652 cases last year compared to 3445 cases this

Pangilinan also assured the public that there is no cause for alarm as there is no MERS - COV (Middle East Respiratory Syndrome Corona Virus)- positive case monitored in the region. She affirmed that so far the only case recorded in the country is that of a male nurse who was intercepted in Manila, and reportedly acquired the virus in United Arab Emirates.

Pangilinan said the continuing decrease of cases of diseases and illness can be attributed to the collective efforts of the different stakeholders in maintaining a healthy environment for the general public particularly in the municipal and provincial and even in barangay health units regionwide.

She added that public awareness and vigilance on the different illness also help in the prevention of diseases in the region. She said that the regular conduct of kapihan media forums is a big help in advocating disease prevention to the public. The DOH sponsors a kapihan forum each month.

The media forums and interviews are avenues where the public get informed and updated of the common diseases particularly the season illnesses, on the preventive measures of illness, how to be healthy and other important reminders from the DOH.

Pangilinan reminded that despite the reported decrease of diseases, the DOH is calling on the general public to always stay healthy to prevent diseases. The public, she added, should always clean their surroundings to prevent diseases./JDP/RMC- PIA CAR

Gulla called on the public to have more patience as the NSO is doing its best to continuously adjust its system and its personnel's capacity to the growing clients. She reiterated her appeal for clients not to bring along companions especially children as they add up in clogging the NSO Service outlet.

If there are wrong entries or corrections, adjustments can be done. This way, they avoid the queue and the rush during NSO peak months.

The World Health Organization reports that the global tobacco epidemic kills nearly 6 million people each year, of which more than 600 000 are non-smokers dying from breathing second-hand smoke.

Tobacco use is the single most preventable cause of death globally and is currently responsible for 10 percent of adult deaths worldwide, it showed.

WHO and partners everywhere mark May 31 every year as World No Tobacco Day, highlighting the health risks associated with tobacco use and advocating for effective policies to reduce tobacco consumption.

The ultimate goal of World No Tobacco Day is to contribute to protecting present and future generations not only from the devastating health consequences due to tobacco, but also from the social, environmental and economic scourges of tobacco use and exposure to tobacco smoke

For World No Tobacco Day 2014, WHO and partners call on countries to raise taxes on tobacco.

Meanwhile, Foman-eg lauded the city of Baguio for the Anti-Smoking Ordinance prohibiting smoking in the different public places and other establishments in the city. But she pointed out that this still needs refinement including penalties of violations and the citizen's arrest. She also noted the lack of no smoking enforcers teams to monitor and prohibit the citizens from smoking in public places./ JDP/RMC- PIA CAR

## "Boses ng Baguio" Talent Search on

BAGUIO CITY - Do you have the talent and the guts to be Baguio City's next singing star? Join "Boses ng Baguio - the search for the summer capital's new singing sensation".

A project of John Glen Gaerlan, a renowned Baguio tenor and music enthusiast, in partnership with the city's Association of Barangay Kagawads (ABK), the search is open to all residents of Baguio City aged 15 to 30 years old.

Qualified contestants must be certified residents of the barangays they are representing, must not have joined/competed in any national/international competitions and must not have any contract with any production company or agency.

Gaerlan, in launching the search in a kapihan media forum Wednesday, said he came up with the project in recognition of the potentials of Baguio talents.

"Boses ng Baguio is envisioned to be annual search for the most competitive singing sensation of Baguio City, highlighting the participation of the different barangays in the city and giving them equal opportunities to showcase their talents. Eventual winner will also represent the city in any other singing competition outside of Baguio", Gaerlan said.

Baguio ABK president Eva Fianza reported that the whole audition process will involve all the 128 city barangays clustered into 10 areas. Cluster contestants will battle it out within 6 to 8 weeks before the semi-finals.

The organizers set the semi-finals on July 27 at the SM City Baguio, while the finals would be on August 9 at the Baguio Convention Center.

Justin Samson, one of the contest organizers, explained that the preliminary auditions will take place in a venue they will assign and would run for 5 to 6 weeks.

The contest guidelines include: maximum of two contestants per barangay is allowed to compete; contestants are required to prepare one song from any genre/style of his/her choice to be sung either acapella, or with minimal accompaniment (eg. guitar or keyboard) or with minus one; song piece should not be less than two minutes and not more than four minutes,; and all minus one (in MP3 format written in cd or recorded in a flash drive) should be given to the organizers upon registration.

The contestants will be judged based on vocal range (20 percent), vocal quality (20%), subtext/artistic Interpretation (20%), level of difficulty (15%), stage presence (15%) and audience impact(10%).

The Boses ng Baguio grand winner will be awarded with P30,000, 1st runner-P20,000 and 2nd runner-P10,000. Consolation prizes of P2,000 will also be awarded to the other finalists. # Behavior Change of Stakeholders Developing Poro Point Plays Vital Role in Revitalizing Baiiii River

BAGUIO CITY - Behavior change of stakeholders play a vital role in the upkeep of the Balili River system.

This was underscored in a two-day Behavior Change Workshop of the Balili River System Revitalization Coalition(BRSRC) held recently.

Facilitated by Ramon Daen and Alexander Deocareza of the Harnessing the Nucleus of Strengthened Services (HARNESS) consultancy group, BRSRC members identified crucial behaviors to work on in order to achieve change.

Among these are inconsistent implementation of policies, improper segregation or garbage disposal, pig waste dumping into the river, refusal to desludge septic waste, refusal to segregate waste, absence or improper design of septic tanks, and encroachments tolerated along riverside.

While there are ongoing efforts endeavored in revitalizing the Balili River, Daen pointed out that if change is desired focus should also be given on the vital behaviors.

Daen presented the theories behind behavioral change which he said are unconsciously being applied but learning about it gives confidence in doing the right thing.

But he cautioned that most of the behavior change efforts fail because it gives focus to only one level. The various levels progress which start with personal progressing into social and finally structural levels which incorporate elements of motivation and ability, and hand in hand, the combination is called sources of influence, according to Daen.

Making the undesirable desirable, surpassing one's limit, harnessing peer pressure, design reward and demand accountability and changing the environment are the sources of influence in changing behavior so that if all are present change is inevitable, Daen pointed out.

In developing a plan for the river system, he said all of the influencers should be considered to give a sense of ownership among the stakeholders at the barangay level with the guidance of the BRSRC.

The coalition recognized the need to actively involve the community or the barangay, the forerunners in maintaining the river system, in the revitalization effort apart from the ongoing efforts and those already undertaken.

Equipped with knowledge and skills on changing attitudes and behaviors, the coalition members are expected to download these to the barangays through appropriate activities in ensuring better participation and sustainability in the upkeep of the Sagudin-Balili River.

The workshop was sponsored by the University of the Philippines- Baguio together with the Environment and Management Bureau of the Department of Environ-



and Barangay Ekip and Balete in Bokod.

She said that there were no road network in the past years and people have to walk to their respective communities through a trail. But in the past few years the area was developed and a road network which is now considered as a 'logging road' was opened..

Last year, Albas recommended to the Provincial Peace and Order Council the closure of the road.

Albas said that the joint task force would be validating the information as well as the evidences they gathered for them to file appropriate complaints and formal charges to the three individuals who are staying in the forest reserve area of Mount Pulag particularly for violation of the Forest Code of the Philippines, the Philippine Clean Water Act and the National Integrated Protected Areas System (NIPAS) Act.

The report will also be turned over to the local government units and the DENR CENRO, PENDRO and Regional Office.

The task force was lead by the PENRO and CENRO together with the operatives from the Police Regional Office – Cordillera and the Bokod Municipal Police Office, Philippine Army 51st Infantry Battalion, National Power Corporation and members of the local media

Meanwhile, Albas called on everyone to do their share in maintaining, conserving and protecting the Mount Pulag National Park which is considered as the 'mountain of the gods'.

The Mount Pulag National Park covers 11,550 hectares were established to protect and preserve the natural features of the area such as its outstanding vegetation and wildlife. It borders Kayapa, Nueva Vizcaya and Tinoc, Ifugao and Kabayan and Bokod in Benguet./JDP/RMC- PIA-CAR

# **Mount Pulag Continues Under Threat**

BOKOD, Benguet - The Mount Pulag National Park is in critical state and continues to be under threat despite the actions being under taken by the different local government units and the advocacy of hundreds of mountaineers climbing the sacred mountain.

More than 10 hectares of forest land inside the Mount Pulag reservation were found to have been burned and cleared and converted into farmlands in Naubanan, Ekip in Bokod, Benguet following an investigation and survey by the joint Provincial and Municipal Anti-illegal Logging Task Force operation last week.

Mount Pulag Protected Areas Superintendent Emerita Albas said that of the three areas which the task force investigated at Naubanan, Ekip, at least 200 pine and oak trees were cut or burned down due to Illegal logging activities and more than 10 hectares of land were also converted into high

value crop farming with the unabated expansion of commercial vegetable farms.

The 200 trees were located in the areas which were investigated and surveyed but hundreds more were found out to be cut down and burned along the mountain sides in Naubanan. The trees cut down were mostly for commercial use, for conversion to farmlands and for use in reported small scale mining activities in Kabayan and Bokod, Benguet.

Albas said that initial investigation they conducted showed that three areas were illegally converted into farmlands after individuals and eventually their families migrated to the areas which was suppose to be a forest reservation area and off limits to residential and commercial use.

Albas said that the area in Naubanan had fast forest denudation and uncontrolled development after a road was opened in the area which connects barangay Bashoy in Kabayan Cont. on page 9

# **Power Situation** in Luzon Still

Normal- DOE

BAGUIO CITY - Power situation in Luzon is still normal and power reserve as of last week was pegged at more than 900 megawatts.

This was the assurance made by Department of Energy (DOE) Luzon Field Office Director Efren Balaoing, in an interview, during the DOE- led Forum on Multi-sectoral Advocacy Campaign on Downstream Oil Industry at City Light Hotel, here, last Thursday.

The occasional rains in the Baguio -Benguet area and the upcoming rainy season that is expected to bring in rains despite the forecast of El Niño will rejuvenate the Cordillera watersheds that bring water to the lowlands and will boost the power generating capacity of Ambuklao and Binga Dam, both located in Benguet, Balaoing said.

"Ambuklao has a generating capacity of 105 MW while Binga generates 125 MW", he disclosed.

In the same interview, Balaoing also affirmed the rich potentials of Cordillera Administrative Region as far as geo-thermal power and hydro power are concerned.

He reported that there are pending applications six 6 geo-thermal plants in the region that will have a total generating capacity of 230 megawatts and 22 applications for hydro power plants that could bring in more than 700 megawatts of power supply.

"If these power generation development contracts push through, through the endorsement of local government units
