


Our courses are geared towards awareness and making sure you understand that you may be inadvertently put in harm's way.

# UNDERSTANDING AUTISM FOR THE CODE OFFICIAL

During an inspection, we may visit individuals with autism or their loved ones. We, as code officials, must approach with awareness and understanding. Many individuals on the autism spectrum do not understand the rules and boundaries of social behavior. As a result, many respond impulsively to their feelings without regard to specific social mores. Others react inappropriately as a result of sensory regulation problems.

These individuals can become overstimulated and may have what appears to be an unprovoked "meltdown."

Because of these and other symptoms of Autism


Spectrum Disorder (ASD), it is possible for individuals to find themselves in trouble with the law without any awareness of having done something wrong or without any understanding of what they did that got them into trouble. 


