City to Clamp Down on Sham Chari Fund Drives

The profiteering days - and nights - of organizers of fundraisers for their personal profit but masquerading as humanitarian and civic projects will soon be over, at least here in Baguio.

Stung by the proliferation of fun-runs, concerts and other solicitation events labeled "for-a-cause" but turn out to be "fora-cost" to line the pockets of the organizers, the city social welfare and development office is set to endorse to mayor Mauricio Domogan an executive order regulating any form of fund-raising here.

The executive order being drafted, according to city social welfare and development officer Betty Fangasan, is in accordance with Presidential Decree No. 1564, also known as the Solicitation Permit Law and the Local Government Code giving local government executives the authority to issue permits for fund-raising activities.

The solicitation permit requirement is intended to distinguish and protect well-meaning fund-raising activities from profitoriented concerts, fun-runs and other solicitations announced as intended for indigent patients or civic projects that remain anony-

More Police Visibility in Schools Sought

BAGUIO CITY - Mayor Mauricio Domogan on Monday directed the city police under police director Jesus Cambay Jr. to increase police visibility in all public and private schools in the city to deter crimes and maintain order in the school areas.

Cambay committed to beef up their manpower deployment in said areas as requested.

The city council later approved a resolution authored by Councilor Roberto Ortega asking the city police to implement city resolutions for the augmentation of police visibility to maintain peace and order in said areas.

"Delinquencies, misconducts and criminalities are clearly rampant in said areas which lead to untoward crimes. Crime prevention group or any relation organization in preventing crimes of the school is not enough to control inhibit crimes," Ortega noted.

He cited three past resolutions expressing the same

Theft remains as the most prevalent crime in the city and most of these happen in crowded places like university belts.

Cambay acknowledged the need to deploy more policemen in schools also as a means to curb youth offenses./

Young Mother Pleads for Support In Fight Against Cancer

Taking a respite from searching for Samaritans, Remedios Walleng, a 34-year old mother of two, took time - like a mother should - to breast-feed Jereka, her five-month old daughter.

She was wearing a mask against infection, as her immune system has been weakened by Hodgkins lymphoma, a cancer of the lymph nodes diagnosed Christmas last year, and by four chemotherapy sessions she had undergone since then.

She, however, could not submit to chemo immediately after diagnosis as she was then 25 weeks pregnant. She gave birth to Jereka last June 20 and started her chemo treatment last July 8 under a 12-cycle protocol at the Baguio General Hospital and Medical Center.

Jeremia Piaoan, her live-in partner, tried to work double time as a taxi driver in an effort to raise P19,000, the price per cycle. As it was a tall order, the price was reduced to about P8,000 per session, enabling Remedios to undergo three cycles.

With her family financially exhausted, Remedios had her third session last Sept. 4 and then stopped with nine more to go. It proved costly as the mass on the side of her face enlarged, a sign of relapse.

Last November 29, she began anew her chemotherapy from square one, again following a 12-session protocol spread every 21 days.

Cordillera Medical Mission Bound for Leyte

Aside from relief support, the Cordillera is sending this yuletide a 28-member medical mission to serve victims of super-typhoon Yolanda that hit Eastern Visayas early

Led by Dr. Manuel Quirino, head of the emergency department of the Baguio General Hospital and Medical Center, the team will enplane this Tuesday for Tacloban City to relieve other volunteers earlier sent by the Department of Health to serve at the Eastern Visayas Medical Center in the calamity-devastated city.

Quirino, a surgeon, has also specialized in health emergency in disaster management and serves as trainer and course coordinator in basic life support – adult and pediatric, advanced cardiac life support and mass casualty incident man-

With him in the team are eight representatives of the Department of Health, 15 from the BGHMC, four from the Conner District Hopsital in Apayao and one from the Far North Luzon Gen. Hospital in Luna, Apayao.

A government official

City Allots P1.8 Million for Calamity Areas

The city government had sent P500,000 support to three earthquake-hit areas in the Visayas and is working out the transmittal of P1.3 million more to seven other local government units devastated by super-typhoon

"We have notified the seven typhoon-hit areas to which the city's support will be given to send us their city or municipal bank account numbers so we can work out the bank transfer the city's assistance," Ryan Mangusan of the mayor's staff said.

On request of mayor Mauricio Domogan, the city council approved P500,000 as cash support to some areas damaged by the earthquake and an equal amount for the LGUs that absorbed the brunt of Typhoon Yolanda's fury. From savings, partly through cancelling its Christmas program, the city added P800,000 to for typhoon-ravaged localities.

The earthquake support fund was sent to the provincial government of Bohol -P200,000-; the city of Tagbilaran – P150,000 and the town of Trinidad, Bohol. Bohol was hit by a killer quake registered at moment magnitude scale 7.2.

A total of P200,000 from the P1.3 million support to typhoon hit areas will be for Tacloban city, and P100,000 each for Ormoc City and Tanauan town, both in Leyte, and the towns of Guiun, Lawaan, Balangiga and Quinapondan, all in Eastern Samar.

Mayor Domogan also asked that victims of the earthquake and typhoon devastations who had ventured into Baguio in search of rehabilitation and support to report to the city social welfare and development office at Upper Session Rd. so that their situation can be validated so they can avail of government

City social welfare and development officer Betty Fangasan said that aside from relief, assistance will include transport support for those who would like to return to their places of origin.

Some of the typhoon victims who came up to Baguio were taken in as house helps or absorbed as workers by some commercial establishments here.

It would still be best help them return to Tacloban and their native towns where the world's support to help them rebuild their lives is concentrated in the calamity areas.

"They have better opportunities to get back on their feet in Eastern Visayas than in any other place because relief and rehabilitation are concentrated there," the mayor pointed out./ Ramon Dacawi.

The mayor has remained firm on his stand to ban the sale of firecrackers and pyrotechnic devices in the city for Christmas and New Year celebrations.

He reiterated this during the Kapihan media forum with the Department of Health Cordillera last Wednesday where he assured that he will not issue any permit for the sale of firecrackers in any part of

Last November 27, he categorically denied the appeal of the Baguio-PAILAW group represented by Agnes Montoya for reconsideration of their request to again sell aerial fireworks for the New Year celebration.

"We stand by our earlier pronouncements that we will not issue any permit allowing the sale of firecrackers and

Colder Temperature Prevails in Baguio, Expected to Drop **Further**

BAGUIO CITY - The Yuletide season is now being felt in the Summer Capital with colder temperature being experienced especially in the early morning and in the late afternoon until evening.

Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA)-Baguio meteorologist Danny Galate reported that present temperature ranges from 14 to 22 degrees Celsius though they expect the temperature to drop down to 12 or even 11 degrees level this coming week as the coldest season in the city is usually from December until February.

According to Galate, the cold weather in Baguio came earlier than usual as it started to be felt last week October instead of the first week of Novem-

"So far the lowest temperature recorded in Baguio for this year was at 12.6 degrees Celsius recorded last October 27," he said.

The lowest temperature in the city so far reUacorded was 6.3 degrees Celsius on January 8,

He also reported that PAGASA still expects to have one or two typhoon before the year ends though with less effect in Baguio and the rest of Cordillera.

With the colder weather, Department of Health (DOH-CAR) Assistant Regional Director Dr. Amelita Pangilinan reminded the public to protect themselves from the cold breeze and be wary of Influenza-like Illnesses. ILI is also known as acute respiratory infection and commonly caused by common cold and influenza.

DOH-CAR data from January to November 23 shows 3,420 ILI cases in Baguio, a slight increase compared to the 3,212 ILI cases recorded during the same period last year.

In 2011, the mayor expressed the same wishes for the city council to amend the ordinance in favor of a total ban but contented himself with a resolution that expanded the list of prohibited firecrackers to virtually allow only the aerial ones, saying he understood that the body did not have enough time to amend the measure.

Last year, the mayor again signed the city council resolution allowing the sale of the aerial types but made it clear that it would be the last time that he will allow the same./A Refuerzo

Diocese of Baguio, OWWA Partner for School-Based Ministry on Migrant **Workers Concerns**

ITOGON Benguet - The Diocese of Baguio, in partnership with the Overseas Workers Welfare Administration (OWWA-CAR), recently visited the Saint Louis High School campus here to provide children and parents and spouse of Overseas Filipino Workers school-based ministry on migrant workers plight, welfare and development.

The activity was part of the "Migrant Apostolate" program of the Diocese of Baguio which aims to develop specific programs at the parish and school level that would help address the concerns of migrant workers and the families they left behind, as well as to serve as a venue for participants to learn about the different welfare and development programs of the government.

There are an estimated 3-6 million children of OFWs nationwide, according to a study conducted by UNICEF and around 10 to 20 percent of these Filipino children has one or two parent/s working abroad, thus reflecting the need for such programs.

During the activity, OWWA-CAR IT Instructor Karen Rodillas gave an orientation on OWWA programs and services while Family Welfare Officer Lourdes Estocapio presented the rewards or gains of being OFWs through the audio visual presentation of the regional winner of the search for Model OFW of the Year Award.

The module on Strengthening Family Program which OWWA-CAR implements for families of OFWs was likewise discussed.

An open forum was also conducted, and most of the participants showed interests in the available scholarship programs and skills trainings under OWWA.

Meantime, OWWA will lead the observance of Migrants' Workers Day which is being celebrated in the country every December 7 by virtue of Republic Act 8042 or the Migrant Workers Acti which institutes the policies of overseas employment and establish a higher standard of protection and promotion of the welfare of migrant workers, their families and overseas Filipinos in distress, and for other purposes.

On December 13, OWWA-CAR t is also set to conduct training on OFW Family Welfare cases management for OFW Family Circle leaders in the region./

Rare window

Will the pork barrel scam spiral into a march by the millions next week? The theft shoved to the back burners other equally critical issues from "nutritional black holes" to loss of keystone species.

"He who plants trees benefits another generation." After 12 years of below-radarscreen efforts, research has paid off. Another rare tree in Cebu has won international recognition. But Cynometra cebuensis is critically endangered.

Journal Blumea declared the tree as "scientifically described" on Nov. 24 last year. The decision appeared on the Net this month.

"This brings island-endemic tree species to three," notes botanist Franz Seidenschwarz who tracked Cynometra from seed to fruit-bearing. All three cluster within the Tabunan forest slivers. "Germany has zero endemic tree species."

Cynometra Cebu bears no local name, unlike the other two. Discovered in 1922, Arthrophyllum cenabrei is named Bingliu—the area where it sprouted. Cinnamomum cebuense Kostermans, recognized in 1986, is called Kalingag in Visayan.

Degraded habitats and limited numbers will insert Cynometra Cebu into "Critically Endangered" tables of the 2001 "Red List" by the International Union for Conservation of Nature.

A University of Munich graduate, Seidenschwarz led the University of San Carlos (USC) Botany Research Group. Fluent in Cebuano, he authored various studies, including "Plant World of the Philippines—An Illustrated Dictionary of Visayan Plants."

He married Cebuana Elizabeth Cinco who teaches German in a language school she established. Their eldest son is a New York hospital internist. Franz Jr. is a resident physician at Perpetual Succor Hospital in Cebu.

Today, Seidenschwarz juggles the duties of Germany's consul in Cebu with research in a private Maria Luisa Park tree farm. "It is my garden and a secret area where I plant

the critically endangered species of Cebu." That fills a gap in research

material.

USC researchers, in November 1998, discovered a new damselfly. Scientifically described by Dr. Matti Hämälainen, it is now known as Risiocnemis seidenschwarzi. But in July 2000, the damselfly population dwindled. It was last seen in March of 2001. New populations were spotted in Badian, then Tabunan. The Zoological Society of London included this damselfly on a list of "100 most endangered species of the planet."

Starting in 1999, Seidenschwarz tracked 17 Cynometra Cebu trees whose seeds came from one mother tree. The species thrives in dry forests on limestone at altitudes of 400-600 meters. Flowering occurs at the onset of the dry season. But they last only for a few days.

The tassels of young trees are bright pink; in older trees, they are creamy greenish yellow. They attract butterflies, dragonflies and other insects. The woody fruit pods fall in Inty

The new species differs from the Cynometra in Sibuyan Island. Its leaves are much larger. Its habitat is different. Sibuyan trees sprout on moist fertile wooded flats along rivers. All Indo-Pacific species of Cynometra grow under ever-wet climatic conditions. In contrast, Cebu is seared by a dry season from the middle of March to early June.

"It took me over a decade to prove that it is a new species," Seidenschwarz recalls now. "I waited for the flowers. But the blooming was very irregular."

Today's trees bear the imprint of history. Cebu is one of the country's two most deforested provinces. Indiscriminate logging interlocked with unrelenting kaingin or clearing of trees by fire. This pillage led the Spanish colonial government, in 1870, to shred all special licenses to cut trees on Cebu. The Spanish governorgeneral, in 1873, appointed 12 officials to prevent countrywide deforestation. They were tasked to hold on to depleted forest stands.

They failed. So did the US colonial administrators and Filipino officials who took over after the grant of independence in 1946. Less than a quarter of Philippine rainforests are left.

Deforestation threatens also the birds. The Cebu Flowerpecker or Dicaeum quadricolor, for example, is extinct, despite the crossed fingers of conservationists.

In 1917, President Sergio Osmeña opened Cebu's Camp 7 reforestation project. It still exists in a province where the key project of his grandson, former Rep. Tomas Osmeña, is a treeless, 296-hectare reclaimed South Road Properties.

In Central and Southern Cebu, tree-covered tracts remain only in higher and less accessible mountains. Paradoxically, this remaining 0.2 percent fragment of natural forests is unusually rich in endemic plant and animal species. Many of them are rare and endangered.

The largest remnant is the 145-hectare spread within the Tabunan forest. It is hemmed in by farms. And pressure on the land and trees ratchet up from population growth, inflow of migrants and poverty.

Habitat deterioration is caused by timber harvesting, specially by fires during the dry season, says Seidenschwarz who has monitored Tabunan since 1994. That threat is compounded by encroachments.

The nearby Cantipla forest was once "a habitat of the new species," Seidenschwarz notes. On paper, the area is well protected. The reality on the ground is different. The forest area should be delineated soonest, so protection measures can follow.

That gut issue lands on newly elected Cebu Gov. Hilario Davide III's lap. It provides him with a rare window of opportunity for lifetime achievement. Few dare to tally the price tag for failure./Juan L. Mercado/E-mail: juan_mercado77@yahoo.com

METRO MANILA —The Philippine Press Institute (PPI) met the other night in downtown Makati and discussed how to deal with the complaint filed by Senator Juan Ponce Enrile against the Philippine Daily Inquirer. It stemmed from the publication of PDI of a story that identified him as allegedly the "mastermind" or "brains" behind the alleged PDAF scam of Janet Napoles. Senator Enrile vehemently denied this.

nstead of filing a libel or civil case in the regular courts, it was instead filed before the **Philippine Press Council (PPC)**, asking for an investigation and the corresponding sanctions imposed, if warranted. I will not talk here about the merits of the Enrile complaint. I will just show to you what this process is all about.

This grievance procedure is not known to many. But at PPC, an aggrieved citizen can lodge a complaint against the newspaper concerned without going to court and seek redress from the print media sector itself. PPC is composed of sectoral representatives from the academe, civil society and private media. It somehow serves as a "watchdog" in that an individual can lodge a complaint against a PPI newspapermember if he feels aggrieved due to a published article and he needs to also have his side reasonably heard as a way of vindication. It is a mechanism that allows the media sector itself the matter of policing its own ranks and disciplining its own members and at the same time upholding press freedom.

However, there are certain "jurisdictional elements" that must be present to set in motion this procedure of seeking redress. Here are some basic things to bear in mind before the council can take cognizance of a complaint.

First, the newspaper subject of the complaint must be a PPI member. This is necessary because sanctions cannot be imposed on non-members for obvious reasons, the press council being an instrumentality of PPI. Secondly, there must be no other pending case in court or in any other body over the same subject matter. In this case, a certification submitted by the complainant must first attest to this non-pendency. Thirdly, there must be a waiver on the part of the complaining party as to judicial recourse, meaning he will forego of his right to go to the regular court or any other administrative body to seek redress if he submits to the jurisdiction of the press council. Lastly, the complainant must show proof that he had communicated to the newspaper concerned to give his side to a published derogatory report but this has not been given due consideration by the said publication.

If all the above elements are present, the press council shall then take cognizance of the complaint and after due investigation and hearing both parties, a decision is rendered. An erring newspaper will be required to publish the decision of the council and/or will be ordered to give reasonable space for the publication of the complainant's own side of the story subject of the case. If the newspaper refuses to comply, a possible fine can be imposed and the other PPI newspaper-members may then proceed to publish in their own publications either the decision or the side of the aggrieved party or both.

This mechanism for redress has not been resorted to too often by aggrieved citizens principally because this procedure for redress is not known to many yet. In fact, there were not too many of such complaints lodged before the council up to the present. According to records, the most notable and the latest case so far heard was the case filed by former **Executive Secretary Alberto Romulo** against the late Philippine **Star** columnist **Max Soliven**, for the latter's series of commentaries allegedly derogatory to former ES Bert. But this happened many years ago. In fact,

Remove SC control over lawyers?

WHAT ATTY. KAPUNAN SHOULD DO: Maybe, lawyer Lorna Patajo Kapunan (a colleague whom I worked with at the defunct Aksiyon Demokratiko Party to push the second presidential run of deceased Sen. Raul S. Roco in 2004), should include in her explanation before the Supreme Court disclosures about judicial corruption earlier aired by Manila Mayor Joseph Estrada, and newspaper columnists Ramon Tulfo and Jarius Bondoc.

Why? Well, so the Supreme Court, which has ordered her to explain her statements in a TV interview about corruption in the judiciary, will also have the opportunity to assess whether the disclosures made by Estrada (specifically, about his claims about "hoodlums in robes" when he was president), Tulfo and Bondoc are true, and would merit sanctions against erring members of the judiciary, if any.

Kapunan should seize this opportunity to respond to calls by Chief Justice Lourdes Sereno herself for lawyers to come out in the open and expose the grafters and the corrupt in the judicial branch of government, instead of simply murmuring their complaints under bated breaths, and thereby trailblaze a cleansing process that would restore judges and justices to their noble role of maintaining justice in the courts.

REMOVE SC CONTROL OVER LAWYERS: In line with this, here are earlier columns I wrote about corruption in the judiciary. On September 27, 2013, I said: "If we really want lawyers to 'spill the beans' on corrupt judges and justices, as Chief Justice Maria Lourdes Sereno proposed during a gathering on 25 September 2013, the first step that should be done is to remove Supreme Court control over the legal profession, and allow lawyers to police themselves through an independent Integrated Bar of the Philippines (IBP).

"For as long as any judge will have the opportunity of becoming a Supreme Court justice at some point in his or her judicial career, and the Supreme Court shall continue having the power of life and death, literally and figuratively, over any lawyer, talk about who is corrupt will remain 'hushed-hushed', 'in bated breath', and through 'blind items', for reprisals against whistleblowing lawyers can come real fast and easy."

SC SHOULD CALL WHISTLEBLOWERS, TOO:

On October 11, 2013, I wrote: "Corruption in the judiciary is a very ticklish subject matter to tackle, simply because those supposed to be involved in it—the lawyers and the judges or justices and, many a time, even the prosecutors under the Department of Justice—simply would seldom talk and incriminate themselves. But, every now and then, there are some who are imbued with the courage to talk, and it is these people who should be called to spill the beans, so to speak.

'First, I am referring to Manila Mayor Joseph `Erap' Estrada, whose short-lived presidency was pockmarked with accusations about what he referred to as 'hoodlums in robes'. Indeed, everyone in the whole Philippine archipelago knew what he meant—corrupt judges, justices and prosecutors, or the members of the prosecution arm of the executive branch of government and the men and women of judiciary who sell, to the highest bidder, their decisions.

"However, he was never given a chance to detail his accusations, after he was ousted in what is now known as the second EDSA People Power Revolution, which ouster was subsequently confirmed and validated

This was the message of the Department of Health- Cordillera Regional Office (DOH-CAR) and partner agencies officials during the launching of this year's "Iwas Paputok" advocacy campaign in the Kapihan sa Baguio, Wednesday at the DOH regional

DOH-CAR Assistant Regional Director Dr. Amelita Pangilinan, said that the "Iwas Paputok" campaign theme, "Maging ligtas ngayong kapaskuhan, mga biktima ng kalamidad handugan" (Be safe this Christmas Season and help victims of calamities) aims to reiterate the health department's advocacy against the use of firecrackers/fireworks to ensure the safety and health of everyone, as well as to advocate the need for all sectors to work together in helping our fellow Filipinos that were devastated by the recent calamities that hit the country namely Typhoon Yolanda, Bohol Earthquake and the Mindanao Crisis.

DOH Health Emergency Management System head Elnoria Bugnosen, in the same media forum, reported that the DOH has recorded 58 cases of fireworks related injuries in the region during the surveillance period from Dec. 21, 2012 to January 4, 2013, an 11 percent increase compared to the same period in 2011-2012.

Out of the 58 cases, 33 belonged to the 6 to 12 years old age group. 19 of the injury cases were caused by "Piccolo". Abra registered the most cases with 19 followed by Baguio City with 15.

Meantime, Baguio City Mayor Mauricio Domogan, one of the panelists during the forum, bared his decision to ban selling any kind of firecrackers/fireworks in the city as he called for public support in ensuring the safety of everyone especially

He also enjoined the local chief executives of nearby Benguet provinces - La Trinidad, Itogon, Sablan, Tuba and Tublay - to support the "Iwas Paputok" campaign by banning the selling of firecrackers in their respective communities.

Last November 30, a white passenger van from Buguias, Benguet bound for Baguio City fell off a 50-meter ravine at Calasipan, Atok resulting to the death of two passengers including Mountain Province State Polytechnic College President Dr. Eufemia Lamen who died while being operated at the Baguio General Hospital and Medical Center in Baguio City on Sunday.

Another passenger identified as Bernabe Lablabong was pronounced dead on arrival at the Atok District Hospital while 14 more others were rushed to the Atok District Hospital and at Pines City Doctors Hospital and BGHMC in Baguio City for further treatment.

Atok Police Chief, PInsp. Cleff Vencio bared based on their initial findings, the driver identified as Jimmy Bangbanga dozed causing the van to fall into the ravine. Bangbanga is still recuperating at the BGHMC and may face several charges.

Survivors of the tragic accident were PO3 Sabyat Rolex, 40; Ngosi Tino, 45; Danilo Melvin, 18; Victoria Licwasen,33; Bernaditte Dinisia, 32; Elena Salipen,65; Jake Bantasan, 29; Tito Ingosan, 57; Rachel Bacte, 16; Ben Bayas, 17; Marietta Pagnas, 51; Dona Jane, 1 year and 2 months and Charlene Calabson.

mous or non-existent.

Fangasan said all forms of solicitation, including those intended as support to victims of Typhoon Yolanda and other calamities, will have to be covered by a permit to be issued by the city mayor.

For caroling activities this yuletide, Fangasan said the permit is issued by the punong barangay of the community where the driver is to be conducted. If it covers more than one barangay, the city mayor issues the permit.

"The number of individuals, organizations and corporations in the city who seek donations and voluntary contributions have increased over the past years, thereby (necessitating their regulation) to obviate illegal fund drives and to protect the general public," the draft of the executive order pointed out.

Fangasan added that issuances of laws and administrative orders regarding solicitations sometimes create confusion and conflict at the regional and national level, prompting the need for the city to issue guidelines.

Pending the issuance of the executive order, all individuals and groups who are into soliciting donations for Typhoon Yolanda victims will be enjoined to submit a detailed report on the cash and goods they have collected and the identities of the calamity victims or beneficiaries of these.

"We are also asking them to apply for permits through our office so that their project can be monitored and their legitimacy and reputation upheld and protected," Fangasan said.

The permit requirement was agreed upon during a meeting with mayor Domogan and city councilor Peter Fianza, who was earlier designated as acting chair of the city relief operations for the typhoon victims

The draft guidelines limit the administrative expense from the proceeds to 15 percent of the total gross income, with the remaining 85 percent to go to the project to be undertaken by groups. In case the fund-raising activity is solely through voluntary contributions, the administrative expenses shall not be more than 10 percent of the total collection.

That provision, Fangasan stressed, protects the charitable or civic purpose of a fun-raiser, given complaints from would-be beneficiaries of concerts and fun-runs that they actually received nothing or only a pittance of the collections as the organizers had jacked up administrative expenses, sometimes to the point of declaring loss.

The draft also enjoins media outlets to air or publish only projects which are already covered by permits issued by the mayor and to ask the organizers to submit, also for publication or announcement, a detailed report on the collections and disbursements of the fund drive they undertook. The report will include donors and their corresponding contributions, together with the identities and personal circumstances of the beneficiaries and the contributions they received.

Some previous fun-runs and concerts were announced for the benefit of patients when these re launched but nothing was

heard from the organizers on how much was collected and how much and to whom the proceeds were distributed after the race or the show.

The mayor's permit, Fangasan said, may also be the basis for police officers and volunteer communication and support groups to respond to requests for them to assist in the conduct of legitimate fund-drives-for-a-cause.

Meanwhile, a staff member of the city mayor's office also clarified that mayor Domogan has not issued any permit for any solicitation activity pending the issuance of the guidelines.

Ryan Mangusan, the mayor's personal secretary, announced this in the wake of reports reaching the office that some solicitors are out seeking contributions using fake permits./Ramon Dacawi.

incumbent PPC chair **Tony La Vina** said the council had been inactive for sometime and needs to re-charge batteries now with the Enrile complaint filed before it.

Provincial or regional press councils may also be organized by the local press groups to address their own local problems. I was informed that the press council that is most active and functioning today is the press council in **Cebu City**. I touched base with the council through **Ms. Cherrie Lim** when I was in Cebu last week. We need to replicate this mechanism nationwide. For the moment, the Philippine Press Council has been moribund and it got out of long slumber only with this recent complaint filed before it by a senator of the Republic.

This will now bring me to some other important points I wish to stress. If the press council is active and functioning and worthy of the public's trust, there is in fact no more need for Congress to pass the controversial "right to reply bill" that media is opposing. I understand the "right to information" bill that media is pushing is still pending in Congress and is subject to a "quid pro quo" deal where the last time I checked, Congress seemed to push for an "exchange deal" for the latter's baby, the Right to Reply bill. Come to think of it, there is no more need for this "tit for tat" arrangement. The intendment of the "right to reply" law is rendered moot by this press council mechanism. Moreover, by availing of the press council grievance machinery, we all avoid and prevent long, tedious, expensive and acrimonious law suits and cases between the press and litigants seeking redress.

We always also hear the advocacy of de-criminalizing libel. This press council mechanism, if normally availed of by those who have complaints against newspapers, will bring about this desired end - even before the law is amended. Ultimately, this will all bring us a more responsible, a much livelier and freer press - a necessary bulwark of our democracy. related injuries last year while Abra recorded 17% increase, Benguet with 167% increase, Ifugao with 50% increase, Apayao with 100% increase, Mountain Province with 25% increase and Kalinga with 40% decrease.

Picollo remains the number one cause of injury in the Cordillera.

Also in the report, there has been a gradual decrease of fireworks related injuries in the city with 28 in 2008, 23 in 2009, 24 in 2010, 13 in 2011 and a slight increase in 2012 with 15 noted injuries.

The DOH has launched the "Aksyon: Paputok Injury Reduction" (APIR) towards a safe holiday season.

The call is also supported by the Police Regional Office-Cordillera and the Baguio City Police Office (BCPO), the Bureau of Fire (BFP) and the Department of Education (Dep-Ed).

Pro-Cor PSSupt. Ulysses Abellera made calls to the community to discourage relatives in bringing-in fireworks in the city.

Abellera said, "the best way to minimize injuries is not to use firecrackers."

"We are also appealing to gun owners and our policemen not to fire their guns indiscriminately not only during the yuletide season but through-out the year, "he stressed.

Dr. Donna Tuvera of the City Health Services Office (CHSO) added the most vulnerable sector of fire-

works-related injuries are children ages 11 years old and below.

"Sadly, fireworks related victims are passive users, she said.

In the event that a person gets hurt due to firecrackers, wash the wound immediately with clean water and mild soap and bring the patient to the nearest health center or hospital for appropriate treatment.

Meantime, Domogan said, "the city government should now hasten the passage of a city ordinance which will totally ban fireworks in the city."

"We should follow the footsteps of Davao City which totally eradicated the use of fireworks, "he said.

The mayor said there are safer ways to make noise during the new year like honking car horns.

"This way, we can all enjoy the Christmas and New Year with our families safely and happily, " he said.

Recently, Councilors Leandro and Karminn Cheryl Dinney Yangot proposed an ordinance making it unlawful to manufacture, sell, distribute, possess and use types of firecrackers, pyrotechnic devices and similar devices within the jurisdiction of the city which is seen to finally resolve the issue on pyrotechnics use in the city./paul rillorta

AIDS Society of the Phl engages Baguio Poets in HIV/AIDS Advocacy Campaign

BAGUIO CITY - The AIDS Society of the Philippines is adopting another strategy in its advocacy against HIV- AIDS- using poetry engaging the city's poetry enthusiasts in a poetry slam at the Mt. Cloud Bookshop along Casa Vallejo, Session Road in this city.

The Poetry Slam in partnership with Mt. Cloud and the Baguio Writers Group, engaged 12 young adult poets in a three-round poetry contests last week.

The first round was poetry reading of pre-selected poems; the second round involved originally composed poems of the participants about the HIV-AIDS advocacy campaign of "Zero New HIV infections, Zero Discrimination, Zero AIDS-related deaths" while the last round was an impromptu poem writing based on the question, "How would you react (what you would do or say) if somebody you know tell you that he/she has an HIV/AIDS".

AIDS Society of the Philippines Board of Trustees Secretary Diana Mendoza disclosed that with poetry as one of group's advocacy medium, they aim to inform people on ways how to prevent acquiring such kind of viral disease that has no vaccine yet.

She explained that HIV is the virus while AIDS is the disease state wherein a person's immune system weakens and no longer has defenses against the HIV virus. HIV she said can be acquired from unprotected sexual intercourse, unsafe blood transfusion, mother to child transmission and during illegal drug use where there is sharing of needles.

As HIV/AIDS in the country is now in an alarming situation with majority of those infected aged 15 to 24 years old, mostly students and young professionals, the AIDS Society of the Philippines is intensifying its effort of conducting information, education and communication drive among various stakeholders and communities including schools offices and other institutions.
