

Comelec reminds April 29 deadline of voters' registration for barangay, SK polls

 $\mathbf{B}^{\mathrm{ANGUED}}$, Abra - Amidst the proposal of President Rodrigo Duterte to postpone the Barangay and Sangguniang Kabataan (SK) elections scheduled on October 23, 2017, the Commission on Elections (COMELEC) here is continuing its preparations.

Provincial Election Supervisor Mae Richelle Beronilla urges qualified voters who have not registered yet to register now until April 29, 2017 in case the law governing the conduct of barangay elections is not amended.

Beronilla said the barangays can coordinate with the election officers for satellite or offsite registration.

For voters who want to transfer and those who have corrections with their names, Beronilla advises them to bring documents like certificate of residency or birth certificate.

The scheduled filing of certificate of candidacy will be on September 23 to September 30, 2017. /PIA Abra#

Respect the process", judge asks Courts to dispose old records

This was emphasized by Municipal Trial Court in Cities – Baguio City executive judge Glenda Ortiz-Soriano during the flag-raising ceremonies at city hall before officials and employees led by Congressman Mark Go, Mayor Mauricio Domogan and vice-mayor Edison Bilog.

"These days, when there is instant gratification in everything that we do, when everything can be achieved with a touch of a button, there is a waning respect for the process ... an obvious lack of tolerance for the old school," she said.

Soriano pointed out that even the wheels of justice are not spared this digitized world and claimed that as people move on with advancing technology, "there is a growing disdain for the paper and more and more reliance on the screen."

"Gone are the days when thoughts are simply put on paper and written by hand and with ink.

BAGUIO CITY – In Winnings rendered on for instant gratification this age of fast-paced paper are sometimes and results, most of the relegated as mere 'paper victories'. But that should not be. Not all paper victories are empty and for naught. These are tangible evidence of rights, and rights, to be enforced, go through a rigorous process whether in or out of court, we speak of due process," she said.

Soriano explained that due process evades a precise definition where the Constitution "simply expounds such concept with the guarantee that no man shall be deprived of life, liberty, or property without due process of law. The purpose of the guaranty is to prevent arbitrary encroachment against the life, liberty and property of individuals."

She added that the due process guaranty serves as a protection against arbitrary regulation or seizure and it speaks often times of a long and tedious process of notice, of the opportunity to be heard, of establishing the ground prior to any deprivation or regulation of rights.

Building owners back free parking spaces for customers

BAGUIO CITY -Representatives of various companies that operate various buildings in the city expressed their support to the passage of the pending proposed ordinance in the City Council requiring all commercial establishments to provide free parking spaces for their patrons and customers.

Bantay Basura revs up garbage management efforts in La Trinidad

A TRINIDAD, Benguet - The local gov-Lernment revved up its garbage management efforts with the deputization of Bantay Basura personnel and the issuance of citation tickets to violators.

This is aimed to prolong the life span of the newly opened compartment or Cell 3 of the Engineered Sanitary Landfill (ESL) in barangay Alno here.

Municipal Environment and Natural Resources Officer Arthur Pedro said Cell 3 will only accommodate residuals and has a life span of 14 months only. Thus, segregation at source is being advocated. Municipal Ordinance No. 53 -98 or the Comprehensive Solid Waste Management Ordinance is now also strictly implemented.

Pedro said a total of 183 Bantay Basura personnel have been deputized to monitor compliance to solid waste segregation and to ensure that the bringing out of garbage during prescribed schedule of collection is being followed by households and establishments.

The waste management ordinance also provides penalties for violators. To date, 21 violators were recorded at the Municipal Treasury while reports of violators at the barangay level are being consolidated. Fines vary for residential, sari-sari store, mall, hotel, among others, he added.

The installation of Bantay Basura and issuance of citation tickets made an impact, Pedro reported. People, he said, are becoming aware of their responsibilities with the measures being undertaken and are now compliant based on their monitoring.

The town collects an average of 30-35 tons of garbage daily. The ESL in Alno was utilized for more than three years reaching its maximum capacity. In 2014, the LGU contracted out the hauling of garbage waste from the town to Tarlac until the opening of Cell 3 in February this year. The local government spent an average of P2 million a month as hauling and tipping fee. /PIA Benguet#

The Swallowed Cigarette Butt and **Other Legends of President Duterte**

The story went like this: A Filipino tourist was sitting in a restaurant in Davao City $m{I}$ and refused to put out his cigarette despite a strict city smoking ban.

The mayor, Rodrigo Duterte, was called to the scene. Eat the cigarette butt or lose a valuable piece of male anatomy, the mayor said, pointing a pistol at the man's lap. The man meekly swallowed what remained of his cigarette.

It seemed the perfect anecdote for a New York Times profile of Mr. Duterte to illustrate his violent nature and his hands-on style of running the city.

Too perfect.

As with many of the stories that swirl around Mr. Duterte, who is now president of the Philippines, the truth is hard to pin down. He and his supporters promote tales that place him at the center of police raids, brutal killings and other acts of macho violence.

But on closer inspection, many of Mr. Duterte's most remarkable deeds dissolve into legend — making reporting on him all the more challenging.

Mr. Duterte speaks often and freely, which provided a wealth of material for the profile. Yet he declined to be interviewed or answer questions directly, making the job of separating fact from fiction that much harder.

For instance, one tale I chased was the report **DITORIAL** of his pushing a usua control of his pushing a usua con of his pushing a drug lord out of a helicopter and years, and although a former diplomat told me

that Mr. Duterte had once crowed to him about it, details proved scarce. Who was the drug lord, and where was the helicopter? When did it happen? And why were the mayor and a drug lord in a helicopter together? Answers to these questions never surfaced.

Mr. Duterte has bragged many times about personally killing people. In December, he boasted about patrolling his city by motorcycle years before, looking for criminals to kill. At other times, he spoke of stabbing a man at a beach and shooting kidnappers in police raids.

During two trips to Davao City, in the southern Philippines, I pursued these and other cases. While proof was usually lacking, the story of the swallowed cigarette butt was promising because it looked like there were witnesses.

Emmanuel Piñol, a longtime friend of Mr. Duterte's who is now his secretary of agriculture, had recounted the episode on Facebook, complete with quotes from participants. The post, which cited "sources close" to Mayor Duterte, was shared nearly 5,800 times and drew 1,700 comments.

According to Mr. Piñol's account, the arrogant tourist was informed of the local smoking law and responded by insulting the mayor. The restaurant owner called the police and asked them to summon Mr. Duterte.

He pulled out his snub-nosed, .38-caliber revolver and threatened to shoot. After the man swallowed his cigarette butt, Mr. Piñol wrote, the mayor told him, "Never, ever challenge the law."

I called Mr. Piñol for details. When did this happen? Which restaurant? Was it possible to contact the owner or other witnesses?

Mr. Piñol, a former journalist, was friendly, if vague. He said he had never asked Mr. Duterte for the restaurant's name, which seemed odd. And it wasn't clear who the witnesses were. But he promised to get more information for me.

He never did. Nor *did he take my calls after that.*

I tried to find others who knew of these events. One of Mr. Duterte's friends came up with a restaurant name. The owner said he knew nothing about it.

Jocellyn Duterte, Mr. Duterte's sister, said she believed that the cigarette butt and helicopter stories were just myths.

Finally, I asked Mr. Duterte's communications secretary, Martin Andanar, if the smoking incident was true.

Mr. Andanar, also a former journalist, put the story to rest, at least for me.

"Secretary Piñol said the story has become a stuff of legend," Mr. Andanar said in an email. "It has been the talk of the town in Davao for many, many years." / By RICHARD C. PADDOCK/www.nytimes.com

priate inputs for the realization of the long overdue commitment of the government to the inhabitants of the concerned barangays.

According to him, residents in the barangays to be segregated must understand the rules and regulations being implemented by BCDA and JHMC regarding the entry of construction materials wherein if the said materials will be for the improvements of their houses, then they must coordinate the matter to the JHMC for their information and guidance.

Under existing rules, vertical and horizontal improvements of structures within the barangays situated within the Camp John Hay reservation are prohibited, except for individuals who own titled properties in the said barangays.

Domogan claimed what is important now is the present BCDA and JHMC officials recognize the validity of the 19 conditions imposed by the local government for the development of the 247-hectare John Hay Special Economic Zone (JHSEZ) wherein one of the conditions is for the BCDA to facilitate the exclusion of the 14 barangays from the forest reservation.

He pointed out the present BCDA and JHMC leadership is proactive that is why there is no compelling reason why the long overdue segregation of the 14 barangays will not be realized considering the existence of final survey results which only needs the approval of the DENR to start the process wherein the people in the barangays to be segregated will have the chance to process the titling of their lots once the lands in their barangays will be reclassified to be alienable and disposable.

compliance to the provision of parking spaces within their buildings as approved by the Local Zoning Board of Adjustments and Appeals (LZBAA) while other building owners admitted their structures were issued notices of violation by the City Building and Architecture Office (CBAO) for their failure to provide parking allocations for their customers, thus, they are currently on the process of working out their compliance to the notice of violation issued to them.

The building owners pointed out their customs deserve free parking spaces when transacting business with the different establishments in their structure, thus, there must be a provision that will be included that the security personnel or the staff of the company have the right to validate the receipts of the patrons and customers upon leaving their business areas to ascertain whether or not the customers really transacted business with their establishments to avail of the free parking for a certain duration of time.

The proposed ordinance will still be subjected to further consultations with the various stakeholders in the city to get their sentiments on the matter before the local legislative measure will be calendared for second reading before publication, second reading after publication and third reading after the introduction of the necessary amendments when it will be formally deliberated.

More benguet towns, barangays adopt resolutions of support to free dialysis drive

BAGUIO CITY – More Ramon Dacawi said. Last week, more sig barangays adopted resolutions or support to the on-going campaign to make dialysis a free medical service in the country.

Baguio Correspondents and Broadcasters Club Inc. (BCBC) moved the submission of the documents to President Rodrigo Duterte and other national government offices to a later date this week to accommodate more resolutions from other local government units as well as signatures being submitted by groups and individuals who volunteered to conduct their own initiatives.

Last week, more signatures were received from the Benguet Renal Center Patients and Caregivers Association headed by Ariel Bastian, St. Louis University renal center, Kias barangay and the Dept. of Environment and Natural Resources (DENR) bringing the total signatures to roughly 40.000.

Bastian and his co-patients also forwarded copies of the resolutions of support to the campaign adopted by the provincial government of Benguet, municipalities of La Trinidad, Îtogon, Kapangan, Buguias, Tublay, the Liga ng mga Barangay of La Trinidad and Buguias and the Sangguniang Barangay of barangays Puguis, Cruz and Poblacion all of La Trinidad town.
