ANILA, Philippines (UPDATED) – Martial Law victims on Monday, August 15, asked the Supreme Court to intervene and stop the planned hero's interment for the late dictator Ferdinand Marcos.

Led by former Bayan Muna Representative Neri Colmenares and activist Bonifacio Ilagan, the petitioners argued that the late president does not deserve a slot in the national shrine because burying him there violates Republic Act 289, which created the Libingan ng mga Bayani.

"The law states that only Presidents worthy of emulation and inspiration deserve to be buried there," Colmenares told reporters in Filipino.

Merger of Baguio barangays pushed Illegal BIBAK structures to

BAGUIO CITY -Mayor Mauricio G. Domogan wants the long overdue proposal for the merger of the city's 128 barangays to guarantee the maximum utilization of available resources for the development of the smallest political subdivision in the current bureaucracy.

The local chief executive said the merger of the existing number of the city's barangays to a lean and mean number upon proper consultations with the concerned sectors will definitely help in the much-awaited progress and development of the city.

'We have to make sure that our barangays will comply with the provisions of the Local Government Code so that they will have the available resources to spur the desired growth and development in their respective areas of jurisdiction," Domogan stressed.

Under the provisions of the Local Government Code (LGC), a barangay should have at least 5,000 inhabitants in order to legally exist as the smallest political subdivision.

The city mayor clarified that the merger of the city's barangays will only be pursued after thorough consultations to gather the sentiments of the local residents on the desired merger in compliance with the provisions of the LGC and other related laws, rules, and regulations.

According to him, there are many barangays under the current situation that cannot actually comply with the provisions of the LGC in terms of population thus the need for the local government to revisit the existing number of barangays to comply with the minimum number of inhabitants required for a barangay to independentlv exist.

However, he admitted that there had been strong opposition to the proposed merger when it as earlier proposed in the early 2000s because there are barangay officials who fear that they might be displaced from their current positions once merged with their neighboring barangays which are bigger in population,

among others.

Domogan claimed the ideal number of city's barangays is 42, but depending on the result of consultations aimed getting inputs from stakeholders, it could be increased.

He added among the benefits included in the merger of barangays are increased internal revenue allotment (IRA) for the implementation of development projects and improved delivery of basic services, guaranteed salary for barangay officials, the hiring of enough number of workforce that will help in the effective and efficient delivery of services to constituents.

Domogan appealed to concerned stakeholders in the barangays to share their views on the planned merger by actively participating the projected consultations with the knowledge that the merger of the city's barangays will only take effect after the completion of the term of barangay officials who will be elected this October 2016./By Dexter A. BAGUIO CITY – The City government and other concerned agencies will pursue the demolition of at least sixty illegal structures constructed by informal settlers over a 5.000-meter land area under the name of the Benguet-Ifugao-Bontoc-Apayao-Kalinga (BIBAK) along Harrison road anytime next month.

Mayor Mauricio G. Domogan said the demolition of the illegal structures within the BIBAK property has been a long-standing problem for the local government and concerned government agencies, but now that the courts and other quasi-judicial bodies have spoken in favor of the demolition of the illegal structures, the occupant informal settlers must now voluntarily dismantle their structures before the

The illegal structures in the BIBAK property were up for demolition August 2015 but the informal settlers sought the intervention of the court which granted them respite. However, the Regional Trial court (RTC) decided that the informal settlers do not have a right to the property which has been

the property of the State. We appeal to the informal settlers to start voluntarily demolishing their structures so that they can salvage important materials and personal belongings. We have gone through the tedious legal process and the courts have already spoken," Domogan said.

occupants of the government property and it found the existing informal settlers not to be considered as urban poor.

According to him, the informal settlers are not also qualified for possible relocation because most of the existing structures are in violation of the provisions of Republic Act (RA) 7279 or the Urban Housing and Development Act (UDHA).

Domogan explained he is optimistic that owners of the illegal structures within the government property will comply with the call of the local government for the immediate demolition of their structures and not to wait for the scheduled demolition so as to avoid possible conflict during the demolition is enforced.

City to pursue LED lighting system

BAGUIO CITY -Mayor Mauricio G. Domogan said the local government is studying the possibility of converting its existing streetlight system into the much accepted Light Emitting Diode (LED) lighting system to reduce the cost of lighting public places.

We have to continue finding ways of reducing

expenses in our streetlight bulbs currently used for system to have sufficient savings that could be used to improve the system through the purchase of much cheaper but quality LED bulbs," Domogan stressed.

The city mayor revealed an available budget of P12 million for the purchase of LED bulbs to replace

the city's streetlights but the city's technical personnel is still evaluating what would be the most practical solution to reduce the expenses of the local government on streetlight operation.

Local executives warned on modus of enterprising individuals

BAGUIO CITY – The Department of the Interior and Local government (DILG) recently warned local officials and employees not to deal with enterprising individuals who misrepresent themselves as close aides of Interior and Local Government Secretary Ismael Mike Sueno and collect from them monetary considerations in exchange for the immediate release of their pending requests with the agency. among other considerations.

In an advisory to all provincial governors, city, municipal mayors, DILG regional directors and other concerned officials and employees, Josephine C. Leysa, DILG Head Executive Assistant, informed local officials that there are some enterprising individuals who misrepresent themselves as an official or employee working or otherwise connected with the agency through short message service, email communication, letter, verbal or in any other form and name

1,980 tuberculosis cases recorded in Cordillera

BAGUIO CITY – Health authorities preported decreasing tuberculosis cases but not as fast as they were projected towards achieving a tuberculosis free global village by 2035.

Dr. Alexie Marrero, head of the regional epidemiology and surveillance unit of the Cordillera office of the Department of Health (DOH-CAR), said individuals seeking medical attention for tuberculosis is increasing but the overall actual number of cases is decreasing but not in accordance to the rate that they have projected in order to achieve the goal of the World Health Organization (WHO) for the world to be free of tuberculosis.

"Tuberculosis cases are decreasing but not in accordance to the pace that we have projected. We call on individuals suffering from one to two weeks of continuous cough to immediately seek medical attention because TB is curable," Marrero stressed.

Clint Gil Ildefonso, TB and leprosy program coordinator of the DOH-CAR, said that the health department provided the medication of 1,980 tuberculosis patients by the first semester of this year compared to the 3,594 cases by the end of last year.

According to him, one of the problems that health authorities encounter is discontinuation of medication by patients due to felt side-effects, and this does not cure the illness but instead allows them to contaminate other individuals.

Ildefonso reported there is a 90-percent success rate in the treatment of tuberculosis patients who have completed the 6-month medication cycle which is why health officials are encouraging possible TB suspects not to hesitate in seeking medical attention from the nearest health facility because the TB medicines from the health department are free.

He advised people suffering from continuous cough not to self-medicate because it might worsen their condition, but instead to seek early medical consultation with health experts from the nearest health facilities.

dropping any DILG official or employee, to solicit favour in the form of money and other considerations.

"All concerned are hereby advised to report to the Philippine National Police or appropriate authority any related incident as mentioned," Leysa said.

It was learned that said individuals had been approaching several local chief executives in the different parts of the archipelago and informing them of their influence to facilitate the immediate release of the funds for projects or their pending requests for fire trucks and police cars, in exchange for a certain amount of money.

These individuals disappear after receiving money from those who believe in their modus operandi.

Leysa advised local officials, particularly the newly elected ones, not to entertain such individuals but to directly transact business with the municipal, provincial, city, regional and national offices of the agency to avoid being victimized by such individuals.

According to her, concerned DILG officials who are in charge of the release of funds and units of equipment being distributed to the different local governments are prohibited from collecting any monetary considerations in exchange for the speedy processing of requests and fixers claiming to facilitate release of pending requests should not be entertained.

She underscored that it is the duty of officials and employees of the agency to work out the release of the requests of concerned local officials without anything in exchange for the grant of such requests, thus, any demand for monetary considerations for such releases should not be actually entertained in the first place.

At the same time, the DILG has not authorized any individual to transact with local officials regarding the processing of their requests as all the work is done within the respective offices and not outside./D. A. See

Law prohibits Marcos' burial at the Libingan ng mga Bayani - Atty. Mel Sta. Maria

"The late President Ferdinand Marcos cannot be buried at the "Libingan ng mga Bayani." The law prohibits it."

This is what lawyer, professor and broadcaster Mel Sta. Maria said in his opinion I column at InterAksyon.com about the planned hero's burial for the late dictator this September 18.

President Rodrigo Duterte gave the go signal for Marcos' burial as a way of keeping his campaign promise.

Sta. Maria cited that Section 1 of Republic Act No. 289 does not allow the burial of Marcos at the hero's cemetery.

"Section 1 of Republic Act No. 289, otherwise known as "An Act Providing for the Construction of a National Pantheon for Presidents of the Philippines, National Heroes and Patriots of the Country" is quite clear in its purpose - to 'perpetuate the memory of all Presidents of the Philippines, national heroes and patriots for the inspiration and emulation of this generation and of generations still unborn."

He pointed out that the cemetery is meant only to be the final resting place for honorable men and women who are inspiring and worth emulating, something that Marcos wasn't.

The lawyer also brought up how Republic Act No. 10368 acknowledged the horrors of the Marcos regime under Martial Law. He quoted this provision:

"... it is hereby declared the policy of the State to recognize the heroism and sacrifices of all Filipinos who were victims of summary execution, torture, enforced or involuntary disappearance and other gross human rights violations committed during the regime of former President Ferdinand E. Marcos covering the period from September 21, 1972 to February 25, 1986 and restore the victims' honor and dignity. The State hereby acknowledges its moral and legal obligation to recognize and/or provide reparation to said victims and/or their families for the deaths, injuries, sufferings, deprivations and damages they suffered under the Marcos regime.

Similarly, it is the obligation of the State to acknowledge the sufferings and damages inflicted upon persons whose properties or businesses were forcibly taken over, sequestered or used, or those whose professions were damaged and/or impaired, or those whose freedom of movement was restricted, and/or such other victims of the violations of the Bill of Rights."

The late President Corazon Aquino created the Presidential Commission on Good Government (PCGG) as her first executive order, Sta. Maria added. He said that the commission has recovered around P170 billion of the Marcoses' ill-gotten wealth and is still trying to recover millions or billions more. He pointed this out as the dictator's "memory" that should not be perpetuated, as provided for by RA 289, and could not be distinguished as a hero's achievement.

Duterte kept raising the fact that Marcos was a soldier, earning him a spot at the hero's cemetery, but Sta. Maria quashed it, saying that that National Historical Commission of the Philippines (NHCP) considers Marcos' exploits and medals as a soldier as dubious.

The lawyer cited that burying a "dishonorable and corrupt president" cannot be within the noble intent of RA 289.

Sta. Maria added that this line, "shall be the burial place of their mortal remains" should not be taken as a command, since the Supreme Court has ruled that this should mean "permissive when no public benefit or private right requires that it be given an imperative meaning." He explained that the Marcoses do not have a private right on the hero's cemetery and the strongman's burial at the sacred place does not have any public benefit.

And not all presidents were buried at the cemetery, like the late Presidents Manuel L. Quezon, Sergio Osmeña, Ramon Magsaysay and Manuel Roxas, he emphasized.

Sta. Maria said that pushing through with Marcos' burial will "desecrate" the hero's cemetery.

"To honor him, despite the recovery of billions of ill-gotten wealth (which is still on-going) and in spite of the unequivocal public-policy-recognition of the savagery of his regime against his own countrymen/women, is to render absurd Republic Act Number 289 and desecrate the 'Libingan ng mga Bayani,'" he said.

For those who reasoned out that the burial would mean moving on from the darkest period in Philippine history, he said that while this might not

undo what happened, refusing his burial means that the Filipinos refuse Tired of Graft & Corruption? to be "subjected to the cruelty and greed of a despotic president."

"And if erasing the memory of one of the darkest periods in our history after World War II is what the proponents of this Cont. on page 6

FDA: bottled water "high risk food product"

FDA: BOTTLED WATER "HIGH RISK FOOD PRODUCT": Here's a totally scary information coming from the Food and Drugs Administration (FDA) of the Philippine Department of Health: bottled water, which is the source of drinking water for millions and millions of Filipinos today, is classified by the FDA as unsafe because it is a "high risk food product".

In FDA Circular No. 2016-014 which is dated August 12, 2016, bottled water, along with many other food items, are determined by the government to contain harmful chemicals and pathogenic microorganisms that support the formation of toxins or the grown of pathogenic microorganisms (please see http://thestandard. com.ph/dailypdf/2016-08-18).

What are pathogenic microorganisms? According to Global Food Safety Resource, in its website www.globalfoodsafetyresource.com (http://globalfoodsafetyresource. com/food-science/pathogenic-organisms), they are organisms "capable of causing disease in its host. A human pathogen is capable of causing illness in humans. Common examples of pathogenic organisms include specific strains of bacteria like Salmonella, Listeria and E. coli, and viruses such as Cryptosporidium..."

OTHER FOOD ITEMS "CAPABLE OF CAUSING SICKNESS": But that is not the only scary information FDA dished out in its Circular No. 2016-014 dated August 12, 2016. It also classified many other food items and drinks as high risk food products and are therefore unsafe. By way of public service, I am listing these food items and drinks here.

Under the heading "dairy products and analogues: 1. Milk and dairy based drinks. A. Milk (plain) and buttermilk (plain). B. Dairy based drinks, flavored and/or fermented (e.g. chocolate milk, cocoa, eggnog, drinking yoghurt, whey based drinks). 1. Fermented and renneted milk products (plain), excluding dairy based drinks.

"3. Cream (plain) and cream analogues. A. Pasteurized cream (plain). B. Sterilized and UHT creams, whipping and whipped creams, and reduced fat creams (plain). C. Clotted cream (plain). D. Cream analogues."

City tree management programs gaining ground

BAGUIO CITY – The tree management and improvement program of the city government is gaining ground with a total of 30 trees rescued now in Burnham and other parks.

City environment and parks management officer CordeliaLacsamana said the salvaged trees underwent tree surgery performed by CEPMO foresters and partners from other agencies including the Green Core Society.

The program began in 2009 aims to rehabilitate trees damaged by typhoons and manage those infected by pests as part of the city's efforts to protect the trees and to maintain the city's green environs.

Under the program, trees damaged by pests will undergo tree surgery while those severely damaged or with center rot will have to undergo sanitation cutting to avoid infecting other trees or posing danger to lives and properties.

The management program also covers tree rejuvenation through trimming and pruning as what was done recently to trees at the Rizal Park which elicited

Open letter to Marcos family

This letter comes as a plea for you to recall your request to have your beloved Ferdinand Marcos buried in the Libingan ng mga Bayani, to avoid further divisiveness in this country and make it easier for President Duterte to do what he desires, which is to bring significant change in all sectors.

Although we have been at odds on many issues in the sociopolitical world, at last we have found a common ground: to support our President's goals and dreams for the country. It is his great desire to unite all sectors of society so that our country can move on toward greater peace and prosperity for all.

In his intention to eradicate divisiveness, the President has graciously given in to your call to bury the head of your family in the Libingan, believing that no matter the alleged crimes he committed against the people, he was still a soldier and a duly elected president.

But there are a multitude of reactions that will surely emphasize the divisiveness, and one of the mildest comes from Mel Sta. Maria. In his online article, he quotes nothing less than a law, Republic Act No. 10368, which states: "... [I]t is hereby declared the policy of the State to recognize the heroism and sacrifices of all Filipinos who were victims of summary execution, torture, enforced or involuntary disappearance and other gross human rights violations committed during the regime of former President Ferdinand E. "Similarly, it is the obligation of the State to acknowledge the sufferings and damages inflicted upon persons whose properties or businesses were forcibly taken over, sequestered or used, or those whose professions were damaged and/or impaired, or those whose freedom of movement was restricted, and/or such other victims of the violations of the Bill of Rights."

This law is unknown to many young Filipinos, as seen in the number of votes that Bongbong Marcos received in the vice presidential election. For you to proceed to bury the late president in the Libingan will not only reopen old wounds but also create a greater divisiveness which the President really wants to wipe out. This will only serve to distract his attention from his "war" on drugs, criminality and corruption in our clearly drug-ridden nation. Why bring back to life the dead past and disturb our new President from his focus on more important matters?

I believe that your family is now in a position to help the President bring forth his dream to expunge the divisiveness that he perceives to be standing in the way of a progressive, peaceful and prosperous country, by taking back your appeal to have your beloved Ferdinand Marcos buried in the Libingan. Please consider leaving his remains where they are now; it is, after all, his place of birth where many consider him a hero and even revere him as a saint.

Considering that rabies is a public health problem worldwide, it is the mandate of local government units to ensure that all dogs are registered under Republic Act 9482 also known as the Anti-Rabies Act of 2007.

With the on-going animal population survey, the CVO has already covered around 35 barangays in the city. Out of the 17,448 households covered, there are 8,599 who are dog owners.

Moreover, from July 1 to August 15 survey, there are 16,855 dogs; 1,607 cats; 9,361 chicken; 1,430 other avian (birds, ducks, goose, etc.); and 1,113 swine recorded in the Baguio.

"The most frequent way that human become infected with rabies is through the bite of infected dogs, thus, monitoring and control of stray dog population is still one of the important and effective tools for the prevention or rabies in man and animals," said
