Council drums up support to anti-jueteng crusade

BAGUIO CITY -The city council last Monday sought to drum up support for an anti-jueteng crusade it passed a as resolution "enjoining the people of Baguio to actively participate and to express their strong opposition to the continued operations of jueteng and other illegal gambling activities in the city.

The measure was proposed by Councilor Perlita Rondez in reaction to the fact that the illegal numbers game continues to run in the city.

Mayor Reinaldo Bautista Jr. who earlier gave the city police an ultimatum to stop jueteng in ten days the other week told his

press briefing that the city police responded to his order through a report from director Moises Guevarra indicating that they have driven away jueteng operations even the guerilla-type operations from the city.

The mayor said the city police should now work to sustain this status.

The fact that the guerrilla-type draws have been stopped in the city however does not guarantee that jueteng operations have stopped in the city as it can happen that the draws were just transferred in nearby municipalities but the bets are still being made in the city. In the resolution,

date, the city police have not made a declaration that the city is "jueteng-free."

"To date, Baguio City is not free from other illegal gambling activities," she added. "There is a need

to enjoin and call on all residents and organizations to actively participate in the crusade to curb jueteng and other gambling illegal activities by requesting them to immediately report any draws, lotteries or 'bolas' being undertaken in their barangays and to submit the names of all bet collectors or 'cobradores' and all other illegal operators and protectors of the said illegal number games,' the resolution noted.

to enjoin all residents and organizations to submit their respective petitions or position papers to the Sangguniang Panlungsod STRONGLY **OPPOSING** the continued operations of jueteng and other illegal gambling activities so that they may be furnished to the DILG, PNP and other concerned authorities.'

Mayor's 100-day report

Mayor Reinaldo Bautista, Jr. during the State of the City Address (SOCA), October 11, 2007, took pride in his own "Men in Black" on top of other citv accomplishments as he claimed, "we have accomplished, in a span of few weeks, previous what administrations took years to address.³

At the mayor's right flank, a blushing Public Order and Safety Division (POSD) chief Gregorio Deligero could only try to hide pleasure. With a sigh of satisfaction he whispered, "With the mayor's admiration, I guess we'll just have to do better in an unremitting fashion."

Bautista flashily mused, "I am sure [you] have felt that extraordinary feeling of being transported back in time when elements POSD, together with our volunteers and law started enforcers clearing up easements

and our market from unsightly encroachments and illegal vending activities."

Armed with hammers, bolt-cutters, and their signature ball-cap and black uniform, Deligero's unit composed of 17 men earlier braved Burnham Park, the side streets of the business district and the market, vielding vending materials enough to build a house and fill a small warehouse with.

Meanwhile. Deligero revealed that POSD is closely coordinating with city administrator Peter Fianza in conducting dialogues with displaced informal businessmen.

He said that the POSD has adopted a policy of "implement anti-vending laws now, dialogue later' strategy as a means letting of the affected sector realize that POSD "means business and not just photoops.'

Ifugao hospital reports 108 dengue cases

LAGAWE, Ifugao-The Ifugao Provincial Hospital (IPH) here noted 108 dengue cases from Jan. to Sept. 2007.

Dra Jaqueline Chief. Kitong, Technical Division of the IPH here said that the cases of dengue here has risen in the months of July, August and September but noted that there are no casualties. Kitong attributed the zero death to the capability of the hospital in treating the disease. There were 18 cases in July, 23 in Aug. and 38 in Sept.

Kitong disclosed that the municipality of Lagawe registered the highest number of dengue cases with 24, followed by Hingyon 19; Lamut, 14, Banaue 12; Kiangan, 11;Asipulo, 6; Mayoyao, 4; Aguinaldo, 3; and Tinoc, 2. There were also 8 outsiders from

Nueva Vizcaya, Isabela and Quirino who had their medical check up at IPHO.

The IPHO and its municipal counterparts had been conducting Information Education Campaign (IEC) in the municipalities to prevent the occurrence of the disease especially in Lamut and Lagawe.

The municipal government here started advocating for


a clean environment to prevent diseases caused by a dirty surrounding. "We are prepared

with reagents for dengue and we hope that the procurement will be faster in order to save lives," Kitong said. Due to the long process of bidding at the provincial government. the procurement of medicines and other needs are delayed./ Vency D. Bulayungan (PIA-Ifugao)



THE PEACE COMBATANT

Baguio needs better statesmanship from the office occupied by the Hon. Mayor Reinaldo Bautista

October is indigenous people's month. It is also traditionally a peasant's or farmer's month in the Philippines, being the month when the martial law land reform law was reportedly crafted and the month when many peasant leaders usually get killed as they lead protests on the streets. However, recent events in the Philippines and Baguio City made me contemplate to suggest that we make October also a garbage month.

Why? Look, Metro Manila is having a problem with garbage and so does the City of Baguio. It is probably a problem nationwide because if it is a problem in Manila then it is probably a problem elsewhere in the country. If it is a problem in Baguio City then it is a probably a problem in other municipalities of the north as well. However, later in this piece I would tell you that La Trinidad or the province of Benguet appears to be handling the problem better.

I was really planning to take pictures of all the garbage dumps in the City. That would be an excellent documentation of October 2007. I only discarded the idea when a friend told me that he is planning the same thing and found out later that my three other friends are planning to the same thing. I did not check though if they really did it but the information was enough for me to do other things instead. A hundred or so pictures of garbage dumps throughout Baguio may really give a big jolt to all of us. It would give a good message that we ought to do our share in the garbage problem. However, the pictures would also highlight how we ought not to handle the problem in our city.

The poor barangay captains and kagawads were blamed for the garbage problem. However, the fact that the problem took place in almost all barangays of the city provides evidence that the problem is systemic and cannot be blamed on the leadership of this and that barangay chairmen and councilmen. The Office of the Mayor has an important role in the problem. What are needed from his office are leadership and statesmanship and not passing the buck.

How did the Office of the Mayor attempted to solve the problem of garbage segregation in the City? Well, he declared that from henceforth the responsibility of segregating the garbage would be a responsibility of the barangay. Whew! With this kind of reasoning, it will not be surprising that the next time around, all the problems of the city would be a responsibility of the barangay: health, crime, traffic jam, meninggo coccemia, epidemics. Of course, the Office of the Mayor was probably the one responsible for the segregation leaflets posted in a few sari-sari stores. I, myself, am a practitioner of garbage segregation at home even before segregation became a fad or whatever in Baguio. However, there are really practical problems involved in segregation that cannot be resolved by sheer appeal to patriotism alone. For garbage segregation to succeed, the real cost of implementing the scheme must not be too exorbitant to implement. Otherwise, only the super patriots will be able to implement the scheme.

Information and education are important factors. There is a need to deepen our information and education drives. The leaflets in the stores will not suffice. We need leaflets in every home. Guidelines and comic books on garbage segregation must be in every house. We can fund these because we have business giants like the SM and the firms of the Baguio Economic Zone in the city. The city earns sizeable revenues.

Do we want the barangay local governments acquire greater responsibility in garbage segregation? If so then the city government must guide and train the barangay local governments and not simply impose or dictate on them. Passing the blame would be worst because that would not solve the problem and it will only earn enemies. For instance, the recyclables in the barangays can be awarded to a few collectors. The collector must not be a single collector because that will lead to complacency but not many because the collection business may not be viable to sustain. Further, the collection contracts should be for a short period (perhaps three months) only so contract renewals could be based on performance. The barangays should be guided on how they can tap people in the recycling business in managing our solid wastes. The Office of the Mayor has an important role in this. (...to be continued...)

Violence in Baguio: Dangerously High (Part I) By GRACE BANDOY



My utter apologies for a seemingly long absence from this paper, it's just that I subjected myself into hibernation after my family suffered a tragedy in August and well, I have been on a personal knotty journey too during the same time.

But hey, we can't be sad forever. We just have to get out of our rutty shells and be part of the world again so here we are.

The tragedy that happened in August to us is very, very profound (for me) and is something you'll never ever forget for the rest of your life. It has affected me gravely and has changed some of my outlooks in life.

There is an alarming rise of violent crimes in Baguio today. It's no secret. It's scary. It worries a lot of us.

One never really knows the feeling of being scared from something that is violent unless you experience it personally – when it happens to someone close to you.

I might not be the immediate family of my aunty Mary but she's my aunty Mary as long as I can remember.

She's this sweet but sometimes nicely naughty and funny old woman who decided to spend the rest of her life in the Philippines when they came here for a vacation some two years ago from the United States (after staying there for nearly a decade).

She probably thought, "why the hell should I go back there and work my ass off?! I'm staying here by hook or by crook!," so dear ole' aunty Mary stayed and lived in their family home at Hillside.

For her age of 68, she's strong and very much able. She can take care of herself! She's a super old woman. You know how some old people get – they want to be alone. I guess some of our old folks find some sort of happiness in solitude.

And like your typical senior citizen, she sometimes can be uncanny but most of the time, she's funny and greets you in the morning when you pass by her house and she can be talkative sometimes when you get into a story with her.

I love old people, (I said it for the nth time already), they're gentle, harmless, they are the world, they're way ahead all of us. They know everything already while we're just beginning to discover the real deal about life. You just want to hug them and wish that they're always safe and comfortable and happy. Their smiles are just one of the most beautiful things on earth.

I come from a poor family but if I were rich, I'll put up a shelter and gather all the old people being maltreated out there and cuddle all of them and make them happy. I'm not as affectionate towards the younger generations of our society because c'mon, we and the younger ones have a whole lifetime ahead of us to make our lives better, but these old people have been there and done it and the rest of their days should be spent with no more suffering, only good times and happy times.

They should not be out there begging on the streets and looking for food and a place to sleep in at night.

In the afternoon of August 21, 2007, my mother found the body of aunty Mary in her home, lifeless and swimming in a pool of blood. (It's hard to think about it without shedding a tear).

She has been robbed of still an undetermined amount of money and was hit in the head twelve (12) times with a more-than-14mm iron steel bar. Twelve deadly blows to the head that even the doctor who conducted the autopsy found gruesome. He said it is one of the most violent acts on a person he has known as an autopsy doctor of the SOCO (Baguio's CSI) department of the Baguio City Police office.

The fatal wounds to her head were all deep that it cracked open her skull and damaged her brains. No person on earth could have survived those kinds of wounds inflicted on her. She's a 68-year-old woman. SHE DOES NOT DESERVE THAT. And no innocent person on earth deserves that.

It has been a shock to all of us members of her family and to our community at Hillside Barangay.

It has been a sleepless 30 days for me.

No suspects, no witnesses.

I have not been a fan of dead people (attending dead people's wakes and burials, going to cemeteries, etc.) ever since my dad died (of sickness) in 2003.

But in the dark, cold morgue of the Funenaria Paz on August 23, 2007 while it was freezing and it was raining like hell, **Cont. on page 7** **TELL IT AS IT IS**

It's hard not to think about it and think of my aunt and miss her. It's unacceptable and this heavy feeling is still difficult to shrug off. One cannot fully recover from something like that.

It makes me wonder how it all became like this. Sometimes we think we're invincible, but that murder should be a wake up call for all of us that no one is safe anymore. Not even in the comfort of our own homes. And it could happen to us anytime.

Is this what Baguio has become?

The asshole who did that must not be out there free as a bird and may commit the same crime again!!

S i n o t 's TNHALA likewise demanded the city stop negotiating with individual landowners claiming TNHALA represented the will of the majority of the Asin residents.

However, with various opinions cropping up from the landowners themselves, it was clear during the meeting that TNHALA was merely a piece of the salted pie. Sinot himself revealed the meeting conducted at City Hall was "the most attended," even punning, "the only time residents attend is when city hall calls for the assembly," hinting that not all residents do subscribe to TNHALA's stand.

Fianza said, "The demands of TNHALA might be too high and that the various suggestions from other lot-owners are simply not entwined with said demands."

He explained that if such demands are anchored on the power produced by erstwhile Asin o p e r a t o r H y d r o e l e c t r i c D e v e l o p m e n t Corporation (Hedcor), the demands will be impossible to meet.

He explained, "The city only earns a fraction of Hedcor's production which is further reduced because of shares going to the municipal government of Tuba and provincial government of Benguet. "Add to this the salaries of plant workers and other operating expenses and the income of Asin becomes insignificant if we would consider TNHALA demands."

HEDCOR during its time have 2generators running in each of the three plants, not to mention reserved sets, producing about 5-thousand KWH per day.

Fianza in an earlier interview related, "While the plants have a combined generating capacity of 1,500-KWH per day... our generators are old and may just breakdown if pushed to capacity."

Plant 2 is currently in "sick bay" after flume lines supplying water to the facility was damaged.

It could be remembered that the council directed the MANCOM-TWG to d r a f t recommendations as to "whether or not it is better to maintain the facility as an enterprise managed by the city; or simply to bid out the same."

It is highly doubted however that MANCOM-TWG would be able to comply with the council deadline on October 30 with the ever changing demands of Asin landowners yet to be reconciled to a more realistic petition.

Me antime, Tuba and Benguet officials recommended Asin landowners to "go back to the roundtable" to have a united and more realistic stand before requesting a meeting with them or the city government.**ISL

Ebdane also vowed DPWH-CAR officials who participated in the mess will face charges. M o u n t a i n

Province residents traveling along the Halsema Highway (Baguio-Bontoc Road) are complaining that contractors ordered by Ebdane who himself saw the defects, are defying him.

Winning contractors of the P800 million worth SONA projects are reportedly stubborn in following "R&R" Ebdane's (already a byword by Mountain Province folks because of the alleged corruption scandal hounding these projects) claiming they lack equipment to do it and could give warranty to these projects.

"How can you give warranty to something softer than hollow blocks?", an apparently irked sec. Ebdane told journalists here after speaking at the Road Engineers Association of the Philippines (REAP) national convention Thursday last week at the Pines View Hotel. Ebdane reiterated

that those that should be repaired and replaced did not pass government standards.

earlier directed the removal and replacement of defective pavements found in ten contracts of the Phase II and III of the Halsema Road improvement project, particularly along the Mt Data, Bauko– Bontoc and Bontoc, Mt Province–Banaue, Ifugao road sections.

In his two surprise inspections in July and August of the multimillion flagship projects which were complained as allegedly "substandard", megaoverpriced, and reeking corruption, with Ebdane confirmed for himself the complaints from residents of Mountain Province reaching his office.

A core testing conducted by the Bureau of Standards also technically proved that 10 portions of the 52 contracts by at least five major contractors were sub-standard.

Four kin lose arms, legs to electrocution; cry for

help

BAGUIO CITY — Fifty-year-old John Idio, a handicraft furniture helper was looking towards a bright future for his family with his son Joey's graduation from college, when tragedy struck.

One of Idio's arm and legs were cut after he was electrocuted along with his son Joey, 24, and neighbors Marlon Sanchez, 22 and Charlie Galerio, 32.

The four were hoisting a water pipe around 20 feet up the air when the iron pole was suddenly pulled by strong current from a high tension wire passing through their frail bodies and exiting through their limbs.

They were digging a deep well for water that fateful day at their residence in Purok 1, Camp 1, Rosario, La Union on Sept. 6 around 10 a.m.

The victims are now confined at the Baguio General Hospital. They were rushed by relatives and neighbors in borrowed vehicles since caretakers of the local ambulance reportedly said they couldn't use the vehicle as it was in bad condition.

At the BGH, John's left arm and leg were amputated. Joey and Sanchez each lost a leg cut below the knee.

Both of Galerio's legs are in danger of being amputated. He was in critical condition at press time and badly needed Type A blood.

Annie Tamayo, Baguio Red Cross chief, when contacted gladly gave the needed blood but which she said, should be replaced as soon as possible since other patients may need it. Before the

accident, John's determination to send Joey to college was fulfilled. The son graduated from the University of Baguio with a degree in hotel, r e s t a u r a n t management last semester.

M e a n w h i l e, Sanchez graduated at the Lyceum Northern Luzon in Urdaneta City in Pangasinan with a Commerce degree. Galerio was a pandesal vendor diligently scouring the streets of Urdaneta for buyers particularly during the wee hours of the morning.

Except for John, all three were single. Once they would be discharged, crutches and if possible, prosthetics would be needed.

Their faces are putting a brave front, but their demeanor betrays their uncertainty. At this time, their immediate problem is where to get the money to pay their hospital bills and daily expenses which are growing by the day.

Sannie Fianza, a neighbor said their relatives contacted the Philippine Charity Sweepstakes office in Urdaneta but were told they had to give the medical abstract of the four victims so these could be studied if they really needed money.

The BGH hasn't yet released the abstract as of press time. Joey's sister Jay Ann said only Mayor Flores Bellarmin of Rosario gave financial help to the victims with a thousand pesos each.

They have reportedly asked some La Union Electric Co. officials for help in defraying their expenses (since the company owned the electric wires) but were told this would still have to be subjected to a meeting.

Barangay 1 residents have reportedly been urging LUELCO officials to relocate the wires as these posed danger to their lives but the power firm never did anything about the matter.

Relatives said some Baguio City government officials pledged to write

Mt. Prov. Gov, 15 Other Execs Face 33 counts of Estafa, Graft

BAGUIO CITYing, Sixteen provincial officials, employees and a private lawyer including Mountain Province Governor Maximo Dalog have been charged with 33 counts of estafa BAC through falsification of public and commercial documents stemming from an alleged anomalous procurement of a van which was eventually converted to an ambulance. The National of

Bureau of Investigation (NBI) in the Cordillera, in a 20-page case report signed by Valentino T. Valvuena and Atty. Paul Alain M. Moises named the erring officials and employees as Gov. Dalog, provincial accountant Teodore B. Marrero, provincial

health officer Nenita Lizardo, provincial Nurse Helen Macliprovincial administrator and Bids and Awards Committee chairman Paulo Pagteilan, Lily Rose T. Kollin, Bids and Awards vicechairperson as well as members Florence Gut-omen. Edward Likigan, Solidad Teresa F. Wanawan, Jerome Falingao and Abdon M. Emingan, Abelardo T. Pachingel, inspector of vehicle, Teodore L. Dalog, engineer IV and inspector of vehicle, provincial treasurer Cawed A. Gammonac, Ronald C. Kimakim, proprietor of RONHIL Trading and lawyer Bartolome Macli-ing. Except for Macli-

ing and Kimakim, all officials including Dalog and employees were also administratively charged for grave misconduct and dishonesty.

Governor Dalog in a telephone interview belied such charges claiming such were politically-motivated hv а losing gubernatorial bet. Although, the governor claimed he has not received any copy of the charges, he maintained his innocence. He added that the said van (ambulance) is in the possession of the provincial government.

Atty. Macli-ing was also recommended by the NBI investigating team for disbarment for participating in the alleged anomalous transaction.

The case stemmed from the letter-complaint on February 5, 2007 by former Tadian mayor Harry C. Dominguez requesting the NBI to investigate the alleged a n o m a l o u s transaction regarding the purchase of one unit Mitsubishi van acquired by the provincial government of Mountain Province and registered at the Land Transportation Office (LTO), Bayombong, Nueva Vizcaya.

The NBI verified with the LTO in Baguio City that the said vehicle bearing license plate number SGA-109 was registered on September 12, 2006 at the LTO, Bayombong in Nueva Vizcaya. C o n t r a d i c t i n g transactions involving the same vehicle was found.

On February 15, this year, Kimakim appeared before the NBI-CAR and denied having made transactions **Cont. on page 10**





Itogon tanod, cops arrest electric meter tamperer posing as BENECO employee

BENGUET: Itogon police operatives arrested Israel Badongen Fuswelan caught in the act of tampering a BENECO electric meter 4 PM of October 9, 2007 at Antamok Trail, Tuding, Itogon Benguet.

Fuswelan, 23, a resident of Kamog, Sablan, Benguet was caught by Edmund Ngina, a barangay tanod who coordinated the entrapment operation with residents and the police.

In his affidavit, Ngina said "on or about 4 PM of October 9, 2007 I received a text message through my cellular phone from Josie Kitayan informing me that a certain Israel B. Fuswelan whom they contacted together with Liza L. Abing to conduct a recalibration of an electric meter installed at the house of Mirriam Ag-agwa and purposely to entrap him and effect the suspect's immediate arrest."

Furthermore, Ngina said "I immediately proceeded to the house...whereby in flagrante, I confronted and apprehended Israel Fuswelan who was about to start to re-calibrate the electric meter using a screwdriver, and at the same time confiscated the assorted stainless screw driver, pliers, pen light with lighter and a Nokia 1600 cell phone..."

In a telephone interview with Police Chief Inspector Dennis Sabit, chief of police of the Itogon Municipal Police "there have been several complaints received by this station from residents at the said barangay regarding the collection of service fees from Mr. Fuswelan (that) prompted the residents to cooperate and conduct the entrapment..."

For a fee of P1,200 suspected meter tamperers promise BENECO consumers they will pay less for their electricity consumption. But apparently, prior to the arrest, there was one incident where the tampered meter of another resident registered double than their previous consumption and instead of paying less as promised, they had to pay double, according to Sab-it.

Fuswelan is the second suspected meter tamperer caught in the act by authorities and BENECO representatives, according to outgoing Consumer Services Department manager Lawrence Umaming. "The first whom we have filed a complaint in court died recently while the case is ongoing," Umaming said.


Meter tampering is a violation of Republic Act 7832 known as Anti-Pilferage Law. Such cases contribute a lot to the systems losses of the BENECO worth several millions of pesos.

It is a non-technical loss which is one of the contributory causes of non-technical losses which accounts for 6 percentage points out of the current 11 to 12 % systems loss of the electric cooperative covering the period January to August 2007.

Non-technical loss is a result of leaves and other things getting in contact with live wires, loose connections, and sometimes poor installation of service drops, but mostly by



cases of tampering, flying connections, etc., Landocan explained.

Sab-it and Technical Support Services supervisor Engr. Glenn Muscara are encouraging the public who were possible victims of Fuswelan not only in the municipality of Itogon, but also in areas where there were reported similar cases like Mankayan, to report. "In almost all barangays of Itogon like Virac, Tuding, Poblacion, Ampucao, and Ucab we received similar complaints," Sabit said.

Only a couple of months previously, 50 BENECO consumers were also duped by con men posing as BENECO employees with the same modus operandi in Dalicno, Itogon.
