Sen. Chiz Escudero said President Arroyo's decision to veto the transparency clause in the 2009 budget will lead to more corruption.

"I am disappointed with that decision because I believe that transparency is the best prescription for fighting rampant corruption in this administration. Transparency equals accountability," Sen. Chiz the opposition senator said.

Malacanang reiterated the President was being consistent with her past actions and that due regard should be given to legally and judicially established regulations.

Mrs. Arroyo also said that some measure of confidentiality needs to be enforced on certain matters and that with every office having the right to control its operations it may regulate the manner by which the public can examine or copy any public record.

Sen. Chiz Escudero said vesterday the fact two individuals from very non-traditional backgrounds can consider running for national office shows that democracy is thriving in the coun-

"I welcome the move of civil society to drum up support for the entry of Gov. Ed Panlilio Pampanga and Gov. Grace Padaca of Isabel in the 2010 presidential elections," the opposition senator added.

However, he said Gov. Panlilio may want to consider the cases of two Catholic priests who became politicians, as he contemplates a run for the presidency.

"There may be a lesson or two to be learned from the political forays of former Haiti president Jean-Bertrand Aristide and former US Rep. Robert Drinan of Massachusetts. Both had to make a choice eventually," the opposition senator added.

Aristide was already out of the

post in 1991, while Drinan declined to run for re-election in 1981 after Pope John Paul II unequivocally demanded that all priests withdraw from electoral politics.

Aristide was expelled from the Salesian order in 1988 after his political activities were deemed an incitement to hatred and violence.

Drinan, who remained a priest while serving his elective post in the 70s, eventually heeded the Pope's directive.

Senator Chiz Escudero said vesterday that House Speaker Prospero Nograles should heed the people's opposition to charter change before 2010 by withdrawing his support from the draft resolution calling for a constituent assembly.

"I urge and challenge the Speaker not to give in to the pressure of the House cha-cha train. He should stand his ground for the

people even at the expense of losing his position," he said in a statement.

Escudero, who is chair of the Senate Committee on Constitutional Amendments, noted that the latest Pulse Asia survey shows that two out of three Filipinos do not favor changing the constitution at this

Conducted from February 2 to 15, the Pulse Asia poll also shows that cha-cha is a "view shared by majorities (60% to 70%) in all geographic areas and socio-economic groupings.'

"The right time for charter change is not now, but after 2010. The Senate will not be a party to this charade and the people will surely reject any proposed amendments at this time," Escudero said.

BAGUIO CITY

The city government will soon begin ground preparations for its engineered sanitary landfill project.

M a y o r Reinaldo Bautista Jr. has given the go signal for the conduct of land survey, identification and evaluations of the 2.9-hectare Sto. Tomas School Area barangay recently chosen as the landfill site.

The said processes are required before the landfill project can be prosecuted.

City Environment Management Office (CEMO) head Romeo Concio said that after passing the resolution confirming the site, the city council will also have to officially identify the area as disposal site as a requirement of the law.

In his Administrative Order No. 60, the mayor created the Sto. Tomas Cont. on page 11

Households, business establishments urged to join clean drive wastes and are leing the refuse in

BAGUIO CITY – Residents and businessmen here were urged to keep their surroundings clean as their contribution to the city's cleanliness campaign.

Acting vice mayor Daniel Farinas in a memorandum requested heads of households and owners of business establishments including boarding houses at the central business district and at the different barangays to strictly comply with the city

ordinances on cleanliness particularly Ordinance No. 498 series of 1969 and Ordinance No. 572 series of 1973.

Farinas noted that during the cleanup drive conducted by the officials and employees of the city government, it was observed that residential and boarding houses have not been segregating their wastes and are leaving the refuse near sidewalks without using garbage bins or trash bags. The practice causes the areas even those located within the central business district to become eyesores.

"There is therefore a need for the owners of such boarding houses to likewise inform their

Rules set on implementation smoking law closed area outside one's private residence.

BAGUIO CITY – The city government has adopted the rules and regulations to implement Ordinance No. 8 series of 2008 or the Comprehensive Anti-Smoking Ordinance of Baguio City.

The ordinance prohibits smoking in public utility vehicles, government-owned vehicles or other means of public transport, accommodation and entertainment establishments, public buildings, public places, enclosed public places or any en-

closed area outside one's private resident or private place of work except in duly-designated smoking rooms.

The rules defined all areas where smoking will be banned:

PUVs would refer to public utility jeepneys, buses, taxis and other vehicles used in the transport of goods and members of the general public. Accommodation and entertainment establishment refer to restaurants, fastfood

Paradoxes' Promises

(Government) goes on in strange paradox: decided only to be undecided; resolved to be irresolute; adamant for drift; solid for fluidity; powerful for impotence, That's how Winston Churchill, in November of 1936, skewered the party then in power.

Isn't this the theme that also underpins Paradox and Promise in the Philippines' European Union, Asian Development Bank and five other agencies published this 143-page study.

The analysis uses the prism of gender equality. Don't go away. The book is not fixated about empowerment of women. It weaves an insightful matrix of national problems, plus specific action plans.

Filipinos are no slouch in crafting a favorable policy

environment, the study says. But implementation is patchy. Policy

hasn't delivered intended benefits as extensively and effectively as hoped for. This is one of the many paradoxes amid promise in the country.

A paradox, the dictionary says, is a seemingly contradictory statement that is true. Gilbert Keith Chesterton often paraphrased paradoxes by the Master from Galilee The paradox of courage, GKC wrote, is that a man must be a little careless of his life in order to keep it.

Filipinos highly value schooling. Paradoxically, education indicators are skidding Fewer children enroll in the world's 12th most populous country. More also drop out. In Autonomous Region of Muslin Mindanao, only 35 out of 100 make it to grade 6. The quality deficit is worse. Only 6 out of 1,000 grade 1 entrants will graduate from grade 6 grounded solidly in math, science or English.

We train the largest number of health personnel in ASEAN. Paradoxically, the proportion of Filipinos dying without medical attention has risen to 70 percent. That's a figure not seen, in this neck of the woods, since the mid-1970s.

Out of every 100 Filipino doctors, 68 practice abroad. Over 164,000 nurses migrated in four decades. A perverse consequence is de-skilling. Thats where doctors train to become nurses to wangle a visa.

Visible issues lend themselves to action where officials scrunch up grit, the study says. But some persistent problems are invisible from appalling conditions for domestic workers to human trafficking. Responding to them is particularly difficult. Failing to respond beckons disaster.

Unnoticed, an average of eight women die daily from pregnancy and child-birth related causes. They're just as dead as PR man Salvador Dacer and his driver whose unsolved murder hug the headlines. So are 700,000 babies aborted yearly. Abortion substitutes for hard-to-come-by family planning services.

Chronic hunger doesn't make prime-time newscasts as Erap's bigote does. But it shrivels a quarter of pre-schoolers. Out of 100 pregnant and breast-feeding mothers, 42 are anemic. Wizened mothers give birth to midget kids. Given our priority for politics over reform, it'll take 50 years before we solve this problem, says the Food Research & Nutrition Institute.

Having a woman President can be convenient. The lady jacks up indicators of gender empowerment. So do women justices and executives Of 81 governors, 18 are women; of 1,631 mayors, 286 are women. Majority of government employees are women.


Pardoxically, the plight of 2.5 million domestic migrants mostly female –don't cause a blip on radar screens. Often between 15 to 24 years old, most work in private homes. The least protected of workers, many are exploited. There's been little help for women employees, who've been sexually

Lacson: villain or victim?

The daughters of publicist Salvador Dacer have filed murder cases against Senator Panfilo Lacson for the murder of their father. Dacer sisters Carina, Sabina, Emily, and Amparo executed an affidavit saying that their father repeatedly told them that should anything happened to him, then Presidential Anti-Organized Crime Task Force (PAOCTF) Chief and concurrent Chief of the Philippine National Panfilo Lacson is the one to blame.

The complaint of the Dacer sisters cited the testimony of former Police Superintendent Mancao II who executed an affidavit that it was Lacson who ordered the killing of Dacer. Mancao executed the affidavit in Florida, United States of America.

Justice Secretary Raul Gonzales has said that the filing of the affidavit by the Dacer sisters will accelerate the reopening of the Dacer-Corbito murder case. The Dacer sisters filed the affidavit in California where they currently reside.

Senator Panfilo Lacson, on the other hand, claims that the Dacer sisters are gravely mistaken and misguided. He claims that the sisters are committing a serious injustice.

Former PAOCTF Officer Michael Ray Aquino, Lacson's co-accused in the case is being held in a correctional facility in the U.S. for espionage charges. An error is believed to have been committed in his case and he will be re-sentenced for the offense sometime this month.

As discussed by The Peace Combatant last week, it is not likely that Lacson's intent to be one of the presidential candidates in 2010 is the motive for the filing of the criminal charges against him. Lacson is not the presidential candidate to beat in 2010. Other presidential candidates outshine Lacson.

So the only hypothesis plausible is that either Lacson is guilty or that he is a victim of an elaborate frame-up by the criminal gangs that he has supposedly hunted down. Either way, the situation reflects a deplorable state of the nation: criminals can either assume the position of the Chief PNP or that criminals can influence the Department of Justice and the likes of Justice Secretary Raul Gonzales.

Thus, more than a political motive to the recent filing of a murder case against Senator Panfilo Lacson, the nation should see the ongoing circus as reflective of a fundamental disease affecting our political life: criminals can rule or become influential in our society, they can even occupy the highest positions of leadership or authority of our land.

If Senator Panfilo Lacson is guilty then the Office of the Chief PNP can be occupied by hoodlums. On the other hand, if he is not then the Office of the Justice Secretary or the office facilitating the filing of criminal charges against Lacson today can be influenced by the criminal gangs.

Thus, one of the most important challenges confronting the Filipino people in 2010 is to be free from criminal gangs that are attempting to influence our political institutions.

Of course, voters must be prepared to vote intelligently. Voters must also become political actors that conduct political actions other than voting.

At the same time, our men and women have an important role to play. They must not allow themselves to be tempted by the criminal gangs.

The criminal gangs that some of our men and women in uniform support today can become big enough to influence our political life.

"TTISTHE PEOPLE'S RIGHT TO RECLAIM GOVERNMENTAL POWER": So that the public may know, I am reprinting here parts of the statement, entitled "Civil Intervention is Divine Intervention" thus:

"Government power is not absolute. It is based (on) and dependent upon sovereign will and power of the supreme ruler and arbiter, the people. The legal and political sovereignty conferred by the people upon its government is neither absolute.

"It is dependent upon the faithful compliance of the government to the *social contract*, our Constitution. If and when *fundamental* provisions of the *social contract* were grossly violated by the government, the people have absolute right to reclaim from that government the *authority* and *power to* govern.

"They have the right to annul its contract with that government because `sovereignty resides in the people and all government authority emanates from them.' More of this in succeeding issues.

"BIDA" MARCH: 1.5 M PARTICIPATED DESPITE THE HEAT:

The Cultural Center of the Philippines-Quirino Grandstand-Roxas Boulevard March staged by BIDA, or "Batang Iwas Droga at Abuso", last Saturday, March 21, 2009, achieved much more than its goal of landing a new record with the Guinness Book of World Records—that of being the longest march in the Philippines.

Indeed, with official and unofficial estimates saying that the people who participated in the march could reach about 1.5 million, this is a record that is hard to beat for a long time.

But then, it is also going to be the loudest condemnation ever by Filipinos of the drug menace that appears to have already gripped tightly the country and its people in its clutches, to the point that the rich and the poor have become drug pushers and users, and government officials have stooped so low as to enable them to nonchalantly sell their souls for a few hundred thousands of pesos from drug lords.

The message of the more than a million souls who braved the heat and the humid atmosphere Saturday just to join the BIDA march, without being paid and without being fed anything, is loud and clear: the scourge that is illegal drugs must be stopped, at all costs, and woe to those who will act otherwise.

GENUINO'S POLITICAL STAR SHINES WITH "BIDA"

MARCH: It is because of the success of the march in inspiring more than a million people to come out strongly against a major problem of the country that one of its principal organizers managed to shine brightly last Saturday, and I am referring to Chairman Efraim Genuino, now known as "Kuya Efren", of the Philippine Amusement and Gaming Corporation (PAGCOR).

Fil-Am nurse enjoys success in U.S. home health industry Competended among home

OAK BROOK, IIlinois — While many traders and financial managers in the United States are groping in darkness over the gloomy economic atmosphere wrought by recession, a 41year-old nurse from Miag-ao, Iloilo in the Philippines has successfully inched her way into home health business in Fairfield Way, Bloomingdale.

The success of Lira Faicol Mueda's four-year-old home health business that serves the entire state of Illinois however didn't happen overnight.

"We also encountered some problems in the beginning, but me and my husband, Edwin, do the marketing and directly manage the business," quipped Mueda, who considers Edwin as the business' "most effective hands-on administrator."

Problems such as nurses not following instructions, marketing and staffing, manpower shortage, employees being pirated by rival home health centers, immediately hounded Mueda's business, put up in partnership with another Ilonggo nurse and entrepreneur Roland Hedriana, according to Edwin.

"But despite the recession, we haven't laid off anyone," Mueda sighed. "In fact, we keep hiring people."

FILIPINO STAFF

Mueda, who worked in home health for 12 years, said 90 percent of their staff are Filipino nurses, physical therapists, nursing aides, occupational therapists, speech

therapists, and social workers.

Mueda described home health as "like a hospital but is done in the home and the nature of this business is professional health care staff."

She and Edwin valiantly decided to establish their own home health upon the advice of their doctor friends who made firm assurances to use the home health for the doctors' patients.

"Thus we became independent and decision-making is the most important," Mueda explained. "We figured it is easy to run it (home health) if you have the knowledge, background and experience."

Mueda graduated at St. Paul College (now university) in Iloilo City in 1989 and credited the Catholic-run institution "for what I am today as well as the other nurses who graduated there."

CHICAGO HOME HEALTH

In 1992, Mueda, a board passer and full-fledged nurse, arrived in the United States and landed right away in home health in Chicago's central nursing home.

"That's the only nursing field I know since then," she humbly stressed in an exclusive interview at the Braxton Seafood Grill, here, recently.

She finds her fellow Filipino medical professionals to be "flexible and trustworthy" and "always willing to go out in the field." Competitions among home health centers in Illinois are tight owing to growing patient population and longer life expectancy among Americans, according to Mueda; "but our advantage is we operate for 24 hours and we keep that as a standard."

Mueda said her main satisfaction and something any operators of home health anywhere in the United Sates would not have the qualms to brag about, is "patient or client satisfaction."

"We provide their needs on time, we give excellent patient care, and courtesy visits," she pointed out. "Our nurses in the field who are mostly Filipinos are really good and well-known (in the United States) as excellent caregivers."

A Filipino male employee described both Lira and Edwin as "one of the most generous couples in business" saying "they always recognized employees by holding annual gathering like christmas party where great raffle prizes are given away."

'RECESSION PROOF'

Why is nursing considered a "recession-proof" profession? Mueda volunteered that in health care system in the United States, no one is being turned down and there are more demands for the job.

"Aside from being accessible, health care is basic

Lawmaker calls on gov't, communist rebels to resume peace talks

Without pre-conditions

Opposition Senator Chiz Escudero yesterday called on government and the National Democratic Front (NDF) to resume peace talks without preconditions to show their sincerity in ending the longest-running communist insurgency in Asia.

"We should do away with preconditions. Both sides should work for the immediate resumption of the formal talks. The bloodletting must stop, especially now that our countrymen are being hit hard by the economic crisis," he said.

The senator issued the statement on the eve of the 40th founding anniversary of the New People's Army (NPA), the NDF's armed wing, on March 29. Formal talks between the Philippine government and the NDF collapsed in August 2004 with the inclusion of the rebels in the US and EU (European Union) terror-

"The failure of past administrations to bring about true and meaningful change in our country has fueled this longrunning revolutionary movement. But armed struggle is not the answer to our country's problems, Escudero, chairman of the Senate Committee on Justice and Human Rights, said.

He said both

sides should work together to break the impasse by implementing confidence-building measures.

The government demands, among other things, an indefinite ceasefire as a precondition to the resumption of formal talks and proposed that the discussions focus on disarmament, demobilization and reintegration (DDR).

The rebels, on the other hand, have outlined a number of "impediments" to the continuation of the peace process. The NDF is demanding that the government move for the delisting of the CPP-NPA as a "foreign terrorist organization" in the list of the United States and the European Union.

It is also asking for the release of NDF consultants Elizabeth Principe, Randolf Echanis, Eduardo Serrano, Eduardo Sarmiento and Randv Malayao. It thas also urged the government to stop the "persecution" of its chief political consultant Jose Ma. Sison in The Netherlands.

The NDF has also deplored alleged extrajudicial killings and enforced disappearances of over 1,000 unarmed legal activists.

The opposition senator said that the recent electoral victories of the Left in Latin America show that the parliamentary arena is a viable alternative to armed struggle.

Escudero said the success of Bayan Muna party-list leader, Rep. Satur Ocampo, and his militant colleagues as well as other left-of-center groups in getting elected to the Lower House show the advances in the country's political environment since 1986.

"Democratic space has widened considerably since 1946 when the elected representatives of the Democratic Alliance were barred from taking their seats in the House. We must work together to expand it further," he said.

Escudero also said the government must seek peace with honor instead of engaging in a military campaign to destroy the rebels by 2010.

He pointed out that billions being spent by government in its counter-insurgency campaign could be instead be allocated for development purposes if talks resume and a ceasefire agreed upon by both parties.

"We all know that a military solution will not end this insurgency. Unless we root out poverty and injustice, the rebellion will continue," Escudero said.

"There can be no genuine development without peace. All we need is the political will and purity of heart to end this conflict among Filipinos once and for all."/Office Of Senator Chiz Escudero

chains, eateries, motels, lodges, inns, boarding housing, disco houses, videoke bars and movie houses or any other place offering food, sleeping, accommodation and recreational facilities to the public for a fee.

Public building refers to any building or structure owned by the government and used for government purpose or one that is owned by a private person but used exclusively by the government or any of its instrumentalities or any building used or controlled for public purposes without reference to the ownership of the building.

A public place refers to gasoline stations, banks, malls, town squares, terminals, shopping or business arcades, schools, churches, hospitals, cinema houses, gymnasia, funeral parlors, barber shops and parks.

As per the rules, establishments are required to designate a smoking room or area which is totally enclosed or physically segregated but properly ventilated and properly marked by a sign posted saying "Smoking Area."

The sign shall include a warning in English about the ill effects of both smoking and secondary exposure to tobacco smoke.

Accommodations and entertainment establishments can however opt to be considered as smoking establishments but must first obtain registration with the Office of the City Mayor.

Persons liable are any individual smoking within the prohibited areas, any passenger, driver, conductor or inspector of government-owned vehicles or PUVs, or the president or manager, owner/proprietor or operator of accommodation and entertainment establishments who "knowingly and willfully allows, abets or tolerates and/or fails

to warn, advise or report violators."

The Health and Services Office and the City Building and Architecture Office are tasked to inspect and certify the appropriateness of the designated smoking areas while the inspection of tourism-accredited and non-accredited establishments shall be done by the city health office in coordination with the city administrator's office.

The rules also give establishments 60 days to comply with the requirements including the registration of accommodation and entertainment establishments with designated smoking areas.

For the penalties, violators will be meted fines ranging from P500 to P2,000 or imprisonment or not less than one to six months or both upon discretion of the courts.

Failure to comply with the 60-day period would be a ground for business permit revocation.

Establishment owners will be subject to following penalties: P300 fine or one month imprisonment or both for the first offense; P500 fine and two months imprisonment for second offense and P1,000 fine and four months imprisonment for third and subsequent offenses.

PUV violators are subject to fines ranging from P100 to P500 and imprisonment of from one to three months.

Three violations of the rules shall be ground for cancellation of the establishment's business permit./aileen p. refuerzo

and a right, not a privilege. Health care in the United States is very open and most elderly here live longer," she enthused. "Lay off (among medical professionals) is very rare and the job is really in demand."

Mueda disclosed that health care in the United States "is not yet and may not be affected by recession."

Home health, according to her, "is the cheapest form of homecare." Home health helps patients stay for a shorter period in the hospital; it helps save medicare a lot of money, she admitted.

Other advantages of home health, she added, are the following: It avoids cross infections for patients; patients heal better; and helps patients how to be independent instead of letting them stay in the hospital.

An increasing number of underaged Muslim girls are funneled to Middle East countries, the report says. Of 287 studied by the Human Rights Documentation System, 40 were minors when trafficked. The youngest was a 10-year old a year younger than now released former Congressman Romeo Jalosjos' victim.

Women trafficked to Saudi Arabia, Syria, Taipei and the United Arab Emirates are generally destined for sexual exploitation and slavery-like conditions of domestic work. Those shipped to Cyprus, Hong Kong, Japan, Korea, Malaysia and Singapore are generally destined for prostitution.

Migration comes at a cost. More so for a country where almost 3,000 leave daily to beat grinding poverty. Much attention has focused on OFW remittances. But the real bill has not been fully tallied. What is the real cost for whole generations long separated from spouses children and families Not by bread alone do countries survive.

There've been useful initiatives to address these interlocking problems. Many come from the private sector. Bantay Bata, for example, helped more than 13,000 victims. The Catholic Church has a full time commission on migrants. The Visayan Forum aids human trafficking victims. Philippine Port Authority set up half-way houses. Lihok Pilpina in Cebu has mustered resources for this sector.

But much remains to be done. "It is nice enough that we do our best, Winston Churchill often stressed. Sometimes, we have to do what is required.

branch from reallocating funds for one project to another without informing the Legislative, or allowing the public to scrutinize such allocations.

Escudero recalled that in a study done last year by the Washington-based think-tank International Budget Partnership, the Philippines was seen as not having initiated ways to make it easy for citizens to track its spending, revenue collection and borrowing.

He also said that the money wasted on corruption by government annually could have been spent on education and social services, health and agriculture.

"The Presidential Anti-Graft Commission recently disclosed that 20% of the country's annual budget goes to corruption. With the 2009 budget set at P1.415 trillion, one can only imagine the amount that will go to the pockets of others," he noted.

In 2008, the budget for education was P145 billion, social services P5.5 billion, health P1.66 billion, and agriculture P21.7 billion.

Escudero said such sums would be paltry compared to what is lost to corruption.

The opposition senator said Mrs. Arroyo's veto decision makes it harder to hold government accountable for cases involving abuse, misuse, and corruption of public funds.

As chairman of the Committee on Constitutional Amendments, Revisions of Laws and Codes, Escudero has already taken steps to address corruption.

In trying to make Republic Act 9184, otherwise known as the Government Procurement Reform Act, more effective, he filed Senate Bill 1963 that sought to put treaties, bilateral arrangements, and executive agreements under the coverage of the procurement law.

Escudero noted that the charges filed this week against 17 former and current DPWH officials in connection with the anomalous bidding for World-Bank funded road projects only underscores the need for more transparency.

"It is the duty of any government to have all information on the budget available to the public so that scandals like this can be prevented," he said./Office Of Senator Chiz Escudero

In welcoming the Panlilio-Padaca teamup, Escudero also said that since the Philippines values freedom and the rule of law, anyone who can contribute to nation-building or help provide solutions to the country's ills is welcome to participate in the political process.

"I believe that our democratic ideals are best served when more people of every political persuasion can lend a hand in boosting efforts to engender hope and harmony in the country rather despair and disillusionment."

He stressed that the current government has pushed the country to the brink of ruin,

where corruption is the order of the day rather than transparency and accountability.

"If Gov. Panlilio and Gov. Padaca share our national values over individual interests, I am sure we will be able to find common ground in finding the proper way to address many vexing issues facing our nation," Escudero stressed./Office Of Senator Chiz Escudero

the Philippines and the Coordinating Council of Private Educational Associations against the CHED plan, Escudero said making nursing a five-year course would mean an additional financial burden to parents and students.

"Parents set aside a budget for the education of their children. Based on current figures each nursing student needs about P100,000 annually for matriculation plus textbooks, excluding review courses. Adding another year to the course makes it more expensive," the senator pointed out.

At the same time, Escudero also called for a moratorium on tuition, miscellaneous and other fees, noting that most nursing colleges also have compulsory in-house review courses that are paid for separately by students.

Meanwhile, based on a report done by CHED and the Professional Regulatory Commission, only 12 out of the top 175 nursing schools in the country had a passing rate of 90% or higher during the period 2000-2004.

In the 1970s & 1980s, the passing average for the Nursing Licensure Exam was 80-90%. But in 2008, only 44.51%, or 39,455 out of 88,649 examinees, passed.

"The nursing profession in the Philippines has yet to recover from the 2006 leakage case. This is a symptom of the long-standing deterioration of our nursing education. The CHED must not focus on facilitating the commercialization of the profession and instead make it less difficult for those wanting to take it up," Escudero said./Office Of Senator Chiz Escudero

Property Land Identification Task Force composed of city personnel with technical capabilities to undertake the land identification and survey to establish the metes and bounds of the property.

The task force will be composed of Engrs. Luis Ortencio of the city assessor's office, Edward Magalgalit of the city building and architecture office, Gerald Sannad of the city engineering office and Virgilio Tumayan of the city planning and development office, Salvador Goyala, Edwin Ingosan and Roland Obello of the city environment management office and three police personnel from the city police office.

Apart from conducting the actual identification, survey and evaluation of the lot, the task force will also be tasked to coordinate with barangay officials and residents on the plans and activities of the task force and to prepare and submit to the Baguio City Solid Waste Management Board evaluation reports, plans and other pertinent documents generated during the identification and survey.

The body was also tasked to submit a report on its accomplishments after a month.

The Sto. Tomas lot was recently chosen over four other shortlisted options as the final location of the planned landfill. It is said to be the most advantageous since it is located within the city and would require the least development cost of P61 million.

Concio said the city will also have to begin the process of conducting a survey on social acceptability to satisfy the requirements of the Dept. of Environment and Natural Resources.

Afterwhich, a full-blown feasibility study on the site will be made preparatory for the city's application for an Environmental Compliance Certificate (ECC) from the DENR.

Construction or development proper will only begin upon satisfaction of these requirements.

Concio said the city plans to develop the first cell which will require a one-hectare area of the lot. He said this cell can contain the city's wastes for three to five years. The succeeding cells can be developed in future.

The establishment of a landfill has been identified as the city's final disposal facility after the closure of the Irisan open dumpsite pursuant to Republic Act No. 9003 or the Ecological Solid Waste Management Act of 2000.

The mayor said a safe disposal system is also included in the city's Comprehensive Land Use Plan of 2002-2008 and the Medium-Term Development Plan of Baguio City for 2005-2010./aileen p. refuerzo

unveiled a multi-trillion-dollar budget on February 26, an ambitious plan to boost clean energy development, access to education and health care coverage.

Some of those costs would be offset in part by allowing tax cuts to expire for the wealthiest households. An overview of the spending plan for health care showed

the budget sets aside a reserve fund for what Obama calls a "down payment on health care reform": \$633.8 billion over the next 10 years.

About half of the money would come from reductions in payments to health care providers who serve the Medicare and Medicaid programs. The other half would come from limiting the value of itemized deductions for wealthier families, those earning \$250,000 a year or more.

The budget also lays out eight principles for Congress to use in fashioning a health overhaul plan, including making health coverage affordable; guaranteeing people a choice of plans (including keeping the coverage they have through their employers); and investing in prevention and wellness. Another principle: "Aim for universality. "The budget says any health care overhaul "must put the United States on a clear path to covering all Americans."
