BAGUIO CITY - Despite the city giving notices to stall owners in the city market to voluntarily remove/dismantle all illegal structures and /or extensions introduced in their stalls, still, there are willful owners who did not comply with the order of the city.

Initial investigation has been conducted by the City Buildings and Architecture Office, Peace and Order Safety Division and the City Market Division of the Treasury Office on the actual occupants of the

Mayor Mauricio Domogan directed the City Market Division to fast tract the investigation and inventory of illegal structures in order for the city to implement the clearing of the city market.

Domogan stressed, "it is very clear under tax ordinance no. 2000-001 that no alteration, improvement or partition may be effected or constructed without the authority or permit issued by the CBAO and with the approval of the Sangguniang Panlungsod.'

Also, BCMA Resolution Nos. 014-2013 and 007-2014 states, "all constructions, extensions and illegal structures caused by leaseholders to their stalls without permission by the BCMA, the city council or the CBAO must be removed immediately."/Jho

# Oplan Kaluluwa Flower, Candle Sale Guidelines Out

BAGUIO CITY - The city government issued the guidelines for the "Oplan Kaluluwa 2014" sale of flowers and candles in observance of All Saints Day on Nov. 1.

A total of 150 stalls will be rented out to vendors who will be allowed to sell from October 26 to November 1 at the Jadewell parking area at Burnham Park.

The city treasury office under city treasurer Alicia Onoza will begin issuing application forms on a firstcome-first-served basis on October 21 upon the submission of the requirements by the applicants

Accomplished forms may be submitted on the same day together with the payment of P720 representing taxes and fees. Those lacking any requirement will not be given

Applicant vendors must be bonafide residents of Baguio, of legal age, must have no flower stall at the city market or Marbay vicinity and must not have committed any violation during the previous years.

It was also emphasized that applicants must not have relatives among the other applicants.

The requirements are two copies of 2"x2" photo, barangay clearance and residence certificate.

Upon submission and payment of fees, the successful applicants will be given their assigned stall number.

They will secure special permit at the permits and licensing division On October 24.

During the sale, only flowers and candles will be allowed for sale and display in the vending areas. Other items will be confiscated.

Swapping of stalls, cooking of food and gambling within the area will strictly be prohibited and the vending area must be clean at all times.

Violation of the guidelines will mean no permit for the next three years./A Refuerzo

Vice President Jejomar Binay slammed his critics anew in his speech at the 5th MCLE (Mandatory Continuing Legal Education) Accredited National Convention of Public Attorneys at the Manila Hotel.

However, Binay's newly received award didn't deter him from blasting the administration.

Once again, Binay declared that he will not be showing up at the Senate for the probe on the Makati City Hall Building II.

"I won't dignify that kind of proceeding by attending it. Ladies and gentlemen, I am the vice president of the Republic of the Philippines," he said.

As for his accuser, former Makati City vice mayor Ernesto Mercado, Binay had this to say: "Itong testigong ito pinalamon ko po sa kamay ko iyan. Umiiyak pa iyan. Nangyari lamang po iyan (Mercado's accusations) kasi noong matalo s'ya, nawalan s'ya ng delihensya."/ANC-YAHOO

# Reasonable Tax Increase

BAGUIO CITY - Members of the Hotel and Restaurant Association of Baguio (HRAB) expressed reception to the city government's plan to increase business and real property taxes and suggested measures to temper the effects of the adjustments.

Mayor Mauricio Domogan who attended the HRAB's induction-cum-consultation on tax increase last Wednesday said that the hotel and restaurant owners understood the need for the tax hike but suggested a staggered imposition of the increase in the realty levy and the adoption of an incentive scheme for businesses with environment-friendly waste disposal systems.

"I am happy with the position of the HRAB. I hope that other sectors will also understand the necessity of increasing our taxes so we can give what is due to our city and contribute to making it a good place to live in," the mayor said.

He said the consultations with the various sectors will continue to get the pulse of the public and determine what is reasonable to both the city government and the taxpayers.

He however cautioned the public against persons who will capitalize on the issue for political gains.

"Some people may ride on this issue to discredit me but I hope our constituents will understand that we are doing this for the sake of our city and because it is now obligatory to increase the taxes as the rates are now outdated and not in accordance with the law," the mayor said.

The city is eyeing a 10 percent increase in business taxes under Tax Ordinance No. 2000-01 and the updated schedule of fair market values of real properties has been submitted to the Bureau of Local Government Finance (BLGF) and eventually to the city council for approval.

City treasurer Alicia Onoza earlier said the last time the city hiked the revenue rates was in 2001 or 13 years ago. She said the city has practically imposed only a ten percent adjustment from the 1974 rates under Ordinance No. 588 -74 and the city's current rates are comparatively lower than nearby cities like Urdaneta and Dagupan in Pangasinan and San Fernando City in La Union which levy business taxes higher by as much as 500 percent.

City assessor Nilda Navarro said the city is now obliged to update its schedule of real property tax valuation to comply with the New Local Government Code or the Republic Act No. 7160 provision which mandates local government units to undertake a general revision of real property tax valuation every three years. The city last implemented the revision in 1996 and since 2001 when the city government adopted Tax Ordinance 2000-001 which imposed lower assessment levels for real properties, the city has not implemented another revision for humanitarian consideration

As a result of the city's failure to comply with the revision every three years, the city was named as among those non-complying LGUs by the Bureau of Internal Revenue (BIR) while the city assessor's office has been given a poor rating by the

Navarro assured that a minimal assessment level will be recommended to temper the expected huge increase in the market value as a result of the city's passing up on several revision terms since 1996./A Refuerzo

# BCPO Calls for Community BCPO Maintains High Modest Increase in **Participation In Peace and Order Efforts**

BAGUIO CITY - The Baguio City Police Office(BCPO) is encouraging community participation in ensuring peace and order in every city barangay with the rapidly increasing population of Baguio.

BCPO Deputy Director for Administration Police Superintendent Engelbert Soriano, in an interview over PIA Hour radio program, reported that the BCPO with its 600 strong police personnel, is continuously doing its best in maximizing police presence and in bringing in pre-emptive and preventive measures to minimize unlawful activities.

While admitting that it is hard for the BCPO to attain the ideal ratio of 1:500 or 1 policeman for every 500 person given that with the around 500,000 population of the city, tourists, students and workers who come in and out daily add up to the number, the BCPO is doing its best, Soriano said.

He disclosed that presently assisting BCPO personnel are 200 police recruits (100 from the Police Regional Office - Cordillera and 100 from the National Capital Region) who are currently on field training in the city.

Soriano stressed the importance of community participation- for the public including the students to help in keeping themselves and their community

Social responsibility is another key for peace and order to be maintained, he said as he encouraged the public to be vigilant and report immediately any suspicious person or activity in their area.

He also highlighted the importance of CCTV (closed-circuit TV) cameras in households and commercial establishments which help in solving crimes.

According to Soriano, the common peace and order problems in Baguio are physical injuries, mostly alcohol-related, theft and other street crimes, and robbery or forced entry./JDP/CCD - Erin Miana and Kurt Lubos- PIA/UB interns

# Morale; Launches Blue Proposed 2015 Budget

# Mass

BAGUIO CITY — The morale of the men and women of the Baguio City Police Office(BCPO) remains high despite the many issues facing the police force today.

Deputy Director for Administration PSupt. Engelbert Soriano, in a radio interview, said although there could be an effect to the police such as their outlook and other aspects but their performance in delivering the needed services to the people are not affected.

"Apektado kami sa mga pangyayari sa aming mga kasamahan pero hindi pa nag spill over sa mga kapulisan at hndi din apektado ang aming performance," said Soriano.

'Overall, the BCPO and including the Cordillera Police force are highly motivated to perform their tasks and duties to the public and to their country," he stressed.

Among the issues hounding the PNP include the involvement of some

policemen in illegal activities and issues on PNP Chief Director Alan Purisima on alleged plunder, and graft.

The BCPO is doing well and the relationship with the residents and the community is good as well, he said.

Meanwhile, the BCPO recently launched the Blue Mass as another way to boost the morale of Baguio's Finest through spiritual guid-

Soriano said the Blue Mass is a holy mass being sponsored by the BCPO evthe Baguio Cathedral. The mass aims to enlighten the police officers and strengthen their moral and seek divine guidance in their duties.

As this is for Roman Catholics, Soriano said the BCPO is encouraging their members from the different religious sectors to organize and attend masses at their own churches.

"It is also our own little way of bringing the police closer to God, their families and the community," Said Soriano./JDP/RMC & Kurt Lubos- UB Intern, PIA-

Magsaysay, 'those who have less in life must have more in law.

Under the law, there should be balance and equality, however, the problem in society is that we are not created equal which is a reality in life, he further said.

He explained that the Constitution gives an imprimatur in the passage of such law. It states that the rights of ICCs to their ancestral lands must be respected to ensure their economic, social, and cultural well-being.

He pointed out that even in government, the IPRA is still being questioned as there is still no common understanding of its application. But it should not be an issue anymore by reason of Constitutional mandate, he stressed.

Libiran mentioned that the IPs and the people of Baguio were among the strongest contingents that lobbied

for IPRA. The fight came from the Cordillera and the legislation was borne here and we brought it to Congress, he said.

It is significant to note that the IPRA was passed prior to the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) ratified by countries in 2007.

When there are forums about ancestral domains of IPs abroad, they are always looking at the Philippines because it is more advanced in terms of IP law, he said.

Countries with IPs like Australia and Canada do not have legislations similar to IPRA but they only have recognition of their rights. All the other countries follow the UNDRIP but the declaration is not binding.

Despite the many controversial provisions, the state law that we have is very powerful and is binding, according to

BAGUIO CITY - Mayor Mauricio Domogan has proposed a modest increase in next year's budget.

The mayor on Thursday submitted to the city council an executive budget of P1,501,510,000 which is higher by P61,928,000 than last year's financial plan amounting to P1,439,582,000.

The mayor earlier said he decided on a conservative figure because the city expects a minimal increase in the income from local taxes this year due to the outdated tax rates being imposed by the city on businesses and real properties.

He said the city can only maximize the income from this source if the planned tax reforms to update the antiquated rates can be implemented.

As proposed, the estimated income will come ery Sunday at 6:00AM at from the beginning balance of P160,000,000; tax revenue amounting to P374,450,000; non-tax revenue – P194,280,000; and external sources – P772,780,000.

> The proposed expenses to cover the cost of delivery of basic services are distributed as follows: P536,610,000 for personal services; P608,025,000 for maintenance and other operating expenses; P109,143,000 for capital outlay; P67,076,000 for Disaster Risk Reduction Management Fund and P180,656,000 for development fund.

> In his budget message, the mayor said the financial plan addresses the priorities set at the start of his term which are also aligned with the programs of the national government.

> The said thrusts were enunciated in the budget call issued by the mayor and city budget officer Leticia Clemente:

\*Sustainable environment with green governance as core thrust. The mayor said the programs must only focus on advocacy but also on research and development:

\*Sustainable economy to focus on prioritizing revenue generation programs;

\*Socially inclusive growth anchored on the inclusion of requirements for the development needs of the community through grassroots participatory budgeting process;

Responsible and accountable public servants to focus on ensuring a more motivated and effective human resource; and

\*Safe and resilient Baguio where programs on climate change mitigation will be prioritized.

Other programs on gender and development, senior citizens and persons with disability, Acquired Immune Deficiency Syndrome (ADIS) and children protection were also addressed in the proposed budget./A Refuerzo

# 'Pingpong children'

They best symbolize the concern of the ongoing synod that ends on Sunday. The "pingpong children" shuttle between separated parents, are trapped in wars, or swept in often chaotic immigration waves.

Set up by Pope Paul VI in 1965, the synod convenes to give a pontiff counsel on key issues. Today's extraordinary synod, the third ever held, brought together 184 bishops plus 69 lay people, sisters and priests.

Pope Francis jolted the synod when he added six to the team that will write its "Final Report," which will anchor the October 2015 synod. "That could be a game changer," the weekly America notes.

Note the spread of Francis' choices: the cardinal-archbishop of Washington, an Italian who heads the pontifical council for culture, the president of the Korean bishops' conference, the father general of the Jesuits, the rector of the Catholic University of Buenos Aires, plus the archbishop of Tlalnepantla, Mexico.

Cardinal Luis Antonio Tagle of Manila presided over a session that heard George and Cynthia Campos from Couples for Christ in the Philippines. George is an engineer and Cynthia a psychologist. They have four children. CFC is present in all 81 Philippine dioceses and has been brought to 163 countries.

As a novice, Cynthia was told by the retreat director: "Your work is outside. God will give you a husband who will help you rear children who'll serve Him." That turned out to be George who, at age 46, quit his job of 25 years. "I spent the first

# EDITORIAL half of my life serving this firm," he told the owner. "Now, I'll spend

the second half serving the Lord.'

On her fourth pregnancy, Cynthia was diagnosed with gestational diabetes and pre-eclampsia; her life was at risk. The child had a high probability of being born abnormal. Abort or risk? Choose. "We decided to abide by the will of God." She survived, and daughter Christen is now a healthy adult.

In 1998, breast cancer struck and Cynthia was given three to six months to live. Instead of letting go of CFC service, "we continued—with prayers," she said. "Now, I stand before you cured with a simple medical intervention and antibiotics."

But what about those who do not have a support group? They were stunned when a local church advisory came: CFC is "meant only for couples married in church." The synod can foster "an enlightened pastoral charity," they said. That'd inaugurate innovative forms of "accompaniment," of conjugal spirituality formation, and of inclusionary participation leading to full communion.

In a report, the New York Times quoted Cardinal Tagle as telling a news conference that some of the bishops felt the "spirit" of Vatican II in this synod. He said the mid-synod report was a marker against which bishops could "see what needs to be deepened, what needs to be clarified, and what other things should be raised."

At the synod's first plenary session on Oct. 6, Francis gave what was "akin to a bill of rights that creates a climate of freedom," Gerald O'Connell wrote. Say what you really think. And do so in total freedom and without fear of consequences.

"You bring the voice of local churches through the bishops' conferences," Francis told them. "You bring the realities of the churches, to help them to walk on that way which is the Gospel of the family."

"A cardinal wrote to me after the Consistory of Cardinals in February 2014," Francis recalled. "He said it was a pity that some cardinals did not have the courage to say certain things, thinking perhaps that the Pope thought differently."

"This is not synodality," Francis said. "It is necessary to say everything that in the Lord we feel must be said. We must listen with humility to all that our brothers say. And do so with peace, because the synod is conducted always with Peter who guarantees custody of the faith."

Today's climate of freedom departs from previous synods, where Vatican bureaucrats clamped "discreet but effective censorship," said Archbishop Jose Maria Arancedo, president of the Argentine Bishops. Even more damaging was the "self-censorship" by participants. The second week found disagreement aired by bishops from Poland and the United States.

There's consensus on the question of the indissolubility of marriage. But other positions emerged. How is mercy matched with justice? Is there a path that can open the door to the reception of the sacraments of reconciliation and communion for divorced and remarried Catholics?

"Homosexuals have gifts and qualities to offer the Christian community," says the synod document "Relatio," Reuters reported on Monday. Often they wish to encounter a Church that offers them a welcoming home. "Are we capable of guaranteeing them a further space in our communities?"

It did not change the Church's basic stand on homosexual unions. But it clearly reflects Pope Francis' desire to adopt a more merciful pastoral approach on marriage and family issues, wrote Vatican expert John Thavis.

Mercy can, in some cases, be offered too cheaply in the style of cheap grace—

# SURIGAO REVISITED

BOOM TOWN — I revisited the Caraga region these past few days. How it lately transformed to what it is today is just remarkable. Surigao City is booming with new establishments. A new, plush towering TAVERN HOTEL faces the calming sea. It used to be a seedy hideaway. At the outside patio, many foreigners quaffed chilled beer watching rugby matches on a large TV screen outside. Across the channel, world class Siargao surfs beckoned. The roads are well paved and widened. Construction is still underway in several areas. A sprawling soon-to-be inaugurated Surigao del Norte provincial hospital at the outskirts is just waiting for Pres. Aquino's presence. The mining towns along the route from Butuan City are swarming with people especially at the Bad-as junction which can lead one to Placer town, a mining area and to Surigao City on the opposite direction.

POLITICAL — The MATUGAS clan's political control still holds strong. The provincial capitol is occupied by lady GOV. SOL MATUGAS, a hardworking, gracious chief executive who earned her spurs while previously serving in various capacities at the department of education & sports. When I called on her at her office last Monday well beyond office hours, she was still closeted with her key staff working closed door. It was a non-working holiday. Her husband, CONG. FRANCISCO "Lalo" MATUGAS (2nd district) was also set to meet with PNP Provincial DIRECTOR JULITO DIRAY when I walked in. He just came from look-see visit of the new provincial hospital to make sure things were ready for the president's coming. Cong. Lalo's brother, MAYOR ERNESTO "Nitoy" MATUGAS runs Surigao City to complete the political triumvirate.

In political tandem with the MATUGAS clan is the ROMARATE family headed by CONG. GUILLERMO ROMARATE, JR. of the 1st district who also holds sway with his stronghold at TUBOD town ( around 40 kilometers from Surigao City ) where his daughter, MAYOR CRISTINA HEMADY ROMARATE ARCILLAS is town mayor. She struck me as a young, development oriented chief who told me over breakfast that she's still even going to school for her master's degree. "It's my dad's wish and dream," she curtly said when I showed quizzical eyes. At the provincial board as senior member is matriarch MYRNA ROMARATE who can potentially also go up the political ladder in 2016.

Another Surigao power block is the **BARBERS** family, principally skippered now by former legislator and cabinet member **ACE BARBERS** after the passing sometime ago of his father, legendary **ROBERT BARBERS**, policeman turned *compleat* politician.

MINING — While in Surigao, I visited several barangays around a mining site that was first opened in the early 1930s and closed in the 1980s. The people I talked to were generally supportive of mining. They were even petitioning for the mine's early resumption of operations with strong support from the locals and the officials, principally Cong. Lalo. The locals had seen over the years the benefits brought by mining to them individually and as a community. They had witnessed first hand the benefits of mining not seen or experienced by "outsiders" who, according to them only talk of "horror" stories about mining.

**CO-EXIST** — Contrary to popular belief, responsible mining, agriculture and community living can and DO co-exist. I saw this at a gold project site at Tubod

#### PNOY FAILS IN FIGHT VS. POVERTY-CREDIT

SUISSE: If anyone from the Aquino government's economic team needed proof that President Aquino failed to improve the lives of Filipinos with his four years in office, they must read the latest report of the Credit Suisse Group, which says that the gap between the rich and the poor in the country remains wide, and there remains a "very high inequality" in terms of wealth distribution among our citizens.

The report also confirmed that about 76 percent of the country's wealth in 2014 is controlled by a very small minority of only about 10% of our richest individuals. This 10% does not mean 10% of the entire 100 million population of the Philippines. Rather, it means that among the country's richest, only 10% of them control 76% of the country's wealth. How many are the people that we can count as the country's richest?

My perception, based on available data, is that, there are only about 100 or so families who can be considered as the Philippines' richest. Consequently, only 10% of this 100 or so families—or only about 10 families—are really very, very rich, because they are the ones that control 76% of the country's wealth. I am quite sure that these 10 very, very rich families are either foreigners or of foreign descent, and not native Filipinos.

What brought the sudden emergence of a leader's control over Ukraine's territories? Despite the interventions of united foreign powers like the European Union (EU) and the United States of America, why does the country still confront conflicts? 

She sends them to school while they work for her. "I am not an outgoing person. Although I occasionally socialize. But while there are no appointments outside, I take care of my 86 year old father and my 83 year old mother since my siblings are overseas. My parents serve at Philippine Government National Employees Association, an organization for professional government retired employees. "My mother is the Lakambini of the organization. She'll be crowned on October 28. She is a member of the Puguis Women's Association in La Trinidad, "she said.

Ms. Gawisan is a vegetarian, a sea food enthusiast except for pusit and catfish. She eats green salad in the evening and prepares kimchi herself. She does not eat meat and only tastes it occasionally in small slices during meetings or gatherings. "I guess because I'm a pet lover and I teach my pets to be vegetarian, too. Psychologically, I am very caring for animals. When I was an OSE in Abra and drove the car myself, I panicked more when I came across dogs on the streets because I did not know if I step on the break or the accelerator whereas when I encountered people on the road, I found time to distinguish what was to step on to stop the car. People have common sense to run or to stop but with dogs, I don't want to hit nor kill one," she said. Ms. Gawisan was sent to Korea and Singapore for trainings on entrepreneurship. She travels to Europe herself to visit her siblings and their families.

"You are paid to do the job required of you so that you should cater to everybody and extend to them your services even of you don't know those people,' said Ms Gawisan. This is why some clients who come to government offices back off if they don't see the people they know because sometimes they find these people whom they do not know that do not want to do the favors' ask from them, she added.

Dear Mr. Retuta:

This is a rejoinder to your Comment on my letter of August 2014 as submitted by you to the Regional Direct or upon her behest.

FIRST. Unless you have a good motive for saying that I have resigned as Regional Manager of LTFRB for unknown reasons, your mentioning it is irrelevant to the issues at hand. It is also naughty and inviting quarrel. For your info, I irrevocably resigned out of delicadeza arising from an unsigned poison letter accusing me of approving CPC for a fee of up to P15T. The letter was of course instigated by a lawyer and fixers who thought I will again be assigned in Region 1 after my stint with LTFRB Region IV. One of the fixers involved confessed this truth to the me after I have already resigned.

Pls. be corrected also that I did not accuse all my fellow lawyers for covering up the corruption in the LTFRB-CAR. In my letter, I alluded to only two lawyers who allowed themselves to be used unwittingly to disguise the corruption arising from fixing activities. You should know who they are because as the one who usually conduct hearings, reception of evidence in your case, you know the lawyers who usually have sale and transfer or cases of similar nature like opposition. As far as I know this had not unexplainable stack of cases for hearing,

SECOND. I do not remember making Entry of Appearance as an issue, yet you made a lengthy discussion of it. The issue relative hereto is your non-implementation of Sec. 12, Rule 4 of the Rules. From the time the Rules were promulgated up to lately, you allowed the "hearing" of applications signed only by the applicants. I remember I have "lectured" n you about Entry of Appearance in lawyers as practiced in the Board en banc since you are not imposing it. I also called your attention to the fact that the cases you were hearing were not filed by lawyers but you retorted that they were because it is notarized by lawyers. But I suppose that by now you know that you were wrong. Still, I am not sure what you do with applications not truly filed by counsel reaching

THIRD. Sorry, I don't get what you mean by "a single transaction cannot be accomplished without the presence of single employee, or in the absence of one, the need of multi-tasking by anther employee." But what I know is that if some employees can afford to play solitaire games in the computer during office hours or break time, they also have time to prepare applications and tab the documents of the applicants.

FOURTH. Morality is not involved when fixers are able to influence lawyers to cause the mere hearing of cases of their so-called "clients," but the ethics of the legal profession is. The point here is that LTFRB-CAR management has an inherent duty and responsibility to see tat that fixing activities are actually stopped by action, not just by issuing written policy or memorandum. It will interest you to know that the Board en banc during the time of Chairman Lantin gave the lawyers (through its Association) the privilege to inform the Board who are fixing and in what manner fixing activities are being carried out. As a result, all applications became cases of lawyers prepared, filed fixers" in your own room of office in violation of your own window policy, that will and actually prosecuted by them, while the fixers and the personnel were relegated to probably dispel my doubts towards your integrity. mere finders of applicants made entitled to a "finder's fee" only (Atty. Parado told me he knew this because he practiced in the LTFRB Quezon City).

parable of Juan Tamad referring to a situation where a lawyer, like me "insist" to have his office in a place not accessible to the "transacting public." For your info, I have my own reasons why I purposely decided not to hold office in Pacdal, and they are:

- I am not comfortable with the fact that DOTC-CAR allowed the construction of stalls and offices within fifty (50) meters distance from the LTO and LTFRB, thereby violating the policy enunciated before by LTC (now LTFRB and LTO) aimed at precluding unholy alliances between personnel and concessionaires
- The stalls as constructed are without common sanitary amenities, like CR, which is a big problem to people with prostate problem like me.

- The make-up of LTFRB/LTO compound is susceptible to widespread fixing activities as even stall owners who are insurance agents, meters installing shop, etc... Have their own excuse for fixing.
- Most of all, the size and design of stalls being rented is not suited for a dignified law office; ok lang ito for notarial office.

Anyway, I don't believe that the distance of law office from or to the LTFRB has something to do with the fact that some lawyers have more cases than others. Atty, Calabias, for instance, has a law office nearby LTFRB in addition to his office at Engineer's Hill but since he is not one of the favored lawyers, he has without "one foot high stack" of folders during hearing. It's the same case with the Mabalot Law Office who even has extensive clientele among all lawyers but is not favored.

SIXTH. No wonder hearings of applications are swift because the only task of Hearing Officer as you alleged is verification of authenticity of documents. From what I know, as a lawyer and a former Regional Director of the LTFRB, hearing includes the observance of the following:

- At the beginning of the hearing cases are called up on times as indicated in the Notice of Hearing for the purpose of transparency and possible existence of oppositions. There is a second call for those who failed to respond to the first call up of cases.
- Proper manner of appearance of counsel who did not sign the pleading in the first instance pursuant to the Rules of Procedure;
- The presence of the actual o or necessary parties is required particularly in been observed religiously that's why CPCs are sometimes sold and transferred to another without the knowledge of the owner grantee.
- Compliance to the jurisdictional requirement is required for the Board to obtain authority to hear and decide, such as in following:
  - That the application/petition is correct and proper;
- That the publication was done within the prescribed time (for many years you allowed publication without compliance to the prescribed time because you did not know how to count the 10-day requirement of publication, thus, the jurisdictional requirement were not complied with; you can check the past case records on file);
- The correctness and completeness of the requirements are not strictly observed such that Ms. Oyaman could still see your inadequacy in this respect.
- That the participants in the hearing particularly the lawyers and the Hearing Officer are in improper attire (this is neglected).
- That the Formal Offer and the Affidavit in support thereof are prepared, dated and submitted on he day of hearing, not before, to name a few.

BY THE WAY, speedy and judicious disposition of cases does not mean that hearing will be conducted abbreviadly and irregularly. Further, you also claimed that hi have vested interest (whatever that is), reason why I am the only one complaining. You should know better that even as the only one taxpayer complaining, the complaint should and must be addressed, and the same being the duty of people in the bureaucracy serving the sovereign public.

LASTLY, physical improvement in service does not prove that integrity exists as a hallmark of personnel in your agency. In your case, if you will stop seeing "clients and



lion Ukrainians died. From 1939 to 1940, Western Ukraine was annexed to Germany by Soviet Union based on a secret treaty withNaziGermany triggering uprisings from Ukrainian insurgent army. By 1943 to 1944, the Russians returned prompting Ukrainian residence to flee in England, France, and Canada and to the USA. The vears that followed were struggles for the Ukrainian on their fight to independence especially in the Western region. The 1980's became a legacy of continues protests and the national movement for the liberation of Ukraine was formed with the acronym RUKH. In 1990, Ukrainian sovereignty was granted and in 1996, its constitution wasofficially proclaimed. However, being a country conceived by a disturbing pasts, Ukraine is destined to face coming series of dilemmas.

So by November 2013, former deposed president Viktor Yanukovych declared that he won't forge an agreement that would strengthen relationship with the EU. He instead announced that he is seeking closer cooperation with Russia. Protest resulted to the streets among Pro-Ukrainian populace. They demanded closer agreement andties with the EU instead of Russia. But therewas no sign of compromise from his abusive administration thatharassed its citizens, illegitimately putspeople injail and ruthlessly tortured activists. By February 2014, a sniper killed anactivistin front of the president's administrative building followed by the killing of 82 protesters by government troops in Kiev through the command of Yanukovych who fled the capital finding his planned route to Russia evading a warrant of arrest issued by Ukraine's Interim Government and newly declared President OleksandrTurchinov. The siege continued in Crimea, a Southern region of Ukraine that is nominally autonomousby having its own parliament. The Crimean Port city of Sevastopol is a home to naval bases for Ukraine and Russia who obtained a long-term lease from Ukraine after havingdeclared independence from the communist Soviet Union in 1991 but it does not have the right to disaffiliate. After Ukraine's pro-Russian president stepped down to power, pro-Russian Crimeandemonstrated in the streets to secede from Ukraine.Pro Ukrainian government did the same. Crimean military surrounds Ukraine military bases in Crimea where more than half of the population comprises ethnic Russians. Ukrainian elected officials were ordered to step down at gunpoint and were replaced with pro-Russian politicians. The Crimean selfappointed leaders announced a referendum to split with Ukraine for Russia. It is a voting process backed by President Putin who earlier have been trying to intervene on Ukraine's spurring ties with the EU. Putin was quoted to have stated in the past public speeches that 'Ukraine and other nations who were once held captive by the former Soviet Union should return to Russian control, a line which supports and foretells the idea of an imperialistic move.

ByMarch 16, 2014, Crimea voting results showed 97% of voters backed a

unionbetween Russia and Crimea. This resultedto Russia's lower parliament to ratify a treaty making Crimea officially part of the Russian Federation. Such referendum was contradicted by the White Houseand theEU calling it a violation of Internationallaw. To give preliminary sanctions to Russia, the White House and the EU thought of destabilizing Russia's economy while strengthening their support to Ukraine.

It is strongly believe that Crimea isn't only a political but geographical danger to other neighboring countries of the European continent which Russia once disarrayed, gruesomely batteredand terrorized the in the years of cold war. History chronicles that when the Soviet Union was defaced in 1991, countries includingPoland, East Germany, Republic of Ukraine and Latvia amongothers were fully and finally emancipated. However, time could be tricky considering that residents of Ukraine manifest their varied ideological divisions.

Today even if the regime was replaced by President Petro Poroshenko, the saga of unresolved conflicts continue to ensue between these two countriesnot over Crimeathis time but for other Ukrainian territories which too threaten countries nearby its borders. Whatever lies ahead of Ukraine's confrontation to the present brawl with Russia remains to be seen. Putin's move disregarding the breakthroughs of nations' independence may be his first step to justify his obsession in assembling back the dissolved USSR.

For citizens of countries free from cold war, always believe in the might of solidarity.

I concur with him when he said he will not consider running for a national office unless an enabling environment for good governance is in place. A shift to federal is one avenue.
