

BCPO chief calls on Muslims in Baguio to be partners for peace

City Police Office Director PSSupt. Ramil Saculles took this opportunity to talk to the Muslim brothers and sisters in the city and to appeal to them to help maintain peace and order in Baguio and help the authorities in preventing terrorism threats and activities to occur in the city.

BAGUIO CITY -Mayor Mauricio G. Domogan said he will first meet the officers of the different association of truckers in Baguio and Benguet to ascertain their compliance to the implementation of the temporary relief from the city's truck ban ordinance pending the approval of the amendments being worked out by the members of the City Council.

The local chief executive pointed out he received reports that some of the truckers have questionable stickers that were posted on their trucks allowing them to be exempted from the truck ban while others have reproduced the limited numbers that were provided them to be able to travel from their points of origin to their destinations.

Earlier, 11 members of the local legislative body wrote Mayor Domogan expressing no objection to the implementation of the pertinent provisions of Administrative Order No. 050, series of 2017 that granted exemptions to certain groups of truckers from the coverage of the truck ban

also requested the mayor to adopt measures to deter abuse and the cancellation wholly or partly of exemptions granted for violations committed by those that were granted the exemptions.

Under the Administrative Order, a maximum of 30 trucks loaded with perishable goods like agricultural crops will be exempted from the coverage of the truck ban ordinance while for cutflower truckers, 10 trucks will be exempted from the ban during Thursdays to Saturdays while 7 trucks will be exempted from Sundays to Wednesdays.

Water delivery trucks will be exempted from the truck ban while trucks loaded with finished mine products from Philex mines will also be granted exemption from the ban.

The local legislators admitted the amendments to the provisions of Ordinance No. 05, series of 2017 or the city's truck ban ordinance will have to take a little more time because of the need to balance the interest of the city and the truckers as the implementation of the measure has resulted By Dexter A. See

The local legislators to significant relief among the motorists because of lesser traffic congestions.

Mayor Domogan claimed the meeting is intended to thresh out the problems raised during the implementation of the exemptions to the truck ban so that the truckers will not be delayed in the delivery of their products to the markets in the lowlands and Metro Manila.

He explained the issuance of the order was intended to provide a stop-gap measure to the plight of the truckers who were not earlier exempted from the coverage of the truck ban and that the submission of the order to the council for confirmation was intended to involve the members of the local legislative body in granting the exemptions to the sectors who deserve to be exempted from the coverage of the truck ban ordinance.

He emphasized he saw merit in the clamor of various sectors in seeking exemption from the coverage of the truck ban ordinance because of the need for perishable goods to be immediately brought to the markets. /

Barangays ordered to submit high impact dev't projects

BAGUIO CITY - The City Development Council (CDC) adopted a standing policy mandating all the city's 128 barangays to submit proposals for high impact development project to the city government for funding to prevent unimplemented projects due to lack of funds that affects the performance of the city and its competitiveness in project implementation.

Mayor Mauricio G. Domogan said over the past several years, the city was not able to implement hundreds of millions worth of infrastructure projects that funded by the annual budget because of problems on the target project sites apart from absence of takers of the projects when bid out due to the meagre funding earmarked for the projects.

We agreed that barangays should submit to the City Development Council for approval high impact development projects to allow the projects to be funded sufficiently and implemented to avoid past projects costing one hundred thousand pesos and below which have not been implemented through the years because there are no takers," Domogan stressed.

He explained that even if the small projects will be undertaken, the process in their implementation by administration is far more tedious than undergoing the rigid bidding process thereby leaving the projects unimplemented and affecting the city's overall performance in the implementation of projects were funded under its annual budget.

According to him, the CDC agreed to realign the funding for the small unimplemented projects so that those projects that should be funded will be the ones to be implemented, especially if there will be no problems encountered in the project site, so that overall development in the city's barangays could be realized.

Further, the CDC approved the shopping list of projects where Rep. Mark Go and the members of the City Council will select projects for funding from the national government and the annual budget of the city next year and that there will no longer be amendments made in the list.

He added the approved shopping list is the product of all the list of Cont. on page 7

SC ruling: Duterte can put 'entire PH' under martial law

MANILA, Philippines (UPDATED) – The Supreme Court (SC), in a landmark decision on Tuesday, July 4, said the Chief Executive should be trusted to declare martial law and should have the sole discretion on its scope.

"The Constitution grants him the prerogative whether to put the entire Philippines or any part thereof under martial law. There is no constitutional edict that martial law should be confined only in the particular place where the armed public uprising actually transpired," the SC said in its ruling penned by Associate Justice Mariano del Castillo.

Del Castillo's ponencia upheld the constitutionality of President Rodrigo Duterte's martial law in Mindanao, with concurrences from Associate Justices Lucas Bersamin, Presbitero Velasco Jr, Jose Mendoza, Bienvenido Reyes, Diosdado Peralta, Teresita Leonardo-de Castro, Estela Perlas-Bernabe, Noel Tijam, Samuel Martires, and Francis Jardeleza.

Senior Associate Justice Antonio Carpio believes martial law should be



Justice Benjamin Caguioa voted to limit martial **EDITORIAL** law to the provinces of Lanao del Sur, Maguindanao, and Sulu.

Associate Justice Marvic Leonen was the lone dissenter in the High Court, siding with the petitioners' bid to nullify Proclamation No. 216.

Armed Forces of the Philippines (AFP) chief General Eduardo Año and Philippine National Police (PNP) chief Director General Ronald dela Rosa have indicated that they would recommend to Duterte the extension of martial law in Mindanao, which is supposed to end on July 22.

Presidential prerogative

In the 82-page ruling released late Wednesday, July 5, the High Court said all issues of martial law and circumstances of its proclamation are upon Duterte's prerogative.

The SC said the President does not need the approval of the High Court, not even Congress, to impose martial law - it's up to him to determine that there is rebellion and to impose military rule.

"The Court, as Congress does, must thus accord the President the same leeway by not wading into the realm that is reserved exclusively by the Constitution to the Executive Department," the SC said.

The SC also said Duterte has the power to declare martial law not only in the area where he finds rebellion to exist but also in "other areas where present hostilities are in danger of spilling over."

"In fine, it is difficult, if not impossible, to fix the territorial scope of martial law in direct proportion to the range of actual rebellion and public safety simply because rebellion and public safety have no fixed physical dimensions," the SC said.

"The Constitution must have considered these limitations when it granted the President wide leeway and flexibility in determining the territorial scope of martial law. Limiting the proclamation and/or suspension to the place where there is actual rebellion would not only defeat the purpose of declaring martial law, it will make the exercise thereof ineffective and useless," the SC added.

The High Court cited incidents related to the Marawi clashes one way or the other which occurred outside the besieged city, such as the arrest of Maute matriarch Farhana Maute in Masiu town, and even the attack of the Bangsamoro Islamic Freedom Fighters (BIFF) in Cotabato City.

Sereno said, however, that the SC should not have given the President carte blanche, or the exclusive discretion to determine the matter.

"Validating a Mindanao-wide coverage is indeed convenient for the Court but it is not right. If, to use the words of the ponencia, the most important objective of Article VII, Section 18 is to 'curtail the extent of the power of the President,' then this Court miserably failed," Sereno said in her opinion.

Probable cause enough

The Constitution says martial law may be declared in the event of a rebellion, but for the SC, Duterte does not need to be sure that there is actual rebellion; he only needs to have probable cause to believe so.

"The President only needs to convince himself that there is probable cause or evidence showing that more likely than not a rebellion was committed or is being committed. To require him to satisfy a higher standard of proof would restrict the

exercise of his emergency powers," the SC said. Carpio, although voting to restrict martial law to Marawi City, agreed that only probable cause is required of the President. "Probable cause is the same amount of proof required for the filing of **Cont. on page 5**

from page 4 by the prosecutor and for the issuance of an arrest warrant by a judge," Carpio said in his opinion. As for the convincing factors, the SC said the President does not need to be correct but only needs to have "sufficient factual basis" for making the declaration.

"The Court does not need to satisfy itself that the President's decision is correct, rather it only needs to determine whether the President's decision had sufficient factual basis," the SC said.

For majority in the SC, the inaccuracies in Duterte's martial law report to Congress are "irrelevant" in view of the necessary haste in deciding on the imposition of military rule.

"As the President is expected to decide quickly on whether there is a need to proclaim martial law even only on the basis of intelligence reports, it is irrelevant, for purposes of the Court's review, if subsequent events prove that the situation had not been accurately reported to him," the SC said.

The SC also agreed that Duterte does not need the recommendation of anyone, not even his top security officials, for his proclamation to be valid.

The petitioners had cited inaccuracies in the martial law report in seeking to nullify Proclamation No. 216, mostly based on news reports that fact-checked Duterte's report. The SC said news reports are inadmissible.

The SC also said the presence of true and accurate incidents in the report would be sufficient.

The ruling also said that Duterte, as Commander-in-Chief, and not the High Court, can "properly assess the ground conditions."

The SC said it would be up to Duterte if he wants to *disclose to the public certain information.*

"He cannot be forced to divulge intelligence reports and confidential information that may prejudice the operations and the safety of the military," the High Court said.

Vague martial law?

The Bayan group of petitioners alleged that the martial law declaration was too vague because of its inclusion of "other rebel groups."

In fact, the military's operational directive for martial law in Mindanao also targets communist rebels, drug syndicates, and other peace spoilers.

The petitioners' counsel, Neri Colmenares, even showed a copy of the annex that Solicitor General Jose Calida submitted to the SC listing the BIFF, a splinter group of the Moro Islamic Liberation Front (MILF), as among the peace spoilers in the region.

For Colmenares, rebel groups outside of the Maute network are irrelevant to the case. He accused Calida of inventing facts to justify martial law.

For the SC, the vagueness doctrine only applies to cases of free speech, and martial law is not such a case.

The High Court also said the absence of clear operational guidelines does not make martial law vague. It said it is not the SC's job anyway to determine the legality of operations when ruling on the constitutionality of martial law.

The SC said it would address questions about the legality of a martial law-related operation when raised before the High Court.

"Any act committed under the said orders in violation of the Constitution and the laws, such as criminal acts or human rights violations, should be resolved in a separate proceeding."

On House Speaker Alvarez' threat to file impeachment case vs. Supreme **Court Chief Justice Sereno**

Speaker Pantaleon Alvarez must be drunk from all the power he wields if we are to go by his recent statements about Court of Appeals Justices, the Chief Justice and even the postponement of Barangay Elections.

Typical of the so-called "leadership" style of this administration, when faced with opposition, his reaction was to lash out, curse and threaten the CA Justices with disbarment, the Chief Justice with impeachment, and even threaten the entire judiciary with the dissolution of the CA-all because a Division of the CA performed its duty by unanimously finding merit in a petition for habeas corpus. Last time I checked, that's a subject for a motion for reconsideration and, thereafter, appeal-not an opportunity to flex one's ego and political clout.

For that is what this is: a show of political power. He is certainly not purporting to hold that much power by himself: instead, this is Alvarez throwing the weight of his borrowed influence as a henchman of a more powerful patron.

That is where he gets the gumption to threaten the Chief Justice of the Philippines with impeachment.

That is also where he gets the bloated confidence to announce the postponement of the Barangay Elections and that barangay officials will, instead, be appointed, as if such are already writ in stone simply upon his say-so.

His statements are not just galling to hear, but also very disturbing. They are a manifestation of a grave threat to the Rule of Law and our democratic way of life, for they are geared towards making key institutions and officials vulnerable to undue threats and, ultimately, malleable to the whims and tantrums of bullies and dictators, whose capacity for conflict resolution ranges from inflicting ad hominem attacks, to doing their utmost to ruin the life and career of those who disagree with them.

That is their obvious endgame.

I can only hope that members of the Judiciary, as well as my fellow lawmakers in both Houses of Congress, will find the willpower to continue resisting such threats. I would be the first to say that it isn't an easy task. But it is possible because those who resist will also wield their own brand of power-the power of knowing that we are defending our people by doing what is right.

er-in-Chief's powers; further curtailment of presidential powers should not only be discouraged but also avoided," the SC said.

For the SC, it is enough that the 1987 Constitution limits the basis of martial law to only rebellion, and that it imposed a 60-day expiry on the proclamation.

The High Court said the public should not be scared or biased against martial law because of the country's experience of military rule under the late strongman Ferdinand Marcos.

"After all, martial law is critical and crucial to the The High Court also cited "sufficient safeguards" in promotion of public safety, the preservation of the nation's sovereignty and ultimately, the survival of our country," the SC said.

NFA Baguio-Benguet Provincial Manager Cecilia Concubierta recently led an inspection of the various stalls selling rice in the Baguio Public Market to ensure that fake rice has not entered the city. The NFA also conducted inspection at the market areas in La Trinidad, Benguet.

Concubierta said NFA conducted daily monitoring of the rice market situation and has not found any adulterated or unusual rice stocks in any of the markets covered.

Reports in social media showing alleged fake or plastic rice are being verified by NFA's investigation and enforcement department. NFA management has instructed its field offices to further heighten their monitoring activities and seek out people complaining about alleged fake rice in their respective areas.

On Friday, a consumer from Baguio City posted on social media that they bought fake rice. NFA took samples of the alleged fake rice and conducted laboratory analysis and it was found out that it was real rice and not fake rice.

The public is also being encouraged to be vigilant and report to NFA observations about any unusual features in the rice that they buy, in terms of appearance, smell or tastes, so that the agency can send enforcement agents to the source of the stocks and samples can be taken for laboratory analysis by the agency's Food Development Center.

Meanwhile, in the wake of reports about alleged fake rice in the market. the NFA has released guidelines for the public to ensure that what they are buying is real rice.

For raw rice, consumers should make sure that they buy only from retailers accredited by the NFA or from their "suki" rather than from vendors they do not know or trust. An NFA accredited store displays the trader's full

name and license number.

If the grains are uniformly-sized, there's a chance they may have been made by a machine. All rice grains have a chalky dot or scar at the tip of the kernel where the germ or embryo was removed. It looks like a small groove at the tip of each grain of rice.

Aside from the appearance, consumers should also be aware of the smell of rice. If it smells anything like plastic or any synthetic material, it should be subjected to laboratory analysis to ascertain the composition of the "grain."

For cooked rice, consumers must also make sure it does not smell unusual. There should be no foam -like substance left on top of the rice when cooked. If one feels ill from eating any suspected fake rice, it is best to see a doctor immediately.

Sample of the rice, at least 1 kilogram, should be brought to the NFA-FDC for analysis. For those who cannot go to NFA directly, they may give their address and contact

bags of stockpiled organic fertilizer

fifty thousand bags of stockpiled organic fertilizer are available for bidding out to interested individual or institutional buyers for use in the production of organically raised crops for household or commercial consumption.

City Assistant General Services officer Eugene Buyocan informed members of the City Council there are over 8,870 tons of organic fertilizer produced by the city's two Environmental Recycling system (ERS) machines from the conversion of biodegradable waste to compost fertilizer which are ready for disposal to interested individual and institutional buvers.

The winning bidder of the initial 3,000 bags of organic fertilizer that was bid out by the city's disposal committee in coordination with the Commission on Audit (COA) has not yet gotten the items as he cannot come up to the city to haul the said compost fertilizer.

The city's disposal committee declared

Buyocan claimed the city's disposal committee wants to increase the volume of the compost fertilizer to be bid out to a maximum of 20,000 bags at 25 kilos each to attract organic farmers to buy the organic fertilizer this rainv season before they become soaked or carried away by rains.

The organic fertilizer produced from the ERS machines were previously subjected to tests by the regional soils laboratory in San Fernando City, La Union and a Manilabased private company and it was proven that it is organic considering that its nitrogen, phosphorus and potassium content is around 5.3 which is within the 5-7 range of being classified as an organic fertilizer.

On his part, City Assistant Environment and Parks Management Officer Ruben Cervantes said this ERS-produced Rapport Innovations, a organic fertilizer is being Dexter A. See

in the different parks around the city and it was proven effective although slow in its effect.

He said that CEPMO personnel want to get more supply of organic fertilizer from the General Services office so that it could use these in the planting and production of various types of flowers in the different parts and champion the use of the locally produced organic fertilizer.

Cervantes said by using the locally produced organic fertilizer in the parks, people will be convinced to use the same in their production of flowers and organic vegetables and they can minimize their expenses in the use of chemical-based fertilizers.

While the local governments still needs chemical fertilizers, Cervantes said the availability of the ERS-produced organic fertilizers from the city's biodegradable waste will definitely help in reducing the expenses of the city in terms of fertilizers for the parks among others. /By
