o Parks to Escape Clearing

BAGUIO CITY ambulant vendors displaced by the clearing operations being undertaken by the Public Order and Safety Division (POSD) of the City Mayor's Office on all sidewalks have gone to the parks.

City Mayor Mauricio Domogan has ordered the Baguio City Market Authority (BCMA) to ascertain reports that displaced vendors are now using some of the city's parks to ply their trade.

"We will be implementing continuous clearing operations on all sidewalks including our parks of ambulant vendors," Domogan said.

Recently, the mayor ordered the immediate removal of vendors who have been occupying portions of the city's sidewalks supposedly intended for public use.

Domogan stressed, "the city government is strengthening the clearing operations to remove human and structural obstructions along sidewalks and streets to improve traffic flow."

"I hope our vendors would apply for vacant slots in the public market so they can ply their trade without fear of arrests or confiscation," he said.

The mayor have tasked the BCMA to identify portions of the Public Market Blocks 3 and 4 for the reloca-Cont. on page 6

CJHDevCo Loses Insurance Cover on Injunction Against BCDA

The bonding company where the Sobrepeña-led Camp John Hay Development Corporation (CHDevCo) tapped its bond to make effective a writ of preliminary injunction, has filed a motion to withdraw their insurance.

In a Motion for Cancellation of Injunction Bond filed by Liberty Insurance Corporation on July 03, 2013 before Branch 6 of the Regional Trial Court (RTC) of Baguio City said it is no longer in a position to renew the injunction bond due to underwriting restriction and constraints.

The withdrawal of the bonding company lies contrary to the statement issued by CJHDevCo lawyer and spokesperson Manuel Ubarra, Jr. that the injunction guaranteed by Liberty Insurance Corporation remains in effect. A criminal case for perjury was recently filed by the Department of Justice (DOJ) against Ubarra before the Municipal Trial Court of Quezon City for knowingly making false statements under oath in a complaint that he filed before the Office of the Ombudsman against the Board of Directors of the Bases Conversion and Development Authority (BCDA).

The P736 million bond that the CJHDevCo posted was a prerequisite to make effective the injunction that prevents a government takeover of their leased properties in John Hay. CJHDevCo has not yet offered to replace the bond.

BCDA President and CEO Arnel Paciano D. Casanova said if Liberty Insurance Corporation withdraws, there is no bond to speak of which makes the writ of preliminary injunction void. "Without the bond, no injunctive relief can be extended to CJHDevCo," he said.

Casanova added that CJHDevCo had no basis for securing the injunction against a takeover of CJHDevCo's leased properties in Camp John Hay because there was no attempt to take over the leased properties.

"There was no basis for the writ of preliminary injunction. No takeover has taken place, and no attempt has been made, hence the court order came as a surprise and mystery," Casanova said.

The BCDA, the government body that owns Camp John Hay, pointed out that the termination of lease agreement that it served to CJHDevCo on May 16, 2012 still stands. BCDA earlier terminated the lease agreement with CJHDevCo due to material and incurable breaches, foremost of which is the lessee's continued refusal to pay its lease to the Philippine government, which has already ballooned to P3 billion..CHDEVCO-PR

DOH Brings Adolescent Vaccination Program to Public HS Students in

BAGUIO CITY - The Department of **Baguio** Health (DOH), in its effort to eliminate

the emergence of vaccine-preventable diseases, is now pushing for a school-based adolescent vaccination program for public high school students in selected cities and provinces

To launch the program in Baguio City, DOH Center for Health and Development - Cordillera (DOH-CHD-CAR) officials headed by Dr. Virginia Narciso, along with city officials headed by Mayor Mauricio Domogan and City Health officer Dr. Florence Reyes, led a simple program and ceremonial vaccination at the Baguio City National High School (BCNHS), Tuesday.

Several health teams proceeds to the classrooms to conduct MMR (Measles, Mumps and Rubella) and Td (Tetanus Diphtheria) vaccination to grade 7 (first year) up to fourth year high School students of BCNHS who have letter of consent from their parents to avail of such free vaccination.

Narciso, who heads the Family Health Cluster of CHD-CAR, said the school-based adolescent Immunization is a nationwide program of the DOH that adopts the theme, "Malusog na Kabataan, Kabalikat at Pag-asa para sa Kaunlaran: Magpapabakuna".

This is in line with the country's 2007 commitment to eliminate vaccine preventable diseases such as measles, mumps, rubella and diphtheria, which the DOH's National Epidemiology Center identified as also common to adolescents nowadays.

Under the program, Narciso said they hope to provide booster dose of MMR and Td to around 19,600 high school students in 22 public high schools in Baguio City to boost their immunity against the vaccine-related illnesses.

Narciso also disclosed that the province of Abra and Apayao are the other beneficiaries of the said school-based adolescent immunization program in the Cordillera Region.

Domogan and BCNHS Principal Dr. Elma Donaal warmly welcomed the program and expressed their gratitude to the DOH for bringing the free immunization program to Baguio starting with the largest public high school in the city. They encouraged all the students to avail of the program 'so that all together we can bring in and promote a healthy environment for the city and the people of Baguio./JDP/CCD-PIA

City Tackles Busol **Lot Problem**

BAGUIO CITY - City legal officer Melchor Carlos Rabanes last week advised city assessor Nilda Navarro not to issue tax declarations over the 22 subdivided lots covered by a 211 title and located within the Busol watershed.

In a letter to Navarro, Rabanes said issuing tax declarations over the lots covered by Original Certificate of Title No. 018-0-162 "would be reckless, anomalous and irregular and would certainly cause grave and irreparable damage and injury to the government and to the public" as said title was not revalidated despite being a 211 title under Land Registration Case No. 1 Record No. 211.

"Without any validation, (Presidential Decree) 1271 declares the title null and void and without force and effect (and in this case) we do not see any validation of the said original and derivative titles,' Rabanes said.

Rabanes also said that based on the findings by the city assessor the lots fall within the Busol Watershed Reservation and thus are not valid considering that the Busol watershed was established as a forest reservation by Proclamation No. 15 on April 27, 1922 which "antedated OCT 018-0-162 which purports to have been issued only on March 26, 1965.'

Rabanes also asked Navarro to coordinate with the Register of Deeds of Baguio "for the annotation on the purported derivative titles your findings that said lots fall within the Busol Forest Reservation" and at the same time inform the Dept of Environment and Natural Resources and the city council for a "joint verification and investigation of this serious concern.'

OCT 018-0-162 covers an area of 77,849 square meters and was subdivided into 22 lots with duly issued Transfer Certificates of Title (TCTs).

Navarro discovered the spurious titles upon review of applications for tax declaration covering the subdivided lots and noticed the lack of revalidation of the Original Certificate of Title No. 018-0-162 before its subdivision.

Mayor Mauricio Domogan tasked Navarro to coordinate with the legal office to undertake necessary actions to nullify said titles./A Refuerzo

PNP-Cordillera Holds Consultation on Draft IRR of **Comprehensive Gun and**

BAGUIO CITY, - The Police Re-**Ammo Law** gional Office (PRO-Cordillera)

headed by Regional Director PCSupt. Benjamin Magalong conducted on Thursday a stakeholders' hearing and consultation of the draft Implementing Rules and Regulation (IRR) of Republic Act 10591 at the Crown Legacy Hotel here.

RA 10591, otherwise known as the Comprehensive Firearms and Ammunition Regulation Act, which was signed into law by President Benigno Aquino III last May 29, puts in place stricter measures for gun registration and licensing that generally aims to promote responsible gun ownership and reduce gun-related crime and violence in the country.

With the law already in place, the task of drafting its IRR was mandated by the president to the chief of the Philippine

During the consultation, PSSupt. Oliver Enmodias of PRO-Cor presented the draft IRR.

Participants that included officials and representatives from other regional law enforcement offices, line agencies, security services, gun stores or suppliers and other stakeholders shared in their views, suggestions and ideas, which were collated as the region's input for the final IRR consultation at the national level.

Magalong, in closing the regional consultation meeting, outlined the importance of the participation of various stakeholders in ensuring the effective implementation of RA 10591, which would help in reducing gun-related crimes and violence especially those involving loose firearms.

He cited that 78 percent of recorded homicide cases and 86 percent of murder cases in the country are gun related. Of these crimes, around 90 to 93 percent involves loose firearms.

He stressed that with RA 10591, the country will adopt a more efficient system in gun ownership, licensing and registration, as well as a general amnesty that responsible gun ownerships should take advantage of to register their fire-

Sobrepeña's Co-Accused Arraigned for Malversation

Three officials of the Sobrepeñaled Camp John Hay Development Corporation (CJHDevCo) were arraigned on Thursday for malversation before the Baguio City Regional Trial Court Branch 6. The executives, Ferdinand Santos (president), Alfredo Yniguez III (chief operating officer) and Emily Roces-Falco (chief finance officer) pleaded not guilty before Cecilia Judge Corazon Dulay-Archog to two counts malversation of public funds or properties.

Chairman Robert John Sobrepeña was arraigned last June 27, 2013 on the same malversation charge.

Sobrepeña and his colleagues were charged by the Department of Justice (DOJ) with malversation on April 1, 2013, following a complaint filed by the BCDA against the Board of Directors and officials of CJHDevCo and its subsidiary, Camp John Hay Hotel Corporation (CJH Hotels).

BCDA president and CEO Arnel Paciano D. Casanova hailed

CJHDevCo the speedy progression of the case, saying that "we look forward to the commencement of the trial of Sobrepeña and his cohorts, and we are highly confident that they will be convicted of their crimes."

Benguet, former CPLA ink MOA for Livelihood Reintegration

Projects

LA TRINIDAD, Benguet - Three areas of Benguet are set to benefit from the

livelihood project as part of the closure agreement between the government of the Philippines and the former Cordillera Peoples Liberation Army(CPLA) under the economic reintegration component towards its transformation into a socioeconomic entity.

The P2.7 million livelihood funds under of the Office of the Presidential Adviser for Peace Process (OPAPP) will be coursed through the provincial government which is designated as the fund manager.

The provincial government represented by Governor Nestor Fongwan and members of the former CPLA group now tagged as Cordillera Forum for Peace and Development (CFPD)- Peoples Organization, through the Benguet Saguday Livelihood Association, Inc. (BSLAI) represented by its president Carlito Payangdo, inked a memorandum of agreement on said livelihood project in a simple rite at the Provincial Capitol last August 13.

Also present during the activity was OPAPP Program Management Office Chief

Dir. Alexander Umpar.

Fongwan told recipients from Cabiten in Mankayan, Camp 3 in Tuba and Palina in Kibungan to work out registration requirements from concerned agencies and the other requirements prior to the release of initial funds to the associa-

Funds will be released in tranches. The first tranche worth P270,000.00 will be used to purchase construction materials. The next tranche amounting to P1.89 million will be released upon compliance with the process and project requirements, upon approval of project proposal and after disbursement report shall have been verified. The last tranche amounting to P540,000.00 will finally be released upon submission of certificate of project completion, terminal report, sustainability plan among others.

According to OPAPP Technical Staff Jenny Mordeno, identified projects under the program are raising of organic free-range chicken side by side with organic feeds processing and a rolling store where organic inputs will be traded.

Parties to the MOA as agreed will adopt the Community-Driven Enterprise Development concept of the Department of Social Welfare and Development which focuses on capability building and business values formation that inculcates participation and empowerment.

Mordeno said series of trainings among the recipients were held earlier to prepare them for the entrepreneurial projects.

The livelihood project is an offshoot of the signing of a joint declaration of commitment in 2011 between the Government of the Philippines and the Cordillera Bodong Administration-Cordillera Peoples Liberation Army (CBA-CPLA) towards a closure agreement that will finally transform the group into a legitimate socio-economic entity to fast track peace and development in the Cordillera Region./JDP/SCA-PIA CAR, Benguet

Rare Window

Will the pork barrel scam spiral into a march by the millions next week? The theft shoved to the back burners other equally critical issues from "nutritional black holes" to loss of keystone species.

"He who plants trees benefits another generation." After 12 years of below-radarscreen efforts, research has paid off. Another rare tree in Cebu has won international recognition. But Cynometra cebuensis is critically endangered.

Journal Blumea declared the tree as "scientifically described" on Nov. 24 last year. The decision appeared on the Net this month.

"This brings island-endemic tree species to three," notes botanist Franz Seidenschwarz who tracked Cynometra from seed to fruit-bearing. All three cluster within the Tabunan forest slivers. "Germany has zero endemic tree species."

Cynometra Cebu bears no local name, unlike the other two. Discovered in 1922, Arthrophyllum cenabrei is named Bingliu—the area where it sprouted. Cinnamomum cebuense Kostermans, recognized in 1986, is called Kalingag in Visayan.

Degraded habitats and limited numbers will insert Cynometra Cebu into "Critically Endangered"

tables of the 2001 "Red List" by the International Union for Conservation of Nature. A University of Munich graduate, Seidenschwarz led the University of San Carlos (USC) Botany Research Group. Fluent in Cebuano, he authored various studies, including "Plant World of the Philippines-An Illustrated Dictionary of Visayan Plants."

He married Cebuana Elizabeth Cinco who teaches German in a language school she established. Their eldest son is a New York hospital internist. Franz Jr. is a resident physician at Perpetual Succor Hospital in Cebu.

Today, Seidenschwarz juggles the duties of Germany's consul in Cebu with research in a private Maria Luisa Park tree farm. "It is my garden and a secret area where I plant the critically endangered species of Cebu." That fills a gap in research

USC researchers, in November 1998, discovered a new damselfly. Scientifically described by Dr. Matti Hämälainen, it is now known as Risiocnemis seidenschwarzi. But in July 2000, the damselfly population dwindled. It was last seen in March of 2001. New populations were spotted in Badian, then Tabunan. The Zoological Society of London included this damselfly on a list of "100 most endangered species of the

Starting in 1999, Seidenschwarz tracked 17 Cynometra Cebu trees whose seeds came from one mother tree. The species thrives in dry forests on limestone at altitudes of 400-600 meters. Flowering occurs at the onset of the dry season. But they last only for a few days.

The tassels of young trees are bright pink; in older trees, they are creamy greenish yellow. They attract butterflies, dragonflies and other insects. The woody fruit pods fall

The new species differs from the Cynometra in Sibuyan Island. Its leaves are much larger. Its habitat is different. Sibuyan trees sprout on moist fertile wooded flats along rivers. All Indo-Pacific species of Cynometra grow under ever-wet climatic conditions. In contrast, Cebu is seared by a dry season from the middle of March to early June.

"It took me over a decade to prove that it is a new species," Seidenschwarz recalls now. "I waited for the flowers. But the blooming was very irregular."

Today's trees bear the imprint of history. Cebu is one of the country's two most deforested provinces. Indiscriminate logging interlocked with unrelenting kaingin or clearing of trees by fire. This pillage led the Spanish colonial government, in 1870, to shred all special licenses to cut trees on Cebu. The Spanish governor-general, in 1873, appointed 12 officials to prevent countrywide deforestation. They were tasked to hold on to depleted forest stands.

They failed. So did the US colonial administrators and Filipino officials who took over after the grant of independence in 1946. Less than a quarter of Philippine rainforests

Deforestation threatens also the birds. The Cebu Flowerpecker or Dicaeum quadricolor, for example, is extinct, despite the crossed fingers of conservationists.

In 1917, President Sergio Osmeña opened Cebu's Camp 7 reforestation project. It still exists in a province where the key project of his grandson, former Rep. Tomas Osmeña, is a treeless, 296-hectare reclaimed South Road Properties.

In Central and Southern Cebu, tree-covered tracts remain only in higher and less accessible mountains. Paradoxically, this remaining 0.2 percent fragment of natural forests is unusually rich in endemic plant and animal species. Many of them are rare

The largest remnant is the 145-hectare spread within the Tabunan forest. It is hemmed in by farms. And pressure on the land and trees ratchet up from population growth, inflow of migrants and poverty.

Habitat deterioration is caused by timber harvesting, specially by fires during the dry season, says Seidenschwarz who has monitored Tabunan since 1994. That threat is compounded by encroachments.

The nearby Cantipla forest was once "a habitat of the new species," Seidenschwarz notes. On paper, the area is well protected. The reality on the ground is different. The forest area should be delineated soonest, so protection measures can follow.

That gut issue lands on newly elected Cebu Gov. Hilario Davide III's lap. It provides him with a rare window of opportunity for lifetime achievement. Few dare to tally the price tag for failure./Juan L. Mercado/E-mail: juan_mercado77@yahoo.com

He assembled his thousands of followers in a show of force then in a horse race track in Davao City to make known his opposition to the **MILF** peace agreement. I had a suspicion at that time that this declaration would take place if his moves would not attract attention and corresponding response from the government. Nur's consistent and strong statements opposing the framework agreement with the MILF were ominous. He wanted that the whole Philippine government peace process, including the MILF negotiations, factor in or take into account the existing MNLF peace agreement. It seemed he felt he was ignored. He feared that his nurtured 1996 Peace Agreement would be abrogated and set aside with the onset of the final peace agreement with the MILF.

RESTIVE —I am not sure now how things and events will spin out from here on. So far, statements coming from some MNLF leaders are moderate, if not conciliatory. An associate of MISUARI told me his movements were restricted. He was last reported to be still in Sulu. however is the restiveness noted in some MNLF communities. Remember that there are still strong misgivings on the implementation of MNLF peace agreement. In fact, a Tripartite review started during my watch at **OPAPP** to look into these misgivings. Remember that the Final Peace Agreement with them in 1996 did not contain any provision on "disarmament" so their fighters, although transitioning to peaceful lives, kept their firearms somewhere. I know of some MNLF groups which buried their greased weaponry in plastic bag sunderground. I will not be surprised if some are starting to dig them up just in case.

VOLATILE — However, I note positive signs. **Ustadz Habier MALIK**, whose enclave in Sulu I personally visited sometime ago, was quoted as saying that "Maas" (referring to NUR, literally meaning "respected one") will take a PEACEFUL route in pursuing the declaration of independence. I do hope so. BUT WE CAN NEVER TELL HOW VOLATILE EVENTS SUCH AS THESE COULD SPIN INTO.

MALIK, a religious leader who maintains an armed force inthe fastnesses of Sulu, isone of the loyalists who "hostaged" Marine General BEN DOLORFINO and Gen. RAMON SANTOS, my OPAPP undersecretary when they entered his camp to deliver some "goodies" and in a goodwill mission. They were prevented from leaving the camp for several days for one reason or another. I had to fly to Jolo and personally negotiate with Malik to set them free.

STILL AN ICON —NUR is still an "icon" to some Muslims. Although his capability to lead his people to wage war against the Philippine govern-

Mining Company Conducts Abolish Pork, Lawmaker Asks Senator Chiz Escudero has formally asked Senate

the senate to abolish the priority development assistance fund (PDAF) by filing Senate Resolution No. 193 (PSR No.193)

Escudero, chairman of the senate committee on finance is coming in from the heels of his resolution, PSR No. 41 asking the senate to probe the pork barrel scam when it first hit the public through a series of investigative reports on a major broadsheet. He was the first in the senate to make such call.

The senator's PSR 193 calls the Upper Chamber to "express its sense to abolish the PDAF and its allied congressional initiative allocation collectively known as "pork bar-

"The people have spoken and it is necessary to draw the line further between public accountability and patronage politics by being truthful to the constitutional allocation of powers and prerogatives" Escudero said in the resolution.

The PDAF, whose pre-cursor is the Countrywide Development Fund (CDF) established in 1990, is supposed to fund the needs of every Filipino on a priority basis as identified by the national government.

"Now, it has already mutated into a multi-billion racket allegedly perpetrated by syndicates in both the public and private sectors. Despite proper use and disbursement by wellmeaning public officials and despite its statutory laudable purpose, the misconception that the pork barrel has become a form of "horse trading" and a major source of corruption in the government is apparently starting to become real in the eyes of the Filipino people".

Escudero said with the Commission on Audit (COA) confirming the gravity and extent of the pork barrel abuse and the strong calls of the people to scrap the source of the public outrage, it is now time to totally scrap the pork barrel.

"The PDAF should now be abolished in general". He says Congress should limit itself to the enactment of the national budget and the Executive to its implementation.

As this developed, Escudero throws his support to the anti-pork barrel protest on August 26, saying everyone is equally responsible to guard the public coffers. But while he supports the move, he will stay away from the event so as not to politicize it. "That is the people's event; it's their voices that must be heard. I will always carry their voice to the Senate. I am hoping that no one will take advantage of it and paint it with their political color because frankly, I don't think the people will allow it" /- OFFICIAL WEBSITE: htt

22-page complaint to the DOJ stated that the CJHDevCo directors and officers, even after the lawful demand of the BCDA, refused to return the public properties to the government. These properties are 16 units of the CJH Manor Hotel and 10 units of the CJH Suites Hotel which have a total value of P121 Million. The hotel units were payments in kind or dacion en pago made to BCDA in 2008, as partial settlement of CJHDevCo's unpaid rental obligations.

CJHDevCo's debt to the government has already ballooned to more than P3 billion.

The BCDA's complaint further stated that CJHDevCo continues to earn from these units but refused to provide the liquidation of public funds-revenues that it earned from the use and lease of the 26 units which should go to the public coffers.

The DOJ approved the filing of two counts of malversation of funds, stating that "In the instant case, respondents' delayed remittance of the rental income of BCDA despite repeated demands did not extinguish their criminal liability for malversation of public funds. Again, it should be noted that the respondents did not provide any sufficient explanation for the said remittance. Thus, they are presumed to have malversed the rents due to BCDA for the period mentioned above under leaseback agreement."

CJHDevCo is facing more legal trouble aside from the malversation case, as CJHDevCo's lawyer and spokesperson, Atty. Manuel Ubarra Jr., was recently charged by the DOJ with perjury before the Municipal Trial Court of Quezon City for knowingly making false accusations against

the Directors of the BCDA before the Office of the Ombudsman.

Aside from the malversation and perjury charges, the BCDA had also previously charged CJHDevCo with estafa for the "double sale" of a property in Camp John Hay, and with professional squatting for the building of illegal structures within Camp John Hay./BCDA-PR

Clarence Baguilat also reported that there are around 300 former CPLA members who are hired as "Bantay Gubat" (forest guards). They are set to finish their training this month before their actual work deployment.

On social reintegration, a representative from the Armed Forces of the Philippines said the re-integration into the APF of several former CPLAs is on-going. Around 90 of them have already finished their training while around 168 more are also set to undergo training.

ment is doubted by some quarters, he is still revered by those who believe in him. Even the Islamic world still held him in high esteem. This was evident when I attended several conferences the Organization of Islamic Conference (OIC) in the Middle East where I saw for myself how he was received as if he was Head of State. Up to today, and as far as I know, he is still considered the representative of the country's Bangsamoro by OIC leaders.

SABAH — This Bangsamoro Republik announcement can mean going to an instrumentality or agency of the United Nations seeking recognition of the "republik". And my hope is that Misuari's new mission for independence will remain within the realm of a non-violent, peaceful pursuit.

For sure, SABAH will be part of this Bangsamoro "republik". The Sabah claim of the Sultanate of Sulu is also MNLF's own aspiration. In fact, I got confidential information that those so-called Sultanate Army fighters who penetrated Sabah were actually MNLF forces from Sulu, wearing newly sewn Sultanate army uniforms.

Moreover, the angst of Nur against the Malaysians got worse when he was arrested in 2001 after a failed MNLF attack of Jolo. I recall that after escaping from Sulu, he landed in his usual Malaysian hideaway thinking and confident, albeit erroneously, that he was still enjoying sanctuary status. The Malaysians promptly intercepted him as soon as he landed and took him into custody. He was dumped in a detainee's celland cut off from the rest of the world for sometime. I was secretly dispatched to Malaysia (on board a C-130 plane in the middle of the night) to fetch Nur and fly him back to a waiting, specially furbished prison facility in Santa Rosa, Laguna. He spent almost the whole 5 hours of flying time from Kuala Lumpur to Manila relating to me how he was badly treated by the Malaysians. (And to think that many thought he was luxuriously billeted in some plush hotel or villa.) I was sure he did not expect such treatment from them who were his patrons and supporters during his rebellion days against Philippine authorities. Malaysia, in fact, was the arms supply depot and staging point of MNLF rebels at the height of the rebellion. NUR FAILED TO NOTICE, or perhaps ignored, THE PARADIGM SHIFT in the international scene.

NOT A SPENT FORCE— I have not personally talked to him for sometime now so I cannot as yet divine what's in his mind.. But I am certain that how NUR will be handled from hereon will be cru-

As things stand, we cannot afford to have another potentially explosive front to deal with while we are tackling the end game of the MILF peace agreement. Not to mention the upswing of terrorists' incidents here and there.
