City to operationalize CCTV surveillance system soon

 $B^{\text{AGUIO CITY}-\text{The city's own closed-circuit tele-}\\ \text{vision (CCTV) surveillance system project will}$ soon be operationalized.

Mayor Mauricio Domogan led city officials last Thursday in inspecting the newly constructed Baguio City Public Safety and Security Command Center at the Baguio City Police Office which will serve as the nerve center of the system where CCTV footage monitoring and response will emanate.

An inspection of the 70 CCTV cameras and the fiber optic cable installed at the central business district was also conducted last Friday while the training of personnel to man the command center will begin next

Latest revision of proposed schedule of market values results to lower rates

AGUIO CITY - The Baguo of 1 market values underwent another revision which resulted to a general lowering of the tax rates than those proposed in the 2014 proposal.

City assessor Almaya Addawe said they also decided to pursue only a tax revision on land values and forewent earlier proposals for buildings and improvements after observing that realty taxes covering them are still relevant.

Addawe last Wednesday presented the new schedule to Mayor Mauricio Domogan who expressed hopes that the schedule will finally be adopted by the city council before the year ends for implementation by January 2017.

The valuation processes used to determine the current and fair market value for land were through "geographic stratification" where areas having similar characteristic were identified and grouped under one sub-classification, "sales comparison approach or market data analysis" using sales data and through consultations with bank appraisers, real estate brokers and assessors.

Comparing the 2014 and 2016 schedules, Addawe said the rates in the 2016 schedule of values in both residential. commercial and industrial classifications were generally lower than in the 2014 set-up.

areas where rates were increased after this last revision but the rates in most areas considerably decreased," she said.

The latest revision was effected following the suggestion of Rep. Marquez Go and Mayor Domogan recently to review the stratification of the taxable areas as well as the market values of the 2014 schedule to make them more appropriate.

She said this entailed having to go through the process of gathering data anew but was done just the same to capture inputs and more current sales and market data

They also updated the proposed assessment levels for land from the current assessment levels of 12 percent in residential lands to just six percent; 35 percent for commercial and industrial land to just eight percent and 12.5 percent for cultural, scientific and hospital to just five percent.

Addawe again justified the proposed increase citing that it is mandated under section 219 of the Republic Act 7160 or the Local Government Code that the city assessor undertake a general revision of real property assessments within two vears after the effectivity of the code in 1992 and every three years there-

"There are some series of 1995 that took effect in 1996. This was implemented in three phases thus the revision was fully implemented in 1998. Had we complied with the law, there should have been six revisions to date,"

> "Due to our failure to update our schedule of market values, the city was cited by the Department of Finance in its LGU Fiscal Sustainability Scorecard as 'non-compliant' in the regular updating of schedule of market values and conduct of general revision of property assessment and was given a poor rating the area of revenue generation capacity for the years 2010, 2011 and 2013," she said.

Addawe said that for the last 19 years, real property values are assessed at their 1996 levels which are abnormally low considering that the real property market was still affected by the memory of the 1990 earthquake.

Over the years when the city bounced back from the calamity, the city's population ballooned and the demand for real property and consequently the market value of land also increased but the city still appraises real properties at their 1995 values, she said.

"It is about time that we achieve the main purpose of a general revision of real property assessments in compliance with the law which is to reflect the true market levels of prop-

LBenguet, - Drug surrenderees in all barangays of Itogon are now being organized into associations for the possibility of extending livelihood opportunities in order to mainstreamed as productive members of the community.

Itogon Livelihood and Cooperative Development Officer Patrick Alcedo said livelihood is one of the priority programs of Mayor Victor Palangdan aimed to reduce poverty,

provide alternative employment and increase family income of organized groups or associa-

Drug surrenderees numbering to 187 to date were included in the livelihood program of the local government anchored on the national government's campaign on illegal drugs.

Through Municipal and Barangay Anti-drug Abuse Council (MADAC/BADAC), Alcedo said surrenderees in all of the nine barangays are being organized and are ongoing registration with the Department of Labor and Employment as one

Outstanding Barangay Peace and Order Council honored

BAGUIO CITY - The Barangay Peace and Order Council (BPOC) has a very significant role in the citywide implementation of peace and order initiatives in this mountain resort.

During the 24th Local Government Day celebration Monday, October 10, the ten most outstanding BPOC were honored for its commitment in sustaining crime prevention to the peace and order program of the city government here.

Middle Quirino Hill barangay headed by punong barangay Ignacio Gallente is this year's most outstanding BPOC receiving plaque of recognition and Php20,000 cash incentive.

The first runner-up is Irisan headed by PB Thomas Dumalti, second runner-up is Lower Quirino Hill headed by PB Oliver dicing and third runner-up is Atok Trail headed by PB Federico Codley.

They received plaques of recognition and cash incentives amounting to Php15,000, Php10,000 and Php7,000, respectively.

The other six finalists received certificates of recognition plus Php4,000 cash incentives each are barangays City Camp Proper, San Antonio Village, Camp Allen, Sto. Tomas Central, Asin, and Pucsusan.

It is recalled that said 10 barangays were nominated and recommended by the precinct stations in Baguio and subsequently assessed and evaluated by the assessment team.

It's Time to Suspend America's Alliance with the **Philippines**

The United States has an unfortunate history of acquiring ugly authoritarian $m{I}$ allies even when America's security interests do not justify making such moral compromises. Malou Innocent and I described many of those unfortunate relationships in our book Perilous Partners, noting that a majority of the security relationships did not involve situations in which America's vital interests were imperiled.

Washington faces another increasingly problematic relationship: its alliance with the Philippines. As I've noted previously on this site, Philippine president Rodrigo Duterte is the personification of a "loose-cannon" ally. Among other things, he referred to President Obama as "a son of a bitch," and made it clear that he had no intention of necessarily following Washington's lead on foreign policy.

Since I wrote that article, his erratic behavior, both domestically and internationally, has grown worse. After indicating that he wished to conclude alliances with both Russia and China, Duterte stated that there will be no further military exercises with U.S. forces because China objects to such exercises. Now he has

inconvenient obstacles of due process—and would like to kill millions, just like Hitler killed millions of Jews.

U.S. officials seem strangely tone-deaf to the outrages of their East Asian ally. Even as Duterte was cozying up to China and waxing about Hitler, U.S. Secretary of Defense Ashton Carter was affirming that Washington's alliance with the Philippines was nothing less than "ironclad."


That is an unwise position for several reasons. First, it is generally a bad idea for a great power to pass out security guarantees in a promiscuous manner, since any one of them has the potential to entangle it in a dubious military confrontation. The United States has violated that rule in a spectacular fashion, undertaking explicit, treaty-bound security obligations to more than four dozen countries and implicit commitments to many more. The "mutual" defense treaty with Manila is actually one of the older obligations, having been concluded when the Philippines were granted independence in the late 1940s. But the venerable nature of the treaty does not make it a wise one.

A second reason a great power should avoid alliances like the relationship with Manila is that the security client's agenda can create embarrassments or even great dangers. The Philippines have ambitious territorial claims in the volatile South China Sea—along with several other countries. At a minimum, having a treaty ally in that position creates a headache for the United States.

Finally, a security relationship makes America at least indirectly culpable for the domestic behavior of the client regime. Throughout the Cold War, Washington embarrassed itself (if not shamed itself) by its close relationships with an assortment of thuggish "allies." American officials may have deluded themselves into believing that such relationships were essential for the republic's security, but in the vast majority of cases, that simply was not true. Now in the absence of the kind of existential threat that the Soviet Union posed, the justification for tossing basic moral values overboard is even weaker.

The United States needs to take an immediate stand regarding the Philippines. It is absurd for America to be putting its security on the line to defend a country ruled by an individual who is showing his unreliability on foreign policy issues and engages in utterly odious domestic behavior. Washington should suspend the alliance with Manila indefinitely. In the 1980s, the United States suspended its

defense commitment to New Zealand through the ANZUS pact because Wellington would not allow U.S. nuclear vessels to operate in its waters. TS THERE BASIS FOR RAMOS' CLAIMS VS. DUTERTE? So, okay, former President Ramos is not satisfied with the performance of President Duterte during the first 100 days of the Duterte government. According to Ramos, Duterte focused principally on the illegal drug trade, virtually leaving out issues on poverty, living costs, jobs, and foreign investment.

The question, however, is this: is there a factual basis for the claim of Ramos that nothing has been done by the Duterte government about poverty, living costs, jobs, and foreign investments during its first 100 days? It is significant to note that what Ramos offered in support of his claims are mere generalizations, without appropriate data to back him up.

This is dangerous as it is misleading, especially since it came from someone who, for all intents and purposes on account of his being Duterte's personal representative on the South China Sea row, is a part of the Duterte government. People may entertain---as indeed, many, especially from those who oppose Duterte, are now entertaining the possibility that Duterte really failed in his first 100 days, as what Ramos said.

DUTERTE GOV'T IS DOING ALL ITS CAN TO ADDRESS PROBLEMS:

I mean, it is one thing to say that nothing is being done about something, and another to say that nothing is being reported about what the government

is actually doing to address the many problems that have been inherited by President Duterte from past administrations, including that of Ramos.

What, to me, is happening at this point, is that, each and every department of government under the Duterte administration are discharging their respective duties and responsibilities, in an attempt to achieve the goals set out by President Duterte when he assumed the presidency on June 30, 2016.

Let us take the example of the Department of Agriculture, under the leadership of Sec. Manny Pinol. In July, he ordered the release to farmers and their organizations some P2 billion worth of farm equipment and machineries, which were simply kept and undistributed under the Aquino government. This certainly empowered farmers and their organizations towards greater agricultural production.

OBJECTIVITY KEY TO APPRECIAT-ING WHAT DUTERTE HAS DONE:

Then, in line with Duterte's objective of taking away our people's fascination and dependence on gambling, the Duterte government decisively shut down a company whose franchise allowed it to operate gambling facilities through the Internet, also during its first 100 days.

The company is still trying to win back its franchise but at this point, gambling through its outlets or stations have been stopped. There is no doubt that removing gambling from our people's way of life would improve their lives better, with more productive use of the time that they have been spending on games of chance.

Old peso bills can be exchanged in banks until Dec. 2016 only

 ${f B}^{\rm AGUIO\ CITY}$ - Bangko Sentral ng Pilipinas (BSP) encourages individuals who still have old bank notes or peso bills (New Denomination Series) in their possession to exchange these with the New Generation Currency (NGC) Series in banks until December 31, 2016 only.

Old bank notes that have not been exchanged or surrendered will be demonetized or will no longer have monetary value starting January 1, 2017, said BSP La Union Regional Director Rogel Joseph del Rosario during the kapihan media forum here last week.

Del Rosario explained that demonetization is the process by which a central bank removes the monetary value of a legal tender currency it issued and can no longer be accepted as payment for goods and services.

The BSP is demonetizing the old banknote series which have been in circulation for 30 years as a way to safeguard the integrity of our currency, he said.

The RRCY is a facility designed to provide intensive treatment in a residential setting for the rehabilitation of CICL whose sentences have been suspended. It serves as a nurturing out-of-home placement for children in need of rehabilitation.

The Center caters to CICL aged 15 years to not more than 18 years old male, who have committed an offense and ordered by the court to undergo rehabilitation. CICL who are on suspended sentence may, upon order of the court, undergo any or a combination of disposition measures appropriate to their rehabilitation and welfare./Nerizza Faye G. 

DO-18A contains the rules implementing articles 106-109 of the Labor Code regarding contracting and subcontracting that applies to all parties of contracting and subcontracting arrangements where employer-employee relationship exists including cooperatives engaged in contracting or subcontracting arrangements.

DOLE-Ifugao Field Office Officer-In-Charge Isabelita Codamon explained that contracting and subcontracting arrangements are allowed by law but subject to regulations for the promotion of employment and the observance of the rights of workers to a just and humane conditions of work, security of tenure, self-organization and

or endorsement by at least majority of the Sanggunian concerned.

Flowers and candle-selling guidelines

issued a call for applicants for candle and flower-selling on October 26 to Nov. 1 at the Jadewell Parking Area, to prepare pertinent documents for submission on Oct. 18 at city hall.

The applicant must be a bonafide resident of Baguio City, of legal age, and must not have any violations from the past years of selling candles and flowers.

Together with a properly filled up application form from the Campaign and Investigation Division, Treasury Office, applicants must submit two copies of 2" x 2" photo, barangay business clearance, (Baguio city) residence certificate, 2016 Official Receipt of Residential Garbage payment, and

The applicant's documents are evaluated, followed by the assignment of stall number. Fees and taxes totaling P1,020.00 are paid at the One-Stop-Shop, Other Fees Section, after which the applicant proceeds to the Permits and Licensing Office for submission of all documents, and preparation of a special permit.

Some 125 stalls measuring 6 feet x 6 feet each are prepared, but may be extended, if needed. Parking goes on, at the right side of the selling area, it was known.

There should be no swapping of stalls, no cooking, no gambling, no sub-leasing, and sanitation should be observed. The special permit issued should be posted at all

BAGUIO CITY - The Photocopy of any valid times in the stall, and violation of the policies would mean no permit for the next three years.

> There should be no retail of flowers in the bagsakan areas, and tents; which may be obtained from a supplier, must be uniform in size and color, the guidelines from the city treasury office states.

> The assignment of stalls are strictly on a first-come, first-served basis; only applicants with complete requirements are accepted; and only candles, flowers and floral arrangement materials are allowed to be sold.
