# Family in crisis appeals for help Baguio dad orders fast tracking



# Baguio dengue cases increase by 400%

Office reported that dengue fever cases in the city increased by over four hundred percent from 239 cases from January 1 to July 20, 2015 to 1,875 cases during the same period this year.

Dra. Rowena Galpo, City Health Services Officer, said 64 percent or 1,199 cases were residents of the city's barangays while the rest of the reported dengue cases are from nearby municipalities and provinces.

56 percent of the dengue cases were males while the remainder were females and that the age range of the affected patients were from 3 months to 82 years old.

Galpo revealed among the actions taken by the concerned offices to help combat the rapid increase in dengue fever cases include the purchase of two ultra-low volume space spray machines, emergency hiring of two fumigators, training of Emergency Management Services (EMS) and City

Council (CDRRMC) staff as pesticide applicators to augment manpower, policy development through consultative meetings for the crafting of the dengue ordinance of the city, signing of appropriate lawful orders to mobilize the available city resources against dengue, dengue advocacy meetings with barangay officials, private-public partnership meetings with stakeholders to discuss inter-agency response against dengue and misting of the affected barangays.

The City Health Officer disclosed there were 30 barangays covered by the misting operations since May 18, 2016 but there are still more barangays to be covered by the said activity up to next month.

On the other hand, Galpo claimed there were 12 schools that were covered by the misting operations from June 1-9, 2016 as part of the Brigada Eskwela and the schools were located

ated its previous invitation for regional and district officials of the Department of Public works and Highways (DPWH) to appear before its regular session on August 1, 2016 to shed light on the snail-paced implementation of their projects and the unabated citywide diggings causing monstrous traffic congestions in the central business district area.

The local legislative body expressed disappointment over the failure o regional and district officials of the agency to appear in last Monday's regular session without even sending a written notice stating the reasons for their non-appearance.

Members of the council were to air the sentiments of the public in relation to the on-going implementation of city infrastructure projects, particularly the non-compliance of the erring contractors to simple project specifications and their failure to install appropriate early of regional and district A. > The appearance of regional and district officials of the DOPWH before Council's regular session was fundamental in seeking explanations and justifications on the very slow implementation of their projects and the contractors' failure to fulfil their commitments to complete most of their projects within the central business district by the first week of July.

> It will be recalled that last May 23, 2016, DPWH officials committed to complete the drainage projects in the central business district area will be completed within this month but ocular observation will confirm that several of these projects now the cause of the monstrous traffic jams in the central business district.

> The inability of contractors to install the appropriate early warning signages and the capacity

pliance of the contractors to such simple provisions in their contracts is being questioned by some legislators and these should have been clarified had these entities appeared before the legislative body.

Obvious contractors' lack of adequate personnel to immediate complete their projects, especially in the central business district, is leading to traffic jams resulting to loss of valuable time for those who are working.

Observers opine that the regional and district offices of the DPWH must verify with concrete proof that winning contractors must be financially and technically competent to implement projects in a timely manner with the highest quality prescribed in their contracts.

The council will decide on its future actions against the DPWH officials who will again snub the next Council meeting without justifiable reasons./By Dexter

# Ateneo president hits killings in Philippines

'If real change is to happen, it can only come when we hold before us the value and sanctity of every person's life,' the Ateneo president says

*Ateneo de Manila University president Father Jose Ramon Villarin on Friday, July 29, condemned the recent spate of killings in the Philippines.* 

Villarin also referred to the bloody war against illegal drugs waged by the administration of Philippine President Rodrigo Duterte, who ran on a platform of change.

**EDITORIAL** *change.* The Ateneo president said "real change will happen only when Filipinos "respective contractions of the second sec

sanctity of every person's life."

Villarin issued this statement after the murder of Emmanuel Jose "Em-J" Pavia an Ateneo teacher and alumnus. Pavia is also the son of two Ateneo teachers.

Unidentified killers shot Pavia to death "on his way home to Barangka, Marikina," he said.

"Though official investigation continues, under no circumstances can the killing of such a young and dedicated teacher be spared condemnation in the strongest terms," Villarin said in his statement "on the passing of Ateneo alumnus and teacher Emmanuel Jose 'Em-J' Magno Pavia."

The Ateneo president then turned to the "primal feelings of frustration, anger, and fear unleashed by the violence that continues to stalk our people," especially the poor.

"We recognize the willful efforts of government, the private sector, and civil society to rid our communities of this drug menace and to institute measures that protect persons and property from such violence," he said.

"However, Christian faith tells us that Jesus came so that all may have life and have it more abundantly (Jn 10,10). Because of the fundamental Gospel value and sanctity of each person's life, the death of anyone regardless of virtue cannot but diminish us, and any society or culture that encourages and multiplies death cheapens life for everyone," he added.

#### 'Real change'

Villarin also said: "We join our voice with other sympathetic voices in civil society. We find resonance with the sentiments of our friends from the La Sallian community on this pressing concern."

Leaders of Catholic nuns, the president of De La Salle Philippines, and the Catholic Bishops' Conference of the Philippines, among others, have voiced their concern over the killings since Duterte won the presidency. Given the scope of the problem, Villarin on Friday urged members of the Ateneo community to:


• "Promote reverence for life, respect for human rights, and restorative justice"

• "Espouse best practices in crime prevention and control"


• "Watch over the enforcement of equality before the law, due process, and mandated judicial processes in instances of criminal arrest"

Dear Mr. President:

For so long, we have been the recipients of poor and inefficient service from incompetent and corrupt personnel of the DOTC-CAR and its two (2) agencies, the LTFRB-CAR and the LTO-CAR.

DOTC-CAR was established almost at the same time as DOTC CARAGA on experimental basis by then DOTC Secretary Rainerio Reyes for the purpose of combining the functions of LTO, LTFRB and supposedly other DOTC sectoral offices in the administrative regions and put them all under the control and supervision of the Department through only one regional director. It was not implemented in all administrative regions as intended however, hence, we have LTO, LTFRB and other sectoral offices still separate from each other under one (1) regional director.

Not that this experiment of small DOTC in the region was an structure not suited or unwieldy to manage but, just like in the case of DOTC-CAR, the defect lies in the caliber of regional directors appointed by the President who were not qualified to handle an expanded regional office. So, we have had regional directors incapable and incompetent to render proper service and to stop FIXING ACTIVITIES and RED TAPES which are the roots of corruption in the DOTC-CAR particularly in the LTFRB-CAR and the LTO-CAR, despite Rep. Act. 6713 and Rep. Act 9485.

Corruption in the DOTC-CAR perpetrated through fixing activities and red tape primarily account for the following irregularities to date, among which are the following:

1. Thousands of irregularly-issued PUV franchises many of which were granted fraudulently and spuriously, notwithstanding the moratorium existing in Baguio City and other parts of CAR since 1998 to the present, thus contributing to the worsening traffic congestion of Baguio City.

2. Failure of its law enforcers to contain continuous colorum and out-of-line operations of PUVs, thereby also causing the almost debilitating traffic congestion during peak hours in the city.

3. Inefficiency and corrupt practices of DOTC-CAR personnel concerned who because of corruption, allow and tolerate for-hire motor vehicles to use the city roads and streets as garage and terminals.

# **Court commends city** for dumpsite rehab

**B**AGUIO CITY – The Court of Appeals has commended the city government for its efforts to rehabilitate the Irisan dumpsite.

In a resolution dated June 27, 2016, Associate Justice Ricardo Rosario cited the monitoring re-port submitted by the Dept. of Environment and Natural Resources (DENR) and of the city gov-ernment on the activities inside the closed facility.

The DENR reported that the "facility remained closed for dumping and was secured, as it is se-cured, with perimeter fence."

"As previously observed the Irisan Dumpsite has not been used for dumping, the area has slowly been covered with natural vegetation or grasses and weeds," the reports notes.

The DENR also noted the presence of mounds of compost inside the facility and the continued operation of the Environmental Recycling System for the processing of the biodegradable wastes.

"The retaining walls, its buttresses, perimeter canals, storm/surface runoff canals, fence and other engineering structures, are still intact, serving their purpose."

The city for its part submitted its semestral updates on the closure and rehabilitation plan of the facility

# EMB to extend aid to LGUs for solid waste facilities

**B**AGUIO CITY – The Environmental Management Bureau (EMB) is willing to extend the appropriate assistance to all local government units for the establishment of the necessary sol-id waste disposal facilities to help address their respective garbage problems pursuant to the pro-visions of Republic Act (RA) 9003 or the Ecological Solid Waste Management Act of 2000.

EMB Director Gilbert Gonzales informed stakeholders that aside from the establishment of engineered sanitary landfill in the different cities and municipalities, there are other available state-of-theart technologies that could be put in place in order for local governments to comply with the closure of their respective open dumpsites and controlled dump facilities for health rea-sons and improved state of their environment.

'Our regional offices will be available to extend assistance to concerned local govern-ments wanting to adopt available technologies to address their respective garbage problems in case there are serious problems confronting the local governments from pursuing the establish-ment of engineered sanitary landfills in their areas or a cluster of cities and municipalities," Gon-zales stressed.

The EMB official agreed there is a need to review the existing guidelines on the compli-ance of local governments to the solid waste management law because of problems on the inade-quacy of lands to put up landfills, the presence of conflicting claims over available lands and the mountainous terrain of highland areas like the Cordillera that deprive local governments the chance to comply with the requirements of the law.

According to him, other technologies like the put up of waste-to-energy plants among others will be readily available for local governments to embrace depending on their updated sol-id waste management plans so that those who cannot qualify for the establishment of landfills will have alternative modes of addressing their respective garbage problems.

However, Gonzales emphasized that solutions to the garbage problem of localities should not be solely lodged with the city or municipal governments but formulating solutions to such problems is an individual and collective effort of local residents who should first strictly adhere to the segregation of waste at source in order to initially lessen the garbage being dumped in the pickup stations in their respective places.

He explained local governments must first formulate their respective solid waste man-agement plans in order to provide details on how local officials will effectively and efficiently address pressing solid waste management issues in their respec-Cont. on page 9 tive areas of jurisdiction within

Supreme Court (SC) Justice Marvic Leonan has accused his fellow magistrates of failing to see the evidence when they acquitted former President Gloria Macapagal-Arroyo of plunder.

#### Third of four parts

#### 3. The Tribunal's Decisions on the Scope of its **Iurisdiction**

The Tribunal has addressed the scope of its jurisdiction to consider the Philippines' claims both in its Award on Jurisdiction, to the extent that issues of jurisdiction could be decided as a preliminary matter, and in its Award of 12 July 2016, to the extent that issues of jurisdiction were intertwined with the merits of the Philippines' claims. The Tribunal's Award of 12 July 2016 also incorporates and reaffirms the decisions on jurisdiction taken in the Award on Jurisdiction.

For completeness, the Tribunal's decisions on jurisdiction in both awards are summarized here together.

a. Preliminary Matters

In its Award on Jurisdiction, the Tribunal considered a number of preliminary matters with respect to its jurisdiction. The Tribunal noted that both the Philippines and China are parties to the Convention and that the Convention does not permit a State to except itself generally from the mechanism for the resolution of disputes set out in the Convention. The Tribunal held that China's non-participation does not deprive the Tribunal of jurisdiction and that the Tribunal had been properly constituted pursuant to the provisions of Annex VII to the Convention, which include a procedure to form a tribunal even in the absence of one party.

Finally, the Tribunal rejected an argument set out in China's Position Paper and held that the mere act of unilaterally initiating an arbitration cannot constitute an abuse of the Convention.

#### b. Existence of a Dispute Concerning Interpretation and Application of the Convention

In its Award on Jurisdiction, the Tribunal considered whether the Parties' disputes concerned the interpretation or application of the Convention, which is a requirement for resort to the dispute settlement mechanisms of the Convention.

The Tribunal rejected the argument set out in China's Position Paper that the Parties' dispute is actually about territorial sovereignty and therefore not a matter concerning the Convention. The Tribunal accepted that there is a dispute between the Parties concerning sovereignty over islands in the South China Sea, but held that the matters submitted to arbitration by the Philippines do not concern sovereignty. The Tribunal considered that it would not need to implicitly decide sovereignty to address the Philippines' Submissions and that doing so would not advance the sovereignty claims of either Party to islands in the South China Sea.

The Tribunal also rejected the argument set out in China's Position Paper that the Parties' dispute is actually about maritime boundary delimitation and therefore excluded from dispute settlement by Article 298 of the Convention and a declaration that China made on 25 August 2006 pursuant to that Article. The Tribunal noted that a dispute concerning whether a State has an entitlement to a maritime zone is a distinct matter from the delimitation of maritime zones in an area in which they

> issues, are commonly considered in a boundary delimitation, but can also arise in other contexts. The Tribunal held that it does not follow that a dispute over each of these issues is necessarily a dispute over boundary delimitation.

Finally, the Tribunal held that each of the Philippines' Submissions reflected a dispute concerning the Convention. In doing so, the Tribunal emphasized (a) that a dispute concerning the interaction between the Convention and other rights (including any Chinese "historic rights") is a dispute concerning the Convention and (b) that where China has not clearly stated its position, the existence of a dispute may be inferred from the conduct of a State or from silence and is a matter to be determined objectively.

#### c. Involvement of Indispensable Third-Parties

In its Award on Jurisdiction, the Tribunal considered whether the absence from this arbitration of other States that have made claims to the islands of the South China Sea would be a bar to the Tribunal's jurisdiction. The Tribunal noted that the rights of other States would not form "the very subject-matter of the decision," the standard for a third-party to be indispensable. The Tribunal further noted that in December 2014, Viet Nam had submitted a statement to the Tribunal, in which Viet Nam asserted that it has "no doubt that the Tribunal has jurisdiction in these proceedings." The Tribunal also noted that Viet Nam, Malaysia, and Indonesia had attended the hearing on jurisdiction as observers, without any State raising the argument that its participation was indispensable.

In its Award of 12 July 2016, the Tribunal noted that it had received a communication from Malaysia on 23 June 2016, recalling Malaysia's claims in the South China Sea. The Tribunal compared its decisions on the merits of the Philippines' Submissions with the rights claimed by Malaysia and reaffirmed its decision that Malaysia is not an indispensable party and that Malaysia's interests in the South China Sea do not prevent the Tribunal from addressing the Philippines' Submissions.

#### d. Preconditions to Jurisdiction

In its Award on Jurisdiction, the Tribunal considered the applicability of Articles 281 and 282 of the Convention, which may prevent a State from making use of the mechanisms under the Convention if they have already agreed to another means of dispute resolution.

The Tribunal rejected the argument set out in China's Position Paper that the 2002 China-ASEAN Declaration on the Conduct of Parties in the South China Sea prevented the Philippines from initiating arbitration. The Tribunal held that the Declaration is a political agreement and not legally binding, does not provide a mechanism for binding settlement, does not exclude other means of dispute settlement, and therefore does not restrict the Tribunal's jurisdiction under Articles 281 or 282. The Tribunal also considered the Treaty of Amity and Cooperation in Southeast Asia, and the Convention on Biological Diversity, and a series of joint statements issued by the Philippines and China referring to the resolution of disputes through negotiations and concluded that none of these instruments constitute an agreement that would prevent the Philippines from bringing its claims to arbitration.

The Tribunal further held that the Parties had exchanged views regarding the settlement of their disputes, as required by Article 283 of the Convention, before the Philippines initiated the arbitration. The Tribunal concluded that this requirement was met in the record of diplomatic communications between the Philippines and China, in which the Philippines expressed a clear preference for multilateral negotiations involving the other States surrounding the South China Sea, while China insisted that only bilateral talks could be considered.

**Exceptions and Limitations to Jurisdiction** 

In its Award of 12 July 2016, the Tribunal considered whether the Philippines' Submissions concerning Chinese historic rights and the 'nine-dash line' were affected by the exception from jurisdiction for disputes "historic title" in Article 298 of the Convention. The Tribunal reviewed the meaning of "historic title" in the law of the sea and held that this refers to claims of historic sovereignty over bays and other near-shore waters. Reviewing China's claims and conduct in the South China Sea, the Tribunal concluded that China claims historic rights to resources within the 'nine-dash line', but does not claim historic title over the waters of the South China Sea. Accordingly, the Tribunal concluded that it had jurisdiction to consider the Philippines' claims concerning historic rights and, as between the Philippines and China, the 'nine-dash line'.

In its Award of 12 July 2016, the Tribunal also considered whether the Philippines' Submissions were affected by the exception from jurisdiction in Article 298 for disputes concerning sea boundary delimitation.

The Tribunal had already found in its Award on Jurisdiction that the Philippines' Submissions do not concern boundary delimitation as such, but noted that several of the Philippines' Submissions were dependent on certain areas forming part of the Philippines' exclusive economic zone. The Tribunal held that it could only address such submissions if there was no possibility that China could have an entitlement to an exclusive economic zone overlapping that of the Philippines and deferred a final decision on its jurisdiction.

In its Award of 12 July 2016, the Tribunal reviewed evidence about the reefs and islands claimed by China in the South China Sea and concluded that none is capable of generating an entitlement to an exclusive economic zone. Because China has no possible entitlement to an exclusive economic zone overlapping that of the Philippines in the Spratly Islands, the Tribunal held that the Philippines' submissions were not dependent on a prior delimitation of a boundary.

In its Award of 12 July 2016, the Tribunal also considered whether the Philippines' Submissions were affected by the exception from jurisdiction in Article 298 for disputes concerning law enforcement activities in the exclusive economic zone. The Tribunal recalled that the exception in Article 298 would apply only if the Philippines' Submissions related to law enforcement activities in China's exclusive economic zone.

Because, however, the Philippines' Submissions related to events in the Philippines' own exclusive economic zone or in the territorial sea, the Tribunal concluded that Article 298 did not pose an obstacle to its jurisdiction.

Lastly, in its Award of 12 July 2016, the Tribunal considered whether the Philippines' submissions were affected by the exception from jurisdiction in Article 298 for disputes concerning military activities. The Tribunal considered that the stand-off between Philippine marines on Second Thomas Shoal and Chinese naval and law enforcement vessels constituted military activities and concluded that it lacked jurisdiction over the Philippines' Submission No. 14(a)-(c). The Tribunal also considered whether China's land reclamation and construction of artificial islands at seven features in the Spratly Islands constituted military activities, but noted that China had repeatedly emphasized the non-military nature of its actions and had at the highest level that it would not militarize its presence in the Spratlys. The Tribunal decided that it would not deem activities to be military in nature when China itself had repeatedly affirmed the opposite. Accordingly, the Tribunal concluded that Article 298 did not pose an obstacle to its jurisdiction.
