# We are Implementing a New GSIS Assures Industrial Policy; CAR Gets Flexible and Transparent Security for Operating Ready to Draw Up Regional Loan Windows BAGUIO CITY -**Industry Roadmaps**

Baguio City - Industry Development Assistant Secretary Rafaelita Aldaba lauded the support and initiative of the Cordillera Administrative Region (CAR) to localize industry roadmaps. "In crafting your roadmaps and aligning this with our national strategies for growth and development. together we are building capacities to take advantage of the ASEAN Economic Community (AEC) and tariff free entry of more than 6000 products in the European market," she said

More than 250 participants from various businesses and business organizations, government agencies, PEZA locators, Mayors, and owners of small and medium enterprises from CAR attended last week the "Industry Roadmaps and the AEC Game Plan: Regional Localization for Competitiveness" forum. The Department of Trade and Industry (DTI) and the Board of Investments (BOI) organized the forum.

DTI CAR Regional Director Myrna P. Pablo urged local participants to strengthen private partnerships. public "The next step is clearly for us to formulate our own regional roadmaps to set the direction and vision of our industries. Today we are here to start formulating our regional roadmaps on Coffee and Processed Vegetables and Fruits," she said.

Some 35 sectoral roadmaps have been crafted and submitted to the BOI. The crafting of industry roadmaps at national and regional levels is private-sector led while government acts as facilitator and enabler.

The DTI and the BOI have been conducting similar fora in the country to facilitate development of local roadmaps. "What has been highlighted as the forum moves from one region to another is the need for all of us government, industry associations, academe, civil society and other stakeholders to engage in industrial cooperation and partnership in order to equip us better to face the challenges and take advantage of the opportunities from AEC," Pablo said.

The AEC seeks to create a single market and a single production base within the ASEAN region, and become fully integrated with the global market. Since January 2010, more than 99.65% of goods have been traded at zero tariff in ASEAN. Very few products remain protected by tariffs within ASEAN In the Philippines, these are primarily agricultural products including rice, sugar, cassava and sweet potatoes, maize, chicken and swine. LGU Intervention in HIV BAGUIO CITY - The Spread Needed rise in number of recorded cases of human immunodeficiency virus or HIV in the country has been described by the Department of Health as "fast and furious"

With increasing number of recorded cases of HIV in Baguio since 1984, dealing with what Philippine NGO Council on Population Health and Welfare (PNGOC) Executive Director Dr. Eden Divingracia calls a "more a social development concern rather than a disease", requires the strong presence of local government units (LGUs) in intervening with the spread of HIV.

During a workshop for civil society organizations and media practitioners, Divingracia shared one model of innovation in HIV prevention in Quezon City. PNGOC and the Quezon City LGU teamed up for a social hygiene clinic called Klinika Bernardo in Cubao. It has become a model for clinics dealing with HIV for in the daytime, Divingracia said, the clinic delivers services such as testing, counseling, distribution of antiretroviral drugs to persons living with HIV (PLHIV).

In the daytime the clinic caters to sex workers at the "population at large", but from 5:00-11:00 PM the clinic caters to gays and transgenders who prefer to avail of services away from the public eve. Such a set up values the importance of confidentiality in the issue of HIV/AIDS.

Divingracia further said that in the clinic, peer educators motivate vulnerable groups (i.e. men

The clinic also has a case management system in place wherein a service delivery network gives patients referral systems when going to hospitals. Eagle Corinthian Integrated Security, Inc. is now the subject of investigation by the PNP Civil Security Group. The CJHDevCo-hired security agency is in violation of sub-para A5 of paragraph 2, Section VIII of Standing Operating Procedure (SOP) No. 007-08 which states: "No PSA [Private Security Agency] shall enter into contract with any client whose property/establishment has an existing conflict of claim, ownership, management or administration of properties/establishment with another party, without written permission from the police that has jurisdiction of the property/ establishment ..

Quita said the uncalled for unauthorized deployment of Eagle Corinthian Integrated Security, Inc. within Camp John Hay demonstrates CJHDevCo's strengthening of its security forces in contravention to intent and spirit of SOP No. 007-08.

# Solons Say BBL can Help Mayor Condemns Attack Cordillera's Pursuit of Regional Autonomy BAGUIO CITY - While the draft BAGUIO CITY - Mayor tance to Galletes who is

**Autonomy** BAGUIO CITY - While the draft Bangsamoro Basic Law(BBL) intends to establish the Bangsamoro political entity with the goal of bringing peace and development in Mindanao, it can also be beneficial to Cordillera's pursuit of regional autonomy.

This was the position of Baguio City congressman Nicasio Aliping Jr. and Ifugao Representative Teodoro Baguilat during the Office of the Presidential Adviser on the Peace Process (OPAPP)- led BBL forum for Baguio media practitioners and bloggers at El Cielito Inn here on Friday.

Aliping said the BBL and Cordillera's pursuit for regional autonomy are similar as both aim to push for progress and development in the area.

If the BBL is passed into law, some of its provisions can be adopted in the draft Cordillera autonomy bill or House Bill 4649 now pending in Congress, the lawmakers said adding that the BBL can be a template to bring in provisions that will be beneficial to Cordillera.

The Cordillera Region is on its third attempt of pursuing a Cordillera autonomous region. The creation of autonomous region in Muslim Mindanao and in the Cordillera is provided for under the 1987 Constitution.

Baguilat, in the same forum, affirmed the support of Cordillera congressmen to BBL for the achievement of peace and bringing in progress in the Bangsamoro region. But he assured that they will be actively participating in the discussions to ensure that BBL will be for the good of the people and country.

He said there is no "railroading" of the BBL in the House of Representatives as it passes through intensive and comprehensive hearing, discussions and debates. At the end of the day, it will be the whole Congress that will decide on it.

Passing BBL within the term of President Benigno Aquino III will be the best time to bring in peace and development in Mindanao because the president himself started the ceasefire with the MILF, Baguilat added.

In the said forum, OPAPP legal team member, Atty. Sittie Amirah Pendatun gave an orientation on the salient points of the BBL and answered questions on BBL issues and concerns.

On June 10, another OPAPP- led BBL forum is set at the Baguio Convention Center./JDP/CCD – PIA CAR

# *City Strengthens Anti-Smoking Campaign*

BAGUIO CITY – the City Government here is slated to amend the Comprehensive Anti-Smoking Ordinance also known as City Ordinance Number 8 series of 2008 to make it more effective in its implementation.

The proposed amendatory ordinance introduced by Councilors Richard Carino, Elmer Datuin and Fred Bagbagen will be known as the "New Comprehensive Anti-Smoking Ordinance of Baguio City."

According to Mayor Mauricio Domogan during the Stakeholders Meeting held Wednesday, the city's Comprehensive Anti-Smoking Ordinance still has loopholes in certain portions of the ordinance such as prohibited acts, designation of smoking areas and definition of public places which need improvement and amendments for its implementation to be effective.

Domogan said, "a stumbling block for the ordinance has been decided in court which said that the definition of a public place was not appropriately indicated in the ordinance, hence the needed

A still unidentified assailant treacherously stabbed Francisco Galletes, a Public Order and Safety Division (POSD) City Mayor's Office in front of a Bakery along Magsaysay Avenue in broad daylight.

"We have to make them answer for what they did to our enforcer who was just doing his job," he said.

Galletes was implementing anti-peddling operations in the city's public market when the incident happened.

The amendatory ordinance presently with the Sangunian Panglungsod Committee on Health and Sanitation, Ecology and Environmental Protection cures this defect by enumerating in detail places where it is prohibited to smoke.

The amendatory ordinance further strengthens Republic Act 9211 or the Tobacco Regulation Act which empowers city and municipal mayors, building officials and the police with the responsibility of ensuring full compliance of the law.

Section 5 of the RA 9211 specifically prohibits Smoking in the following public places; a. Centers of youth activity such as playschools, preparatory schools, el-ementary schools, high schools, colleges and universities, youth hostels, and recreational facilities for persons under eighteen (18) years old; b. Elevator and stairwells; c. Location in which fire hazards are present, including gas stations and storage ar-

tance to Galletes who is presently confined but already in stable condition at the Baguio General hospital and Medical Center (BGHMC)."

Domogan said," POSD personnel will be briefed again on maximum tolerance, buddybuddy system, values during operations and protection of self to avoid a repeat of the incident."

The mayor also said team up with the Baguio City Police Office (BCPO) during operations will also be strengthened to ensure safety of its personnel.

POSD Chief Policarpio Cambod also condemned the stabbing of Galletes but stood firm that anti-peddling operations will continue."

Cambod said, "the incident will not deter his men in implementing anti-peddling operations but instead bolster their resolve to go after lawless elements."/Paul Rillorta

# Solon Says National ID System to Speed Business Transaction

BAGUIO CITY - House Bill No. 5060 or the "Filipino Identification System Act" will speed up government and other official transactions in lieu of other government Identification (ID) cards, so said Baguio Congressman Nicasio Aliping, Jr.

Aliping, co-author of the bill, said that the National ID System aims to integrate all government-issued IDs into one national information card to "streamline government transactions, and help promote a progressive society through an efficient delivery of basic services."

There are many Filipinos who have no official IDs and it is a hindrance in doing official transactions, he said.

The House of Representatives passed said bill on second reading last week and is now up for third reading deliberation.

If the bill becomes a law, all Filipinos residing in the country or abroad, will be required to register their personal information into the national ID system. The ID would be non-transferable and valid for life.

The Philippine Statistics Authority and the Department of Foreign Affairs are the identified implementing agencies under the bill to create and maintain a Filipino Citizen Registry.

George dela Cruz, a laborer, said he welcomes the national ID system because everytime, he transacts business in government or private office, they look for an ID./JDP/JBZ- PIA CAR

# An Asian Francis?

That echoes a March 2015 BBC "Hardtalk" interview of Tagle. Stephen Sackur asked: "There's never been an Asian pope. Your name is mentioned as a serious contender in a future conclave. You could be the first Asian pope. Has that crossed your mind?"

"No, it's a joke. In fact..." Tagle said, but could not finish as BBC interjected: "A lot of people did not raise the possibility as a joke. They think in the future the next pope could come from the global south.

"The holy father comes from Argentina. But me in that position? No, no, I laugh at it," Tagle protested. "That's a creation of some people with imagination. Here, I make a public confession I cannot even manage my life. How can I manage a worldwide community?"

"Well, you do a good line at self-deprecation," BBC noted.

Tagle emphasizes "the need for the church to listen, as much as it talks," Allen notes. "And he exudes a slow burn charisma."

Tagle served earlier as bishop of Imus (Cavite). Writes Allen: He did not own a car, preferring to walk or hop on a jeepney. He invited beggars outside his cathedral to dine with him.

"Many told me that I'm not strong, that I don't condemn enough," Tagle is quoted to have said. "Pope Francis' example helped resolve my doubts. Now I hear him say: 'I'm a son of the church. I know the teachings of the church. But

why should I condemn anyone?"

EDITORIA Tagle opposed the Reproductive Health bill which requires government to make contraceptives available. He was criticized by some for not pushing harder.

"When a bishop threatened President Aquino with excommunication, Tagle did not join the fray. When Catholic activists labeled backers of the law 'Team Patay,' Tagle declined to put attack ad posters in Manila.'

Tagle says he's open to allowing Catholics who divorce, then remarry to receive communion and other sacraments. Marriage is for life, he adds. "But openness comes in pastoral judgements, in concrete situations. No two cases are alike.

Indeed "parroting positions of the hierarchy" is not "thinking with the church, Pope Francis insists. Thus, many on the right says Francis is not 'their man.'" The daily Il Foglio had conservative commentators write: "Why We Don't Like This Pope."

"Francis determined not to use his 'bully pulpit primarily to fight political battles over sexual morality.' He has little patience with the 'smells and bells' of ornate rituals that conjure other worldliness of faith.'

In a Washington Post article, Rachel Held Evans slammed church services "that are nothing but hoopla." Pew Forum on Religion & Public Life reports a quarter of Americans claim no religious affiliation. "When I left church at age 29, full of doubt, I wasn't looking for a better-produced Christianity but an authentic faith," Evans writes.

'We're not as shallow as you might think. You can get coffee anywhere. But the church is the only place you can get ashes smudged on your forehead as a reminder of your mortality. You can be dazzled by bands. But the church is the shared meal that brings us into the presence of God.

"What brought me back, after years of running away, wasn't lattés or skinny jeans, it was the sacraments. Baptism, confession, communion, anointing of the sick-rituals Christians have been practicing for 2,000 years now.

'At the Episcopal Church, every week I find myself, at age 33, kneeling next to a gray-haired lady to my left and a gay couple to my right as I confess my sins and recite the Lord's prayer.

"No one's trying to sell me anything. Church attendance may be dipping," Evans adds. "God can survive the Internet age. After all, He knows a thing or two about resurrection."

Similar convictions "leave the Catholic middle as Francis' main constituency," Allen notes. These are people generally content with Catholic teaching but tend to be generous on how it is applied. They are capable of critical thought without being axiomatically hostile.

'They are hungry for reform but not for revolution. They long for leaders who can lift up the gamut of Catholic life rather than a selective version of church teaching tailored to advance theological or political agendas."

Evangelical Catholicism was the watchword of the St. John Paul II and Benedict XVI eras, Allen observes. "Moderate realism seems to be the new direction under Francis.

"It does not make for sweeping revolutions in doctrine. But at the level of application and tone, it has the potential to shape a very different kind of Catholic church."/Juan L. Mercado

Colliding with China

The Philippines is now on a collision course with China over disputed territories that can be an international flashpoint.

A few days ago, a US spy plane making a "fly-by" over disputed territories in the "Spratly's" was "challenged" over radio by Chinese military and told to "go away". Another commercial airplane flying overhead was similarly challenged. Earlier, Philippine vessels supplying provisions to Filipino soldiers stationed in the area were blockaded. Filipino fishermen were harassed, shooed away and fired upon with water cannons from Chinese vessels. Massive reclamation and building construction by the Chinese is on going with China now telling the world that all territories in the South China Sea, irrespective of whether they are within the "exclusive economic zones" (EEZs) of different countries, are considered Chinese territory.

No doubt, we are now on a "collision course" with China due to territorial disputes in the South China Sea. I have a few basic information that may help for a better understanding of what this is all about. A few days ago, I sat in a forum in Manila with fifteen (15) foreign journalists who were Jefferson Fellows under the auspices of Honolulu-based East-West Center. They were on a study tour principally to listen to some briefings and get information on our territorial dispute with China. With the Philippine Press Institute assisting in the visit, it was a good chance for me to take a good close look at what this territorial dispute is all about. The "claim" with giant China can be a flashpoint of a global crisis, given that other countries like our ally, the United States of America can be drawn into this due to geopolitical implications.

"NINE DASH LINE" — The conflicting claims amongst several neighboring countries over shoals, reefs or just rocks protruding from the sea during high tides had been in the "backburners" for some time now. It was there as a thorny issue but no one was really giving it special attention. Not until China unilaterally released recently a map with lines expanding its territorial borders. It is now what is famously known as "NINE DASH LINE". It draws an imaginary line with a bigger swathe, in effect proclaiming that it exercises sovereignty over a wider area in almost the whole of South China Sea by reason of history. It simply served notice to the whole world that territories found west of the Philippines, even though near other countries all belong to China. To counter this, we started calling it the "West Philippine Sea" instead and filed a case before the United Nations declaring that the new China map is not valid.

- According to University of the Philippines PROF. CHITO TWO AREAS -STA. ROMANA, a former Beijing-based Filipino journalist and an expert on the issue, there are two disputed areas: first, the "Scarborough or Panatag Shoals" in Zambales province. Second, the area down south off Palawan called the "Spratlys or Kalayaan Island Group" where the claim involves other countries like Vietnam, Malaysia, Indonesia, Brunei and Taiwan.

"SCARBOROUGH" -"Scarborough or Panatag Shoals" in Zambales province is only a rock jutting out of the sea. During low tide, some seabed will appear. This was a favorite fishing grounds of local fishermen and named "Bajo de Masinloc", being part of Masinloc municipality. The shoal Cont. on page 7 also served as a place for refuge from giant waves for

The arrest of two (2) LTFRB fixers for Estafa last 25 May 2015 by elements of the CIDG in Baguio, by virtue of warrants issued by the Regional Trial Court in Baguio City supposedly should serve as a lesson or deterrence for other fixers in this agency to stop this pernicious and illegal practice. But bet you, it will not. Fixing has been so rampant and pervasive ever since, it will not see the end of day by mere arrests and prosecutions of a few fixers.

5. In complaints for irregularities of government agencies and personnel file by aggrieved taxpayers, disciplining authorities instead of protecting the interest of the complainant people, would rather side or serve the interest of the bureaucracy thereby cleansing the abuses and anomalies committed therein and setting the culprits free in the process.

### Anti-discrimination Laws Mandated: Human **Rights'** Vigilance



"It is often easier to become outraged by injustice half a world away than by oppression and discrimination half a block from home." Carl T. Rowan

Discrimination happens because of age, disability, race, language, culture, beliefs/religious affiliations, ethnicity, sexual preferences, gender as well as the educational institutions where graduates earned their degrees. According to Dictionary.com, it is a treatment or consideration of, or making a distinction in favor of or against, a person or thing based on the group, class, or category to which that person or thing belongs rather than on individual merit. Without statistical analysis for the emergence of figures to prove their occurrences, we hear multiple accounts encountered by countless individuals which elucidate bias incidents.

The discrimination-related experiences of fellow citizens reverberate for everyone's awareness not to mention multiple accounts of individuals who kept them in long -endured silence. But whether these forms of discrimination are told or not, the bottom line is they are all victims of unjustified prejudice who deserve restitution of citizen's legal rights. Despite the drawbacks of the governments' efforts in finding solutions for these impartiality, some of these discrimination-related problems are being addressed by the country's law-making bodies.

In the government service, the case on job search discrimination isn't much a piercing controversial issue. A republic act governs how applicants are absorbed into the Philippine Civil Service (PSC). According to Republic Act No. 7041, it is an act requiring regular publications of existing vacant positions in government offices. In here, Section 1 stipulates "that it shall be the policy of the government to promote efficiency in the allocation of personnel in the civil service, as well as transparency and equal opportunities in the recruitment and hiring of new personnel." It further specifi-cally points out in its Section 2 that "The duty of all Chief Personnel or Administrative Officers of all branches, subdivisions, instrumentality and agencies of the government, including governmentowned or controlled corporations with original charters, and local government units, to post in three (3) conspicuous places of their offices for a period of ten (10) days a complete list of all existing vacant positions in their respective offices which are authorized to be filled, and to transmit a copy of such list and the corresponding qualification standards to the Civil Service Commission not later than the tenth day of every month." It further explains that "Vacant positions shall not be filled until after publication: provided, however, that vacant unfilled positions that are: primarily confidential; policydetermining; highly technical; coterminous with that of the appointing authority, or limited to the duration of a particular project shall be excluded from the list required under this Law." Furthermore, its Section 3 focuses on publication of vacancies which defines that 'The Chairman and members of the Civil Service Commission shall publish once every quarter a complete list of all the existing vacant positions in the Government throughout the country, including the qualification standards required for each position and, thereafter, certify under oath to the completion of publication." It further reiterates that "The said publication shall be posted by the Chief Personnel or Administrative Officer of all local government units in at least three

those caught during typhoons at sea. However, recently the local fisher folks were shooed away from the area by Chinese vessels using water cannons. During the time of the US bases in the 1990s it was used as a target practice area by the American forces during war drills, being close to the former US bases in Subic and Clark.

Zambales Governor Hermogenes "Jun" Ebdane, a former colleague in the Arroyo cabinet, has recently installed a hi-tech surveillance system with the help of a Canadian company to monitor Chinese intrusions to protect his fisher folks who had been deprived of livelihood.

"SPRATLY'S" Further down south in Palawan are located the Spratly's group of islands scattered with around 50 islands or reefs or areas that appear above water only during low tide. Several Asian countries are "claimants". It was said that in 1947, Filipino Thomas Cloma, an owner of a maritime academy in Manila (thus earning the moniker "Admiral") "discovered" these uninhabited islands and named the island cluster FREEDOMLAND which later became known as "Kalayaan Islands". A cement bust of discoverer Cloma still stands in the area. He "turned over " his rights to the Philippine government in 1974, making them part of Palawan province, being only about 100 miles away from Palawan shores and well within the internationally recognized 200-mile "exclusive zone" economic About 20 (EEZ). years later or in 1995, China started constructing fisherman's structures for Chinese fishermen. Today, China is building what looks like a military installation.

...from page 4 Philippines' territorial claims include five (5)islets, two (2) cays (small islands) and two reefs or a total of nine (9) features or areas. China is claiming seven (7) areas while Vietnam has twentytwo (22). Malaysia, Indonesia, Brunei and Taiwan also have their own claimed islets or areas near their own borders. The different countries' basis for their respective claims is that although these areas are beyond their 12-mile territorial limits, these territories are within their 200 -mile exclusive economic zones (EEZ) from their continental shelf, as recognized by international protocols called United Nations Convention of the Law of the Seas (UNCLOS). Mainland china is geographically far from these areas. But with China's recent officiallyissued 'NINE DASH LINE" map, all these territories claimed by these countries were unilaterally declared as Chinese territory which the Philippines refused to recognize. CHINESE MIS-CHIEFS — In one of our nine (9) claimed

However, there are those who say (like party-list Akbayan leader WALDEN BELLO) that the US will not risk going to war with China just to uphold and protect the Philippine position. The situation can be volatile. The latest report of a US spy plane being challenged by the Chinese military during a "flyby" over the Spratly's a few days ago, is an indication of the US concern and direction it will take. The latest events show that the US will not stand idly by and will challenge China when its intrusions are now clearly becoming an international maritime matter.

the identified recipients will be provided with feeds and technical assistance.

Prior to the distribution, the BFAR, local government unit, and fisheries technicians in municipalities will conduct site validation of the identified beneficiaries to determine if their proposed site for fish production is feasible for rice-fish culture.

Rice-Fish culture is a technology where fish is integrated in the rice paddies and grown simultaneously. Pond preparation is done at least two weeks before the stocking of fingerlings. Fish stocks will then be monitored by the bureau on the first month to determine the growth performance and the daily feeding requirements until harvest.

According to BFAR, production of tilapia and catfishin the province is increasing and is a good sign of aquaculture development. Likewise, the number of registered fisherfolk in the province has increased to 2, 553./BFAR-CAR

# LTO Heeds Cayetano's Call, **Suspends 'No Plate No Travel'**

After a se- its policy. Policy ries of hearings conducted at the Senate, the Land Transportation Office (LTO) finally heeded to the calls of Senate Majority Leader Alan Peter Cayetano and the public to suspend its 'No Plate, No Travel' policy.

"Ako'y natutuwa na nagka-solution ... that LTO met with car dealers, and tried to solve the existing problems," Cayetano said in an interview on the sidelines of the Senate Committee on Public Services and Blue Ribbon Subcommittee's joint investigation on the alleged irregularities in the agency's license plate program.

"Pero kung kinonsulta siguro muna nila ang mga tao bago ipatupad ang polisiya, hindi na sana nangyari itong napakalaking problema, he added

Admitting to the agency's problems as cited by Cayetano, and acknowledging the inconvenience it had brought to the public, LTO officials finally agreed to the senator's proposal to defer the implementation of

Publication Rates are standard as agreed w

Cayetano said he welcomes LTO's decision, but asserted that he will continue monitoring updates on the issue.

"While we commend LTO's suspension of its 'No Plate, No Travel' policy, it does not end here. We know that the DOTC, among other agencies in government, are still riddled with several problems that cause burden to the people. That is why we will continue to guard the public against any governinefficiency," ment Cavtenao said.

The senator earlier blasted the LTO for imposing unjust penalties to car owners and drivers under its 'No Plate, No Travel' policy, while noting that it was in fact the agency's fault that there had been a delay in the issuance of plates for new vehicles.

He also cited LTO's failure to clarify the guidelines of its regulation to law enforcers on the ground, which he feared could have caused confusion and possible abuse of the public.

# BFAR to Disperse 236,000 Fingerlings in Benguet
