310.21 A STATEMENT OF THE PREHISTORIC, HISTORIC, ARCHITECTURAL, AND/OR CULTURAL SIGNIFICANCE OF THE PROPERTY PROPOSED FOR DESIGNATION.

Old Engine Company 11 qualifies for landmark status in the District of Columbia by meeting the following criteria as established in the final rules of the DC Historic Preservation Review Board as published in the DC Register in 1995:

- 1) It is the site of significant events and is associated with persons, groups, and institutions that contributed significantly to the heritage, culture, and development of the National Capital and the Nation;
- 2) It exemplifies significant political, economic, social, scientific, technical, educational, historical, and architectural heritage of the National Capital and the Nation;
- 3) It embodies the distinguishing characteristics of architectural style, a building type, and urban design significant to the appearance and development of the National Capital and the Nation;
- 5) It contains information about and evidence of historic events, institutions, design, construction, and settlement patterns that is known to be important to understanding our culture.

The context and significance for this firehouse is described in the Washington, DC Firehouse Multiple Property Documentation form.

Originally Truck F, renamed Truck Company 6 in 1906, this firehouse received its third name in 1940 when it was combined with Engine Company 11.1

310.21 STATEMENT OF SIGNIFICANCE (Old Engine Company 11 - con't.)

The firehouse helped to establish the tone of Columbia Heights which, developing at the turn-of-the-century, became a neighborhood of elegant rowhouses designed for upper-middle income residents.² It is likely the firehouse was designed by Leon Dessez, the architect credited with designing at least seven Washington firehouses. He designed two others in 1900 - Engine Company 5, 3412 Dent Place, NW, Georgetown and Engine Company 20, 4300 Wisconsin Avenue, NW.

Since the 1982 construction of a new firehouse for Engine Company 11 at 3420 14th Street, N.W., this building has served as a storage center for the Fire Department.



Old Engine Company 11 references Italian Renaissance palazzi. The facade of the firehouse, constructed of blond brick, probably to evoke stone, and ornamented with intricate terra cotta, has a cornice which extends approximately two feet beyond the face of the building. The cornice is supported by four pairs of brackets which are mounted on a frieze of intricate design the center panel of which is inscribed with, "Truck Company F, D.C.F.D." Terra cotta windows surrounds with oversized voussoirs ornament the three second-story windows which have sills supported by small brackets on each end. The end windows are topped by straight lintels while the center window has a curved pediment.

The original apparatus-door openings, which were destroyed during enlargement, were formed of voussoirs arranged as arches. Although dirt has obscured much of the terra cotta detail, the exterior is fully intact. The interior partitions, with the exception of the horsestalls, are also intact. An outbuilding at the rear of the firehouse probably served as a supplementary a stable. The coffered-tin ceiling in the bunkroom is still in place and in good condition. Probably designed to be a free-standing building, it is now attached on the west to a front-porch rowhouse.




