

LONG LIVE THE FILIPINO!!! DENR Reports 211 **Logging Cases Filed** 



BAGUIO CITY - Cutting without permit and transport without permit top the list of illegal logging cases in the Cordillera.

Department of Environment and Natural Resources (DENR-CAR) Forest Management Services (FMS) Regional Technical Director Augusto Lagon reported this during the Regional Peace and Order Council meeting in Tabuk, Kalinga last Monday.

From 1996 to 2010, the DENR had already filed 211 anti-illegal logging related cases all over the region.

According to Lagoon, of the total

cases, 16 have already been resolved, 41 were dismissed, 142 are still on trial while 12 are already archived.

Per provincial breakdown, Benguet recorded the number of cases with 96, followed by Abra with 46, Mountain Province with 33, Ifugao, 18, Apayao has 12 and Kalinga with six cases.

Lagon also reported that in line with DENR Secretary memo dated July 16, 201 directing the immediate donation of all confiscated logs/lumber Cont. on page 10

### PDEA Reports 3 Drug Mule Cases

in CAR

**BAGUIO CITY** The increasing number of Filipinos being caught or sentenced abroad for drug mule or drug courier cases is a pressing problem for the country. This is made more evident with the report of three Filipinos who are set to be executed in China on Monday for being drug mules.

In the Cordillera, there are three from the region who were charged abroad as drug mules. This was reported by Philippine Drug Enforcement Agency (PDEA) Regional Director Edgar Apalla during the Regional Peace and Order Committee (RPOC) meeting held in Tabuk, Kalinga this week.

The first case involved a 61 years old woman, married with five children, who was caught with 1.022 kilograms of high grade shabu in China on July 1, 1993. She was sentenced on June 25 1996 with life imprisonment with two years reprieve. **Plantation** juana cultivator was caught in the act tending his marijuana plants by joint drug operatives at Sitio Mocgao in Badeo, Kibungan,

Benguet last week.

Alfredo Balangen Acdang, 30, single, elementary school graduate, farmer, native and resident of Bito, Mocgao, Badeo, Kibungan, Benguet was arrested by a composite team from the Philippine Drug Enforcement Agency (PDEA) Regional Offices – I and Cordillera Administrative Region (CAR), Regional Anti-illegal Drugs Special Operations Task Group of Police Regional Office - Cordillera, and Philippine Air Force.

Acdang, who is in the list of Drug Personalities both in Region - I and CAR, was with a cohort during the anti-drug operation but the latter was able

to elude arrest.

Anti-narcotic operatives uprooted 120,000 marijuana seedlings and 24,000 full-grown MJ with an overall Dangerous Drugs Board (DDB) value of

land area of 6,000 square meters.

Also seized from Acdang was a small sack of dried marijuana

fruiting tops and leaves ready for conversion into brick form weighing 1,641.50 grams with DDB value of P41,037.50.

Operatives also captured marijuana brick processing paraphernalia including a hydraulic jack, a wooden quadrilateral cylinder,

marijuana brick molder and a weighing scale.

PDEA CAR Regional Director Edgar Apalla said a case for violation of Section 16 (Cultivation of Marijuana), in relation to Section 26e (Conspiracy to Cultivate) of the Dangerous Drugs Act, was filed last February 12 against Acdang and his cohort before the Office of the Provincial Prosecutor in Benguet./PDEA

### P14,400,000.00 from Acdang's two separate plantations with total Mayors to Conduct Physical Inventory and inspection of Police

CITY- All city and municipal mayors were recently ordered by Department of Interior and Local Government Secretary Jesse M Robredo to conduct a physical inventory and inspection of all police officers under their respective jurisdiction using the latest station list of police officers as the reference document.

This is pursuant to Section 64 of Republic Act No. 8511or 'An Act Providing for the Reform and Reorganization of the Philippine National Police

BAGUIO and for other purposes,' which prescribes that local chief executives (LCEs) as deputized agents of National P o l i c e Commission(NAPOLCOM) shall inspect police forces and units, conduct and audit and exercise other functions as may be duly authorized by the Commission.

"In view of the current issues and concerns affecting the PNP, the NAPOLCOM has identified the accounting of all our police officers nationwide as a necessary step that will impress upon in the public's mind that we, who are partners in police administration are serious in our efforts in reforming our police officer," Robredo, who is the Chairman of NAPOLCOM, said in his directive.

### Schizophrenic Puzzle

"Eet es a puzzlement", the King of Siam told Anna the governess," we muttered over morning papers. "What?" the startled wife asked.

That line is from 1956 film "The King and I," we recalled. But this reflects President Benigno Aquino III's waffling on the Freedom of Information bill. He oscillated from "cross-my-heart" support to awshucks back pedaling.

"Malacañang is being cautious about fully supporting FOI", presidential spokesman Edwin Lacierda said. It might be abused. Pnoy wants "a balance between transparency and privacy of confidential government data".

Thus, the FOI bill won't be among 17 priority measures the President will submit to the Legislative-Executive Development Advisory Council Feb. 28.

### **EDITORIAL**

"The liberty of man to search for truth ought not

to be fettered, no matter what orthodoxies he may challenge." Justice Felix Frankurter wrote..."

Corazon and Benigno Aquino Jr stood, without ifs and buts for transparency in government. Did it ever occur to P-Noy that his waffling smudges the" draw-the-sand-line" stance his parents took?

At the Philippine Daily Inquirer's 25th anniversary bash, PNoy recalled that his father lived by that belief "A free media is indispensable if a democracy is to function efficiently, if it is to be real," Noynoy quoted Ninoy. "The people, who are sovereign, must be adequately informed all the time."

Cory Aquino dismantled the Marcos censorship machine and smashed padlocks on the papers and broadcast stations. "The media's power is frail," she said from bitter experience. "Without the people's support, it can be shut off with the ease of turning a light switch".

For 42 days, Corazon Aquino and her family (including the young PNoy) were denied information, by the Marcos dictatorship, on whereabouts of detainees Ninoy and Senator Jose Diokno. Both were choppered, in secret to solitary confinement cells in Laur, Nueva Eciia.

Only after six weeks of anguished search did the Aquino and Diokno families learn the reason for this brutal incarceration, Cory said in an interview with Journalist Miriam Grace Go. From his Fort Bonifacio high-security prison, Ninoy smuggle a detailed paper to the Bangkok Post. He posed, thereby, the first overt challenge to martial law.

We funneled Ninoy's manuscript, thru an Air India executive, to the late Post editor Theh Chongkadikij. But that story is for another day. The point here is: A gagged media never challenged this brutal incarceration of Aquino and Diokno. And that cost is seared into the soul of PNoy.

Is it?

As new president, PNoy vowed to reverse the sabotage of the FOI bill by partisans of Gloria Macapagal Arroyo. In the closing days of the 14th Congress. Prospero Nograles (Davao) Pedro Romualdo (Camiguin) and pro-Arroyo congressmen killed the bill by absenting themselves.

"In doing so, they built another "firewall" for the anticipatednow coming to pass --exposes of sleaze against their patron: Gloria Macapagal Arroyo", this column noted then. "They fractured the Constitutional directive for transparency". The FOI bill would have implemented that mandate."

The day after the Lower House "massacre", PNoy pledged to fast track FOI in the current Congress. Thus, Rep. Lorenzo "Erin" Tanada (4th District, Quezon) predicted early approval of a reintroduced measure. That'd make FOI the "very first legacy" of the 15th Congress under the Aquino III administration," Tanada declared.

In his P1.64 trillion budget for 2011, Aquino stitched in special provisions that require online publication of budgetary allocations and disbursements. The Department of Budget and Management's website now includes data on lump-sum releases made in 2009, congressional allocations in what used to be the graft -laden Public Works department.

To be uploaded are releases from the "pork barrel" (Priority Development Assistance Fund in 2009) and school building fund. These are welcome steps towards transparency --- the first essential step towards accountability.

But "fortune has a fickle heart and a short memory," the Chinese proverb warns. In his first State of the Nation address, PNoy didn't spare a line about retrieving the gutted FOI measure.

"Many of us are puzzled. This (is) an uncharacteristic omission" by the President," fretted Inquirer columnist Cielito Habito, "No one beyond P-Noy's innermost circle seems to know the real reason for the omission. One can only hope it's not an ominous **Cont. on page 7**

Comprehensive earthquake preparedness for Baguio

The recent earthquakes during the past few days are reminders that we must double our efforts in preparing ourselves for the possibility of a major earthquake in Baguio City. On Thursday lunchtime, an intensity 2 earthquake followed up by an intensity 4 earthquake on Friday morning struck Baguio City.

We were taught that an earthquake is usually followed by aftershocks. In the Thursday and Friday earthquakes, however, we have earthquakes of increasing intensities. The increasing intensity of the earthquake is consistent with a build-up of momentum rather than with aftershocks. During the mid-1980s, Baguio has a similar experience of weak earthquakes only to be a followed up by a very strong one on 16 July 1990. Is history repeating itself?

Of course, we should not be afraid because fear and anxiety can certainly cause more harm than the earthquake itself. Nevertheless, we must be prepared for any eventuality and one such possible eventuality is an earthquake similar in magnitude to the 16 July 1990 earthquake.

In the July 1990 earthquake, a number of people survived after several days being under the rubble of destroyed buildings without food and water by drinking their urine and eating tissue papers. If I recall it right, a survivor was able to survive under the rubble of a collapsed building for close to two weeks. One lesson from this event is that survivors can be found even many days after a major earthquake. Of course, another lesson is that survivors can probably increase by stocking up food and water——for the just-in-case-scenarios.

Fortunately, many schools and offices in Baguio City have earthquake drills. However, we need to double check because some of them may have not been conducting any earthquake drill at all. Months ago, some posters have been made available to schools on how one can increase his or her probability of survival during an earthquake. We may have to re-circulate the same materials during this time when earthquakes seem to be more frequent. A number of people claim that four earthquakes occurred from February 17-18 although I felt only one and that was in the morning of February 18.

We must do a lot more. For instance, do we have sufficient rice should a strong earthquake strike? We live in a mountain city and this makes us vulnerable to being isolated from the rest of the world and supplies. How about the other food supplies? LPG? Fuel? Do we have enough stock that would enable us to have supplies even just for a few days should we become isolated?

How about water? Electricity? Maybe we can live for a few days without electricity. But water? Probably not. Do we have contingency plans on this?

How about crowd control? Are the security guards in the malls, like SM, for instance, prepared to manage a crowd that is panicking during an earthquake? Is our city training and briefing the malls and the security guards under the malls' command? Are our police prepared to handle a panicking **Cont. on page 11**





#### Walter William's Journalist's Creed

This creed was written by Walter Williams (1864-1935), the man who founded the world's first school of journalism at the University of Missouri and perhaps contributed more toward the promotion of professional journalism than any other person of his time.

I believe in the profession of Journalism.

I believe that the public journal is a public trust; that all connected with it are, to the full measure of responsibility, trustees for the public; that acceptance of lesser service than the public service is a betrayal of this trust.

I believe that clear thinking, clear statement, accuracy and fairness are fundamental to good journalism.

I believe that a journalist should write only what he holds in his heart to be true. I believe that suppression of the news, for any consideration other than the welfare of society, is indefensible.

I believe that no one should write as a journalist what he would not say as a gentleman; that bribery by one's own pocket book is as much to be avoided as bribery by the pocketbook of another; that individual responsibility may not be escaped by pleading another's instructions or another's dividends.

I believe that advertising, news and editorial columns should alike serve the best interests of readers; that a single standard of helpful truth and cleanness should prevail for all; that supreme test of good journalism is the measure of its public service.

I believe that the journalism which succeeds the best-and best deserves success-fears God and honors man; is stoutly independent; unmoved by pride of opinion or greed of power; constructive, tolerant but never careless, self-con-trolled, patient, always respectful of its readers but always unafraid, is quickly indignant at injustice; is unswayed by the appeal of the privilege or the clamor of the mob; seeks to give every man a chance, and as far as law, an honest wage and recognition of human brotherhood can make it so, an equal chance; is profoundly patriotic while sincerely promoting international good will and cementing world-comradeship, is a journalism of humanity, of and for today's world. /http:// www.nationalpressclub.org.ph

to the Department of Education (DepEd), they have already donated 857 pieces of lumber with a total volume of 11,948 board feet to DepED-CAR, through deed of donation.

Meanwhile, Lagon is calling on larger participation of the local government units and communities relative to President Noynoy Aquino's Executive Order no. 23, declaring a moratorium on cutting and harvesting of timber on natural and residual forests and creation of Anti illegal logging task force.

Lagon is batting that that the Department of Interior and Local Government (DILG) pass a memorandum to all LGU for the enactment of local policy or ordinance on Environment and Natural Resources rules and regulations.

Under EO 23, P-Noy directed the DENR to prohibit itself from issuing logging contracts/agreements in all natural and residual forests. EO 23 also creates the anti-illegal logging task force which will enforce and lead the campaign against illegal logging and who will ensure the implementation of the said EO.

The Task Force will be chaired by the DENR Secretary, with DILG and Department of National Defense secretaries, as well as the Philippine National Police and Armed Forces of the Philippines chief, or their authorized representatives as members.

For the Cordillera RPOC involvement, Lagon stressed the need to deputize Environment and Natural Resources Officers (ENRO) and also for them to call for PNP and Army's more active support on the forest protection and law enforcement of ENR Laws./ Lito Dar/PIA CAR

Apayao adopting the second version in 1998. The Supreme Court, however, ruled that a one-province autonomous region is not legally tenable.

Expressing support for the third push for self-rule were governors Jocel Baac of Kalinga who also chairs the Regional Development Council, Nestor Fongwan of Benguet, Leonard Mayaen of Mt. Province and Eugene Balitang of Ifugao, private sector representative Virgilio Bautista of the Regional Development Council and economic and development regional director Juan Ngalob.

"Ifugao will support autonomy as it was the first to vote for it," Balitang said.

Mayaen noted that autonomy will give the people of Mt. Province the power to decide on how its natural and mineral resources, which remain intact, would be harnessed for its own development.

"We have no choice but to support autonomy or else we would be left out in push for progress," Fongwan said.

Under autonomy, Domogan said that the exploitation, exploration, development, enjoyment and utilization of natural resources found in the Cordillera shall be under the control, permission and supervision of the regional government upon due consultation, except with respect to uranium, coal and petroleum which shall be under the control and supervision of the national government.

In his report to members of the RDC who trooped here for their quarterly meeting, Domogan said the premise of non-diminution of existing benefits and powers has been adopted as one of five principles five principles in the renewed push for autonomy.

The RDC members include regional directors of the national line agencies whose positions were created under Executive Order 220 issued in 1987 by then President Corazon Aquino to create the temporary administrative set-up. These regional offices were mandated to prepare the Cordillera for autonomy.

The four other principles, Domogan said, are on the establishment of the region's permanent identity as such, continuous payment of salaries of national paid officials and employees by the national government, subsidy from the national government and sufficient budgetary allocation to the region to ensure its financial stability and sustenance.

He pointed out that leaders in Bicol recently began clamoring for autonomy to speed up their region's development, even as this chance provided in the national Constitution is limited to the Cordillera and Muslim Mindanao.

Last week, constitutional experts led by former Supreme Court Chief Justice Reynato Puno expressed support for a shift to a federal form of government that, like autonomy, would provide greater powers to local gov-

Puno said the unitary form of government "has stunted the growth of our local government units"./Ramon Dacawi.

Although it does not mean that there is no such disaster-preparedness plan, perhaps the city should consider publishing pointers, including the disaster preparedness plan, on the city's official website.
