2, DPS Compound, Baguio City, about a hundred meters away from Purple Bar, Club & Disco, in a sting operation by the Philippine Drug Enforcement Agency (PDEA) -Cordillera Administrative Region (CAR). He sold one sachet of shabu to a PDEA - CAR agent, who acted as buyer. The illegal drug weighs exactly .31 gram and has a market value of PhP2,697.00.

Moreover, Nider is in the Target List of Drug Personalities in the Cordillera Region; and had been a member of the neutralized, very notorious and long-existing drug group operating in the Cordillera and Ilocos Regions that his older brother led for about three decades until his last capture on November 12 last year likewise by agents of the PDEA – CAR. Another older brother and a nephew were also members of the local drug group.

Nider is 44, single, high school graduate, driver, resident of Minda's Eatery, No. 168 Slaughterhouse (Sto Niño), Baguio City. He is likewise a native of the city.

Baguio City Commemorates 1990 Lawmaker Asks Senate DOH Partners Killer Quake with DRRM drills, for a Full-Blown Inves-**Demo and Inter-Faith Praver**

BAGUIO CITY - The City Government of Baguio spearheaded various disaster risk reduction and management drills, demonstration and other related activities along Burnham Park and Session road Tuesday in line with the observance of National Disaster Consciousness Month (NDCM) and the commemoration of the July 16, 1990 killer earthquake that devastated the city.

Along the Juan De Luna Drive of Burnham Park, short program opened an emergency exposition of Search and Rescue Equipment(SAR), a rescue olympic, poster making contest and a whole day blood-letting activity.

The Office of Civil Defense – Cordillera (OCD-CAR) also launched the Cordillera Regional Disaster Risk Reduction and Management Plan.

In the afternoon, the city government in partnership with the various volunteer emergency groups, conducted simultaneous earthquake drill and evacuation exercise at Session Road.

An inter-faithprayer followed the activity. The winners of the rescue Olympics and poster making contest were also awarded.

Mayor Mauricio Domogan expressed the city's gratitude to the survivors who helped on the search and rescue of trapped people during the July 1990 killer earthquake and offered prayers to those who suffered and perished during the said disaster, the worst that hit Baguio City.

Domogan also reminded the people of Baguio of their own duties and responsibilities on disaster preparedness stressing that disaster comes without prior notice.

He also highlighted the importance of continuing camaraderie and teamwork. as he lauded the various civic groups who are always partnering with the city government. He mentioned the volunteer groups of Philex Mines and Lepanto Mines, who have been vital in rescue operations during the killer quake.

The 7.8 magnitude Luzon killer earthquake struck at around 4:26PM of July 16, 1990. An estimated 1,621 people were killed in the tremblor mostly in Pangasinan, Baguio City and Nueva Ecija./JDP/CCD and Jamene Terceño-PIA CAR

"DOES AN OLD BOYS' CLUB EXISTS?"

A full blown inquiry into the alleged ten billion pesos Priority Development Assistance Fund (PDAF) scam is pushed in the Senate by Senator Chiz Escudero once the 16th Congress opens next week.

Escudero filed Senate Resolution Number 40 (PSRN 40) directing the Blue Ribbon committee to conduct an inquiry into the said scam purportedly involving the Janet Lim-Napoles Group.

The scam was bared in an investigative report which showed how the PDAF collectively known as pork barrel was released to dummy nongovernment organizations through forgery, falsification and bribery.

"Accountability and transparency in government dictates that this report must be guizzically looked into, not only for the representatives of the people to clarify their respective positions, if some may be involved, but to show to every Filipino as well that neither sacred cows nor the notion of an "old boys' club" exists in a government working for change" Escudero explained in his resolution.

The senator, who has always espoused for a transparent and relevant use of PDAF, said the scam is damaging to the country as a whole and besmirching the names of all congressmen and senators in general.

"It has become a painful misconception that the PDAF is a cash allocation given to congressmen and senators with unlimited discretion to disburse and spend with neither constraints nor accountability. But to the contrary, legislators do not handle the funds and implement the projects. Their participation is but limited to the designation of beneficiaries and identification of projects, and the implementation is undertaken by government agencies concerned".

Escudero said the designation of PDAF beneficiaries and how it purportedly mutated into a multi-billion government racket or scam allegedly by the Janet Lim-Napoles (JLN) Group of Companies must be scrutinized and must see an end where legislative and preventive measures are enacted to address this disturbing

"We deserve no less as a people and as a nation, we have to make sure that everyone adheres to the principles of good governance when it comes to public funds. At the same time, we have a responsibility to protect the integrity and reputation of the Senate as an institution and as a pillar of our democracy. This should be non-negotiable" he said.

"Let the sovereign decide after due hearing and investigation whether to hang the Sword of Damocles or not"./

OMB, NBI Penalizing Owners of Establishments Selling Pirated Discs Seeks Passage Of **Local Law**

BAGUIO CITY - The Optical Media Board and the National Bureau of Investigation - Cordillera are set to recommend to the Baguio City Council to enact an ordinance that will penalize owners of malls, stalls and other establishments who will be selling pirated discs in their properties following the raid conducted in the different establishments in the city Thursday last week.

OMB Chairman Ronnie Rickets together with NBI-CAR Regional Director Rogelio Mamauag led a raid with the Baguio City Police Office at the different establishments in the city's central business district where they confiscated pirated DVDs, VCDs and CDs with a market value amounting to at least P8 million.

The joint elements raided establishments along Session Road, at the public market and at the Maharlika Livelihood Center where they hauled more than 70 sacks of pirated discs which are openly sold in public.

The group also had to open several stalls which were closed down when they arrived at the establishments and they even discovered discs which were kept in cabinets and covered with clothes.

In April this year, the same establishments were again visited by the authorities and confiscated P 12 M worth of pirated discs including a duplicating machine used in creating discs. Most of the pirated discs are local and international movies and TV programs, music and music videos, computer games, softwares and in-

After the raid last week, the NBI and OMB decided to ask the city council to pass a local ordinance that will complement Republic Act No. 9239 or the OMB Law and will penalize owners of buildings and establishment renting out the stalls to people selling and producing illegal and pirated discs.

Thru this move, the city would be helping a lot in the fight against piracy in the city and the country as well.

Rickets said that they have raided these establishments for four times already and they have had dialogue with the vendors renting the stalls and every time they are being raided they say that they will not be selling pirated discs but still they are doing it.

This time they will be taking action by preventing sellers of pirated discs to rent spaces in any area

of the city particularly establishments with in the central business district.

The OMB noted that the city of Baguio became one of the producers and sellers of pirated discs since it is the summer capital of the country and tourists are costumer of these discs./ JDP/RC-PIA CAR

DepEd-CAR to **Conduct Massive Regional Literacy Mapping**

BAGUIO CITY -The Department of Education-Cordillera Administrative Region (DepEd-CAR) will conduct massive Regional Literacy Mapping (RLM) to survey all indigenous peoples (IP) and non-IP learners, outof-school youths (OSYs) and adults in all the barangays of the region.

In regional Memorandum No. 76 issued by DepEd-CAR Regional Director Ellen B. Donato, it stated that the RLM is a locally initiated project that aims to support the attainment of the universalization of the Basic Education and the objectives of the Education For All (EFA) and will involve the participation of all barangay officials to assist in the conduct of the mapping.

Other objectives of the activity are: to establish census of all in school learners, OSYs and adults including senior citizen groups, IPs, street children and persons with disabilities to guarantee their enrollment in the formal education or in the Alternative Learning System; to determine appropriate/relevant DepEd programs and projects or alternative delivery modes for the different group of learners and to establish regional repository of data and information needed for policy formulation and preparation of the Regional Educational Development Plan (REDP).

The RLM which will be massively conducted in the months of June to September 2013 in all barangays in the region, will be done by selected formal teachers, ALS mobile teachers and district ALS coordinators.

The literacy mapping will be done every Saturdays, Sundays or holidays or it could also be done after office or class hours.

All DepEd officials who will be involved in the said endeavor shall be given Compensatory Time-Off or Compensatory Overtime Credit for 15 days.

The RLM survey forms were finalized by members of the Regional RLM Technical Working Group that included representatives from DepEd, National Economic and Development Authority, Department of Interior and Local Government, Dept. of Social Welfare and Development, National Commission on Indigenous People, National Statistic Office, state universities and colleges and Philippine Information Agency.

Other members were planning officer/Indigenous Peoples Education (IPED) coordinator of the different schools division offices./JDP/MAWC -PIA CAR

Mayor Says Good Revenue Will Move City Forward

BAGUIO CITY - Mayor Mauricio Domogan laid down plans for the city's priority direction for the next three years to the city's department heads and administrative officers during the Strategic Performance Management System (SPMS) orientation workshop here.

Domogan said, 'the main priority of the city which it cannot do away with is its revenue.

We cannot do a lot of things if we do not have funding, we have to make good in our performance in the revenue programs of the city government,' he said.

The mayor also pointed out the need for the updating of the city's old ordinances to cope up with the present situation. We have to update and look into our old ordinances like the appraisal values of real properties, he said pointing out thelong period in which the city was not able to upgrade the same.

Domogan also tackled on the upgrading of fees collected for sewerage and garbage. He said, 'the city has been collecting twenty pesos a month per household which is already too low.' 'We only collected 18 million for garbage fees in 2012 and yet we are spending more than 100 million for garbage, 'he said. 'There is a lot of challenge that something must be done, ' he said.

Domogan is also pushing for the modernization of the different offices in city hall to be at par with other cities.

'It's about time that we have to computerize the Assessor's Office, the Licensing Office, the Treasury Office and the Accounting Office as a starting point, it must be done, he stressed.

Domogan said, 'If the city has good revenue then it can address social concerns administered by the Social Department like senior citizens, livelihood, youth, values formation and others.

'The peace and order program of the city government is anchored on how much we can continue to augment the budget of the national government for the BCPO to implement a good peace and order program for the city, he

Domogan also said, 'the Health Services Office reported a tremendous increase in dengue cases compared to last year, again we have to increase the amount we should use to address this problem.'

'The tourism programs of the city government rely on how much we can collect to really run an investment program for our city, he said.

Finally, the mayor hopes that he can accomplish a lot in improving the revenue programs of the city for the three year period. We are happy to say the report from our business taxes, the City Treasury Office has already exceeded its revenue estimate for 2013 to the tune of 43 Million, 'Domogan said.

Domogan said, 'the city's revenue estimate for 2013 is 182 Million and last week, it has already collected 228 Million.'/paul rillorta

Balance from significance

The Moro Islamic Liberation Front and the Philippine government signed a wealthsharing formula Saturday. It's another step towards turning swords, in a rebellion that killed and maimed thousands and stalled Mindanao's promise as an island of bounty, into plough-shares. That made the morning papers.

The Supreme Court shredded Eduardo Cojuangco's claim to more slabs of the coconut levy. Government will sell P14 billion worth of stocks and create a trust fund for coconut farmers. "What does it profit a man if he grabs the levy but in the end have the poor piss on his grave?" That hit the evening newscasts.

These reports can obscure other significant accounts that make for balance. Read the United Nations speech delivered last week by a 16-year-old girl who was shot in the head by the Taliban for promoting education for girls.

On Oct. 9, 2012, a Taliban gunman hit Malala Yousafzai as she rode on a school bus, after taking an exam in Pakistan's Swat Valley. Two other students were wounded. Ehsanullah Ehsan, Pakistani Taliban spokesman, claimed responsibility for the attack.

Yousafzai "is the symbol of the infidels," he said, adding that if

she survived, the Taliban would target her again. Since the Malala ambush, the Taliban has attacked more than 800 schools.

"They thought that the bullets would silence us," Malala told young leaders from 100 countries at the UN Youth Assembly last week. "But they failed.... And out of that silence came thousands of voices (seeking) to live in peace, to be treated with dignity... to be educated.

"Nothing changed in my life except this: Weakness, fear and hopelessness died. Strength, power and courage (were) born. I am the same Malala. My ambitions are the same. My hopes are the same. My dreams are the same."

"By targeting Malala, extremists showed what they feared the most: a girl with a book," UN Secretary General Ban Ki-moon told the youth assembly. "Malala is calling on us to keep our promises—invest in young people and put education first."

"She has inspired many millions of people, particularly young people. This world is very young. More than half the global population is young people under the age of 25.... Still, 57 million young people are out of school. When it comes to secondary education, more than 100 million people are out of school. This is not acceptable," Ban Ki-moon added.

This year's "Children Battling To Go To School" report found that nine out of 10 kids don't get a primary school education. They live in low and lower-middle income countries. Girls make up 55 percent of the total. They're often the victims of rape and other sexual violence. "Armed conflict continues to destroy schools and also the hopes of a whole generation of children."

(President Aquino has proposed, in his 2013 budget, that the allocation for education be jacked up 22 percent—from P238.8 billion to P292.7 billion. This could scrub all resource gaps—classrooms, teachers, textbooks and other facilities by next year, the President anticipates. The proposed education budget is the highest allocation given to a government department.)

"Malala Day is not my day," the 16-year-old schoolgirl told the jampacked UN Assembly Hall. "Today is the day of every woman, every boy and every girl who have raised their voice for their rights.

"Thousands have been killed by the terrorists and millions have been injured. I am just one of them... I speak not for myself, but so those without a voice can be heard for their rights to live in peace, to be treated with dignity, to be educated.

"(I do) not seek personal revenge, I am here to speak for the right of education for every child (including) the sons and daughters of the Taliban and all terrorists.... This is the compassion I (learned) from Mohammed, Jesus Christ and Lord Buddha. This the legacy of change I inherited from Martin Luther King, Nelson Mandela and Mohammed Ali Jinnah.

"This is the philosophy of nonviolence that I have learned from Gandhi... Mother Teresa. And this is the forgiveness that I learned from my father and mother. This is what my soul is telling me: Be peaceful and love everyone....We realize the importance of light when we see darkness. We realize the importance of our voice when we are silenced....

"The extremists are afraid of books and pens. The power of education frightens them. They are afraid of women. The power of the voice of women frightens them.

"'Why are the Taliban against education?' a boy in our school was asked by a journalist He answered very simply by pointing to his book, saying: 'A Talib doesn't know what is written inside this book.'

"They think that God is a tiny, little conservative being who would point guns at people's heads just for going to school. These terrorists are misusing the name of Islam for their own personal benefit....

"We call upon all governments to ensure free, compulsory education all over the world for every child. We call upon all to support the expansion of education opportunities for girls. We cannot all succeed when half of us are held back... We must not forget that millions are suffering from poverty, injustice and ignorance. We must not ignore the millions of children who are out of schools. They wait for a bright, peaceful future.

"No one can stop us. We will speak up for our rights and we will bring change with our voice. We believe in the power and the strength of our words. Our words can change the whole world because we are all together....

"To struggle against illiteracy, poverty and terrorism, let us pick up our books and our pens. They are the most powerful weapons. One child, one teacher, one book and one pen can change the world. Education first."/E-mail: juan_mercado77@yahoo.com

IN DEFENSE OF RODY DUTERTE

The accusation by Palace spokesperson ABIGAIL VALTE that the "shoot-to-kill" order of Davao Mayor Rody "Digong" Duterte is 'ILLEGAL' is a knee-jerk, irresponsible statement coming from one whom we expect should be more circumspect, her words being presumed to be those of the Philippine president. Her statement was published on Page 2 of the Manila Bulletin, of yesterday's Sunday issue captioned "DUTERTE'S ORDER IS ILLEGAL.—PALACE"

I have listened closely in many instances when "DIGONG" would spew "fire" and expletives when making public statements. I have always noticed that he makes his statements, although at times bordering on the unconventional, closely hueing within the bounds of law. Case in point: when he makes statements about shooting to kill the criminals, he carefully prefaces his words by saying to the effect that they should be shot if they fight back. Or resist. Or words to that effect.

Don't be overwhelmed by his bluster and "f——king" language. Don't misread him. Go listen closely to his spoken words. He's more astute than you think.

I have known him for a long time. He knows his law. He was one of the city prosecutors in Davao. And was doing a regular radio program on legal aid and legal information in the Cebuano dialect with our Integrated Bar group as a public service program when I was IBP head in Davao.

DESERVE TO DIE—Yes, criminals who will shoot it out with the police are not safe in Davao City. That botched ransom payment where a kidnapped Manila matron was rescued with the death of 3 suspects is a recent example of this. Those armed and prepared to shoot it out with the authorities put their own lives on the line. Physical extinction can be the logical next step. If the suspects are armed to the teeth and are dangerous, policemen are not supposed to wait for the hoods to open fire first before they are mowed down. They deserve to BE SHOT at the first instance. If they die in the process, then so be it.

MURDER? —But wait! Those physically neutralized, like wounded suspects or surrendering need not be shot to finish them off. That's plain and simple murder.

This seems to be the reason why Human Rights Commissioner Etta Rosales, while watching a video of the "high noon shooting" in the Allied Bank incident, exclaimed: "THAT'S MURDER'. The rules of engagement require that those wounded or effectively neutralized or surrendering (with his hands up) should be handled accordingly. And not finished off with a "coup de grace." I am not yet sure what actually happened. I have not seen the footage. So I reserve comments on this for the moment.

SUMMARY EXECUTION — In the same vein, I worry with the resurgence lately of gang-land type of killings. We should not always rejoice if some known criminal is summarily shot and killed, as many seem to now relish and welcome. Only after legal processes are observed should one be made to pay for his crimes. Not by summary executions by some motor-cycle riding, hooded hoods who "play god'!

Lest we all forget, let's apply the rules to others what we want to be applied to us. Meaning, suspects and criminals, even the self-confessed ones, like you and me have rights too. Many of us may be fascinated by summary killings because they bring swift justice. But what if we are the ones on the receiving end? Shall we allow others to do this same swift-justice treatment to us, our relatives or friends and those close to us? I doubt it! Let all, abiding and non-abiding citizens, equally go by the same rules. That's what democracy is all about

9165 (The Comprehensive Dangerous Drugs Act of 2002), specifically illegal sale of Dangerous Drugs, will be filed in court against Nider.

This is actually the fifth time that Nider was apprehended. He was first collared with one Jimmy Tong y Belen for Violations of Sections 5 (Sale of Dangerous Drugs) and 11 (Possession of Dangerous Drugs) of RA 9165 on April 15, 2003 at Quirino Highway (formerly Naguilian Rd.), Baguio City by members of the Criminal Investigation & Detection Group – CAR. The duo was nabbed with .06 gram of shabu. Sadly, they were acquitted of the criminal cases filed against them at the Baguio City Drug Court on May 10, 2005.

On August 21, 2005, or a little over three months after his acquittal, Nider was again arrested for drug law violations at San Carlos Heights, Irisan, Baguio City. He was busted then with another cohort, a certain Dolores Dakin, by PDEA – CAR's anti-drug operatives, where nearly half a gram of shabu was confiscated from them. Unfortunately, the cases against the two were dismissed at the prosecution level on September 27, 2005.

Nearly two years later, on March 6, 2007, Nider was apprehended once more at Carnelia Alley, QM, Baguio City by law enforcers of PDEA – CAR. He was then with another cohort named as Renato Busoy y Esquerdo. Nearly a gram of shabu was seized from the duo. A case for Violations of Section 11, Section 12 (Possession of Paraphernalia for Dangerous Drugs) and Section 15 (Use of Dangerous Drugs) of RA 9165 was successfully filed in court. Yet again, the respondents were acquitted on January 8, 2008.

More than a year and two months later in a buy-bust operation by PDEA – CAR drug law enforcement officers, on March 24, 2009, Nider and half-Dutch cohort, Frits Besselink y Batnag, were collared with five sachets of shabu at Rimando Rd., ABCR (Andres Bonifacio-Caguioa-Rimando), Baguio City. But both accused were acquitted of their grave offenses on January 10, 2011.

Allan Nider's older brother, Arthur, who had led the Nider Drug Group, was cornered at Irisan, Baguio City on November 12, 2012 by PDEA – CAR's drug law enforcement agents, ending the drug dealings top dog's haunting of the City of Baguio with his notoriety, especially on illegal drugs, villainies and womanizing, for more or less 30, long years.

Meanwhile, Allan's nephew, Joel Nider y De Dios, also a regional top priority target, was nabbed by PDEA – CAR agents last June 12 after he and a cohort-lover sold .05 gram of shabu at City Camp Alley, City Camp Proper, Baguio City.

Joel's dad, Albert, another older brother of Allan, was arrested in 1997 during the time of the Philippine National Police Narcotics Group and consequently convicted under the old drug law, RA 6425 (The Dangerous Drugs Act of 1972). After meeting his brief term in Muntinlupa, he came back home right away to Baguio City and resumed his illegal drug business until his death in 2012.

Just like Albert, his brothers, Arthur and Allan, and his son, Joel, had been in the drug target list, and regarded as repeat offender, hardened drug personalities./ Emely Fama (PDEA-CAR)
