

Listahang Tubig Project

Pushed BAGUIO CITY - Mayor Mauricio Domogan last week has designated the

City Planning and Development Office (CPDO) to head in the implementation of Listahang Tubig project to be assisted by the City Health Office (CHO) through Administrative Order No. 016, series of 2015.

Listahang Tubig is a national survey of all water service providers covering all service levels - Level I or point source, Level II or communal faucets, and Level III or piped connections. The data that can be collected from the survey can be used to increase access to improved drinking water supply, particularly the poor, improve the performance of water utilities, and also improve regulation of water resources in the country.

It is recalled that a Memorandum of Agreement (MOA) between the National Water Resources Board, Department of the Interior and Local Government and Local Water Utilities Administration was signed on October 29, 2014 together with the respective Memorandum Circulars (MCs) of these national government agencies cooperating to complete a national survey of all water service providers in the country. The National Economic and Development Authority is providing policy directions for this initiative.

In the order, it is the function of the CPDO to reproduce, distribute and collect the Listahang Tubig survey form to all the water service providers of level I, II, III operating in the city, and to encode the data gathered in the Listahang Tubig website.

While the CHO will assist the CPDO in the distribution and collection of the survey forms and submit the same to CPDO for encoding in the website.

Accordingly, the data gathered in the survey under Listahang Tubig project of the DILG, National Water Resource Board and Local Water Utilities Administration will be useful to the city as an instrument in planning on how to reach barangays to improve the delivery of water supply services.

Improving water management practices is a key to delivering and sustaining better water services in all LGUs, stressed the mayor. /Jho Arranz

City Strengthens ARTA

BAGUIO CITY - The Republic Act 9485, otherwise known as the Anti-Red Tape Act (Arta) of 2007 has been in effect since September 5, 2008 following the issuance of the Implementing Rules and Regulations (IRR) by the Civil Service Commission. It provides that all government agencies including departments, bureaus, offices, instrumentalities, or government-owned and or controlled corporations, or local government or district units shall set up their respective standards to be known as the Citizen's Charter within one year after the effectivity of said law.

Said act aims to promote efficiency and transparency in government with regard to the manner of transacting with the public by requiring each agency to simplify frontline service procedures, formulate ser-

City Reminds Motorists of 'King of the Road' Ordinance

BAGUIO CITY – stakeholders here are once again clamouring for the strict implementation of the city's King of the Road Ordinance to discipline driver's and prevent vehicular accidents.

The ordinance requires motorists to slow down when approaching a pedestrian lane and fully stop for 5 seconds in all pedestrian crossings within the city.

The ordinance is yet to see full implementation given the fact that the Traffic Management Unit lacks augmentation personnel to man all the pedestrian lanes.

Signages of the ordinance are in place and augmentation forces which includes police interns are already manning different choke points in the city.

Volunteers were also tapped to help in directing traffic especially during weekends and big city events.

Mayor Mauricio Domogan during the Weekly Ugnayan Presser said, "there is a continuing order for the Baguio City Police Office (BCPO) to man the different crossings of the city especially in crowded and problematic areas.

This he said includes areas where frequent accidents are recorded.

"We have asked the Department of Public Works and Highways (DPWH) to cut savings from the pedestrian overpass being constructed by removing the planned elevator, hopefully the money saved can be appropriated for another overpass or underpass fronting Saint Louis University," Domogan said.

The mayor again reminded driver's to follow traffic rules and regulations, speed limits and observe utmost care when driving a motor vehicle.

"This also applies to pedestrians, they should also use designated pedestrian lanes when crossing and driver's should yield to pedestrians," he

As per Ordinance No. 7 series of 1984 or the Comprehensive Transportation and Traffic Ordinance of the City of Baguio, it is unlawful for any person to drive in a built up area at a speed exceeding 30 kilometers per hour.

Domogan said, "following the speed limit will not only reduce the number of vehicular accidents but will serve to discipline reckless drivers."

A recent incident of over speeding and careless driving caused the death of a student in the city last month. /Paul Rillorta

De Guia Honored

BAGUIO CITY – City officials paid tribute to the late lady stalwart Virgina Oteyza-De Guia, the city's first woman councilor, vice mayor and acting city mayor, who passed away last Feb. 9 at the age of 98.

In necrological rites held last Monday at the City Hall, Mayor Mauricio Domogan said, "No spoken word would be enough to eulogize (De Guia)," a "noble and extraordinary woman" who "lived a full life" with her "stellar performance in public service" and in many other fronts.

He said De Guia lived her "Baguio Ko, Mahal Ko" motto to the hilt and to the very end of her life. In 2013, De Guia led her brood in donating a 95-hectare land to the city government for maintenance as a forest and research area.

"We are forever grateful to her and may we draw lessons and inspiration from her social spirit and motherly concern," the mayor said.

Former city councilor Edilberto Tenefrancia referred to De Guia as a partner in Team Baguio.

"If she had regrets, it would be that she was two years short to a century of service to God, country and her city," he said.

He said De Guia, along with her departed friends, media matriarch Cecile Afable and writer Leonora San Agustin, should be called "switches" rather than "witches" in reference to the trio's moniker, "The Three Witches of Baguio."

"Switches because when these three were switched on, they were dynamic sources of ideas and activism. Whether you agree with them or not, they make Baguio turn around with their imagination and creativity," Tenefrancia said.

Tenefrancia said that of all the roles that De Guia played, her best would be her being a mother to her brood: internationally renowned artist Eric a.k.a. Kidlat Tahimik who shares her mother's love for the arts, Virginia and Patricia. Her other son Victor Jr., was among the 23 other Filipino scouts who perished in a plane crash at the Sea of Bombay in India while on their way to the 11th Boy Scouts World Jamboree in Marathon, Greece in 1963.

Her brother, Joaquin Bogayong confirmed that De Guia was a calm and loving person whose "obsession was to introduce change to her beloved Baguio."

Granddaughter Anna Ericksson said, "Lola's life is a lesson in being a woman, in every sense of the word. She showed me that a woman could

No Trade Fair, Only Baguio **Blooms Extension – Mayor**

BAGUIO CITY - Mayor Feb. 17 to March 8. Domogan Mauricio Wednesday clarified that he sanctioned the extension of the Baguio Blooms at Burnham Park to accommodate more stalls for the Panagbenga activity but not the conduct of a trade fair in the area.

The mayor returned unsigned and with a notation a city council resolution allowing two groups to conduct "bazaar activities" in connection with the Panagbenga activities but apparently independent from the Baguio Flower Festival Foundation Inc.-sanctioned Baguio Blooms, along Juan Luna Drive at the park.

In his marginal note, the mayor pointed out that he did not agree to a trade fair but only to the extension of the Baguio Blooms subject to the terms and conditions set for the event by the Baguio Festival Foundation Inc.

He said this means that those who will avail of the additional spaces will have to apply for registration with the BFFI Baguio Blooms committee and will be subject to the same rules being applied to the present Baguio Blooms concessionaires.

They also have to operate under the BFFI and not under any private individual or organization, the mayor stressed.

The city council last Monday allowed two groups -Pilipinas Realty Management Corporation and Shining Star - to share the Juan Luna space for the conduct of bazaar activities in line with the Panagbenga celebration from

In giving the go signal, the body put in as conditions that the groups will be under the supervision of city treasurer Alicia Onoza, the designated chair of the Baguio Blooms activity and that they will be subject to the same terms and conditions as those required in the Panagbenga event as per the administrative order of the

Earlier, the council committee on market under Councilor Elaine Sembrano, expressed reservations on allowing the applicants saying it may be improper considering that the Baguio Blooms exhibition is already underway. The committee was also wary that it may cause further obstructions in the area and may be in violation of the city's trade fair ordinance.

Last Thursday, the tents were put up in the area raising opposition from the Baguio Blooms concessionaires wary of competition and from BFFI head Anthony De Leon who said this did not pass through BFFI screening and thus cannot be considered part of the official Panagbenga activity.

Vice Mayor Edison Bilog assured however that the proceeds of the bazaar will also to go to BFFI.

Under the city's trade fair ordinance, no such activity is allowed anywhere in the city at

Domogan said that the only exception is the Baguio Blooms being an institutionalized activity of the Panagbenga, the city's biggest official tourism event./ A Refuerzo

Mayor: No Winner in John Hay Arbitration Case; City Biggest Loser

BAGUIO CITY - Not one of the two parties can claim victory in the decision rendered by the arbitral court on the Bases Conversion Development Authority (BCDA) and the Camp John Hay Development Corporation (CJHDevCo) case and the city government stands to be the biggest loser with the looming non-collection of its supposed share from the lease of the former military reservation.

Thus declared Mayor Mauricio Domogan in his Ugnayang Panlungsod press briefing last Wednesday where he said that the ruling was an upset for both the BCDA and the CJHDevCo and moreso for the city government.

In the ruling dated February 11, the Philippine Dispute Resolution Center Inc., finding "mutual breach" of the agreement by both parties, rescinded the original and derivative lease agreements and ordered the CJHDevCo to cede the leased premises to BCDA while in turn directing the BCDA to return to the CJHDevCo the rental payments it made totaling P1,421,096,052 and further cleared CJHDevCo from its liability to pay its arrears amounting to P3.3 bil-

But according to the mayor, the city suffered the biggest blow as it may now be totally deprived of its 25 percent share from the lease rentals which it had demanded for so long and which it could have used to fund priority projects.

The mayor however said that the city will not give up and will watch out for post-decision developments so it can accordingly to assert its rights Cont. on page 8

BCDA-JHMC Told to Stop **Barring Gov't Projects in** John Hay Barangays

BAGUIO CITY - The Bases Conversion Development Authority (BCDA) and the John Hay Management Corporation (JHMC) should refrain from barring the implementation of government projects as well as the entry of construction materials in the barangays located within the Camp John Hay.

The city council pushed thus in a resolution adopted after heads of the barangays complained against the BCDA-JHMC's restrictions that have affected even the development programs of their communities.

The punong barangays complained on the harsh treatment they are receiving from the BCDA-JHMC including their security force which maintained their intimidating presence despite previous appeals by the residents

They bemoaned the BCDA-JHMC's irrational restrictions on the entry of construction materials and even the implementation of the infrastructure projects programmed for the barangays even if these were justified.

Councilor Betty Lourdes Tabanda said BCDA and JHMC should not restrict these projects especially if these were legitimate.

The body in another resolution moved by Councilor Faustino Olowan requested mayor Mauricio Domogan to immediately act with dispatch on the complaints of the punong barangays and to reiterate that the BCDA-JHMC comply with the 19 conditionalities set under Resolution Numbered 362, series of 1994 which include the segregation of all the 13

Council Sets Inquiry on Second Phase of **Athletic Bowl Rehab**

BAGUIO CITY - The city council will scrutinize the second phase of the Baguio Athletic Bowl rehabilitation with the representatives from concerned agencies and offices who were invited in the august body's session tomorrow, (Feb. 23).

The body summoned representatives from the Office of Rep. Nicasio Aliping Jr., the Dept. of Public Works and Highways Cordillera (DPWH-CAR), the contracting company, the city environment and parks management office, the general services office, city engineering office and the city building and architecture office to shed light on the project.

The inquiry stemmed from Councilor Peter Fianza's proposed resolution asking the DPWH-CAR to review with the city the phase 2 plan on the improvement of the facility which was planned for implementation after the Panagbenga celebra-

Fianza said he learned that an additional P50 million has been allocated from the DPWH 2015 general appropriations act for the second phase of the work which accordingly will include an additional span of bleachers in the newly rehabilitated grandstand, comfort rooms, offices and a rubberized track oval.

"The improvement of the Athletic Bowl is definitely a long and most awaited development in the city (but) with what was seen however in the implementation of the initial phase (of the work), primarily in the rehabilitation of the grandstand, there is a need for the city to fully apprise itself with the remaining program of (work) and as much as possible, take part in its design and in the implementation of the same," Fianza said.

Fianza also asked the agency to consider reprogramming certain items of work in the plan like the construction of the additional bleachers which will necessitate the cutting of two fully grown agojo trees which even if maintained, will be obstructive to viewers seated in said additional bleachers.

'Instead of the additional bleachers, the area may perhaps be landscaped and considered for the construction of a rain collection facility and a lounging area, Fianza said./A Refuerzo

Prelate: 'Fallen 44 Point to Peace'

If they should be remembered for one thing, the SAF44 should bring to mind the urgency of finding better ways to peace in Mindanao, said a prelate during a Mass celebrated in memory of the forty-four members of the Philippine National Police-Special Action Force (PNP-SAF) who were killed in a clash with rebel groups in Mamasapano, Maguindanao on Jan. 25.

"The heroes of Mamasapano may be gone before the eyes of this world, but their legacy of courage remains in our hearts and minds in order to inspire us and make us build communities founded in love, in unity and in mutual respect," said Palo Archbishop John Du during a requiem Mass for three of the 44 fallen police officers held recently at the Regional Office of the PNP in Camp Ruperto Kangleon.

EDITORIAL mast at the Halls of Justice

Flags are flown at halfacross the country, such as

at the Regional Trial Court in Tacloban City, to honor the PNP-SAF members recently killed in a clash with the MILF and BIFF.

Right to live without fear

"[Their death is a] signal for all of us to find more effective ways to peace, and to defend with more eagerness our right to live without fear," he noted.

According to the prelate, "the Heroes of Mamasapano have fallen like that precious 'grain of wheat' Jesus speaks of."

He added: "The 44 members of the Philippine National Police Special Action Force are honored by the whole country because of their courage. And their courage has made them face even the fear of dying any moment during that night because they believed that courage was all they had in order to stand for the greater good they wanted to serve."

Although all the fallen cops were hailed by the Filipinos as heroes, Du agreed with Col. Danilo Pamonag of the Philippine Army's public address, that the men and women in uniform, the Filipino soldiers, the policemen and policewomen, "don't claim to be fearless", but that they "can only stand courageous."

Commended to God

"We are mourning the death of modern-day 'heroes'. And heroes are not fearless people. Although courageous, heroes are men or women who also have a fear of one thing. Heroes fear they might not be giving enough even if it is already their best," the prelate explained.

Du also called on the faithful to commend to God the souls of the policemen who died in said tragic incident in Mamasapano. Finally, the prelate in consoling the bereaved loved ones of the dead SAF members uttered these Biblical words: "The hour has

come for our brothers to leave this life. They have done their best in the race, they have run the full distance, and they have kept the faith." (Eileen Nazareno-Ballesteros/CBCPNews)

MORE INFO DISCLOSED ON WHO IS LIABLE FOR MURDER OF SAF

44: As the days are passing by since January 25, 2015, the day that 44 officers and men of the Special Action Force were slaughtered and murdered by the Moro Islamic Liberation Front and the Bangsamoro Islamic Freedom Fighters, it is becoming increasingly clear that there was no other official who should be blamed for this deadly operation to kill terrorist Zulkifli bin Hir or Marwan.

From bits and pieces of information that are now surfacing from many quarters, it is clear that the Mamasapano, Maguindanao SAF operation involved big contingents—392 or so police officers and men in all—from the Philippine National Police, which only a very high official-higher than excluded OIC PNP chief Gen. Resolution Nr. 115, S. of 2014: Revisited (Part 2)

In part 1 of this article, this writer delved on the reason for saying that Resolution Nr. 115, S. of 2014 passed by the City Council was without factual basis. The principal reasons being that there is an ordinance in the city, Ordinance 7-84 or the Comprehensive Transportation and Traffic Ordinance of Baguio City and there are franchises issued by the LTFRB authorizing the inter-municipality jeepneys to operate inside the city. On this basis, the City Council cannot just prohibit these jeepneys from picking up passengers on intra-city routes by mere Resolution.

In this part 2, it will be shown that such prohibition to pick up passengers within the city routes commonly authorized with intra-city jeepneys has no legal moorings to stand on, so to speak.

Firstly, as grantees of franchises or Certificates of Public Convenience (CPCs) by the LTFRB, the only government agency authorized by law to issue, modify and/or revoke these CPCs, they have rights as well as obligations to pick up passengers on these routes. To deny them these rights is a violation not only of their franchises, the essence of which is the freedom to serve the public and earn a living as an offshoot of their investment, but also it is a violation of Section 1, Article III of the Bill of Rights of our Constitution which provides:

"Section 1. No person shall be deprived of life, liberty, or property without due process of law, nor shall any person be denied the equal protection of the laws."

Secondly, the fact that Resolution (purporting to be an ordinance) was allegedly done as an exercise of police power under the "general welfare clause" of the Local Government Code does not make its passage valid. In the case of "White Light Corp., et. al. vs City of Manila, Jan. 20, 2009, the Supreme Court held that an ordinance to be valid, it must conform to the following requirements:

- (1) must not contravene the Constitution or any statute;
 - (2) must not be unfair or oppressive;
 - (3) must not be partial or discriminatory;
 - (4) must not prohibit but may regulate trade;
- (5) must be general and consistent with public policy; and
 - (6) must not be unreasonable

Obviously, the Resolution (purporting to be ordinance) does not even approximate the above requirements.

Thirdly, as an exercise of Police Power allegedly, the Resolution does not pass the requirements set forth by the Supreme Court in Restituto Ynot vs. Intermediate Appellate Court, Et. Al., March 20, 1987, which are:

- The interest of the public, not mere particular class require the exercise of police power.
- The means employed is reasonably necessary for the accomplishment of the purpose and not unduly oppressive to individuals.

Sad to note in Resolution Nr. 115, the interest of the intra-city jeepney operators was made primordial over the interest of the commuting public and was prejudicial to other class of operators. As stated clearly in the Resolution, its purpose is to increase the daily income of the intra-city operators irregardless of the consequence to the prejudiced inter-municipality operators and the riding public deprived of timely service. Other than the mandated prohibition to pick up passengers through a resolution, there are other means less intrusive to the pub-

World Events Enliven Fictional Characters

"Each age tries to form its own conception of the past. Each age writes the history of the past anew with reference to the conditions uppermost in its own time." - Frederick Jackson Turner

In the literary world, the likes of Icarus, Faustus and Ozymandias are symbols of human powers' declines. Just like streams of interspersing dreams, human powers emerged and within a split of seconds, they obscurely disappear. They occur because time creates constant changes where the empowered occupy deceiving dais expect that their exalted stages will remain elevated as long as they desire.

But time must have been indiscriminately tired by all masquerading masters' dramatic interludes of inflicted woes to the masses. Evolving time must have awakened and dictated humanity's consciousness through the unending deafening cries of the oppressed innocent who knew nothing but embrace the tranquil gifts of splendid human lives.

As a silent witness to gruesome human deeds, time has mourned a lot to unfold the return of literary characters' dooms in an arena where the offended can no longer withstand oppressions. Time has found the right moment of enlightenment to unleash uprisings as decisive solutions of survival in a planet battered by consecutive atrocities.

As consequences, political conflicts chronicled by metamorphosing history continue to ensue reaching almost a quarter of the 21st century exposing clashes from different countries whose crucial objectives are to achieve transformations, they have long- waited.

The ongoing sieges like the Syrian Civil War, the uprisings in Ukraine and its conflict to Russia, the clashes in Venezuela, and Thailand citizens' protest foreshadow downfalls of unwanted leaders as results of revolutionary acts that manifest conjoint and significant visionary patterns.

It can be recalled that time has yielded series of fallen leaders in different tactics even during the beginning of the present century.

In 2000, Serbia protest erupted in Belgrade causing the downfall of Slobodan Milosevic who was transferred at the United Nation Crimes Tribunal who death came earlier while awaiting trial in 2006.

In 2003, an alliance maneuvered by the U.S. and U.K. attacked Iraq to overthrow Hussein. Saddam's Ba'ath group was disposed and elections followed. After his detention on December 2003, trial took place under the Iraqi provisional government and on November 5, 2006, Saddam was convicted of charges connected to the 1982 killing of Iraqi Shi'ites. He was sentenced to death by hanging on December 30, 2006.

Also in 2003, former President Edward Shevardnadze of Georgia resigned during the Rose Revolution after oppositions apprehended the parliament over wangled elections.

By 2005, President Azkar Akayev of Kyrgyzstan was dethroned and fled to seek refuge in Russia after thousands of protesters attacked the country's main administration building in the capital, Bishkels during the Tulip Revolution.

Other leaders followed to fall. Hosni Mubarak, Egypt's longtime Cont. on page 9

From a house full

of stories of paranormal haunts, the Laperal White House along Leonard Wood Road is now gaining popularity as an art gallery.

On Monday, February 23, Philippine Bamboo Foundation Incorporated (PBFI) President Edgar Manda, Tan Yan Kee Foundation representative Leo Pugal, City Mayor Mauricio Domogan, Congressman Nicasio Aliping and Bishop Carlito Cenzon of the Diocese of Baguio-Benguet will lead the opening of art exhibit inside the famous 'White House' which now serves as the Bamboo Museum in this Summer Capital of the country.

The exhibit includes bamboo wood carvings, arts, portraits and religious icons, among others. There is also a Bambusetum, bamboo plant garden beside the White House which can serve as an eco-tour and a bamboo propagation hands-on workshop area.

The strategically located White House built by the Laperal family in 1920, is now owned by Tan Yan Kee Foundation of the Lucio Tan Group of Companies. The 'haunted' house was first transformed into an art gallery in 2013 with the Ifugao Bamboo Carving exhibit by the PBFI.

Manda disclosed that in partnership with the city government, they are hoping to promote public awareness on the benefits of bamboo and to encourage the propagation of more bamboo forests that will help in bringing in ecological balance, economic gains from trade and new lumber materials, among others.

"By promoting bamboo as an alternate lumber, we can help offset the loss of trees and reduce air pollution in the city as the project will embark on creating pocket bamboo gardens around the city, starting at the City Hall grounds", Manda said.

This new project is also designed to help soil erosion and landslides in the area since spread of bamboo roots stitch the soil and hold the ground together. A new bamboo forest will grow for only

c) establishment and regulation of bus and vehicle stops and terminals;

d) regulate the operations of conveyances for hire (and this include the authority to re-route)

Definitely, to modify the condition of the franchises issued by LTFRB is not one of the powers of the City Council.

Darby, binenta niya sa Alphaland ang interes niya at 12,000 per share, 100 percent ang binili. Binigay ang five percent kay Mr. Oreta, nilagay niya sa Noble Care, pero ang binayad niya lang ay P20 per share. Later on, a few years later, binalik niya, kinuha niya ang Alphaland share at P10 per share. Pero ang halaga na nito ay P60 per share. based on the 19 conditionalities it set on the Camp John Hay development once the decision becomes final.

BCDA had sought the payment of CJHDevCo's arrears and botched negotiations between the two parties led to the arbitration by the courts.

The mayor also took exception from the BCDA's claims that the city did not do its part to help in the efforts to collect the unpaid rentals.

"Records would bear us out that we were not negligent and we tried our best to reach out to both the BCDA and the CJHDevCo even before they decided on the arbitration. We sought them out and tried to convince them to settle the conflict amicably but they refused," the mayor said.

In 2012, Domogan on a number of occasions tried to broker a diplomatic settlement for the two parties urging them to sit down and negotiate out-of-court. He suggested that the two, based on the terms of the contracts they have entered, evaluate and determine the obligations that each failed to deliver, quantify in monetary value and compensate each other under a compromise agreement.

"Sana kung nakinig sila, hindi sana nagresulta sa ganito," he bemoaned. The city stands to collect 25 percent share of the arrears being collected pursuant to the conditionalities under Resolution No. 362, series of 1994.

The original agreement pegged the lease rental at P425 million annually for the first five years starting in 1996 and P150 million annually thereafter and the city's share from the rental was supposed to be 25 percent or P106 million for the first five years and P35,500,000 for the succeeding years. "The late Virginia "Gene" Oteyza-De Guia was born on 26 December 1916 in Baguio City to spouses Mauricio Oteyza and Dolores Sta. Maria. She graduated with honors from the Baguio Central School and at the Mt. Province High School. She earned her Bachelors degrees in Philosophy and Laws and a Master of Arts in Public Administration from the University of the Philippines. During her college days, she was awarded the UP Model Code in 1938 during the National Girls' Week and was also an intercollegiate tennis champion in 1935;

"She made her mark in the political arena of Baguio City as the first lady Councilor and appointed as the first lady City Vice-Mayor and Acting City Mayor by then President Manuel A. Roxas in 1946;

'She was one of the prominent figures in the tourism development and culture. She was a tourism booster, having created the Baguio Visitors and Vacation Bureau that focused on developing active programs in the promotion of the city as a tourism capital of the North. Her vast collections of Igorot articrafts and her love for the preservation of the Igorot culture were the first steps to the establishment of the Baguio-Mt. Province Museum. She also initiated the construction of authentic tribal homes at the Museum of Igorot Architecture, now the Baguio Botanical Garden;

"She advocated for a sustainable development and participated actively in the workshops for the formulation of the City Development Plan and the Land Use Plan and one of the convenors of the environmental group "Alay sa Kalinisan;"

She believed in the significance of scouting to the lives of the young people and their role in society. She was instrumental in the establishment of "Ang Ating Tahanan", a venue for the scouting movement which she embraced to her heart, with husband Engr. Victor de Guia Sr.;

"In March 2009, she was awarded as one of the Outstanding Centennial Women Leaders of the city in the field of public service during the Women's Month. She was also among the personalities inscribed in the book Builders of Baguio, a tribute to the early men and women who made their mark in the transformation of the city from an idvllic mountain resort to a vibrant community.

"Prior to her political career and unknown to many, Virginia "Gene" Oteyza-De Guia had a cinematic experience when she appeared in the movie "Nagkaisang Landas" in 1939 using the screen name Lydia Leynes;

"The late Virginia "Gene" Oteyza-De Guia was an epitome of a woman empowered, a catalyst, an environmental advocate, a sensible critic, a social activist, stalwart, curator and a tender mother to her own children and the people of Baguio City."/A Refuerzo

There is an accu-7606.33 mulated board feet (or 30.96 cubic meters) of sawn lumber with 180 edgings; while 4.938.83 board feet of lumber with 109.34 cubic meters of firewood and landscape materials and 80 pieces of edgings remain.

Some of the forest products are stored at the Diplomat Heritage Hill compound, including 35 pieces of rustic furniture crafted from the trees.

leader was sentenced to life in prison for being charged of complicity or collaboration in the killing of protesters against his administration.

Zine El -Abidene Ben Ali of Tunisia fled to Saudi Arabia in January 2011 after uprisings that sparked the Arab Spring Revolution. He was tried in Absentia by a Tunisian court.

Muammar Gaddafi of Libya who governed Libya for 42 years fled to his hometown, Sirte after the revolutionary group captured the Capital. He was murdered by a protesting mob in October 2011.

Ali Abdullah Saleh of Yemen has taken power for nearly a year but with the public outcry in his country, he was forced to turn over his administration to another chosen leader.

With these historical events before the world's populace, allusions of Icarus from Greek mythology whose high -flying technique for freedom brought his downfall reemerged.

Another is Ozymandias by England's Percy Bysshe Shelley who described in his poem, that a king's rule has finally ended and the wrath of the populace he once governed were expressed through the destruction of a king's once- adored effigy in protest against his dictatorship.

Thirdly, among these characters is Christopher Marlowe's Faustus. Marlowe's play featured a man called Dr. Faustus who sold his soul to the devil in exchange for knowledge and for abusive powers which led to his entire devasta-

All these characters were brought to life becoming symbolically significant in bringing pictures of life-imitating arts which provide scenarios of fallen leaders in world events.

Time tells that majority ought to be wise and vigilant. Gone were the times of puppetry. Gone were the moments when man's rational capacities were replaced or barred by deceiving human powers. Time, being the greatest element of change has finally offered lessons to humanity through the breakthroughs of uncontrolled man-made phenomena, to use their reasons instead of sentiments in choosing commendable leaders to reduce sieges if not to totally eradicate.

Comelec Calls on About 150,000 Cordilleran Voters with no **Biometrics to Register Now**

BAGUIO CITY - The Commission on Election, reminds is reminding all Cordillera voters especially the old voters who have no biometrics yet to visit the Comelec offices to have their bio-metrics record so that they can exercise their right to vote in the 2016 national election.

Comelec Cordillera regional Director Atty. Julius Torres, in an interview, disclosed that based on their records there are around 150,000 old voter registrants in the last election who need to re-register and have their bio-metrics so that they can be added to the qualified voters list.

For Baguio - Benguet area, Election Supervisor Aty. Julia Tabangin Capuyan said there are about 50,945 voters in their list who have no biometrics yet.

Capuyan is encouraging those in the Baguio - Benguet area to take advantage of Comelec's iRehistro, an online application for registration which was recently launched here.

This simplifies or shortens the registration process. Aside from filling-out the forms on-line, registrants can also set the date or appointment, for the day/time that they will go to the Baguio or Benguet election office (along Governor Pack road) to submit their forms (which registrants need to print 3 copies in legal size bond papers) and have their bio-metrics taken

Under iRehistro, qualified voters can accomplish their online by visiting application forms www.iRehistro.com or www.comelec.gov.ph.

The report was noted by City Environment and Parks Management Office (CEPMO) Forestry division head Beatriz Gajete.

The ASK meeting was presided over by General Services Office head Romeo Concio and City Administrator Carlos Canilao, and
