## 2 What data do we collect?

Our Company collects the following data:

- Personal identification information (Name, email address, phone number, city and country in which you reside)

## 3 How do we collect your data?

You directly provide Our Company with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.

Our Company may also receive your data indirectly from the following sources:

- Publicly-available contact information on academic web pages.
- Publicly-available contact information on social media profiles.

## 4 How will we use your data?

Our Company collects your data so that we can:

- Process your order, manage your account, and provide services.
- Email you with offers and updates about products and services provided by our company.
- Improve our ability to provide services to you and other customers.

Our Company will not share your data with other companies unless we first ask you for permission to do so. When Our Company processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

## 5 How do we store your data?

Our Company currently only collects your data via the formr survey platform, and securely stores your data using the [formr security precautions](#). Our Company will keep your contact information, information that you provide about your capacities as a Red Teamer, information that you provide about your desires to hire a Red Team, and other correspondences with you that occur via email or sms, for an indefinite time period. You can request to have your data deleted at any time by contacting us via phone or email.

## 6 Marketing

Our Company may contact you about products and services of ours that we think you might like. If you have agreed to receive marketing, you may always opt out at a later date. You have the right at any time to stop Our Company from contacting you for marketing purposes. If you no longer wish to be contacted for marketing purposes, please contact us via phone or email.

## 7 What are your data protection rights?

Our Company would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

- The right to access – You have the right to request Our Company for copies of your personal data. We may charge you a small fee for this service.
- The right to rectification – You have the right to request that Our Company correct any information you believe is inaccurate. You also have the right to request Our Company to complete the information you believe is incomplete.
- The right to erasure – You have the right to request that Our Company erase your personal data, under certain conditions.
- The right to restrict processing – You have the right to request that Our Company restrict the processing of your personal data, under certain conditions.
- The right to object to processing – You have the right to object to Our Company’s processing of your personal data, under certain conditions.

- The right to data portability – You have the right to request that Our Company transfer the data that we have collected to another organization, or directly to you, under certain conditions.
