CDA-CAR Issues Public Advisory vs. Fraudulent Group Enticing Investors

LA TRINIDAD, Benguet - The Cooperative Development Authority - Cordillera(CDA-CAR) issued a public advisory against a group of people introducing themselves as cooperative and recruiting individuals to become members and collecting deposits or investments promising high returns.

CDA Director Franco Bawang, Jr issued the call to caution unassuming individuals people being victimized by this fraudulent group going around Baguio City to entice investors for easy money and larger returns.

According to CDA Senior Cooperative Development Specialist Martin Manodon, complaints that reached their office indicate that the group who claims to be from Laguna, entices individuals to invest in its so called venture promising tenfold of their investment or in the guise of a surety fund program.

Bawang said this happened several times in the past and those involved coops are no longer existing today or their whereabouts unknown depriving investor-members of their hard earned investments.

The Shoe is in the Other Foot for Family of Social Worker

The constant pressure - emotional and financial - on end=stage kidney ailment patients and their families is as debilitating and draining as the illness itself that today afflicts thousands of Filipinos.

The analogy here is that of being chained to a treadmill that keeps on gaining velocity until one can no longer stay in-step, inevitably spinning out of control and hurtling into oblivion.

Locally, individual cases are being featured in this space almost weekly, as the number of cases just keeps on rising, as does the number of families also seeking space for them to thank Samaritans, many of whom they'll never know or meet, but still reached out to them.

The pressure on Nora Mangusan (nee Bolong), a social worker at the Baguio General Hospital and Medical Center, must be most trying than most who have to deal with kidney ailment. As such, she has her hands full counseling patients and their families, recommending them eligible as charity cases, to ease their load of mounting medical and hospital

She knows too well, however, that the cost of hemodialysis treatment can not be waived for any of the patients who, as of the last count by the newly formed BGHMC Dialysis Patients and Supporters Association, numbered

For her, the shoe is on the other foot. Her 57year old husband, Delfin, is one of them. Since February last year, he has been on thrice-a-week hemodialysis treatment at the BGHMC. At P2,200 per session, he needs P6,600 a

Social Media Campaign for Road Pedestrianization Studied – Mayor

BAGUIO CITY - The pedestrianization of Session road is under thorough study, as to business and traffic concerns, Mayor Mauricio Domogan clarified last week during the regular media Ugnayan at city hall.

Responding to a query, the mayor said the city's main road's pedestrianization has long been proposed at the council due to environmental, particularly air pollution issues, but opposed by the business community in the area.

The move was initiated in the city council sometime in the 90s and again in 2009 but was brushed aside due to "cleanliness, sewerage, security and safety," issues.

If pedestrianization pushes through, the city's main street shall be "vehicle-less," it was known, with coffee tables and chairs interspersed with ornamental and green areas. Session road as a walking park is also being considered. Another suggestion is its being car-less during holidays and weekdays, it

Alternative routes including the circumferential road are being considered, however, with studies being done by the Transport and Traffic Management Committee (TTMC) and the Department of Science and Technology (DOST) for tramline and monorail system. The routes are seen to skip the central business district (CBD), travel towards the outskirts of the city; but to tourist destinations within Benguet province and beyond.

The proposed pedestrianization is been pushed due to a World Health Organization (WHO) report which earlier tagged the city as having the "most polluted air in the coun-

We are doing everything and working with different agencies, the Roadside Testing and Monitoring Team (RTMT), anti-smoking ordinance, the National Greening Program (NGP) to ensure the decrease of air pollution in the city, the mayor

Less exhaust is expected with properly-maintained vehicles, while more trees planted as to the NGP assures us of purer air, the mayor has said during the Alay Sa Kalinisan (ASK) meetings.

The city has also conducted meetings with the Baguio-La Trinidad-Itogon-Sablan-Tuba-Tublay (BLISTT) airshed committee for programs to minimize air pollution in the area./ juliegfianza

Born and raised at Balsigan, Baguio, Delfin traces his roots to Tetep-an, Sagada, Mt. Province. In April, 1996, he was diagnosed for diabetes, a metabolic disease marked by high blood sugar levels that, over a long period, leads to leads to complications such as heart and kidney diseases and

The fourth in a brood of five, Delfin lost his mother to complications of diabetes in 1993 and his father in 2012. He studied at the Baguio City National High School and dropped out of Criminology in his third year at the University of Baguio when he went on training to become a police

His medical problems began in 1996 when he was diagnosed for diabetes, which, for years now, he tried to control with regular insulin injection. In August, 2008, he suffered a mild stroke and was hospitalized for three weeks. Later, he underwent two eye operations to clear his vision of cataract. Early last year, he began hemodialysis treatment.

His wife, Nora, a native of Natubleng, Buguias, Benguet is now the sole breadwinner. As social worker, she grosses over P25,718 s month but gets a take-home net of P5,000 due to loans from the Government Service Insurance System, the

Cordillera Solons file House BWD Report: Gap Bill on Autonomy Between Water

Staying true to their word during the Regional Summit, all of the seven Cordillera representatives have finally signed and filed the House Bill 4649, An Act Establishing the Cordillera Autonomous Region, on June 11, just in time before the session in Congress goes on recess.

HB 4649 was drafted by a technical working group (TWG), composed of the chiefs-of-staff of the Cordillera Solons, representatives of the Regional Development Council (RDC), and provincial and city government units, in a technical writeshop coordinated by NEDA-CAR on June 2-5 in Baguio City.

Suggestions brought up during the RDC-led provincial, city and sectoral pre-summit consultation were reviewed and integrated into the working draft, the previously filed HB 5595. The TWG agreed that as long as a proposed provision is not controversial, such recommendation must be accommodated in the working draft.

The Congressmen evaluated the output of the technical writeshop and finalized the draft bill before submitting it in the Committee on Local Government.

The RDC requested to participate in the Committee deliberations for the said Bill, which will be held once the Congress resumes its session in July.

Moreover, NEDA-CAR is currently preparing to intensify the advocacy for autonomy. A workshop on Enhanced Provincial IEC for Cordillera Autonomy will be conducted on June 19. The said workshop intends to generate action plans that are contextualized with politicosocial organizations' interest in the provinces for the remaining months of the year, and to unite key autonomy players in the provinces and cities where Information, Education, communication (IEC) and Alliance Building campaigns could be focused on./NEDA-CAR-MEDIA RELEASE

Mayor: SC Decision Did not Authorize Jadewell's Return

BAGUIO CITY – The Supreme Court's April 23, 2014 decision invalidating the city council's rescission of the city government-Jadewell Parking Systems Corporation contract did not authorize the parking firm to resume operation in the city, Mayor Mauricio Domogan said on Wednesday.

"It's true that the decision affirmed the validity of our contract with them but it did not mention that Jadewell can reoperate in our city," the mayor said.

The mayor said he received a letter from the legal counsel of Jadewell seeking talks with the city government presumably on the resumption of their operations.

"But we will answer them to clarify that there was no mention of their reoperation in the decision," the mayor said.

The mayor said he expects Jadewell to file a motion with the Court for clarification of the ruling on this end.

Acting city legal officer Melchor Carlos Rabanes on Monday also opined that what the Court nullified was only the first act of rescission by the city council done on February 19, 2002 as the five-year guarantee against rescission stipulated in the contract had not lapsed yet at that time but the second act of rescission done in 2006 was considered valid because it was beyond the guarantee period.

Rabanes told the department heads' meeting that in the recent decision, the Court dismissed the contempt charges filed against him, acting city mayor Reinaldo Bautista Jr. and the members of the city council by Jadewell as a result of the said second act of rescission.

"So that means that the second rescission was valid and that means that we are free to use Ganza parking, all roads and areas subject of the Jadewell contract but we still have to wait for the entry of judgement," Rabanes said.

BWD Report: Gap Between Water Supply, Demand to Worsen in 8 Years

BAGUIO CITY – The ballooning gap between the water need of the populace vis-à-vis the production capability of the water sources in the city is expected to worsen in eight years.

This was based on the water supply and demand projection presented to the city council last Monday by Baguio Water District (BWD) general manager Salvador Royeca.

Based on the figures presented, the disparity between the supply and demand will increase from the estimated 17,000 cubic meter per day difference for 2014 to 28,000 cubic meter per day in 2022.

Royeca pointed out that water production capability of the city is beset with challenges foremost of which the declining pumping water levels due to depleting recharge areas of water sources as almost 70 percent of the city's land area is already developed and only 30 percent have old grown pine trees, production pine stands and brush lands. Another cause of the decline is the proliferation of private deepwells.

Other challenges being faced are the increase in the demand due to population growth and influx of transients and climate change.

One immediate problem that emerged is the destruction of water sources at Amliang, Sto. Tomas due to the massive road construction in the area which he said is being addressed at present.

Royeca was invited by the body to shed light on reports of water shortage in the city as per request of Councilor Peter Fianza.

BWD serves 122 of the 129 barangays in the city with a total of 36,949 connections as of April 2014. It has a total of 65 pumping stations, 57 deepwells and five spring sources.

Royeca said the district will pursue the bulk water project to address the water shortage problem in the city./A Refuerzo

In a decision dated April 23, Chief Justice Ma. Lourdes P. A. Sereno affirmed the Court of Appeals ruling dated July 7, 2003 invalidating the city council's rescission of the memorandum of agreement that authorized Jadewell's operation in the city in 2001.

But the Court did not award any damage in favor of the parking firm noting that there was not enough evidence on the extent of Jadewell's violations of the contract to prove whether or not the unilateral rescission of the contract was in order.

"While Jadewell prays for damages against the public respondent, and while ordinarily we could grant the same, the context of this case prevents us

form of recompense to Jadewell even if the rescission of the MOA did not follow the required legal procedure. This is because it would be appalling to grant Jadewell any award of damages, considering (1) it installed only 14 out of the apparently 100 contemplated parking meters; (2) its employees, private citizens who did not possess any authority from the LTO (Land Transportation Office), were manually collecting parking fees from the public, and (3) it did not, apparently properly remit any significant amount of money to

Mayor Convenes Local Inter-Agency Committee, Status Quo Ordered on Proclaimed Lands

BAGUIO CITY – Mayor Mauricio Domogan Wednesday convened the Local Inter-Agency Committee (LIAC) to expedite the disposal of proclaimed lands to qualified beneficiaries in this mountain resort.

The LIAC chaired by the mayor is created for the primary function of formulating and adopting rules and policy guidelines on the disposition of proclaimed lands within the jurisdiction of Baguio City.

Committee on Urban Planning, Lands, Housing and Relocation Sites chairman and Councillor Leandro Yangot, Jr. will serve as co-chair and action officer and the City Planning Office as secretariat.

The members are the Regional Director of the DENR, Regional Director of HUDCC-CAR, City Administrator, City Planning and Development Officer, City Social Welfare and Development Officer, City Engineer, DILG City Director, representatives from the Mayor's Office, NHA, PCUP, Administrator of the proclaimed land, homeowners and the Punong Barangays of the land subject for disposition.

The barangays covered include Cabinet Hill-Teachers Camp, Marcoville, Southdrive, Engineers Hill, DPS Compound, San Luis, San Roque, PMA Fort Del Pilar, North Sanitary Camp, East Quirino Hill, M. Roxas, BGH Compound, Pinget, Loakan Proper, East Bayan Park, Ambiong and Brookspoint.

Domogan also created subcommittees for the barangays in question which is tasked to recommend actions to be undertaken.

The mayor said the committees other functions will include the drafting of a plan for expeditious disposition of lands, identify and mobilize fund resources, approve the master list of qualified beneficiaries, formulate measures to maintain peaceful possession of the land

"This should not be a license for anyone to enter any forest reserve and squat, it would be our policy to demolish any new structure which will be constructed without any building permit in any of this proclaimed lands," he said.

Domogan also stressed pending complaints will continue to be processed under the rules including pending demo-

Domogan also appealed to homeowners not to renovate or extend their present structures except if it is necessary or it will be construed as a new structure and will be subject for demolition

"We should be consistent in our stand in protecting the remaining forest reserves and this status quo order will hamper would be settlers in constructing new structures," he said

The mayor also noted that part of the requirements in order for a proclaimed reservation to be disposed to actual occupants is the consent of the reservee.

"We will get the recommendations of the reservee on this proclaimed lands, they should also give their consent or opposition to the same," he

Wishbone—or backbone?

Applause is the end and aim of "weak minds," parliamentarian Edmund Burke once wrote. But it also spurs "noble minds." That's tailor-fit for Ombudsman Conchita Carpio Morales.

She didn't dally for the standing ovation that erupted after she hauled, into the antigraft court, Senators Juan Ponce Enrile, Jinggoy Estrada, Bong Revilla and associates for plunder. Instead, she lodged an urgent petition with the Supreme Court: Please create two special divisions, in the antigraft court, to conduct, without break, trial of the pork barrel scam.

Morales cited four compelling reasons: "national magnitude of these cases, complexities of the issues, multiple number of accused, and 'far-reaching consequences.'"

The Constitution, precedent, plus the Sandiganbayan's own rules, underpin swift action. In January 2002, the high court crafted a special division, in the Sandiganbayan, to tackle plunder charges against President Joseph Estrada and coaccused. It convicted Erap with dispatch.

Sen. Bong Revilla—charged with repeatedly slurping into the pork barrel for bogus nongovernment organizations—scurried to the Sandiganbayan Saturday with motions for suspension of proceedings. If granted, that would stave off the arresting posses for now. But what if denied? Then, his lawyers would lodge a petition for certiorari with the Supreme Court. "If you are in his shoes, you will not also want to be jailed," the senator's counsel said.

Sure. But "never grow a wishbone where your backbone should be," columnist Dorothy Parker would josh friends in New York's Lower East Side. And backbone is what this Ombudsman always had.

Islamic Liberation Front on ancestral domain. "The biggest joke to hit the century," she bristled at the Corona Court majority allowing Eduardo Cojuangco to dip into levies extorted from indigent coconut farmers. The tycoon pocketed 16.2 million San Miguel shares.

"Our fears are shaped by past betrayals," Viewpoint noted (Opinion, 3/23/10). "A Supreme Court that grovels... whistles up a gross image (of) a Chief Justice trotting behind Imelda Marcos, as parasol bearer."

The lady Ombudsman's petition will be heard Tuesday by a court led by a lady chief justice: Maria Lourdes Sereno. "Ing mayap a babai, maiguit ya karing rubi," a Pampango proverb says. "A good woman is worth more than rubies."

Shattered hopes in constitutional institutions are reviving—thanks to Filipino women of "burnished steel." That includes Gabriela Silang, executed in 1763 for rebelling against colonizers and "housewife" Corazon Aquino who sent a dictator packing.

"Women are only good for the bedroom," Ferdinand Marcos sneered when told that Cory reluctantly agreed to a draft. "Walang alam 'yan." And Cory snapped back: "True. I don't know how to steal, cheat, lie or murder."

"People Power 1" installed Aquino as the 11th—and first woman—president. She reestablished constitutional government, served with integrity, oversaw peaceful transition of power and returned to her modest Times Street home. Marcos' corpse molders in a mausoleum as his heirs badger for denied Libingan ng mga Bayani honors.

People respect women who hew to principles and refuse to be cowed. That includes today's Justice Secretary Leila de Lima, Commission on Audit's Grace Pulido Tan and Heidi Mendoza, Social Welfare Secretary Dinky Soliman and Internal Revenue Commissioner Kim Henares.

They're cut from the same bolt as Cecilia Muñoz Palma's (1913-2006). The first woman Supreme Court justice didn't buckle when male colleagues surrendered to Marcos the 12th-century prerogative of courts to rule on habeas corpus pleas. She flayed, in January 1975, the farcical "Citizens Assemblies." "A referendum under martial rule can be of no far-reaching significance," Palma wrote with Justice Claudio Teehankee. "It is accomplished under a climate of fear."

When the Presidential Commission on Good Government was under the watch of Haydee Yorac, the treasury recovered \$683 million from Marcos' Swiss bank accounts. That same feistiness showed in Yorac's work, from peace negotiator to Commission on Elections official.

"Yorac knows she will not complete the task herself," the 2004 Ramon Magsaysay Award Foundation citation noted. "Others will rise to it. No one is indispensable, she reminds us all. Making a difference is enough."

Then senior vice president of Equitable-PCI Bank Clarissa Ocampo made a difference when she witnessed, from "a foot away," President Joseph Estrada sign a P500-million loan as "Jose Velarde." "I refused to certify it," Ocampo said. She later received threats on her life and for some years lived abroad. She is now a senior broadcast executive.

Heidi Mendoza audited the comptroller's office of the Armed Forces of the Philippines and documented that, under Maj. Gen. Carlos Garcia, the office plundered AFP funds. That included a P200-million reimbursement check from the United Nations for Filipino peacekeepers.

Mendoza left an Asian Development Bank job to testify after her report on an almost P510-million AFP loss had been refrigerated. Her congressional testimony led to action. Garcia landed in the clink. A stacked Commission on Appointments, meanwhile, keeps Mendoza's confirmation in the freezer.

"Kami lahat DUTERTE dito kung tatakbo sya pagka presidente. Kaso ayaw yata. Kaya BINAY kami sa ngayon." ("We will all be for Duterte here if he runs for president. Problem is he seems not interested. So we are for Binay for now".)

This was my golf caddy at the Intramuros golf links in downtown Manila, not someone from Davao, talking. I was trying to divert his attention from my bad golf swing so I started talking politics. When he spoke of Duterte, he did not even know yet that I was from Davao. Caddies usually try to make their players feel good especially when the going in the fairways gets rough — or should I say — going to the "rough" of the fairways literally, which was actually happening! I haven't played golf for months but JCI Senate Foundation President TONY CERILLES (also governor of Zambo Sur) would not take "no" for an answer. So my caddy and I watched helplessly as my whacked golf ball, flawlessly off-target, soared over the centuries-old adobe brick walls towards the Manila BULLETIN building on the other side beyond the fairways. "OB sir!", he shouted. (OB stands for "out of bounds" with a 2-stroke penalty). Never mind, I was interested in what he had to say about Davao Mayor RODY DUTERTE.

NONE FROM MINDANAO - During the same week, my Ateneo college classmate CESAR "Osting" LAPID from Cagayan de Oro called and asked whether the DUTERTE FOR PRESIDENT movement was going to his place in CDO because his friends there were already asking, knowing that Osting originally came from Davao. Then just within days, during the culmination of the Press Freedom Week in Cagayan de Oro, media man Ruffy Magbanua emailed me a situationer where he reported that the three (3) Mindanao stalwarts, Reuben Canoy, Homobono Adaza and Aquilino "Nene" Pimentel who were honorees during the media event had spontaneously agreed to help convince Mayor Duterte to consider running for the presidency to install a Mindanaoan in Malacanang —there being none in recent memory. Very significant is that all three are FEDERALISTS, whose pre-historic dreams for Mindanao was to go federal. Then, in no time I read a report that Mr. Canoy, formerly assemblyman and a pre-martial law advocate of Mindanao independence, immediately flew to Davao and promptly met with the mayor behind closed door at Marco Polo Hotel. Without admitting it, he seems to have given it some good thought too. Who wouldn't?

"DON'T F_K HERE"—I may be getting it all wrong wrong but the temperature for Duterte is fast rising. After his much publicized "I 'll kill you" statement in the Senate during the rice smuggling controversy, he quietly secured a few days ago, the safe release from the NPAs in COMVAL area, which is outside the city, the mem-

116 years after, RP still not independent

LIFE'S INSPIRATIONS: "...I will walk about in freedom, for I have sought out your precepts..." (Psalm 119:45, the Holy Bible).

116 YEARS AFTER, RP STILL NOT INDEPEN-**DENT:** As the nation celebrated its 116th year of independence on June 12, 2014, many perceptive citizens are questioning whether there is real independence in the Philippines today. The general consensus is that there is

nothing to celebrate really, simply because the Filipino people, more than ever, never became independent, even as they remain in bondage to slavery in its many forms.

First, we are definitely still slaves and therefore are not free from foreign domination on economic mattersit is the foreigners among us that continue to control big businesses not only in Metro Manila, but in every part of the archipelago. Filipinos do not have any businesses at all, and if they happen to be in business in any way, they deal only with small bucks.

Second, foreigners or Filipinos with clear and strong foreign lineage or descent are the ones in control of government—from national to local governments. In fact, there is an admission that even the president of this country, President Aquino, and much of his Cabinet secretaries, are either Chinese or Spanish or American. Local officials have family names that contain only two or three letters, or four, at most.

RP STILL UNDER FOREIGN CONTROL: Third, Filipinos still have no freedom to work gainfully in this country, as they are still compelled to go and find employment abroad-where they are usually subjected to physical or emotional abuse by their employers or by the foreign community where they live in—because there is no real opportunity for them to decently earn in the

Fourth, the nation as a whole is not really free because it is still taken advantage of, pushed around, and bullied relentlessly, by stronger and mightier countries, just like what the United States of America and China are doing. Indeed, because of our weakness, the US can easily get concessions like defense agreements that clearly contravene our Constitution, and China can just go in and out of our territorial waters.

Fifth, many Filipinos remain at the mercy of greedy and corrupt political leaders whose only concern in getting themselves elected or appointed in government is to amass great, even if illegal, wealth to lay the foundation for their political dynasties, so they could continue raping the coffers of this country for their, and their families', benefit.

THE ROAD TO REAL INDEPENDENCE: What has caused this continuing slavery of the Filipino people? There would be many factors and reasons for this. But we should not forget that this kind of slavery, this kind of suffering and difficult and cursed life, had all been warned about and promised by the Bible to happen to a people who no longer listen to God and who no longer obey Him.

Tracking Done

BAGUIO CITY - A council resolution done in 2012 for the installation of appropriate or additional step board in public utility jeepneys (PUJs) needs a more detailed study, as to the legislative tracking analysis done by the city's Sangguniang Panlungsod staff.

The resolution earlier requested Baguio City jeepney drivers and operators to install appropriate or additional step board for the safety and convenience of senior citizens, persons with disabilities (PWDs) and pregnant women.

The recommendations after a letter was sent to PUJ associations, and interviews with personnel from the Land Transportation Franchising and Regulatory Board (LTFRB-CAR) and Department of Transportation and Communications (DOTC-CAR) were conducted, includes;

- The need to confirm from the LTFRB-CAR and DOTC-CAR the maximum width and height of a stepboard, both, as 25 centimeters;
- For jeepneys needing additional step board, its height and width needs to be determined, as it has been observed that there were narrow additional stepboards. These pose danger to passengers, rather than convenience, it was known.
- The council resolution should be an ordinance instead, for jeepney drivers and operators to take the matter seriously as the safety of passengers is of con-

The tracking staff of the SP also took note of a suggestion that the terrain in some areas of Baguio having a high stepboard would require an additional stepboard, which may be disassembled, as needed.

The respondents of the study numbering about a hundred, include those from the red, blue, green and yellow trunklines; drivers and operators, all members of jeepney associations plying the city's jeepney routes./

DepEd, Police Report Smooth and Peaceful Opening of Classes in Baguio

BAGUIO CITY — The Department of Education Baguio Division Office and the Baguio City Police Office reported a smooth, orderly and peaceful class opening in the city during the nationwide start of classes on June 2.

DepEd Baguio Schools Division Superintendent Dr. Francis Bringas reported that the class opening went smoothly in the elementary and high school despite the reported usual problems in most of the schools in the city like lack of classrooms, teachers and other school facilities.

Bringas during the weekly Kapihan sa Baguio media forum last week said that most of the public schools reported an increase number of enrollees from the primary to the secondary level. He explained that the increase of tuition fee and other fees in the private schools

forced more parents to enroll their children in public schools.

But Bringas made clear that even if there have been minor problem namely the lack of rooms and facilities, the public schools will still continue to accept enrollees in their schools until the second week of June.

The DepEd is mandated to accept all students in their institution despite the problem on the number of students per class,

At the Baguio City National High School, the largest public high school in the region, almost 7000 came to class on Monday, with ratio of student to a room pegged at 1:70 particularly in the fourth year

BCNHS Principal Dr. Elma Donaal said that despite the 1:45 ideal ratio of

PUJ Step Board Resolution Panagbenga Dialogue up – Mayor

BAGUIO CITY - A dialogue between and among concerned agencies and personalities as to the management of the Baguio Flower Festival or Panagbenga shall be arranged as soon as the audited statement is ready, Mayor Mauricio Domogan said during the media Ugnayan last

This is an offshoot of the privilege speech given by Councilor Leandro Yangot Jr., alleging that the flower festival needs to be given back to the city for management as it has "metamorphosed from a cultural event to a commercial endeavor, from a community affair to a profitdriven show." He also said locals and handicraft producers were not given appropriate chances to promote their products during the Market Encounter of Panagbenga 2014 last February. There was even a call for a resolution to convene a team for the preparation of Panagbenga 2015, on its 20th staging; to generate fund for social services, and other city programs and projects.

However the Baguio Flower Festival Foundation Inc. (BFFFI) held its own press conference at the Baguio Country Club last June 5 to refute said claims.

"The Panagbenga belongs to the people of Baguio City," BFFFI with member-directors; hotelier Frederico Alquiros, Dr. Julie Cabato, Atty. Damaso Bangaoet, Jr., Schools Superintendent Dr. Francis Cesar Bringas, Mayor Mauricio Domgan, and Congressman Nicasio Aliping, Jr. , said. They also urged public and private entities to work together for the next Panagbenga, or offer alternatives instead of criticizing the activity's flaws, real or imag-

The father of Panagbenga, Atty. Bangaoet, Jr., said the flower festival would always emerge developed with inputs from those working for its improvement.

Physician and environmentalist Dr. Cabato, encouraged the application of family values for those working for Panagbenga; as we "take things to heart." There should be no "unpeace" in this endeavor, she gen-

In his privilege speech, Councilor Yangot said that the school and barangay landscape contests were scrapped as there are "not money-making" activities. It has been clarified by BFFFI directors, however that said contests were now year-long clean and green activities, not just for the Panagbenga month.

As to what has been alleged as the flower festival funds being unaudited, Mayor Domogan clarified that every flower festival "has been duly audited, as a "mandatory requirement," except for the 2005 edition, he said. That was during former Braulio Yaranon's term, he added.

Mayor Domogan also gave out data on the increase

BWD: No Water Shortage Preservation in City Royeca said, "wa-

BAGUIO CITY - the downpour sweeping across the Cordilleras this month, bringing soaking rainfall in the city is a welcome sign for the Baguio Water District (BWD) here.

Finally, this dramatic shift has signalled the end of the hot summer month and the city's watersheds will be recharged until the summer season next

BWD General Manager Salvador Royeca speaking before the Council Monday expressed relief that the reduced yield of water experienced not only in the city but the country especially during summer season is finally over.

This is in reply to a council inquiry penned by Councillor Peter Fianza seeking explanation on reports of water shortage and water supply rationing in many urban cities and local government units in the country.

Royeca admitted water rationing is being done in the city especially during summer but dismissed allegations that there is a looming water crisis.

ter rationing in the city is based on results of evaluation being conducted by the agency and dependent on the location of the barangay they are servicing."

As per a report of the BWD presented to the Sangunian, it is currently serving a total of 122 barangays out of 128 existing barangays in the city.

Kias and Fort Del Pilar Barangays as reported have their own water system while Scout Barrio Barangay is being supplied by Camp John Hay.

As per barangays Apugan-Loakan, Atok Trail, Lucnab and Happy Hollow, the BWD said it is deriving its water supply from spring sources and private delivery trucks.

The BWD present has 65 pumping stations, deepwells and 5 spring sources where it gets the supply of water rationed to residential homes, business establishments and government facilities

It has 36,949 active water service connections comprising 27,019 residential A, 5,186 Residential B, 514 residential C, 230

Bakun Passes Ordinance on Indigenous Wildlife

LA TRINIDAD, Benguet - Preserving the flora and fauna of Bakun is a primary concern of officials of this town as they passed an ordinance underscoring the conservation and protection of indigenous wildlife and their habitat.

Ordinance Number 04-2014 is now in the hands of the Benguet Provincial Board for further deliberation.

Vice Mayor Edwin Bandao who authored the ordinance, said some of the wildlife in the area are tagged as critically endangered and endangered thus the need to preserve and protect these including their habitat.

'We are indigenous peoples yet we cannot show any indigenous wildlife in our area," said Bandao. "Our next generation will question us on what have we done to preserve all those," he added.

Among the critically endangered flora are orchids, blackberry, Benguet Lily, Almaciga tree while fauna include the Philippine brown deer and bearded pig. Some endangered species are the cloud rat, wild cat, wood pecker, and giant ferns.

Contributing to the annihilation of indigenous wildlife are illegal acts such as killing and destruction, hunting, trapping, collecting, possessing, trading, and transporting such species.

Dumping of waste products detrimental to wildlife, squatting or occupying portions of the critical habitat, mineral exploitation and/or extraction, curning, logging and quarrying are identified as unlawful acts in identified critical habitat.

If approved by the provincial board, a task force on wildlife protection and conservation will be created for the implementation and enforcement of the ordinance./JDP/SCA-PIA CAR, Benguet

Royeca said, "the BWD aims to improve the distribution of water in the city reason why it is in the process of exploring additional sources of water and even contemplating on entering into a joint venture with private investors for a bulk water

"Interested investors for the bulk water supply include Manila Water, Maynilad and Prime Water which has already asked for technical data to support their feasibility study," he said.

The agency reported an annual water production of 14,500,000 plus per cubic meter but the supply is still lesser than the demand due to the ballooning city population.

Royeca said, "with a projected total city population of 332,137, it is serving 312,209 and supplies 41,504 cubic meter per day, lesser than the demand projected at 58,367 cubic meter per day for this year alone.'

It is estimated that the demand for water will increase tremendously over the next years.

PAB, a quasi-judicial body, extended indefinitely in its July 5, 2013 decision the lifting of a cease-and-desist order it served to Philex Mining's Padcal operations on Nov. 28, 2012.

Meanwhile in a statement from Philex Mining CEO and President Eulalio Austin, Jr., "We've always expressed our commitment to abide by government rules, including on environmental protection, for our smooth operations and continued service to our country and to all our other stakeholders."

On February 26, 2013, the MGB-DENR received payment amounting to P1.034 billion from Philex officials as payment for damages resulting from the mine tailings leakage.

bers of the survey team of the DENR. Then, everyone could not forget how the main CM Recto Street in downtown Davao City got littered with dead bodies of armed kidnappers from Manila who thought they could collect their ransom from a victim in a Davao City bank. Duterte stood over the dead bodies and merely said: "Don't f k here!" The woman victim was recovered safe. And just as I write this piece, the gruesome murder of a prominent businessman, Sonny "TY" Garcia in Davao City was solved even before the public woke up to learn about the brutal incident the following morning. I heard someone proclaim: there may be unsolved crimes all over the country, but not in DUTERTE COUNTRY! But no, that's not really accurate knowing that Duterte's turf is still in the human rights map for summary kill-

ENIGMA — Yes, Duterte with some of his unorthodox ways continue to be an enigma to many. Truth to tell, I had talked with Mayor Rody about the presidency many times over not so much about encouraging him to run, as I am also still tentative about it myself. I totally agree with him that THIS IS A LONG SHOT! But I did so upon requests of several well-meaning friends who were not from Davao and who thought I was that close to "Digong". (His closest, by the way, was my late brod-in-law Charlie "Paging" ALDEVERA whose advice he always sought and whose last word was: DON'T!) Rody had consistently and confidentially told me that yes, being president is destiny but he is not cut out for it. He confided to me of several groups and national personalities who also talked to him about it. He gave the same answer. "Baka nag kamali kayo kung ako e- presidente nyo.," was his standard answer.("You might be committing a mistake if you make me president"). He told me of another group from Manila who came to ask his permission that they would organize for his candidacy. He cut them off immediately and told them firmly: NO! At the very least, however, they got his assurance that he would not publicly embarrass them after they said that they would still proceed with their plans "even without his blessings". When the group left, he told me later that he agreed to the latter arrangement out of courtesy as they were prominent. I remember early this year, in the course of my Zambo City visits following the MNLF siege, an association of Zamboangueno taxpayers asked me to hand carry an invitation to Mayor Rody as their inducting officer, although they told me they wanted to launch a DUTERTE FOR PRESIDENT core group during the event. When Rody asked me, I truthfully told him. He declined the invitation.

WHAT IF? -But there is no question at all in my mind that he had seriously mulled this over. In fact, in one occasion, we had a freewheeling "WHAT IF" chat. What if you were president, I asked him once. Without thinking, he said: "I will first run without a congressional or senatorial slate because first thing I will do if I win will be to declare a revolutionary government and abolish Congress. Then I will initiate reforms." Under the present rules, he said, there is no way we can institute reforms. With all the big interests entrenched that are controlling all aspects of the country, he said he would only be gobbled up helplessly by the system and rendered inutile. "I may even end up in jail like all the presidents we know," he said seriously, But here's something interesting. While he seems not too confident about himself as a candidate, he is sure and certain about an agenda for the country. As a matter of fact, (and I risk getting his displeasure on this) he may be persuaded to instead campaigning for an advocacy, a plan of action, a program of government, a reform agenda. Whether it his him or someone else to carry it through is not yet an issue.

Usually, our chat about the presidency gets endless but Rody knows exactly how to cut it by merely telling me as he stands up to go: "Basta ikaw ES—executive secretary—ha?" We then would laugh together. He knows exactly my turn-off point, having told him before that the position in Malacanang that I would never accept nor aspire for, as far as I was concerned, was that of the ES, having seen it close and even having been, in fact, officially designated ES for several days when ES Ed ERMITA went abroad at one time. But that's another long story.

INCLUDE IN SURVEYS — Last week, my bosom friend, publisher and veteran journalist SERAFIN "Jun" LEDESMA, Jr. posted a blog which, among other things, asked why, with all the growing hoopla on the DUTERTE FOR PRESIDENT noise, the survey firms had EXCLUDED the name of Rody from their surveys. Someone even remarked: "They even had KRIS in the surveys, why not Digong?" Why oh why indeed?

From the looks of it, the DUTERTE ENIGMA is still an enigma. Is he for real? Is it really true that he is getting traction nation-wide as an "alternative"? Is the general public buying his line about radical reforms? Or is this just a passing fancy fanned momentarily by the Napoles scandal? Perhaps, including his name in the succeeding surveys by pollsters like SWS, Pulse Asia and others can give us a good read. Then and only then can we validate what that golf caddy in Intramuros told me about Duterte's winnability? But most important of all, we will get some indication

whether the public is prepared to accept and adopt the unorthodoxes that the Duterte enigma represents. Then perhaps, this can be a signal for that momentous step for Mindanao, or the whole country for that matter, to go FEDERAL!/ADVOCACY MINDANOW FOUNDATION, INC. the City of Baguio," the Court said.

"These three facts are uncontested, these omissions are offensive to the concept of public service that the residents of Baguio were promised through Jadewell. From its ambiguous responses.., it is clear that Jadewell does not appear to be an investor who has lost in its investments in the Baguio City project. Thus, we do not award any damages to Jadewell."

In the same ruling, the Court also dismissed Jadewell's petitions to cite former mayors Braulio Yaranon, Bernardo Vergara and Mayor Reinaldo Bautista Jr., former vice mayor Betty Lourdes Tabanda, members of the then city council and Judge Fernando Vil Pamintuan for indirect contempt and to disbar city officials who are lawyers by profession.

The Court also denied the petition of Jadewell for certiorari, prohibition and madamus as well as its prayer for the issuance of a temporary restraining order and/or writ of preliminary injunction.

Yaranon's petition for review on certiorari relative to his suspension from office in 2006 was also denied for being moot and academic.

Jadewell's operations in the city which was assailed for a long time was stopped in November, 2006 after the city council repealed Ordinance No. 003-2000 for the privatization and administration of on-

street parking in the city and rescinded the MOA that authorized its operation in 2001.

This resulted to Jadewell's filing of the case against the city government questioning the validity of the rescission.

The Regional Trial Court on October 8, 2002 declared the city council's move as unlawful and this was sustained by the Court of Appeals on July 7, 2003.

The main case spawned a bevy of cases, one of which resulted to the suspension of former mayor Yaranon in 2006.

EDC has already rescued 85 premium endangered tree species out of the 96 target priority species with the help of its BINHI partners nationwide.

BINHI is a nationwide reforestation and biodiversity preservation project initiated and being implemented by EDC to arrest forest degradation, contribute to climate change mitigation, and provide sustainable livelihood for forest communities.

Launched in 2008 using EDC's three decades of experience in integrated social forestry as platform, BINHI has become a model for corporate-led reforestation programs among Philippine businesses.

What sets it apart from other reforestation efforts is its focus on bringing back high-value but fast-dwindling native trees such as yakal, tindalo, kamagong, mangkono and ipil.

The ceremony was capped by a tree planting activity of indigenous trees with Bencab together with Lopez Museum President Cedie Lopez-Vargas and Lopez Group Foundation Operations Head Angela Lopez, planting 100 seedlings consisting of 18 premium native endangered tree species at Bencab's eco-trail.

They were joined by University of the Philippines-Baguio and the Philippine Society for the Study of Nature in the tree planting activity, which was is also part of the Philippine Environment Month and the World Environment Month celebra-

Medrano said the tree planting activity will be enrolled as part of the National Greening Program of the DENR in the

Meanwhile, in an interview, Bencab expressed gladness of the project being undertaken in his own backyard as he stressed that he loves trees and he always attributes the partnership of art and nature.

"Aside from art, the museum is very interested in the environment and we are happy with collaboration with EDC to bring back endangered trees in their natural habitat. I am pleased that we are working together with the EDC in a project to make the eco-trail and the forest the heart of this community," said Bencab.

Vargas, on the other hand, said that the museum compound is the best spot for the BINHI project since it is an area which is protected and it is assured that trees planted would survive and be protected until it is ready to be reproduced. She stressed that they are lucky for having a partner such as Bencab who is not only a great Filipino artist but also a nature lover and environmentalist./JDP/RMC-PIA CAR


Re-live Filipino Heroism for Sustainable Freedom and a Greater Philippines, Mayor
