Public asked to report on "suspicious individuals"

BAGUIO CITY – We are all stakeholders in ensuring the safety of our families and communities.

In Monday's flag-raising ceremonies at city hall, Mayor Mauricio Domogan is asking the public to report to the Baguio City Police Office if they observe any "suspicious individuals" in their respective barangays who they have never seen before or are wary of.

Domogan explained that this will allow the police to do proper monitoring on said individuals to know the reason for their visit to the Summer Capital and other pertinent information.

He stressed that this is not to discriminate against anyone but to prevent the occurrence of any untoward incidents that will compromise the safety and security of local residents.

The Mayor met earlier with leaders and representatives of the local Muslim community and appealed for their help by coordinating with the Cont. on page 5

This was emphasized by Mayor Mauricio Domogan in Monday's flag-raising ceremonies at city hall where he reminded city government officials and employees about the city's "Smoke-Free Baguio" ordinance that was passed recently.

Health Services Office chief Rowena Galpo said that the smoke-free task force that will oversee the measure's implementing rules and regulations is currently being formed.

Domogan pointed out the need for concerned city government offices and other agencies to coordinate with local police in strictly implementing the ordinance's provisions.

The Mayor met earlier with department heads led by city administrator Carlos Canilao, city health office head Rowena Galpo, city treasurer Alex Cabarrubias, city accountant Tony Tabin, city human resource man-agement head Agustin ed smoking areas," the

Baguio City Police Office representative and others at the SP session hall, city

Ordinance number 34 series of 2017 prohibits the use, sale, distribution and advertisement of cigarettes and other tobacco products in certain places, imposing penalties for violations thereof and providing funds therefor, and for other purposes.

The measure's purpose is to safeguard public health and ensure the wellbeing of all its constituents by protecting them from the harmful effects of smoking and tobacco consumption.

"It shall be unlawful for any person to smoke or allow smoking in public utility vehicles, government-owned vehicles or any other means of public transport for passengers, accommodation and entertainment establishments, public building, public place, enclosed public place, or any enclosed area outside of one's private residence or private place of work,

The measure shall apply to all persons, whether natural or juridical, whether resident or not, and in all places, found within the territorial jurisdiction of the city government of Baguio.

It also lists the prohibited acts, penalties to be imposed on violators, where the funds will go and creates a smoke free task force chaired by the Mayor whose members include various heads of government offices and other concerned agencies.

The task force will aid in the implementation, enforcement and monitoring of the ordinance and protect the same from tobacco industry interference at all times, as well as to conduct educational awareness campaigns, information dissemination and capacity building programs that will inform constituents and train enforcement officers.

For further information about the ordinance, the public can contact CESU at (074) 442-9829; 300-6588; Sanitation at (074) 444-9217; 300-3895; and HEPO at 300-3953./ Domogan requested the hauler of the city's residual waste from its transfer station in Lamtang, Puguis, La Trinidad to already relocate its existing waste transfer station to his property to avoid complaints from residents on the alleged nuisance that it poses to them.

The city chief executive said the local government should not have been included in the case filed by residents against MA Camilo Freight Services because it is the primary obligation of the hauler to provide his own transfer station prior to the hauling of the residual waste to the Capas landfill.

We were informed that Camilo has a 4,500square meter property in the same barangay which was set for inspection by the technical personnel of the Department of Environment and Natural Resources if it passes the guidelines for a waste transfer station so that he can relocate the questioned transfer station to the said place and avoid complaints from

One of the terms of reference when the local government bid out the hauling of the city's residual waste to the Capas landfill was that the hauler must have his own transfer station compliant with the stringent rules of the DENR.

Despite the prayer for the issuance of the required temporary restraining order to stop the utilization of the Lamtang waste transfer station by the hauler, a local court failed to issue the prayed restraining order and instead set the hearing on the case on June 27.

Domogan suggested that what the hauler could do is to bargain with the La Trinidad municipal government to give him time to relocate the questioned Lamtang waste transfer station to an area that has passed the requirements of the agency.

The city's garbage trucks bring the collected waste from the barangays to the waste transfer station where the same shall be sorted and the residual

Domogan admitted the closure of the waste transfer station without the identification of a new transfer site will be detrimental to the city's garbage disposal, thus, the need for the hauler to make the appropriate representations with the concerned government agencies and the La Trinidad municipal government to find solutions to the existing concern.

m AGUIO\,CITY}$ – The local government has given building owners in the city public market and other city-owned properties in the central business district area 90 days to sign the renewal of their final 15-year contract for the continuous operation of their businesses.

City Treasurer Alex Cabarrubias informed members of the local legislative body that Mayor Mauricio G. Domogan already gave final notice to the concerned building owners that they have 90 days from May 28, 2017, to renew their contracts for their leased premises for the final 15 years or else the building owners must vacate the premises and remove their structures.

He explained the decision of the local government to impose the deadline was an offshoot of the findings of the Commission on Audit (COA) on the alleged disadvantageous contracts entered into by the local government regarding the utilization of city-owned lands and that the rentals being paid by the building owners are way below the prevailing rentals in similarly situated structures privately owned within the central business district area.

Of the 127 building owners having lease contracts with the local government, Cabarrubias revealed 81 building owners decided to renew their contracts with the local government with the condition that after the lapse of the 15-year agreement, the buildings and all other improvements in the areas that they currently occupy will automatically become the properties of the city, while 46 building owners refuse to renew their contracts since they want the assailed provision of the contract to be removed, particularly the one that provides that the city will own all the improvements after the lapse of 15 years.

The year of living with autocracy and incompetence

Duterte's experience as mayor is out of proportion to the demands of the presidency. It ill-prepared him for checks and balances central to a

In April, during a visit to the Armed Forces Western Command (WesCom) in Palawan, the province closest to the disputed islands, President Rodrigo Duterte was briefed on the contentious state of affairs in the South China Sea, including which islands and reefs were occupied by the Philippines, China, Vietnam, and Malaysia.

In a conference room in the new WesCom headquarters, he was shown slides of maps and the islands, color-coded depending on the country that controlled them, as well as the structures and military installations on each of them. Defense Secretary Delfin Lorenza, among other top security officials, accompanied the President.

After emerging from what looked like a straightforward briefing, Duterte, in a meeting with the press, announced that he had ordered the military to

occupy areas in the South China Sea: "I **EDITORIAL** have ordered the Armea Forces to occupy all the so many islands, I think 9 or 10. Lagyan ng structures (Build structures)

and the Philippine flag."

What happened here? It is hard to find any explanation other than that Duterte didn't get it.

Apparently, the fact that 9 islands had been under Philippine control, 8 of them since the 1970s, and the last one since 1999, escaped the mind of the President. Each of the features hoists a Philippine flag and various structures have been erected, the most extensive of which are in Pag-asa, a municipality of Palawan.

This appears to be a simple case of lack of comprehension. But, in the first year of his presidency, this is the most benign instance of Duterte's limited mental capacity. There are other examples where he shows that he is either under-informed or that new information slides off his mind, resulting in decision-making that is without rigor.

Overall, it's been a year of living with an incapable leader who has cloaked himself in autocracy. His incompetence is masked by lots of bravado, using violent language, threats, and stinging curses. He fuels his rule with fear, a cover for his inadequacies. *These distract us from his true worth as a leader.*

Foreign commentators have criticized Duterte's splintered attention, zeroing in on drugs at the expense of terrorism, and his seeming lack of coherence on two vital fronts, the war on drugs and the diplomatic battle against China, "leaving the country deeply confused and divided." They are not far off the mark.

What institutions?

His first year in office shows that Duterte's experience as mayor is vastly out of proportion to the demands of the presidency. And it has ill-prepared him for the checks and balances that are central to a democracy.

Shaped by decades of ruling Davao as the uncontested mayor, he has little regard for co-equal bodies. Remember that he threatened to declare martial law when the Supreme Court chief justice, Maria Lourdes Sereno, cautioned him on his unrelenting drug war.

And woe to any institution or person who challenges his views. He fired the head of the Dangerous Drugs Board for sticking to a lower figure of drug users, 1.8 million, which is based on a 2016 scientific survey, in contrast to Duterte's 4 million, taken out of thin air. He calls his critics names and is unable to engage in a civilized debate - "Daldal ng daldal...wala namang ginawa... (He keeps yakking but he hasn't done anything)" is how he responded to Justice Antonio Carpio's push to assert Philippine sovereignty over islands in our exclusive economic zone.

What is most disturbing, so far, is that he has used the power of the state to send a critic to jail on feeble charges. It's been about 4 months since Senator Leila de Lima has been detained.

Duterte believes he is often right, disregarding consulting with his Cabinet members on vital issues ranging from the declaration of martial law - he made the decision without meeting with his defense secretary - to mining policy. The President did not convene his socio-economic team to provide strategic direction in this crucial sector. It was only after Environment Secretary Gina Lopez suspended operations of several mining companies, creating an uproar in the industry, did the Cabinet meet to clarify the policy.

Drugs and disputed islands

Simple solutions are his responses to complex problems, like the magic wand of martial law and killing of drug users, thinking that these will make the problems go away. He still hasn't caught up Cont. on page 6



Who really started the Marawi City siege?

WHO REALLY STARTED THE MARAWI CITY SIEGE? An intriguing issue that is being thrown against the declaration by President Duterte of martial law in Mindanao is the claim that it was the government itself that started the firefight in Marawi City, forcing terror groups led by Isnilon Hapilon to simply fight back.

police to ensure the city's peace and order situation.

Domogan said that in view of the on-going armed conflict between government forces and the Maute rebel group in Marawi City, he is asking "our Muslim brothers and sisters" to report to the police if they have any visitors, especially coming from that area, who they do not truly know or are suspicious of.

He emphasized, however, that the request does not in any way target or discriminate against Muslims whom he said "are respected members of Baguio's community", but is due to the on-going armed conflict in Marawi City that has moved Pres. Duterte to declare Martial Law in Mindanao.

Domogan points out that he does not tolerate discrimination of any kind and that, "everybody is treated equally in the city regardless of religion or ethnic background".

As a melting pot of various cultures, the Mayor has often extolled the importance of Baguio residents being "united in diversity" for the city's progress. / Gaby Keith

She added under the Philippine Amusement Gaming Corporation (PAGCOR) Gaming Site Regulatory Manual, specifically Section on site location distance requirements, it provides that the electronic and traditional bingo site must comply with the distance requirements, not less than 300 meters from schools, places of worships or churches, public markets among others.

According to her, the St. Joseph Church and Little Flower Retreat House, a church and a place of worship, Dr. Jose P. Rizal Elementary School, a public school, the Pacdal satellite market, which form part of the Baguio City market, are located within 300 meters from the Albergo Hotel, which is the proposed site of the Bingo Palace Corporation for its electronic and traditional bingo games.

On the other hand, The Church of the Our Lady of Atonement Cathedral, a church, is located within 300 meters from SM City Baguio while the Baguio City public market, the Baguio Central University, the University of Baguio and the St. Louis University are located within 300 meters from the Baguio Center Mall, the existing gaming site of Highland Gaming Corporation.

The resolution stated electronic and traditional bingo are games which involve money, thus, they are considered games of chance thereby making it addictive to some individuals.

It claimed problems arise when an addicted gambler acquires debts from numerous loan sharks or financial institutions, and personal and real properties are lost because of gambling addiction that results to bankruptcy and broken families.

"Speaker Alvarez threatens to dissolve Court of Appeals

"Congress can at any time 'dissolve'the Court of Appeals, Speaker Pantaleon Alvarez warned on Friday, insisting that the appellate court had no power to compel the House of Representatives to release the six Ilocos Norte officials in its custody.

"They are not even our co-equal branch... They are merely a creation of Congress—that Court of Appeals. They only exist because they were created by Congress. Any time, we can dissolve them. So they better start thinking, he told a radio interview.

"The leader of the House also threatened to disbar the three justices from the CA Special Fourth Division, Stephen Cruz, Edwin Sorongon and Nina Antonino-Valenzuela, for granting the habeas corpus petition of the six and issuing a release order allowing them to post bail.

"He called them 'gago' (idiot) in a text message to reporters on Wednesday. He added two more epithets: 'bugok' (rotten) and 'buwang' (crazy) in the early Friday interview on dzMM, a transcript of which was sent to House reporters by the Speaker's office.

"For me, they have no jurisdiction over us. Who are they to dictate Congress what to do? We have rights that have been upheld by the Supreme Court a number of times,' Alvarez said.

"That's really gross ignorance of the law. That is why I will not honor their order to [allow the six] to post bail. I will claim responsibility, let's see, because they are too much,' he said.

"The Court of Appeals, the second highest court of the land, was created with the passage of Commonwealth Act No. 3 in December 1935 in what was then supposed to be a transition from US rule to an independent Philippine government.

"This week, the CA attempted three times to serve the order at the Batasang Pambansa but was prevented from doing so, on Alvarez' directive.

"The so-called 'Ilocos Six' were held in contempt by the House good government and public accountability committee and later ordered detained by Alvarez for allegedly refusing to answer questions during an inquiry into the alleged irregular procurement of P66.45-million worth of vehicles by the provincial government.

"Pedro Agcaoili, chair of the bids and awards committee and provincial planning and development officer; provincial budget officer Evangeline Tabulog; provincial treasurer Josephine Calajate; accountant Eden Battulayan, and treasury office staff Genedine Jambaro and Encarnacion Gaor, have been detained since May 29.

"Alvarez said Antonino-Valenzuela was married to a former associate of Estelito Mendoza, the counsel of the Ilocos Six, and should have inhibited herself

Take the drug war, his centerpiece program. Despite evidence showing that curbing drug abuse is not simply a matter of using force but is tied to social issues, Duterte has continued with his policy to exterminate users. He is unable to link drugs to poverty and the feeling of exclusion, poor governance, and unresponsive public health programs.

In foreign policy, he shows a similar limited understanding of the issues. For example, after

the boost given by the country's overwhelming victory over China in July 2016, Duterte sees war with our giant neighbor as the only way to enforce the ruling. He has repeatedly said that the Philippines cannot afford to go to war with China, dismissing outright peaceful avenues.

As experts have pointed out, there are a number of diplomatic options in the President's arsenal, including strengthening alliances with claimant countries as well as allies to put pressure on China and creating a marine park in parts of the South China Sea to preserve the fishery resources and protect the environment.

Maute and Marawi

Duterte's narrow mindset came to the fore

again when he said the root of the crisis in Marawi, where Maute violently seized parts of the city, was the drug money boosting the criminal group. "...Ang puno't dulo diyan is droga kasi diyan ang hotbed ng shabu pati drug sa Mindanao (This is rooted in drugs because Mindanao is the hotbed of shabu)," he told soldiers in Sulu.

While this may be partly true, the problem is not one-dimensional. Systemic problems, such as weak governance, poverty, and dysfunctional courts and prisons, have made groups like Maute thrive.

Duterte's solution was to declare martial law in Mindanao. Again, this is only one tool in his kit. Will it fix the problem of terrorism? The country's experience - 14 years of martial law under President Ferdinand Marcos and one week of martial law in Maguindanao under President Gloria Arroyo - has shown that it will not. Till today, we're still living with a communist insurgency, a Muslim rebellion, terrorism, and lawlessness and feudal politics.
