This was the opening salvo of newly-elected Mayor Benjamin Magalong during his brief message in Monday's flag-raising rites at City Hall – his first since assuming office.

As expected, his statement brought some laughter, a lot of smiles and even a few sighs of relief from among the audience who were expecting a certain stereotype that being a retired General, Magalong would be somewhat "all business", "rigid" or even "humorless". His words changed all that.

In attendance were local officials headed by re-elected Rep. Mark Go and newly-elected Vice-Mayor Faustino Olowan, city councilors, department heads, police, jail and fire department personnel, city employees and other guests.

A dyed-in-the-wool Baguio boy, the local chief executive appealed for unity and reminded City hall officials and workers that they "are one family" and should work together in achieving their collective vision of a greener, cleaner, safer and more progressive Baguio for everyone.

In an earlier briefing with city department heads, Magalong assured that his management style at City Hall will not mirror his military Cont. on page 3

Aggressive campaign against

stray dogs ordered

BAGUIO CITY - Mayor Benjamin B. Magalong directed the City Veterinary Office to conduct an aggressive month-long campaign against stray dogs in the city's 128 barangays to ensure residents confine their dogs in their backyards.

The new local chief executive also ordered the concerned department to study the possibility of significantly increasing the penalties for owners of stray dogs to force them to confine their dogs in their homes or backyards instead of allowing their pets to loiter along roads posing serious threats to the public passing through where the dogs often play and scatter their animal waste.

He agreed to the request of City Veterinarian Dr. Brigit P. Piok for the rehiring of job orders to compose another team of impounders that will around day and night to impound stray dogs that loiter in the city's barangays.

"We have to ensure a sustained and aggressive campaign against stray dogs in all the barangays to make sure residents

inside their houses and backyards and prevent them from inconveniencing the public," Mayor Magalong stressed.

Piok claimed the local government has currently one team of impounders as the job order contracts of members of another team helping in impounding stray dogs are expiring.

According to him, the aggressive campaign against stray dogs will start in Purok 17, Irisan and the same will be replicated in other barangays to rid the roads and streets of stray dogs for the safety of the public.

Magalong instructed the City Veterinary Office to consider conducting their operations at night so that all stray dogs will be impounded and for the owners to learn their lesson and confine their pets inside their houses and backyards to prevent the scattering of their waste along streets and public places.

Magalong also sought the cooperation of barangay officials in the aggressive campaign against stray dogs to maximise the results of the said campaign which should be felt by

most people the soonest possible time.

Piok disclosed the dogs that will be impounded will be brought to the common impounding area within the Slaughterhouse compound for the owners to retrieve.

Magalong claimed dogs that will no longer be claimed by the owners will be euthanized and buried in the identified common burial ground of euthanized animals.

Irisan punong barangay Arthur Carlos and Asin punong barangay Candido Jaime assured their support to the pronouncement of the local chief executive for the City Veterinary Office to immediately launch a month-long aggressive campaign against stray dogs in all the city's barangays to help in clearing the roads and streets of dog manure that are an eyesore to residents and visitors alike.

Documents for the hiring of the job order impounders will be finalized the soonest and submitted to the city mayor for signing to guarantee the immediate reactivation of the second impounding team to carry out the marching orders./ Dexter A. See

Magalong orders implementation of safety standards in project sites

BAGUIO CITY - Effective July 1, the safety standards and procedures will be strictly implemented in all construction sites in the city.

Benjamin Mayor Magalong directed the City Engineering Office and the City Buildings and Architecture Office (CBAO) to ensure that all workers in ongoing projects are wearing personal protective equipment (PPE) like protective clothing, helmets, goggles or other garments or equipment designed to protect the wearer's body from injury

Contractors will be held accountable for violation of the directive, the mayor said.

The directive was also part of the mayor's marching orders in his oath-taking speech last June 30.

City Engineer Edgar Victorio Olpindo said they have notified all the private contractors undertaking projects and no one objected.

He said he was told that most of the companies have started to comply by procuring the PPE for their workers.

The mayor personally went around some ongoing project sites and advised

foremen to comply with the safety requirements.

He said this is to prevent unnecessary accidents and even death caused by non-observance of safety standards in construction

Ordinance No. 3 series of 2019 approved last Jan. 14 by the city council requires all construction companies conducting business in the city to provide an independent construction safety officers at their project sites to ensure compliance with the safety standards.

Use of mobile devices while crossing city's streets okayed

BAGUIO CITY – The other pedestrians and be the authorized agencies using a mobile device in charge of implementing on third and final reading a proposed ordinance prohibiting and regulating the use of mobile devices and other destructive devices and items while walking and crossing the streets and sidewalks in the city.

The ordinance authored by members of the local legislative body that was culled from a proposal of Scout Councilor Eriko R. Coscoluela stated the local government recognizes it has the responsibility to enact ordinances to promote the public health and safety of everyone riding and traversing the city.

Under the approved local legislative measure, the prohibited acts include texting or reading text messages while crossing a pedestrian lane or street; reading any material while crossing a pedestrian lane or a street; texting or reading while traversing a sidewalk which causes delays in the mobility of

while crossing a pedestrian lane or the street wherein the line of sight is directed or focused to such devices.

The ordinance stipulated violators of the measure shall be penalized with a reprimand by the person-in-charge or officer on duty for the first offense; a fine of P1,000 community service or imprisonment of 11-30 days depending on the decision of the court for the fourth and succeeding

The ordinance tasked the City Public Order and Safety Division (POSD), the Baguio City Police Office-Traffic Management Unit, barangay police and enforcers to

or community service for the second offense; a fine of P2,000 or community service or penalty of 1-10 days in jail depending on the decision of the court for the third offense and a fine of P2,500 and

the measure.

The ordinance added authorities should exercise due diligence, patience and maximum tolerance when reprimanding and advising potential violators of their blatant violations.

The ordinance allowed the use of closed circuit television (CCTV) cameras installed by the BCPO and barangays in the proper monitoring and proof of violation of the newly approved measure

Further, offenses that will be charged to the violators may be contested through the presentation of footages and that the absence of proof can be construed as grounds for the outright dismissal of the case

The ordinance stipulated fees collected from violators of the said measure shall form part of the city's special education fund.

The ordinance noted the State exercises its inherent powers, one of which is the police power wherein certain rights are curtailed to govern, and to make, adopt, and enforce laws for the protection and preservation of public health, justice, morals, order, safety and security, and public welfare./Dexter A. BAGUIO CITY Newly-appointed City Administrator Engr. Bonifacio dela Peña assured the residents living below the Irisan controlled dump facility that the retaining wall was constructed by the local government to prevent the overflow of garbage from the closed facility is safe and the stability of the structure is guaranteed.

The new city administrator made the commitment to barangay officials of Asin and Irisan who brought to the attention of Mayor Benjamin B. Magalong the fear of residents living below the structure on the possible repeat of the 2012 deadly trash slide that claimed innocent lives below the dump facility.

of the structure after the deadly trash slide in 2012 thus the safety and stability of the structure is guaranteed and there will no repeat of the said incident because of the planned conversion of the former open dumpsite to an eco-park," dela Peña stressed.

He also assured that the local government will not add up to the existing stockpile of raw compost produced by the previous operation of the two environmental recycling system (ERS) machines as the same will be re-processed to compost fertilizer by the partner of the city, Rapport Innovations.

The trash slide that happened during the wrath of Typhoon Mina "We were personally on August 27, 2012 led to the eventual closure of the Irisan dumpsite and the temporary hauling of the city's residual waste to the engineered sanitary landfill to the lowlands.

Based on the inventory of the City General Services Office on the stockpiled raw compost, there are over 40,000 cubic meters of raw compost generated from the operation of the 2 ERS machines over the past 8

Rapport Innovations engineers claimed that the 2 ERS machines purchased by the local government in 2011 are good units of equipment but they deteriorated over time and are undergoing repairs for their possible full blast operation by July 20, 2019.

Declaration of Baguio as Earlier, the City

Mining Regulatomining-free backed Mining Regulatory Board (CMRB)

AGUIO CITY – Mayor **D**Benjamin B. Magalong and some members of the local legislative body support the proposal of some sectors to declare as a mining-free city to help lessen the threats to the city's environment.

The new local chief executive underscored people from all walks of life are aware of the adverse effects of mining to the environment thus it is best for

the local government not to allow the small or large-scale mining in the city considering its already threatened environment.

Proclamation No. 414 and Proclamation No. 572 declare some parts of Baguio, specifically Loakan-Apugan, Atok Trail, Kias and some parts of Mines view and Gibraltar, respectively, as mineral zones that may allow mining activities in the city.

passed a resolution seeking the possible repeal of the said proclamations to prevent the conduct of mining operations in the city that might pose a serious threat to the state of the environment as some of the declared mining zones fall under declared geohazard areas in the city.

Mineral zones are not also contained in the city's Comprehensive Land Use Plan (CLUP), thus, the bid to declare the city as mining-free to prevent enterprising individuals and companies from prospecting and mining in the mineralized areas which are now actually heavily populated.

Some legislators also expressed their support to the declaration of Baguio as a mining-free city as some of the small-scale miners enter the territory of the city through the towns of Itogon and Tuba.

According to them, the declared mineral zones no longer serve their purpose as some of the said areas are already heavily populated, thus, it must instead be declared as alienable and disposable and subsequently awarded to the qualified home lot appli-

topiary and aesthetics. He said the pruning works will be completed in a span of three years with the goal that the trees will have an even height at 3-4 feet bonsai effect by the fourth year.

'We also need to prune the trees into bonsai height for easier management, aesthetics, and to protect the plant boxes from being overgrown by the balete roots, remember these trees are in the center of a very busy road," Killip furthered.

The CEPMO personnel explained the balete tree belonging to the genus Ficus specie are capable of regrowing and are supposed to be pruned regularly to avoid branches from obstructing passageways or compromising service lines.

He said CEPMO will follow procedural rules in seeking the pruning permit from the city mayor as well as the necessity to inform the Department of Environment and Natural Resources Cordillera.

Meantime, Mayor Benjamin Magalong told CEPMO that he will have to consider public acceptability of the plan to prune the balete trees before acting on the request./Jessa Samidan

"Win-win' solution for proposed tax hike eyed

BAGUIO CITY - The executive and legislative branches of the local government are looking into the possibility of having a win-win' solution in the proposed increase of taxes being pushed by the city's finance officers as the existing tax rates are already antiquat-

Mayor Benjamin B. Magalong advised the members of the local finance committee to study the proposal of the members of the City Council for minimal and staggered increase in the existing tax rates so that the

taxpayers will not be caught by surprise when settling their obligations with the local government.

Local finance committee members informed the new set of local officials that the local government could not significantly increase its annual budget primarily because there was no increase in taxes in the city for over two decades now.

In the case of the schedule of market values for real property taxes, the last increase that was approved was in 1996, while the latest increase in business taxes was in 2000 when Tax Ordinance

No. 001, series of 2000 was enacted.

Vice Mayor Faustino A. Olowan claimed the problem with the proposed increase in taxes being proposed by the local finance committee is that it is allegedly beyond the reach of taxpayers, thus, something must be done to address the situation that will ensure its acceptability once it will be implemented.

Under the provisions of the Local Government Code, local governments are mandated to increase their schedule of market

The importance of integrity

Rappler Editor's Note: Supreme Court Senior Associate Justice Antonio Carpio delivered this speech at the University of the Philippines College of Social Sciences and Philosophy for its Recognition Day on Saturday, June 29.

Chancellor Michael L. Tan, Dean Maria Bernadette L. Abrera, members of the faculty, students of the College of Social Sciences and Philosophy who are being recognized and honored this morning, their parents, relatives and loved ones, friends, magandang umaga sa inyong lahat.

Let me congratulate all the students being recognized and honored here in this hall. Your perseverance and hard work have brought you to the finish line as you will now graduate from this university to start a new phase in your lives. Many of you will work in the private or public sector, while some of you will start your own businesses. Others will proceed for further studies. There will also be those who will seek work abroad.

Whatever you do, wherever you may go, there is one element that will define you as a person, before your coworkers, before your colleagues in business, before the community, and before the public at large. And that is your personal integrity.

Integrity simply means being consistently honest and truthful in your actions regardless of the consequences, even if it means self-sacrifice on your part. This means doing an act because it is the right thing to do, even if you are alone against many. This means firmly standing by your principles,

EDITORIAL though the heavens may fall.

It is not easy to be a person of personal integrity, to do what is right, and to stand

by your principles, when it is so much easier to simply go with the flow and stay under the radar. So why be a person of personal integrity and make life hard on yourself?

The Constitution expressly requires that all public officials and employees must serve with utmost integrity. In the private sector, employers conduct, in varying degrees, background checks on the personal integrity of an applicant before accepting an applicant for employment.

As you go up the ladder in the public or private sector, you will always be evaluated based on your personal integrity. There will always be objectors against those with questionable personal integrity, while those with known personal integrity will find little or no opposition. Employers will almost always never employ anyone with known questionable integrity no matter how competent the person may be.

In your daily life even as a student, you always evaluate people based on their personal integrity. If a classmate or schoolmate wants to borrow from you, be it money, a book or anything of value, you always ask yourself: can I trust this person to pay me back or to return what he has borrowed? You are actually evaluating the personal integrity of the person.

In banking, there is what is called a character loan. The branch manager may lend you money without any collateral, at low interest, if he knows you have personal integrity. This means the branch manager believes you when you promise to pay the loan on a certain date. You are known as a man of your word.

If you have a questionable personal integrity, the branch manage will most likely not lend you at all. Or if ever he lends you, he will surely require that you put up a collateral – hard assets like land or condominium. And you will most likely be charged a high interest rate for being a credit risk.

In the academe, the worst offense you can possibly commit, in my opinion, is to cheat in exams. Cheating is mental dishonesty. To cheat is the complete opposite of honesty and truthfulness. That is why the penalty for this offense may be dismissal or even expulsion.

If you lose your personal integrity, many doors will close on you. Your friends will be wary of you, your business associates will hesitate to transact with whatever you say or do. There is a heavy price to pay for losing your personal integrity.

can recover. You may be able to recover, but the odds may be against you.

That is why you should always protect your personal integrity, and safeguard it like you are safeguarding your very own life. Your personal integrity is your face to the world, it is how the world sees you. Surely, you do not want to present a face that drives people away from you.

Territorial integrity

There is another kind of integrity that —

is also of utmost concern to all of us Filipino citizens. This is an integrity that you must also protect and safeguard with your own life, if necessary. I am referring to the territorial integrity of our country.

Under the Constitution, our national territory includes submarine areas over which the Philippines exercises jurisdiction, and that includes our exclusive economic zone (EEZ) in the West Philippines Sea.

The Constitution mandates that the State shall protect its marine wealth in its exclusive economic zone. The essential elements of a State are territory, government, people, and sovereignty. The government and the people are the two groups of actors in these 4 essential elements.

The government and the people are the ones tasked to protect the nation's marine wealth in its exclusive economic zone. Thus, the Filipino people, citizens like you and me, have the constitutional and civic duty to protect our territorial integrity in our exclusive economic zone in the West Philippine Sea.

The area of our exclusive economic zone in the West Philippine Sea, as affirmed with finality by the arbitral tribunal at The Hague, is larger than the total land area of all our islands put together. All the fish, oil, gas and other mineral resources in this huge maritime area belong exclusively to the Filipino people.

The Constitution mandates that the "use and enjoyment" of these resources shall be reserved "exclusively" for the Filipino people. The "use and enjoyment" of these resources cannot be shared with, or given away, to foreign nationals.

This exclusivity is not a "thoughtless and senseless" provision in our Constitution as President Rodrigo Duterte has unfortunately characterized. The United Nations Convention on the Law of the Sea or UNCLOS has been ratified by 167 States, including China, representing an overwhelming number of members of the United Nations, accounting for at least nine-tenths of the world's population.

UNCLOS has reserved the use and enjoyment of all the natural resources in all the EEZs of the world exclusively to the respective adjacent coastal states. The framers of our Constitution have incorporated this exclusivity in our Constitution. Even the small minority of states that have not ratified UNCLOS, like the United States of America, have adopted this exclusivity. International tribunals have declared this exclusivity as part of customary international law – which means it is the governing law for all states of the world.

China itself reserves all the natural resources in its own EEZ exclusively to Chinese citizens. Why will we not accept and protect this exclusivity when the rest of the world is accepting and protecting this exclusivity? Surely, this exclusivity in the use and enjoyment of the resources in the EEZs, being the accepted norm in all civilized states of the world without exception, is not "thoughtless and senseless."

We must protect this enormous wealth in our exclusive economic zone in the West Philippine Sea for the benefit not only of the present generation of Filipinos, but also of future

BAGUIO CITY - The city's Registry of Deeds formally issued 4 separate original titles covering the ownership of the local government over some properties in the city.

Special Patent No. SP-LGU-BEN0019 was issued to the local government covering 233 square meters in New Lucban, barangay which is currently the site of the New Lucban barangay hall.

SP-LGU-Further, BEN-0021 was also issued in the name of the local government covering an area of 621square meters which is currently the site of the building of the Office of the Civil Registry.

On the other hand, SP-LGU-BEN-0022 was also issued in the name of the local government covering an area of 4,026 square meters which covers the compound of the City Health Services Office.

SP-LGU-BEN-0020 was issued to the local govern-

ment covering some 1,209 square meters located in barangay New Lucban which is being occupied by the compound of the City Environment and Parks Management Office (CEPMO).

Under the issued special patents to the local government, the same shall not be disposed by the grantee without the authorization of Congress if owned by a national agency, or authorized by the Sanggunian concerned through an approved ordinance, if owned by a local government unit pursuant to Section 4 of Republic Act (RA) 10023.

City General Services Officer Eugene Buyucan said the issued special patents or original certificate of titles were part of those that were applied for by the local government tracing back to the previous administration of former Mayor Mauricio G. Domogan.

The special patents were entered into the books of the Registry of Deeds of Baguio city on May 15, 2019.

the local government to have its properties titled is gaining ground thus the said office is exerting all efforts to ensure that all city properties will be titled to ensure they spared from being grabbed by other individuals.

According to him, the City General Services Office is still pursuing the titling of other city-owned properties, including the City Hall compound, for the city government to have legal possession over its properties.

Earlier, the Registry of Deeds issued separate special patents for some of the properties owned by the city government located in the different parts of the city pursuant to its mandate to ensure the protection of the properties from possible encroachments by informal settlers.

My generation has built a strong foundation to protect our territorial integrity in our exclusive economic zone in the West Philippines Sea when the Philippines won in July 2016 the landmark victory at The Hague arbitration. Future generations of Filipinos, including your generation, must build on this foundation.

Defending integrity

Our territorial integrity is just like our personal integrity. We must maintain, protect, and defend both with all the power at our command because they are priceless. To protect our territorial integrity requires doing what is right in service to the Filipino people regardless of the consequences. To protect our territorial integrity requires personal integrity.

If we fail to protect our territorial integrity in the West Philippine Sea and lose it to China, we will lose our exclusive economic zone in the West Philippine Sea forever. There is no recovery once we lose this huge maritime area to China.

If we lose our personal integrity there is still a chance of recovering our personal integrity, no matter how long and difficult it may be. But if we lose our territorial integrity, there can be no recovery unless we defeat a nuclear armed China in a war, which is of course impossible.

War, in the first place, is not an option and has never been an option. Under the Constitution, the Philippines has renounced war as an instrument of national policy. This means the Constitution prohibits the government from going to war to enforce The Hague arbitral ruling.

Besides, the United Nations Charter has outlawed the use or threat of force to settle territorial or maritime disputes between states. A country that violates this is an international outcast, and can be sanctioned by the Security Council.

Of course, we also know that if we go to war with China to enforce the arbitral ruling, we will lose and lose badly. Only a fool will go to war with China. It is clear that the specter of war is being raised

DENR reopens Irisan dumpsite in Baguio

BAGUIO CITY - The Undersecretary Benny Cordillera office of the Anteporda issued a Department of Environment and Natural Resources (DENR) granted the request of the local government to reopen the Irisan dumpsite, specifically the operation of the two Environmental Recycling System (ERS) machines, to prevent the possible occurrence of a garbage crisis in the city following the piling up of the uncollected non-biodegradable waste in the different parts of the city.

DENR-CAR regional director Ralph Pablo informed Mayor Magalong that the agency decided to reopen the closed dump facility provided that the local government must ensure that the debris and mixed waste

temporary cease and desist order last Thursday that prevented the local government for continuously operating the 2 ERS machines because of alleged violations of the pertinent provisions of environmental laws and gave the City General Services Office 24 hours to justify the non-continuation of the stoppage order. Among the other condi-

tions in the lifting of the cease and desist order will be the collection of biodegradable waste and the conversion of the area into an eco-friendly park by December 31, 2019.

Magalong explained that the timetable of the local government in the use of the facility is to ensure that the over 40,000 cubic meters of raw compost stocked in the area will be converted into compost fertilizer by the third quarter of next year so that works on the land development will start by the fourth quarter of next year in preparation for its total rehabilitation and conversion into an eco-park by the first quarter of 2021.

He claimed that the 11 small-scale recycling volunteers in the area will also be transferred near the city's temporary waste transfer station at the Baguio Dairy Farm area where the same will be improved and developed for them to continue Cont. on page 7

Waste-to-energy to be pilot

tested in Baguio

Benjamin B. Magalong disclosed that the Stateowned Philippine National Oil Company (PNOC) will be bringing to the city a waste-to-energy demo unit to pilot test its operation near the temporary waste transfer station within the Baguio Dairy Farm to ascertain its feasibility when adopted by the city government as a solution to the prevailing

garbage disposal problem.

The new city chief executive said that the waste-to-energy demo unit will be brought in to the city by PNOC, together with Japanese waste-to-energy experts, and install the same within a 1-hectare area near the waste transfer station for pilot testing purposes as it was the waste-to-energy facility that was seen

and preferred by President Rodrigo R. Duterte when he visited Japan two months

Initially, the Japanese experts will conduct an ocular inspection of the proposed for the demo unit to make the necessary recommendations on how to improve the area prior to the delivery of the said unit to the city.

"We will test the waste-to-energy demo unit in the city to ascertain its feasibility as a prelude to its instal-
