### **Protech Allowed to Collect Wastes** from Barangays; Move Practical, **Says Mayor**

BAGUIO CITY - The move to allow Pro Tech Machinery Corporation (Pro Tech) to directly collect non-biodegradable refuse from the barangays is expected to boost the efficiency of the city's waste collection system.

Mayor Mauricio Domogan on Wednesday expressed confidence that giving the authority on Pro Tech's hands-on collection in the barangays at no cost to the city, albeit still on experimental run for one month, is a practical move as the city will be relieved of the task of collecting the trash and thus will save on hauling and transport costs.

În his Administrative Order No. 125, the mayor granted authority to Pro Tech to help collect the generated garbage from the designated pick-up points in the different barangays in accordance with the collection schedules and subsequently haul them directly out of Baguio on experimental basis from October 1-31.

There is a need for the City Government to avail of any possible assistance to be extended by groups, individuals and companies in order to improve the collection of wastes in the 128 barangays and to empower local residents to segregated their garbage at source to ensure a more effective and efficient collection of garbage in the future," the mayor noted.

The direct collection by Pro Tech will do away with the need for a transfer station to sort out the wastes thus freeing the Irisan controlled dump facility from hosting more wastes for sorting as was the practice.

The mayor said the city is trying to locate a possible permanent transfer station for sorting out non-biodegradables but no area has so far been pinpointed.

The mayor said Pro Tech offered to collect both the nonbiodegradable and biodegradable wastes but he said he only allowed the collection of nonbiodegradables at the moment.

He said that should the system prove advantageous at the end of the month-long experiment, then the city could adopt it permanently.

He assured that no personnel in the solid waste division will be displaced once the system is made permanent.

The city at present has 98 employees serving as garbage collectors and dump truck drivers and the mayor said the city government will see to it that all of them will be absorbed in the other departments.

He said he has directed the city human resource management office to freeze the hiring of utility workers, drivers and laborers and other related positions to accommodate the 90 employees.

The mayor said he believes that the city council will receive well his allowing Pro Tech's direct involvement in waste collection.

"Whatever it is that will help our city perfect our waste management, then by all means let us do it," the mayor said.

Pro Tech presently utilizes the city's trucks and person-

nel in the collection process but gave assurance of adding more trucks in the coming days to improve the service.

Pro Tech assured that it will also continue to haul out the remaining fresh non-biodegradable wastes at the Irisan con-

trolled dumpsite except the inert wastes left by the trash slide. The firm is bound by an agreement with the city government to take charge of hauling out the city's residual wastes

as part of its deal with the city on the Environmental Recycling System (ERS)./A Refuerzo

# Stiffer Penalties For Tampering, Theft Of Disaster Risk Reduction and Preparedness Equipments to be

The enactment into law of House Bill 4010, an Act that would mandate stiffer penalties on the offense of stealing or tampering of risk reduction and preparedness equipment is one of the priorities of President Benigno Aquino III and Congress through the Legislative-Executive Development Advisory Council (LEDAC).

### **Benguet Reports P40 M Damages** to Crops

LA TRINIDAD, Benguet - The onslaught of two succeeding typhoons Pedring and Quiel brought great damages to agricultural crops in the province totaling to P40 million.

Gov Nestor Fongwan admitted the agriculture sector was affected so much by both typhoons but he assured that there is enough supply of most vegetables being produced in the prov-

Temporary shortage of vegetable supply might only be for pepper, beans and lettuce as most of these crops are on the vegetative stage, according to Fongwan.

Benguet supplies most of the highland vegetables requirement of Metro Manila.

Provincial Agriculturist Lolita Bentres said validation of reports to verify the extent of damage in agriculture in the various towns will still take place.

But more damage was noted during typhoon Pedring due to its heavy rains with gusty winds, said Fongwan adding, "Kung ano ang inumpisahan ng (typhoon) Pedring dinaanan lang niya" (referring to typhoon Quiel).

Fongwan said definitely the province will give its share from the calamity fund for those affected but not that much. He expressed hope that the national government will augment the assistance.

Based also on the reports issued by the Provincial Disaster Risk Reduction and Management Council, partial estimated cost of damage to provincial, municipal and barangay roads was pegged at P25 million which excludes damage to national roads.

A few residents were left homeless with 14 houses totally damaged during typhoon Pedring and one in typhoon Quiel. For partially damaged houses, there were 37 in typhoon Pedring and 14 in typhoon Quiel.

Fongwan said P10,000.00 will be given as financial assistance to those whose houses were totally damaged. Normally only P5,000.00 is allotted to such.

As to the threat of succeeding typhoons, Fongwan admitted it is already a normal phenomenon and expected in the rainy season but hopes that typhoon Quiel would already be the

He mentioned that one of the signs of the end of wet season and the beginning of dry season is the sighting of flocks of bird called 'kiling' in the dialect with their resounding chirp.

#### **CBA-CPLA Faction Expresses Desire to** by Leonardo Bun-Talk With Govt

BAGUIO CITY(PIA) - - All is well that ends well, hopefully.

Cordillera o d o n g Administration(CBA)-Cordillera People's Liberation Army(CPLA) faction led by Andres Ngaoand Michael Sugguiao has expressed desire to engage government in a negotiation towards the disposition of arms of the group and its transformation as a socio economic force.

The CBA-CPLA Ngao-i-Sugguiao faction, however indicated in a written statement, that the talk will not lead to a closure of the 1986 Mt. Data peace ac-

quest for regional autonomy, but instead there should be a warming-up of the said peace agreement.

The decision of the CBA-CPLA Ngao-i-Sugguiao faction came following a meeting of the group with Office of Presidential Adviser on the Peace Pro-(OPAPP) cess Undersecretary Maria Cleofe Gettie Sandoval and Col. as, one of the original signatories of the Mount Data Peace Accord or "Sipat" in 1986 between the government led by then President Corazon Aquino and CPLA headed by rebel Čonrado priest Balweg, for the cessation of hostilities in the region and the recognition of the Cordillerans' aspiration for regional autonomy.

Abu Sayyaf group members dwindled to 379 in June, from a peak of 1,270 four years back. Armed Forces headcounts shows 46 ASG leaders were run to the ground. All had bounties on their heads.

Marines in Sulu beat back, an attack by "Awliya", a new band. Two soldiers and 13 attackers were killed. Tuan Awilya was among rebels who rejected peace offers in the 1990s. Today's "Awilya" has links to ASG, the military claims.

Murder to mutilation of dead soliders have been pinned on ASG. They held three International Red Cross workers hostage. ABS-CBN paid ransom to spring broadcaster Ces Drilon.

Thus, ASG's image is that of a terrorist group, packed with jobless, poorly-schooled Muslim youth. An assumption

anchors this perception: A hierarchy of authority, with

defined goals, directs ASG. Does it resemble structured groups, like the Provisional Irish Republican Army?

The reality is more complex, assert Eduardo Ugarte of Global Terrorism Research Centre at Monash University and Mark Macdonald Turner at University of Canberra. ASG is "part of broader and shifting 'dark networks" These webs of kinship, culture and politics enmesh many, including: elected officials, military police to insurgents.

Ugarte and Turner title their analysis "What is the 'Abu Sayyaf'? How Labels Shape Reality "The Pacific Review (London) published their study... Perceptions morph into "reality" and mould policy, they write. "What things are called is incomparably more important than what they are'.

Both assembled scattered data to ."construct reality that, until this Pacific Review issue, has not been coherently analyzed". Tumahubong, Sipadan and Palawan kidnappings, by ASG, are used as case studies.

The notion hat ASG "is a distinct group is an illusion", they conclude. "Classificatory labels, employed by the military and media, are meaningless:... Islamists in southern Philippines, are not concentrated in a discrete collectivity."

Instead, they straddle MILF, MNLF and communal alliances. They've evolved into random networks. Power and leadership are haphazardly distributed. No actor or group makes binding decisions for others.

ASG "is not a organized phalanx of mujahideen.", noted Julkipli Wadi, a leading scholar political Islam scholar. Rather, this jama'a [grouping], is a loose, almost chaotic grouping of disenchanted Muslim youth...".

An Inquirer count, in late 2000, identified a welter of 11 'commanders: "six in Sulu, four in Basilan and one in Zamboanga They control followers even when they tie up with other bands.


ASG's demands "can change from moment to moment," Inquirer's Noralyn Mustafa, commented on the March 2009 kidnapping of Red Cross workers. "After one commander agreed to terms, the following day he'll say:after 'consulting' his co-commanders, they refused to comply. And negotiations begin anew — from zero."

'Interpersonal linkages' command 'overriding importance'. 'Groups survive because their leader crafts a network of relatives and clients "Blood ties are very strong in Sulu, notes researcher Victor Taylor" People don't think in terms of organizational labels, whether Moro National Liberation Front (MNLF) or "Abu Sayyaf". Halo-halo nayan ("They're all mixed together")

In the 2000 kidnappings, assorted ASG groups presented different demands. These ranged from meeting movie actor and Muslim convert Robin Padilla, tearing down of Christian crosses, implementation of fishing laws — and, of course, money. These shifted as each commander advanced his own set of claims

ASG "does not know what it wants,." observed Glenda Gloria, Newsbreak editor and co-author of "Under The Crescent Moon." "It does not know where it wants to go, or how to articulate problems of Muslims in Mindanao beyond what [has] a been articulated by other groups... It is wrong for government to assume that it is dealing with a cohesive organization with a set of doctrines, rules or solid leadership."

ASG groups frequently squabbled over money,"coveting each other's captives", recalls negotiator Roberto. Aventajado. "The jungle did not have a single master. No one could guarantee anyone's safety because no one's writ ran unopposed across the wilds of Talipao...Not even Cont. on page 11

Transparency in Baguio's waste management is needed

It must have been at least two years now that several writeups of columnists have been devoted to Baguio City's garbage. Do writers love it? No. On the contrary, writers despise garbage talk. Do we enjoy talking about it? No. How can one enjoy talking about something that evokes memories of unpleasant sights and smells?

Unfortunately, the city government has been pushing writers to the brink. Garbage has been the topic of the city's papers for several years now but we do not like the topic. Until today, garbage in many of the city's barangays continues to be uncollected. The "new" reason given this time: the households and the barangays have not segregated their garbage between organic and non-organic.

True, waste segregation is important. It must be done. It must be the practice of the 21st century. It must be the lifestyle of this century. It must be the way of life. There is no other way of living correctly but to segregate garbage. We must promote recycling and so on and so forth. However, for waste segregation to be an excuse for not collecting garbage is a different matter. In economic parlance, waste segregation is a public good. People stand to benefit if they free ride. If people do not segregate garbage, they can lose but their losses will be equally shared by society. Thus, there is a strong incentive to free ride. The solution therefore is not to rely on the voluntarism alone but for government to act. To emphasize, these are not arguments not to promote waste segregation. All these are simply arguments on why government should be doing their role in the first place: COLLECT AND MANAGE THE WASTE OF THE CITY.

I tried reflecting on why we have this garbage problem in the first place. It appears clear to me that the fundamental reason on why we have the problem in the first place is that our city has not been transparent on how the garbage problem is being managed. We did not have adequate public consultations on how the garbage problem would be managed if ever we had one at all. On my part, I cannot recall even a single one. To emphasize, what we need is not only one public consultation but several public consultations

I do not recall our city government requesting opinion from the NGOs and the public on how our city's garbage can be solved. I do not recall our city announcing a public bidding for a waste management system. Perhaps, but only perhaps, it had announced one but the announcement may not have been publicized well if truly there was one. I do not recall our city enlisting the participation of our environment-oriented nongovernment organizations in developing and forwarding recommendations on how the garbage problem can be solved.

Because of this lack of transparency, it is not farfetched to suspect that somehow graft and corruption had been involved in the waste management facility that was recently crafted for the

city. Unfortunately, it is also on this lack of Cont. on page 11

Magandang hapon po sa inyong lahat!

Nakakainggit ho kayo ang taas ng energy level n'yo. [Laughter]

Kakagaling lang po natin sa Estados Unidos kung saan naging mainit ang pagtanggap sa atin ng ating mga kababayan doon, dahil na rin po sa magandang bunga ng mga repormang isinusulong natin sa atin pong Inang Bayan. Para na rin po mas makatipid, ginagawa na nating parang biyaheng Quiapo ang lakad natin [laughter]—dirediretso po: Manila to San Francisco, San Francisco to New York, New York to Washington, Washington pabalik ng Maynila, all in five days inclusive of travel time [applause]. Pinaliwanag ko na lang po sa mga kasama natin—'di ko sinabi sa kanilang nagtitipid tayo—sinabi ko, "Alam ninyo, mamadaliin na natin lahat 'to para hindi na natin maranasan iyong jetlag. More OFWs deployed, more dollar earnings came for RP

**PNOY'S GOOD IMAGE HELPING OFWs ALOT:** The good image and positive perception being enjoyed by President Aquino among the members of the international community are the principal reasons why the deployment of overseas Filipin workers (OFWs) abroad continue to be brisk despite the on-going worldwide economic turmoil.

Administrator Carlos Cao, Jr. of the Philippine Overseas Employment Administration (POEA) made this assessment last Thursday, 06 October 2011, in an informal round-table-discussion with members of the Batch '78 of the Sigma Rho Fraternity of the University of the Philippines, College of Law. Cao is a member of Batch '78.

"It is mainly because of the international community's trust on President Aquino and his government that OFW's continue to be warmly accepted by employers in many countries around the world," Cao explained.

MORE OFWs DEPLOYED, MORE DOLLAR REMITTANCES CAME IN: Responding to queries by Batch '78 Sigma Rhoans, Cao disclosed that latest POEA records show that despite the worldwide economic crunch the number of OFWs deployed between January 2011 to September 2011, instead of going down as expected, even surpassed the number of OFWs deployed during the same period for 2010.

Cao also said that the same POEA records, also for January 2011 to September 2011, even registered a similar increase in dollar remittances from the OFW sector and that the same positive trend is expected by the POEA to continue until the end of 2011.

For the period from January 2011 to September 2011, a period where Saudi Arabia and Libya are having problems employing OFWs, deployment of Filipinos topped the 900,000 figure for January 2010 to September 201, while dollar remittances for this year for the same period topped the P11 billion remitted last year.

GOD'S GRACE IS UPON THE FILIPINO PEOPLE: Cao said these positive developments in the deployment of OFWs, and in dollar remittances from Filipino workers abroad, is nearly miraculous, and considered by many in the POEA as God's grace.

"It appears that God's blessings and protection continue to be showered not only on OFWs, but even on the Filipino nation as well, and this could only be because of the sincerity of President Aquino in pursuing a righteous path of governance," Cao added.

Quoting the Bible which he preaches as a Pastor, Cao said "righteousness exalts a nation but sin is a disgrace to any people." Filipinos can surely expect more positive developments under the Aquino administration, he said.

### **Balili River Wanting for Clean and Safe Waters**

LA TRINIDAD, Benguet — The Balili River then categorized as Class A is wanting for clean and safe flowing water free of thrash and liq-

uid wastes.

The Balili River with the Sagudin River in Baguio City as its headwater was categorized as Class A but technically failed to meet the water quality standards set, according to the Environment and Management Bureau of the Department of Environment and Natural Resources (EMB-DENR).

Findings of the EMB-DENR-CAR showed that pollution along the river system is twopronged, solid and liquid wastes. The most common are household wastes seen a floating.

This is coupled with the domestic sewage of some households leading to the river. The untreated effluents from business establishments such as used oil from motor and machine shops well as car washing activities are also contributory factors Regional EMB, Technical Director Paquito Moreno

The problem along the Balili river is compounded by the structures constructed along the embankments encroaching the river system. The identified encroached areas along the river banks in this town and Baguio City are for further valida-

Moreover, the worsening condition of the Balili river is attributed to the social behavior or attitude of people based on studies of the University of the Philippines, according to UP Dean Raymundo Rovillos.

To help in rehabilitating the river system, Moreno advocated for influencing the behavior of people – the affected residents and

community - in their day-to-day lives and reminding them of their responsibilities in not dumping of wastes along the river system. urgency in nurturing and vigilance in protecting the river system rests more upon those directly affected.

He also stressed that strict implementation of the Solid Waste Management Act or Republic Act 9003 will also help in declogging the river.

Compliance to and issuance of building permits is also crucial, he added.

There were past initiatives in the past to save the river. Now, convergence and harmonization of all the efforts is being spearheaded by the Balili River System Revitalization Coalition. This is composed of stakeholders from multi sectors in Baguio City and la Trinidad./ JDP/SCA-CAR, Benguet

**Briquette Training** Charcoal **Expanded to Other Benguet Towns** 

LA TRINIDAD -The successful training on the production of charcoal briquette in the town of Itogon inspired a private company to extend its assistance to other municipalities of the province.

The training and production of charcoal briquettes is part of the Corporate Social Responsibility of Mc Connell Dowell Philippines, Inc. at barangays Ambuklao and Tinongdan, Itogon, as host communities of the rehabilitated Ambuklao and Binga Power Plants.

Mc Connell Dowell Community Relations Officer Rose White said the company's management saw the success and acceptability of the alternative livelihood project in the community the reason they considered the expansion to the other towns of the province.

A training will be held at the Crop Techno Station of the Office of the Provincial Agriculturist in Puguis, here on October 24-27, 2011. After the training, the complete set of equipment necessary to manufacture briquettes for each municipality including one unit for the province will be turned-over to keep them started with the livelihood project.

The materials used for the charcoal briquette are agro-forest wastes such as leaves, twigs, branches which have fallen from the trees according to White.

The use of charcoal briquette is becoming popular as it provides clean burning fuel compared to the traditional charcoal. It is compressed and is denser, burns for longer period and has less moisture compared to the ordinary charcoal.

White said there is market demand particularly for big companies but for now, the aim is to offset the demand for the household consumption of liquid petroleum gas.

Initial products in Itogon are sold locally. White said the briquettes are sold at an affordable price and will definitely be lower than those commercially sold in the market.

To be able to produce charcoal briquette, agro-forest wastes are gathered and placed on a drum. They are burned for a certain period. The smoke emission is minimal as it is filtered by water on top of the drum, said White.

The dried wastes are compressed and formed utilizing a machine. Starch is used as binder to hold the materials together.

The liquid by-product can be used as cleaning material for canals and drainages. If fermented, it can also be used as organic pesticide. The concept is similar to the Mokusaku or organic material for fertilizer and pesticide developed by the Japanese, according to White./JDP/SCA-PIA CAR, Benguet

with the DOT are hotels, travel agencies, tour operators, tour guides, event coordinators and provider for conventions.

composting purposes and as fertilizer. But for pesticide purposes, it needs to be fermented for about six to eight months. The fermented substance could be more effective as pesticides if concocted with botanicals or organic-based materials, said Bentres.

Vegetable production increases if soil is enriched through the application of the substance, Bentres explained. It also cuts production costs of farm inputs such as pesticides and inorganic fertilizers.

According to Bentres, the reason soil quality of farms in the province is deteriorating is because of the overuse of soil due to mono cropping or planting of crops all year round. Soil nutrients tend to be depleted and there is immunity of pests and diseases.

But according to the Japanese experts, the adverse effect of inappropriate practices of farming to soil can still be countered utilizing the said technology, Bentres related./ JDP/SCA-PIA CAR, Benguet

to do with their 20 regular staff of medical technologists, midwives, nurses and clerks. in providing health care services and assistance to the 170 to 200 (average) patients that go to their clinic a day.

BGHMC Pediatrics Department Head, Dr. Eleanor Cuarte, also attested that their trainee nurses have been their partners in delivering services to their patients, which is not only on taking care of sick children but also of babies who are being delivered or born in the hospitals which averages of about 20 to 30 a day. They also helpin providing health related advocacies to both parents and relatives of patients.

'In our New Born Unit, we have about three to four regular staff (nurses) and we take care of healthy and sick babies and their families. And if we have a critically ill baby then a nurse should focus on this single baby alone and forget his other duties" Cuarte said.

"I think I am for the training program for nurses, as aside from the actual training and experience that these nurses learns they are also of big help in providing health care services to the large number of people who come to government hospitals for consultation and treatment, especially with lack of vacant nurses positions to fill in the deficiency to have an ideal nurses to patient ratio". Cuarte added.

In the said forum, DOH-CAR Human Resources Management and Development Section head Caridad Binwag, explained the content of the DOH Memo 0238, She also admitted that termination of all nurse volunteers or trainees in government hospitals somehow has an impact in the delivery of health care services.

She explained that there is an stan-'So today as mandated by LEDAC, dard in staffing that is being followed by

the government that the Department of Budget and Management (DBM) is now rationalizing. In the meantime, government hospitals would have to rely on its supervision and monitoring to address the gaps left by the termination of volunteer or trainee nurses, she said.

Binwag also urged the regular staff nurses of government hospitals to continue in doing their best to assure the delivery of quality health care services to the public./ JDP/LD-PIA CAR

She also said that the MOA will not affect the aspiration of the Cordillera to be an autonomous region.

off, Lower Rock Quarry and Pinget.

To guard the waste pick-up points during the collection schedules to ensure that the wastes being brought there are properly segregated.

The mayor also ordered the punong barangays to conduct massive information education campaign to their constituents on the basics of waste segregation at their homes and on the city's no-segregation-no-collection policy.

During the Ugnayang Panlungsod press briefing, the mayor clarified the intention of the city's no-segregation-no-collection policy for which he said the city should take a radical approach.

He said that instead of the conventional and literal approach of refusing to collect the unsegregated wastes, the city will instead take a revolutionary approach by going after the source of the unsorted refuse and take them to task for violation of the provisions of Republic Act No. 9003.

"Instead of leaving the unsegregated wastes uncollected which will bring more problems because it will result to health hazards and eyesores, we will strengthen the monitoring and coordination with barangay officials so that the perpetrators are identified on site and summoned to do the segregation themselves and execute affidavits and file case against these violators," the mayor said.

The mayor also asked the residents to bear with the city in the implementation of the two-truck biodegradable-nonbiodegradable collection system.

"We are actually experiencing problems on the two-truck system but as we go on, we hope to perfect the system in the long run. Japan, where the Environmental Recycling System (ERS) machines came from, took 30 years to perfect the segregation system. We are only months into the implementation of the segregation policy so we still have a long way so we beg for your understanding," he said./ A Refuerzo

### Baguio Named 'Finalist' for 'Child-Friendly' City Search '11

Baguio City has made it to the final cut in the national Search for Childfriendly City 2011' by the National Juvenile Justice Welfare Council (NJJW).

This, amidst unfounded fears of worsening peace and order wrought by apparent 'isolated cases' of violence against minors.

During the weekly 'Ugnayan' presser sponsored by DZEQ Radio ng Bayan, October 5, Mauricio mayor Domogan revealed the city is pitted with cities Olongapo, Bacolod, and Mandaluyong for the annual award to be conferred President Benigno "Noynoy" Aquino III in Malacanang October 28.

A multi-agency NJJC team composed of reps from the National Economic Development Administration (NEDA), Department of Health (DOH), National Juvenile Welfare Justice Council (JJWC), Department of Social Welfare and Development (DSWD), among others, is currently in the city validating projects, programs and facilities geared towards ad-

BAGUIO CITY dressing multifarious concerns of minors.

> They are set to visit randomly chosen barangays to conduct their validation which include City Camp Proper, North Sanitary Camp, San Luis Village, Gabriela Silang, and Lower Magsaysay.

"The team," Domogan explained, "Is here to verify local projects implemented by non-government organizations and the local government.'

"We - the City Council for the Protection of Children (CCPC) composed of NG had a lengthy discussion with members of the national judging committee where partnership between the local government and private organizations were highlighted and for which we have earned the nomination.'

During said discussions, the city took pride in its City Government-NGO run "Center for Kids" in Balenben, Irisan.

Among others, it was revealed that even before passage of the Juvenile Justice Welfare Act (RA 9344) in 2007, the City already had a

facility wherein which, the diversion program for Children in Conflict with Law (CICL) was already being implemented.

24-minors are currently undergoing diversion in the facility reported City Social Welfare and Development chief Betty Fangasan. Baguio is the one of the few cities where kids no longer share iail cells with adults.

On top of this, the CCPC likewise revealed the nationallv recognized "Brotherhood for Peace" - a group of youngsters formerly involved in gangs and fraternities are helping put an end to senseless violence involving kids in the city through youthled projects.

Domogan said, "Kids welfare and education have always been our priorities.'

"As a matter of fact, the working ties of NGO with government in our city are incomparable to say the least as we have projects like the Ecowalk regreening project being implemented by the kids themselves."

Domogan bared the city also has the private-led Child and Family Services, the Baguio Center for Young Cont. on page 11
