The need to avoid panic in a crisis

BAGUIO CITY – Murphy's Law corollary: "When the top dog talks about improving productivity in waste and parks management, he is never talking about himself."

In a surprising move sure to rock dreams of some for better payday, mayor Reinaldo Bautista, Jr., November 10, ordered schism of one of the city's biggest yet "underperforming" departments - the City Environment and Parks Management Office (CEPMO).

Bautista, in Administrative Order 178-2008, said the strategy is geared towards "effectively addressing" CEPMO's twin concerns – parks and waste management.

He said the CEPMO's double trouble "have grown out of proportion[s]" and thus, the need to restructure the department into 1) the City Parks Management Office (CPMO); and 2) the City Environment Management Office (CEMO).

TTMC asked to submit traffic scheme evaluation report

BAGUIOCITY-

The city council Monday approved a resolution asking the Traffic and Transport Management Committee (TTMC) to submit an evaluation report on the results of the new traffic schemes being implemented in the city for several months now.

Proponent Councilor Betty Lourdes Tabanda said the TTMC should make a final recommendation on these traffic designs to determine if these are effective or not.

"With the experiments having been conducted for several months now, the TTMC can make a recommendation as whether the schemes are benefi-

Tabanda noted that one of the areas affected in the traffic rerouting is Marcos Highway, specifically the along the Campo Sioco area but that there have been several complaints regarding the implementation of the project, particularly on safety concerns.

Tabanda said she received reports that accidents happened in the area allegedly caused by the schemes and the barriers placed along the roads.

"Last October 5, 2008, a pastor named Edmund Foronda met an accident when his motorcycle collided with a traffic barrier which was set up as part of the

traffic scheme along the Campo Sioco Area. To date, the pastor is still recovering from the accident, Tabanda noted.

"There is an urgent need for the TTMC to determine the steps to be undertaken specially for of the safety of motorists who traverse these roads everyday," she said.

As approved, the evaluation report "must take into consideration the easing of the traffic situation, environmental and safety concerns and including recommendations as to what routes should be adopted for the City Council to take the necessary steps to amend existing ordinances."/Aileen P. Refuerzo

City inks accord with RCBC, YGC to beautify Rizal shrine

BAGUIOCITY-The city government hooked up with a private entity, the Yuchengco Group of Companies (YGC) through the Rizal Commercial Banking Corporation (RCBC) for the beautification of the Rizal Monument here.

Mayor Reinaldo Bautista Jr., YGC chairperson Helen Dee RCBC.president and chief executive officer Lorenzo Tan Tuesday signed a memorandum agreement (MOA) for this purpose in a fitting ceremony held at the Baguio Country Club.

During the program, Mayor Bautista expressed gratitude to the YGC for endeavoring to restore the Rizal monument, one of the memorial shrines in the city of which construction was made possible by the Baguio Jaycees Inc. in 1957.

Bautista said this will boost the city's on-going beautification campaign in keeping with its reputation as the country's summer

The venture made Baguio the pilot area for the Rizal Shrine restoration program by the YGC, which is part of its multi-sectoral campaign called "Buhay Rizal," an YGC socio-civic service initiative in collaboration with concerned government units.

will **RCBC** sponsor the pilot project in Baguio while the other upcoming restoration projects lined up in Batangas, Davao and Iloilo will be sponsored by RCBC Bankard, Malayan Insurance and Great Pacific Life Assurance Corporation (GREPALIFE), all flagship companies under the YGC.

During the program, Dee assured recipient local government units of the company's commitment to sustain the projects.

"Our conglomerate has always been founded on a strong sense of corporate social re-

City eyed as discipline zone

BAGUIO CITY— The city council wants the city police to adopt Baguio City as pilot area for its disciplinary reformation campaign or discipline zone in line with the celebration of the city's centennial charter anniversary.

The body last Monday approved the resolution authored by Councilor Perlita Rondez for this purpose.

The discipline zone as presented by city police director Supt. Wilfredo Franco is an area where existing laws and ordinances will be strictly implemented imposing

zero tolerance to lawlessness.

"This approach is based on the Broken Windows Theory under which theory, fixing a social problem is more effective if attacked while (the problem is) still small. Applied in law enforcement, it treats minor incivilities such as vandalism, begging.

Drunkenness, littering and graffit as the starting point of more serious crimes. Apprehending petty crimes and low-level anti-social behavior, at this stage, deters the occurrence of high level crimes."

Rondez said this endeavor should be

supported by law enforcers, barangay officials and the various stakeholders like the businessmen, civil volunteer groups, non-government organizations, religious groups and the academe.

"There is a need therefore for the Baguio City Police Office and the Local Government Baguio to study the possibility of being able to implement our very own discipline zone similar to the one being implemented in the cities ofManila. Paranaque, Marikina and Caloocan," Rondez said./ Aileen P. Refuerzo

World Diabetes Day:Pia: 'Adopt healthy lifestyle, fight

diabetes'

Senator Pia S.
Cayetano today made her own call for 'radical change' — particularly in the eating and health habits of Filipinos — as the country marks 'World Diabetes Day' November 14.

World Diabetes Day was started in 2006 by the United Nations, marking the fist time that a noncommunicable disease was acknowledged by the international body as a global concern.

"One of every five adult Filipinos is suffering from diabetes, which is a noncommunicable disease. It means that this ailment could be readily prevented if only more Filipinos would learn to take on a healthy diet and fit lifestyle, said Cavetano, Chairperson of the Committee on Health and Demography.

Cayetano expressed concern about the rising incidence of diabetes

among Filipino adults, based on a survey conducted last year by the Philippine Cardiovascular Outcome Study on Diabetes Melli-

Citing the survey, she said 20.6 percent of adults aged 30 and above were found to be diabetic — rising tremendously from the findings of a similar survey in 1998 which showed only 3.9 percent of Filipino

City council records said the city has appropriated a total of P70.5 million for the shipment of wastes to Capas, Tarlac until December 31.

In a resolution, the body urged Mayor Reinaldo Bautista Jr. to instead immediately implement measures particularly the rehabilitation of the Irisan dumpsite,

establishment of ten materials recovery facilities and purchase of nine dumptrucks, of which funding requirements were approved by the council recently.

The resolution authored by Councilors Rocky Thomas Balisong, Perlita Rondez, Erdolfo Balajadia, Betty Lourdes Tabanda, Nicasio Aliping Jr., N i c a s i o

Cosalan Jr., Fred Bagbagen, Joel Alangsab, Richard Carino and Elaine Sembrano was approved by the body.

In their resolution, the aldermen said the measures "aim to drastically reduce if not totally stop the hauling out of garbage outside of the (city) with the end in view of preventing the unnecessary deple-

Rizal's turtle and "Joc-Joc"

Remember Jose Rizal's fable "The Turtle and the Monkey"? Ang Pagong At Ang Matsing may offer a clue for today's puzzle: How will Malacanang spring former Agriculture Undersecretary Jocelyn Bolante from a Senate grilling on the P728 million fertilizer scam?

Rizal's fable tells how a cunning turtle outwits an angry monkey. "Turbner's Record" first published this illustrated tale in 1885. Historian Austin Craig includes this tale in his 1913 book on Rizal. "Don't throw me into the river", the turtle pleads in story. The monkey promptly does just that —enabling the turtle to scram.

The fable's point is simple To save your skin, be like the

turtle. Pretend to scorn what you really want.

The last thing

Malacanang wants is Bolante parrying questions from senators who egoes shift into overdrive before cameras. Over 200 legislators and governors sliced chunks from the P728 million fertilizer kitty. Now, some lose sleep over the prospect of their names hanging out with the wash.

Joc-joc clung to US immigration jail. When he run out of legal dodges, US marshals put him on the first flight to Manila. Since then, he's locked himself into his hospital "cell". But now, he has run though most medical tests. To stretch hospital detention, he's scrounging for new tests. This is a bizarre embrace of self-detention. "A man reaps what he sows".

Bolante and the Palace are boxed into a corner — with Rizal's turtle. They pretend to savor what they detest.

Malacanang won't gag Bolante by invoking executive privilege, Press Secretary Jesus Dureza announced. Thanks for nothing. "Joc-Joc" parrots Dureza. He'd dying to sing before "any investigator".

Who? Ombudsman Merceditas Gutierrez? "In 'history's lottery', Gutierrez was the First Gentleman's law school classmate," noted Viewpoint (PDI/ Oct 20,2005) "Even emperors have straw-sandaled relatives."

The 1987 Constitution adopted the Scandinavian innovation of a public interests defender. First crafted by 19th century Sweden, it became a worldwide weapon against sleaze. Filipino felt, rightly, that an Ombudsman should radiate that indefinable power which King Bhumibol of Thailand, for example, wields: moral authority.

The straight-arrow Simeon Marcelo rebuilt trust shattered by scandal-studded Ombudsman Aniano Desierto. Much of Marcelo's work has been flushed down the tube since.


Gutierrez has "proven a willing tool of the Palace to cover up anomalies" claims Senator Manuel Roxas." She dismissed, last wee, charges against administration officials bogged down in a P432-million fertilizer fund diversion quagmire in Mindanao.

The need to avoid panic in a crisis

The Organization for Economic Cooperation and Development (OPEC), a grouping of the world's 30 most developed countries estimated that the United States economy shrank 0.3% in the third quarter this year and would have 2.8% shrinkage by the end of 2009.

Technically, two quarters of negative growth implies a recession. OPEC says that the world's biggest economies are in recession. Concretely, the top 30 developed countries of the world are seen to have a declining output totaling to 0.3% in 2009. The said countries include Japan whose output are seen to drop by 0.1% and Europe at a 0.5% drop.

On the other hand, OPEC believes that China will only experience a slowdown, suggesting that much of the source of its growth is domestic rather than international.

Many Americans are feeling the brunt of the crisis. The bulk includes retirees who found one day that their wealth has reduced been by around half or even to almost nil. They have invested their pensions in the stock market but the prices therein have dropped by so much.

On the positive side is that the price of oil dropped to \$55 a barrel from a high of almost \$150. It is believed that the consumption of petroleum will likely drop more severely than any time since

Worst, the US government announced that the \$700 billion bailout plan would no longer buy assets of troubled banks. This means that those who were bankrupted by the crisis will remain

The Philippines will definitely feel the pinch and punch of the crisis. In the early part of the year there will be pains from the pinch of the crisis and then the punch will probably be felt late next year and even in 2010 and 2011.

The ADB sees no recession for the Philippines in 2009. This simply means that there MAY be no negative growth. However, growth may slowdown given an increasing population. There may be no significant increase in employment that would absorb the army of unemployed every graduation time.

Thus, there can be widespread suffering even if there is no recession. Those who are employed may not feel so much the crisis. In contrast, those who have no employment and who have just entered the labor force may find themselves unemployed. Those who are employed today may fall into the unemployed.

There can be a small income growth but those below the poverty line can increase. Further, the magnitude of people who are unemployed will also increase.

Outsourcing is seen as a bright light in the sea of global gloom. However, the increase in business from outsourcing may not be much and will likely benefit only those who have established themselves in the market for so long ago. This is because even as the US firms decide to outsource from developing countries, the market has shrunk.

Just how the crisis would spread from the US to the world to the Philippines would also depend on how Filipinos would react to the crisis. During the Asian Currency Crisis of 1997, for example, our "economic fundamentals" or economic indicators have been fine but the panic in the currency crisis significantly decreased our income per capita.

If, for example, there is panic, then the crisis would be magnified by so much and the Philippines would experience not only a recession but also a crash. The coming national elections can worsen the impact of the crisis, especially if the results are not seen as legitimate.

Rotary Int'l breaks silence in Jocjoc's case

ROTARY INTERNATIONAL SPEAKS ON BOLANTE: I am a Rotarian since 2004, and I have learned to appreciate the kind of service that Rotary International delivers to the poor, the needy and the destitute here and in many other parts of the world, a service which is called "service above self".

It hurt me no end therefore to find many people literally destroying Rotary and what it stands for, by making unsavory, if unjustified and unfair, connections between it and the accusations against another Rotarian, former Agriculture Undersecretary Jocelyn "Jocjoc" Bolante, as if Rotary had something to do with those accusations, when such is not the fact.

Now, I am glad that Rotary International, through its Philippine Zone Public Imaging Group Coordinator Lyne Abanilla (of the Manila Bulletin), is finally coming up with a stand on the issue, through letters to media entities, and through a statement that will be published in due

I am reprinting portions of Abanilla's letter here, so the public may know:

GIVE BOLANTE HIS RIGHT TO DUE PROCESS: "Warmest Greetings!!!

"Rotary International, through its officers in the Philippines, regrets that it is the one organization that is constantly linked in the media with the name of Joc Joc Bolante. Never is his residence, business or church affiliation, or other ties used as an adjectival adjunct. It is as if the man had no other identity than as a Rotarian and that somehow the Rotary International shares in some way in the accusations that have been brought against him.

"While we acknowledge that Mr. Bolante distinguished himself as a Rotary officer, it is unfair to consistently link his name to Rotary in an attempt to demean the International Organization by presumed implica-

Pia warns Palace: Don't invoke executive privilege in fertilizer fund

scam probe

Senator Pia S. Cayetano today cautioned the Arroyo administration against suppressing the truth at the Senate hearings on the reopened P728million fertilizer fund scam following the unimpressive testimony of former agric u 1 t u r e undersecretary Jocelyn 'Joc-joc' Bolante Thursday.

"Malacañang should think twice before invoking executive privilege or restraining agriculture officials from telling the truth at the Senate next week just to cover up for Bolante's grossly incredulous testimony," warned the lady senator.

Cayetano made the statement after Deputy Presidential Spokeswoman Lorelei Fajardo suggested in a media interview Thursday that Malacañang may invoke executive privilege to stop officials of the Department of Agriculture (DA) from testifying at the reopened probe.

"It's a shame that the Executive Branch is even floating the idea of invoking executive privilege over what clearly is a multi-million-peso scam that has been thoroughly documented by the Commission on Audit, the Senate, media and civil society groups," she said.

"How can the Palace consider derailing the inquiry when millions of Filipinos following this issue are aware that so much taxpayers' money may have been lost from the public coffers?" she asked.

"Whoever made the suggestion [to consider invoking executive privilege] should be fired by Mrs. Arroyo," she stressed.

Cayetano urged the Executive to instead allow DA operations personnel and regional officers to freely testify before the senators to test Bolante's claim that he had no hand in the release of the

funds at the local level. All official documents relating to the fund should also be made available for scrutiny.

"It is said that this regime was built on fraud, and from all indications, it also seems bent on perpetuating itself through lies and cover-ups, and even more fraud."

"Where else can you see a public official given so much power to disburse millions of government money, but who doesn't see the need to exercise a shred of responsibility in ensuring how these funds are used or whoever ends up with it?"

"Bolante's incredible testimony can be summed up in just three words: governance without accountability."

It's precisely this kind of governance that has bred so much public distrust and discontent with the Arroyo administration," she concluded./Office of Senator Cayetano

Ifugao fathers train on ERPAT

LAGAWE. Ifugao - In order to equip the fathers here with proper knowledge, attitudes and skills in facilitating the Empowerment and Reaffirmation of Paternal Abili-Training ties (ERPAT), the Provincial Social Welfare and Development Office conducted recently a three day training here.

The schism, effective November 15, did not only move letters in the "CEPMO" acronym, it likewise laid down foundation for addressing specific concerns by acknowledged connoisseurs in the separate fields of parks administration and waste management.

CPMO shall be led provisionally by erstwhile CEPMO interim chief Cordelia Lacsamana. It shall take care of watershed, parks, and cemetery management chores.

On the other hand, general services officer Romeo Concio rebounds as the city's garbage czar, with CEMO chores relegated to his department.

Waste management used to be a function of the General Services Office until City Hall was restructured sometime in 2004, under erstwhile mayor Bernardo Vergara.

Parks management, on the other hand, used to be a function of the defunct City Architect's Office.

Meanwhile, acting mayor Daniel Farinas revealed former waste management interim head Engr. Nazita Banez will appeal the mayor's order, which placed her in a veritable limbo insofar as function and designation is concerned.

Farinas revealed Banez' detail as interim assistant to Lacsamana under CEPMO has been recalled under the same order.

Consequently, she is back to her old duties as demolition team head - a division under the City Buildings and Architecture Office (CBAO) – a position she dreads because of a shooting incident which nearly caused her life.

The acting chief however said, "The mayor's decision stands until subsequently amended."

"Some may be hurt but as far as I see it, a lot more appreciate the order, viewing the same as the mayor's demonstration of political will."

He however clarified that the order is merely experimental as council action is needed to make the order permanent./ISL

twelve (12) years.

The bill further amends Article 365 of Act No. 3815 of the Revised Penal Code.

Common carriers' criminal liability is found in Article 365 of the Revised Penal Code, Criminal Negligence, which provides as penalty of imprisonment arresto mayor to prision correccional or from one (1) month to four (4) years and two (2) months, depending on the gravity of the resultant crime or felony.

Escudero said these penalties may no longer be apt with the way common carriers, especially buses, have lightly treated their obligation under existing laws.

He added that the culture of carelessness among buses or common carriers is already too alarming too ignore.

A report by the Asian Development Bank identified the Philippines as one of the developing countries with the worst number of deaths on roads, recording one thousand or more every year.

As early as 2003, the Department of Health Road Safety Program statistics already showed that road accidents ranked as the fourth leading cause of deaths among Filipinos and first in terms of injury morbidity, which is 20%.

"As a matter of fundamental statutory policy, common carriers are required to carry their passengers safely as far as human care and foresight can provide, using utmost diligence of very cautious persons, with due regard for all the circumstances" Escudero quoted.

He said stern measures need to be implemented to ensure road safety. "Conscious efforts from all sectors of government and the society should be at high level to avoid further loss of lives and damage to person and property"

An increased penalty for criminal negligence by common carriers, Escudero said, serves not only a reminder to extant statutory duties to public utility vehicles but as a means to put an end to recklessness and irresponsibility which at times already appear intentional and malicious.

"It is not uncommon to hear complaints against erring bus drivers who recklessly race on the road, weaving in and out of the lanes of our major thoroughfares without anymore regard for our traffic rules and safety nets".

This practice, or malpractice of erring common carriers are just accidents waiting to happen which often results to death, crippling and injuring of innocent passengers and pedestrians, Escudero said./Office of Senator Chiz Escudero

tion of the financial resource of the city."

They said these should instead be pursued "to conserve the financial position of the city and at the same time provide for a substantial period for the city to acquire a site for the proposed engineered sanitary landfill.

The body earlier approved Ordinance No. 94 providing for P15 million fund for the rehabilitation of the dumpsite by way of stabilizing the big pile of solid waste to prevent spillage or erosion into the community below it. The measure further provides for the mining of compost fertilizer for use or sale.

"The work that will be done will not only stabilize the pile of solid waste but at the same time it will also leave a space which can be used for the deposit of solid waste generated by the City of Baguio for at least five months thereby lessening or totally stopping the hauling out of garbage for the same period of time while the city is scouting for an appropriate site thereby saving the city approximately P75million for a period of five months as the city is paying approximately P15 million monthly for the hauling out of garbage to Capas, Tarlac landfill," the aldermen noted in a resolution.

The body also approved Ordinance No. 93, which provides P15 million for the establishment of ten MRFs for ten clusters of barangays with composting plants. They said this reduce waste by one ton per day for each MRF clus-

Ordinance No. 79, meanwhile, provides P12,600,000 for the immediate purchase of more or less nine dump trucks to also hopefully cut down on the cost of transport of the wastes. / aileen p. refuerzo

adults to be diabetic.

Young Filipinos face similar risks, noted Cayetano, as she cited estimates by the Philippine Society of Pediatric Metabolism and Endocrinology that around eight percent of Filipino children may be diabetic.

"The number of Filipino children afflicted with diabetes continues to rise, but this could be curbed if their parents would only set a good example. Prevention is still the best option, as they say. Adopting a healthy lifestyle is something that parents need to pass on to their children to prevent so-called lifestyle-related diseases like diabetes," she said

According to the Department of Health (DOH) website, diabetes is a serious chronic metabolic disease characterized by an increase in blood sugar levels associated with long term damage and failure or organ functions, especially the eyes, the kidneys, the nerves, the heart and blood vessels.

Those who are prone to this ailment include children of diabetics, obese people, people with hypertension, people with high cholesterol levels and people with sedentary lifestyles

To prevent diabetes, the DOH advises the public to eat plenty of vegetables, avoid sweets such as chocolates and cakes, cut down on fatty foods, avoid alcohol drinking and stop smoking and exercise regularly. Obese people should try to lose some weight, while those with hypertension should consult their doctor for advice and management./Office Of Senator Pia Cayetano.

ground for the revocation or suspension of the business permit or license for a period of not more than ten days for the first violation, 30 days for second violation and cancellation of business permit or license for the third and subsequent violations.

Pirated, counterfeit or fake goods and articles of any person engaged in any business or trade with or without any license or permit shall be taken into preventive custody and disposed of in accordance with the law.

Inspection of the business establishment concerned is conducted afterwhich notice of suspension or cancellation of the business license or permit shall be issued by the municipal mayor. A fine of P2,500.00 or an imprisonment for a period not exceeding 6 months or both in the discretion of the court is imposed on any person who having been issued a business license or permit shall commit breach of the conditions provided in the ordinance; any person who, without any business license or permit shall engage in the sale, rental, transfer, distribution, manufacture and/or production of pirated, counterfeit or fake goods, articles or services; ay person who shall violate the order of the municipal mayor suspending or canceling a license or permit or taking the subject goods into custody./Juliet B. .... from page 12 reveal that Inchimag wanted to be remembered by the generations after her in spite of being childless.

The locals recounted further that the stones used for the construction were carried up by hands from quite a distant Pinuwo' river and the clay (oklet) to cement or seal the stones together were carried down from a distant elevated area called Tanaw.

The other apfo'or now starting to collapse is that of Uhupfan, a fierce yet childless chieftain in the early period of Mayoyao. Elders unveiled that he was mocked by the people in his community because despite his fierceness, his body will be eaten by dogs when he dies because he has no children to take care of

"Challenged by the ridicules and with a wish to be buried respectably and honourably befitting his status, he planned to build his apfo'or on the hill called Tomo'," the locals said. "He had a hundred bundles of palay pounded on the site and 20 pigs butchered to feed the people," they added.

Gloria Likiyan, one of the indigenous knowledge holders, said she feels bad that the collapse and eventual extinction of the apfo'or burial tombs are manifestations that they are losing their cultural heritage.

"These cultural masterpieces tell something about our past and someone must initiate to find ways to preserve and improve it," Likiyan said.

Some conservationists say that losing such cultural masterpiece would mean the eventual loss of this town's distinctiveness to other places or to other cultures./ Jeremy M. Gawongna

Another Ifugao cultural masterpiece now faces eventual

extinction

Mayoyao, Ifugao - While the provincial government of Ifugao through the Ifugao Cultural Heritage Office now exerts effort to repair the damaged portions of the rice terraces, other historical and cultural masterpieces here now face eventual extinction.

Among these cultural masterpieces are the apfo'or burial tombs erected in It is a rounded stone-walled enclosure where to put in the sitting dead person and constructed to keep away rodents and other animals from ravaging the body. Elders here

narrated that only the well-todo in those times made use of apfo'or to hold their dead. The construction, according to them, was done through bare hands and crude impledomes of the two of these burial tombs collapsed after the passage of years. Besides, weeds and other plants grew over it

One of these tombs is that of Inchimag, wealthy yet childless woman in olden times who had her apfo'or built in full exposure to the sun at the edge of the mountain range of Ottong which could be accessed in just a five-minute walk from the recently constructed Mayoyao hostel.

This serves as a memorial grave since accounts from oral tradition Cont. on page 11

Sadanga crafts ordinance pirated, fake goods

SADANGA. Mt. Province municipal The government here adheres to the policy of the national government to curb the proliferation and introduction into commerce of pirated, counterfeit or fake goods, articles or services and the commission of other acts that violate intellectual property right as protected by law.

Municipal Ordinance No. 64, s.2008 recently approved by members of Sangguniang Panlalawigan, curtails the sale, rental, transfer, distribution, manufacture and/or production of pirated, counterfeit or fake goods, articles or services.

Piracy and counterfeiting of intellectual property rights will not only cause economic prejudice and demoralization among legitimate businessmen and establishments, but also undermine the municipality's strategy for growth and development and unrealized revenues and taxes, ordinance the stated.
