#### Mayor Orders Clearing of Illegal Market RDC Supports City's Effort to Preserve long neglected zoncontinue to defy the Stalls

**BAGUIO CITY**  Mayor Mauricio Domogan last week ordered the removal of all illegal stalls and extensions at the city market to restore order at the city's trading center.

The mayor said this was firmed up during Wednesday's meeting of the Baguio City Market Authority (BCMA) which he heads.

The group decided to summarily remove all unauthorized stalls and extensions to restore the ing policy at market

The mayor assigned the City Market Task Force headed by city administrator Carlos Canilao to map out strategies to implement the clearing operations in coordination with the city po-

Market superintendent Policarpio Tamayo said illegal extensions are rampant along the market sections along Zandueta, Kayang and Hilltop roads...

He said these are owned by enterprising vendors who city's rules despite the city's efforts to put back order at the market place.

He said some of the vendors have been awarded spaces but still venture to put up extensions in unauthorized areas.

# **Pine Stands and Forest Reservations**

The Regional Development Council has joined Baguio in its efforts to preserve and conserve what remains of the diminishing forest resources, pine stands, open spaces and other unique natural qualities that made it the country's Summer Capital and and a national heritage city.

In its en banc meeting last Nov. 12, the RDC endorsed the city's request for the cancellation of private ancestral land certificates over portions of the city's watersheds and forreservations such as the Forbes

The RDC will

endorse to President Aguino the city's request for the President to ask the Solicitor General to petition for the cancellation of ancestral land certificates issued by the National Commission Indigenous Peoples covering forest and other government reservations in

"This is a very serious problem," city mayor Mauricio Domogan told the RDC of the recent decision of the NCIP to award portions of the city's forest reservations to ancestral land claimants.

"We support legitimate ancestral land claims, but let us the law, follow

Domogan stressed, implying that the NCIP wrongly interpreted provisions of Indigenous People's Rights Act (IPRA) on which it anchored its issuance of ancestral land certificates over government reservations and forest reservations here.

The mayor pointed out that under Sec. 78 of the IPRA, Baguio will continue to be governed by its charter and that prior land rights issued by government bodies and the court before the effectivity of "this law" (IPRA) shall remain valid.

## City Mounts Anti-Crime Offensive to **Stem Rob Tide**

**BAGUIOCITY** - An anti-crime offensive is in the works here to stem the tide of robbery cases, even as police statistics showed a considerable decrease in crime volume from August 1 to No-

vember 20 this year. Mayor Mauricio Domogan Monday convened the City Peace and Order Council (CPOC) to assess the crime situation and map out counter measures following a spate of robbery incidents in the city.

During the meeting, the city police officer under city director David Lacdan reported that the city's crime situation "remains at a manageable level" as police records showed that all

## Disaster Team Beefed up

BAGUIO CITY - The city government sought to further improve the city's disaster response capability by harnessing the involvement of the private sector in the activities of the City Disaster Risk Reduction and Management Council (CDRRMC).

Mayor Mauricio Domogan last week amended the composition of the CDRRMC to include the public utility companies particularly the Benguet Electric Cooperative Inc., Baguio Water District (BWD), Philippine Long Distance Telephone Company (PLDT, Sky Cable and Mountain View Satellite Corporation and others in the team's roster of membership.

"There is a need to include the private sector, particularly the public utility companies... to enable the city to effectively and efficiently attend to the needs of people who are directly and indirectly affected by man-made and natural calamities as well as enhance the city's disaster risk management system for the benefit of the public," the mayor noted in his Administrative Order No. 173 series of 2010.

The mayor chairs the CDRRMC while the city administrator acts as its action officer. The members include the following: head of the Disaster Operations Center, city engineer, city accountant, city budget officer, city treasurer, city local government operations officer, city building official, public information officer, city health officer, city police director, city fire marshal, city social welfare and development officer, city schools superintendent, Association of Barangay Councils (ABC) president, Baguio Correspondents and Broadcasters Club (BCBC), and representatives of PAGASA, PHIVOLCS, Philippine National Red Cross Baguio, Baguio City Emergency Medical Service and accredited rescue groups.

In a post-operation assessment meeting after typhoon "Juan" last October, the mayor urged the CDRRMC members to further improve coordination to speed up delivery of services during calamities.

He also reminded government offices of their obligation to relax office protocol to facilitate all the needs and requirements during emergency situations.

The mayor also urged barangays to form their own disaster teams to respond to low magnitude emergencies in their areas of responsibility./A Refuerzo

Last October 22, he issued Administrative Order 176-2010 mandating strict compliance of redplated vehicles with pollution limitations set under Ord. 61-2008.

These, as his gift to the City of Baguio on the occasion of the Department of Environment and Natural Resources' (DENR)declared Clean Air Month this Novem-

BAGUIO CITY-Last week was a high performance week for anti-narcotic operatives of the Philippine Drug Enforcement Agency (PDEA) -Cordillera Administrative Region (CAR) as they arrested three alleged drug pushers and confiscated over P170,000.00 worth of marijuana and shabu in the city, and eradicated an estimated P

1,448,000.00 total worth of marijuana plants in Kapangan, Benguet.

PDEA agents on November 18 apprehended Mary Jane Fernandez Espiritu alias "Myles", 24, Computer Secretarial graduate, jobless, native of Labrador, Pangasinan and resident of Jasmin St., San Luis Village,

Baguio City and her cohort, Christian Pascua Facunla, 24, college student, native of Tarlac, Tarlac and residing at Modern Site, Bakakeng, Baguio City for selling shabu to a drug law enforcer posing as buyer. Seized from the two was about three grams of shabu, which amount to an approximate street cost of Cont. on page 11

## New Can Of Worms?

"How great are the dangers I face to win a good name in Athens," Alexander the Great worried. Jose Velarde never read Alexander. Don't fret. Despite dangers of pending plunder charges, "Velarde" wants to clear his name in Manila.

Who is Jose Velarde?

Today, few recall the uproar when the Impeachment trial of Joseph Estrada tossed up an Equitable Bank book in the name of "Jose Velarde. Deposits in that account caroomed from an initial one peso to over P3.2 billion --- in less than a year.

"Jose Velarde" was not his name Erap insisted –at least through part of his tumultuous impeachment. But in February 2002, he admitted to ABS-CBN's Pia Hontiveros, out of the blue, that he signed as "Jose Velarde". That was to guarantee a half-a-billion loan for crony William Gatchalian of Wellex. The account belonged

to Jaime Dichaves."
"Did he just
borrow the name?
Viewpoint asked then

"Was this THE Jose Velarde everyone futilely searched for, since impeachment erupted into People Power Two?" The Anti Graft court found: Estrada and Jose Velarde were one and the same persons. But that was years down the road.

The impeachment trial probed if Erap did instruct GSIS, through it's president Federico Pascual, to snap up P290 million shares of stock in Belle Resources ---owned by Jaime Dichaves and cousin, Willy Ocier. Social Security System president Carlos Arellano bought 447,650,000 shares in Belle Corp. Who got the hefty commission of P189.7 million?

Dichaves didn't wait to answer. He skipped town ahead of sheriffs waving arrest orders. He didn't leave a forwarding address. Now, is he coming back for real? (Fugitive Panfilo Lacson take note.)

The Chinoy fiberglass manufacturer was among those who chipped into Erap's campaign fund "The neat and bespectacled Jaime Dichaves was a very frequent visitor, (at Malacanang) usually after dinner", recalls cashiered executive secretary Aprodicio Laquian in his book: "The Erap Tragedy."

Dichavez "was every ready to greet people with his affable smile. He was never obtrusive, spoke only when spoken to, and was always very polite.

Did another Dichaves emerge within the alcoholic haze of Estrada's "midnight cabinet"? There, carousing often-soused cronies would "stagger out the door," Malaya's Ellen Tordesillas wrote: Policies and appointments done on the fly...from top-of-the remarks of (those) who may have been inebriated or not...."

That cabal joshed Dichaves as "King of Subic", Laquian recalls He "allegedly smuggled, chicken, cigarettes and other goods purchased through the Subic Bay Freeport.

Dichaves performed as "Erap's errand boy," Laquian wrote. He also supplied choice Petrus wine the cabinet swilled. "(A bottle 1997 Rouge Pomerol costs P34,887. A Bourdeaux Rouge fetches P40,533). Nothing too good for an administration sworn to uplift the poor. Erap Para Sa Mahirap.

"Joseph is a good man," Laquian recalls the late Dr Emilio "Toti" Ejercito, brother of the President, saying in a private talk. "But he can be negatively influenced by some of his friends. Help him."

People that were flagged to Laquian's attention included: Charlie "Atong" Ang; William Gatchalian, Jaime Dichaves, Luico Lao Co and Dante Tan. "But it was next to impossible. The President was always quick to defend his friends any form of critcism."

Now, Dichaves has asked the Sandiganbayan: Quash criminal charges filed for alleged collusion with Erap to commit plunder. The court should recall an arrest warrant that has gathered dust. Or conduct a preliminary investigation.

Not in absentia, of course, Dichaves intends to come back and address all charges, says counsel Pacifico Agabin. He "invokes his constitutional right to due process" He "moves to quash the Amended Information against him.

Guzzling Petrus wine is luxury, not plunder. What are the implica-

Jolibee must be getting special treatment from the government. Sobrang lakas nila sa president natin at na-invite nila siyang mag gupit ng ribbon nila!



Lacsamana said her office is aggressively enforcing city ordinances as the priority of the city is a clean envi-

She added 67% of flagged vehicles have failed the Road side Tests conducted by the Roadside Inspection, Testing and Monitoring Team (RITMT) and her office has already collected 1.9M from violations.

Lacsamana also revealed 5 challenges they usually encounter during operations which include on site intimidation and harassment of the monitoring team.

We know that drivers who are flagged down will defend themselves but we tell our people to keep their cool and do their job, she said.

Damage to vehicles while being tested is number 2 in their list as the monitoring team usually gets the blame when something gets damaged.

Lacsamana however said there are vehicles being tested which really needs repairs.

Political Intervention is third, violators seek the assistance of politicians to be exempted from penalties but we do not give exemptions, she said.

Lacsamana added interventions will not be entertained.

The 4th challenge she said is the claim of some sectors with regards to discrepancies with readings from private emission testing centers relative to emission readings.

Lacsamana stressed RITMT personnel have been trained with TESDA. She however said they will be recommending parallel testing with other PETC's so that they could agree on certain variables and levels which are acceptable to all.

RITMT team is also exposed to health hazards during operations making it the 5th challenge we face, she said./ paul rillorta

"She was one of the very few who could link President Estrada to the Jose Velarde persona. She was 'very, very scared.' To spare her from harm, the court had docketed her as an unscheduled witness.....

"Face twitching with emotion, Estrada's former finance secretary Edgardo Espiritu stunned the Court when he said: Estrada was the real owner of BW Resources, the company at the center of a massive fraud that had nearly destroyed the nation's financial markets...

(He) cited the deplorable presence of drug traffickers and commercial smugglers.(Asked to name them), Espiritu demurred: 'We know many have died doing that."/J.L.mercado

spelled out by Ngalob, are autonomy, integration through reliable transport and communication networks, social and human development, sustained economic growth, environmental quality and sustainable use of resources and cultural integrity.

Following last May's elections, the RDC adopted a new thrust towards autonomy, with city mayor Mauricio Domogan heading a special committee tasked to gather inputs from down to the grassroots level for inclusion in a new draft charter set to be presented next year.

Domogan, one of four nominees for chair or co-chair of the RDC, said the draft, the third so far after the previous two were rejected in plebiscites, is expected to be finished by February for submission to the Office of the President and Congress.

The autonomy committee has adopted five core principles for the fresh push for self-rule that jibe with the development goals Ngalob outlined: permanent regional identity, non-diminution of existing benefits to and powers of the Cordillera region, subsidy from the national government, continuous payment by national government of nationally paid officials and employees, and continuous provision of budgetary allocation to the region.

The Nov. 12 RDC en banc meeting here also adopted 10 key focus areas: agri-industrial technology and knowledge-based industries, prime education center, watershed cradle, indigenous culture and knowledge, social development and good governance.

If their attendance in the RDC en banc meeting is any measure, private sector representatives are more serious in pushing regional development than their government counterparts mandated by their elective or appointive positions to be active partners in good governance./Ramon Dacawi.

judicial and administrative proceedings that reopened the screening of petitions for ancestral land claims before the IPRA was passed and made effective.

NEWS

The RDC likewise supported the city's request for President Aquino to intervene for the city's acquisition of the Baguio Convention Center using the city's share from the rentals of Camp John Hay as payment to the Government Service Insurance System which owns the facility.

Corollary to this is the RDC's support to the city's clamor for the GSIS to maintain the forested area beside the Convention Center as a tree park, it being one of the few remaining areas with pine trees within Baguio's central business district.

The regional policy-making body also endorsed the city's other concerns to the national government presented by city planning and development coordinator Evelyn Cayat, including a request for the President to certify as priority the bill authored by then Rep. Domogan to amend the city's charter.

Others are the fast-tracking of the segregation of 14 barangays from the Camp John Hay reservation, localized composition of the awards committee covering townsite sales applications and funding for the Burnham Park, completion of the city circumferential road and solution to the perennial flooding of the thickly populated City Camp basin.

On the preservation of the mini-pine stand beside the Convention Center, former RDC co-chair and educator Virgilio Bautista noted that then President Arroyo promised to ask GSIS to maintain it as a forest.

The GSIS, which acquired the convention center lot and the now-pine forest for free by virtue of an order by then President Marcos, plans to develop the pine forest as a commercial area in a joint venture with mall giant Shoemart.

The business infrastructure project, dubbed "Baguio Air Residences", drew opposition from city officials, residents and visitors who said the mini-forest should be preserved and maintained as such to serve as a green buffer vis-à-vis the continuing urban sprawl.

"The Baguio Centennial Commission even installed 'thank you' notes to President Arroyo within the mini-forest but these were removed," Bautista recalled.

School children who visited the miniforest also wrote to thank President Arroyo for sparing the patch of pine. Tarpaulin enlargements of their letters installed inside the forest were also carted away. Pupils of the Baguio Pines Family Learning Center replaced the stolen letter-posters but these were also stolen.

Among the first to oppose the GSIS-Shoemart venture were members of the Igorot Global Organization who, in a resolution at their 2008 biennial conference in Banaue-Ifugao, noted that the pine forest remains a symbol of Baguio as a heritage city./Ramon Dacawi.

crimes, both index and non-index, along with the city's Average Monthly Crime Rate (AMCR) decreased by close to 60 percent from August 1 to November 20 as compared to last year's figures.

The police however admitted that although the number decreased, robbery cases have "remained alarming" in the city necessitating immediate counter measures.

As a result, the police mounted an anticrime strategy dubbed "BCPO Implan 26.2010" or the Crime Prevention Strategic Plan which spells out counter measures and tactics to boost crime prevention in the city.

The strategy is anchored on beefing up intelligence operations, improving personnel movement, implementing a 12-hour service among operatives, increasing police visibility and mobility among others.

The police asked the CPOC to endorse the plan to the city council for adoption and support.

They also strongly recommended the activation of peacekeeping units in the barangay level to assist in preventing and responding to crime incidents in their areas of responsibility.

The mayor agreed that a collective effort is needed to address the problem and stressed that this could be done by harnessing the participation of the community.

Heads of the barangays with most number of crimes who were invited in the meeting committed to strengthen their tanod system to conduct night patrols to help in deterring crimes in their respective areas.

Vice Mayor Daniel Farinas also encouraged the barangays to also tap civilians like the neighborhood associations, non-government and civic groups to help in the anticrime campaign. He cited the concept of the "Kapitbahay Ko Bantay Ko (KBKBK)" group advocating for neighborhood watch to guard against crimes and urged the barangay officials to organize similar groups.

The mayor directed the police to incorporate the civilian component and the KBKBK concept in the Implan.

During the meeting, the CPOC approved a resolution requesting the Philippine National Police for additional manpower to augment the city police force.

The city police office is presently undermanned with protection ratio of one cop to 1,400 persons based on the city's day-time population.

Police Station 7 Commander Larry Buansi reiterated his reminder to the public to also do their share by properly securing their own houses and valuables to keep thieves at bay./A Refuerzo

Under the AO, all local government departments are mandated to submit their respective vehicles for testing with CEPMO.

CEPMO on the other hand shall submit a report on testing done within a period of 15days from October 22.

Domogan said, "Government officials and personnel who refuse testing or repair if their vehicles are found violating the ordinance shall be dealt with accordingly."

He added, "[Henceforth, as a means of setting an example for private motorists], emission testing of government vehicles shall be done every six months."/isl

and bettors of illegal gambling in the city; and a 2008 manifesto by Liga officials saying 'no' to all forms of illegal gambling, including bingoteng.

On air, Domogan once again guaranteed, "I am against all forms of illegal gambling in the city.'

He warned, "If the activity is found in violation of our policies and laws, by all means, it will be closed; its perpetrators, apprehended."

"I have already sent memo to the Baguio City Police Office chief to intensify our anti-gambling campaign, even specifying some locations where gambling has been reportedly thriving," he warned.

To confessed bettors bingo sa barangay or bingoteng, jueteng, and STL two-ball are all the same; the difference lying only on the operator.

Apparently bingo sa barangay is run by the littlest local government units for 'fund raising purposes;' while the other betting schemes are either run by the Philippine Charity Sweepstakes Office (PCSO) or administered by ghosts.

Scrutinized however, all the two-number lottery schemes can barely be distinguished from one another except bingoteng has 38 number-choices represented by digits between '1' to '75' from which lucky number combinations are drawn.

During an earlier presser meanwhile, Liga public relations officer Benjamin Macadangdang revealed, "The board never authorized anybody to operate bingo sa barangay.'

"Thus," he added, "any operation of the same should be condemned.

Meantime, church leaders and their respective cliques of anti-gambling hordes are planning to march sometime next week to urge local officials to be adamant in saying 'no' to all forms of gambling in the city./isl

Reports said Espiritu was also nabbed in 2008 with her live-in partner, Joel Fallorin, and two cohorts for sale, possession and use of shabu.

In a separate buy bust operation at Rizal Park, Baguio City, Ike Lagadeo Wadingan 22, single, and native of Belanse, Nueva Vizcaya was immediately apprehended after he delivered dried marijuana fruiting tops in three cylindrical forms and one large block to a PDEA - CAR anti-narcotic operative who acted as poseur-buyer. The illegal drugs had a total value of PP128,750.00.

Criminal cases for Violations of Section 5 (Sale of Dangerous Drugs) in relation to Section 26b (Conspiracy to Sell Dangerous Drugs) and Section 11 (Possession of Dangerous Drugs) of Republic Act 9165 or the Comprehensive Dangerous Drugs Act of 2002) were filed against Espiritu and Facunla before the Office of the City Prosecutor in Baguio, while a case for Violation of Section 5 (Delivery of Dangerous Drugs) was filed against Wadingan.

Meanwhile, two teams of PDEA – CAR agents conducted MJ eradication operation from November 17 to 19 at sitio Pingew in barangay Sagubo in Kapangan,, Benguet yielding 6,400 full-grown marijuana and 4,200 marijuana seedlings. The marijuana with estimated cost of over P1.4 million e were destroyed in eight different cultivation sites having an approximate entire land area of 1,400 square meters. Concerned citizens helped in the destruction of the destructive hemps.

The operatives also conducted dialogues and consultations and information dissemination to the residents on the ill effects of marijuana use, legal implications of marijuana production and trading, participation of the community in the enforcement of the drug law and other related issues.
