# es Peers, Bets to Follow

Senator Chiz Escudero submitted to the Senate secretary his statement of assets, liabilities and net worth (SALN) Thursday to best the April 30 deadline and with it a signed waiver on secrecy of bank deposits in line with his transparency challenge issued earlier to public servants.

The Code of Conduct and Ethical Standards for Public Officials and Employees (RA 6713) requires all government officials and personnel to submit swom SALN documents within 30 days after assuming office and not later than April 30 every year thereafter.

Along with his SALN submission, Escudero said he is reiterating a challenge to his peers in the Senate and candidates for the elections next month? to execute bank secrecy waivers to give the Office of the Ombude:

# Cut Discretion, Red Tape, to Reduce Graft

Equating discretion to corruption, Senator Chiz Escudero said the results of the Report Card Survey (RCS) of the Civil Service Commission showing some 150 government offices miserably mired in red tape was a testament to the deep-seated culture that breeds corrupt practices in government.

"I have always advocated that discretion equals corruption and cutting red tape is putting a stop to discretion," Escudero said.

Based on the RCS, those who failed the efficiency test were offices of the Government Service Insurance System, Civil Aviation Authority of the Philippines (Butuan City branch), Philippine Postal Corp. (Butuan City branch), National Bureau of Investigation (ARMM and Butuan City branches), Bureau of Fire Protection (Baguio City branch) and eight branches of the Bureau of Customs (BOC).

The study was conducted by the CSC last year.

Escudero said red tape has been a persistent problem that hounds every administration.

"Discretion multiplies at the same rate that an official's signature is affixed to a document, thus, reducing red tape is in itself removing invitation to corrupt practices," he said

"In a technologically advanced paperless world, it's a big mystery why it is still necessary to have an average of 10 signatures on documents to transact with the government and to have the signatories decide on the fate of the person seeking to avail of government service," Escudero lamented.

## Residents Take Hold of Titles, now Legal Owners

BAGUIO CITY – the Land Registration Authority (LRA), Registry of Deeds here has awarded land titles to applicants been waiting for it for some time now.

Around 27 Administrative Patents were awarded, bulk of which come from Free Patents, 3 Townsite Sales Applications(TSA) and 3 under Certificate of Ancestral Land Titles (CALT) during Mondays flag rasing Atty. Noel Aperocho who heads the Registry of Deeds handed over the titles to; Winston Casiwan, German Mendoza, Marietta Sap-ay, Almira Cuyo, Noly Navalta, Teresita Celestino, Delia Alican, Janet Aguilar, Guillermo Ambos, jr., Alice Papcio, Alice La Pena, Dominador Marzan, Concepcion Eusebio, Elvira Deuda, Mariano Bernabe, Jr., Reynaldo Charcogan, Cristina Donglayan, Micielo Gracia Opena, Araceli Nucum, Claire He said that while many private now transact business online, those that seek to secure permits or licenses still face the ordeal of carrying bundles of documents to be signed or initialed by up to 30 government functionaries in some cases.

Escudero cited the RCS result on 11 BOC regional offices nationwide in which only its main office in the Port of Manila earned a "good" rating.

"Discretion is involved in the evaluation and determination of what shipments to withhold or release, what cargos should undergo x-ray inspection, what items will have to be imposed additional requirements on top of the basic set of what is required under the law." Escudero said.

"There are several areas that Customs bureau should identify where discretion is present to allow the crafting of a law to lessen it," Escudero said.

"It is the job of the Senate to improve the system through legislation to reduce the instances of red tape in Customs bureau and in any other agencies," Escudero added.

He said that agencies should veer away from resorting to publicity campaigns in improving their image instead of actually improving the services they render.

The CSC survey was based on frontline services delivery, service quality, physical working condition, and overall client satisfaction on government offices.

He was assisted by Mayor Mauricio Domogan, Vice-Mayor Daniel Farinas and other city officials.

During the distribution of the titles, Domogan said, 'more titles should have been awarded to actual occupants if the Revised City charter was not vetoed by the president.'

Domogan also said, 'the revised city charter could 'speed-up' the processing of pending Townsite Sales Applications in the city now numbering 5,000.

It can be recalled that President Benigno Aquino III vetoed the revision of the 1909 City Charter which local officials say could have addressed numerous land problems in the city including the boundary dispute between Baguio City and the Municipality of Tuba.

'Hopefully, we can find a remedy for it so pending applications will be acted upon,' Domogan said.

Officials here still believe amendment to the city charter is long overdue and badly needs revisions to conform to the present situation of the city./paul rillorta

# City Nets 21M Biztax Surplus, Highest in

CITY – the Bureau of Local Government Finance,
Cordillera Administrative Region
(BLGF-CAR) has cited the City Treasury Office for attaining the highest increase in Business Tax Collections in the region here.

The BLGF exercises administrative and technical supervision and coordination over the treasury and assessment operations of local governments including Baguio.

The award signed by BLGF-CAR ICO Regional Director Ricardo Cawed was conferred to said office thru ICO City Treasurer Alicia Onoza last April 17 at the Skyrise Hotel and Restaurant.

The Local Treasury Office's Business Tax collections pegged at 175 million last year has been surpassed by 21 million, so far the highest entire the Cordilleras.

# Signalized Pedestrian Lanes, Creation of Traffic Office Pushed

BAGUIO CITY – The Traffic and Transportation Management Committee (TTMC) on Monday pressed for the approval of the signalized pedestrian crossings along Session Road and the creation of a traffic and transportation office in the city government to better address traffic concerns in the city.

TTMC member Engr. Teodorico Tan on Monday explained the benefits of the proposed signalized pedestrian lanes before the city council saying it will address the concerns of both the pedestrians and motorists.

Earlier, the TTMC chaired by Mayor Mauricio Domogan was torn between reopening and maintaining the closure of the pedestrian lane on the lower part of Session Road.

The city police traffic division under Sr. Supt. James Allan Logan opposed the reopening citing adverse effects to the traffic flow considering the lane's proximity to a major intersection.

But a clamor from senior citizens, barangay officials and business establishments prompted the city council to ask Domogan to cause the re-opening of the pe-

destrian lane.

Tan said the TTMC cautiously weighed the pros and the cons and eventually acquiesced to reopen the lane provided that the signalized pedestrian crossings project will be implemented.

The signalized pedestrian lane project will cover four main pedestrian crossings along Session Rd and will cost P6 million.

The aldermen asked the TTMC to submit a breakdown of the project cost and re-

## Dads to Tackle Garbage Hauling to Clark, Urdaneta

BAGUIO CITY – The city council will tackle the waste hauling deals with the ESL facilities in Capas, Tarlac and in Urdaneta City on the regular sessions on Monday.

The body invited the members of the Bids and Awards Committee (BAC) led by chair City General Services officer Romeo Concio and Metro Clark Waste Management Corporation general manager Rolando Tongco to shed light on BAC Resolution No. 13-08 recommending the award of the ESL services to MCWMC.

The body also invited a representative from the Urdaneta City ESL and N4th Enterprises relative to the proposed Memorandum of Agreement between the city and N4th Enterprises that would allow the city to haul out its wastes to the Urdaneta facility. The said MOA is up for confirmation by the city council.

Council committee on laws chair Councilor Richard Carino sought the discussion to clarify concerns and guide Cont. on page 3

# Mayor Suspends Implementation of Roadside Inspection, Testing & Monitoring Team

BAGUIO CITY - Mayor Mauricio Domogan issued Administrative Order No. 054, series of 2013, suspending the implementation of the Roadside Inspection, Testing and Monitoring Team (RITMT) under the Clean Air Monitoring Unit (CAMU) of the City Environment and Parks Management Office (CEPMO).

With the city's strict implementation of the provisions of Ordinance No. 061, series of 2008 also known as the "Clean Air Ordinance of the city of Baguio", numerous complaints emerged from private and public vehicle owners as to the credibility of the results of the conduct of roadside testing and the results of smoke emission tests from various licensed private emission testing centers in the city. Even several new motor vehicles released by manufacturing companies fail to pass the test of the RITMT despite the fact that these are newly manufactured units.

Because of the inconsistencies on the smoke emission machine readings of both the accredited Private Emission Testing Centers (PETC) and the city's RITMT, it has created confusion and several contention among the private and public utility motorists.

The manner of the testing during the RITMT operations are also being questioned since they are not allegedly experts in such field.



# **Now Is The Perfect Moment**

I am on a ferry boat from Cebu on its way to Hilongos, Leyte. It has been some time since I have taken this route to reach Maasin, Southern Leyte, which is my final destination for today. My age does not encourage me to do traveling like this anymore. After all, I had to wake up at 3 am to be in the airport by 4 am, then take off for Cebu by 6 am. When we dock at Hilongos, I still have an hour of driving to get to Maasin, making today an air, sea and land trek. But this is the Philippines, and traveling can be an adventure in itself

From the airport early in the morning and in between meetings in Cebu, I have been looking at the news from print, TV and cyberspace. Even the kind of traveling I am doing now, it is most possible to stay wired to domestic and global developments. Truly, it is the dawn of the 21st century, even for our country, the long - struggling third world member making a great effort to leap forward. It is not just technology, it is a people blessed with great talent that can use the present and emerging technologies.

Poverty has kept most Filipinos in darkness far too long. But the moment is turning history towards a freedom so long overdue. The reduction of pov-

#### EDITORIAL erty has not been short of fantastic, less because of the

leaderships of the controlling institutions but more from a magnificent effort of the poor as represented by Overseas Filipino Workers. From economic classes D & E that used to comprise 90% of the population, OFWs are slowly but surely pulling themselves up by their bootstraps and creating the emerging middle class. And the collective optimism generated by a fresh presidency seen internationally as honest and consistently supported by the vast majority has catapulted the performance of of the Philippine economy to a rare position - somewhere at the top of the world.

Filipinos who are stuck in deeper poverty may not have the opportunity that the upper portion of the D class had from the global need of labor and services, but government and a more enlightened business elite will be more focused in being the big brothers they never where before. The Conditional Cash Transfer (CCT) is a reflection of government resolve, from the Executive to Congress, that the poor will find more support. The very idea of a Magna Carta for the Poor tells us of a perspective whose time has come. Even though the proposal has not found fruition into law does not mean it will not. In an amended form, it will. It will simply because it's time has come.

Government did not start having a new look at the poor on its own. Private sector efforts and global influence have done their part in awakening government, and the upward movement of tens of millions of OFWs and their families is proving that a more spread out purchasing power can boost our economy. If government and big business want the newly declared investment grade status to bear fruit, they have to reach down to the left behind poor and lift them up with generosity and determination. Global investors will not be as cooperative as before in investing in countries where the poor will pay the price for their profits. The times are simply different, and a new generation is introducing a new ethical standard for doing business.

The age of information means transparency, not just more data. Information by itself is unnecessary baggage because there is just so much of it today. Information has to be processed and it is almost automatically happening. With a little guidance, the processing will produce intelligent insights. Transparency is not really about information but more about intelligent conclusions - the basis of insights. That is why transparency breeds reforms, not just makes available more information.

Intelligent conclusions from transparency is reshaping the very foundation of human understanding, lifting it from superstition to intelligent belief. Faith is not about believing because someone says so, but because there is an intuitive affirmation from many sources in life that makes the faith solid even if inexplicable. Faith is not about darkness, it is about truth - incontrovertible truth that the human soul understands. The journey from transparency to wisdom is a powerful pathway. From our deepening understanding of the environment and life's ecology, to the growing desire of the youth to build a better world, the human ethos is being refined.

Again and again, I am reminded to be grateful, that special men and women have come to bless me with their kindness, their courage, and their nobility. Because of them, I did not tire from the pursuit of a personal and collective destiny. Because of them, we will build a new and strong nation, from the bottom up, from the top down, with the courage to care, with the promise not to leave the poor behind.

We must not wait for the government, we must not wait for the Church. Our obligation as citizens and as men of faith belongs to each one of us, not to them. In the final analysis, there is no government without us, there is no Church without us. At the end of time, we will be judged not by the volume of complaints we made but by the good we did for others. Today, then, is the perfect moment to do more./ By Jose Ma

#### GETTING THOSE BASTARDS!





These last few days, I was having some routine treatment at the **Davao Doctor's Hospital** strapped — and immobilized — to a dextrose bottle. So I was glued all the time to the TV. And saw on **CNN** the minute-by-minute, blow-by- blow account of how two brothers, the bombers of the **Boston** marathon, were cornered and were being made to pay for their dastardly acts.

Guess what was running through my mind all that time: GETTING OUR OWN BAS-TARDS, TOO! If only we could also successfully mount the same operations here and get our own murderers and bombers, too.

But then, that might be wishful thinking just yet. Sorry to say but we are NOT YET attuned, equipped, trained, united, determined, etc, etc and ready to mount a similar or at least, close to what the Americans showed to the world during those few critical days.

I noted a few "fundamentals" in the BOSTON massive operations that resulted to the killing of one bomber and later the arrest of his younger brother who hid inside a parked boat in a backyard of a residential neighborhood.

This may serve a critique of how we, LOCAL, do things, calling to mind the tourist bus HOSTAGE TAKING in Manila (which was fully covered by media as it happened) and other incidents. I may be over simplifying things — or exaggerating — but I will still give it a try. And sorry, this may be at our own expense. And for those who will not agree with me, take this with a grain of salt.

Let's go over my own checklist (initial of 10 items) and see where and how we stand if faced with a similar crisis, how BOSTON did it juxtaposed with our usual LOCAL ways of doing things:

- 1. **BOSTON**: All the operating units, national and local showed coordination and cooperation. It was one cohesive operation. **LOCAL**: each operating unit wants to get the credit, at times even keeping information and not sharing with other agencies and operatives. In some cases, hiding vital info, wanting to get the reward money for its own.
- 2. **BOSTON**: All residents complied and stayed indoors when requested during the search and pursuit operations. **LOCAL**: people rush to the site of the action and crowd even critical areas to witness the action out of curiosity. We are fondly being called "osyoseros" with kibitzers and bystanders right at the front lines.
- 3. **BOSTON**: Politicians, like the Boston Mayor and the Massachusetts Governor, although appearing to be not the best of friends, closed rank. **LOCAL**: Political rivals avoid each other's company and skip being around when the other guy is already on the ground.
- 4. BOSTON: Volunteerism from citizens. A phone call from a resident that blood was found near a parked boat in his neighbor's backyard led to the capture of the 2nd suspect. LOCAL: No one wants to give information for fear of being involved too or afraid of retribution by the bad guys in the days to come. "Huwag tayong maki-alam baka masali pa tayo" is our usual stand.
- 5. BOSTON: Everyone wants to help and appeals for cooperation were the first call. LOCAL: Cash reward money immediately announced and dangled as incentive for citizen cooperation.
  6. BOSTON: Periodic media briefings to prevent undue speculation and inform the worried public of the status and updates as they develop. LOCAL: Media briefings seldom, if at all done, and only called when the crisis is over, leaving media to fight "tooth and nail" for information for their anxious audience.
- 7. **BOSTON**: Media networks, like CNN although up front, were circumspect and very careful with their handling of what they release to the public as the crisis was in progress. Their anchors were professional. **LOCAL**: It's a circus and a rat race amongst **Cont. on page 8**

# Council Approves AIP

BAGUIO CITY - The city council last Monday finally approved the Annual Investment Plan (AIP) which lists the projects to be funded from the 20 percent development fund of the city government for this year.

Vice Mayor Daniel Farinas said the AIP took time to approve because of the need to review the projects by both the executive and legislative departments.

The body had earlier approved the city's budget for 2013 amounting to P1,286,143,000.

Mayor Mauricio Domogan earlier said the city's AIP this year did not include major infrastructure projects as the city decided to focus on sustaining its garbage disposal programs including the continuation of the rehabilitation of the sewer treatment plant (STP) and sewerlines, peace and order and barangay infrastructures.

The AIP focused on barangay development projects which were given P30M or 33.22% of the total AIP cost of P97,307,000.

The construction or rehabilitation of the drainage system including flood control projects in various barangays located along river tributaries was also given P24,807,000 or 27.47 percent.

A total of P13.5M was also allotted to the construction or rehabilitation of sewerlines at various barangays while P12M will go to parks development program and P10M will be used for the development and installation of traffic & transport facilities.

The allocation of the P7M differential from the approved city budget of P1,286,143,000 will also be studied.

As part of the proposed AIP, the city identified major development projects which are proposed to be funded from city funds and other external sources including loans, lease and Build-Operate-Transfer options.

These include the development and rehabilitation of Burnham Park, Wright Park, Bayan Park, Botanical/Centennial Park, Dominican Heritage Hill Development, training center and livelihood center at Upper Session Road, privatization of the abattoir, Asin Hotspring development, commercial buildings at DPS-Beneco, development of Baguio Convention Center. North-bound bus terminal at Slaughterhouse Cmpd, construction of Magsaysay bldg, continuation of the construction of fire station at Aurora Hill, renovation of the second building of the sari-sari section of the city market, upgrading of Malcolm Square, south-bound terminal, city cemetery expansion, socialized housing project, engineered sanitary landfill, full closure of Irisan dumpsite, City Camp lagoon rehabilitation, forest protection project including fencing of watersheds, construction of mini-seweraget treatment plants, fencing of city properties, Baguio Circumferential Road, slope protection projects, among others./A Refuerzo



So, how on earth can we get our own bastards? Ho-hum...


