Agriculture industry remains the biggest employer in CAR

m AGUIO\ CITY}$ - Agriculture and forestry sector remains the biggest employer in the Cordillera region with 43.9 percent or around 336,000 of the 765,000 employed individual based on result of the January 2016 Labor Force Survey recently released by the Philippine Statistics Authority.

Wholesale and retail trade; repair of motor vehicles and motorcycles ranked as the second labor sub industry at 12.4% of the total employed persons in January 2016, followed by construction and manufacturing at 7.7 and 2.2%, respectively.

In terms of occupation groups, laborers and unskilled workers remain to be the largest group of employed workers in Cordillera at 33.3%; followed by farmers, forestry workers and fishermen; Cont. on page 5

Signature campaign to make dialysis free in Cordilleran Army officer laid to gov't health facilities launched in Baguio City rest at the Libingan ng mga Bayani

Baguio Correspondents and Broadcasters Club(BCBC), in partnership with the Philippine Information Agency-Cordillera, launched in a kapihan forum last Tuesday, a signature campaign pushing for Congress to pass a law that will make dialysis in government health facilities free to all patients who need it.

BCBCPresident Ramon Dacawi said it has been his advocacy to help people undergoing dialysis wherein through his write ups, friends and volunteer donors help him provide financial assistance for the treatment of patients. Since he became a dialysis patient himself, the more he realized the financial burden of having such illness, he shared.

they recognize the assistance of the government through Philhealth where 90 sessions of dialysis of health insurance package per year are available for

their dependents. But for new cases in 2015. kidney patients who need three to four sessions a week, such assistance is not enough to sustain their life. To many patients, the average of around P2,400 per dialysis session is too much.

The BCBC and PIA hope that the signature campaign will gain support from every region of the country and even to those living abroad.

Aside from the signature campaign asking Congress to enact a law that will make dialysis free, Dacawi said they are also calling for local government units down to the barangay level to also draft their own version of the said BCBC resolution to make the advocacy stronger.

Dr. Shelly Aral of the Dacawi stressed that Department of Health -CAR affirmed that that end stage renal disease remains a growing health concern in the region. From the over 500 new cases in 2014, it almost PHilhealth members or doubled with 900 plus CAR#

Aside from ensuring that the health department's hemodialysis Unit are providing quality service, DOH also continues with their advocacy on kidney disease prevention, Aral

On the part of Philhealth, Information Officer Maggie Del Rosario said Philhealth is continuously working in improving the health benefit package for their members. Aside from the 90 days per year dialysis package at P2,600 per session for end-stage renal disease, there is also the Peritoneal Dialysis package at P2,600 per session and the Kidney Transplantation Package with P600,000 financial health assistance

According to reports, Capio's team clashed with 60 to 80 Abu Sayyaf members led by Furuji Indama alias Abu Dajana. The military operation against the Abu Savvaf is in line with the directive of President Duterte to eliminate the bandit group known for kidnappings and beheadings

The President personally condoled with the family of Capio at the Libingan ng mga Bayani Mortuary in Fort Bonifacio on Monday before the body was flown to Baguio City. He also extended financial assistance to the family.

During the wake at the Wesleyan Church along Rimando Road here, relatives and friends of Clinton expressed sadness and condoled with the family.

Mauricio Mayor Domogan also paid tribute to the slain soldier. He expressed grief but hailed Capio as among the heroes of the Cordillera.

Delia Capio, Clinton's mother, is devastated but proud that his son was among the heroes of the country fighting to win the war on peace.

The military accorded funeral honors to Capio before being flown from the Loakan Airport to be buried at the Libingan ng Bayani on Friday.

In related development, President Duterte said he will meet with the widows and family members of the Special Action Force (SAF) troopers who were killed in the January 2015 Mamasapano massacre. He wants to talk to them and see how the families are two years after the unfortunate incident that rocked the nation.

DOLE BROADENS BAN ON EMPLOYMENT OF MINORS IN FARMING

aguio City - The Department of Labor Band Employment (DOLE) has broadened the scope of the ban on the employment of minors in agriculture and livestock farming to prevent young people from exposure to hazardous work conditions.


Department Order No. 149-A by Labor Secretary Silvestre Bello III, now classifies farm rearing and related farming activities as hazardous and among the worst forms of child labor including plant propagation activities that involve grafting, budding and marcotting, and tending activities that involve weeding of soil.

OIC Regional Director ExequielRonia A. Guzman said the new order also reinforced the existing ban on the employment of minors in farm activities as clearing of land, plowing, harrowing, irrigating, constructing paddy dike and cutting. Also declared as hazardous are handling, spraying and application of harmful fertilizers, pesticides, herbicides and other toxic chemicals; and loading and carrying of heavy loads.

Guzman added that minors are also not allowed in harvesting activities that involve cutting and picking, spreading for drying, hauling, topping, tumbling, tuxying, stripping, burning of field, sticking and classifying, threshing, loading and carting of produce.

"In post-harvest, minors may not be employed in de-husking, scooping, sacking of products, charcoal making, hauling of products as led by animal guide, loading and unloading of packed farm products, coconut kilning and de-meating from shell or core, sealing and carting of produce for warehousing and transport to market and all ancillary work such as clearing, cleaning, and recycling of farm waste in its preparation as animal food and other related processes" the Director explained.

In livestock farming, work and related activities that are declared hazardous to minors are rearing activities that involve collecting, loading, unloading and transporting of feeds, maintenance and care of large and/or dangerous animals, collecting and disposal of dead animals, animal manure and other waste materials, administering of vaccines and vitamins, Cont. on page 5

Bishop on killings: Filipinos 'quiet like in time of Hitler'

'Let us boldly reject merciless ways of dealing with the most miserable, including our drug addicts,' Bishop Teodoro Bacani says at the Mercy Congress ANILA, Philippines – Novaliches Bishop Emeritus Teodoro Bacani on Wednesday, January 18, questioned the silence of many Filipinos about the recent killings in the war on drugs waged by the Philippine government.

Bacani compared this attitude to the world's silence about the abuses of Nazi leader Adolf Hitler, under whom Nazi Germany slaughtered some 6 million Jews

by the end of World War II. In a speech at the World Apostolic Congress on Mercy (WACOM), the bishop

cited the deaths of more than 6,000 people in the government's war on drugs.

Bacani said: "6,000 people and going. And the Filipino people keep quiet like in the time

of Hitler? How can this be?"

To drive home his point, Bacani recounted the "uproar on social media" against the killing of a dog in the making of the movie Oro, an entry at the recently concluded Metro Manila Film Festival.

Citing a letter to the editor addressed to the Philippine Daily Inquirer, he said that "there is more uproar over the killing of a dog than over the killing of 6,000 people." 'Uphold rights of human beings'

During his speech, Bacani also sought to draw attention to the spiritual aspect of the recent killings.

He remembered a priest telling him: "Bishop, you know what pains me? It's not only those people lost their lives. But if they were sinners, then they were killed in their sleep. They have no time to repent. Now they would be condemned not to jail but to eternal fire."

Alarmed at the drug-related killings, Bacani reminded the public, "Even as we proclaim the mercy of God, let us with boldness - I repeat, with boldness - also uphold the rights of human beings, even of the most miserable."

"As we proclaim life, let us boldly reject merciless ways of dealing with the most miserable, including our drug addicts," he said.


At the same time, Bacani also criticized the Philippine National Police for failing to catch the killers of more than 4,000 suspected drug pushers and users in cases outside police operations.

Like Bacani, Cotabato Archbishop Orlando Cardinal Quevedo and Manila Auxiliary Bishop Broderick Pabillo also hit the recent Philippine killings.

At WACOM, Quevedo said the public's attitude toward the killings "is a symptom or indication of split-level Christianity," while Pabillo said Catholics should speak out against drug-related murders.

WACOM is a 5-day gathering of devotees of the Divine Mercy, which is hosted by the Philippines this year./ with reports from Agence France-Presse/Rappler.com

and handling of disinfectants used for cleaning animal pens/enclosures or for disinfecting animals.

In harvesting activities, work and activities that involve catching or collecting, ranching, and milking in preparation for warehousing or transport to market, and post-harvest activities including the packaging and processing of dairy and other animal by-products in preparation for warehousing and transport to market; and working in slaughterhouses or abattoirs.

In a statement issued by Secretary Bello, he reiterated that child workers are compelled to help augment their families' meager income by engaging in hazardous work and that is the reason the Labor Department will strictly monitor and assess occupational safety and health standards related to child labor.

The Labor Secretary also said the best interest of children is the paramount consideration to ensure that their employment does not endanger their life, safety, health and morals, nor impair their normal development.

"I have six years as my tenure in the office. So hopefully within my term, I will be able to increase not only the number but the quality of our legal services," he said.

According to the Solicitor General, there should be at least 30 assistant solicitor generals. Currently, however, the OSG has only 24.

We are still short of the minimum number to multi-grade classes, of assistant solicitor generals," he said.

Nineteen drug-affected barangays under clearing operations

BAGUIO CITY - With the war against drugs campaign being the top priority of the present administration under the leadership of president Rodrigo Duterte, the city government of Baguio continues to battle drug related problems in the city of Baguio.

For the period July 1 to Dec. 31, 2016, the Baguio City Police Office reported that out of the 128 barangays in Baguio, there are 19 barangays under drug clearing operations.

The 19 drug-affected barangays undergoing clearing operations include Campo Filipino, Quezon Hill Proper, Pinget, Alfonso Tabora, Trancoville, Middle Quirino Hill, Padre Zamora, Pacdal, Saint Joseph Village, Ferdinand, Upper Rock Quarry, Lower Q.M., Honeymoon, Aurora Hill Proper, Loakan Liwanag, Camp7, Irisan, Bakakeng Central and Dontogan.

PCI Dexter Ominga said the drug-affected barangays can only be declared drug-cleared if they meet the specific parameters, such as the non-availability of drug supply, absence of drug transit or transshipment activity, absence of clandestine drug laboratory, absence of clandestine drug warehouse, absence of clandestine chemical warehouse, absence of marijuana cultivation site, absence of drug den, dive or resort, absence of drug pusher, absence of drug user or dependent, absence of protector or coddler and financier, active involvement of barangay officials in anti-drug activities, active

involvement of the Sangguniang Kabataan to help maintain t h e drug-liberated

the barangay, existence of drug awareness, preventive education and information, and existence of voluntary and compulsory drug treatment and rehabilitation processing

On the other hand, the named four unaffected barangays are Country Club, Happy Hallow, Upper Dagsian and Lower General Luna. While, 105 barangays were recommended and submitted as drug cleared barangays.

As reported, 1,971 users and 406 pushers have already surrendered to the authorities.

The BCPO has arrested 176 pushers and 24 users. They have also conducted 106 buy bust operations, nine through police response, another nine through service of search warrant and seven with warrant of arrest.

Moreover, 236.51 grams of shabu were confiscated amounting to P4,257,180.00 while 2,653.56 grams of marijuana were confiscated amounting to P729,729.00.

New recycling machines reduce Baguio waste

BAGUIO CITY-The city's solid waste problem has significantly decreased with the operation ot two Environmental Recycling System (ERS) machines which process the biodegradable waste to high grade compost or fertil-

Romeo Concio, City General Services Office (GSO) head, said the processing of some 48 tons of biogradable waste by the ERS machines daily reduced the volume of solid waste being hauled out of the city to the Engineered Sanitary Landfill (ESL) in Capas, Tarlac.

The volume of garbage being hauled out of the city is about 160 to 200 tons daily, including the 48 tons of biodegradable waste being processed by the ERS machines.

Concio said the city will be able to save PHP12 million annually from the cost of hauling and tipping fee for the 48 tons biodegradable waste.

"Hauling to the ESL in Tarlac is still the feasible option to avoid a serious garbage problem in the city while we are working on the establishment of the planned Integrated Solid Waste Disposal Facility (ISWDF) in

Antamok. The cost of maintenance for the two ERS is PHP12 million while the hauling cost of 48 tons of waste is PHP24 million, "Concio said.

He said the maintenance cost is insignificant considering the benefits the machines give in return - the high grade fertilizer and the reduction of garbage being hauled out of the

The city allocated a total of PHP85 million from the PHP1.776 billion 2017 annual budget of the city purposely for the hauling of the city's
