

Mayor Brushes-off Birthday

Case BAGUIO CITY – instead of a birthday cake, Mayor Mauricio Domogan during the Weekly Ugnayan Presser Wednesday (October 8) confirmed a case has been filed arising from his birthdate.

Speaking to members of the media, Domogan said, 'he was informed that charges for the Anti-Graft and Corrupt Practices Act was indeed filed by a private citizen against him including Vice Mayor Edison Bilog, Councilors Joel Alangsab, Michael Lawana, Betty Lourdes Tabanda, Leandro Yangot, Jr., Faustino Olowan, Fred Bagbagen, Isabelo Cosalan, Jr., Roberto Ortega, Elmer Datuin, Richard Carino, Elaine Sembrano and peter Fianza.'

The case emanated from City Ordinance No. 33 series of 2014 moving the celebration of barangay day to October 10 and amending City Ordinance Number 78 series of 2009 which celebrates barangay day every 2nd Saturday of December.

City officials approved to move the celebration of barangay day to conform with Presidential Proclamation No. 63 series of 1992 which declares the month of October as the Local Government month, the second week of October as Local Government Week and the tenth day of October as Local Government Day.

In the complaint, Peter Puzon, a losing candidate during the 2013 mayoralty race stated by moving the date of the barangay day celebrations to October 10, the respondent officials are depriving barangay constituents specially children, of a festive Christmas season celebration and instead celebrates the mayors birthday which he said is undeserved political gain.

The said ordinance was approved by Mayor Domogan on July 22, 2014.

However, Domogan stressed, "the move of the council to amend ordinance 33 series of 2009 is in line with the actual date of the approval of the 1991 Local Government Code which is October 10.'

Domogan said, "it is just coincidence that his birthday falls on October 10 which is also the day when the Local Government Code was signed and that not a single centavo of government funds is spent for his birthday.'

Despite the case mailed to Ombudsman Conchita Carpio Morales on October 7, the Barangay Day celebrations proceeded full swing last October 10 with the awarding of the Most Outstanding Barangay Peace and Order Committees followed by a parade of City and barangay officials down Session Road to the Ibaloi Park with fun games and prizes for participants./By: Paul Rillorta

Commercial Building Owners given Time to Restore Parking Amenity

BAGUIO CITY - Owners of commercial buildings at the central business district will be given ample time to restore their parking provisions as required in their building permits.

Mayor Mauricio Domogan on Wednesday said the city agreed to the request of the businessmen for a grace period to give them chance to rectify their violation either by restoring their parking areas which were converted and used for other purposes or by designating a parking area outside their buildings but within the property's 200-meter ra-

In a recent dialogue with the mayor initiated by Councilor Elaine Sembrano, the building owners admitted converting their parking sites for other purposes but expressed willingness to reinstate the parking provisions for their customers.

City buildings and architecture officer-in-charge Johnny Degay said that in the course of their inspections of the edifices, it was discovered that many establishments with approved parking spaces in their building permits have altered the plans and instead rented out the spaces intended for parking.

The mayor said this constitutes violation of Presidential Decree 96 or the National Building Code and city ordinances and as such the city can revoke the building and occupancy permits and close the establishments.

'Of course we do not want to go to that extent so we agreed to give them time to comply with the requirement," the mayor said.

The mayor during the dialogue also tasked Degay to investigate building owners who circumvented the parking requirement by applying for building permit for renovation but actually constructed an entirely new edifice.

Apart from the businessmen with approved parking requisites, the city intends to also consult with the other sectors like the schools and others on the parking concern.

"This will be a continuing activity as part of the city's aim to decongest traffic in all areas," the mayor said./A Refuerzo

UP Baguio Builds Compendium of Indigenous Forest Resource Management Systems and **Practices of CAR**

LA TRINIDAD, Benguet - The University of the Philippines- Baguio has come up with a compendium of researches on Indigenous Forest Resource Management Systems and Practices (IFMSP) of the Cordillera Administrative Region which will available to the pub-

The project commissioned to UP Baguio is a joint undertaking of the National Commission on Indigenous Peoples (NCIP) - Department of Agriculture (DA) - Cordillera Highland Agricultural Resources Management Project 2 (CHARMP 2) funded under the International Fund for Agricultural Development (IFAD)

UP Cordillera Studies Center Director Alejandro Ciencia Jr., in presenting the background of the IFMSP compendium in an information and education campaign on Republic Act 8371 or the Indigenous Peoples Rights Act(IPRA) in line with the celebration of Indigenous Month, said this may be used as a reference material or resource guide

But he cautioned that this should not be treated as an authoritative listing of certified IFMSP which is far from complete, however, provides baseline data for future studies as the intention of the project is merely collection of researches, studies and relevant materials.

These are gathered across the region and other areas such as Metro Manila and UP Los Baños composed of various institutions like non-government organizations, libraries, universities and colleges, local government units, and research institutions among others.

The compendium is a compilation of abstracts or summary of the contents of a resource material of IFMSP and bibliographic information to facilitate access and use of such materials.

UP CSC Project Assistant Paula Luz Pamintuan-Riva said creating a compendium serves as a guide for policy makers in the formulation and adoption of timely and appropriate interventions benefitting local communities in CAR.

There is an assumption that there are plenty of research and studies on forest management and indigenous forest management but there has been no complete effort to gather these together for stakeholders which is the reason the compendium was endeavored, according to Pamintuan-Riva.

The compendium is classified into two categories, forest management which is directly relevant to the topic or description of IFMSP and supplemental category which may be used as reference materials divided into sub-categories such as agricultural systems, agro-forestry practices, cultural context, scientific, and general references.

UP Baguio organized a team of study leaders, project management group and researchers in coming up with the compendium of IFMSP./JDP/SCA- PIA CAR, Benguet

Bishop Poised to Oppose Entry of Electronic Gambling in City

BAGUIO CITY – Baguio Apostolic Vicar Bishop Carlito Cenzon on Thursday raised alarm over the reported entry of electronic gambling in the city.

In a meeting with Mayor Mauricio Domogan last Thursday, the bishop served intention to oppose the entry of the so-called electronic casino (ecasino) which he said has reportedly been operating in one of the shopping malls in the city

The mayor authorized the bishop to conduct a study and present a report on the matter for action by the city executive.

As this developed, a company is reportedly eyeing the city government's nod in its application to operate electronic bingo (e-bingo) and other games in a hotel at Lualhati barangay here.

Its application was accordingly approved by the Philippine Amusement and Gaming Corporation (PAGCOR) but it will still need a Letter of No Objection from the city government as a requirement for a license to operate.

Cenzon had in the past been at the forefront of the campaigns against casino and lotto, bingo and small town lottery in the city.

He along with Fr. Andy Cosalan and Pastor Simplicio Dangawan of the United Church of Christ of the Philippines (UCCP) led the Metro Baguio Multi-Sectoral Movement against the Casino to block the plan to operate a casino at the Camp John Hay.

The group said the city must always be vigilant in its stand against all forms of gambling under any form or guise citing Resolution No. 236 series of 1991 entitled "A Resolution opposing the return of casino to Baguio or the establishment of a new one under any other form or guise," Resolution No. 122-02 entitled "Expressing the Sentiment of the People of Baguio and the Policy of the City Government against Gambling..." and Resolution No. 446 series of 2008 "Vigorously opposing the establishment of a casino or the conduct of a gambling activities at Camp John Hay and anywhere in the city..."

The mayor also has a standing order for the police to stop all illegal gambling activities in the city including those barangay-run bingo events noting that these have been used as cover for gambling operations.

This prompted the city council to approve Resolution No. 173 series of 2013 entitled "Requesting the Baguio City Police Office (BCPO) to cause the stoppage of all gambling activities in all Bingo sa Barangay."/A Refuerzo

Public Warned anew vs. Buying Calt Lots

BAGUIO CITY – Mayor Mauricio Domogan on Wednesday cautioned the public anew against buying lots covered by Certificates of Ancestral Land Titles (CALTs) and expanded and overlapping titles which are now the subject of cancellations proceedings.

The mayor reiterated the warning amid reports that a top businessman and other private individuals have been lured into buying parcels of land at Wright Park which are covered by

Baguio, Pangasinan Solons file Bill to Postpone 2015 SK Elections

BAGUIO CITY - Baguio City Representative Nicasio Aliping Jr. and Pangasinan 6th District Rep. Marlyn Primicias-Agabas filed House Bill 5043 seeking to postpone the Sangguniang Kabataan (SK) elections to October 31, 2016 to give way for the deliberation of the proposed amendments and provisions of the Local Government Code.

The bill seeks to postpone anew the SK elections set on February 21, 2015 by the Commission on Elections and synchronize it with the barangay elections in October 2016 as the barangay and SK officials will be working closely together.

It can be recalled that President Benigno Aquino III o signed a bill postponing the October 28, 2013 SK elections in order to pave the way for reforms. It was supposed to held simultaneously with the barangay elections last year.

"We're not yet ready of the reforms that will be undertaking in introducing the Sanguniang Kabataan. It is also a way for us to prepare for the upcoming the presidential election and the local elections that will be held in 2016," Aliping said.

There have been calls to reform or abolish the SK as some lawmakers and various sectors said the youth council was becoming a school for corruption. There are pending bills in Congress either for the reform or the abolition of the SK.

Several bills introducing the much needed reforms were filed and are currently being deliberated as possible amendments to the Local Government Code of 1991.

"These changes will find more meaning and greater impact on the Sangguniang Kabataan if the desired reforms are firmly in place before the leaders and officials are elected," Aliping said./JDP/RMC and Hanah Fabia-PIA/UB Intern CALTs now the subject of annulment cases before the National Commission on Indigenous People (NCIP) and the Office of the Solicitor General.

Mayor, Skating Rink Petitioners Resolve the removal of other business enterprises not in line with the greats

BAGUIO CITY – Mayor Mauricio Domogan and petitioners advocating to open the Burnham Park skating rink for free use by the public ironed out issues in a meeting last Thursday.

Both parties agreed that the lease contract for the operation of the facility presently held by concessionaire Quirante's Fun Rides/Skates Rentals and Recreation Center set to expire on November 2 this year will not be renewed by the city and instead the operation will be bid out based on terms that are beneficial to both the city government and the public.

A proposed master development plan for the facility will be drafted by a task force to be formed by the mayor composed of experts from both the private and government institutions. The plan will serve as basis in the drafting of the terms of reference for the bidding.

After hearing the mayor's justifications, the petitioners led by Bishop Carlito Cenzon of the Burnham Park Fencing Committee, urban planner and former city architect Joseph Alabanza of the Baguio Heritage Committee and former punong barangay Ferdy Bayasen acknowledged that the city cannot allow the absolute free use of the skating rink being one of the few income generators where the city source out funds for the maintenance of the park,

At present, the city earns only P15 million from the various park concessionaires which is way below the fund requirement of P37 million to pay for manpower, water, fertilizer and other maintenance needs of the park, according to the mayor.

As to the petitioners' call for

the removal of other business enterprises not in line with the area's intended use, the mayor said this is consistent with the city's stand that these operations which include bump cars and arcade games must not be allowed inside the facility meant only for a skating rink and including a refreshment canteen and coffee shop.

Bayasen said the petition entitled, "A People's Initiative and Manifesto: "Return the Skating Rink at Burnham Park to the Public'" which gathered a total of 17,065 street and 1,119 on-line signatures aimed to get the pulse of the residents on how they want the skating rink managed.

He said that the common sentiment was that the facility be restored to its olden day status as an open facility.

Alabanza who broached the drafting of the proposed master plan and who will possibly head the task force said they will consider the suggestion in the drafting of the plan. He committed to complete the master plan within two weeks.

The Baguio Heritage Committee is also working on a "mother petition" to declare Burnham Park as heritage site but Alabanza said the plan will not abandon the commercial area component of the park.

The city council through a resolution authored by Councilor Betty Lourdes Tabanda recently sought the conduct of a feasibility study to determine the best option to be adopted for the operation of the skating rink.

The body tasked the city environment and parks management office, the local finance committee and other concerned offices to undertake the study./A Refuerzo

High-risk duty

If we let this pass, no significant witness will testify... because of fear," Sen. Miriam Defensor Santiago fumed. She seeks 24-hour police protection for Audit Commissioner Heidi Mendoza who documented Makati hospital scams before the Senate blue ribbon

Medical equipment for Ospital ng Makati-from sterilizers to beds to cabinetsworth P9.3 million were padded by P61.2 million under Mayor Elenita Binay's watch, Mendoza revealed. That's a 9,056-percent overrun.

There was a break-in at Mendoza's home this year, and she received threatening phone calls before the Senate hearings. The Commission on Audit official, nonetheless, testified that beds claimed to be manufactured in the United States were Taiwanese imports. No public biddings were conducted. And so on.

A parallel controversy erupted over the weekend, when Makati Mayor Junjun Binay slammed Senate President Franklin Drilon for indicating he'll sign a subpoena to compel Binay to testify on the overpriced P2.3-billion Makati City Hall parking building. If a witness refused, "the entire committee can decide if a witness can be detained" until he sings. Drilon stressed he "merely explained Senate procedures.

Binay protested, presenting a "reasonable appeal" to the committee to desist. "The Ombudsman now has jurisdiction over the related plunder case." And Sen. Nancy Binay weighed in: Sen. Teofisto Guingona III should convene the committee to address the jurisdictional issue.

Will this replay the July 1950 investigation of the purchase of Buenavista and

Tambobong estates (GR No. L-3820)? Jean Arnault clammed up on demands that he finger the per-

son to whom he slipped P1.44 million.

Cited in contempt, Arnault was held by the Senate sergeant-at-arms until he answered.

Yes, the Senate had the power to punish Arnault for contempt, the Supreme Court decided. Yes, the Senate had the authority to commit him "for a term beyond its period of legislative session." And no, Arnault may not rightfully invoke his right against selfincrimination.

The legal controversy uncoils in a setting where Vice President Jejomar Binay's standing among the 2016 potential presidential candidates plummeted from 41 to 31 percent in the latest Pulse Asia survey. Conducted from Sept. 8 to 15, the survey also tracked Interior Secretary Mar Roxas placing second with 13 percent. He is up from 7 percent in the previous survey.

"We expected worse," given the "smears," a Binay spokesperson admits. Will the Binay free fall continue in the surveys ahead? The track is littered with the remains of 2010 "front runner" former senator Manuel Villar. Road diversion scandals dragged Villar to a losing third with 4,525,913 votes behind Benigno Aquino III's 12,688,024-

"The support that a legitimate whistle-blower, like auditors, should get remains unclear. An explicit policy... is needed," says the Asian Institute of Management study "Whistle-blowing in the Philippines: Awareness, Attitudes and Structures.

Whistle-blowers who tell the truth make corruption a high-risk activity, wrote Dr. Romulo Miral. The absence of a legal framework makes the personal costs of whistleblowing very high. It is sometimes a "matter of life and death." Indeed, Jerusalem crucified its Whistle-blower.

In many instances, whistle-blowers are key to solving cases. In 2013, the Inquirer picked whistle-blower Benhur Luy, Mary Arlene Baltazar, Merlina Suñas, Gertrudes Luy, Marina Sula and Simonette Briones as "Filipinos of the Year." They blew the lid off the country's biggest sleaze scandal.

Today's Witness Protection Program is a hodgepodge assortment of personnel, Santiago fumed. Indeed, a separate law is needed to protect COA auditors who put their

An expert in fraud examination, Mendoza was employed by the COA, recalls Ateneo's dean of Graduate School Antonio La Viña. In September 2004, then Ombudsman Simeon Marcelo handpicked Mendoza to lead a group to investigate Armed Forces of the Philippines comptroller Carlos Garcia.

Mendoza and team proved sleaze in the handling of funds from the United Nations for peacekeeping missions. Yet, government prosecutors defended a plea bargain, saying: The case was "deficient." Mendoza resigned from an Asian Development Bank post to participate, from 2007 to 2009, in over 16 hearings where she documented her team's findings. "Most of the time, only her husband was there to give her moral

Garcia was convicted and imprisoned. But the strains on Mendoza and family were severe. Aside from the physical risk, there was unrelenting pressure to crumble. President Aquino thereafter handpicked Mendoza, along with Grace Pulido Tan, for the

Sen. Jinggoy Estrada, however, repeatedly blocked Mendoza's confirmation. He reserved "two questions," then failed to show up for the hearings. Estrada also torpedoed the confirmation of Justice Secretary Leila de Lima. Section 20 of the Commission on Appointments rules allows members to block the confirmation of any nominee during the plenary session. No need to give a reason.

De Lima and Mendoza did not buckle and were finally confirmed in June 2014,

THE REALITIES OF **NEGOTIATING**

My previous work as "negotiator" was varied. Let me recall some. I dealt with hostage takers at the Davao Penal Colony where all 8 hostage takers were "neutralized" and the stand-off resolved; I helped in the surrender of prison escapee "Bucay" Manero; the peaceful surrender of high-value suspect Datu Unsay Ampatuan in the Maguindanao Massacre; the surrender of armed rebel commanders in Lanao; the pacification of desperate and hungry farmers at Sultan Kudarat during the EL NINO in 1998; the handling of angry and grieving families of plane crash victims in Cagayan de Oro; the release of an Army general Obillo and his junior officer by NPA Kumander Parago in Davao after a trip to the Netherlands and meeting with Joma Sison; the safe return of Marine General Ben Dolorfino and OPAPP undersecretary Mon Santos from the hands of MNLF Commander Habier Malik in Sulu who figured recently in the Zamboanga siege, handled the return of MNLF's Nur Misuari back to the country from Malaysia where he was arrested after a failed uprising in Sulu. And a few others.

Of course, (and this is true for all husbands) I have to mention the never ending and most inscrutable of all: "negotiations" with our dear wives on matters that are conjugal in nature. This is one area where all husbands (including myself) may not claim much success! (oooops. Ha ha ha!)

WITH REBELS — But here's an undisputable fact: negotiating with rebels in peace talks getting agreements done is something else. They are more complex to handle given that there are principled positions and grievances, mostly generational, that have to be addressed. I had the privilege (and agony) of being part of the peace negotiations with the CPP/NPA/NDF while I was Davao Congressman as House representative in the government panel during the Ramos administration; and as chief negotiator with the MILF; and I dealt with implementation issues with the MNLF while serving as presidential adviser during the Arroyo administration overseeing the whole peace process, not to mention Cordillera's CPLA and other so-called "break-away" groups.

No doubt, dealing with armed rebels who have waged rebellion against government to seek peace is totally a different story from those cases which are purely criminal like hostaging or bringing in of suspects or resolving issues. Peace negotiations are not only about pacification and law enforcement. This genre has deep political dimensions that must be carefully navigated and adroitly handled. Let me share with you some insights.

BEYOND GOVT — First, rebels by taking up arms and rising up against government, impugn, reject and even challenge the legal order. They are outside the ambit of our laws as they do not operate under the Philippine legal framework. In fact, they rise up in arms against it. Hence they claim that they are beyond the reach of the laws and the government. So people should not take it against them or be surprised if they refuse, during negotiations and in signed agreements to make reference to the Constitution or the laws of the land. To do so is to impose on them prematurely what they reject. To do otherwise is, to them, early capitulation and a betrayal of what rebels fought for in the first place.

sult of unresolved issues on spurious CALTs over government reservations, expanded and overlapping titles and other lot fiascos.

The mayor said the spurious CALTs issued over tracts of land within Forbes Park in South Drive, Wright Park, Botanical Garden, the Casa Vallejo property along Upper Session Road, Loakan Airport and the Dairy Farm at Green Valley are now the subject of cancellation proceedings and the NCIP itself recently confirmed irregularities in three of the five CALT cases in the city being investigated by the commission. The two other cases are still being probed.

"If these titles were declared null and void, it follows that any derivative title issued from the said titles will also be void. Naturally, the city will not allow them to claim the said lots. So whoever bought that land will be holding an empty bag. They should go after those who sold the lot to them," the mayor said.

The mayor said he hopes the NCIP can

speed up the resolution of pending questions on the CALTs and that the notices of lis pendens or the order of the Supreme Court against transferring these lots can be annotated to the titles for the protection of would-be buyers.

Aside from Wright Park, another hot spot for scam are the lots within the Baguio Dairy Farm at Green Valley along Marcos Highway now peddled to innocent buyers.

The mayor said the sale is illegal as the area remains to be part of the Bureau of Animal Industry (BAI) reservation under the Dept. of Agriculture (DA). He said he endorsed a petition to the DA to segregate a portion for low cost housing but the same has not been approved.

The mayor said the DA filed a case against the squatters occupying said lots and won the Some 78 hectares of the Dairy Farm had been issued a CALT by the NCIP in favor the heirs of Ikang Paus but the same is presently the subject of cancellation proceedings due to questions on the validity of the claims including the adverse claims by the descendants of Mateo Carino.



Fongwan wants police presence in Mt. Pulag

LATRINIDAD, Benguet Governor Nestor Fongwan called on the Benguet Provincial Police Office to beef up security measures in Mount Pulag following the pullout of Philippine Army troops from the province recently.

Not only for the peace and security in the province, uniformed personnel are also needed in the protection of forests, Fongwan said as he told PPO Director PSSupt. Rodolfo Azurin Jr. to add police presence in the vital areas in the province particularly in Mount Pulag, which is believed as the sacred mountain of Kabunian.

"While waiting for the replacement of soldiers who will be assigned in Mount Pulag, the Benguet police should make sure that the critical areas of the national park will still be protected," Fongwan said.

The Governor noted that since the Army troops were stationed at the Mount Pulag National Park, there were less illegal activities there.

"The military has played a big role in maintaining the remaining forest areas of Pulag", he averred.



Reveals more Overweight Children BAGUIO CITY - The numbers of Cordillera children and adolescents who are overweight or obese are higher than the

national prevalence

This was revealed in result of the 8th National Nutrition Survey (NNS) released by the Food and Nutrition Research Institute of the Department of Science and Technology (FNRI-DOST) during the regional dissemination forum held on October 9 at El Cielito Inn

The anthropometric result among children 0-5 years old showed that in the Cordillera Administrative Region(CAR), about 6 in every 100 or 6.1 percent preschool children are overweight. This is higher than the national preva-

For school-age children aged 6-10 years old, the survey revealed that about one in every 10 or 11.7% were overweight or obese based on their body mass index-for-age. The national average stands at 9.1%.

For adolescents aged 11-19 years old in CAR, about one in every 10 or 11.6 % were overweight and obese based on body mass indexfor-age while the national prevalence is 8.3%.

According to the FNRI-DOST, overweight refers to above normal body weight relative to height, with a body mass index of 25 to 29.9, while obesity refers to an excess amount of body fat. However, recent studies claim that it is not just the amount of fat but its distribution in the body that determines the risk associated with cardiovascular diseases.

During the open forum, Rita Papey, the Regional Nutrition Program Coordinator (RNPC) of the National Nutrition Council, said that the region should focus more interventions on obesity from the regional down to the barangay level.

Meanwhile, Charmaine A. Duante, Supervising Science Research Specialist of FNRI-DOST, informed that the NNS is a designated statistical activity that will generate critical data for decision-making of the government and non-government sectors.

It is being conducted every five years to determine and evaluate the food intake, nutrition and health status of Filipinos and update the official statistics on food, nutrition, and health situation in the country.

The 8th NNS consisted of ten nutrition, health and economic survey components namely; anthropometry, biochemical, clinical, dietary, economic status, food security, government program participation, Infant and Young Child Feeding, maternal health and salt survey.

The forum was attended by nutrition workers and advocates composed of members of the Regional Technical Assistants on Nutrition, Provincial Science and Technology Directors, Provincial Nutrition Action Officers, City and Municipal Nutrition Action Officers and members of the Cordillera Media Educators on Nutrition(CAR-MENU).

Maria Rowena Madarang of DOST-CAR welcomed the participants while Papey facilitated the open forum.



Barangay folks show NPAs not welcomed in lic Safety Company and Provincial **Apayao**

BAGUIO CITY Apayao Governor Elias Bulut Jr. commended the vigilance and hatred to violence of the Iapayaos that led to the death of alleged New People's Army leader and three of his members in a firefight against government troops in Luna, Apayao last week.

According to reports, barangay folks tipped off police officers of the presence of at least 10 heavily armed men conducting extortion activities at barangay Calayucay in Luna morning of October 3. Joint elements of the Apayao Provincial Pub-

Infantry Battalion then conducted an operation and firefight ensued between the rebels and the law enforcers resulting to the death of the four rebels.

Police Regional Office - Cordillera Public Information Officer PSSupt. Davey Limmong identified the casualties as Efren Arquillo alias Mario Domogan of Allacapan, Cagayan, Vinia Alejandro alias Ka Dina/Rani, and Rhoby Edillo. The other casualty remains unidentified. They reportedly were NPA remnants who call themselves Armadong Makikibakang Masa led by Arquillo.

Limmong said that no casualty was

recorded from the police force. Authorities recovered from the fight scene an M-16 rifle, an Uzi sub-machine pistol, a caliber .38 revolver. two shotguns, two hand grenades, assorted ammunition and documents.

Bulut commended the residents of Calayucay for reporting the activities of the armed lawless elements in their community and risking their

"The actions of the citizens who are mostly simple farmers standing up against the rebels show that the NPA, violence and their activities are not welcome in the province of Apayao," said Bulut. It showed that the people have had enough of violence and would like to live in a peaceful manner, he added.

Marag Valley in Luna used to be NPA stronghold.

He called on other residents to be always vigilant and not to be afraid of reporting illegal activities of lawless elements to the authorities to show that these NPAs and their activities are not welcomed in their communities and in the province

Meanwhile, Police Cordillera Regional Director Chief Superintendent Isagani Nerez said the incident shows that police officers are prepared to go after groups out to disrupt peace in the region.

AS EQUALS - In negotiations across the table, the principle of parity or of equal status between negotiating parties is assumed. Of course government does not concede this but being on a high moral ground than rebels, it temporarily suspends disbelief and allows the rebels to negotiate under those parameters. So one party, in principle, cannot admit being subsumed or of lower status than the other. For instance, as a result of this, signed agreements with the MILF or the MNLF for that matter, make direct reference to and use as framework international protocols or mutually agreed references and the Philippine constitution is obviously not one of them.

CALIBRATION PROCESS - But the signing of the FINAL Peace Agreement and the IMPLEMEN-TATION phase signal a strategic shift in this calibration process. At this point, the primacy of the basic law of the land is a "GIVEN" simply because implementing the terms of any peace agreement must be done within the context and confines of the internal laws and under the coercive force of the government. Even the MILF recognizes this as a reality and will have to submit to this unequivocally as the peace process mutates and takes its inevitable course under the good offices and graces of the established regime of the government. I refer to this as a "calibration process" that everyone must understand. This is something that Congress must first understand as they now scrutinize the draft Bangsamoro Basic Law (BBL). Absent this insight, we may unnecessarily dwell and focus and find fault and at every turn quibble on every word or phrase or provision — or look for what is not there - in the agreement and its annexes. looking at them through the conventional prism of constitutionality and legality. Just to illustrate: the "annexes" of the agreement were signed in the course of negotiations and BEFORE the final peace agreement and they were done so during the " calibration" stage. So it is important that the contemporaneous stage at which those vital agreements were signed and sealed had to be seen in this light. Congress and the public must understand all this in this light. I need not explain more.

INCREMENTAL -Thus, I cringed and squirmed in great discomfort when I heard one congressman insisting that the BBL must contain a commitment from the MILF that it would not at all go back to the hills again and rebel

Peace agreements, although again. the ultimate repository of what was mutually agreed are not self-executing. They are merely pieces of paper, although sacrosanct, that will raise expectations among expectant stakeholders. They have to be implemented in on a long-term basis. The process is incremental. We need not say here but it is obvious that failing in keeping true to the government commitments will drive them back, maybe not all, to fight government again and continue their struggle. No amount of cautionary words in the BBL foreclosing their right to rebel again will remedy this. What is key is implementing the terms of the peace agreement, which is not only to show sincerity, but more importantly, we improve forthwith the lives of our own disadvantaged Filipinos who felt that they were excluded from the mainstream.

DISARMAMENT — I had reason to also feel discomfort reading the blaring media headlines, courtesy of OPAPP statements, bannering disarmament or decommissioning protocols well ahead of progress in the congressional work on the BBL. I find this imprudent, although the purpose may be to make the public feel good that the armed rebels will eventually get rid of their firearms. I heard already audible grumblings on the ground from some MILF elements on this. Let us not forget that the MILF agreed to this but only on a phased basis, depending on the implementation outcomes. It can happen only when there are significant progress in agreement implementation and when a" firearms-less" enabling environment is at hand, which requires disarming of warlords, politicians and other criminal elements. Absent this development on the ground, do you think the MILF will voluntarily disarm? Think again!

MILF PARTICIPATION -- I was even surprised to see the MILF, through Panel Chair Mohagher Iqbal gamely participating in the congressional hearings. Although this is a positive development for government, I thought the MILF would have been better off leaving the government panel to defend and advocate for the CAB. To be subjected to the rigors and discomfort of congressional scrutiny is something the MILF will definitely not relish organizationally, given that they have not forsaken their bottom-line positions while the final form of the BBL is still unclear. In my humble view, that canalizes MILF's remaining options. On a positive note, it can be interpreted to mean that MILF will eventually accept and submit to whatever final decision Congress will arrive at - which augers well for peace in the land. They may dismiss the overpricing of the P2.2 billion Makati Building2 and the alleged 13 percent cut of the Binays in all construction projects in Makati as "SOP" (Standard Operating Practice) in the government but if they see sprawling properties, mansions, man-made lakes and scenes that they see only in the movies, they are able to compare them with their own houses and lifestyle. The Binays' Batangas property makes even the middle-class Filipinos' houses look like a dog house.

Just imagine how one family cramped in a rented house in Pasav City feel looking at the Binays' paradise.

In the 2000 exposé against then President Joseph Estrada, it was the photos of the Boracay mansion and other houses of Estrada that enraged the people more than the jueteng money and mis-use of tobacco tax.

Mercado said the money used in the construction and maintenance of the Batangas farm came from Makati City construction projects. It's the money of the people of Makati.

Mercado's odious personality is not enough to diminish the shock value of the information he gave during the Senate hearing.

Trillanes also said Earthright shares the same address as the SPCMB law office at the Value Point Executive Building 227 Salcedo Street in Legazpi Village, Makati City.

One interesting information that shows the ties that bind Tiu and the Binays: Tiu is also the CEO, president and chairman of AgriNurture Inc. (ANI), formerly known as Mabuhay 2000 Enterprises Inc., which was iden-

ing was committed along the election process, related Atty. Torres.

"Over the years, peace and order in the Cordillera during election times are improving", said Atty. Torres. In Abra it had been two times of election that isolated election related deaths occurred coinciding the use of the automated system compared to the manual election that was held in 2007 where most number of casualties were recorded and eighteen army men were ambushed in the province. In my onion, poverty and the lack of livelihood were the reason for the killings. People involved on this gruesome activities engage in politics mainly served as supporters and private armies to the politicians. But in 2010 and 21013, no single casualty in Abra had been reported with the help of the PNP, army, and non-government organizations and likewise this could be attributed to the progress that is taking place in the province, he added. Nevertheless, people accept the results of the elections.

Politics in the Cordilleras for Atty. Torres is average to getting better. The public's voting maturity is high. If they don't like something from a politician, that politician does not expect to get elected or re-elected. If they don't perform well, they don't vote them, unlike in the lowlands, even if the voters do not know the person but if the family name sounds familiar, they vote for that politician. Politicians in the Cordilleras are ok. Compared to other places, Atty Torres said that politicians in this region are better. They perform much even if not everything is provided since this is way impossible. Still, they do their best and as much as they could in doing everything which is good.

COMELEC is task to enforce election laws, election, and plebiscite. This has been the life of Atty. Torres for fifteen years. With the glamour and the grotesque of being in the political arena, he does not mingle that much with politicians. It's not because he is not comfortable dealing with them since this is his job but as much as possible, he distances his self from them so as not to affect the efficiency of his works and his job per se. He said that this is advantageous because he has not been into any problem with any politician.

Working in Regions 1 and 2 is easier than working in the Cordilleras but it is ok for Atty.. Torres. he does not see much negativity in the region. This in spite of the region's peculiarity in topography and geography, difficulty in transportation, and communication. "Unlike in the lowlands it's certain that you can arrive at your destination via vehicle but here in the Cordilleras you have to trek terrains and mountains," he compared. I was a part of history' said Atty. Torres when the automated voting system was newly introduced nationwide and having completed my assignment in Regions 1 and 2. We are the pioneers on the implementation of the system nationwide, although automated system has been used by other countries, it was utilized on specific

part of those counties and not country wide. Though not first time endeavors are perfect, those foreign observers were amazed at us, he added.

As long as he can, Atty, Torres would go for optimal retirement. As long as he can deliver services to the public, his constituents, and to the people to exercise their right to vote and if election in the country is absolutely free and are peaceful then that's the time he will retire from his work.

Atty. Torres enjoys working with the commission on elections. Even if he was not given the chance to had applied his profession as a new lawyer and with no finances yet to had held a private practice, he saw his being with the commission a blessing in disguise, this as supposed to had just been for a short term of time and for experience. "I still consider my self fortunate since my profession is what is needed to run the commission," he said.

He said that working at COMELEC is challenging and satisfying. Challenging because, he is exposed to so many matters to deal with, people, politicians, and voters with different mind sets and satisfying because he meets a lot of people and has a good salary that is sufficient for his family. "If not because of COMELEC, would not had been to Sulu, Mindanao, and abroad," he said. Attv. Torres' working rapport with his colleagues is not a problem. Honestly, he treats his subordinates down to the utilities and janitors as not lower in all matters. He sees them eye to eye and does not impose authority over them. He threshes out problems with them as his friends. Of course, contradictory people are inevitable in all government agencies and departments who do not want the way affairs are being manned but, he makes the most out of it that he'll not be affected.

He is patient with his work, he strives to accomplish the goals the office and the functions mandated to him the soonest possible time, he works efficiently under pressure. Efficiency in one way of what is right is legal; certain issues and circumstances that are legal yet illegal; being in the government performing what is entrusted to him or her within the bounds of law is when everything is ok.

Atty. Torres was not able to have applied his profession privately in an office because he was absorbed by the commission. But even if he is not working in the justice hall, he is performing his profession as a lawful lawver and within the bounds of law in the government. He loves sports particularly basketball, even if he can't play the game with his time, he watches it on tv. He watches American football and movies. He plays table tennis with his high school and college friends. He plays video games on his spare time and it's a habit until now with passion and enjoyment. "i spend time with my family. Addressing the 'hacienda' issue

Earlier this week, Mercado alleged that Binay owns a 350-hectare estate in Rosario, Batangas which is equivalent to "six Luneta Parks, 10 Araneta Centers or even half the city of San Juan."

Mercado said the estate has two mansions, an air-conditioned piggery, orchid farm, cockbreeding farm, horse tanch, and a man-made lagoon.

Senator Antonio Trillanes also insisted that Antonio Tiu, the businessman who claims to be the owner of the property, is just a dummy of Binay.

The vice president and Tiu vehemently denied the allegations.

"Nakakatawa po iyon. Matagal nang isyu iyon. Dumami na nga nang dumami. Dati nga 150 [hectares], apos naging 200 ngayon naging 300 na. Pinaliwanag na po namin iyan. Hindi po ako ang may ari niyan. Nananaginip na lang iyan," Binay said.

He added, "Ang nakakalungkot nga lang po, hindi na yata kasama sa imbestigahan iyan. Ang iimbestigahan supposed to be is yung alleged overpriced building. Kita ninyo pulitikang-pulitika, ito personalan na. Hindi naman po criminal case ito."

Binay also revealed that he pities Fiu after the latter was dragged into the "political circus." He said Tiu is a legitimate businessman who owns the estate, now Sunchamp Agri-Tourism Park, in Batangas.

"Nakakaawa naman ito. Hindi pa nga tumitestigo winawasak na ang pagkatao. Yun ang demeanor ng mga senador na iyon. Siya naman talaga ang nay-ari. What's the problem with hat? Sa palagay ko, kuryente ang abutin noon," he said.

When asked if Tiu is a friend, Binay simply said, "Kakilala ko."

What Trillanes claims

Meanwhile, Senator Trillanes insists that Tiu is, indeed, being used as a "dummy" by Binay to hide properties he supposedly acquired from illgotten wealth.

Trillanes laid out the alleged links between Binay and Tiu, who he said is the dummy owner of the vice president's 350-hectare property in Rosario, Batangas, concealing it under the name of Sunchamp Agri-Tourism Park.

Trillanes shared to the Senate that last August 5, he attended the "launch" of the Sunchamp Agri-Tourism Park along with Presidential Assistant for Food Security and Agri-cultural Modernization Francis Pangilinan, and Agrarian Reform Secretary Virgilio Delos Reyes.

The supposed launch, he claimed, was apparently only an attempt by the camp of Binay to make it appear that Tiu's Sunchamp Agri-Tourism Park is a legitimate business.

"Apparently last August 5 nung ni-launch ito, meron silang intensyon na talagang gamitin ang iba't-ibang opisyal ng gobyerno, including myself, si Sec. Pangilinan at si Sec. Delos Reyes, para linisin and to make it appear legitimate," he said.

He noted that the launch still pushed through even if typhoon "Jose" was battering some parts of the country that time.

"Sabi ko, bakit hindi na lang ipostpone ito at bakit hindi makapaghintay. Well, apparently, meron na talagang naka-setup," he said.

Trillanes also said that he was surprised when he noticed that the park's pavements were not new. "Yung mga pavement, yung mga kalye ay may lumot or luma na. Alam mo na luma na ito. Even the landscaping luma. So nagtataka ako bakit ngayon lang ito ni-launch."

"Well apparently ito na nga, naglilinis na ito. Ito na ang isang patunay na talagang nagre-resort sa dummy itong si Vice President Binay," he said.

"Akala kasi ng iba magpa-picture lang sa atin o imbitahan tayo na magguest sa isang activity eh magiging protektado na natin sila," he added.

To back up his claims, Trillanes also presented to the Senate Tiu's alleged connections to Binay.

According to the senator, Tiu folded Sunchamp Real Estate Development Corp. in 2013 into a publicly listed corporation, the Greenergy Holdings Inc., where Tiu is president.

Trillanes said the main shareholders of Greenergy are the Sunchamp Real Estate Development Corp., Earthright Holdings Inc., and the Three Star Capital.

Citing the website of Greenergy, he said Subido, the legal counsel of Binay, is its corporate secretary and compliance officer.

Subido is also the director of Earthright Holdings Inc., he said.

He stressed that Subido is a law partner of one of Binay's daughters, Makati Representative Abigail Binay, and a senior partner of the Subido, Pagente, Certeza, Mendoza, and Binay (SPCMB) law office.

Trillanes also pointed out that Earthright shares the same address as the SPCMB law office, and that is at the Value Point Executive Building 227 Salcedo Street in Legazpi Village, Makati City./with reports by Kathlyn dela Cruz, ABS-CBNnews.com


