BAGUIO CITY – Only private motor vehicles of tourists and not of city residents are exempted from the coverage of the city's number coding ordinance.

Mayor Reinaldo Bautista Jr. clarified this as he issued Executive Order No.1 setting the guidelines for the implementation of Ordinance No. 107 series of 2008 entitled "Exempting Private Motor Vehicles and Chartered Public Utility Vehicles of Visitors, Tourists, Vacationers or Participants of Sanctioned Activities such as Conventions, Conferences and Assemblies (from the number coding ordinance)."

"The vagueness in the wording of said Ordinance resulted to confusion to motorists, traffic enforcers and the general public (thus) there is a need to elucidate the ambiguity of said amendatory Ordinance by setting guidelines for the purpose," the mayor noted in his executive order.

### Pía on nuclear energy revival: "Look before we go nuke" Let's weigh the

Senator Pia S. Cayetano today called on the Department of Energy (DOE) to open its nuclear energy development plan to extensive discussion and debate that would involve experts, lawmakers, and the general public.

The lady senator said she is keeping an open mind to the energy department's plan to study the rehabilitation of the Bataan Nuclear Power Plant (BNPP), but added that the process should be opened to scrutiny by independent experts, Congress and concerned sectors. "Nuclear power is being promoted in some countries and being discontinued in others. Proponents claim that it is the most environmentfriendly energy source, and that new technology and lessons learned make it safer now."

"But we need to study this very carefully. We must strike a balance between the need to meet our energy requirements in the coming decades, and taking precautions with the known risks of nuclear power, as well as its possible impact on health and the environment, Cayetano said. "We should

look before we leap.

# Chiz to probe alleged bribery scandal in prosecution service

Purported acquittal of cases involving heinous crimes through alleged bribery and influence peddling in the National Prosecution Service will be probed by the Senate Committee on Justice and Human Rights once congressional session opens next week.

Senator Chiz Escudero, committee chairman said he is filing a resolution today to look into the alleged bribery scandal which has brought to fore a very serious issue concerning the administration of justice itself.

Escudero said the allegations involving the country's prosecutors are too disturbing to be ignored especially since these have been said to result to the acquittal of cases

like large scale smuggling, plunder, rape and drug-related crimes.

The senator wants to validate reports that almost 80% of all cases filed in court have been dismissed, specifically illegal drug cases being handled by the Philippine Enforcement Drug Agency (PDEA).

Opposition Senator Chiz today Escudero cautioned the government to stick to humanitarian missions alone of the 2009 **RP-US** Balikatan military exercises in the Bicol provinces in April this year.

The Balikatan exercises have been arranged for engineering and medical missions in the provinces of Albay, Masbate and Sorsogon,

Escudero, Senate Committee Chairman of Justice and Human Rights said the aim of the Balikatan exercises would benefit many locals, especially those who have been severely affected by disasters in previous years, he remains wary of other agenda that may be concealed from the public.

"Our government better make sure that this exer-

cise will adhere to the terms it has been devoted to and not use it as front for other endeavors that may antagonize and stir indifference from various sectors."

Escudero, for one refers to the insurgency problem in the Bicol region with New People's Army on the other end of the government concerns.

### Mayor assures effective waste collection city has regained

BAGUIO CITY -Mayor Reinaldo Bautista Jr. Thursday assured that the city will continue to implement an effective waste collection system in the coming months for the major activities lined up in the city topbilled by the Baguio Flower Festival.

The mayor told the weekly Ugnayang Panlungsod aired over DZEQ Radyo ng Bayan that he had directed general services officer and city environment management head Romeo Concio to work out an effective waste management plan for the expected influx of tourists.

said He the smooth collection activities for the past months show that the control over the erstwhile erratic collection system.

He also assured that the city would be ready to deal with all types of wastes particularly plastic and styfoam containers and other special wastes which are expected to increase due to the presence of tourists here.

The mayor appealed to both residents and tourists to cooperate with the city by observing waste segregation and other city rules and regulations governing waste disposal.

"We hope that we will all be responsible for the success of our waste management program," he said. The mayor early last week also directed Concio to continue the hauling of residual wastes to Capas, Tarlac while other alternative measures are still being pursued on the waste disposal system of the city.

Concio said the city has generated savings from the fund earlier allocated for the hauling of wastes and this will be used to continue the activity.

He said the city is also fasttracking the rehabilitation of the Irisan dumpsite to enable the city to utilize the same while the engineered sanitary landfill is still being worked out./ Aileen P. Refuerzo

# **Power Without People** What did Confucius teach about erosion of trust in a

country's rulers? Supreme Court chief justice Reynato Puno cited the Chinese sage to meet, head-on, reports that Malacanang secretly bankrolls moves to impeach him,

To cashier Puno would help congressmen defend the indefensible: railroaded charter change. That'd enable the President -and themselves - to stay beyond 2010. That will contested before the high court. "We have nothing to do with this ouster bid," Palace spokesmen protest.

Today,"the main problem is moral decadence...and impeachment it's most popular political blood sport," Puno noted. Yet, more than prosperity or military force, government needs the people's trust to govern effectively, Confucius taught.

the exact Confucian warnings. Perhaps, this is as good a time, as any,

to recall the sage's message.

Confucius lived (551 to 479 BC) under the brutal Han dynasty. It was a "time of trouble," Professor Arnold Toynbee noted. The sage wrote on personal and government morality. These were compiled into his "Anaclets"— introduced later to the Western world by the Jesuit scholar Matteo Ricci.

Puno referred to the famous question that a disciple asked Confucius : How does one ensure good government? "An effective government must have sufficient food, enough weapons and confidence of the common people," the sage replied.

"Suppose one of these three must to be dispensed with," the disciple persisted:"What should it be?" The sage replied: "Weapons."

"But what if two must be let go?", he asked. "Then, let the food go," Confucius said. "From of old, death has been the lot of all men. But if people have no confidence in the government, the state can not stand.'

Indeed "what better summary can we find of all that we are learning today from bitter experience than this simple statement spoken 25 centuries ago?" Wait. That's not Puno's comment. That's historian Horacio de la Costa. addressing University of the Philippines graduates in the late 60s.

"Power independent of the people is an illusion... made possible by boundless patience of people," Father del la Costa said. "People are slow to move. But they do move. (Benito) Mussolini was "one of the most powerful men of our time...And we saw what Mussolini was without the people. They took pictures of it — a corpse hanging from a clothesline.

Fr Dela Costa died in 1977 age 60. He did not see how, nine years later, "one of the most powerful men of our time" Ferdinand Marcos" found himself without the people. Marcos shriveled into a lupus-afflicted exile.

The Jesuit historian titled his UP address:"The Eastern Face of Christ". He takes off, as Puno did, on what Confucius taught almost 26 centuries ago "on the function of example in society". They remain "perhaps (Confucius) most original contribution to the science of government." Today, they resonate for a government sapped by decadence.

'If one tries to guide the people by means of rules and keep order by means of punishments, the people will merely seek to avoid penalties without having any sense of moral obligation, "Confucius said "But if one leads them by virtue, and depends upon propriety to maintain order, then people will feel their moral obligation and correct themselves.

Would we dare apply this standard the own social order?De la Costa asked. Yes, Puno said in his speech to the Anvil Business Group in Oritgas. We must apply those yardsticks to our social order in 2009. Let religious leaders step forward as a "moral force".

No, no, no, deputy presidential spokesman Anthony Golez protested. The Arroyo regime already tackles corruption and other ills, even without Puno or Confucius. Golez brandishes the dubi

## THE PEACE COMBATANT

Work for peace in Gaza, protect the women and children

Last week, The Peace Combatant expressed concern on the recent assaults of Israel in Gaza. The Peace Combatant, of course, does not wish to express sides in the conflict given that the resolution of the conflict is not really easy.

The Peace Combatant noted last week that the Palestinian death toll was 760 as of 10 January 2009, with the half civilians. As of 16 January 2009, however, one report says that the death toll stands at 1,132 Palestinians killed, including 311 children and 100 women.

This strongly indicates that Israeli assaults have been largely targeted on non-combatants. In contrast, only 13 Israelis were killed with only 3 of the 13 are civilians.

The Peace Combatant noted last week that while the recent assaults were Israeli response to rocket and mortar from Hamas, the Hamas response was triggered by the food and physical blockade made by Israelis on Gaza. Israel has effective control over the shores and borders and Gaza thereby affecting Gaza's access to food. Hamas argues that the mortar and rocket fires are simply a response to Israel's attacks and blockade.

On the other hand, the United States, European Union, and a number of country governments consider Hamas a terrorist organization. It is the dominant group in Gaza and had marginalized its rival Fatah in leading the Palestinian people. Hamas and Fatah had been competing in leading the Palestinian people.

Recently, Hamas has won the elections in Gaza and had declared itself as the legitimate government. Sympathizers consider Hamas as a fighter for national liberation, a movement for self-defense given Israel's tightening grip on its neck or territory.

Israel has attacked civilian buildings and mosque's claiming that the infrastructures have hidden weapons for the Hamas. In the process, 100 women and 311 children were killed. The attack on civilian infrastructure also explains why around half of the deaths are civilians. Around 45% of the Gaza population are children 14 years or younger. Thus, attacking civilian infrastructure has always a 45% probability that the casualty would be children 14 years or younger.

Gaza, of course, is a biblical landmark. It is the location where much of the story of Samson and Delilah took place. This can be used as a justification for Israel to claim the territory but Islamics can also use the same biblical reference to argue for their claim. Ishmael, son of Abraham with Hagar, is a legitimate heir of Abraham. Islamics identify Ishmael as their ancestor. Ishmael is also the ancestor of Islam's prophet Muhammad. Thus, both the Israelites and Palestinians can have strong bases for their claim on Gaza based on the bible and history.

Unfortunately, far from the being an agent of peace, the United States under the incoming presidency of Barrack Obama would most likely heighten the tensions in Gaza. This is because it is a foreign policy view of Barrack Obama not to distance itself from Israel. Most likely, the Israeli attack on Gaza found encouragement from the policy view of Barrack Obama.

This is to say however that the Barrack Obama government does not have a positive contribution to the American people. The victory of Barrack Obama signals a potential end to the racial divide in America. He is the first black U.S. president. This is the most important contribution of Obama's win.

Unfortunately, Obama's popularity and policy view provide the synergy that will exacerbate the Middle East conflict. His policy view as incoming U.S. president will worsen the divide between Islamics and the rest of the world. For peace to be realized, the American people must review the policy perspective of Obama while the rest of world must condemn with one voice the slaughter of the innocents.

The Barangay Bagsakan is a socialized barangay marketing system, wherein farmers can sell their products at a higher price and where consumers can buy these products and other basic commodities at a lower price than its prevailing market value.

There are already 18 Barangay Bagsakan throughout the region and there are more than 100

Fernando Bahatan, the secretary and treasurer of the CCIPD said that a major problem of the organization is the lack of appropriate stainless containers and funnels. The guidelines are as follows: "\*Sanctioned activities shall refer to sponsored, cosponsored or hosted activities by the city of Baguio which are duly authorized or approved by the (mayor's office) and/or the Honorable City Council through appropriate resolution."

ONLY the private motor vehicles of visitors, tourists, vacationers, or participants of sanctioned activities such as conventions, seminars. Conferences and assemblies are exempted from the implementation of the Baguio City Number Coding Scheme;

\*ONLY the chartered public utility vehicles of said guests attending these aforementioned authorized activities are exempted from the implementation of said scheme;

\*Participants are required to present to the apprehending traffic enforcers the proper identification issued by their respective convention, seminar, conference or assembly organizers to ascertain their involvement to said events;

\*The Traffic Management Branch of the Baguio City Police Office (TMB-BCPO) is hereby directed to strictly enforce this Order; and

as against conviction relating to illegal drugs alone".

Escudero is also after the track record of prosecutors in relation to the cases they have handled and are handling.

"Isa sa titingnan namin yung track record ng mga prosecutor pagdating sa mga kasong isinasampa o nirerekomendahan nilang madismiss, ilan na ba ito, ano ano klaseng kaso ito at kung mayroon tayong judge-bitay ika nga na noon, puro mga execution ang mga desisyon. Baka naman may mga piskal tayo na puro dismissal din ang desisyon ng anumang kasong nakakarating sa kanilang lamesa, kukunin naming ang statistics at datos dahil baka may pattern tayong makikita tungkol sa bagay na ito" Escudero said.

Escudero said the whole National Prosecution Service must be reviewed and accordingly provided appropriate safeguards to thwart any possibility of bribery or influence peddling.

"It really must be looked into and, if warranted, be tempered with appropriate legislation to avoid their office's vulnerability to money and fortune".

As this developed, the senator challenged the Office of the Ombudsman, which has now started a "quiet" probe into the matter, to really rise up in this issue and to show something for its investigation on this issue and all other issues in the past.

He said Ombudsman Gutierrez cannot sit

idly by anymore as she did with previous issues under her office because this bribery scandal has shown the vast powers granted by law to public prosecutors.

"The Ombudsman is the underbelly of the government's cleansing system. Ombudsman Gutierrez has been one with the DOJ before she went to OSG. As a way of personal and professional aside, she should see to it that the National Prosecution Service and all government agencies for that matter, is properly cleansed and policed"./Office Of Senator Chiz Escudero.

in Bicol still persists and needs to be addressed in all fronts, he said the

government should keep external forces out of this matter.

"The Balikatan should avoid at all cost any intervention that may straddle in our internal affairs. The insurgency issue in Bicol, and in any part of the country for that matter, remains the national government's concern and responsibility. Any outside force touching it meddles with our sovereignty".

The senator also cautioned US soldiers joining the exercises to conduct themselves in the true manner of an officer and a gentleman and adhere to the laws governing the country and its people.

"The Balikatan should not leave any single Filipino disadvantaged in any form or manner. Both sides should make sure that they finish the exercises without any untoward incidents".

Escudero, who is a Bicolano himself also appealed to all locals and the armed sectors of the province to let the military humanitarian mission proceed peacefully.

"Let no one antagonize any one. If this mission is really for medical and engineering endeavors, let us not get in the way of helping our fellowmen who have suffered from the devastation of previous disasters."/ Office Of Senator Chiz Escudero

tablished in a recent Supreme Court decision promulgated in November last year.

"In its ruling in Social Justice Society vs. Dangerous Drugs Board and Philippine Drug enforcement Agency, the High Court affirmed the validity of the provision in the Comprehensive Dangerous Drugs Act mandating 'suspicionless' drug tests for students in secondary and tertiary schools."

Quoting from the decision, she said random drug testing in schools should be viewed as "a kind of search in which a reasonable parent might need to engage," and that "minor students have fewer rights than an adult, and are subject to the custody and supervision of their parents, guardians and schools." In pursuing its duty to safeguard the health and well-being of its students, schools may adopt such measures as may reasonably be necessary, she continued.

"I tend to agree with random drug testing, provided that there are clear guidelines for its implementation in order to prevent abuse. "The random testing should not be

"The random testing should not be interpreted as a punitive action, like a seek-and-destroy type of operation but a means to help the victims, the young users, find their way out of their addiction."

"In addition, random testing should be part of a comprehensive program to tackle the drug problem. This program should not lose sight of its main objective which is to crack down on drug pushers and financiers and eliminate shabu laboratories and marijuana farms."/ Office Of Senator Pia Cayetano

to redesign, install, implement and monitor their respective internal control systems taking into consideration the requirements of their organization and operations," Andaya explained.

The NGICS was formulated by the DBM and the Office of the President's Internal Audit Office, with assistance from the Australian Agency for International Development (AusAid), through its Technical Assistance Facility, the Philippines- Australia Partnership for Economic Governance Reforms (PEGR). A Reference Panel (DepEd, DOH, DOF, DILG, DOJ, DOTC, DPWH, NEDA and DAP) and Resource Agencies (COA and PAGC) provided inputs to the document.

The NGICS is now being pilot-tested in the DPWH. The DepEd and 21 other departments/ agencies will soon be provided assistance in strengthening their respective internal control system.

Andaya said the NGICS will be uploaded in the DBM and PEGR websites to facilitate wider and easier access to the document./PIA

These projects, Puno said, include the DILG's Project OYSTER, which provides jobs and emergency economic assistance for marginalized workers and out-of-school youths (OSYs) through the barangays. OYSTER stands for "Out-of-School Youths Servicing Towards Economic Recovery."

Panadero said another DILG "value-added" project—the Localization of Millennium Development Goals (MDG) initiative—is also ready to carry out P107.83 million-worth of projects in the first quarter of 2009 to help generate jobs and provide "social protection" to poor families as soon as the LGU beneficiaries complete the submission of documents for the release of funds for their respective projects.

These projects include the construction of a daycare center, hospital, public market; the establishment of a water system; implementation of an integrated agricultural project and the procurement of heavy equipment in various LGUs across the country.

The DILG's Localization of MDG project aims to capacitate LGUs in effectively implementing programs in their respective localities that conform with the Millennium Development Goals of eradicating poverty.

The United Nations' Millennium Development Goals are the world's timebound and quantified targets for addressing extreme poverty and worst forms of human deprivation in its many dimensions—income poverty, hunger, disease, lack of adequate shelter, and exclusion—while promoting gender equality, education, and environment sustainability./PIA

ers going around/dine-in places around the lake and a fireworks in the evening.

The much awaited Grand Street Parade will be February 28 and a Float Parade is on March 1. De Leon reported that some street dancing groups from the lowlands have signified their intentions to participate.

We have targeted 50 floats this year, higher than last year's 33 floats. Basically because we have waived the registration fee that the committee should be collecting from the participants, De Leon explained.

Also included as major events are: "Market Encounter" and a Landscaping contest in Burnham Park; "Session Road in Bloom" from March 2-8 wherein Session road will be closed for vehicular traffic and open for revelers for a week; Abanao Nights – February 26-28. Other major events are still being coordinated as of press time.

Numerous minor events throughout the month-long celebration, are also lined-up at the SM City Baguio, and in other venues in the city like the Baguio Convention Center, Melvin Jones, Burnham Park and the Athletic Bowl.

More than one million visitors are expected to come up to Baguio City which would be a great contribution to the income of business establishments and primarily to the economy of the city, De Leon said.

Meantime, Baguio City Police Office chief PSSupt Wilfredo Franco assured maximum deployment of personnel and maximum BCPO operations, to ensure the safety of Panagbenga visitors and revelers, and to manage traffic situation in the city. The BCPO already released a traffic and route/re-routing advisory for the Panagbenga 2009 Opening, Grand Street and Float parades and the "Session Road in Bloom" event.

"Panagbenga" or Baguio Flower Festival is a brain child of Mr. Damaso Bangaoet. It was first staged in February 1995. Now on its 14<sup>th</sup> year, it remains the biggest crowd drawer in Baguio City./ PIA

ous claim of "high conviction rates" by an Ombudsman. This officer hasn't even brought the Mega-Pacific election computer thieves, fertilizer and ZTE broadband grafters to book.

"Confucius told us about virtue in the ruler", De la Costa added. "Jose Rizal (told) us about virtue in the people....There is an objective norm of justice to which all human acts must conform".

"There is also an elemental will of people to "live together, to constitute a nation, ", De la Costa notes in his analysis of "El Filibusterismo.", But this will, on surface, is rocked by "shifting gales of partisan strife...It is capable of being distorted by unworthy leadership. "Thus, the leader must...show people what in their aspirations is paramount. (He) must lead them, by degrees to will in each particular crisis what their own best interests demand."

But what if repudiated leaders refuse to relinquish power? Marcos refused. An often soused Estrada never got the time. And Arroyo is bent on clinging, kapit tuko, to the Palace.

"Then, the people have only one course: to resist," de la Costa said. India's Mahatma Ghandi, put his finger on one formidable quality of Asians: "a granite face that will shatter anything that can be hurled against it – patience, the capacity to endure."

"We ought never to forget the great lesson of (non-violent resistance) that Ghandi taught. We may have the occasion to use it in the very near future." This year and 2010 perhaps, as Justice Puno and others fear? /J.L.Mercado

seem Gonzalez is already setting the stage for discrediting the PDEA case against the Alabang Boys, thereby upholding the dismissal of the drug-pushing case filed by PDEA against them.

Also, Gonzalez seems eager to disregard the fact that the PDEA operations participated in or led by Maj. Marcelino were not Marcelino's sole acts, but the PDEA's, so that even if there is a legal question about Marcelino's participation, this would not invalidate PDEA's actions because PDEA itself is authorized by law to conduct such operations.

Finally, the law that created PDEA authorizes it to secure the help of anyone from government agencies in order to eliminate or at least minimize the drug menace.

With due respect, I think Raul Gonzalez is already losing "it", so that he should serious consider going on leave or resigning outright as secretary of the DOJ. -000-
