Thus, in essence, declared mayor Mauricio Domogan last week as he called on Cordillera local government units (LGU) to pass necessary resolutions imploring Malacanang to certify the 2011 Organic Act as urgent piece of legislation.

"The only way we can succeed is if we act together," said Domogan who claimed the bill could have smoother sail through the two houses of Congress if it were stamped with executive certification.

Presidential certification dispenses of the requirement not only of printing but also of reading the bill on separate days as provided in Article VI of the 1987 Constitution.

Release of Fund for Dumpsite **Rehab Awaited**

BAGUIO CITY - Mayor Mauricio Domogan expressed hopes that the P110 million approved by President Benigno Aquino for the rehabilitation of the collapsed retaining wall at Irisan dumpsite here will be released soon to ensure early implementation of the project.

"Hopefully the national government will release the fund approved in principle early so the project can be expedited and completed hopefully before the onset of the rainy season next year," the mayor said.

He said the program of work for the project has been submitted to the Dept. of Public Works and Highways (DPWH).

The project will cover the reconstruction of the retaining wall which collapsed at the height of a typhoon in August triggering a trash slide that killed six people.

The new structure is designed to withstand strong typhoons and heavy water flow which toppled the erstwhile protective wall in the area.

Earlier, the mayor formed a technical committee to prepare the plans for the rehabilitation of the wall and other reinforcement measures to strengthen the area.

The committee is chaired by city engineer Leo Bernardez and composed of Dept. of Environment and Natural Resources Environmental Management Bureau (DENR-CAR EMB) regional director Paquito Moreno, DENR-CAR Mines and Geo-Sciences acting regional director Orlando Pineda Sr., city building official Engr. Oscar Flores, Saint Louis University School of Engineering and Architecture Dean Engr. Bonifacio Dela Pena and Non -Government Organization consultant Dr. Virgilio Bautista./A Refuerzo

BAGUIO CITY - In the face of a petition seeking total abandonment and conversion of erstwhile Irisan garbage dumpsite into a green mound, mayor Mauricio Domogan last week maintained the area "is not and will not be the way it used to.'

"I believe there is confusion here somewhere," he said adding, "There is no

more dumping at Kalikasan', 'writ of Irisan."

"We are merely dumpsite into a transfer and sorting area for non-biodegradable garbage which is shipped to the Capas, Tarlac **Engineered Sanitary** are fed into Environmental Recycling System.'

DENR says NGP Successfully Implemented in CAR

BAGUIO CITY—The first year of implementation of the National Greening Program (NGP)in the Cordillera is a success meeting its target of planting a total of 3.4 million assorted trees in an area of 6,800 hectares.

According to Regional Executive Director Clarence Baguilat of the Department of Environment and Natural Resources (DENR), the success of the implementation of the NGP is attributed to the concerted efforts by the government employees who are required to plant a minimum of ten seedlings a year, the private sector, students, local government units and civil soci-

They played a big role in the accomplishment of our target and we are again asking their support for the NGP in the years to come, Baguilat expressed.

It will be a bigger task next year as we will be planting 15,000 hectares with a 7.5 million trees. It is a challenge and I am confident we can do it if we help each other,' Baguilat said.

According to Baguilat, the DENR is putting additional nurseries and coordinating with the Department of Agriculture to have nurseries for fruit trees.

Big corporations through their corporate social responsibility programs are also encouraged to put up their own nurseries, Baguilat added.

President Benigno S. Aquino issued Executive Order (EO) Number 26 creating the National Greening Program (NGP) in February 2011 to pursue sustainable development for poverty reduction, food security, biodiversity conservation and climate change mitigation and adaption.

The E.O. states that all proceeds from agroforestry plantations duly accounted by the DENR shall accrue to the NGP beneficiary communities to address food security and poverty reduction./JDP/JBZ-PIACAR

Ombudsman calls on Criminal Justice System Pillars to be in the Forefront

BAGUIO CITY Ombudsman Conchita Carpio Morales called on all agencies, organizations and sectors composing the five pillars of the Philippine Criminal Justice System to be at the forefront on the country's battle

against corruption. 'We, in the anticorruption arena, should be at the forefront on the battle against the scourge in society we call corruption. I, thus, loudly call on all of you to end this," Morales said in reference to disturbing reports of corruption, abuse or incompetence by members of the different pillars that may unduly result in the erosion of thrust to the system.

Morales was the keynote speaker during the forum dubbed as "Bridging the Gaps in Integrity Initiatives' here at the Baguio Country Club, Mon-

day, in observance of the International Anti-Corruption Day, Transparency International Philippines. The said forum

spearheaded by the Office of the Ombudsman and the Integrity Project of the US Agency for International Development (USAID), was attended by representatives from the Five Pillars of the Criminal Justice System namely law enforcement, prosecution service, courts, correctional institutions and community including civil society organizations and the media.

Morales also stressed that it beholds that each of the five pillars should guard itself against issues affecting integrity, as well as to operate as an efficient system of check and balance, wherein each pillar is equally accountable to one

another, as all of in Anti-Corruption Drive them are answerable to the people that focuses their thrust in the system.

Morales emphasized on three relevant principles on the country's justice system which she identified as independence, access and integrity.

On independence, Morales pointed out that the country's entire criminal justice system is built around pillars that are interdependent with each other and draws it strength primarily from such connections. 'Hence, the independence of the pillars of the criminal iustice system should not be viewed as to isolate one from the others rather the independence should foster interdependence", Morales said.

"The pillars in isolation does not constitute a whole. Working together as an intimate network

DOH Introduces Complete Treatment pack in CCT areas

BONTOC, Mt. Province — The Department of Health (DOH) introduced the Complete Treatment Pack (ComPack) program to increase patient's access to quality essential medicine, to improve primary health care in the poorest communities, and to provide complete treatment regimens to indigent patients.

The ComPack program is designed to reach the poorest of the poor for the treatment of the common diseases of the country like hypertension, diabetes, infections, and diarrhea; and emphasizes rational use of medicines by promoting compliance or adherence to treatment.

Rache 1 Bayanes of the Food and Drugs Administration-Department of Health Cordillera explained that the DOH ComPack medicines shall be provided for free to beneficiaries of the Conditional Cash Transfer (CCT) or the Pantawid Pamilyang Pilipino Program (4Ps) of the government.

The DOH grants Rural Health Units (RHUs) with medicines package

for prevalent diseases targeting the families enrolled in the CCT program as the beneficiaries.

The beneficiaries receive full subsidy for medicines provided that they go to the health center, have themselves checked and adhere to the treatment prescribed by the doctor, she said.

The DOH ComPack program is also granted to local government unit (LGU) hospitals and DOH-Retained Hospitals and medicines are for sale but at a cheaper price. Medicines under the ComPack program can be availed of Cont. on page 11

DOST Installs Automatic rain Gauges

BAGUIOCITY-The Department of Science and Technology (DOST) is installing Automatic Rain Gauges (ARGs) in the different provinces all over the country to further improve weather forecasting.

DOST-Cordillera Science Research Analyst Hansi Dinumla, in a radio interview said they hope install the ARGs in all prov-

Provinces inces including plus Baguio City before the year end.

Already stalled are the ARGs for Benguet located at the rooftop of the DOST Regional Office; in Kalinga at the Kalinga State College and for Abra, in the town of Lagangilang.

Installation of another ARG is on going in Bontoc, Mountain Province.

Dinumla also bared that they have also provided orientation to the respective provincial Science and Technology and other local stakeholders on the operation and maintenance of such equipment.

DOST-CAR Science Research Specialist II Melchor Deponio explained that the said ARGs were designed by the DOST Advanced Science and Technology Institute (ASTI), in partnership with the Philip-

"One swallow does not make a summer," the old proverb cautions. But when a somnolent Ombudsman suddenly uncorks a slew of overdue charges, you sit up.

Gutierrez took years to flip through documented charges by Businessman Efrain Pelaez Jr. He cited a Commission on Audit report that found computers delivered were not the specified Pentium 4 processors, with 512 megabytes of memory , Lapu Lapu students got Celeron with only half megabytes of memory."

"Conviction rates slumped "dramatically to 14.4 percent by first semester of 2008," under Gutierrez. "Rates (dipped) to as low as 5 percent in March, then 3 percent in May. It was zero by June.

Three months later, only 7 percent of the 349 cases brought forward by Ombudsman Gutierrez resulted in jail terms. In her State of the Nation messages, President Gloria claimed the opposition.

The conviction slide persisted into 2009. "There has been parallel erosion in public perception of the Ombudsman's sincerity". "Cases lie there, And they die there," PHDR said of this agency. That's a line from the 1950 pop song: "Mona Lisa."


City Mayor Paz Radaza offered the de-cajon response, on behalf of her husband. Like many Philippine cities, Lapu-Lapu has had husband and wife take turns at running City Hall.

"We still have to receive a copy of the information from the Office of the Ombudsman, Mayor Radaza told Sun Star. "As soon as we get a copy, our lawyers will study it and recommend to us our next legal move."

Do the Radazas and other Lapu-Lapu officials get the message to get their act together – or be fired? That is the basic issue..Look at some specific findings in COA's latest report on Local Governments:

- 1. The 20% Development Fund is intended to address urgent human needs, from malnutrition to urgent medical needs. But Lapu-Lapu charged P2.55 million against this vital safety net "without observing pertinent guidelines…resulting in the irregular disbursement of government funds."
- 2. Use of the P213.9 million "Hoops Dome and Jeepney Terminal Facilities were not maximized. An income shortfall resulted.
- 3. Over P11.4 million in cash advances, granted to Lapu-Lapu officials "for travel and special purposes, remain unliquidated. This results in padded entries on receivables. "Issue demand letters or withhold salaries" of deadbeats.
- 4. To beat COA bidding safeguards, Lapu-Lapu spent P3.0 million for "security services" by splitting purchase orders. The Bids Committee must stop this underhanded practice.
- 5. A laid back Lapu-Lapu didn't bother to withhold P2.53 million in taxes from P18.3 million allocated for hazard pay.

What Christ would have wanted for Christmas

Today we focus on what our birthday celebrant would have wanted for Christmas! After all, Christ is the real reason why Christmas exists. He is THE celebrant on Christmas day.

The first book on the New Testament is from the apostle Matthew. On chapter 1 of his witness, Matthew said that Jesus was conceived in Mary by the Holy Spirit. Matthew testified that the name "Jesus" is associated with salvation. Jesus' father Joseph was commanded to name the child who is about to born as "Jesus" because He will save many from sins. Yet, at the same time, Matthew also witnessed that the birth of Jesus will be the fulfillment of what the prophets said through the ages that "the virgin will be with child and will give birth to a son" whom people will call as "Immanuel" which means, "God with us." The prophecy that the virgin's son will also be known as "Immanuel" was written in the Book of Isaiah chapter 7 verse 14.

Thus, the Book of Matthew connects itself with the Book of the Prophet Isaiah. Of course, man-made religious customs and traditions probably removed the emphasis on this but the link is clearly affirmed in the New International Version of the New Testament. Christ birth is clearly linked with what have been written in the Book of the Prophet Isaiah. This reference also appears to be clear in versions of the New Testament with the imprimatur of Roman Catholic authorities.

The emphasis of the Book of Mark is a little bit different. Mark's introduction of Jesus starts in chapter 1 with St. John the Baptist who was to preach the baptism of forgiveness. Thus, the Book of Mark emphasized on forgiveness as a central theme of Christianity. But here is a catch. The Book of Mark began with the introduction of the introducer of Jesus, John the Baptist. In turn, John the Baptist, witness for Jesus is in these words, "I will baptize you with water but he will baptize you with the Holy Spirit." In effect, John the Baptist's introduction of Jesus emphasized on the Holy Spirit. Baptism with the Holy Spirit is the baptism that only Jesus can provide based on the testimony of St. John the Baptist as per the documentation in the Book of Mark.

The witness of the Book of Luke chapter 1 on Jesus also began with the person who was to prepare the way to Jesus. In preparing a people ready for Jesus, the Book of Luke said that St. John the Baptist was to "turn the hearts of the fathers for their children and the disobedient to the wisdom of the righteous ——to make ready a people prepared for the Lord." Thus, the emphasis of the Book of Luke is that preparedness for Jesus is also important related to his birth, the first Christmas.

Mining's Big Fight! Part 1

DIPOLOG VISIT—I was back in Dipolog City a few days ago. There's an interesting and important court case now before the Regional Trial Court there. And it's worth watching because the court ruling is crucial on issues on mining, local autonomy, police powers of the state, and other issues clearly with constitutional undertones. It may help resolve the pestering question: if a local legislation comes in conflict with national laws, which one should prevail. Collateral to this is the question on whether the local Sanggunian Panglunsod (SP) or Provincial Board has the authority to pass an ordinance that will outlaw what the national law, the Mining Act allows. Or whether the so-called powers under the local autonomy law allow the LGUs to abridge effective and subsisting contracts. There are still a host of other collateral issues. This Dipolog case will eventually end up in the highest levels: the Supreme Court. It will be precedent setting.

POLICY ISSUES There are also policy issues. For example: Is the national government now under President Aquino really dead serious in its announced policy that it is supporting mining? If so, why are the anti-mining elements in the present administration doing their own thing as if they have their own agenda and ignoring, nay, undermining if not embarrassing, the president's public

On the other hand, perhaps the president himself is indeed NOT supportive of mining. If so, this must be clearly spelled out so everyone, including investors, mostly foreign, will be properly advised. There should be no gray areas in policies. Clarity is needed.

HOW IT STARTED —Here's how the controversy started. In August, this year, the SP of Zamboanga Del Norte province, quietly passed Ordinance no. ZN-11-128 totally banning open pit mining and giving the governor of the province "draconian" powers over "life or death" for a mining company operating within its territory. He can play god. Good if done to protect or promote a greater good. Bad if the purpose is for something else. But that's too early

TVI EXPERIENCE — TVI Resource Development (Phil) Inc. has been doing mining operations in its tenement and plant in Canatuan, Siocon town in Zamboanga del Norte for 7 years now starting 2004, although exploration started 10 years earlier in 1994. Early in the game, it experienced problems and challenges For example, TVI trucks were ambushed twice in 2002 killing 15 Subanens and injuring several, mostly IPs. But it stayed the course. I was in charge of Mindanao then for Malacanang and I was directed to help clean up the mess. It's been 17 years of TVI doing Mindanano. Then this Ordinance

TVI has a Mineral Production and Sharing Agreement (MPSA) with the Philippine government and has complied with all requirements to allow it to do open pit mining. In the years it has been in operations, it brought progress and development to Siocon which was then a sleepy, conflict- affected 4th class municipality becoming a 1st class unit with its economic boom clearly evident immediately as you get into town. Mindful of the issues about mining and how it destroys the environment, TVI when it first came to town, rolled up its sleeves and busied itself doing a clean up of the poisonous and toxic waste left in the wake of crude, dangerous small scale mining. Using the modern mining technology in accordance with stringent requirements of its own country of origin (Canada in this case), TVI went for it and eventually reaped recognitions and awards extolling its pioneering efforts in responsible and sustainable mining. Its Canatuan processing plant even became the Mecca of the curious and the observers, researchers, including doubtful do-gooders as a showcase of what a model mining company should be.

Interestingly, the Zamboanga church hierarchy refused to even take a look at the site, steadfast in its opposition, (perhaps afraid to be confronted with the truth and therefore losing a favorite whipping boy?)

) But that's par for the course I did several visits myself. I was fascinated seeing a "detox" plant to clean up wastes before they are dumped to posterity. I saw palay (for rice) lushly growing in one filled up dam. Their tailings

Hybrid Rice Producer says Dredging of Chico River Will Result to Gov't

Revenue

TABUK CITY, Kalinga – Dredging the Chico river from siltation will result to revenue generation derived from agriculture particularly from rice farming. This is the contention of the chairman of the Kalinga Hybrid Seeds Producers Cooperative.

Dr. Jaime Almora, in his proposal to dredge a 24kilometer stretch of the Chico river from Calanan to Cabaruan, estimated that P240 million in government revenue will be sourced from an estimate 500 hectares of reclaimed lands and quarrying.

The computation he said is based on the 12% value added tax imposed to the agriculture industry that is producing 65,000 tons and valued at roughly P2.2 billion

He said the revenue to be derived from agriculture production and business opportunities from quarrying in the affected areas is not realized because of flooding and scouring of fertile lands all the time by the swelling river during heavy downpour.

Ifugao Women's Group Embarks on **Natural Chicken Production Project**

ASIPULO, Ifugao - The Amduntog Women Rural Improvement Club (AWRIC) here started their natural range chicken production project using fermented or organic feeds instead of commercial feeds which is more economical and sustainable.

This was made possible through the technical assistance of the Provincial Veterinary Office (PVO) who trained the members in the making of fermented feeds with the use of indigenous materials available in the place as one way of promoting organic farming to protect and preserve the environment from destruction at the same time minimize if not avert the impact of climate change caused by the contributory factor of commercial feeds.

Gilbert Caclini of the PVO said that this natural system of raising chicken is more economical and sustainable especially in

Making the organic chicken feeds involve the use of corn grits, corn bran, rice middling, sugar, azola, ipil-ipil and madre de agua which is fermented for four days before it can be used to feed the chickens.

He said that ten members of the organization were already given 17 heads of kabir chickens each consisting of two roosters and 15 hens which they will raise using the fermented feeds until they reproduce and after one year by the last quarter of 2012 they should repay them with the same number of chickens to be redispersed to the second line of beneficiaries so that it will continue expanding using the same appropriate technology.

Caclini said the money used in purchasing the 170 heads of chicken that were distributed to the first line beneficiaries came from the Livelihood Enhancement and Agricultural Development (LEAD) Project of the National Agriculture and Fisheries Council of the Department of Agriculture.

He added that their office will continue to monitor and evaluate this project and render technical assistance to the chicken raisers until they master it and succeed for others to emulate./ JDP/DBC-PIA CAR, Ifugao

Population Office calls on public to observe safe Sex to avoid HIV/AIDS

LAGAWE, Ifugao - As the province observes World AIDS Day, the Provincial Population Sustainable and Development and Ifugao Youth Development Division (PPSD/IYDD) here warn the public to do away with unsafe sex activities.

Speaking in the daily program Humangan with PIA this morning, Wilson Domingo of the PPSD/IYDD appealed to the public to know more about Human Immunodeficiency Virus/Acquired Immunodeficiency disease (HIV/AIDS), know the causes and how to avoid acquiring the said dreaded disease.

HIV is a virus is transmitted from person to person through the exchange of body fluids such as blood, semen, breast milk and vaginal secretions. Sexual contact is the most common way to spread HIV/AIDS, but it can also be transmitted by sharing needles when injecting drugs, or during childbirth and breastfeeding. As HIV AIDS reproduces, it damages the body's immune system and the body becomes susceptible to illness and infection, explained Domingo.

He said the disease is not a big problem in the province, but the public should be informed and be cautious especially that nowadays people are mobile and they can acquire the HIV elsewhere.

Reacting to a listener from Hungduan town who texted his concern on the presence of videoke bars all over the province wherein young girls from outside the province are sometimes being used by customers and probability that bar girls might be the carrier of the said silent disease, Domingo appealed to the local government units to put more teeth into their ordinances covering said business establishments.

According to the Philippines AIDS Council, the number of new cases in the country is nearing the 8,000 mark as 200 new cases were recorded in October. The Philippine HIV/AIDS registry showed that from January 1984 to October 2011, a total of 7,884 cases have been recorded; 937 of them had progressed into AIDS, while 339 had died.

In October, the number of cases recorded was 92 percent higher the 104 cases in October 2010. Public health records showed that 97 percent of the cases were males. The median age was 27 years but ranged from 15 to 65. The 20-29 age group had the most number of cases.

The males having sex with males sector is still the leading contributor of new cases, accounting from 85 percent of the new cases. 17 injecting drug users contracted the virus by sharing contaminated needles.

Of the 200 new cases, one case, that of a 27-year old male, had progressed to AIDS-related death which was recorded in October./JDP/VDB-PIA CAR, Ifugao

3 Baguio Schools use Local Dialect as Medium of Instruction

BAGUIO CITY - The mother tongue-based- multi lingual education(MTB-MLE) of the Department of Education (DepEd) is being implemented in at least three schools in remote areas in the city and has been found effec-

According to City Schools Superintendent, Dr. Ellen Donato, the MTB-MLE program being piloted in Sto. Tomas Elementary School for Kankana-ey dialect, and Fort del Pilar Elementary School and Roxas Elementary School using the Ilokano dialect, is effective.

The pupils in these schools speak a common dialect that is why MTB-MLE is useful and effective. But we cannot implement this in schools in the city proper where there are various dialects being used, she said.

Donato said mother tongue-based education prescribes the use of the language learners speak at home in delivering lessons and in classroom discussions. The MTB-MLE is implemented from pre-school up to Grade 3 and in the alternative learning system.

DepEd Secretary Armin Luistro, in an statement said "local and international studies show that the use of the learner's mother tongue or the language used at home is the most effective medium of learning and it is the easiest way for children to access the unfamiliar world of school learning,

Studies made by educators say that when the use of their eCard or their mother tongue is discarded in favor of an unfamiliar language upon the children's entry into grade school, the learners lose interest in their studies because there is a disconnect in the language used at home and in school.

For better implement this program, the DepEd has allocated funds for the development and production of indigenized teaching and learning materials.

DepEd Order 90 series of 2011, provides that the types of learning materials to be developed and produced are story books in big and small book formats; flash/activity cards using letters and numbers; basic sight words or grade level words and picture dictionary; and thematic picture chart for oral literacy./JDP/JBZ-PIA CAR

DOH to give free A-H1N1 Anti-Virus **Vaccine to Indigent Elderly**

BAGUIO CITY - The Department of Health (DOH) is set to provide free AH1N1 flu-shots to the elderly, especially the indigents identified under the National Household Targeting System for Poverty Reduction (NHTS-PR) of the Department of Social and Welfare and Development (DSWD).

This is in line with President Aquino's Health Agenda of 'Kalusugan Pangkalahatan', which aims to provide access and quality health care to the Filipino people.

DOH-Cordillera Regional Director, Dr. Myrna Cabotaje in a kapihan forum, disclosed that priority for the said AH1N1 antivirus vaccine are the indigent senior citizens in Conditional Cash Transfer (CCT) or Pantawid Pamilyang Pilipino Program (4Ps) ar-

She also affirmed that by next year AH1N1 anti-virus will be incorporated to the usual flu-vaccine that will be made available to the public noting that very young, pregnant and old people who are the common group that are vulnerable to flu virus of any kind.

Cabotaje also reiterated their advisory to the public especially those in Baguio that there is no cause or need for alarm on AH1N1, as it is already being considered as common and nonserious type of flu virus that may thrive on cold places.

Meantime, Cabotaje also affirmed there will be more and intensified health program implementation in line with Aquino Health Agenda of 'Kalusugan Pangkalahatan' next year

According to Cabotaje, the national government, through the DOH, will continue to pay the PHILHEALTH - insurance premium of all the poor families identified under DSWD's NHTS-

In partnership with the DSWD, the Department of Education (DEPED) and the various local government units and through the different Community Heath Teams which are established and trained in the different localities for intensified information, education and communication (IEC) advocacy, will be put in place, as well as monitoring and assistance, especially to the poor families for better access to quality health care services.

Included in the key or primary focus of the Aquino Health Agenda are the upgrading of health facilities and equipment of various hospitals and rural health units in the country, as well as on bringing in the needed programs and services to achieve the country's health-related commitment to the Millennium Development Goals./JDP/LD-PIA CAR

GSIS Grants Emergency Loan to members in Mt. Province loans shall be allowed to renew the loan if

BAGUIO CITY— The Government Service Insurance System (GSIS) is extending emergency loan assistance to eligible members residing and/or working in the Mt. Province after the said area was severely affected by recent typhoons.

Qualified members can apply for an emergency loan starting today, December 12 until January 10, 2012 via the GWAPS kiosk using UMID eCard.

GSIS said members who do not have an eCard Plus or UMID eCard but who are eligible to apply for the loan can apply via over-thecounter (OTC).

Proceeds emergency loan applications filed via OTC will be credited to a temporary eCard the eCard Plus or the UMID eCard.

Under the emergency loan program, each eligible member can borrow P20,000. The loan program carries an interest rate of six percent per year computed in advance, and is payable in three in equal monthly installment.

An Emergency Loan Redemption Insurance (ELRI) of 1.2 percent of the gross loan amount shall be deducted from the proceeds of the loan.

In addition, any outstanding balance of previous emergency loan shall be deducted from the proceeds.

The content of the resolutions: expressions of sentiments of each of the legislative bodies desire to institute autonomy in the region.

Domogan said the bill was disseminated among the Cordi region's six governors for their blessings before its submission to the highland congressmen for their own take on the proposal.

Benguet congressman Ronald Cosalan and Abra rep Maria Jocelyn Bernos declined affixing their signatures on what could be a historical document that would outlive its prime-movers.

The reason: lack of consultation with their respective constituencies.

This would be the region's third attempt at autonomy after HB 5595's precursors failed ratification in 1990 and 1998 in plebiscites held for the purpose of realizing the elusive 'autonomy dream' laid down by Article X of the 1987 Constitution.

Domogan iterated, "With autonomy, there will be devolution of powers from the national government to the regional administration."

"And the bottom line is that we could now manage our natural resources without waiting for trickles veiled with uncertainties from national government agencies."

He guaranteed, "The issue here is not political... it is getting what is due for our region, our children, and our children's children."/isl

of small-scale miners at the height of their destructive trade. When I returned recently, I saw lush forests that TVI developed. In fact, I told friends that I visited a mine site but I saw a resort.

Even the host indigenous people's community, the Subanens which was hostile initially, is now the bulwark of TVI's stakeholders support. The Siocon town, with a swashbuckling former ABS CBN journalist for its mayor (Cesar Soriano) eventually came around and is the strongest and loudest supporter of TVI for seeing up close its operations and recognizing its windfall effects on everyone in the area — and even beyond.

SALIVATING?" —Unfortunately for TVI, the provincial government, headed by 3termer Gov. Rolando Yebes, saw it differently. He had been salivating for sometime hoping to get a piece of the action. Hounded by the thought that he could get more, beyond the pitiful 2 % on gross revenues as excise tax that first goes to the national government, (by the way, taking almost forever to remit to the province its 40% share of that pittance, of which it has to download 35% to Barangay Tabayo and 25 % to Siocon municipality) then bolstered by the church anti-mining campaign championed by Bishop Manguiran no less, Gov Yebes rallied his political cohorts in the SP to pass the Ordinance without anybody noticing it. For one reason or another, he did not affix his signature to it but allowed it to lapse into effectivity. One morning in November, TVI woke up to belatedly discover that the proposed ordinance was quietly ap-

proved 3 months earlier, already in effect and giving TVI 12 months to pack its bags and get out of the province! Pronto!

"NEVER MINDS" — The "go pack up order" shocked everyone. Never mind if TVI has still about 10 years to legally operate under the MPSA with about 4 years of estimated viable mine life left. Never mind if it has already infused \$60 Million (PHP 2.5 Billion!) into its operations. Never mind if it sends about 1,000 gainfully employed and competent Filipino workers to the streets and join the throng of the unemployed. Never mind if the social benefits and royalties estimated at P75 to P100 million annually, given to host Subanen communities will have to also suddenly and prematurely stop. (No wonder the IPs mounted a rally in Dipolog town during the initial court hearings condemning the ordinance.) Never mind if it has built many roads, schoolhouses, gave livelihood programs, funded scholars, etc. Never mind if TVI already offered to increase directly the municipal and provincial share by voluntarily setting up a rehabilitation fund under its social development and management project (SDMP) for the LGUs to manage in coordination with other interested affected sectors to make up for the LGUs pitiful share. Never mind if there is a contractual obligation in place between the national government and TVI and its terms abridged and thrown out of the window. Never mind if it sets the fuse to trigger a hemorrhaging of the vital lifeblood provided by the mining industry all throughout the country. Never mind if it closes down a company that has been the model of what a mining company should be. Oh, a list of more "never minds" but those will suffice for moment.

FIGHTING MOOD —In the face of all this, under the leadership of Canadian Clifford James, a maverick of sorts, an old hand in mining and a Mindanao adventurer since the 90's, TVI decided to give it a fight and not succumb. He filed a case in the Dipolog court for relief believing that the judge, a no-nonsense, soft-spoken former audit bureaucrat, former prosecutor, former law professor and known for his independence and clear legal mind, will rule on this on the merits, Zamboanga peninsula's grip by political lords,

—"I intend to fight this to the end and will not allow the bullies to have their way," Cliff told an equally fired-up crowd of miners and investors in a forum the other day at Makati, the country's economic hub. He also warned his co-travelers in the mining industry that while TVI is willing and in fact going head-on for it single-handidly, a "domino effect" is looming in the horizon: Tampakan, South Cotabato first, Zamboanga del Norte now. Perhaps, Zamboanga Sibugay next. And so on and so forth. The mining crowd

PROXY FIGHT —The Makati crowd clapped and cheered for TVI's Clifford James for taking on a survival fight for his company and his investors. They admired TVI for having the "balls" as the industry's proxy in this fight. But I think that's as far as they can go. We know that businessmen are the most cowardly when it comes to fighting "city hall", never mind if this is also a survival fight for the host IP communities, the stakeholders, the mining industry as a whole and on a higher plain, for the benefit of the Philippine economy as well.

Sadly, the national government appeared nonchalant by the wayside, watching helplessly "biting its nails" as this parade goes by.

While Domogan welcomed the petition, he guaranteed the city and concerned agencies have been doing everything humanly possible to address all Irisan dumpsite concerns, hinting the "magnitude requirement" for the issuance of the writ may no longer

for cooperation is the very foundation of which the system is built. All pillars, therefore, should get their acts together and strive to mutually support each other while maintaining independence," Morales stressed.

Access is another essential principle. Morales pointed out, "access to the criminal justice system especially by the poor, marginalized and vulnerable. I believe is the single most persuasive indicator that the system is running and running smoothly. It is unfortunate that we have yet to achieve universal access to the system", she

Morales pointed out that independence

and access may be worthy principles for an effective criminal justice system, but it can be undermine by the lack of integrity.

The Ombudsman pointed out disturbing reports of corruption, abuse or incompetence by the different pillars that may unduly result in the erosion of thrust to the system, are needed to be addressed.

pine Atmospheric, Geophysical and Astro-Services Administration (PAGASA), also a DOST attached office.

According to Deponio, the ARGs can automatically record on real time rainfall volume and at the same time send its reading to a central server or data terminal, including other pre-identified destinations, which will now become one of the basis of PAGASA weather forecast.

also Automatic Weather Stations (AWS) – stand-alone devices that measure other weather-related factors such as air pressures, temperature and humidity that are installed in Bangued, Abra, Benguet State University (BSU), BSU annex in Bugias, Benguet and at the Ifugao State University.

These AWS, along with the ARGs, will play critical role in disaster or hazard mitigation particularly during typhoons and floods, which will help save lives and properties", Deponio said.

He also announced that the raw data being recorded by both ARGs and AWS in the different parts of the country can be access on Google Earth, though for now, they are still working for the webpage name.

Medicines under the ComPack program include Amoxicillin 500mg, Cotrimoxazole (800mg sulfamethoxazole + 160mg trimethoprim, tablet), Erythromycin 500mg, and Cloxacillin 500mg, all for adult; and Amoxicillin 100mg/ml granules (suspension), Cotrimoxazole (200mg Sulfamethazole + 40mg trimethoprin/5ml suspension, 30, 60 ml), Cotrimoxazole (400mg Sulfamethazole + 80 mg Trimethoprin/5ml suspension, 30, 60ml) and Cloxacillin 125mg/5ml, 60 ml, all for pedia which are for common infectious diseases like pneumonia, upper respiratory tract infections, urinary tract infections and otitis media.

Baguio Police ready for the **Yuletide Season**

Baguio City Police Office Director Senior Superintendent David O Lacdan has ordered the police force to strengthen police patrol operations this coming Yuletide season. Implan "Yuletide Season" has also been released as a measure to ensure the peaceful celebration of Christmas.

All units were tasked to strictly enforce laws related to firecrackers/pyrotechnics by strengthening efforts on the inspection of warehouses and manufacturing sites, intensifying checkpoint operations to prevent proliferation of loose firearms, and instituting appropriate measures to prevent PNP personnel and other gun holders from illegally discharging their firearms during the yuletide season.

BCPO will also deploy Route Safety Marshals along main thoroughfares and Public Assistance Hubs around Baguio city to assist the general public. Church goers especially during "Simbang Gabi" will also be guarded by the Cops on Churches tasked to provide area security while the Tourist spots will be manned by the heightened operations of the Tourist Police. Eighty personnel from the Regional Public Safety Battalion (RPSB) were detailed at BCPO as augmentation force for the duration of the season and will be assigned mostly at the Central Business District.

A simultaneous ceremonial muzzle taping of firearms will also be conducted on Friday, December 16, 2011 to ensure that no PNP personnel will discharge their firearms during the celebrations. Each head of office is directed to tape the muzzle of the issued firearms of their respective personnel with their signature and conduct checking upon the culmination of the yuletide season.

The police officers will also be backed up by the BCPO's explosive ordnance division (EOD) and special weapons and tactics (SWAT) in case of any untoward incidents. Lacdan said that the intensification of police visibility is part of the Police Regional Office Cordillera's directive to maintain peace and order and public safety during the coming Christmas season./ PINSP KARISSMA G STA JUANA

City Eyes Redevelopment of Mines

BAGUIO CITY – The city government **View Park** plans to redevelop Mines View Park here to restore its glory as a promenade center and tourist destination.

Mayor Mauricio Domogan said they have allocated P4 million in this year's budget for the improvement of the park which he said will begin as soon as the vendors vacate the park's premises and move to the satellite market building constructed by the city government nearby.

The satellite market project that cost P50 million was intended to house the legitimate vendors occupying the park along with the barangay hall, multi-purpose hall, day care center and health center of the barangay. It was envisioned to solve the vending problem and put back order in the area in the hope of reclaiming its status as a park and favorite tourist hub.

The mayor said the city government will fast track the screening of the vendors to be accommodated in the satellite marker based on the guidelines and master list of legitimate grantees along with the Memorandum of Agreement between the city government and the Mines View Open Market Vendors Association and the Mines View barangay.
