# BCDA, JHMC Mum On City Demand For Payment of BCC

BAGUIO CITY -The Bases Conversion Development Authority (BCDA) has virtually filed every local legislation and payment demands under miscellaneous, observed local officials.


This time however, the city is bent on making positive steps to make "filing under miscellaneous" less than an option for BCDA.

"The city government is doing everything to protect its rights over the Baguio Convention Center (BCC)," city legal officer Melchor Carlos Rabanes guaranteed adding, "but we are definitely ready for legal battle in case diplomacy fails."

Rabanes last week revealed the city in fact sent "formal demand" dated September 26 to Bases Conversion and Development Authority and its development arm, John Hay Management Corporation (JHMC),

asking both entities to honor the January 23, 2004 BCC buy deal.

The demand letter signed by mayor Reinaldo Bautista, Jr. a addressed



**BCDA** president and chief operating officer Narciso Abaya and JHMC chair Ma. Cristina Corona.

It could remembered that upon execution of the 2004 agreement, BCDA paid BCC erstwhile owner Government Service Insurance System (GSIS) P50-million as partial for the P250-million dilapidated convention center.

# PGMA wants possession of explosives non-ballable

President Gloria Macapagal Arroyo on Friday called for legislation that would make the illegal possession of explosives a nonbailable offense.

In her speech at the 33rd Philippine Business Conference at the Manila Hotel, the President said the Human Security Act (HSA) has enhanced the safety and domestic security of the country "by

giving us more legal power to prosecute those who commit any acts of terror on our people."

But strengthen it, she said, "we are working with Congress on a bill to make the illegal possession explosives nonbailable, with ample safeguards and penalties against planted evidence."

"Our message must be clear: if you are armed and kill civilians, you will be prosecuted. If you are a communist terrorist, religious terrorist or even a rogue element of our own police or mi litary, we will stop you," she said.

"We must be a dequately empowered to crush terrorist the movement in the country and to transform our nation's response to political violence, ensuring that civil rights and social justice are available to all Filipinos, not just a privileged few," she added.

She stressed the people deserve peace, order, political and economic stability.

"We must move on as a nation," she said, adding that "only a strong economy will lift our people out of poverty and expand our middle class." (PNA)

#### DA says investors keen in biofuels plants

The Department of Agriculture (DA) said yesterday more investors are now planning to build biofuels facilities all over the Philippines.

DA Secretary Arthur C. Yap said investors plan to set up plants in the region, Hocos Cagayan Valley, Western Visayas, Zamboanga Peninsula, Northern and Central Mindanao, and the Davao region either through straight purchases, lease arrangements, contract growing or joint ventures.

Yap also said the DA expects the global growing demand for cropsbased alternative clean fuels will further boost the Philippine farm sector, increasing the profitability of small stakeholders and reducing the country dependence on imported energy sources.

Through the Philippine Agricultural Development and Commercial Corp. (PADCC), the DA has committed promote the biofuels sector by generating awareness on the use of agricultural feed stocks for ethanol and biodiesel production.

Yap said the agency is now in the process of identifying private sector investments

with more than 400,000 hectares of land to plant crops that will be used as feedstock biofuels production.

About 90,000 hectares are located in the North Luzon Agribusiness Quadrangle; 10,000 hectares in Central Philippines; and 300,000 Agribusiness Mindanao, he added.

Yap also said the lands being processed already represent 78 percent of the 600,000 hectares target for this year.

The lands will planted cassava, oil palm, coconut, sugarcane, jatropha, and other crops used

for feedstock biofuels production.

Farmers stand to earn more through profit sharing. guaranteed income packages or straight purchases harvested crops, and benefit from new planting technologies that will create more jobs and boost production, Yap added.

## Migration, no guarantee out of rural poverty -WB

MANILA-CONTRARY to popular beliefs, migration, despite the volume of money it brings, has neither brought rural folks out of poverty nor is it a sure fire way for farm people to clamber aboard the prosperity wagon.

"Where migration is more or less permanent, income from migration depends on the success of the migrant and the reason for migration. So migration is not a guaranteed pathway out of poverty," the International Bank for Reconstruction and Development said in its recently released report debunking several myths on agricultural development.

The Washington, United Statesheadquartered IBRD, popularly known as The World Bank, cited in its 386-paged report that "despite massive rural-urban migration, rural poverty will remain dominant for several more decades in Asia".

The bank"s World Development Report 2008 that focused on identifying ways for governments to lift some 600 million rural people from extreme poverty has said that while this has been achieved, it is not due to migration.

'More than 80 percent of the decline in rural poverty is attributable to better conditions in rural areas rather than to outmigration of the poor," the report titled "Agriculture for Development" said.

"So, contrary to common perceptions, migration to cities has not been the main instrument for rural (and world) poverty reduction," it added.

In fact, authors of the World Bank report noted that out-migration of people from rural

## City scores TKO as OP sacks Jadewell complaint

BAGUIO CITY

– It only took a paragraph to wrap up things up... and it came like thief in the night without making the usual big splash in City Hall.

City legal officer Melchor Carlos Rabanes last week revealed that the of the Office President (OP) finally referred Jadewell's administrative complaint in OP Case No. 06-K-410 to the gutter, a month shy of a year after its filing.

It could be remembered that Jadewell spouses Rogelio and Norma Tan, November 13, 2006, filed a complaint for "culpable violation of the Constitution, Misconduct in Office and Abuse of Authority" before the OP.

Impleaded in the case were then set of officials in the person of acting mayor Reinaldo Bautista, Jr., acting vice mayor Leandro Yangot, Jr., councilors Rocky Balisong, Faustino Olowan, Federico Mandapat, Jr., Perlita Rondez, Antonio Tabora, Jr., Jose Molintas, Rufino Panagan, Tenefrancia and city legal officer Melchor Rabanes.

OP deputy executive secretary for legal affairs Manuel B. Gaite, in an order dated
September 28 said,
"In view of the
recently concluded
May elections where
[some] respondents
were [reelected], the
case as
recommended by the
Department of
Interior and Local
Government (DILG)
is dismissed for
being moot and
academic."

Gaite, in the order, cited the August 21, 1992 Supreme Court (SC)-decided case of then-Cagayan governor Rodolfo Aguinaldo against then-DILG secretary Luis Santos, et al.

A g u i n a l d o likewise faced similar wraps — culpable

violation of the Constitution, Misconduct in Office and Abuse of Authority – filed against him by three Cagayan mayors sometime in 1989, shortly after the December 1989 coup d'etat was crushed.

While the administrative case was pending in the OP, Aguinaldo once again ran for governor 1992 and won by landslide. The secretary subsequently found Aguinaldo guilty of the administrative charges and had him removed.

The SC however ruled, "When a people have elected a man to office, it must be assumed that they did this with knowledge of his life and character, and that they disregarded or forgave his fault or misconduct, if he had been guilty of any."

The Tans hinged their OP complaint on alleged disregard by the impleaded city officials of resolutions of the courts pertaining to the Ganza area parking lot in Burnham.

In 2006, the Council through Resolution 204-06 tasked Rabanes to notify Jadewell of the city government's intention to rescind the June 26, 2000 pay-par agreement. The resolution likewise tasked Rabanes to inform Jadewell to stop Cont. on page 8

# What Asean migrant's rights agenda? —analysts

MANILA—ANALYSTS are far from getting their hopes up that migrant workers' rights would spike interest among leaders of the Association of Southeast Asian Nations who would meet next month in Singapore.

Expect follow-through to go slow, said many of 160 participants in a recent discussion on an eight-month-old Asean declaration for protecting and promoting migrant workers' rights.

They were referring to the 12th Asean Summit in Cebu City, where advocacy on upholding the human rights of migrant workers in the Southeast Asian region reached two gains: a declaration and a committee to implement that declaration.

Groups involved in this advocacy found these gains "surprising" since these concern human rights, a bilateral discussion these groups' leaders say usually takes much time.

It will possibly succumb to Asean's nature of work that is slow-paced and non-binding, said most analysts who attended a recent Manila consultation on Asean and migrant workers.

The plus-factor for having those two gains happen, says William Gois of the Migrant Forum in Asia (MFA), is that the Philippine government pushed the Asean member-states to fast-track the migrant workers agenda.

# Health board, literacy body reorganized

- Two important bodies were reorganized last week to make them more responsive to the needs of the times

Mayor Reinaldo Bautista Jr., before leaving the country on official business, is sued Administrative Order No. 139 reconstituting the membership of the local health board to include newly accredited nongovernment organizations.

The board is now composed of the following: the city mayor as the chair; city health officer as vice chair; and with the chairman of the city council committee on health, representative of the Department of Health Cordillera and the Family Planning Organization of the Philippines Baguio-Benguet chapter as the non-government o r g a n i z a t i o n representative to the board

The health board is tasked with the following:

\*Propose to the city council annual b u d g e t a r y allocations for the operation and maintenance of health facilities and services within the city;

\*Serve as an advisory committee to the city council on health matters such as the necessity for and application of local appropriations

for public health purposes;

\*Provide advice recommend policies when necessary to the Health Services office and its committees personnel selection and promotion, bids and awards. grievance and complaints, personnel discipline, budget review, operations review and other committees in accordance with technical and administrative standards of the DOH and other concerned agencies as may be applicable;

\*Acts as the coordinating team for **Cont. on page 7**



Cordillera Regional Autonomy

Last Friday, 26 October 2007, the National Economic Development Authority-Cordillera Autonomous Region (NEDA-CAR) continued its series of meetings to formulate a research agenda. The research agenda formulation was largely aimed at promoting a yes vote should a plebiscite on regional autonomy be held in the region. Unfortunately, the research agenda formulated do no even suggest that the research agenda when pursued would really result to a yes vote for regional autonomy in the Cordillera.

Worst, the research agenda formulation appears misdirected: the cart is ahead before the horse. The conference or meeting does not even seem to recognize that a large yes vote for regional autonomy will come if and only if Cordillerans have a unified vision of what Cordillera autonomy should be. Although Cordillerans desire autonomy, a number doubt its viability. A lot more may have no doubt on its viability but are discordant on what regional autonomy should be or look like. Thus, what should be the emphasis on the work to realize autonomy must focus on arriving at a consensus or near consensus on how autonomy should be. This would hit two birds in one stone: enough awareness is built in the process and groups would move forward to a consensus or near consensus on how autonomy in the Cordillera would look like.

Unfortunately, the NEDA-CAR initiated meetings have not learned enough from the past. The research agenda it has recently formulated only duplicate what has already been done. But let me correct that. The research agenda being unfolded today is a poor duplicate of the various research agenda explicitly or implicitly formulated in the past (except perhaps for that one on ancestral domain).

There really is no forward movement. No genuine learning from the past.

I am sure that there are many good resource persons in the National Commission on Indigenous Peoples-Cordillera Administrative Region (NCIP-CAR) for the workshops on research agenda formulation. Unfortunately, the research agenda formulation did not exploit this enough.

My guess is that not enough right people have been invited to the research agenda formulation. The research agenda formulation methodology is also probably flawed.

Thus, most likely, the NEDA-CAR would be reporting this year to the national government that they have spent P15 million for a job badly done. Of course, NEDA-CAR would probably not recognize this or may not even be aware of this.

If the information I got from a NEDA-CAR official is correct, this is the second or third allocation of P15 million to kick off the campaign to realize regional autonomy. The earlier efforts that have not been spearheaded by the NEDA-CAR have achieved much but have spent less. The one ongoing today has not even surpassed the achievements of the past and yet, if the information provided to me earlier by a NEDA-CAR official is accurate, people's money is being misused. There may not be corruption but it is the same: people's money is likely being wasted.

I will not go into the details of what has been discussed in the series of meetings because I do not want to preempt the ongoing documentation. Besides, I really want NEDA-CAR to have a good chance of packaging their documentation very well because I support regional autonomy for Cordillerans. I want NEDA-CAR to succeed.

Meanwhile, I do not want to sound top-down but a faster way towards regional autonomy in the Cordillera is to **grant autonomy immediately**. The regional autonomy would likely be imperfect but provided enough mechanisms are built so Cordillerans can talk, hold conferences, and decide for themselves, eventually an autonomy that

# New technology to bolster realty tax collections of LGUs Case in point

Around 500 government executives and participants from donor funding institutions, provincial governors, assessors, treasurers and finance experts, IT experts and computer programmers gathered Dumaguete City to discuss means to enhance the local governments' tax collection through the use of a software "integrated taxation system."

T h e Integrated Taxation System

(iTAX ) project is funded by the German government through the GTZ-R P - G e r m a n Cooperative Fiscal Decentralization Project with the province of Negors Oriental as the pilot project area.

The organizers noted that "There is a high amount of taxation power in the local government which is still untapped. Substantial revenue coming from local taxes like real property tax, business tax, special education fund, among others, have yet to be fully realized."

Case in point in the conference is the poor realty tax collection of local government units (LGUs) where only about 50 percent is realized.

The Negros version of iTax is now a modern computer-based tax assessment and collection tool for LGUs.

It answers the specific needs of municipal the assessors and treasurers and involves all functions like payment and collection, assessment and tax mapping.

The system is jointly owned by the Philippine and

"Our efforts to secure title over BCC are being stymied," Bautista said adding, "the stalemate has placed other issues concerning CJH in abeyance and it's putting the city in the losing end."

Meanwhile, Rabanes said that with the two houses of congress finally meeting eye-to-eye, BCDA's scapegoat could now be set aside.

"As soon as the mayor's back, we are definitely pushing for final demand to show BCDA and JHMC we mean business," he added.

# IMF Says Economic Growth Possible With Low Inflation

The Philippines will likely sustain its strong economic growth momentum even under a low inflation regime, the International Monetary Fund (IMF) said. "We expect this [low inflation vis-a-vis robust economic output] to be sustainable. We saw improvements have been made in the way the Philippine economy is being run from a macroeconomic policy perspective," said Timothy Callen, division chief of the IMF's World Economic Studies Division.

"The central bank has been firm when inflation picks up. Monetary policy focusing on managing inflation rate is the right way to go," he added.

The IMF said the Philippines is among the countries in the region that has been successfully managing the surge in foreign exchange inflows.

The international lender, which has been recently aggressive in its surveillance of currency regulations, pointed out that continued liberalization of restrictions on capital outflows would be helpful in dealing with the flood of capital into middle and lower income countries.

"What really helps is being careful with fiscal spending. The lesson here is not that a country needs to cut spending when there are inflows, but rather it needs to exercise fiscal restraint," said Simon Johnson, IMF economic counsellor and director.

The IMF also urged greater exchange rate flexibility, particularly in China, whose large current account surplus remains a key factor to rising global imbalances. Meanwhile, Bangko Sentral ng Pilipinas (BSP) Deputy Governor Diwa C. Guinigundo noted that with fiscal restraint already being observed, the Philippines will likely experience more capital inflows coming as fiscal consolidation boosts investor sentiment.

The central bank, however, ruled out the adoption of tightened capital controls to address the continued influx of funds. Instead, the BSP will continue to push for further liberalization of the foreign exchange market — an initiative it started early in the year when it relaxed banks' currency trading rules and residents' outward investments, Mr. Guinigundo said.

"A disciplined approach to foreign exchange liberalization would be integral to the BSP's responses to handling real exchange rate movements over the long term," Mr. Guinigundo told BusinessWorld. "In addition, the BSP will continue to adopt a mixture of policies in dealing with the surge in capital inflows, [including] exchange rate flexibility, the build-up of reserves as buffer against exogenous shocks, and prepayment of external obligations where feasible," he added./PIA-CAR

LAWYER Carlos Medina, who is secretarygeneral of the Working Group for an Asean Human Rights Mechanism. views these events as the progress of the migrant workers' rights advocacy.

His benchmark of that advocacy in the region is, first, the sectoral committee's formation. That committee, Medina said, could begin formulating Asean-wide instrument migrant workers' rights.

That instrument is the next step for the migrant workers' rights advocacy in Asean, Medina says. An Asean body on migrant workers' rights will then be formed to implement regional that

instrument, surmises.

Medina said another benchmark is having what he calls an Asean intergovernmental human rights commission. The Working Group he heads is lobbying for this.

In the meantime, for human rights issues such as those prevailing currently in Myanmar, Aseanm e m b e r governments voice out their concern but do not make any action as a collegial body that is Asean.

Medina said the Asean also has human rights sectoral commissions women, human rights education, networking among member-countries' human rights institutions. These, he noted, are all products of the Ventianne (Laos) Action Programme crafted two years ago.

The programme emphasizes on the human rights obligations of countries, Medina emphasized. Human rights advocacy for Asean in general is a product of over ten vears of continued talks with Asean leaders, Medina

Thus, the fact that migrant workers were talked about in Asean in just a few months "is a big development already," he said citing that memberstates "don't discuss migrant workers' issues."

These issues are sensitive, too Medina said.

The sensitivity lies in the dynamics between Asean member-countries

who are either sending or receiving migrant labor. Malaysia and Singapore renowned to be host countries migrants, although the former also has citizens working overseas. The Philippines and Indonesia, for their part, are renowned labor-sending countries.

Countries belonging to the Greater Mekong Subregion, such as Laos, Cambodia, Viet Nam, Myanmar, and Thailand (as well as China. though Yunnan province), are affected by movements of refugees as well as labor migration movements by some two million people.

#### Blocks

AT this early, stumbling blocks to the Asean migrant workers' advocacy are coming up.

Malaysia, host to large numbers of undocumented migrants such as **Filipinos** and Indonesians. deferred signing the document for the migrant workers sectoral committee.

No signing ceremony was held in the Manila Ministers' Meeting for that sectoral committee, as Philippine Foreign Affairs Secretary Alberto Romulo said the committee's formation was "adopted" by participating countries.

For her part, Jenina Joy Chavez of Focus of the Global South thinks that while the migrant workers' advocacy is important, Asean is usually "talk-shop" that formulates declarations and

Bulayungan said that with the ITS, the operations of the bureau will be easier because the system encourages voluntary compliance, broaden the taxpayer base, provide, timely, accurate, and relevant information, improve tax processing, enforcement, and control procedures and reduce the cost of tax administration in the long term.

President Gloria Arroyo said last week that with the country's economic strength largely attributed to the various financial and economic reforms, there is no need to implement new tax measures but rather enhance tax administration so as to generate more revenues for socio-economic projects/Vency

regulations "that can't he implemented".

"Even the responsibilities of governments are not spelled out," Chavez adds, explaining that Asean is purely an inter-governmental body.

h e s e observations do not come as a surprise to **International Studies** student and migrant workers' advocate Domini Fangon, who thinks Asean works a "noninterventionist way" that will make it difficult to followthrough the Cebu declaration.

Raymond Balatbat, a staff at the Department Foreign Affairs, can attest to such difficulty to convince other membercountries when it comes to migrant workers. He was the among organizers of the

Cebu meeting for migrant workers.

Getting the Cebu declaration out "was difficult," Balatbat said without citing details.

Getting recommendations to add more flesh to the declarationaddressed would be equally difficult, said lobbyists for greater migrant workers' rights.

T h recommendations include for Asean to create a regional body that migrant workers could go to for redress grievances.

The shopping list of migrant workers' rights advocates also want Asean to issue explicit statements on the protection of low-skilled workers such as domestic workers.

Gois said the absence of such statements in the

Asean declaration's wordings "is a big deficit of the Cebu declaration".

Medina, however, cautions for non-adversarial approach in pushing for these recommendations.

The way to get the consensus of Asean for issues such as the rights of migrant workers is doing things step-by-step, Medina said.

That's based on his experience lobbying for a wide-ranging human rights mechanism for Asean.

"At least. Asean listens," he

areas has even contributed to the constant rate of poverty rate in cities.

The report, released October 19, noted while the poverty rate of US\$1a-day has been declining in developing countries -from 28 percent in 1993 to 22 percent in 2002, this "has been mainly the result of falling rural poverty (from 37 percent to 29 percent) while the urban poverty rate remained nearly constant (at 13 percent).'

The report also noted that during the period under study, 1993-2002, there was an 81-percent reduction in rural poverty worldwide. But this is "ascribed to improved conditions in rural areas; migration accounted for only 19 percent of the reduction".

Migration, the report said, "lifts some of the rural poor out of poverty but takes others to urban slums and continued poverty".

#### Notional

E V E N remittances from abroad are downplayed by the report on contributing to national poverty rate declines.

While the report acknowledges that there are "indirect effects of urbanization on rural poverty through remittances and rural wage changes," this is "through tighter rural labor markets".

But this argument, the report's authors said, has a conservative but unlikely assumption: all rural-urban migrants are poor.

The bank c o m p u t e d

m i g r a t i o n 's contribution to rural poverty reduction using the US\$2.15 poverty line rather than the US\$1.08 extreme poverty line "because it is unrealistic to think that all migrants are extremely poor".

Even so, using the same assumption that all those who migrate are poor, the report noted that reduction in rural poverty would still hit 81 percent, "not to migration".

"Indeed, almost all the decline in South Asia and East Asia is because of a genuine decline in poverty in rural areas. Even when China is excluded from the sample, 67 percent of the reduction in rural poverty is from causes other than migration," the report said.

According to data compiled by the Institute for Migration and Development Issues (Imdi), there is no direct correlation between the number of Filipinos going overseas for temporary or permanent work and and stay, poverty incidence levels.

For example, the National Capital Region, composed of more than a dozen cities, has posted a 4.3-percent poverty incidence level in 2003. In an eight-year period beginning 1998, almost a million overseas Filipinos came from this region.

However, the data that the nonprofit group Imdi compiled couldn't cite if these Filipinos just used the NCR as

temporary residence prior to going overseas or which rural area they came from if they, indeed, migrated from farm villages.

It is difficult to determine so since the NCR is the reservoir of major government agencies processing the export of Filipino labor as well as the receptacle for the air travel and remittance industries.

Likewise, despite Davao del Sur, for example, posting a 24-percent poverty incidence rate and recorded having 55,117 Filipino migrants, Batanes island posted only a 9.2-percent poverty incidence level despite only 72 of its residents having left that fishing and farming province that's the tip of the Philippines.

Another example Pampanga, 18 Gloria President Arroyo's home province, which posted a six-percent poverty incidence level. It is second to the NCR for having the most number of Filipino migrants at 125,226. Compare this to Pangasinan, home province of former President Fidel V. Ramos, which had 111,029 of its citizens migrating in the eightyear period ending 2005. Still the province posted a poverty incidence level of 18.6 percent, more than double neighboring Pampanga's.

With the exception of Batanes, 14 provinces have poverty incidence levels above the national average of 25.7 percent.

"The high poverty levels of these provinces can perhaps explain why citizens from these areas cannot easily migrate overseas," the Imdi scoping study on migrant philanthropy released last August said.

#### **Impacts**

EVEN the World Bank report admits it is difficult to establish migration's direct impact on rural poverty reduction levels.

"Migration can be a climb up the income ladder for well-prepared, skilled workers, or it can be a simple displacement of poverty to the urban environment for others," the report noted.

The report also cited that while remittances from migrants back to the farm household "can relax capital and risk constraints, the relationship between migration and a g r i c u l t u r a l productivity," for one, is "complex."

The (temporary) absence household members reduces the agricultural labor supply. Agricultural productivity can therefore fall in the short run but rise in the long run as households with migrants shift to less labor intensive, but possibly equally profitable, crops or livestock," the report

Remittances, the report noted, "often drastically change the composition of the rural population" and "can pose (their) own challenges for rural development, because migration is selective."

"Those who leave are generally younger, better educated, and more skilled. Migration thus can diminish entrepreneurship and education level among the remaining

population," the report said.

Likewise, the report cited there are evidence suggesting migration "is most accessible for the wealthiest and best educated of the rural population, as moving requires means to pay for transportation and education to find a good job."

"Moreover, better-educated migrants are the most likely to have a successful migration outcome," the report added.

It particularly cited the Philippines as having more female migrants to urban areas faring better than the lesseducated males.

The report estimated some 575 million people migrated from rural to urban areas in developing countries over the past 25 years.

Of these, it said, "400 million lived in transforming

countries, where migration flows increased to almost 20 million a year between 2000 and 2005."

Migration flows as a share of the rural population have been traditionally highest in urbanized economies, but they have fallen over 2000-05 to an annual rate of 1.25 percent. In transforming and agriculture-based economies, annual flow of outmigration steadily increased to 0.8 percent and 0.7 percent of the rural population, respectively.

The report also international migration out of rural areas is maledominated in Ecuador and Mexico, hut femaledominated in the Dominican Republic, Panama, and the Philippines. ISAGANI DE LA P Z Α www.ofwjournalism.net

He cited the recent trip to India with President Gloria Macapagal-Arroyo when investments in agriculture were secured, particularly in the propagation of crops for biofuels manufacturing.

A memorandum of agreement (MOA), was signed between the Philippines and PRAJ Industries of India, which was aimed to help develop the country's biofuels industry, Yap said.

Under the MOA, the DA and PRAJ agreed to team up "for feedstock development and setting up of biofuel production plants" in the Philippines and will provide assistance in identifying varieties of sweet sorghum and jatropha for cultivation trials.

"PRAJ will also provide the design, engineering and supply the biofuel production plants to potential investors in the biofuel sector based on mutually agreed terms and conditions on a case-to-case basis," Yap said.

For its part, he said the DA will identify land for feedstock development; encourage and assist farmers in cultivating sweet sorghum, sugarcane, cassava or jatropha for the production of alternative clean energy; and help in attracting investments for commercial scale feedstock production and the construction of bio-diesel and bio-ethanol plants/PIA-CAR.

# **BSU, AILA launches TESOL course**

LA TRINIDAD, Benguet - The Benguet State University is now accredited in Teaching English to Speakers of Other Languages or TESOL as it has launched its international full course last week.

BSU together with the Australian International Language Academy and in partnership with the Southern Cross International Learning Institution, an internationally accredited institution, will offer TESOL course accredited by the Commonwealth

of Australia after the training of its trainors.

Currently undergoing a 10-day training, representatives from the academe and private institutions in the region who underwent rigid screening will soon serve as trainors for the course.

TESOL is an internationally recognized qualification that allows one to teach English language in countries where the native language is not English.

BSU President Rogelio Colting said the partnership with AILA started two years ago which was then a member of the Q u e e n s l a n d Language Academy now replaced by SCILI.

AILA through SCILI authorized BSU to offer TESOL and other in ternational program not only in the Philippines but in Asia as well. However, BSU alone could not undertake training without AILA's representation according to Colting.

Colting said this has reaffirmed BSU's vision as the premiere state university in Southeast Asia.

The course normally takes around two to three months according Colting. The course provides fundamental tools for teaching English to people who speak other languages and diverse teaching methods based on dissimilar student needs and profiles.

# Natonin abaca growers needs support to sustain

inaustry NATONIN, Mt. Province - The growing abaca industry and the One Town One Product (0TOP) of eastern this municipality needs appropriate support to spur its economic development and enhance livelihood programs to the residents here.

Senior Trade and Industry Development Specialist Benjamin Gayodan of the Provincial Office of the Department of Trade and Industry said the promising abaca industry project which was launched in 2003 is faced with problems that need to be addressed to ensure its sustainability and enable to meet the growing market demands.

Gayodan said the very poor condition of the 24 kilometers road stretch connecting the municipalities of Natonin and Paracelis should be improved for easier transport of abaca production to the market.

He disclosed that aside from the cost of production, the abaca farmers are also hard up with the of cost transportation adding that the freight of every kilo of raw Abaca fiber products Natonin to Paracelis is P2,00 plus the P18,000 hire for every truckload of abaca products from Paracelis to the leading abaca buvers Manila and Bulacan.

Gayodan also batted for more technology assistance such as stripping machines and mechanical dryers to enhance production. He said the trained abaca strippers cannot produced much as they are doing it manually and the abaca stalks can hardly be dried as it depend mostly on air drying as the area is known as the home of the rain.

To improve the quality of the abaca stalks and increase the abaca fiber recovery rate, Gayodan said the abaca farmers are contemplating on

agricultural phase development. He explained that since the abaca plants are naturally grown in forested areas, the surroundings of abaca plants need to be weeded to allow the abaca plants to grow faster and bigger.

So far, the municipality of Natonin and the adjacent barangays in the towns of Barlig and Paracelis where these wild abaca plants thrive abundantly places Mountain Province only abaca producing area in Northern Luzon. The wild abaca plants are naturally growing in some 900 hectares in these

Other abaca producing areas in the Philippines include Bicol, Eastern Visayas and Mindanao . The Philippines provides 85 percent of the world's supply of abaca fiber while the remaining 15 percent comes from Ecuador.

Gayodan said that for January to June of 2007, the abaca farmers were able to sell 24.9 metric tons of raw abaca fiberat P33.50 per kilo to Manila Cordage Corporation and Jingbee Corporation, the two leading abaca fiber buyers in the country. At present, there are three entrepreneurs managing the Abaca Industry.

Meanwhile, the Development Bank of the Philippines has opened an initial P2 Billion credit window to support the government's OTOP program. Aside from loan assistance to OTOP entrepreneurs. the fund could also be access by local government units to support OTOP projects such as service common facility, road networks and infrastructures and financing training centers./ A. Dogaong/PIA-MP
