Praises décision to reject Napoles immunity pleaSenate Majority Leader Alan Peter "Companero" S. Cayetano lauded the Office of the Ombudsman for granting immunity to pork scam whistleblowers and for recognizing Janet Lim-Napoles to be the "most guilty" in the misuse of government funds.

"Tama ang desisyon ng Ombudsman to side with the whistleblowers. This will give them the assurance na magpalit man ng administrasyon, protektado pa rin sila. I laud the ombudsman for her decision" Cayetano said.

As it approved immunity for Luy and other witnesses, the Ombudsman denied Napoles' bid for immunity for "not meeting the qualifications to become an immune witness.'

"I have always been 100 percent against any type of immunity for Napoles and I'm happy with the Ombudsman's decision," Cayetano added.

He also said that the administration should provide more incentives and protection to whistleblowers to encourage them to step forward and reveal what they know in hopes of exposing corruption in government.

"There is a need to finally pass the Whistleblowers Act and expand and strengthen our Witness Protection Program to protect witnesses from threats and make sure that their role in exposing anomalies will not harm their family's safety and livelihood." Cayetano said.

He added that we must learn from other countries where the safety and livelihood of whistleblowers are protected and ensured long after they have testified.

"Many potential whistleblowers are now watching this case and if we show them that people like them will be protected and taken cared of by the state then we will see more courageous people willing to risk their lives to expose and weed out corruption from government." Marcelino Sadyoc Salva- and noted by Buguis dor, a 51-yer old carpenter from Kibungan, Benguet, and his wife Martina (nee Malines), 43, a small-scale vegetable farmer, tried to raise and send their four children to school.

Now, only Jarimar, the eldest child at 21, and Shalimar, their only daughter at 19, are the ones in school, both in first year college. Sons Maymark, 19, and Ferdimar, 17, both high school graduates, are looking for work, their dreams of going to college doused by their father's ailment.

Marcelino and his wife were living in Buyacaoan, Buguias but recently had to transfer to the boarding house being rented by Jarimar and Shalimar at Km. 4, La Trinidad Benguet. The boarding house is close to King's Collge, where Shalimar is a freshman taking up hotel and restaurant management, and to the Univerity of the Cordilleras, where Jarimar is enrolled in civil engineering.

The couple has no choice but to squeeze in. Marcelino needs to be close to the Baguio General hospsital and Medical Center where he has been on twice-a-week hemodialysis treatment for kidney failure since last March.

For months, Marcelino had refused to under go hemodicalysis treatment, which has to be for life, as it would mean a budget of P2,200 per session, or P4,400 a week, amounting to P17,600 a month. Thefigure does not include other medications, occasional blood transfusion and other maintenance costs.

"Due to his condition, Marcelino can not work, noted social worker Agustina Calion in a case study report she prepared

### **BFFFI Responds to Yangot Panagbenga Transfer Speech**

BAGUIO CITY - "The Panagbenga belongs to the people of Baguio City," the Baguio Flower Festival Foundation, Inc (BFFFI) asserted last Thursday during a press conference held at the Baguio Country Club to clear issues as to a privilege speech delivered earlier by Councilor Leandro Yangot, Jr.

The councilor earlier in his speech said that the operation of the Baguio Flower Festival should be given back to the city as it has "metamorphosed from a cultural event to a commercial endeavor, from a community affair to a profitdriven show," citing the removal of school and barangaybased landscaping activities, and extended road spaces for stall rentals. Councilor Yangot said the flower festival was a wasted opportunity to showcase local art, and handicrafts

and to honor local talent and art and to celebrate culture." Locals and handicraft producers were also not given chances to promote their products, the councilor further said in his speech. Even payment for electric usage was scrutinized, as with the audit of the city's P4M contribution and sponsors' support. "Let the Panagbenga be a community even, not a private fund raising activity," the councilor said.

The councilor earlier called on his colleagues' approval for a resolution for the mayor to convene a management team in preparation for Panagbenga 2015, as the 20th edition

The councilor voiced out confidence that the city government can efficiently run and generate income through the Panagbenga festival, for social services, programs and projects' fund allotment.

Members of the BFFFI board of directors present in the press conference which included hotelier Frederico Alquiros, Dr. Julie Cabato, Atty. Damaso Bangaoet, Jr., Dr. Francis Cesar Bringas, Mayor Mauricio Domgan, and Congressman Nicasio Aliping, Jr. each spoke about improving the next edition of Panagbenga, or giving better alternatives instead of criticizing it.

Atty. Bangaoet, Jr., emphatically said there would always be room for improvement.

Dr. Cabato, gently enthused that every Panagbenga activity should be worked at "together as a family," and there should be no suspicions nor "unpeace," as we "take things to heart."

Department of Education top executive Dr. Francis Cesar Bringas noted that it was Councilor Leandro Yangot who handed out landscape winners' prizes during the Panagbenga closing program on March 2 at the Athletic Bowl.

It was also mentioned that the landscape contest is now in the clean and green program, as it was agreed to be a yearlong, not a month-long activity.

Mayor Domogan clarified that every flower festival "has been duly audited, as a "mandatory requirement," except for the 2005 edition, he said.

The panagbenga is a community activity, thus, "let us not segregate ourselves, but unite and cooperate for whatever needs improvement," the mayor said. He gave out data which showed the tremendous increase of business taxes collected, P50M when Panagbenga started and now at P200M. Such taxes collected way back in 1992 was then P13M-P15, the mayor added. With the rise in the annual city budget, however, he is calling for the passage of a sales tax ordinance. This is for the council to act on, he added.

The city funded P4M assistance to Panagbenga is for prizes for the streetdancing, drum and lyre, Mayor Domogan also clarified.

The BFFFI body present during the forum also made it clear that the running of Panagbenga entailed sacrifices from the Baguioites. There is no doubt that there were also inconveniences during the festival, they admitted. The Panagbenga, however has been a product of partnership between the community and private entities, thus it should sustained that way, they said.

A joint statement asked the councilor to "revisit" a city council resolution which returned the 2006 Panagbenga preparations to BFFFI as it recognized that "BFFFI, to-

### SC Ruling on City-Jadewell **Cases** out

BAGUIO CITY - The Supreme Court has ruled on the cases between the city government and the Jadewell Jadewell Systems Parking Corporation, the controversial operator of the city's on-street payparking project in the early 2000s.

In a decision penned on April 23, the Chief Justice Ma. Lourdes P. A. Sereno affirmed the Court of Appeals ruling dated July 7, 2003 invalidating the city council's rescission of the memorandum of agreement that authorized Jadewell's operation in the city in 2001.

The Court however pointed out that there was not enough evidence on the extent of Jadewell's violations of the contract to prove whether or not the unilateral rescission of the contract was in order.

Moreover, the Court did not award any damage in favor of the parking firm.

"While Jadewell prays for damages against the public respondent, and while ordinarily we could grant the same, the context of this case prevents us from giving any form of recompense to Jadewell even if the rescission of the MOA did not follow the required legal procedure. This is because it would be appalling to grant Jadewell any award of damages, considering (1) it installed only 14 out of the apparently 100 contemplated parking meters; (2) its employees, private citizens who did not possess any authority from the LTO (Land Transportation Office), were manually collecting parking fees from the public, and (3) it did not, apparently properly remit any significant amount of money to the City of Baguio," the Court said.

"These three facts are uncontested, these omissions are offensive to the concept of public service that the residents of Baguio were promised through Jadewell. From its ambiguous responses ..., it is clear that Jadewell does not appear to be an investor who has lost in its investments in the Baguio City project. Thus, we do not award any damages to Jadewell."

In the same ruling, the Court also dismissed Jadewell's petitions to cite former mayors Braulio Yaranon, Bernardo Vergara and Mayor Reinaldo Bautista Jr., former vice mayor Betty Lourdes Tabanda, members of the then city council and Judge Fernando Vil Pamintuan for indirect contempt and to disbar city officials who are lawyers by profession.

The Court also denied the petition of Jadewell for certiorari, prohibition and madamus as well as its prayer for the issuance of a temporary restraining order and/or writ of preliminary injunction.

Yaranon's petition for review on certiorari relative to his suspension from office in 2006 was also denied for being moot and academic.

Mayor Mauricio Domogan believes the SC decision would not be the end of the Jadewell issue in the city

He said Jadewell can still file a motion to clarify the ruling.

Jadewell's operations in the city which was assailed for a long time was stopped in November, 2006 after the city council repealed Ordinance No. 003-2000 for the privatization and administration of on-street parking in the city and rescinded the MOA that authorized its operation in 2001.

This resulted to Jadewell's filing of the case against the city government questioning the validity of the rescission.

The Regional Trial Court on October 8, 2002 declared the city council's move as unlawful and this was sustained by the Court of Appeals on July 7, 2003.

The main case spawned a bevy of cases, one of which resulted to the suspension of former mayor Yaranon in 2006.

## NEWS PE, Bong, and Jinggoy Formally Slapped with **Plunder Charges**

Janet Lim Napoles is charged along with them. On Friday afternoon, June 6, the Office of the Ombudsman filed at the Sandiganbayan plunder and graft charges against Senators Juan Ponce Enrile, Ramon "Bong" Revilla Jr., and Jinggoy Estrada for their alleged involvement in the P10 billion Priority Development Assistance Fund (PDAF) scam.

Enrile allegedly plundered P172 million; Revilla, P242 million, and Estrada, P183 million.

Aside from the three senators, their chiefs of staff were also were also charged: Atty. Jessica "Gigi" Reyes, former chief of staff of Enrile; Richard Cambe, chief of staff of Revilla; and Pauline Labaven, staff of Estrada.

Janet Lim Napoles, the alleged mastermind of the scam, was likewise charged with plunder.

Two heads of Napoles-linked NGOs, John Raymond de Asis (Kaupdanan para sa Mangunguma Foundation Inc.) and Ronald John Lim (Ginintuang Alay sa Magsasaka Foundation Inc.) were also charged./ANC News Channel

BAGUIO CITY More than 350,000 elementary and high school students in public schools in city trooped to their respective schools for the

opening of classes on Monday, June 2. Amidst the usual problems on school opening like lack of classrooms, teachers and other school facilities, classes resumed smoothly.

Dr. Elma Donaal, principal of the Baguio City National High School Principal, the city's biggest public school, said the lack of classrooms is due to the unprecedented increase of students in the public schools.

As of Monday, more than 6700 students are enrolled at the BCNHS Main and annex campuses in the city, and the number is still expected to increase with enrolment still on going.

Donaal said the lack of classrooms is still a big problem in the BCNHS since there were only few classrooms which were created out of the old school facilities just to accommodate the increasing number of stu-

at the moment, the school has a 1:70 classroom to student ratio particularly at the fourth year classes which increased this year. Department of Education's prescribed ratio is 1:45.

In

The fourth year level needed at least nine classrooms more to accommodate the growing number of students but they had only remedied five classrooms. Two are at the old Gabaldon building which is considered as a heritage building since it is a more than 60 year old structure, but is now being refurbished to be used as classrooms.

It was also learned from Donaal that the DepEd has allowed only two new teachers to be added to the manpower of the school.

She stressed that they would not deprive any student who would be coming to enroll at their school even if they are faced with such problems.

Meanwhile, the Fort Del Pilar Elementary School inside the Philippine Military Academy has postponed the start of classes for the kinder

Give Filipino Families the Swift Justice they deserve

As "the day of accounting" has come for pork plunderers, Senate Majority Leader Alan Peter "Companero" S. Cayetano said the Sandiganbayan must ensure that Filipino families get the swift but fair justice they deserve.

Citing a World Bank study, Cayetano pointed out that the average case processing time in the Sandiganbayan is nine to 10 years. As of 2012, the Sandiganbayan has almost 2,300 pending cases

"We can no longer let this happen. Ipakita natin sa publiko na kaya natin silang bigyan ng mabilis na hustisya at hindi makakawala ang mga nagnakaw ng perang ng taumbyan. This is the best and strongest message the government can send na hindi nito itotolerate ang korupsyon," Cayetano said.

Cayetano made the statement following the filing of plunder charges against Senators Juan Ponce Enrile, Jinggoy Estrada, Ramon "Bong" Revilla Jr., along with Janet Lim-Napoles, and other personalities at the Sandiganbayan today.

"The judiciary must now exercise political will by designating a special criminal courts or divisions to expedite trials such as these. Otherwise, this is another case of 'justice delayed is justice denied'," Cayetano said.

"We must do everything to finish this and other high-profile cases involving the plunder of the people's money in 500 days or one and a half years. This should be more than enough if the Court prioritizes these cases. The evidence is there. The paper trail is there. The whistleblowers have risked their lives to reveal in their sworn testimonies what they know. Hindi ako naniniwala na hindi kayang pabilisin ang procesong ito." Cayetano said.

Cayetano stressed the need to swiftly resolve the plunder cases before the 2016 presidential elections.

"Dapat ang desisyon mangyari bago mag eleksyon para yung mga guilty will not benefit from a change in the administration by 2016," he said./Office of Senator Alan Peter Cavetano

## Restitution

The Court of Appeals Thursday stood pat on its earlier decision affirming Ombudsman Conchita Carpio Morales' order: Fire 10 Navy officers linked to the 1995 murder of then 24-year-old Ensign Philip Pestaño.

#### Pestaño-who?

He studied at the Sacred Heart School in Cebu, then enrolled at Ateneo de Manila where he was an honor student. Pestaño joined the Philippine Navy after graduating from the Philippine Military Academy in 1993. He was posted as cargomaster for the Navy ship BRP Bacolod City.

Among other things, he refused to load 14,000 board feet of illegal logs, weapons and shabu. For that, he got threatening phone calls. "'Kawawa ang bayan,' Pestaño told anxious parents, who pleaded with him to resign from the Navy," the late James Reuter, SJ, recalled in his column, "At 3 A.M."

As the story goes, part of the shipment turned out to be "a gift" from then Gov. Gerry Matba for Admiral Pio Carranza. "Orders from above" overruled Pestaño. The Department of Environment and Natural Resources certified that the logs were inspected in Zamboanga—when the boat was already docked in Cavite. The logs vanished but spurious clearances appeared.

Pestaño was found in his cabin with a gunshot wound on his right temple after the ship meandered on an hour-and-a-half trip from Cavite to dock at Roxas Boulevard. Normally, that trip takes 25 minutes. Logbook entries vanished.

"Suicide," ruled the Navy within 24 hours, sans investigation. Nonsense, objected

Pestaño's PMA classmates, who pointed to the absence of powder burns on the body and also offered testimony.

Archive the Pestaño case as the evidence is "patchy," ordered then Ombudsman

**CORIAL** Aniano Desierto. As Marcos military prosecutor, Desierto hounded sena-

tors Benigno Aquino Jr., Jose Diokno and other dictatorship victims. Up to his death, senator Lorenzo Tañada refused to even address Desierto directly.

Ombudsman Desierto "will be devoting a considerable amount of his official time protecting his hide," constitutional scholar Joaquin Bernas, SJ, predicted then. "His image is shattered... and it is impossible for him to function effectively..."

And that's where the Pestaño case was boxed into—until the Senate committees on human rights and national defense stepped in. Led by the late Senate president and former chief justice Marcelo Fernan, the committees held eight meetings between May 5 and Sept. 3, 1997. Members inspected Pestaño's cabin.

Senate Report No. 800 concluded: "Pestaño... was bludgeoned unconscious and then shot to death somewhere else in the vessel. His body was moved and laid on the bed where it was found. Identify the persons who participated in this attempt to fake suicide.... The clear absence of blood spatters, bone fragments or other human tissues is physical evidence more eloquent than a hundred witnesses..."

Then Sen. Fred Lim did just that in a later privilege speech. He fingered Lt. Carlito Amoroso (PMA Class 1994) a close-in security for Admiral Carranza. Amoroso was on board BRP Bacolod City as an "unmanifested passenger." Lim lashed at Ensign Joselito Colico who admitted, before the Senate, that he removed the magazine from the .45-caliber pistol and wiped off fingerprints. Both are among those cashiered by the Court of Appeals.

The ensign's parents, Felipe and Evelyn, gave up knocking at then Ombudsman Merceditas Gutierrez's door. "She has not agreed to see us," they said.

Gutierrez added "sting to injury," noted then UP College of Law dean and now Inquirer publisher Raul Pangalangan. She dismissed the complaint after Pestaño's parents signed the impeachment complaint against her. Gutierrez quit when the House of Representatives impeached her.

In 2011, President Aquino appointed former Supreme Court justice Conchita Carpio Morales as Ombudsman. That same year, Morales reversed Gutierrez's 2009 decision shredding the murder and administrative misconduct charges against the 10 Navy men.

Pestaño's parents also sought the United Nations' help. In March 2011, the UN Human Rights Commission (UN-HRC) wrote: Despite denials by authorities, Pestaño was not a suicide but the victim of homicide. "Violation of Ensign Pestaño's right to life and to redress of grievance... is directly attributable to the State in party (Republic of the Philippines)."

"No one has been prosecuted for the crime—after (more than a decade). It had been committed with impunity." The Philippines should "undertake enforceable remedies.... and inform the UN within 180 days."

Within four months of Pestaño's death, comrades disappeared in "mysterious circumstances," the UN-HRC in Geneva found.

PO2 Zosimo Villanueva tipped Pestaño "on drugs stashed in 20 sacks of rice aboard the ship." Then Villanueva was "lost at sea" but his three companions survived. Only a bloodied speedboat was found.

PO3 Fidel Tagaytay was BRP Bacolod City's radio operator. Tagaytay agreed to brief the provost marshal about people who had sneaked aboard. He vanished when summoned to testify. Wife Leonila's efforts to trace his whereabouts were brushed off by the claim that Tagaytay was "absent without leave."

Ensign Alvin Farone contacted Marissa, Pestaño's sister, saying he wanted "to tell what really happened to Philip." He died before he could do so.

Firing is half of the job. What about the restitution? Zacchaeus told the Master he would repay fourfold what he stole. And what compensation can we, as a people of notoriously short memories, accord to a young officer for standing up to what was right?

"UNORTHODOX" DOCTOR

I was seated in a clinic receiving room in Quezon City a few days ago waiting for our turn to meet the doctor, a certain "DOC LEAL" who was supposed to be an expert on non- invasive treatment for body pains. Then I spotted on the wall of the reception area a full-spread front page clipping of last year's SUN STAR Davao April 2013 issue. Featured in a full banner story written by its Editor Stella Estremera was Dr. ISAGANI S. LEAL from Magpet, North Cotabato, now a musculoskeletal expert with whom we had an appointment for consultations that afternoon. He is supposed to be the only one of his kind in the country today. His photos with sports stars, even one with businessman Manuel V. Pangilinan (MVP) and senators and other celebrities in Manila were collaged on the wall. Seated in the reception area were mostly "senior citizens" with walking canes and one young lady in wheelchair evidently injured. I was there with Beth for her recurring neck pains that had been troubling her for years whose medications evidently caused her kidney ailment. Truth to tell, it was Davao Mayor Rody Duterte who mentioned to Beth during the wake of our brother-in-law in Davao City to see a "Dr. Leal" in Manila after both of them exchanged notes about their common recurring neck pains and headaches. But I had no way of contacting him as I failed to get his cell phone number. By some coincidence last week, former Gov. Manny Pinol picked up the phone during coffee at Starbucks in SM mall in Davao City and linked me up with the DOC LEAL who was actually a native of Gov. Manny's province. My wife and I promptly went to Manila to meet this doctor in our continuous search for relief from her recurring neck pains to further nurture her improving kidneys.

NON-CONVENTIONAL - When we entered his small clinic, he immediately told me in Cebuano: "Kaila man ko nimo, sir." (I know you, sir) although I barely recognized him. He used to work as a doctor at the regional health office in Cotabato City when I was handling Mindanao for Malacanang. I would visit his area during calamities like bombings, shooting incidents and outbreak of epidemics. He recalled seeing me often during the "war" (with the MILF) in Pikit, North Cotabato as he was involved in community - based medical services attending to the evacuees. Even as a medical doctor, he was more fascinated with the "unconventional and the unorthodox". He dawdled with herbal medicines, therapy, "hilot" and other alternative procedures. He even authored a manual on alternative herbal medicines that up to this day is being used by the regional health office. An opportunity came when he was sent on a 3-month training in Israel on a new method called musculoskeletal medicine. After his 3-month scholarship, he decided to stay and personally paid his way to more training and immersion in a pioneering medical field. He "moonlighted" as a part time doctor in TelAviv (usually pro bono to his "kababayans") and even worked as contributor to a medical magazine. His meager earnings as a part- time writer and practitioner were used to finance his frugal life there just to learn some more. He gave free medical assistance to Pinoy OFWs in his spare time. It was while he was in Israel that he lost his wife who was left in Cotabato due to leukemia.( His only daughter is now 18 years old. ) He trained in Tel Aviv, Israel for 4 years on what can be described by western medicine as an "unorthodox" or alternative way of treating body pains and ailments.

CLINIC — Upon returning home, he eventually opened in 2009 a clinic called CENTER FOR MUSCULOSKELETAL SCIENCE—ASIA, now known for its Cont. on page 9

#### De Lima must answer immorality raps



LIFE'S INSPIRATIONS: "... Therefore, get rid of all moral filth and the evil that is so prevalent and humbly accept the word planted in you, which can save you..." (James 1:21, the Holy Bible).

#### MORALITY OF A GOV'T OFFICIAL IS A LEGAL

**ISSUE:** This is not to agree and say that the accusations of immorality or of having illicit relationships with two married men against Justice Secretary Leila De Lima are true. As a lawyer, I know that these kinds of accusations must be proved in court first, if they are to be believed at all.

But then, I do not agree that De Lima need not answer them, nor "dignify them with explanations" at this point, because they pertain to "personal matters". The fact is that, accusations involving the morality of anyone in government once raised publicly, must have to be answered, explained, and immediately refuted, because they involve an issue that is not only personal or moral, but also totally legal.

For it cannot be denied that there are laws and Supreme Court decisions in the country right now that direct anyone working in government not only to be morally upright at all times, to behave and conduct themselves according to law, good morals, good customs, and public policy, but also to avoid any appearance of impropriety affecting the integrity of public service.

LAWS DWELLING ON MORALITY OF OFFI-CIALS: The first of these laws is found under Section 27, Art. II, Declaration of Principles and State Policies, which says: "The State shall maintain honesty and integrity in the public service and take positive and effective measures against graft and corruption..."

Second, morality in government service is also required under Republic Act 6713, which is the "Code of Conduct and Ethical Standards for Government Officials and Employees". Its Section 4 (c) says: "... Every public official and employee ... shall refrain from doing acts contrary to law, good morals, good customs, public policy, public order, public safety and public interest..."

Then, we also have Proclamation No. 62, Series of September 30, 1992, which is entitled "Declaring A Moral Recovery and Enjoining Active Participation of All Sectors in the Filipino Society". This law says "... there is a need for moral renewal in order to eradicate the social ills that have plagued us for the past several decades..."

**DE LIMA MUST RESPOND TO ACCUSATIONS ON IMMORALITY:** Executive Order 319, Series of April 03, 1996, on the other hand, directed "(A)ll government departments, offices, agencies, instrumentalities and government-owned and controlled corporations are enjoined to establish Integrity Circles or any similar mechanism to lay the necessary foundations of the moral recovery crusade for Filipinos..."

In the case of "Samson vs. Restrivera", G.R. No. 178459, March 28, 2011, the Supreme Court gave a directive for all government officials and employees to "avoid any appearance of impropriety affecting integrity of public service." Surely, the morality, or lack of it, by any government official is a matter that affects public service and should any question be raised about it, a forthright answer is demanded.

De Lima therefore owes not only to President Aquino, but also to God and to the Filipino people, to squarely respond to any challenge on her moral uprightness, not as an admission of any guilt, but because as a ranking official under a government that supposedly espouses "righteous governance", she has a legal obligation to do so.

How Do We Go About Legalizing Irregularly-Issued Franchises?

First and foremost, we should work for the issuance by LTFRB en banc of a memorandum circular allowing holders of irregularly-issued franchises or CPCs to file petition for legalization individually in the Regional Board. It is similar to Memorandum Circular No. 2000-019 in which the Board allowed the legalization of taxi franchises in Baguio City issued in violation of the Public Service Law. Precisely, this is what we are asking now the Board in the pending Petition for Legalization that we filed in August 2013.

Unfortunately, in the hearing of the petition last March, the Board en banc suspended the hearing, instead, it ordered the conduct of audit of the CPCs listed in the Inventory of Irregularly-Issued CPCs submitted by the LTFRB-CAR. It is my thinking though that the audit of the Board should not have been limited to the CPCs inventoried by LTFRB-CAR consisting only of 1400 cases because, in my own honest calculation, the Regional Board granted more of these CPCs during the period of moratorium from 1996 to the present.

At any rate, in an Omnibus Motion that we will file after the Board's audit, we will request the Board for the continuance of hearing of the pending petition for legalization. We will also ask that acceptance of application for sale and transfer be suspended in the meanwhile.

In resolving the pending petition for legalization, the Board en banc will probably be faced with several options, or so I think. These may partake of the following:

1. To deny in its entirety the petition for the reason that irregularly- issued franchises being illegal or void cannot be legalized. (however, it will have to contend with the precedence established by the Board in legalizing taxi franchises in 2000 for violations of the Public Service Act.)

2. To partially grant the legalization by way of allowing the CPCs irregularly issued in violation of the moratorium and other LTFRB rules, but not the CPCs granted in violation of law like the spurious and the fraudulent.

3. Maintain the status quo of the procedures presently observed by the LTFRB-CAR in which all applications filed by holders of irregularly-issued franchises are granted by the mere submission of the self-serving Affidavit of Undertaking (this would be the worst option that the Board will take if ever, since it will perpetuate the existence of invalid or void CPCs.)

4. Or, the Board will grant the petition, subject to terms and conditions that it may deem proper and necessary.

For the purpose herein, we will assume that the pending petition for legalization will be granted favorably.

The object of this legalization is to make all irregular CPCs in the hands of PUV operators in the Cordillera legitimate or valid for, if they remained as such they will pose danger to the security of both operators and the riding public. Otherwise put, legalization should be able to cleanse the dockets of the LTFRB-CAR of tainted CPCs or CPCs issued in violation of law, the moratorium and other rules promulgated by LTFRB en banc. We have no definite timeline for it, but legalization should successfully be completed within five (5) years by which period all cases and CPCs shall have been verified or the irregular CPCs have been determined.

To facilitate the determination of who are holders of irregularly-issued CPCs required to file petition for legalization, the following incipient presumptions can be adopted by the LTFRB-CAR (if it wants to):

1. As a rule of thumb, all CPCs issued in the first instance BEFORE the effectivity of moratorium under LTFRB M.C. No. 96-002 or M.C. 98-026 or M.C. No. 2003-028 and their derivatives (CPCs derived therefrom),





BAGUIO CITY –the City Social Welfare and Development Office (CSWDO) has recommended the amendment of a 13-year old ordinance granting assistance to victims of calamities here.

City ordinance Number 46-2001 or the 'Relief and Rehabilitation Assistance to Victims of Disasters Ordinance' passed 13 years ago provides assistance to victims of disaster and calamities man-made or natural.

City Social Welfare and Development Officer Betty Fangasan April 14, 2014 recommended amendments to the ordinance specifically the increase in cash assistance given to victims.

This is in response to the legislative tracking and analysis being conducted by the Sangunian Panglungsod (SP) research division on said ordinance for its implementation and further improvement.

Fangasan said, 'they are currently implementing the ordinance but certain provisions need amendment as it is already not at par with the present situation.'

Pointed-out by the social department for amendment are provisions in the rehabilitation assistance such as the 'Food-for-Work and Cash-for-Work' program, Balik Probinsya Program and Supplemental Feeding Program.

Fangasan said, 'considering the escalation of basic commodities such as rice, canned goods and mineral water since 2001, the cash assistance of P100.00 is no longer enough and suggested to increase the same to P250.00.'

For the Balik Probinsya program, the ordinance mandates cash assistance of P4,000.00 as maximum amount per family for transportation and food while on travel.

Fangasan said, 'it would be more feasible for the city to provide actual travelling expenses on transportation and food costs for the program considering that most families who avail of the program are more than three members.'

The CSWDO also recommended the increase from P10.00 to P20.00 per day for 30 days the fund allotted per child for the Supplemental Feeding Program.

The city council passed in November 5, 2009 amendments to the ordinance increasing the assistance being afforded to victims and their families.

Although Amendatory Ordinance 80-2009 provided the increase in Assistance to Individuals in Crises (AIC) from P3,000.00 to P6,000.00 per beneficiary.

It also increased the financial assistance given to the bereaved families of victims of disaster and calamities from P6,000.00 to P20,000.00 covering primarily funeral expenses.

P30,000.00 was also included as assistance to rescuers and government officials and employees who die performing their duties in rescue and disaster operations.

Families of missing victims during disasters will also be given P2,000.00 a day for a maximum of five days.

If the victim is still missing in the tenth day, the family will receive financial assistance to complete the amount of P20,000.00.

The amended provisions in Ordinance 80-2009 did not however increase the Food-for-Work and Cash-for-Work program, Balik Probinsya program and the Supplemental Feeding program.

The SP tracking team also recommended for the increase in the amount allotted to the different programs of the ordinance to be increased every five years for continuous and effective implementation of the same./paul rillorta

## **LTFRB** Monitors Implementation of 20% Fare Discount

BAGUIO CITY - The Land Transportation Franchising and Regulatory Board (LTFRB) Cordillera is doing inspection on public utility transportation units including jeepneys, buses, taxis, AUVs or vans and express service franchises on the implementation of the 20 percent fare discount.

Rosario K. Oyaman, head of LTFRB in the region, said that with the opening of classes, public utility drivers should give the mandatory 20 percent fare discount to students., as well as senior citizens and people with disability.

Students from preschool to college, including vocational and technical schools recognized by the government, are entitled to the discount.

Students of postgraduate studies and short-term courses like seminars, however, are not covered by such privilege.

Also entitled to the 20% percent fare discount are senior citizens and people with disability.

To avail of the discount, they must present their identification cards.

On the part of the transport sector, Perfecto "Jonie" Itliong Jr, 1 UTAK coordinator, said they are giving fare discounts to those who are entitled to it.

"We know the difficulty parents face to defray household expenses with prices of basic commodities rising. This is the least we can do to help our students keep their spirit of going to school and pursuing their education," Itliong said.

## Igorot Karateka's Foundation Sustains Support for the Sick

Almost quietly but consistently, a small foundation established in 2004 by an Igorot expatriate in southern Germany has been reaching out to the sick and needy, mostly kidney patients continuously being pressed to sustain their twice- or thrice-a-week hemodialysis treatment to survive.

"I've been asked repeatedly how many of those we've been helping have been freed of their disease, and it's difficult to answer, given that hemodialysis treatment is for a life-time," Julian Chees, a former world karate champion and head of Shoshin Kinderhilfe Foundation, said.

'Still, it's more difficult to limit our support only to patients suffering from early stages of cancer and other ailments that can be cured after sometime, as those undergoing hemodialysis need help with greater urgency than those afflicted with other ailments," he said.

From January last year to April this year, Julian Chees-Shoshin Kinderhilfe sent a total of PP380,193.26 that was disbursed to kidney and other patients in Baguio and other parts of the Cordillera

Among those supported by the fund within that 16-month period were dialysis patients Marilou Matias of Villasis, Pangasinan, Jocelyn Laigo of Burgos, La Union, Sharon Dalida of Ambiong, La Trinidad, Benguet; James Belinan of Kapangan, Benguet; Ferdinande Dumol of Banaue, Ifugao; Russell Solinto of Camp 6, Tuba, Benguet; Leah Lyn Talangan of Talubin, Bontoc, Mt. Province; Shaly Cris Banas of Ilocos Sur; Jennier Payoyo of Palawan; Edward Magat, Belinda Allosa ; Quakelyn Lisayen, Amor Orpilla, Grace Bango ; Mary Grace Binay-an; Edwin Bagano; Agustin Gayao; Norman Balog-ang; Nancy Ayson; Chester Raga; Robert Nabus; and Leonard Nalos.

### **Baguio-Barlig Twinning Confirmed**

BAGUIO CITY - The city council last Monday sealed the sisterhood agreement between Baguio and Barlig town in Mt. Province.

The body confirmed the memorandum of agreement for such kinship earlier signed by Mayor Mauricio Domogan and Barlig Mayor Clark Ngaya.

Barlig officials in July last year, approved a resolution declaring intent for the city-town pairing and responding to the move, the city council accepted and adopted Resolution No. 240 saying the sisterhood ties will promote the exchange of best practices of both localities.

Under the MOA, both local government units sought "to build ties and to create an atmosphere where economic development, trade and tourism between the two parties can further be development, implemented and strengthened."

To realize the goal, the city agreed to provide technical expertise and assistance on the development of the eco-tourism industry and promotion of local handicrafts, agricultural products and livestock Barlig and on the exchange of cultural and educational programs through scholarships, environmental research and eco-tours.

Barlig, for its part, agreed to provide information on the promotion of tourism industry of the city, enhancement of trade relations on agricultural products and livestock and the strengthening of education and cultural relations with the city.

Barlig is a fifth-class municipality of Mt. Province with a population 6,168 divided in 11 barangays. treme weather events are the other issues that are linked to the environment," she said.

"The message of this year's World Environment Day focuses on the risks posed by rising sea level and the vulnerability of coastal communities and small island nations. Several studies have already noted the high vulnerability of coastal communities in the Philippines to sea level rise. This is the challenge that we must address because according to a study by the Asian Development Bank (ADB), sea level rise will affect at least 13.6 million Filipinos who will have to relocate to higher, safer places," Legarda stressed.

The 2012 ADB study "Addressing Climate Change and Migration in Asia and the Pacific," said that the Philippines is among the most vulnerable countries to climate change and it is ranked 5th in terms of individuals affected by sea level rise.

The Senator also noted a study by the University of the Philippines Los Baños (UPLB) Climate Change Program which showed that a total of 167,290 hectares of seashore land in 171 coastal towns under 10 provinces will go underwater due to a one-meter sea level rise.

The 10 provinces are Cagayan, Palawan, Iloilo, Zamboanga Sibugay, Camarines Sur, Negros Occidental, Capiz, Bohol, Tawi-Tawi and Sulu.

Legarda, who also chairs the Senate Committee on Climate Change, said that while there is little the country can do to prevent sea level rise, it can reduce the risks and act ahead of time to protect the communities that will be most affected.

"With the threat of sea level rise, local government units especially of the 10 most vulnerable provinces must already update their respective comprehensive land use plans and they have to gradually relocate communities near the seashore land. Since we are also experiencing stronger storms, we have to build resilient infrastructure and it is important to strengthen the defense of coastal communities by building natural buffers through massive mangrove reforestation," she explained.

"Sea level rise is a great challenge for an archipelagic country like the Philippines and while we cannot prevent it from happening, we must do everything in our capacity to reduce its effect on our people. Even if our country is a minor emitter of greenhouse gas (GHG), which is the major cause of global warming, we still have to pursue a low carbon lifestyle and strengthen environment conservation efforts as a way of urging other nations, especially the developed countries that are major emitters of GHG, to drastically reduce their GHG emissions and assist countries that are most vulnerable to the effects of climate change," Legarda concluded.\*\*\*/

"After due deliberation by TTMC, it was unanimously approved that the jeepney trunklines coming from outside and going to Baguio City and vice versa are prohibited from picking up passengers within the jurisdiction of Baguio City because there are existing PUJ franchises that serve the needs of passengers in order to prevent the possibility of physical conflicts and violence involving the affected PUJs," the TMC noted in its Resolution No. 1 series of 2014.

Alangsab said the body must adopt the TTMC policy to really prevent conflicts.

"The existing PUJ franchises granted to Baguio jeepney operators serving Baguio commuters and passengers must be respected," he added.

eter fence.

The city government has since practiced the immediate demolition of illegal structures inside the Buyog Watershed.

There are at least 6 watersheds in Benguet particularly Ambuklao-Binga Wateshed Forest Reserve with an area of 63,650ha proclaimed on April 19, 1969, Ambuklao Watershed Forest Reserve with an area of 9,700ha proclaimed on November 25, 1966, Lower Agno Watershed Forest Reserve with an area of 39,304ha proclaimed on November 22, 1983, Busol Watershed with an area of 329ha proclaimed on December 12, 1987, Buyog Watershed Forest Reserve with an area of 20ha proclaimed on November 5, 1992 and Lucnab Watershed Forest Reserve with an area of 1.98ha proclaimed on May 12, 1992.

Domogan said, "the city is trying all it can to reclaim areas of its forest reservations to illegal land claimants as this could lead to serious environmental problems."

Domogan also questioned the rampant titling of Forest Reserves and Parks by the National Commission on Indigenous Peoples (NCIP) recently which presented a big problem for the city.

Among the reservations and parks issued Certificates of Ancestral Land Titles (CALTs) include the parts of the Busol Watershed, Forbes Park, Wright Park and Botanical Garden.

The city has remained locked in a battle to reclaim said areas and continue to pursue efforts of recovery to the point of seeking help from the national government regarding the issue./ paul rillorta

innovative and alternative mode of treatment, located along West Ave in Quezon City ( tel. 09179404762; <u>www.cms-asia.net</u>). It provides minimally invasive image-guided treatment for back pains, arthritis, shoulder pain, spinal problems and sports injuries using arthroscopic, fluoroscopic and ultrasound- guided interventions and regenerative medicine. (He treated my recurring knee problem — due to high uric acid —and in a matter of minutes, it erased the numbing pain just like magic. I swear!) But that's going ahead of his boyhood story.

**POOR BARRIO BOY** —Doc Gani, 48 years old, grew up as a poor boy in Magpet, North Cotabato where he had to walk about seven kilometers daily to school. His father was a passenger jeepney driver and his mother a public school teacher. He was featured in that SUN STAR article because his father, a lowly driver was a surprise graduation speaker in a local college to inspire the graduates about how hard work could give deliverance to poor families like theirs. Chatting with him briefly brought me back to my own

memory lane. I immediately had an eeriefeeling of familiarity with him, my own father being a passenger bus driver too and my mother also a public school teacher and having spent boyhood days in our barrio. He first wanted to become a priest and entered the seminary (I too almost entered the Brothers of the Sacred Heart juniorate in high school) but he shifted to the medical school by supporting himself, during pre- med days, as waiter and dishwasher at the "Tropical Hut", a resto chain. Then to finance his medical course proper, he worked as a roomboy at a drive-in motel called Anito Hotel in Manila. (No, I didn't work in trysting hideaways but in a newsroom.) He was lucky to get scholarships due to his exceptional grades to finish medicine.(I had scholarships for academics and as a band member during pre-law but had to pay for law school tuition even after becoming a lawyer due to outstanding promissory notes with the Ateneo finance office. ) He told of hard times when unable to have decent meals, he would just have rice with "salt" with some splice of "sarsi" a cheap cola — for taste. (I was lucky my aunt in the city took me in for free board and lodging and settled in a small corner under the stairs but I had to leisurely walk a kilometer away to Ateneo from the house.) After becoming a doctor, he worked at Region 12 Health facility in Cotabato. It was from there that he got the chance to get special training in musculoskeletal medicine in Israel . He stayed there for 4 years, training and at the same time attending to Pinoy OFWs there giving free medical services.

ISRAELI TECHNOLOGY — He described his instruments and techniques as "Israeli technology", not practiced by traditional western medicine. For example, after some preliminaries, he put Beth in a "balancing machine" that electronically measured and examined her body "balance" . To our surprise, we learned for the first time that her left side was shorter by .25 centimeters compared to her right. Simply, this means an imbalance that triggers the recurring pains that had been troubling her for as long as we could remember. He used a skeletal scale model in explaining how the pains were triggered if one side was shorter than the other. To correct this, he simply recommended that Beth's left shoe or footwear be "padded" with a .25 cms. shoe padding. A cushioned portable seat with the same padding thicker on her left side every time she would sit down was also prescribed. Then Beth had to go through a 9 - day therapy session that normally consisted of therapeutic ultrasound, extra corporeal shock waves therapy, acupuncture, physical therapy, traction and muscle relaxant injections in the neck guided by ultrasound imaging shown on the screen. Every daily session lasts for an hour. Now Beth hopefully need not agonize taking painkillers that will further threaten her already precarious kidneys that had bounced back somehow after her fresh stem cell treatment in VILLA MEDICA in Germany two years ago. ( As I write this, Beth is on her 6th day therapy session. I will continue to track her treatment and share updates from time to time.)

#### PAYBACK TIME —A simple man with



simple dreams, Doc Gani is now bringing to his hometown in North Cotabato what he as a young boy always dreamt of: seeing in person PBA basketball players in flesh and blood. No doubt, PBA playerpatients whom he treated are just too glad to visit his hometown barangays in Cotabato in appreciation for his "magical" treatments that keep highly paid basketballers who are injured or in pain back on the hard-court in a jiffy. Being the resident sports doctor of MVP's AZKALS TEAM and TALK & TEXT, he makes arrangements to have PBA players visit his native town to do clinics and exhibition games. Boxing Champ Manny Paquiao, I was told, had consulted him on some muscle-related concerns.

Still determined to help his fellow Mindanaoans who could not afford to travel to Manila, he agreed to meet with patients at the ALEXIAN WELLNESS CENTER in Matina, Davao City once a month during a weekend before he motors to his hometown three hours away. He said he is in solidarity with the missionary zeal of the Alexian Brothers who run the Center in Davao. Someone describes his medical fees as "*de lastico*", meaning socially elastic to suit each one's capacity to pay.

Here is a local boy who surmounted poverty and now the only musculoskeletal expert in town doing "*payback*" time for the less fortunate. He remains to be a simple down-to-earth "*provinciano* "with his "*unorthodox*" methods of healing.

**SICK PHILIPPINES** — One last "*hirit*" if I may: We must all still continue to search for that "*unorthodox doctor*" to treat our country's AILING BODY POLITIC that is so sick today that conventional ways will definitely no longer work! Are you with me on this? Let us know.

all CPCs that were granted with exemptions to the moratorium and their derivatives, and all CPCs that were legalized under M.C. No. 2000-019 and their derivatives will all be deemed regularly issued, hence, legal and valid. It will only be a waste of time verifying them.

2. On the other hand, all CPCs issued in the first instance AFTER the effectivity of the moratorium under LTFRB M.C. No. 96-002 or M.C. 98-026 or M.C. No. 2003-028 and their derivatives shall be considered irregularly issued, hence, illegal and void. They shall be required to file petitions for legalization individually.

In the interim, as coordinate measures, *all kinds of applications* being filed at LTFRB-CAR shall undergo verification of records to determine if they are truly irregularly issued CPCs. However, to facilitate, the verifications process should make use of the above presumptions, the audited Inventory of Irregularly Issued Franchises and the previous Audit Reports made by LTFRB and DOTC personnel.

Going back, the memorandum circular

to be promulgated by the Board en banc allowing legalization should perhaps contain the following terms and conditions, among others:

1. The records of LTFRB Region 1 and LTFRB-CAR, despite the attendant irregularities, shall be the sole and exclusive basis for classifying irregularly issued CPCs.

2. The compulsory filing of the petition for legalization within one (1) month upon classification of CPCs shall commence upon classification of the CPCs as irregularly issued by the LTFRB-CAR which shall be published and notice given to the operators.

3. The payment of filing fees, and penalties if not condoned (however, since the irregularities were the making of the Regional Boards, there may be equitable reasons to reduce the fees.)

4. The petition shall be processed like ordinary application for CPCs with hearing.

5. To facilitate legalization, LTFRB-CAR personnel shall be augmented by other personnel from other regions, except personnel from Region 1 from where the irregularities begun.

-0 -

ASACAVEAT: Since Chairman Ginez had been quoted to have said he is more inclined not to legalize irregularly issued CPCs, it behoove all holders of irregular CPCs to act accordingly and fast. For, if the LTFRB Chairman can cancel fleet franchises of buses due to some violations, he could also be capable of cancelling or revoking all irregularly issued franchises in Baguio City and the Cordillera because they are invalid and void.
