

Of the \$1.27 million freshman state representative Marc LaHood hauled in in less than 2 weeks, 62% came from Democrat trial lawyers, their firms, and the PAC they formed (Texas for Truth & Liberty).

- ◆ LaHood reported \$1,272,285.25 in contributions on his July 15th semiannual report covering the first 6 months of 2025. As lawmakers are prohibited from receiving contributions during the legislative session, all contributions were reported received 6/17-6/30 2025.
- ◆ Note 1: \$20,000 came from the Texas Trial Lawyers Association PAC and \$200,000 from Texans for Truth & Liberty PAC (funded with \$10m from Arnold & Itkin). For the purposes of this analysis, the \$200,000 from Texans for Truth & Liberty PAC is included in the total from “Democrat trial lawyers” because the PAC is funded 100% from Arnold & Itkin and they are both Democrats. Where voter records could not be identified or had non-partisan history, political contributions/public statements were used to make a partisan determination for the LaHood donor and that information is linked in the table below (also linked [here](#))
- ◆ Note 2: If the contribution came from a law firm, the partisanship of the firm’s namesake was used.
- ◆ Note 3: Although he has announced he’s now a Republican, Desi Martinez (\$5,000 contribution) is included in this list of Democrats as he voted in the 2024 Democrat primary.
- ◆ Note 4: Further exploration of the political giving of LaHood’s biggest Democrat donors is covered in subsequent findings in this report.
- ◆ Note 5: The information in the 5 columns on the right side of the table is appended from other sources, not found in the original campaign finance report.

◆ “Founders of “Texas Democratic Voices” Spending Big to Influence GOP Primaries” ([The Texas Voice](#))

- Democrat personal injury trial lawyers Kurt Arnold and Jason Itkin have launched the Texans for Truth and Liberty PAC with a \$10 million donation from their law firm
- The Arnold & Itkin law firm was a major donor, along with George Soros, to the First Tuesday PAC that spent millions to “Stop MAGA Republicans” last year.
- Much of the Texans for Truth and Liberty PAC’s spending appears to be geared towards influencing Republican Primaries

A liberal law firm that helped bankroll efforts to “Stop MAGA Republicans” and whose owners started an organization called “Texas Democratic Voices” was the largest political donor in Texas during the first half of 2025, with many of their contributions seemingly geared towards influencing Republican Primary elections.

The Arnold & Itkin law firm donated \$10 million to the Texans for Truth and Liberty PAC on June 16. Texans for Truth and Liberty was formed by Arnold & Itkin’s owners, Houston personal injury trial lawyers Kurt Arnold and Jason Itkin, on April 29. The \$10 million contribution from their law firm was the only donation that Texans for Truth and Liberty PAC reported receiving.

◆ Arnold & Itkin was the top donor to First Tuesday PAC.

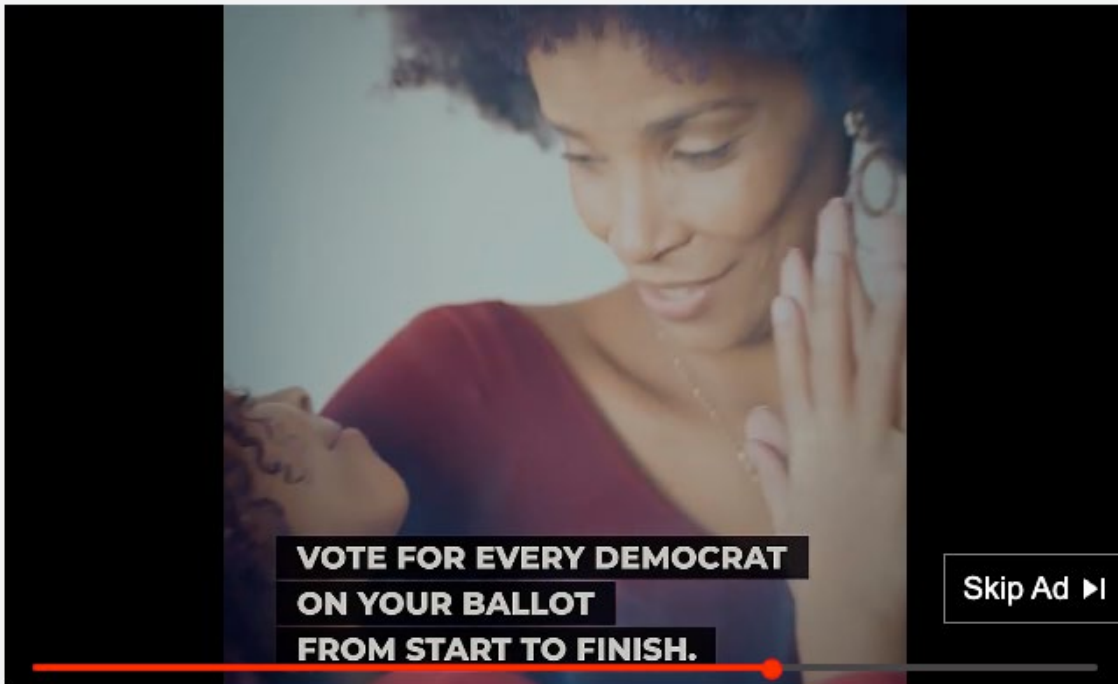
