

# CREATING AN OFFICE PROCEDURES MANUAL

## PREFACE

This handbook is a guide for creating your firm's office procedures manual. All law firms, no matter their size, have certain procedures that enable employees to accomplish their work. While there are no universal procedures, some elements are common to every office. Compiling and stating these procedures in a manual available for all employees can help the firm achieve a more efficient workflow, and maintain procedural continuity throughout the office.

Customize this handbook to serve as a desktop reference by inserting section dividers with the appropriate written procedures developed and approved by your firm. Keep the manual in loose-leaf form, and update it at regular intervals. Expansion of office staff and/or space, purchase of new equipment, promulgation of new court rules, or a change in administration are just a few events that may trigger procedure updates. A current procedures manual is vital to the orientation and training of new employees and as an ongoing reference for existing staff.

**KEEP YOUR FIRM'S POLICY MANUAL SEPARATE FROM THE FIRM PROCEDURES MANUAL.** The policy manual provides specific policies relating to the administration of the firm, while the procedures manual sets out guidelines to accomplish tasks in the office. They should not be confused.

## DOES YOUR FIRM NEED A PROCEDURE MANUAL?

There are many tasks performed by each employee of your firm. The methods to complete these tasks are examples of office procedures. Without written procedures, employees may find themselves lost or confused as to how they can accomplish these tasks. The result is that employees will develop their own methods, and you will soon find everyone in the office performing tasks differently with different results. Important elements may be missed or overlooked, and any consistency will be lost.

The advantages to providing a written procedures manual include:

1. Uniformity of work product;
2. Reduced training time;
3. Fewer disruptions for clarifications;
4. Assignment of responsibility;
5. Continuity; and
6. Clarified expectations.

A properly written procedures manual enables any firm employee to step in and complete or assist with any project. Putting all necessary instructions in writing helps an employee pick up where someone else left off. Should an employee's workload be more than the employee can handle (as often occurs in the practice of law), written procedures allow work to easily be distributed to other employees and completed within the necessary time. This creates a more efficient and productive staff, able to handle all projects in a timely manner. It is an added advantage that the firm's work product will be as uniform as possible, both in accuracy and in style.

Both existing and new employees can use the office procedures manual as a quick reference guide, reducing the time required by administrative personnel and other employees to answer questions. New employees can immediately review all office procedures and instructions on how to complete any task, enhancing or developing the employee's performance and

productivity more quickly. Written procedures also promote continuity. When written procedures exist, everyone has the same information and guidelines, and changes in staff or administration do not impact continuity.

Written procedures also help pinpoint responsibility. If a particular task is not performed, you can easily identify what caused the failure and correct it. Employees will know exactly what the firm expects in the employee's daily work, and uncertainty and frustration will be reduced.

## **GETTING STARTED**

Although reviewing another firm's procedures manual can help you get started, it is not always beneficial to copy that other firm's procedures. Each firm has different administrative and support staff. Not all procedures will work in every firm. Look at your firm's current procedures and start from there. Creating an office procedures manual does not necessarily mean creating new procedures for your office. It can merely be the process of putting all of your current procedures in writing.

The office procedures manual should be detailed, complete, and accurate. It should be easy to read, with clear, concise directions and an easy-to-use index. It should also contain examples and/or samples. Remember this is a "how-to" book for employees. It should be an educational tool, as well as an easy reference guide. Keep in mind procedures must have a beginning and an end. Establish a sequence of steps to be followed for each procedure, and consider any applicable time limits. Identify by title (not by name) the person responsible for the designated task, and state in clear, concise terms the procedures to be followed. Remember, creating the first procedures manual can be a time-consuming, trial-and-error experience. A final version will not be produced overnight.

If possible, involve staff. Many times staff can provide practical suggestions as to how to improve procedures so desired goals are achieved without creating unnecessary problems in the process. If you do not reach out and encourage staff to participate, you will find few employees will be willing to make suggestions on their own.

Unwritten procedures can assist in developing written procedures. Start with a list of current firm procedures, even if they are not written down and are simply "understood" procedures of the firm. Start with an outline of topics to be covered and then fill in the topics with step-by-step procedures. Imagine yourself as a new employee, and try to include procedures unfamiliar to a new employee. Keep in mind areas where current employees ask frequent questions. Remember, new employees may have to learn procedures that differ from their past work experience. Get input from all personnel. If possible, form a committee with at least one "interested" partner, associate, supervisor, and staff person.

Assign the task of writing the first draft to one person, who should have ultimate responsibility for its completion. Establish a definite time schedule. An index of all topics covered should be included for easy reference. The layout, numbering system, cover, type style, etc. should be determined and used consistently.

## **WRITING IT RIGHT**

This guide includes examples of procedures, and demonstrates how to write clear, concise instructions. The examples are for informational purposes only, and demonstrate simple useful procedures and forms. Some procedures may not apply to all firms.

In addition to providing the procedures, the specific responsibilities are also assigned. This approach enables employees to determine at the outset what their responsibilities are.

Samples of forms should always be included. Most firms already have forms in use, and they should be incorporated as examples in the manual. When possible, include checklists to guide the employee through all procedures necessary to complete the task.

Once the procedures are drafted, circulate the written procedures to a few employees for “testing.” Provide a comment sheet so they are able to evaluate the written product and suggest changes, improvements, or additions. Sections dealing with specific departments of the firm should be reviewed by the department manager.

The next step is to create an index to make it easy for employees to find specific procedures. If employees cannot find a procedure or answer a question quickly, they will simply ask someone else, thus wasting time for two employees. Keep in mind, while the author may look under “Communication System” for information on how to make a long distance telephone call, a new employee might just as easily look under “Telephone Equipment,” so it is always a good idea to cross-reference all procedures.

The final draft of the procedures manual should then be distributed to all partners and administrative personnel for review and comment. When the final draft has been approved, a meeting should be arranged with all staff to introduce the new procedures manual. Everyone should be instructed to read the manual completely. Let employees know the person to whom questions should be directed. Encourage employees to ask if there is any procedure they do not understand or they find confusing.

All new employees should be given the procedures manual and instructed to review it thoroughly. They should be advised that samples are contained in the manual which should be followed closely. Temporary employees should also review the procedures manual.

## **TOPICS TO BE COVERED**

The following topics are provided for reference. Since the size of a firm may dictate its needed procedures, not all firms will use all the topics contained herein, but keep in mind the basic topics necessary in every law firm, such as docketing, letter and pleading form and style, filing system, etc. Carefully choose which items are important to your firm, keeping in mind that simply because your firm does not have a policy on a particular item now, does not mean the firm does not need one.

**DOCKETING SYSTEM**

Example:

Incoming pleadings: The docket clerk will review all incoming pleadings and make date entries on the main calendar or in the computerized docketing system, and also stamp and initial a docket date on the pleading. The docket clerk will enter any related appearance dates. The assigned attorney will then review every incoming pleading, and confirm the docket clerk has stamped and initialed the docket date.

Outgoing pleadings: The assistant will confirm that a copy of every outgoing pleading is sent to the docket clerk for docketing. No pleading is to be placed in a client/matter file until the docket clerk has docketed the related appearance dates and stamped and initialed the docket date.

Docket request slips: All deposition dates, motion dates, hearing dates, etc. are to be docketed as soon as they are scheduled. The assistant will complete a docket request slip and send it to the docket clerk. The slip will then be returned to the assistant with a docket date stamped and initialed by the docket clerk.

Daily and weekly docket slips: The firm docket clerk will see that the attorneys receive daily docket slips and the weekly docket for their assigned cases. On Friday of each week, the docket clerk prepares a weekly docket showing the time within which some affirmative action must be taken in active cases. Each attorney in the office is given a copy of the weekly docket.

The body of the letter is always single spaced, and paragraphs are not indented. Addresses must contain a zip code (preferably 9 digit). All letters are printed on letterhead stationery.

"Quotes within a letter are single spaced and are indented 0.5" on both the left and right margins."

All letters must contain a reference line. If you are not able to ascertain a proper reference from the file, ask the assigned attorney/dictator.

Example:

All projects submitted to the Word Processing Department must be accompanied by a fully completed instruction sheet. Instruction sheets are available at the front counter in the Word Processing Department. Projects and completed instruction sheets should be put in a folder (yellow for non-rush work and red for rush work) and placed in the "IN" basket at the front counter.

Assistants will be notified by telephone when a project is ready for pickup. A message will be left on voice mail if the assistant is unavailable. It is the responsibility of the assistant to check voicemail messages, especially when awaiting the completion of a rush project.

Revision of projects is handled in the same manner as the initial project. An instruction sheet must be completed each time a project is submitted.

It is the responsibility of the Word Processing Department Supervisor to make sure all projects are logged in and assigned to be completed as requested. If there is a problem, the assistant will be contacted immediately.

### Example:

Equipment and location: The firm has four photocopy machines located on the 6th and 7th floors, and in the Copy Center on the 8th floor. All machines make two-sided copies, collate, reduce, and enlarge. The machine in the Copy Center will also automatically staple.

Procedures for using equipment: A code system is used with all photocopy machines requiring the entry of your telephone extension (entered after pressing the “user” button on the panel which is attached to the machine), and a number to be charged (entering the client number after pressing the “client” button, and entering the matter number after pressing the “matter” button). After entering the user and client/matter numbers, press the start button. Next, select the number of copies, desired paper tray, and press start.

Charges for copies: All clients are charged 20¢ per copy. Please make sure you enter the correct client/matter number for billing purposes. If copies are to be charged to the firm, enter 999 under the client number and the following matter number:

- 100 - Charitable
- 200 - Professional
- 300 - Personnel
- 400 - General office (file and interoffice copies)
- 500 - Special billing
- 600 - Bar Association
- 700 - Replace spoiled or ruined copies
- 800 - New client (no client or matter number yet)
- 900 - Administrative

Personal copies are charged to employees by using 999 as the client number and your telephone extension for the matter number.

Example:

Client Costs

1. A client expense request form must be completed for receipt of any funds to be charged to the client's account. This form must be completed in full and must be signed by the person requesting the funds. All requests should be given to the Accounting Department as early in the day as possible. Checks are distributed at 4:00 p.m.
2. Travel and professional expenses must be accompanied by supporting receipts.
3. Any expenses exceeding \$500 must be approved by the attorney in charge of the file.
4. Every staff member should have a schedule of disbursement codes. If you do not, contact the Accounting Supervisor.

Example:

1. Reserving a conference room: The assistant should check with the receptionist to reserve a conference room, providing the name of the person reserving the room, the date, hour, number of people, and length of time needed. The receptionist keeps a schedule of all conference room reservations. (Specify the location these reservations are kept.)
2. Resolving conflicts: If the conference room is already reserved for a time you wish to reserve it, the receptionist will provide the assistant with the availability of other conference rooms and/or the name of the person currently reserving the conference room in question. It is then the responsibility of the assistant to confer with the person requesting the reservation and the person who currently has the conference room reserved to resolve the conflict. The assistant should then call the receptionist to advise of the outcome.
3. Maintaining supplies: All conference rooms contain message pads, pencils, pens, paper clips, coffee cups, water glasses, napkins, and condiments. It is the responsibility of the assistant to provide the coffee, tea, and water.
4. Cleaning up: It is the responsibility of the assistant to clean up the conference room when the conference is over. The conference table should be cleared, and all dirty cups, glasses, and pots should be returned to the kitchen. All supplies should be replenished.

## **KEEPING YOUR MANUAL CURRENT**

A procedures manual will only be successful if you update it over time. To make updates easy, keep your procedures manual on your computer network or in a loose-leaf notebook. As new material is added and existing procedures are revised, insert or delete pages as needed. Advise staff of these changes by circulating an inter-office memorandum, briefly describing the changes and including the added or revised pages. If major changes are made, hold a short staff meeting with time for questions.

## **CONCLUSION**

Remember, a procedures manual should:

- Be an orientation tool
- Be a training guide
- Be a reference guide
- Provide uniformity
- Reduce disputes as to work methods
- Delegate through clearly outlined duties and responsibilities
- Facilitate work measurement and provide information for cost control
- Improve morale by letting everyone know the standards and expectations
