CORSHAM CEMETERY – TABLE OF FEES 2017/2018 (EFFECTIVE FROM 1 APRIL 2017)

The Fees and other charges set out below apply:

- where the person to be interred was, at the time of their death, a parishioner of the Parish of Corsham; or resident had been moved to a care home outside of parish within the past two years of death
- where the person to whom a right is granted is such a parishioner;
- in the case of a stillborn child, where one of the parents is such a parishioner.

In all other cases the fees and other charges will be doubled, except where the Exclusive Right of Burial in the grave in question or the right of constructing the walled grave or vault was purchased at the single rate.

(a)	of the body of a stillborn child or of a child whose age at the time of death did not exceed 12 months or of the cremated remains thereof.	FREE (non-parishioners £120.00)
(b)	of the body of a child whose age at the time of death exceeded 12 months but did not exceed 16 years or of the cremated remains thereof.	£120.00
(c)	of the body of a person whose age at the time of death exceeded 16 years.	£540.00
(d)	of the cremated remains of a person whose age at the time of death exceeded 16 years.	£200.00
(e)	walled grave or vault	at cost
1B	<i>For the interment in a grave (in the lawned area – no kerbing) including grave digging</i>	
(a)	of the body of a stillborn child or of a child whose age at the time of death did not exceed 12 months or of the cremated remains thereof.	FREE (non-parishioners £90.00)

(b)	of the body of a child whose age at the time of death exceeded 12 months but did not exceed 16 years or of the cremated remains thereof.	£90.00
(b)	of the body of a person whose age at the time of death exceeds 16 years.	£500.00
(c)	of the cremated remains of a person whose age at the time of death exceeded 16 years	£175.00
2.	<i>Exclusive Rights of Burial – in traditional grave (per plot)</i>	2017/2018
(a)	in an earthen grave 7ft x 3ft	£390.00
(b)	of cremated remains in an earthen grave 3ft x 2ft	£190.00
3.	<i>Exclusive Rights of Burial – in the lawned area – no kerbing (per plot)</i>	
(a)	in an earthen grave 7ft x 3ft	£330.00
(b)	of cremated remains in an earthen grave 3ft x 2ft	£155.00

	An additional charge for burials outside of office hours (10.00am - 3.00pm Mon-Fri excl. Bank Holidays)	£140 .00
4.	<i>Gravestones and Inscriptions</i>	
(a)	for the right to erect on an earthen grave in respect of which the Exclusive Rights of Burial has been granted, a headstone with first inscription (traditional grave with or without kerbing)	£200.00 + VAT
(b)	for the right to erect on an earthen grave in respect of which the Exclusive Rights of Burial has been granted, a headstone with first inscription (in the lawned area – no kerbing)	£145.00 + VAT
(c)	for each subsequent inscription	£65.00 + VAT
5.	<i>Records</i>	
	For a certified copy of an entry in the Burial Register	£15.00
6.	<i>Scattering of Ashes</i>	£65.00
